(57) **CLAIM**

The ornamental design for a digital electronic test instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a digital electronic test instrument embodying my new design; FIG. 2 is a front plan view thereof; FIG. 3 is a top elevation view thereof; FIG. 4 is a bottom elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; and, FIG. 7 is a back plan view thereof. The broken lines shown in FIG. 1 are for illustrative purposes only and form no part of the claimed design.

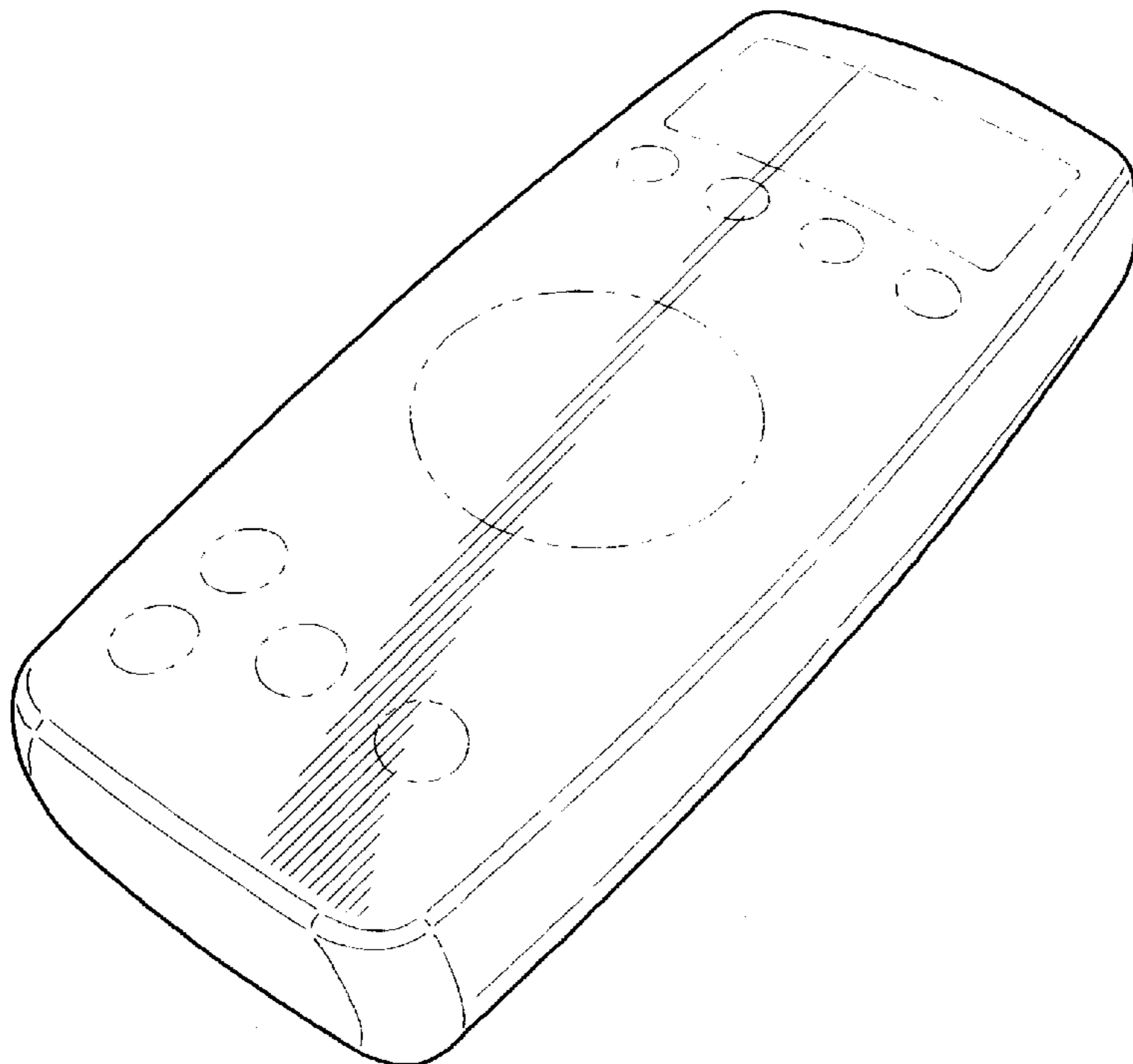

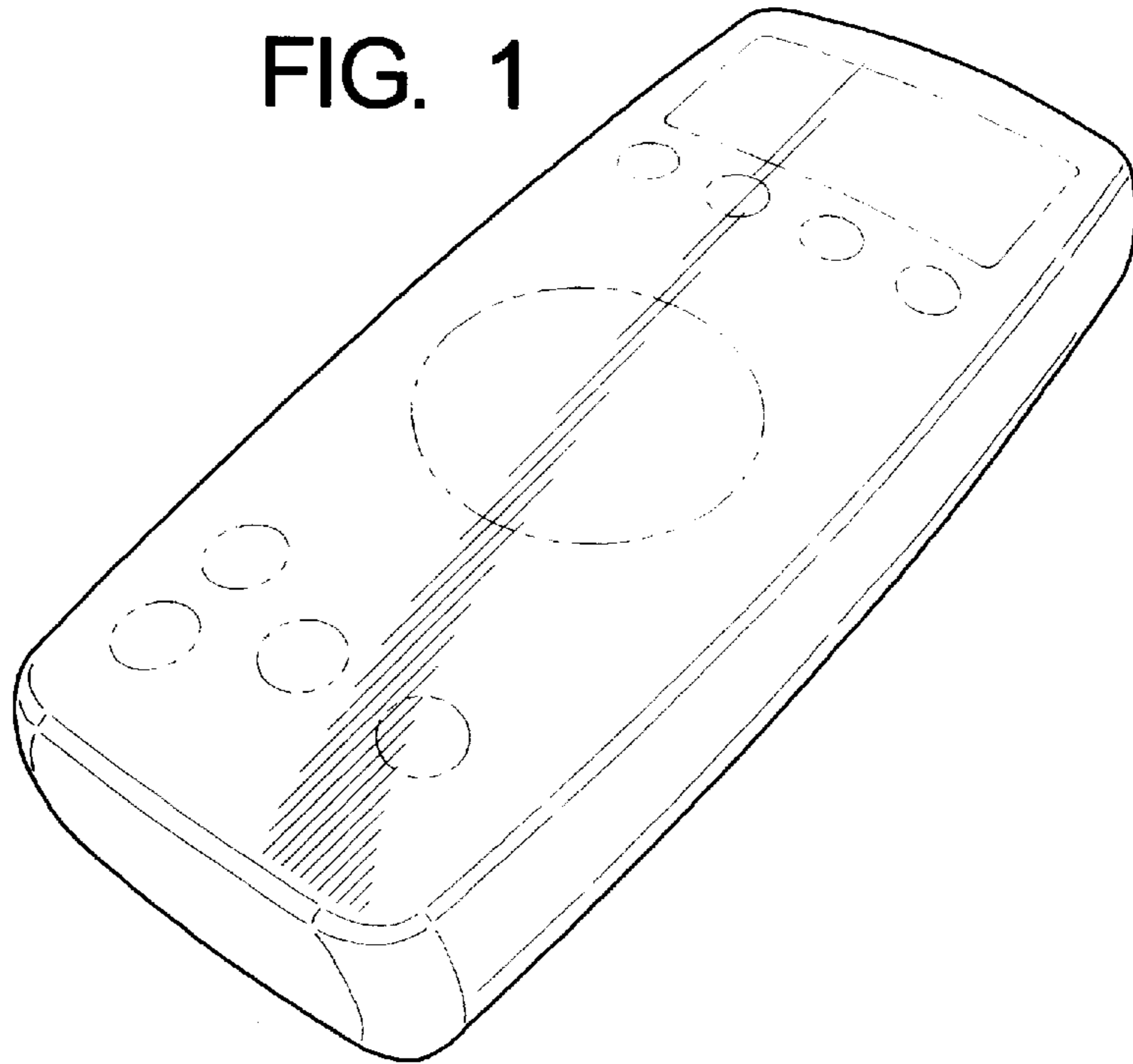

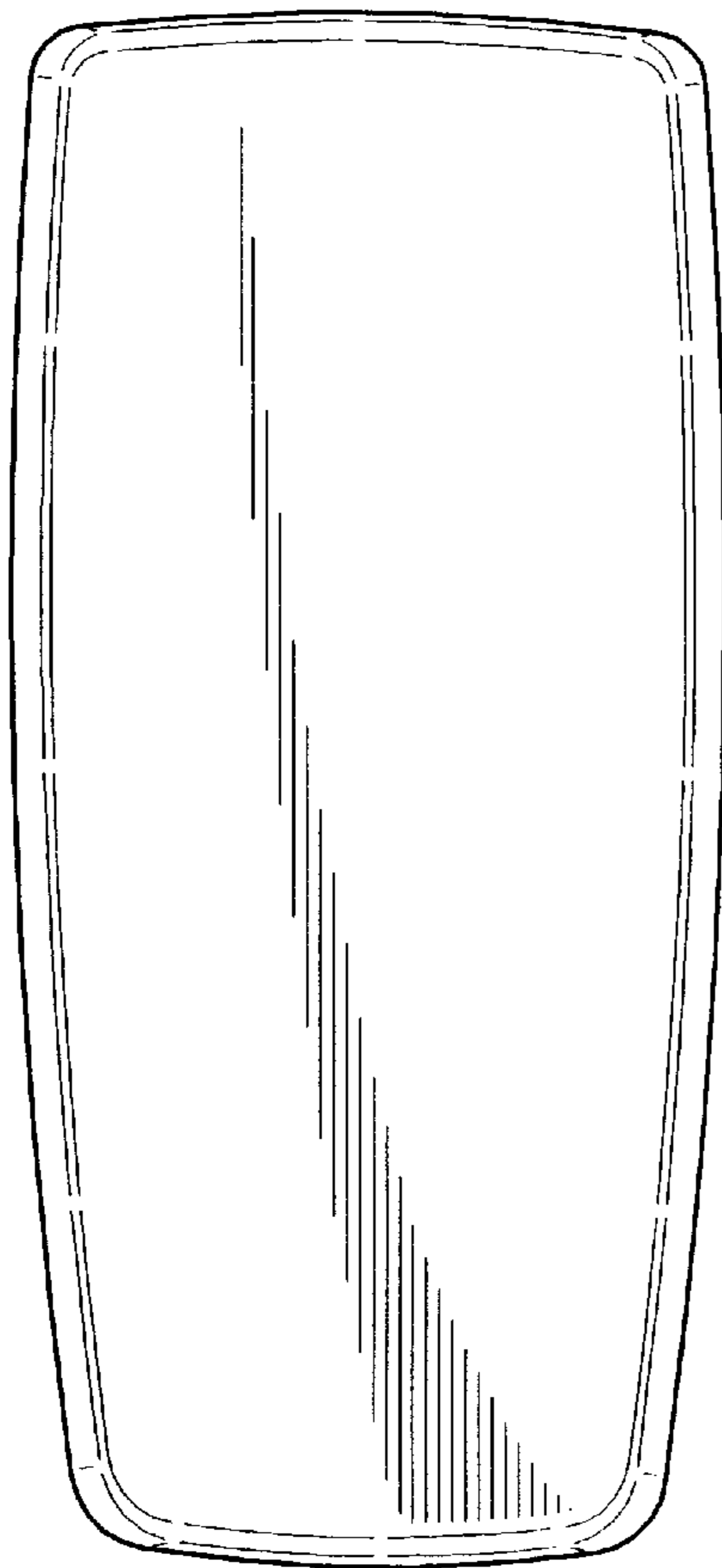

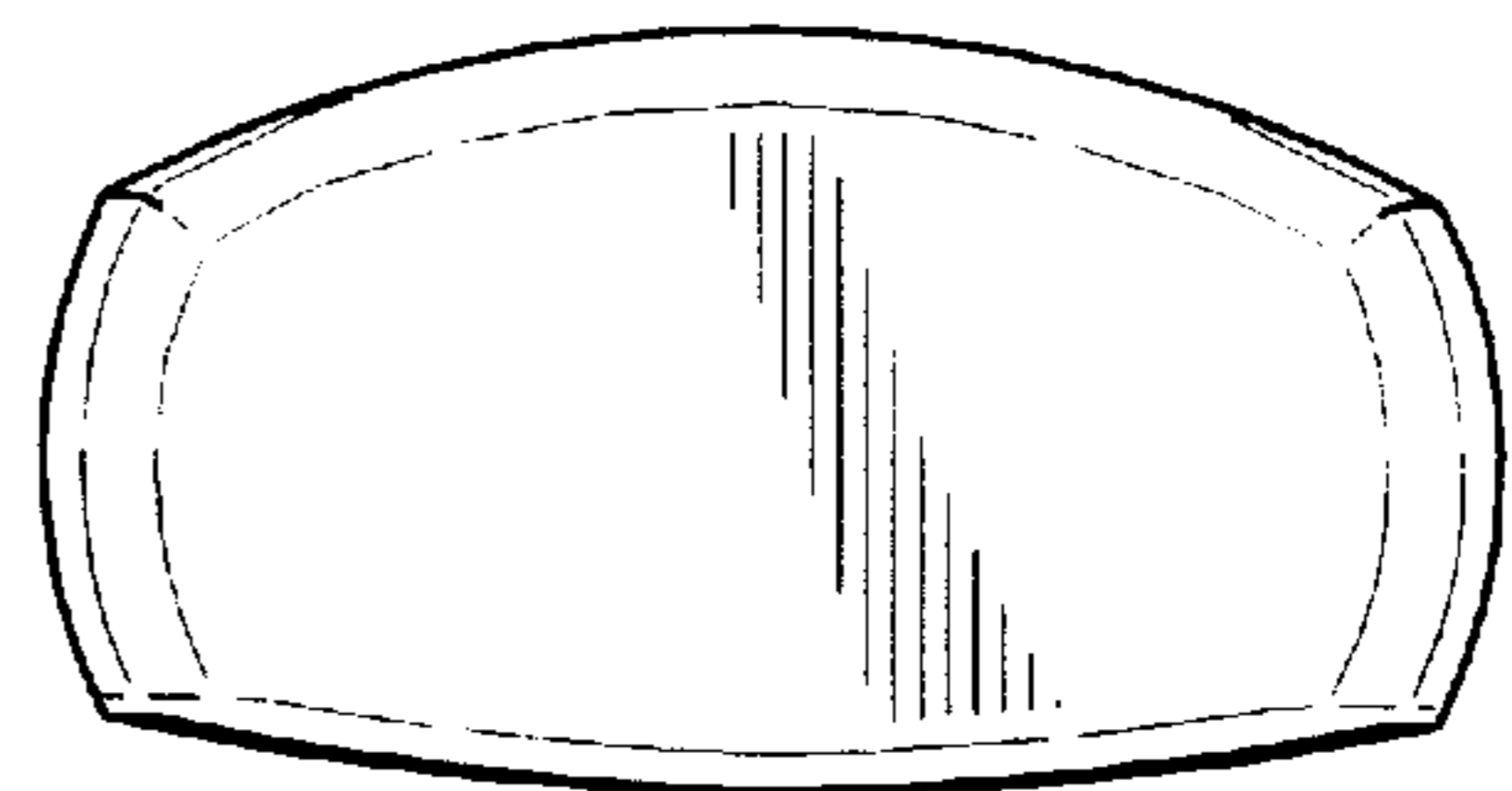

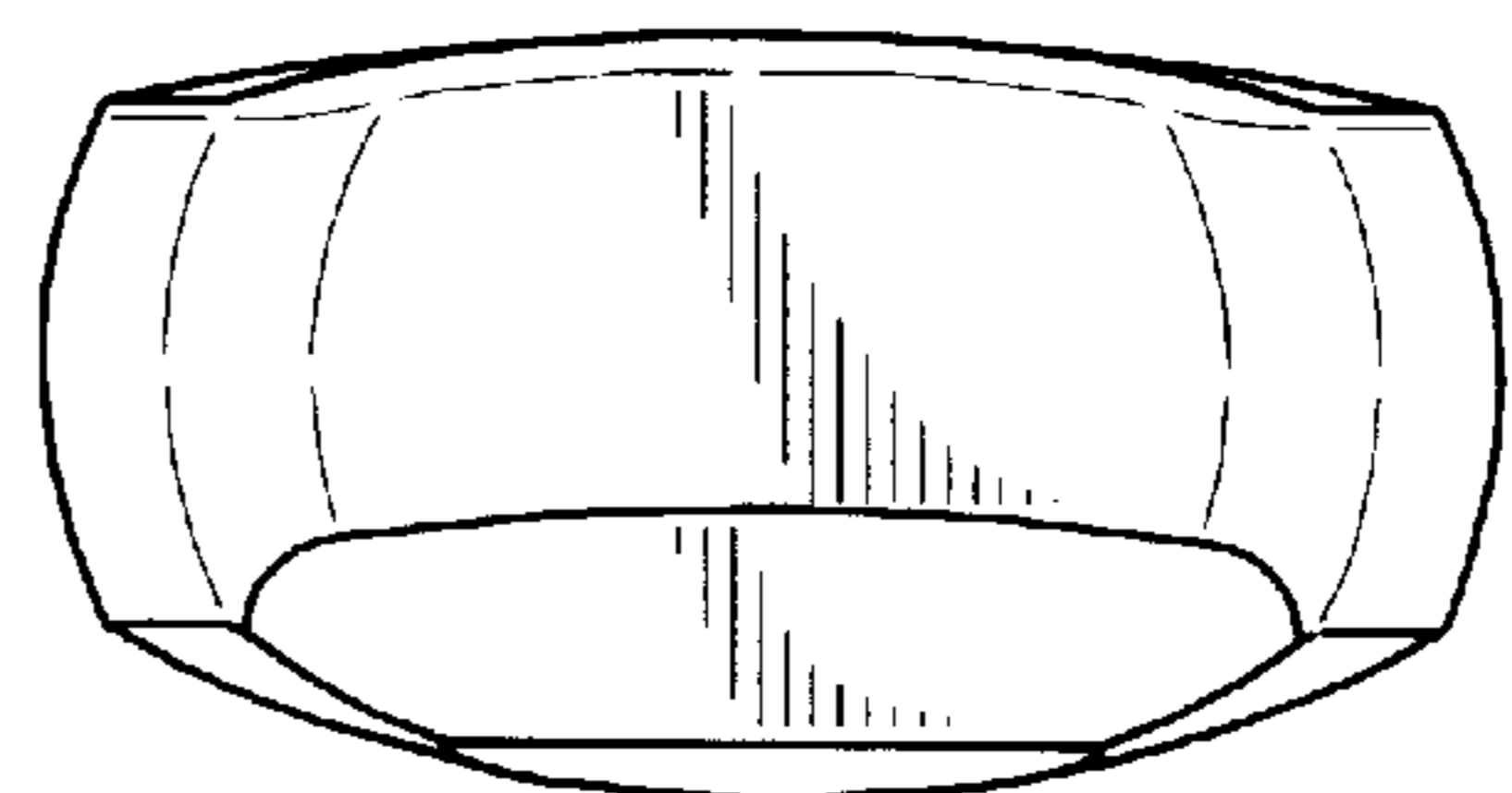

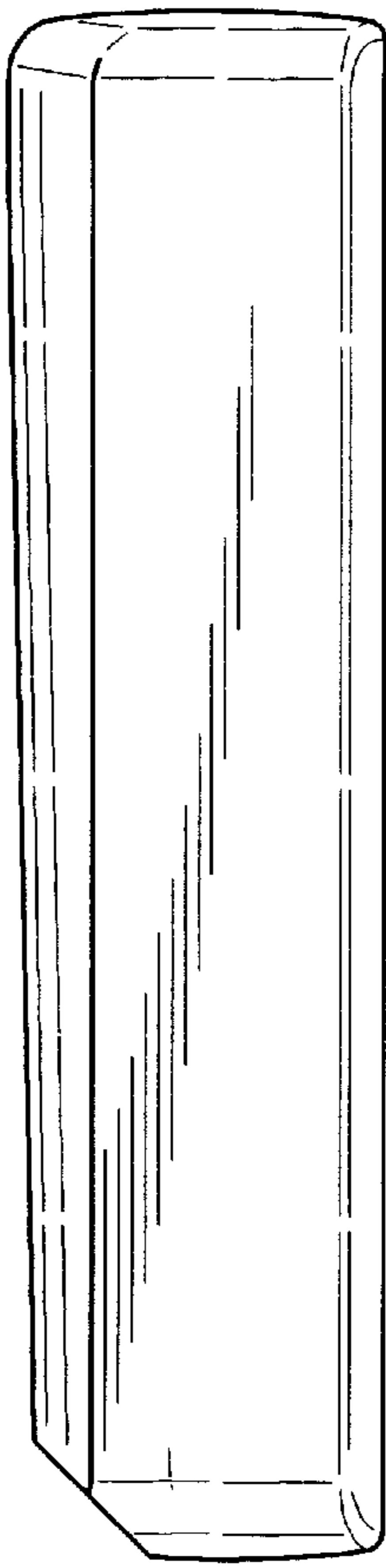

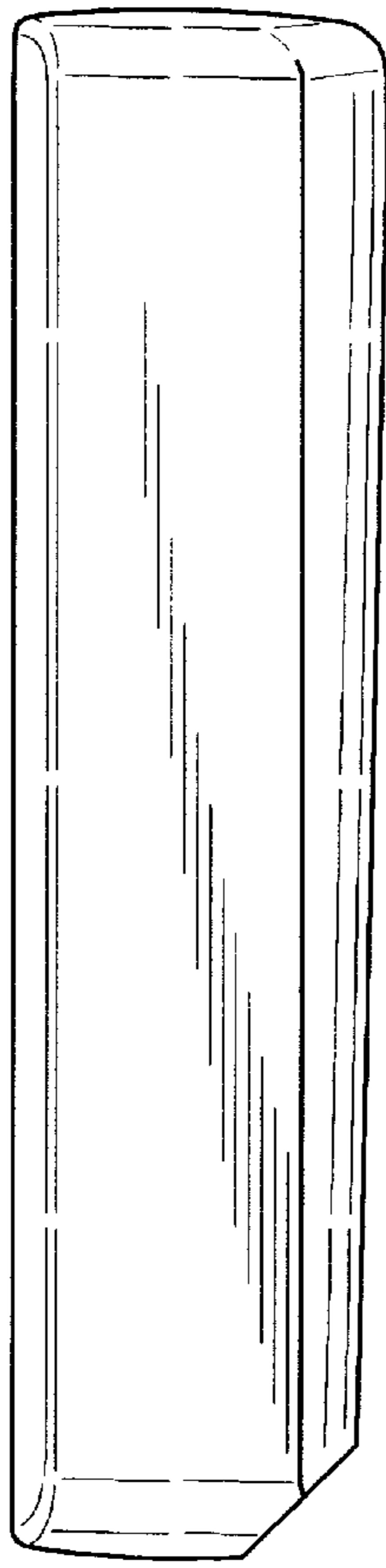
