(57) **CLAIM**

The ornamental design for a stroller frame, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of our new design with the broken line showing for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

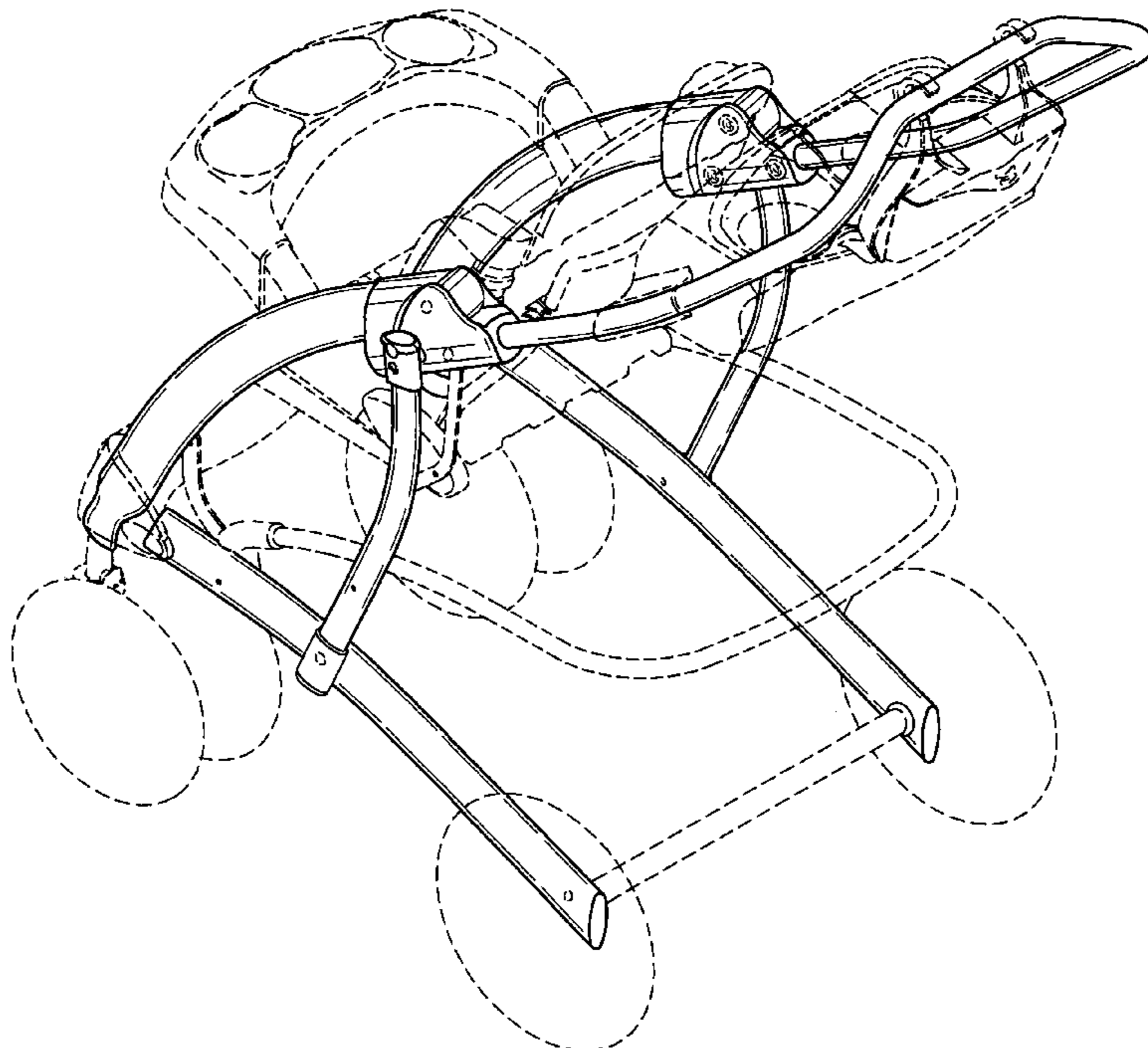
FIG. 5 is a right side elevation view thereof;

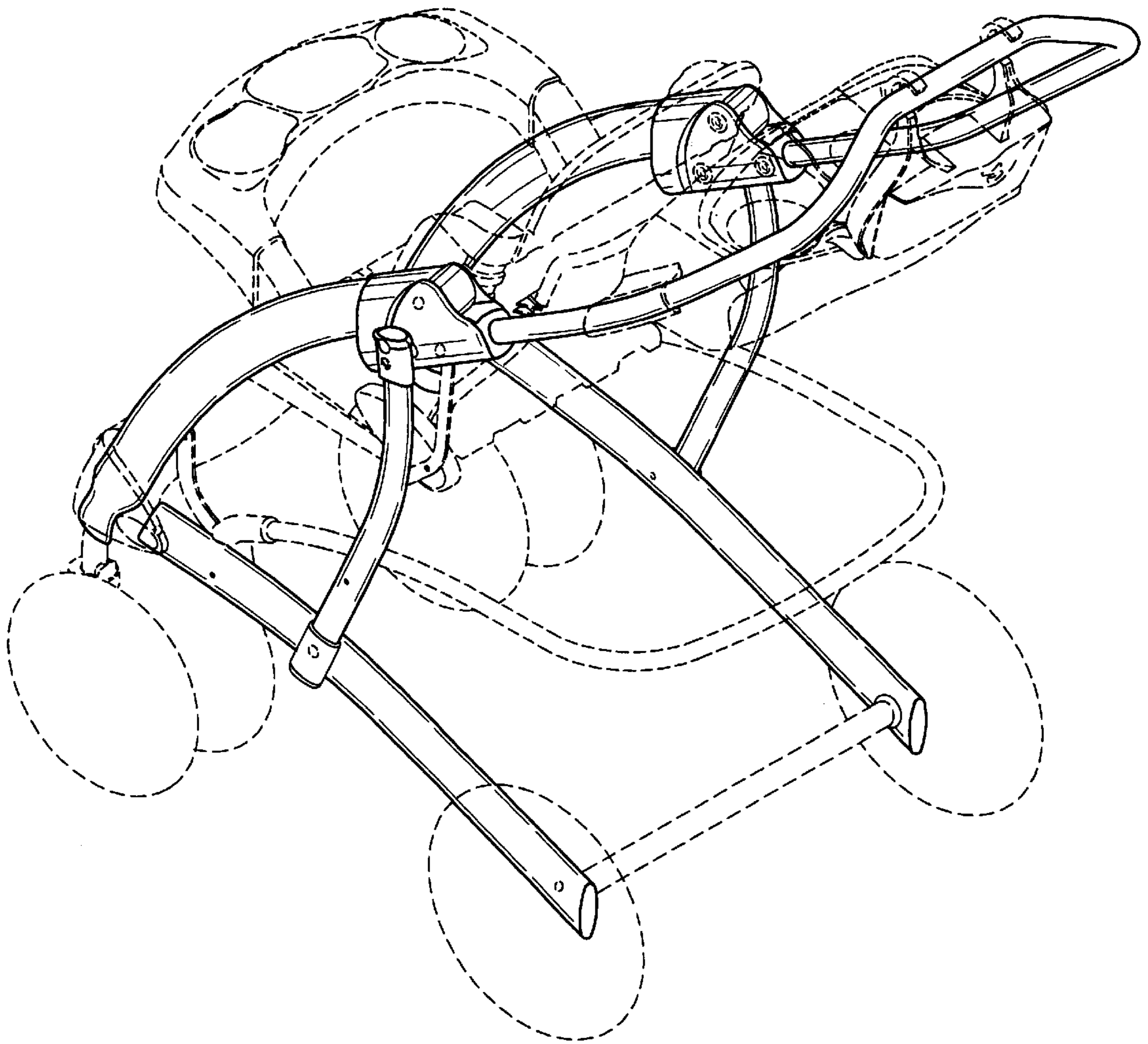

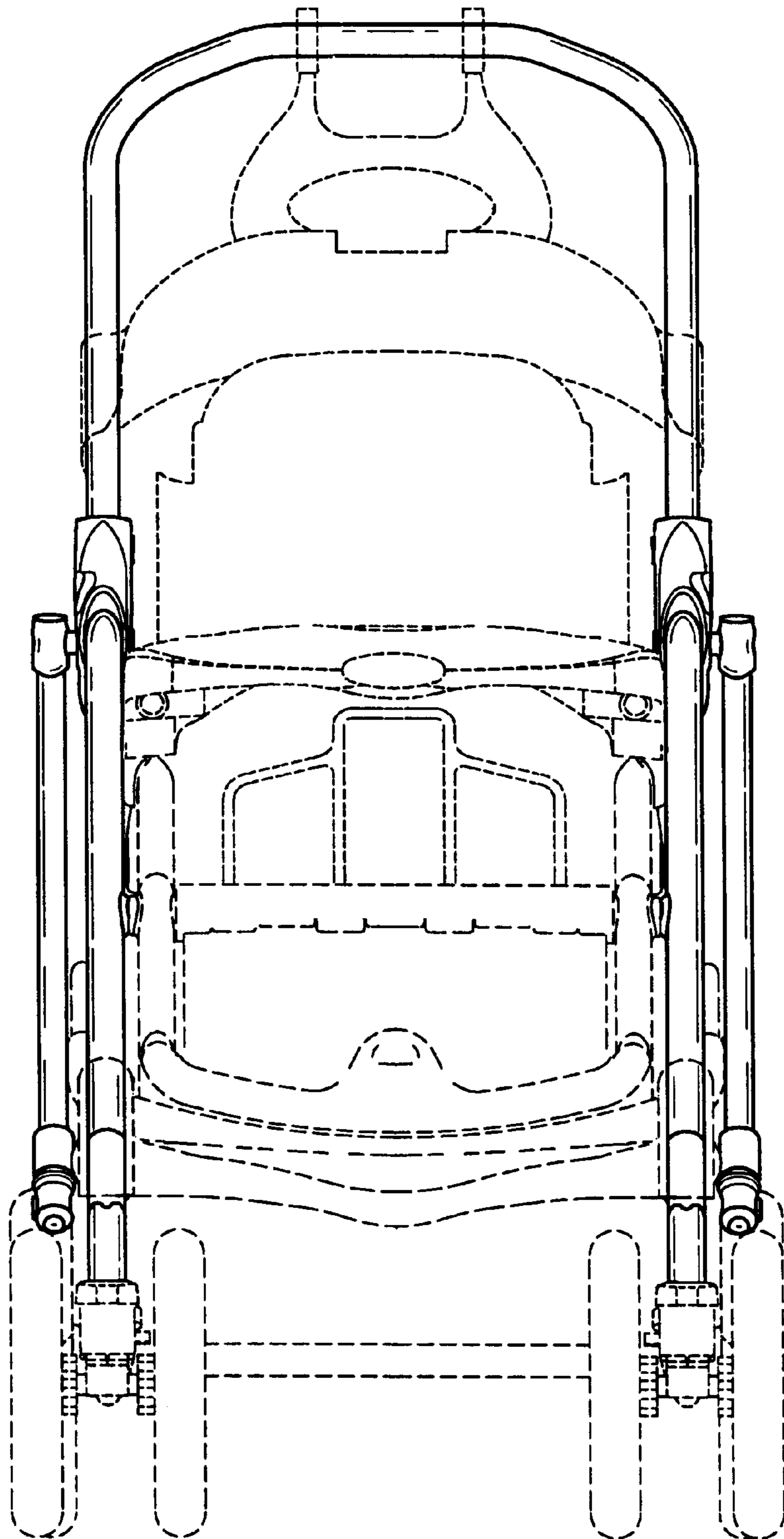

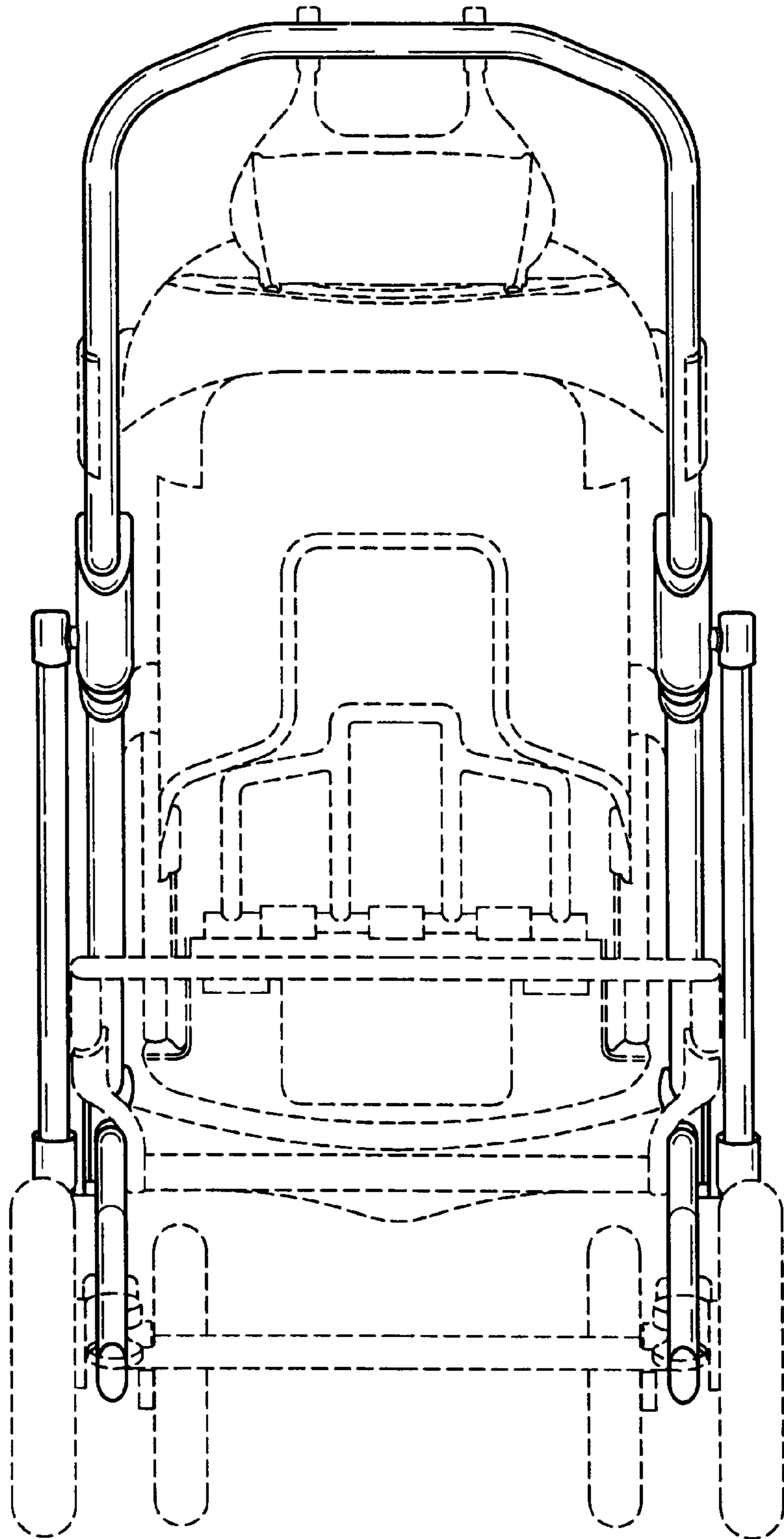

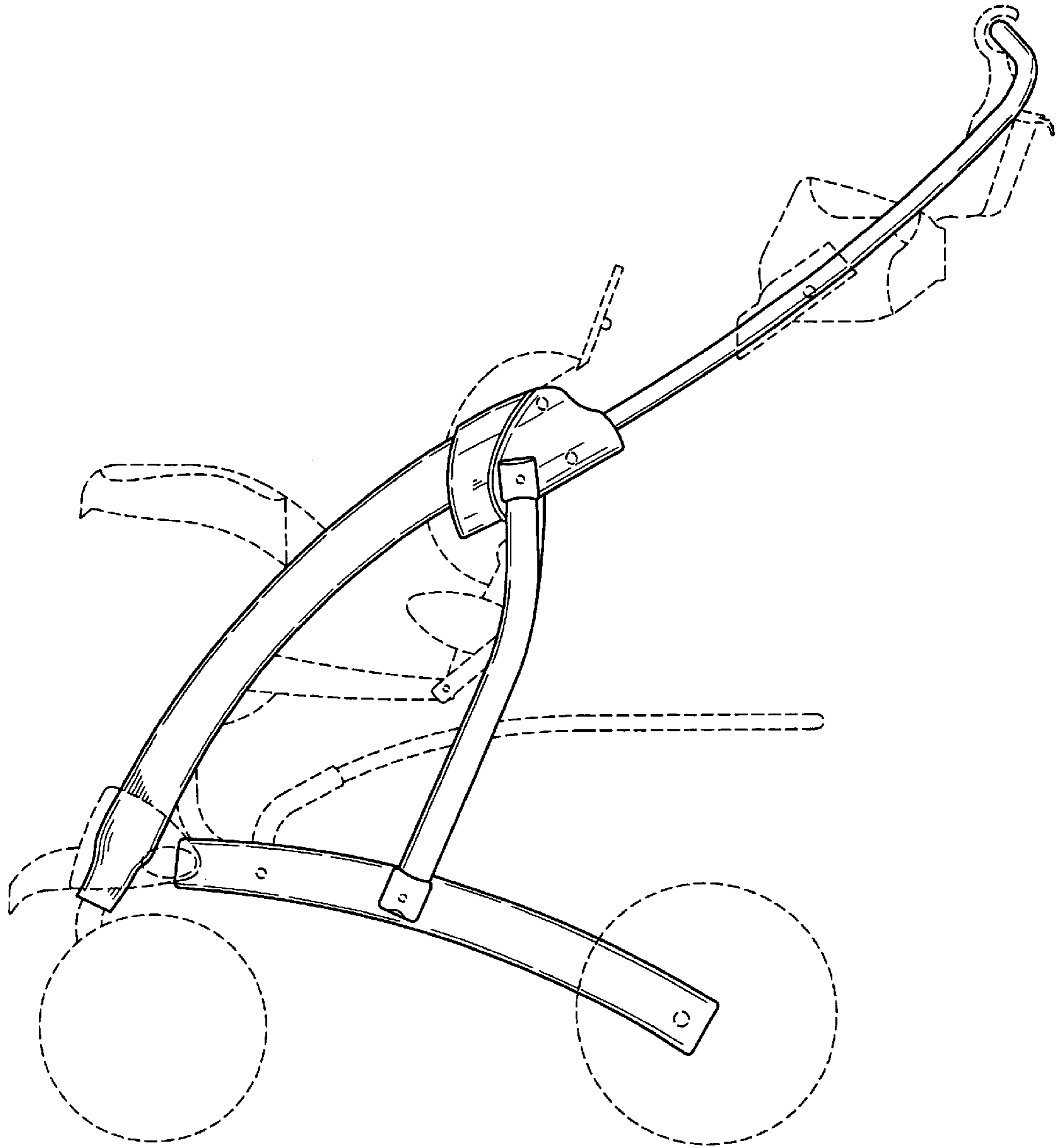

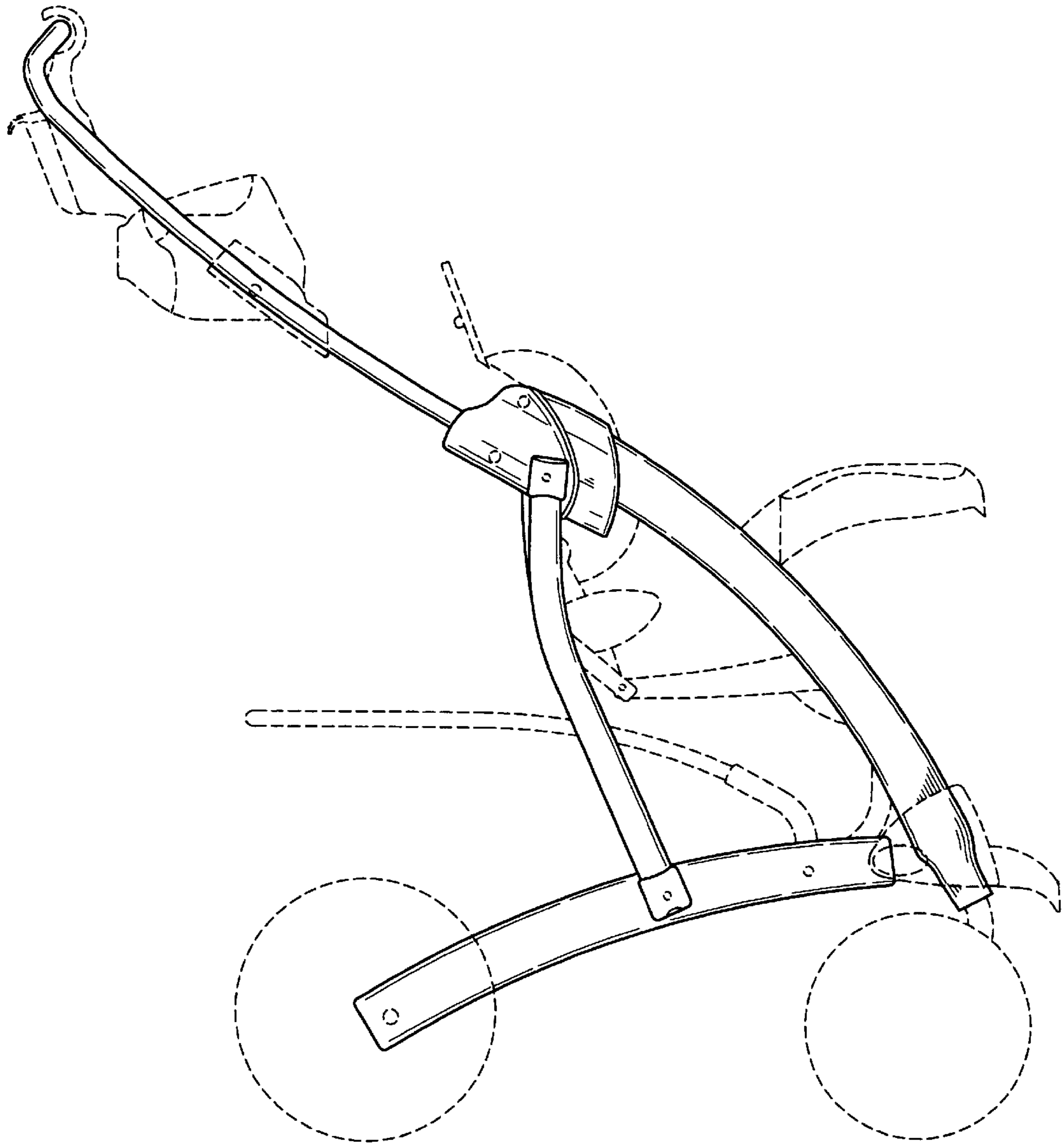

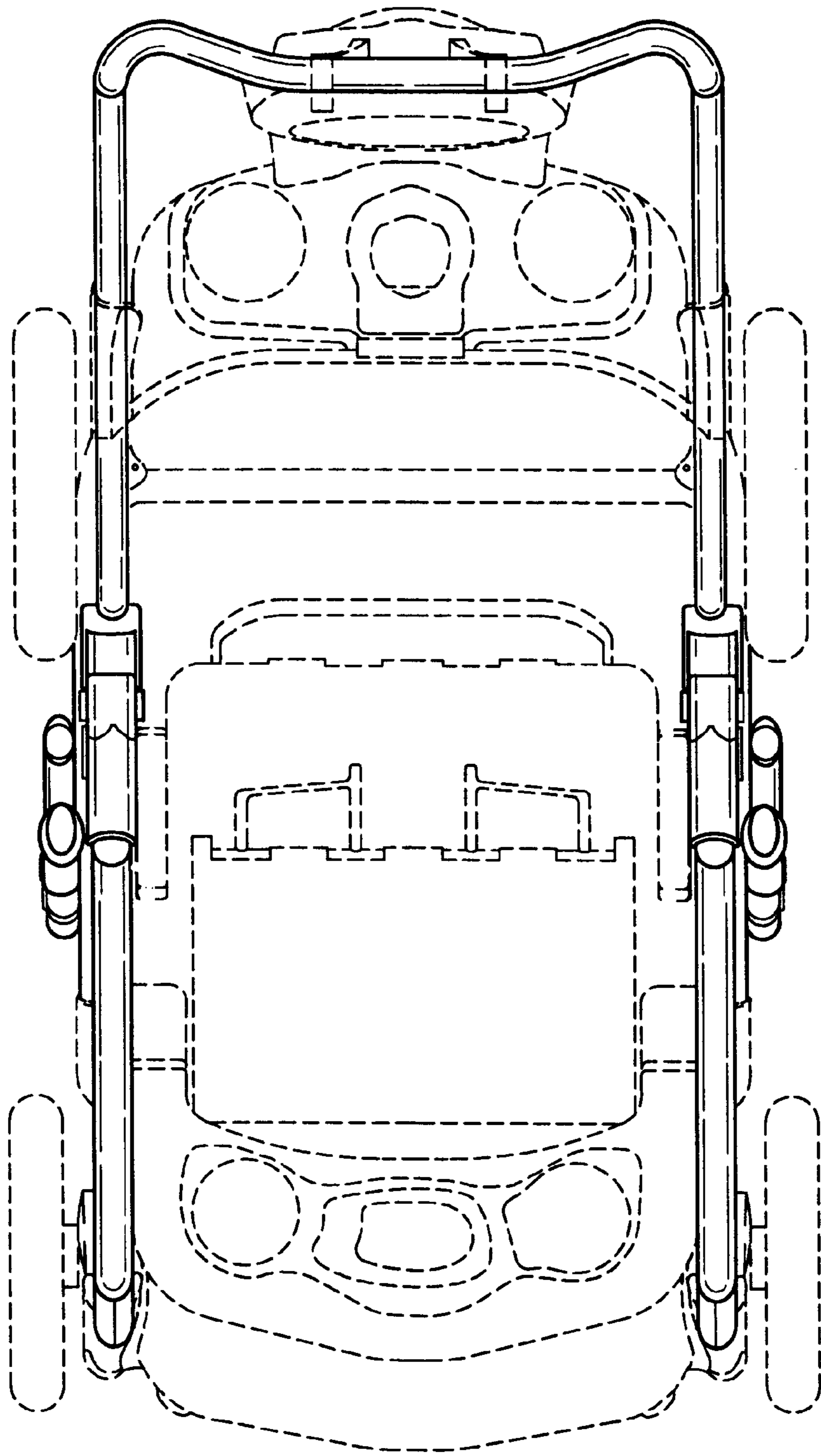

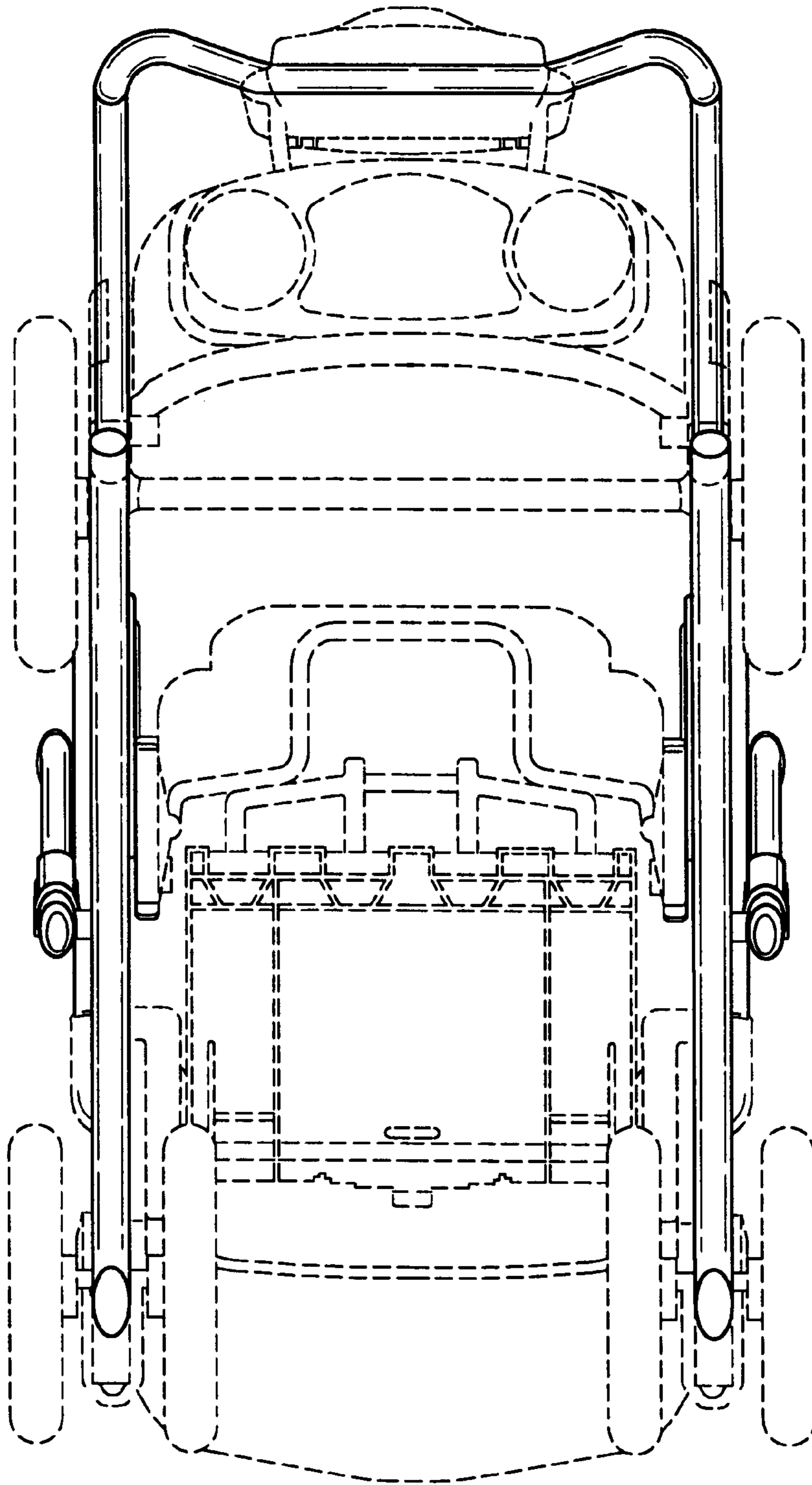

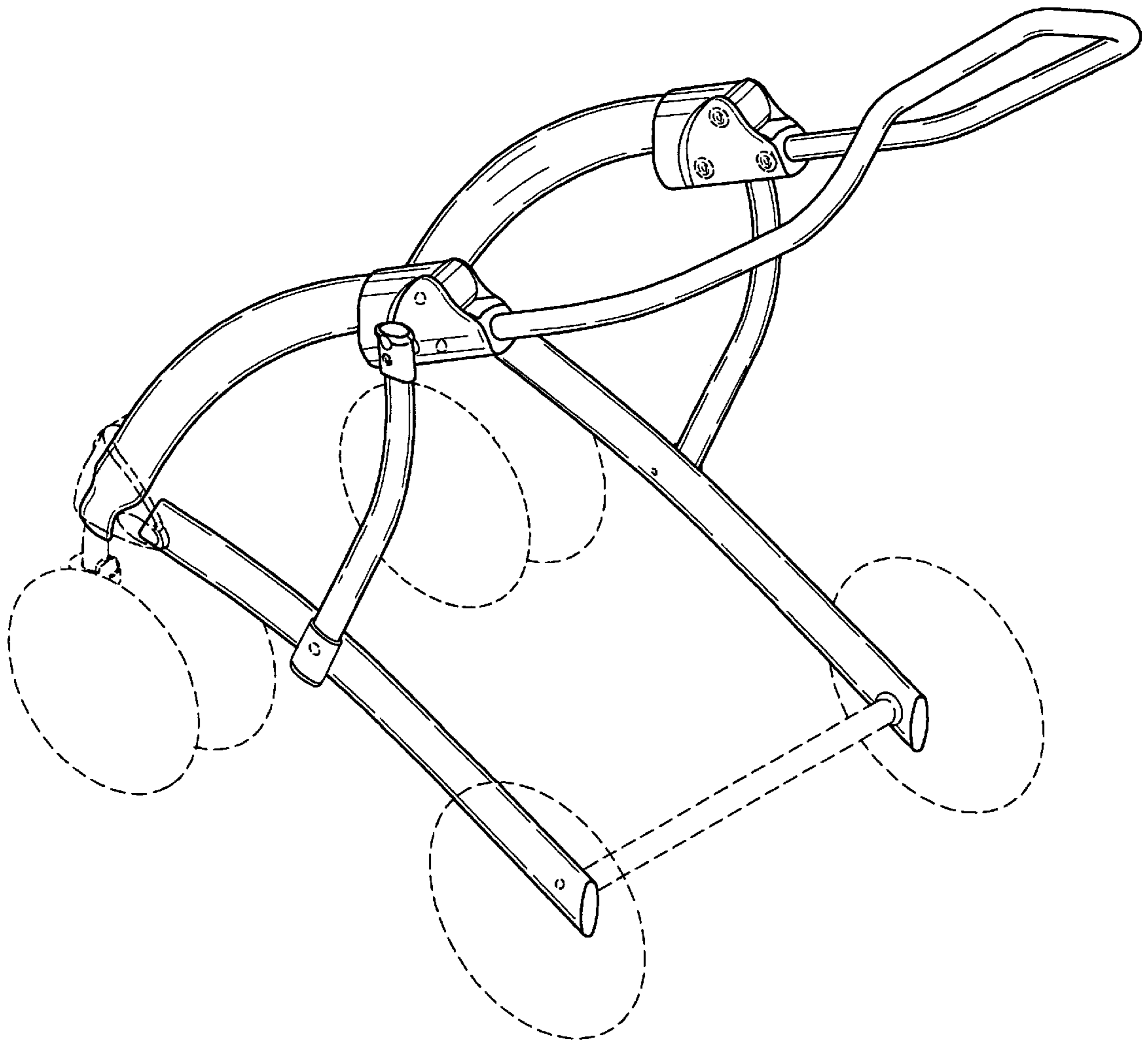
