(57) **CLAIM**

The ornamental design for a fender, as shown and described.

DESCRIPTION

FIG. 1 is a right front elevated perspective view of a fender showing our new design.

FIG. 2 is a top plan view of the fender design of FIG. 1.

FIG. 3 is a right side view of the fender design of FIG. 1.

FIG. 4 is a front view of the fender design of FIG. 1.

FIG. 5 is a rear view of the fender design of FIG. 1.

FIG. 6 is a left front elevated perspective view of the fender showing a second embodiment of our new design.

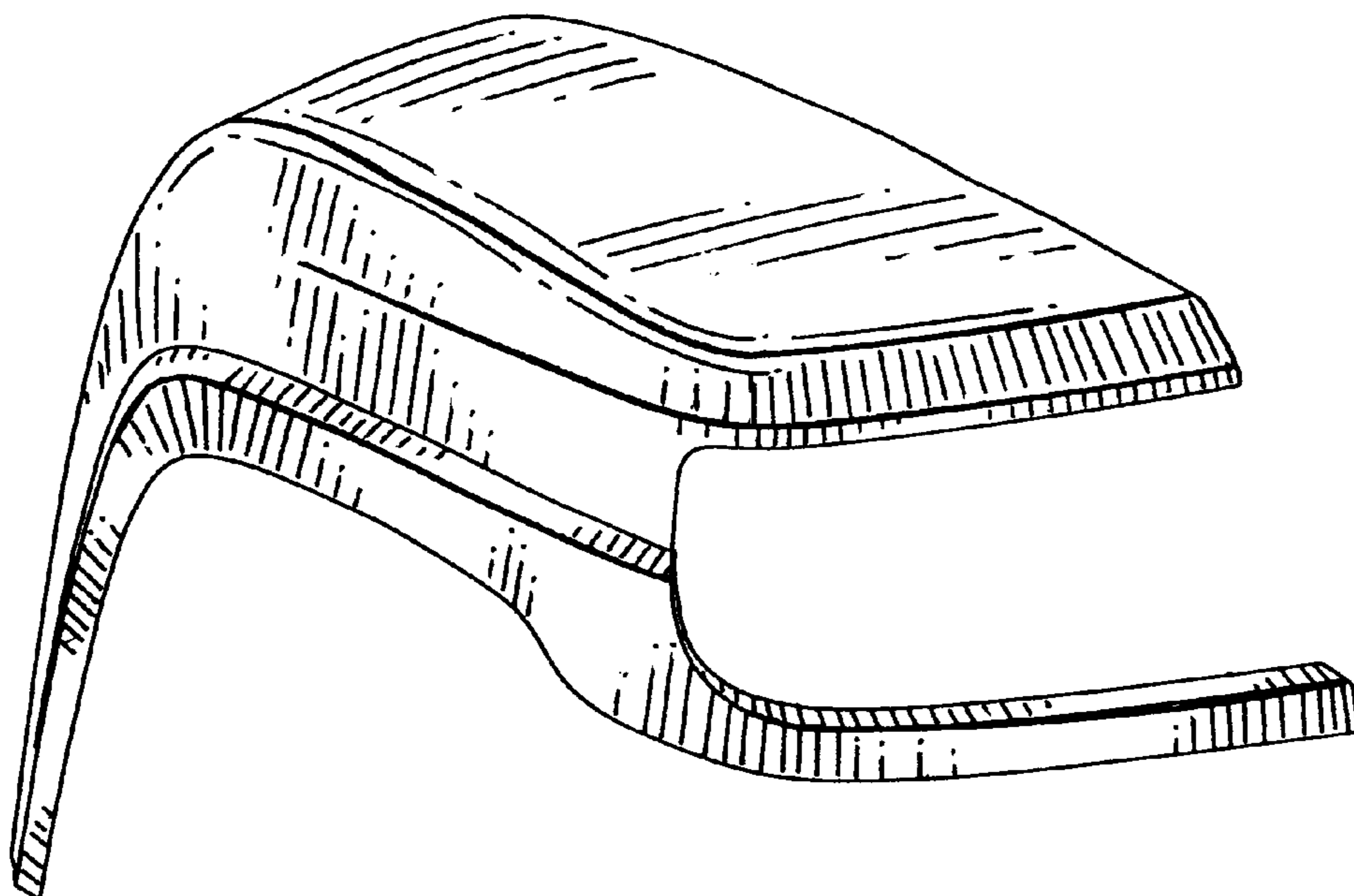
FIG. 7 is a top plan view of the fender design of FIG. 6.

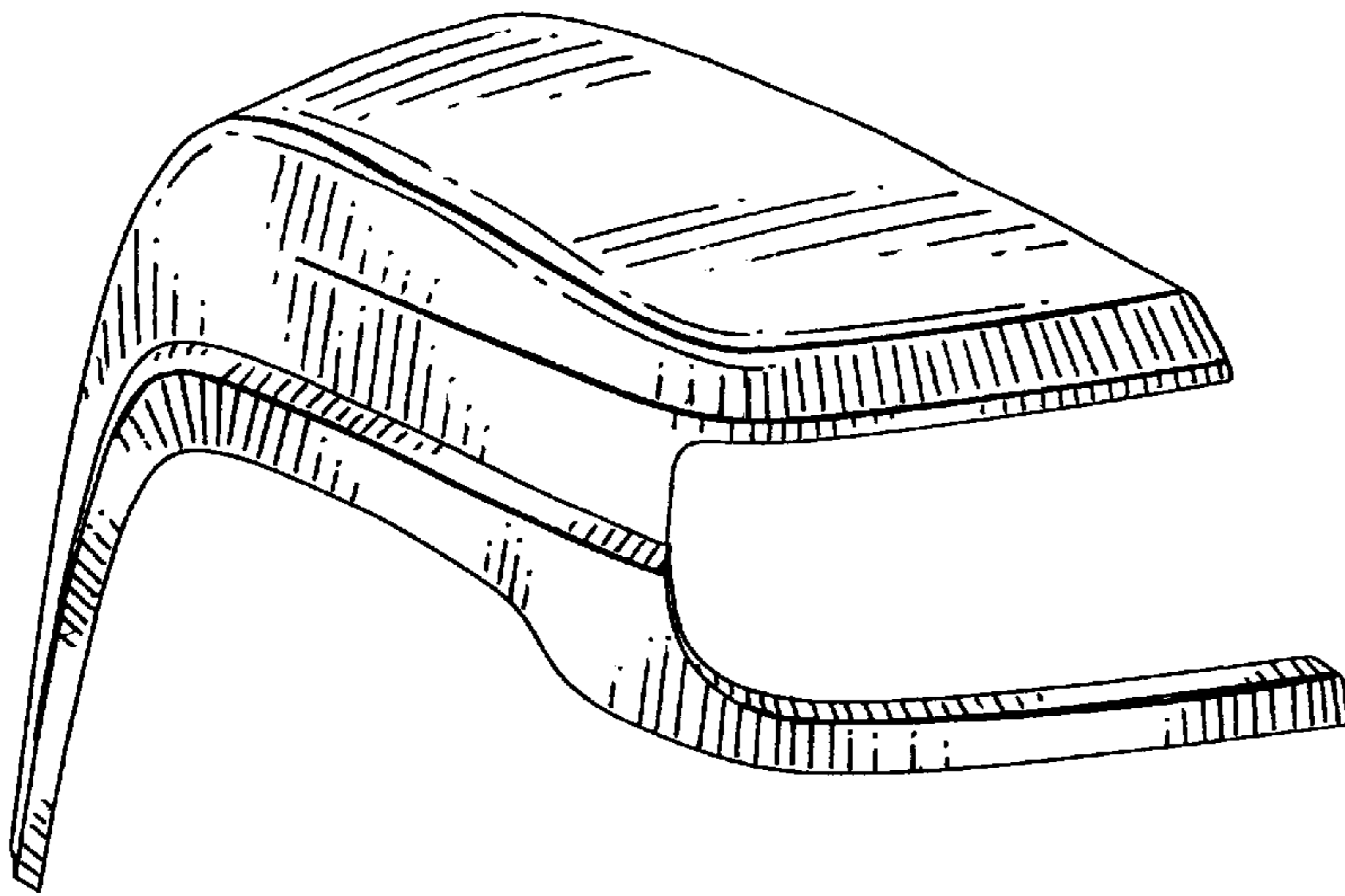

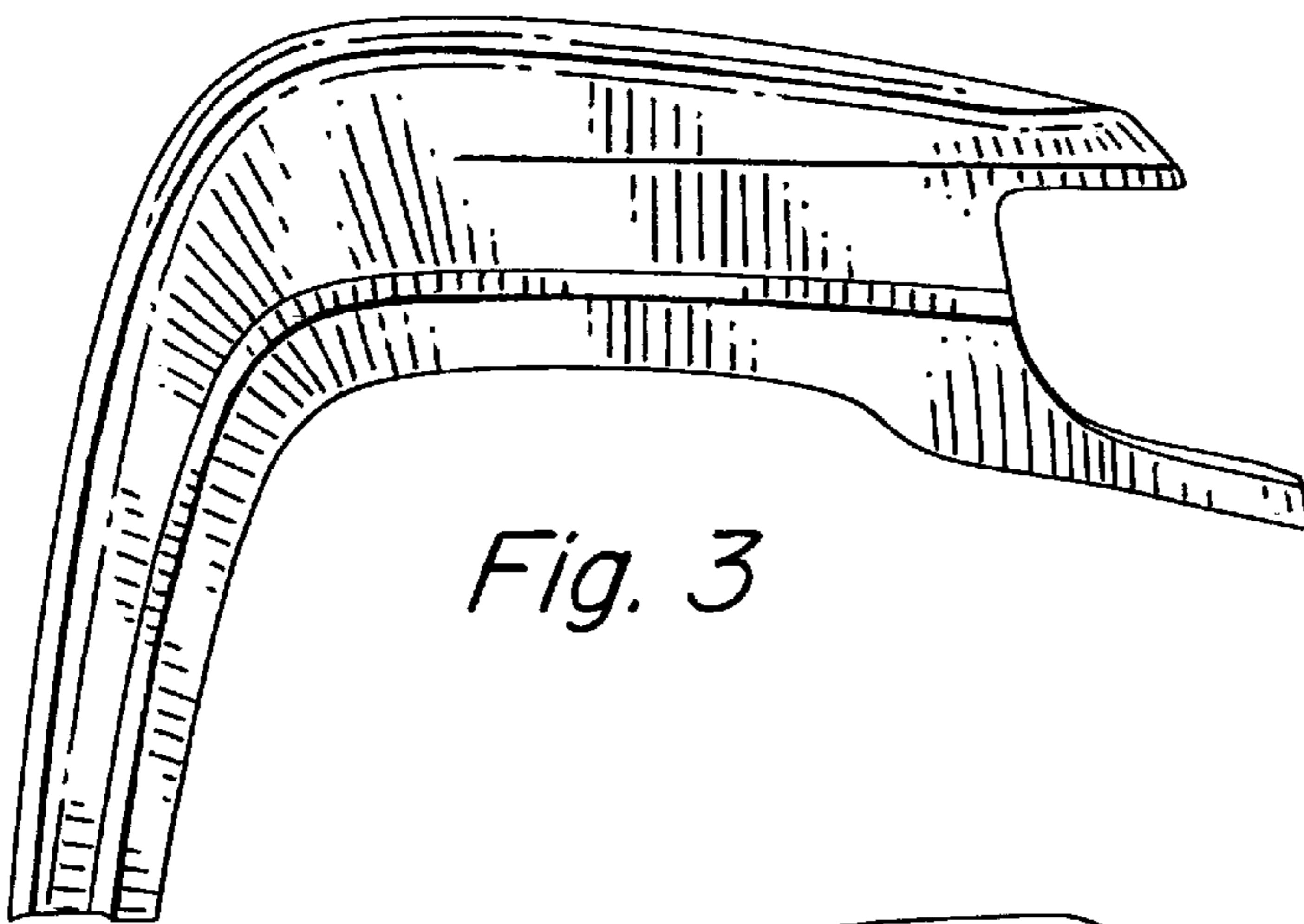
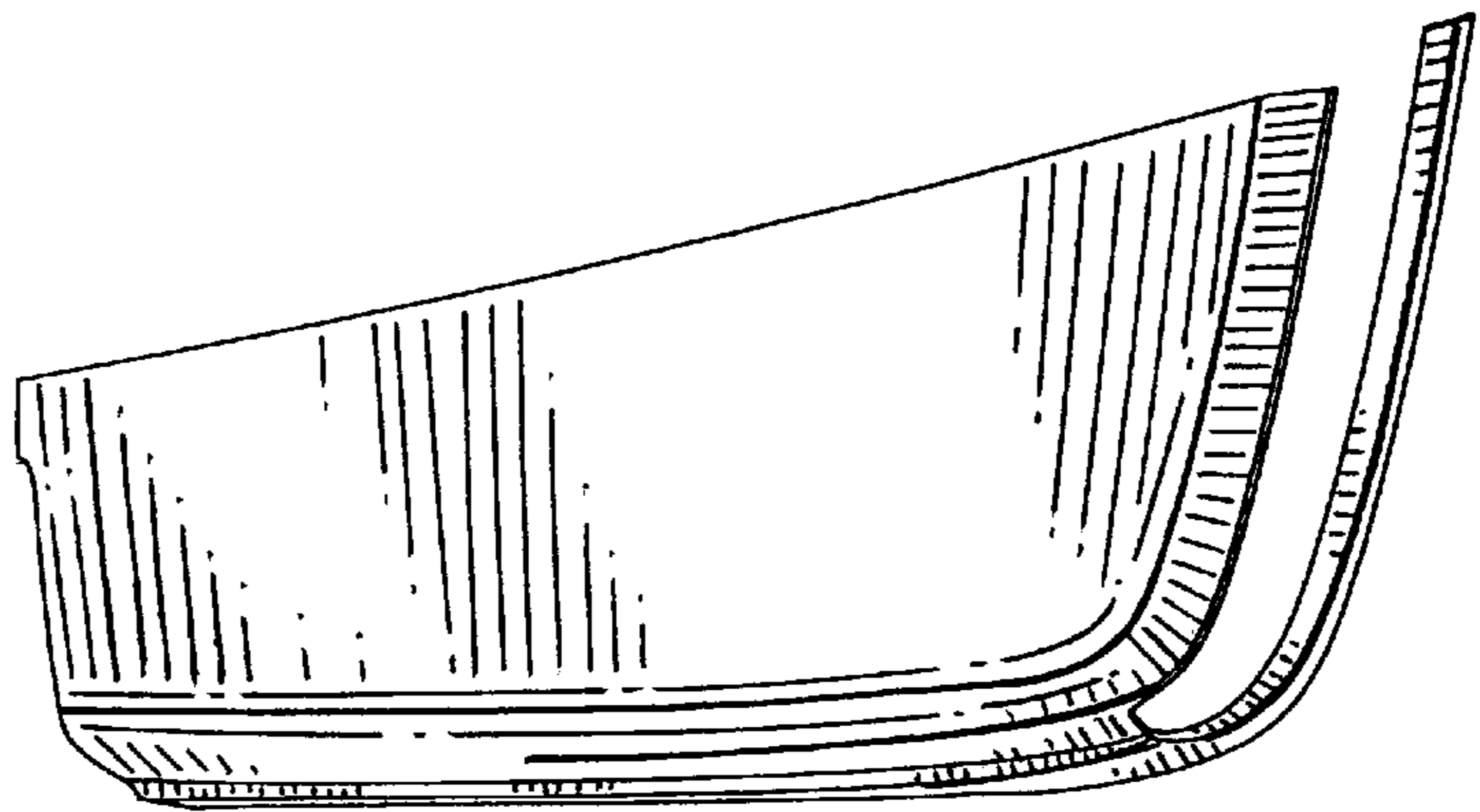

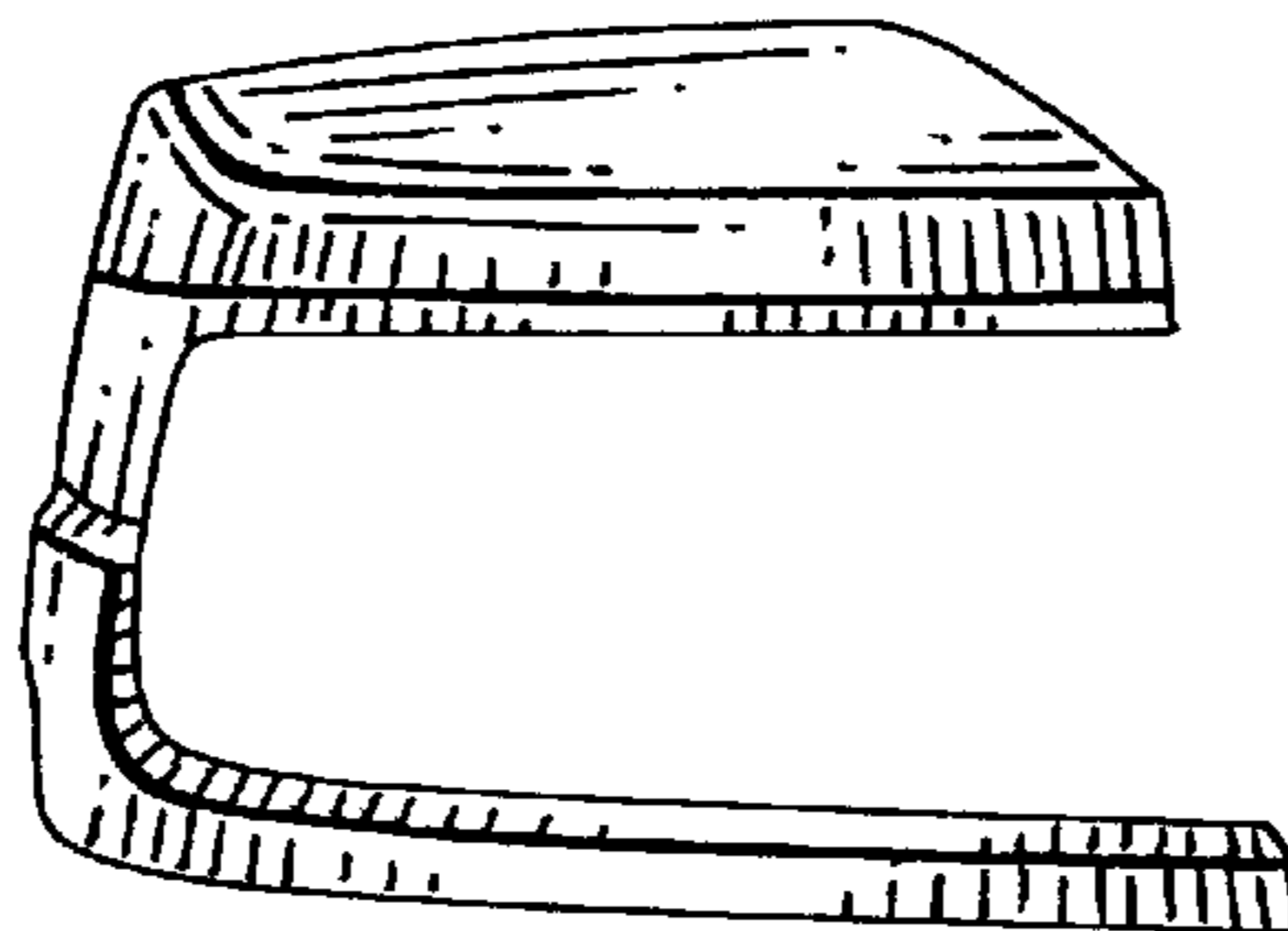

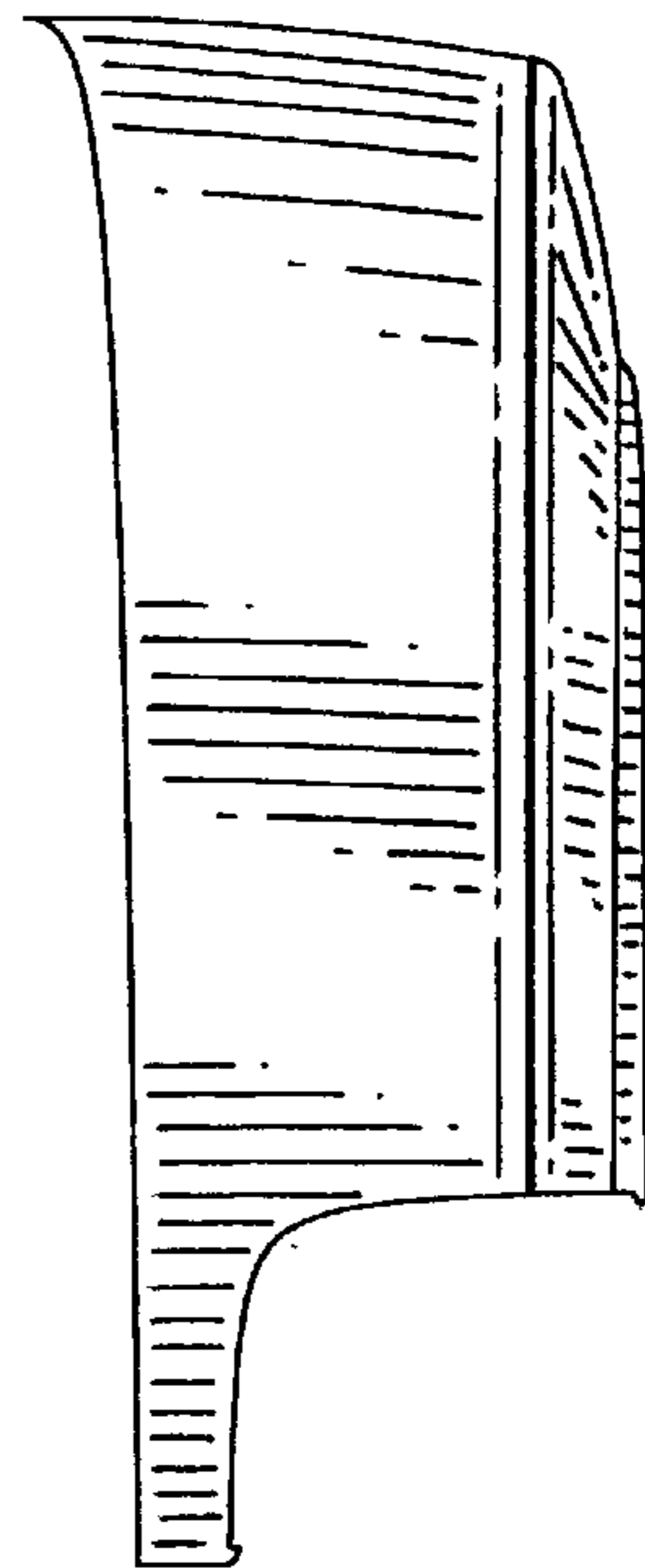

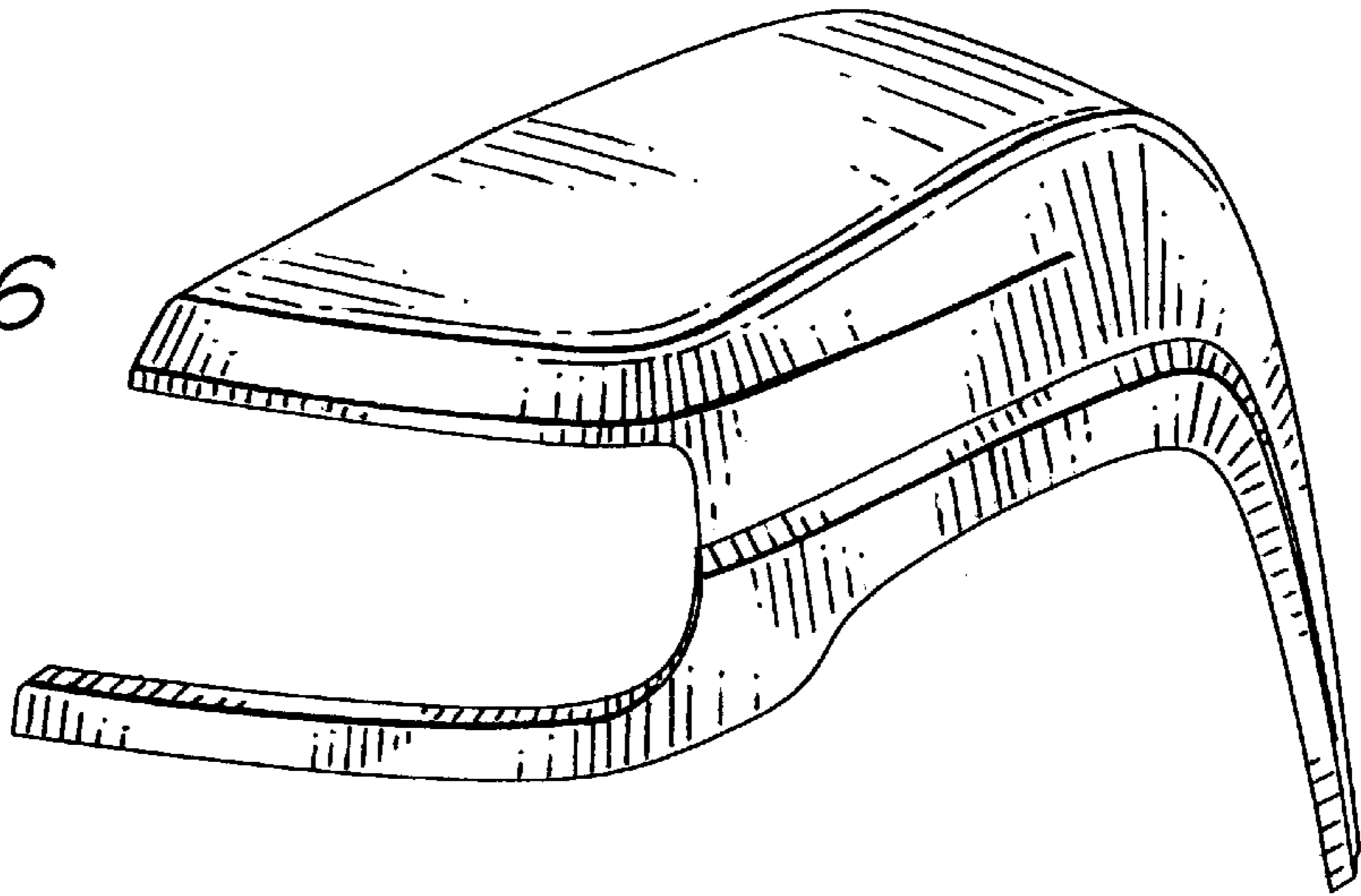

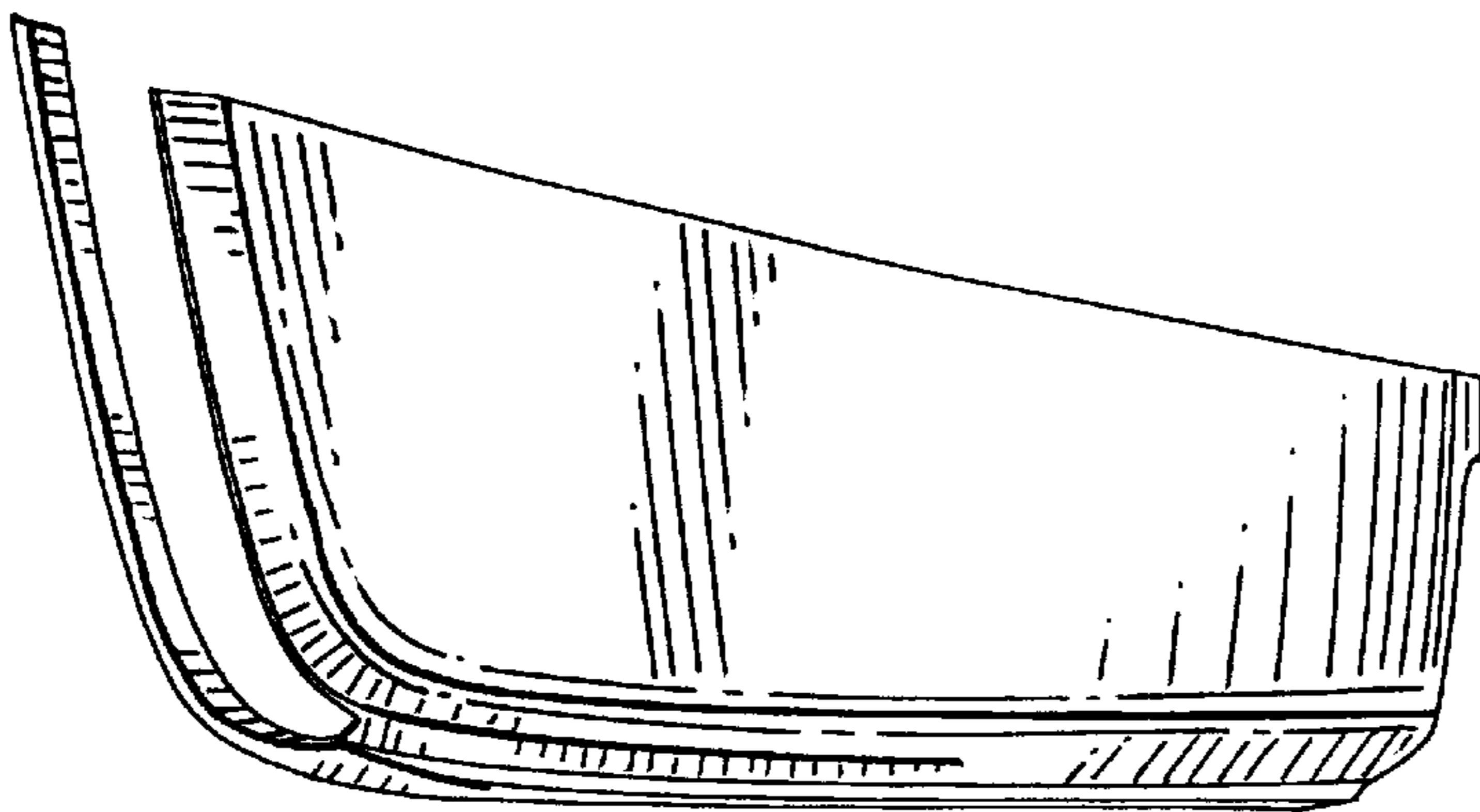

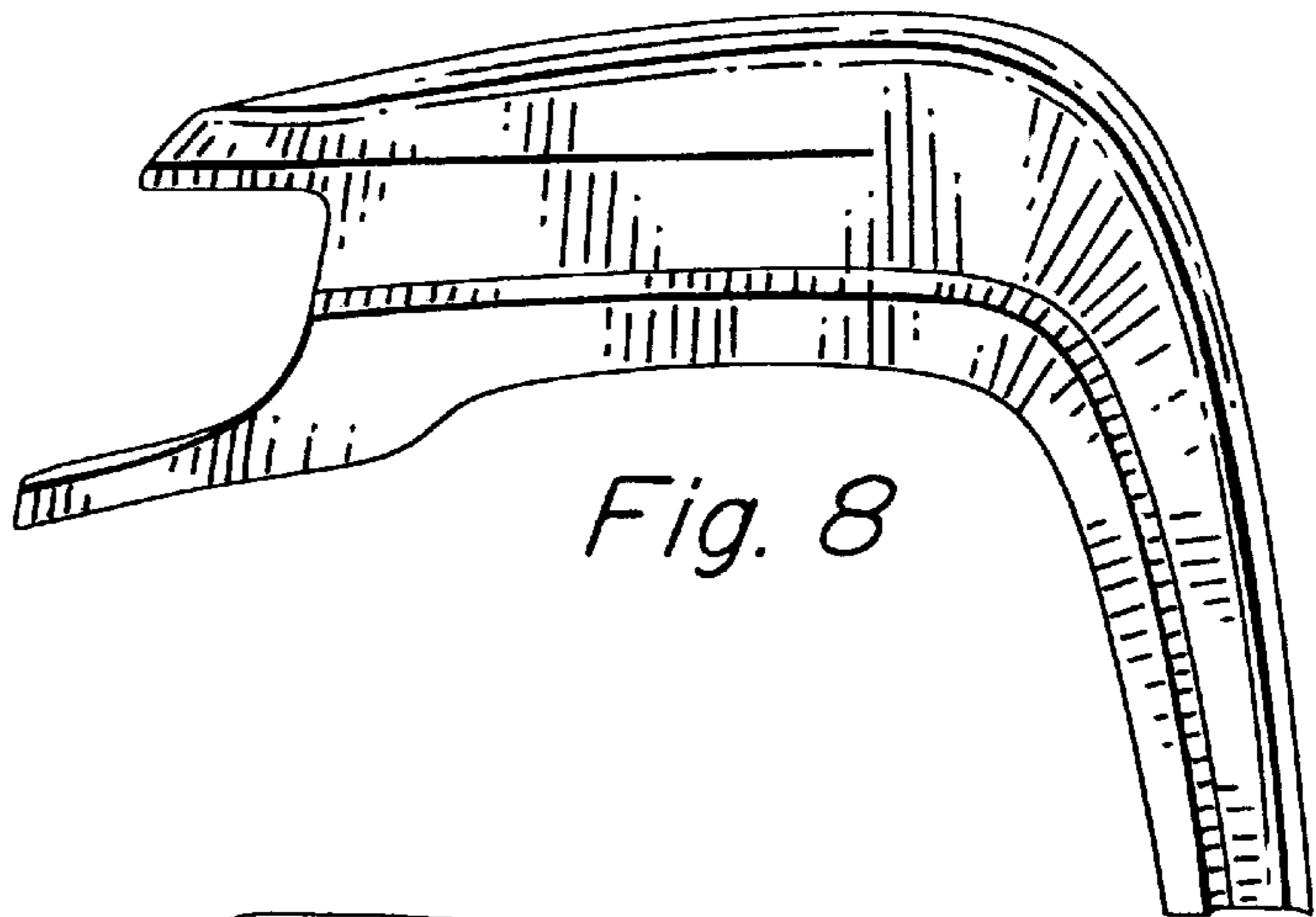

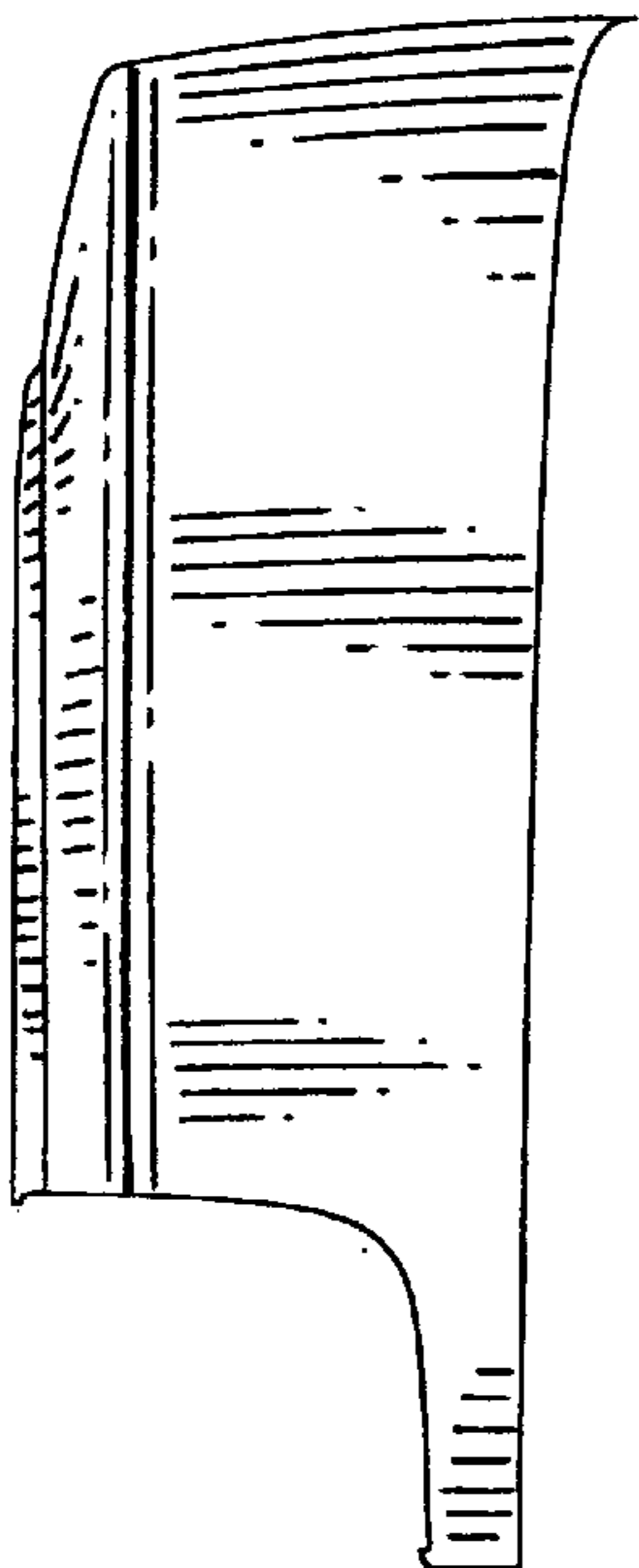
