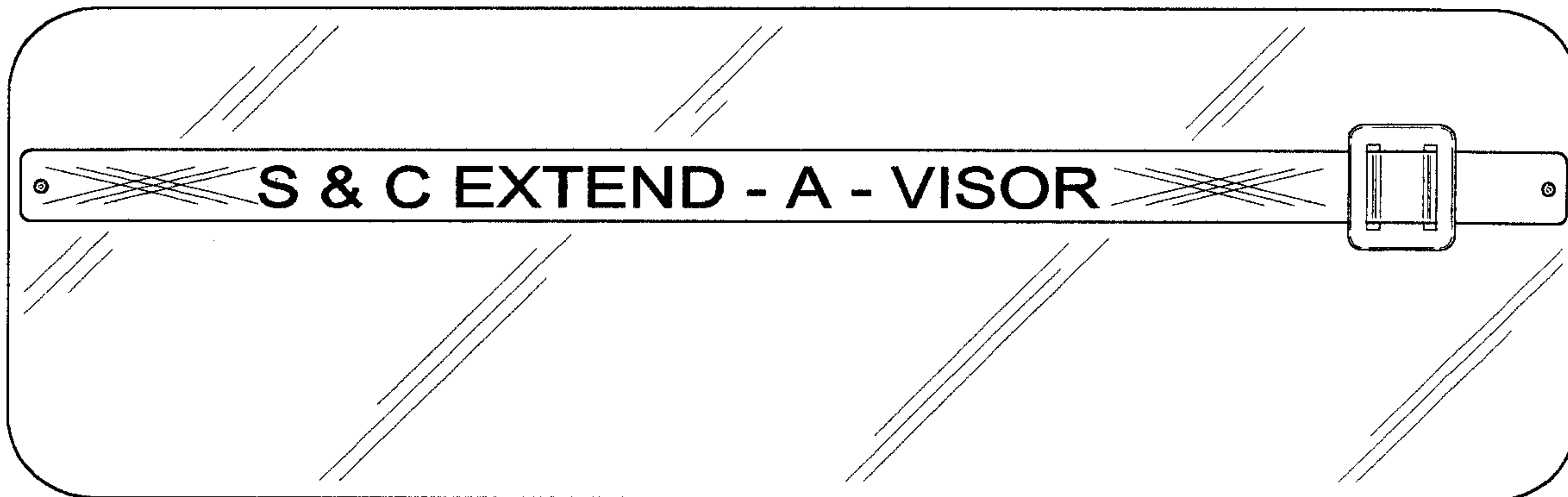
(57) **CLAIM**

The ornamental design for a sun visor extension, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a sun visor extension showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a side view, taken from the left side of FIG. 1, the right side view being a mirror image thereof; and,  
FIG. 4 is a bottom plan view thereof, the top plan view being a mirror image thereof.

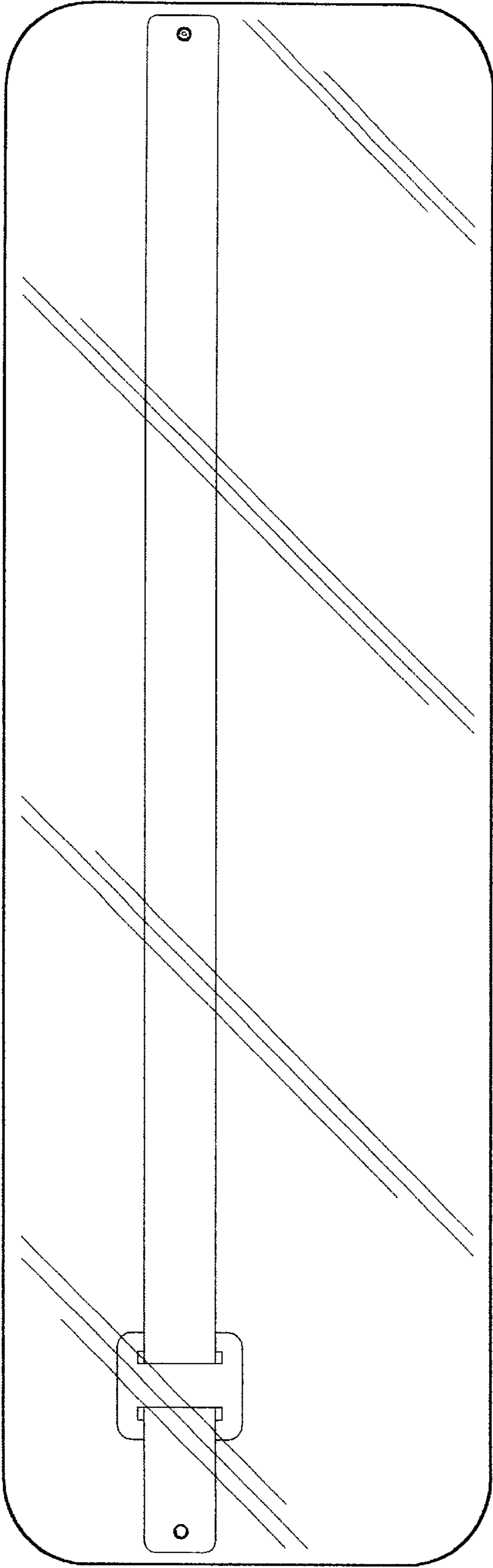
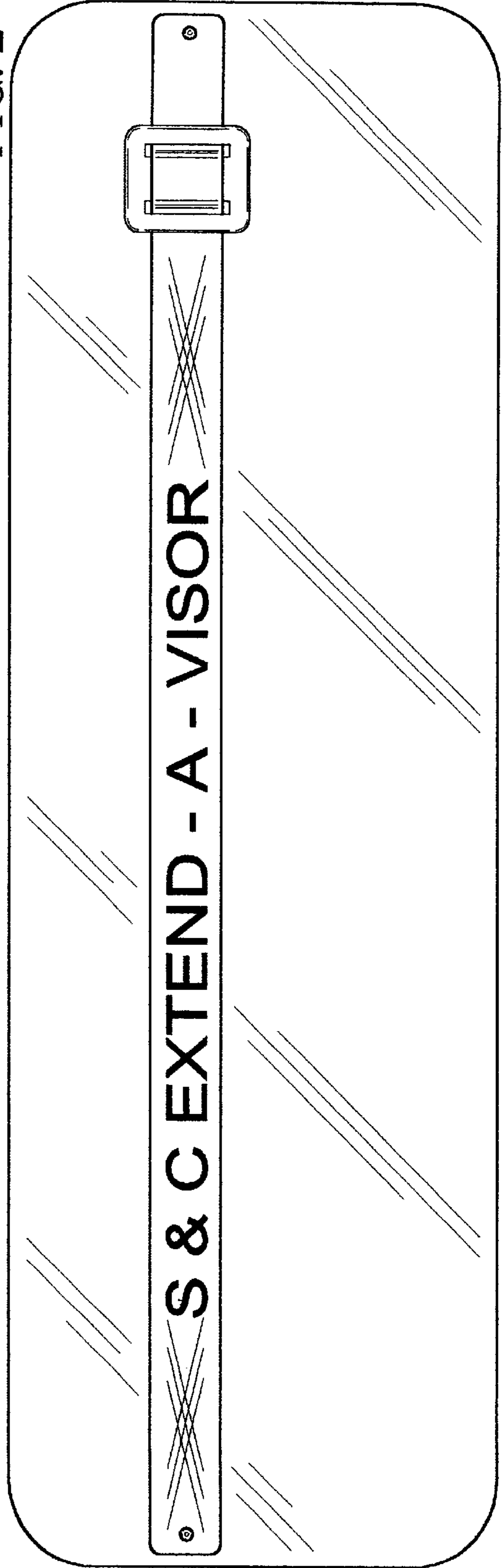

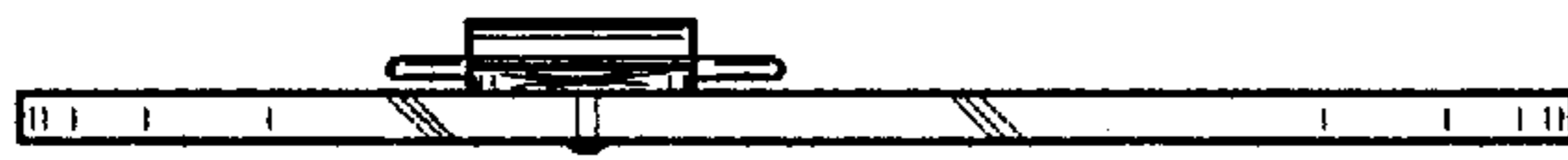

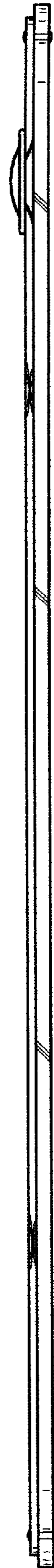
