**DESCRIPTION**

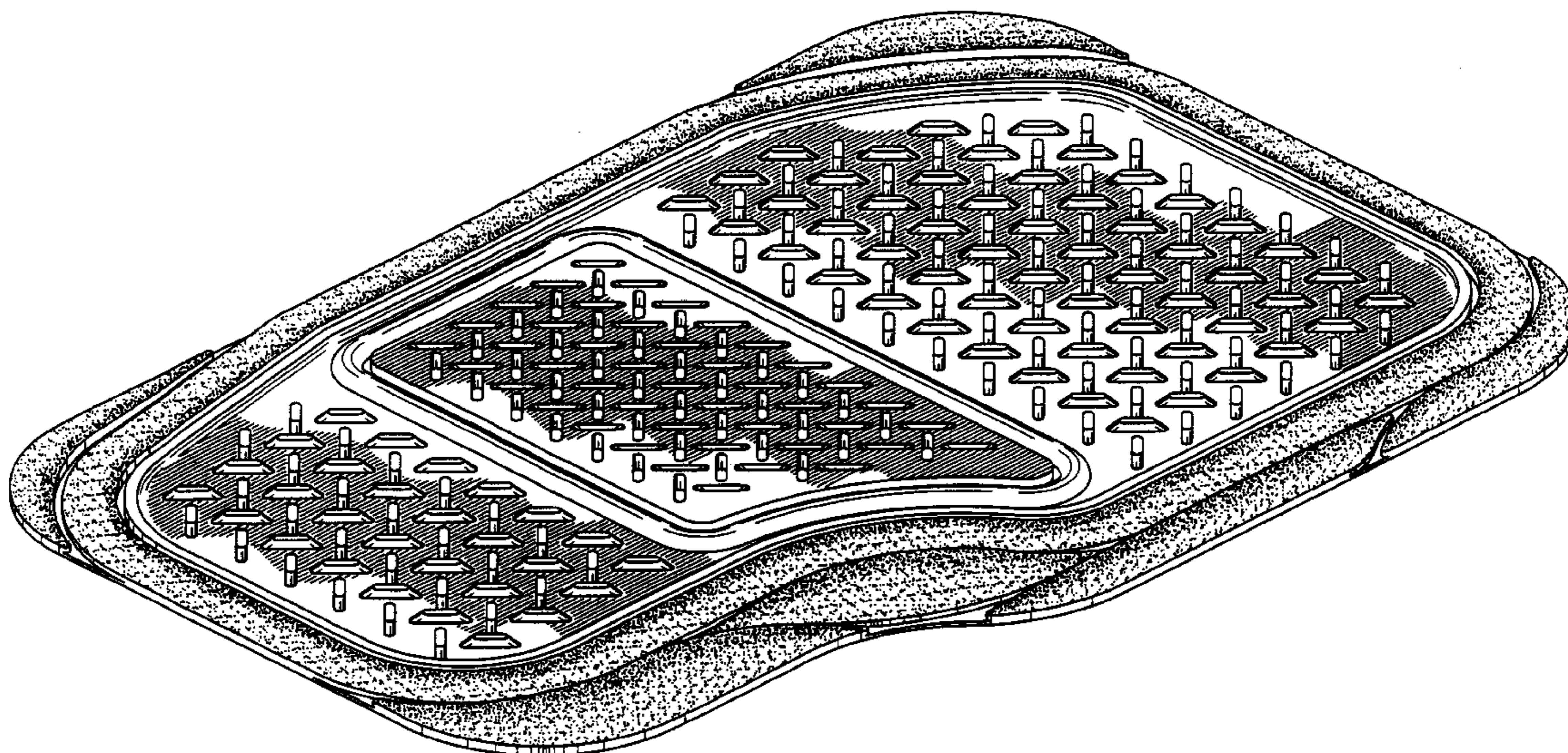
FIG. 1 is a perspective view of a floor mat for vehicles showing my new design;

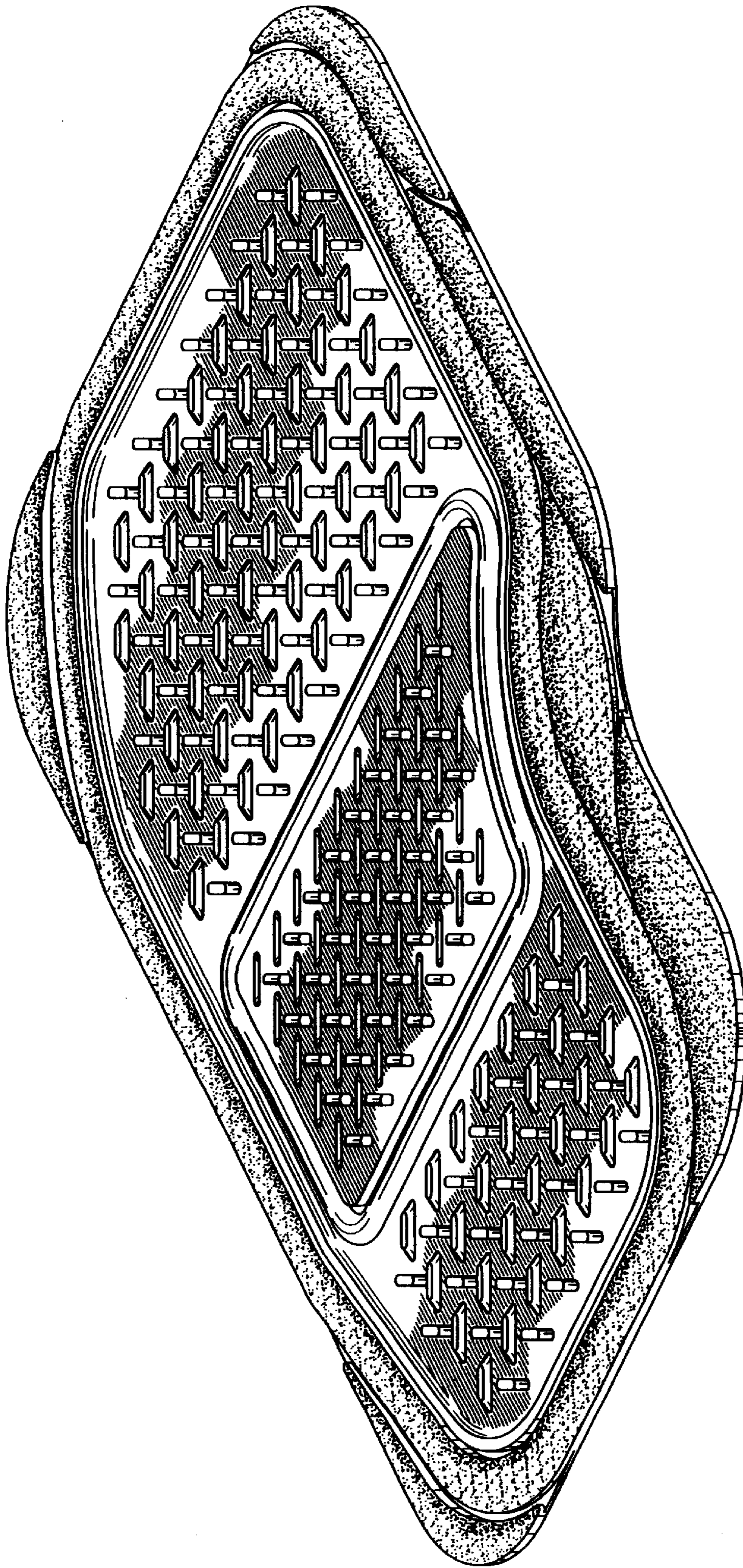

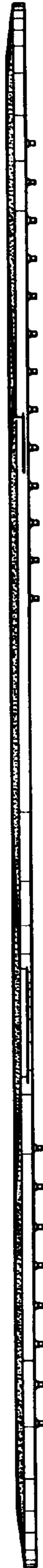

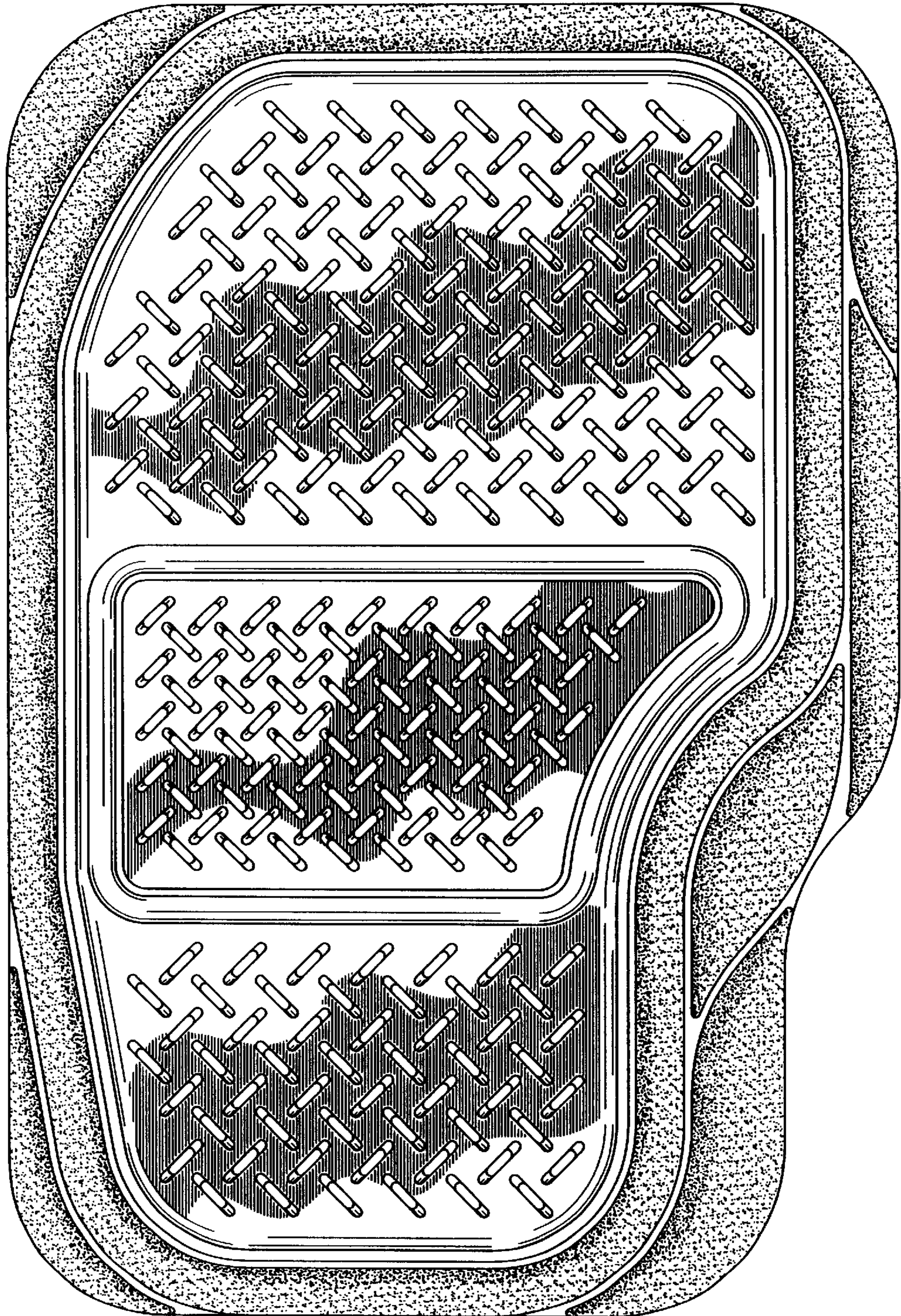

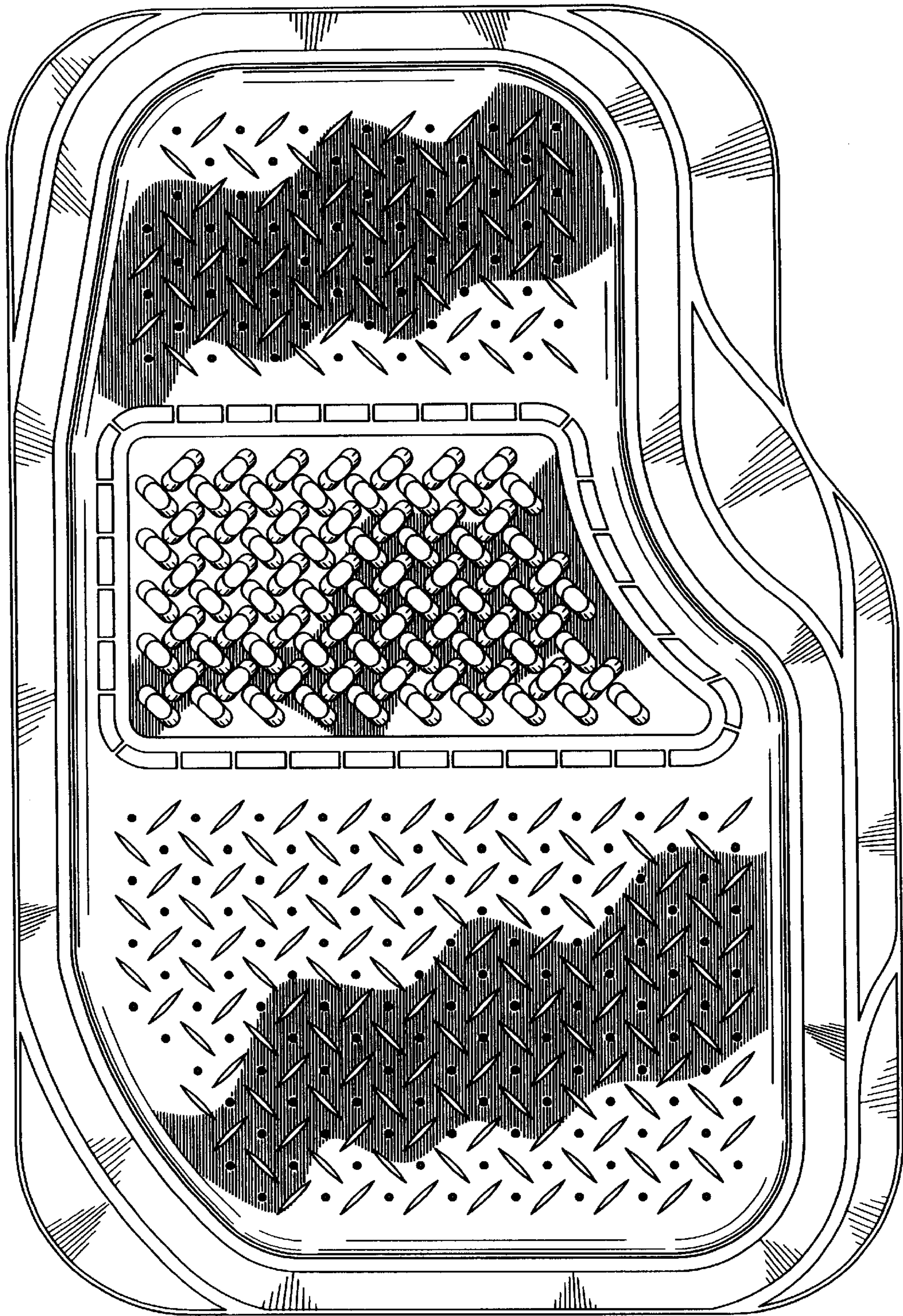
