FIG. 6 is a top plan view thereof.

FIG. 7 is a bottom plan view thereof.

FIG. 8 is a modified form of the design showing the agitator auger flighting and showing a cylindrical auger barrel in phantom lines and forming no part of the claimed design.

FIG. 9 is a front elevational view thereof.

FIG. 10 is a side elevational view taken from the right of FIG. 9.

FIG. 11 is a side elevational view taken from the left of FIG.
