FIG. 13 is a top view; and,

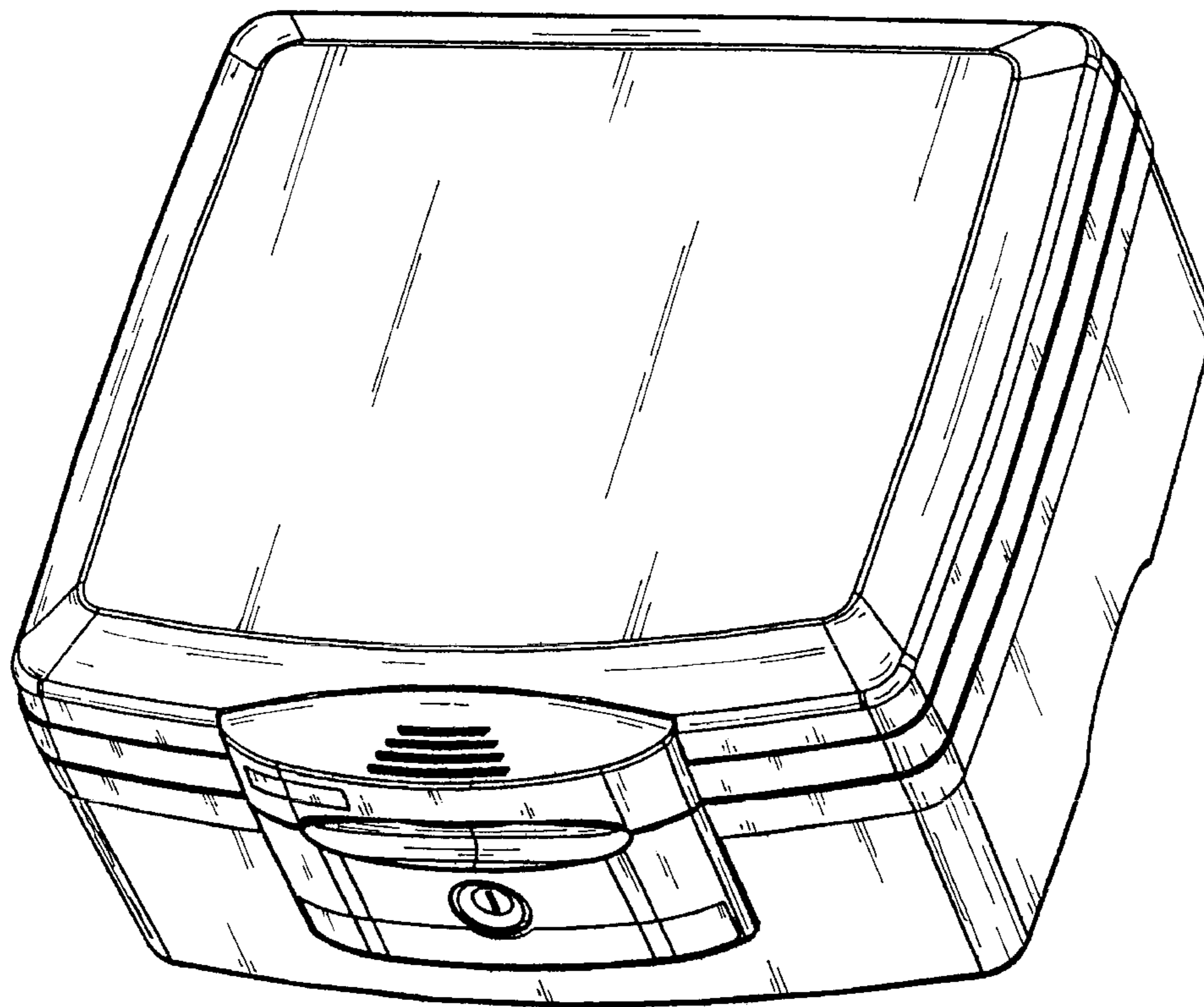
FIG. 14 is a bottom view.

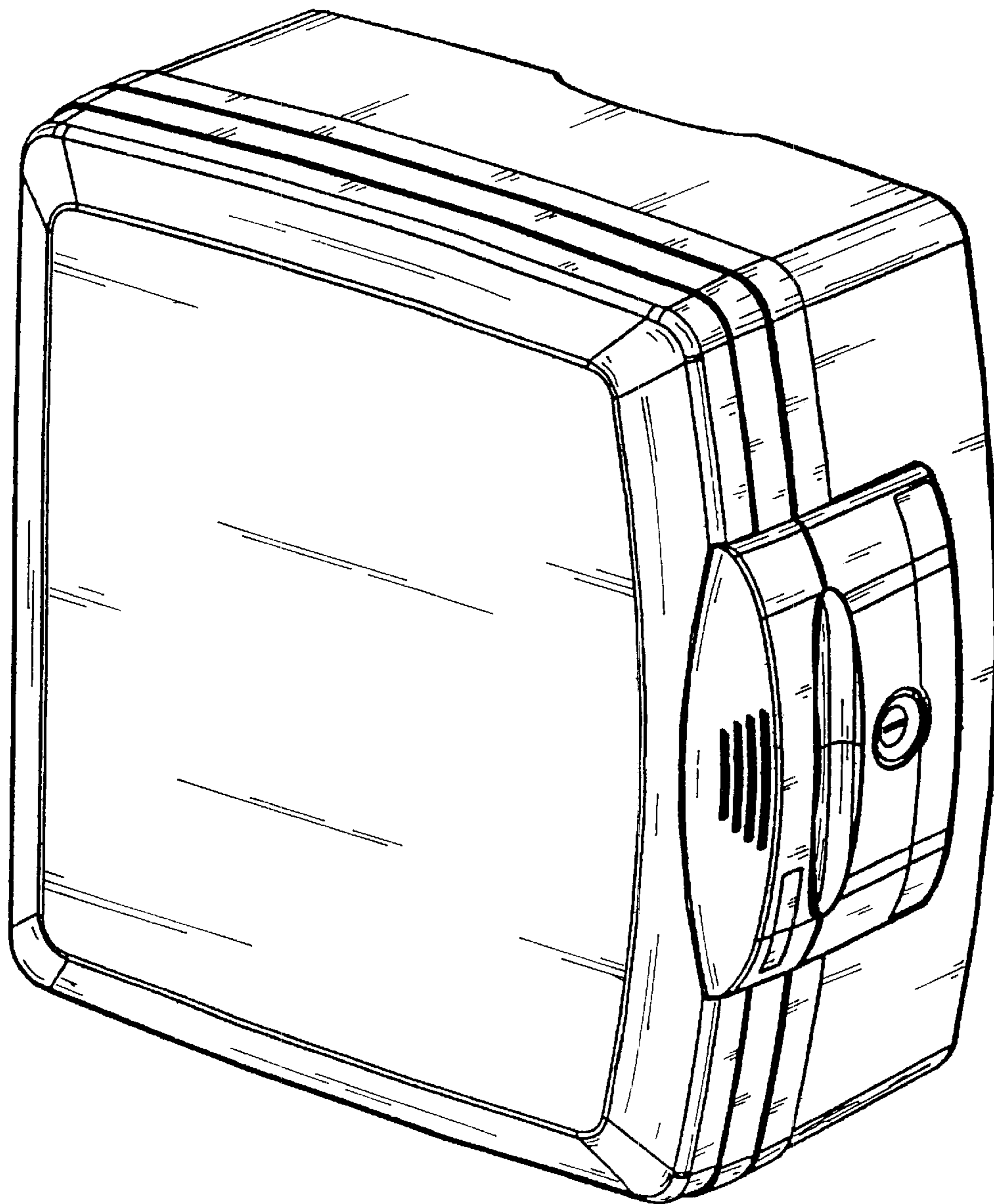

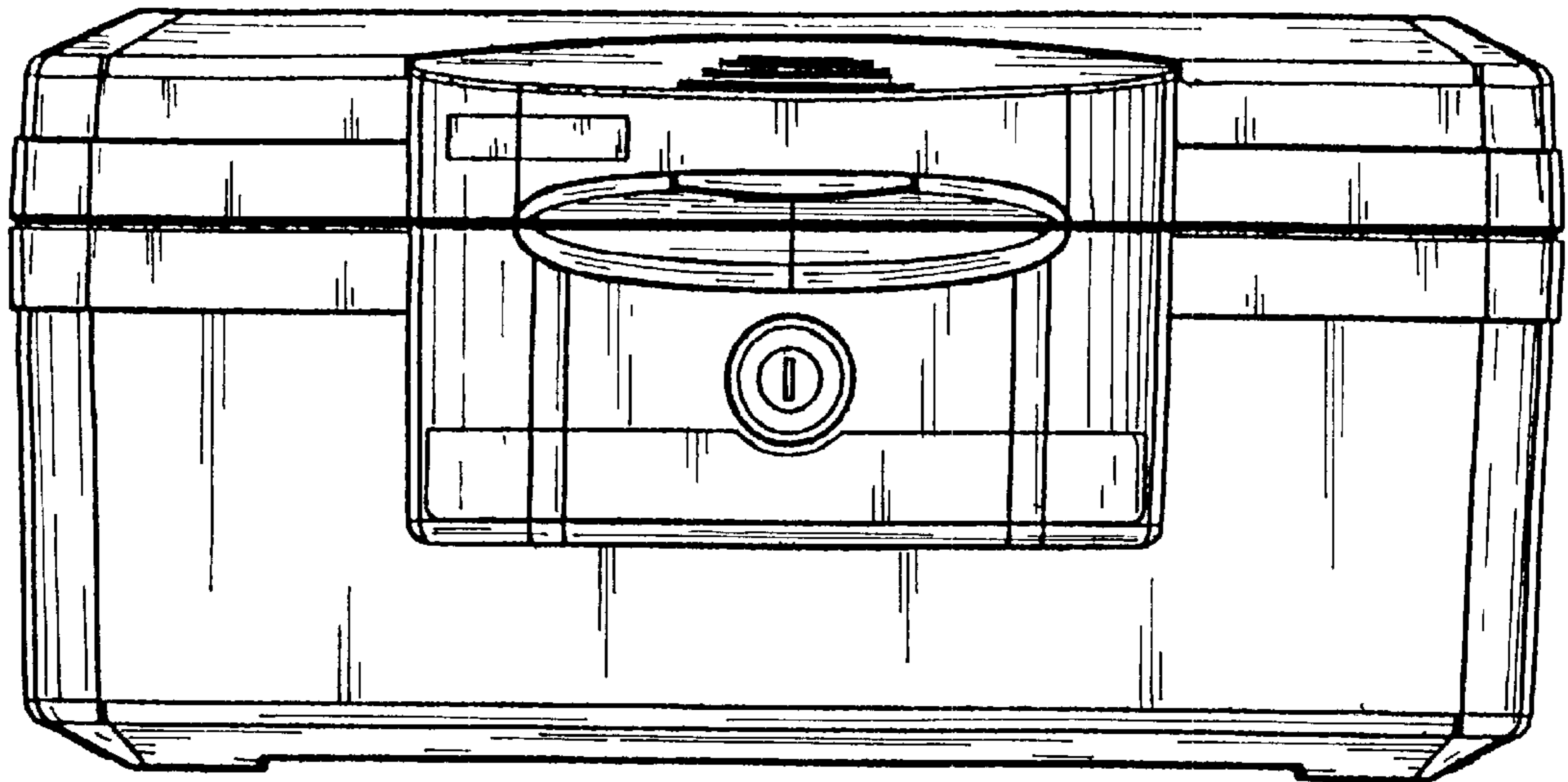

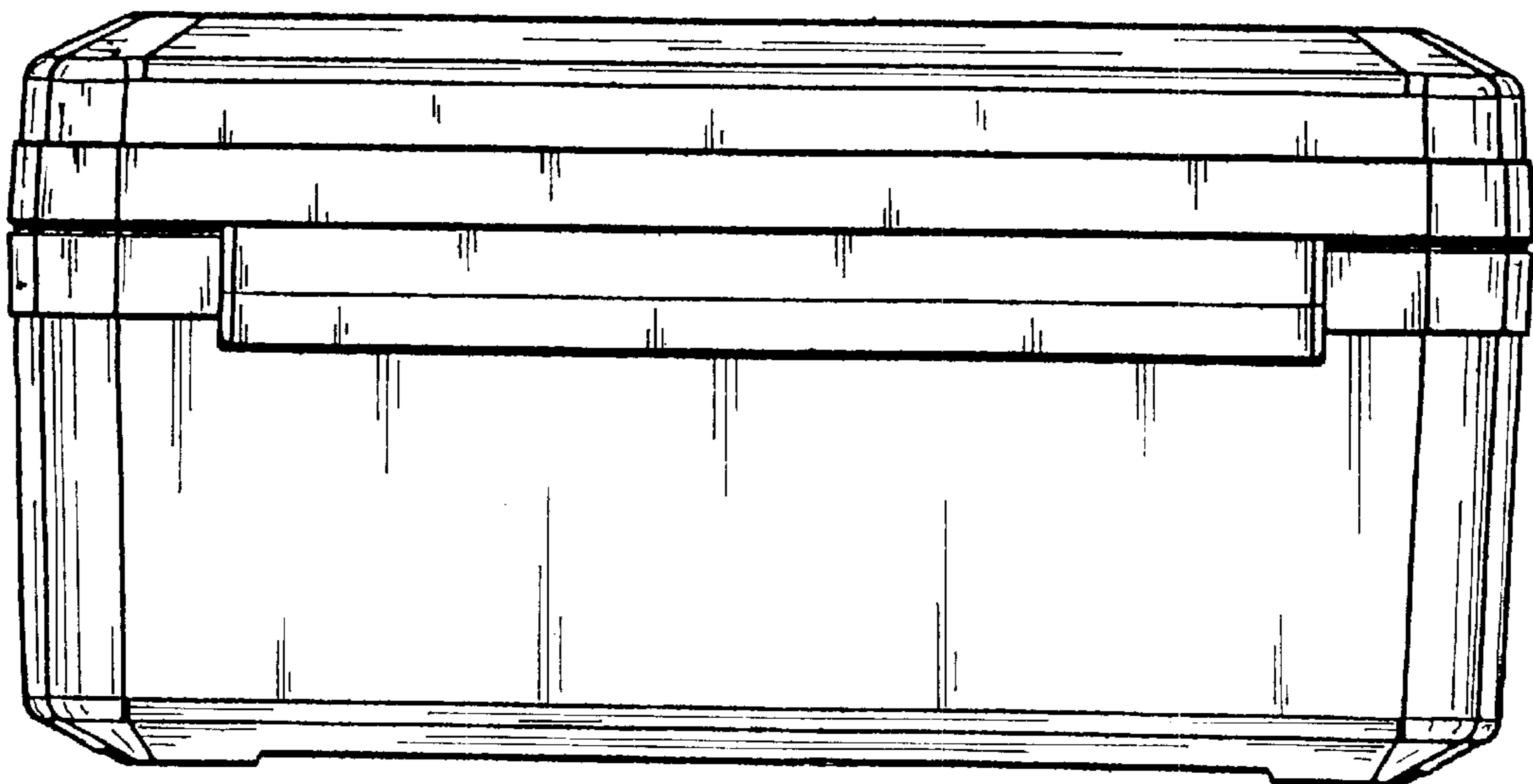

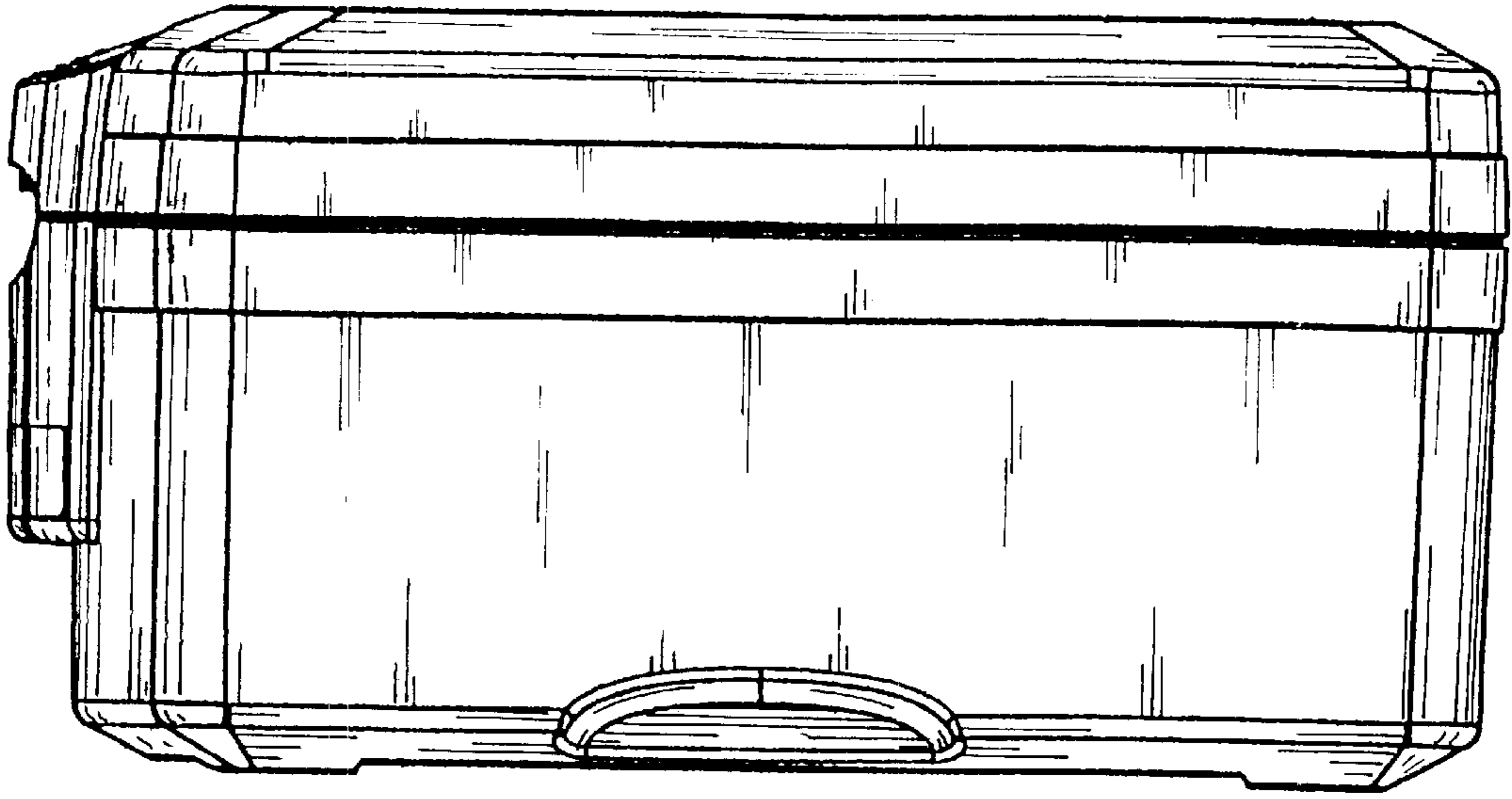

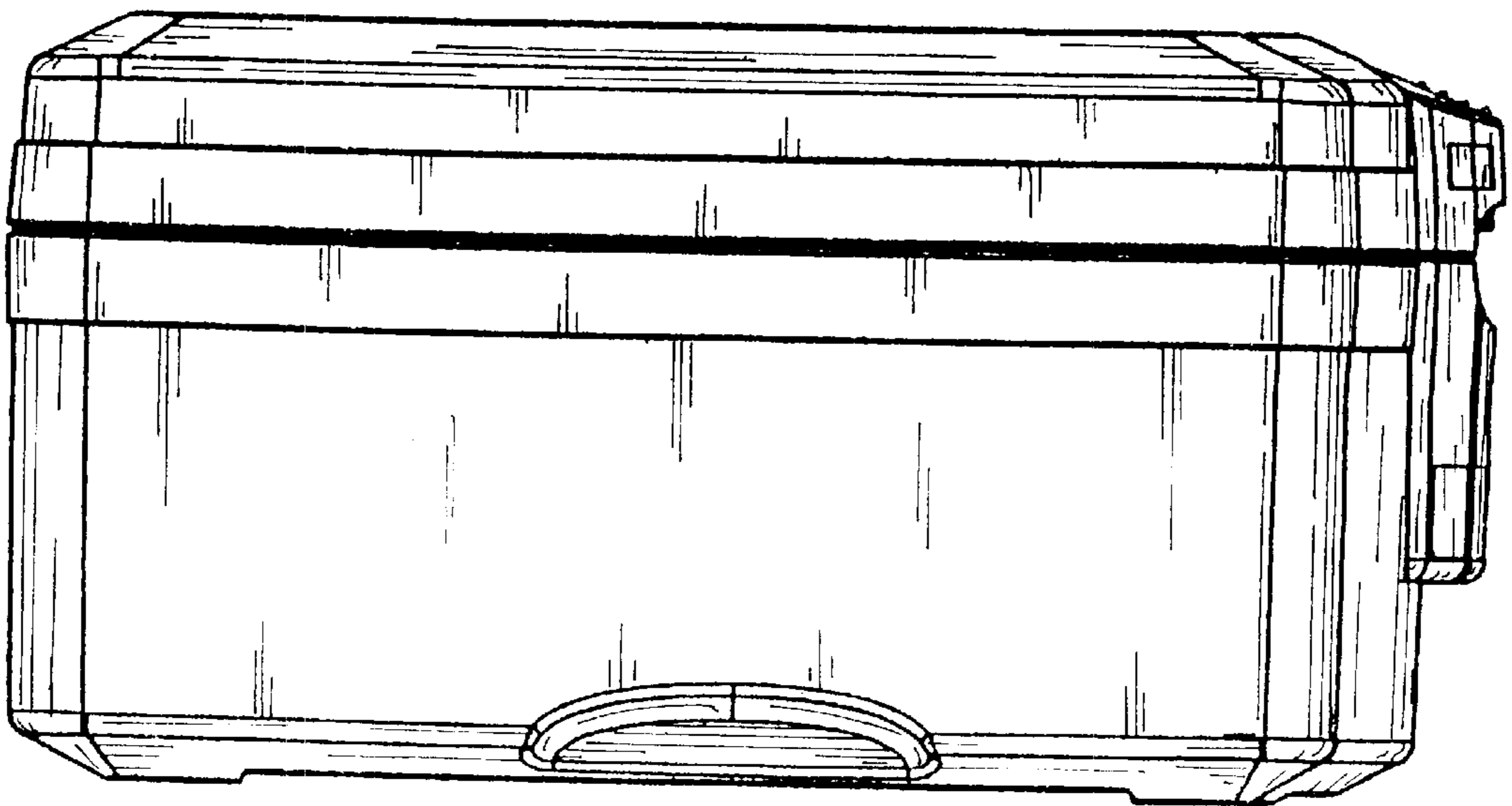

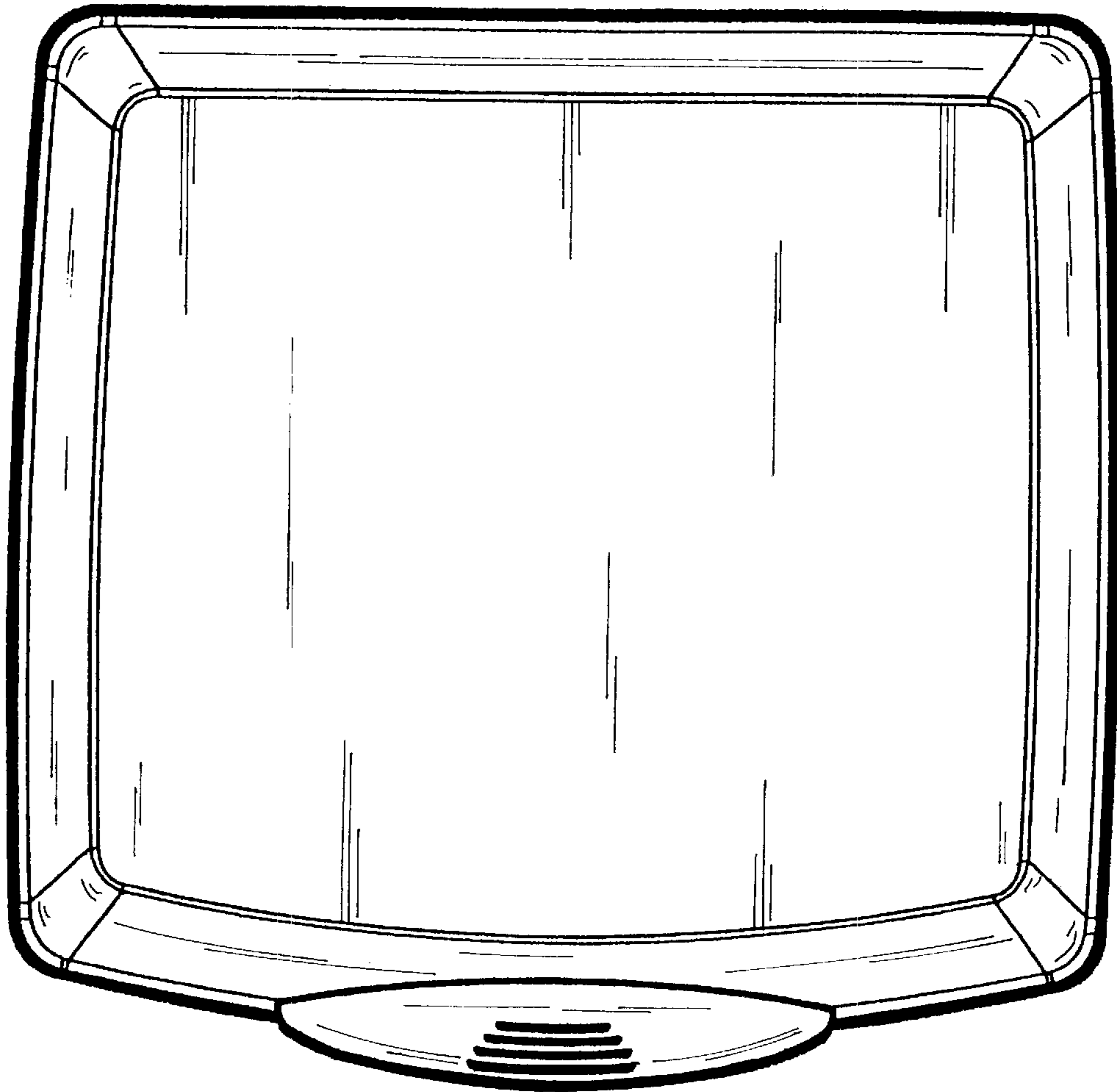

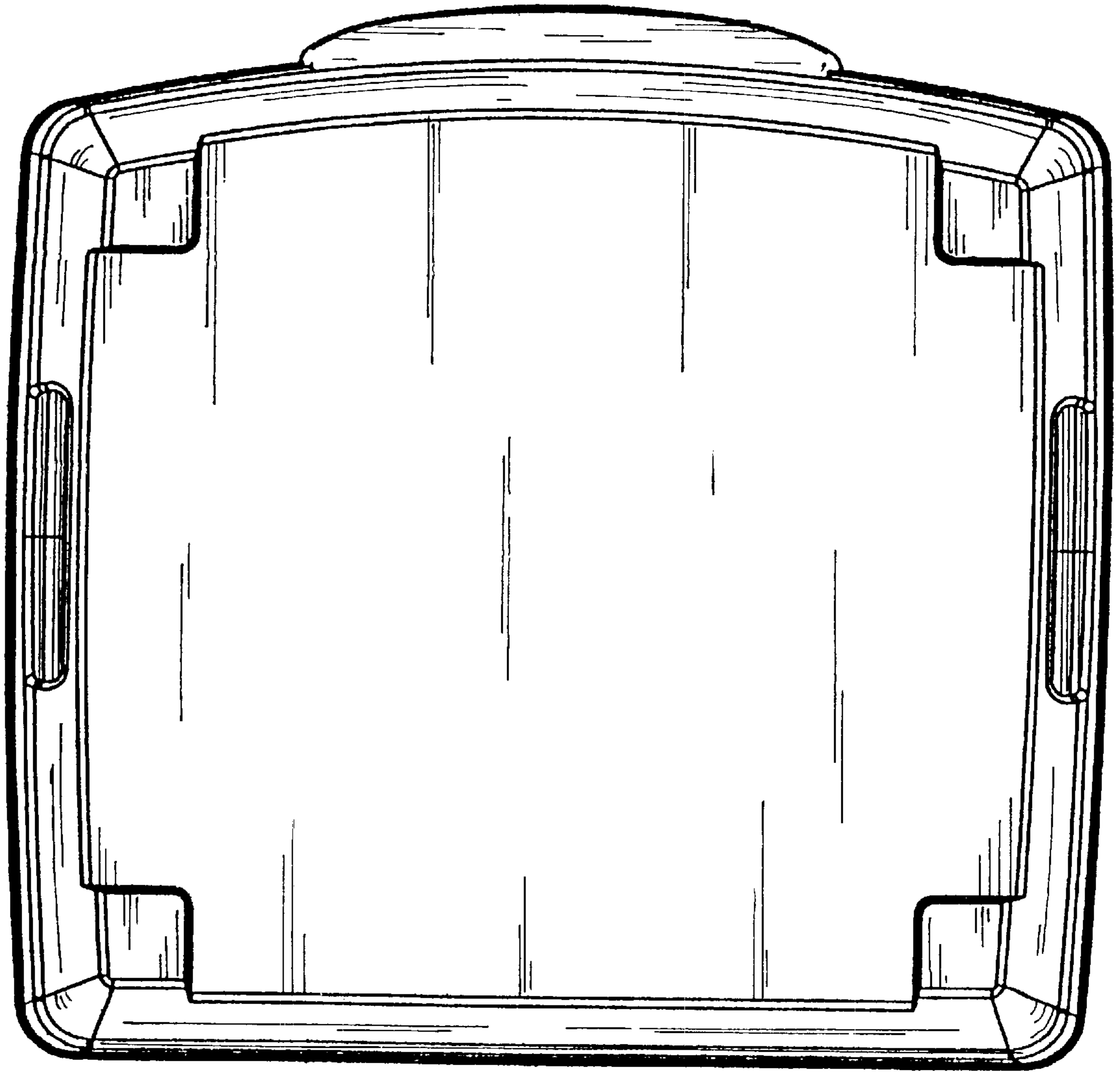

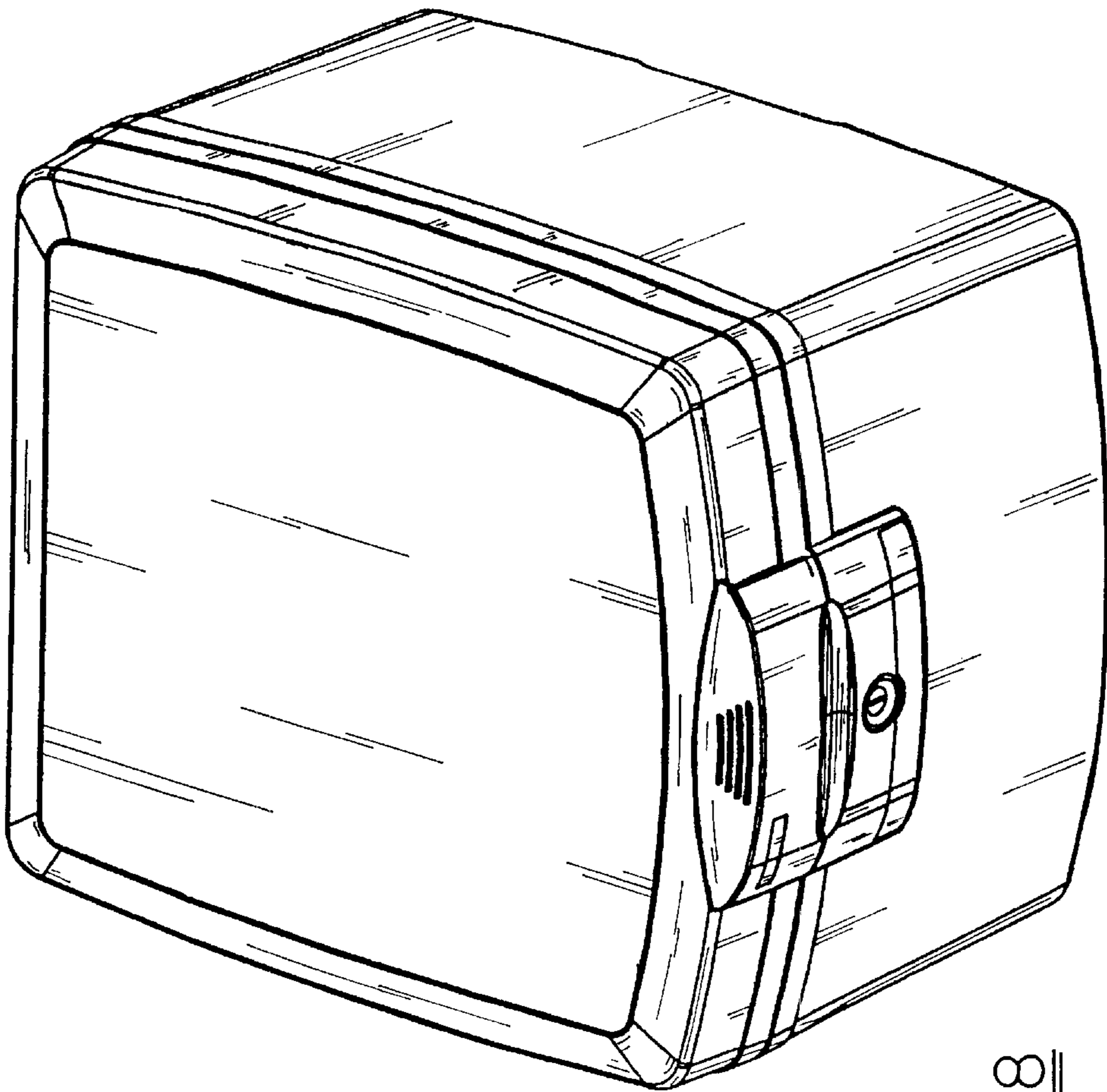

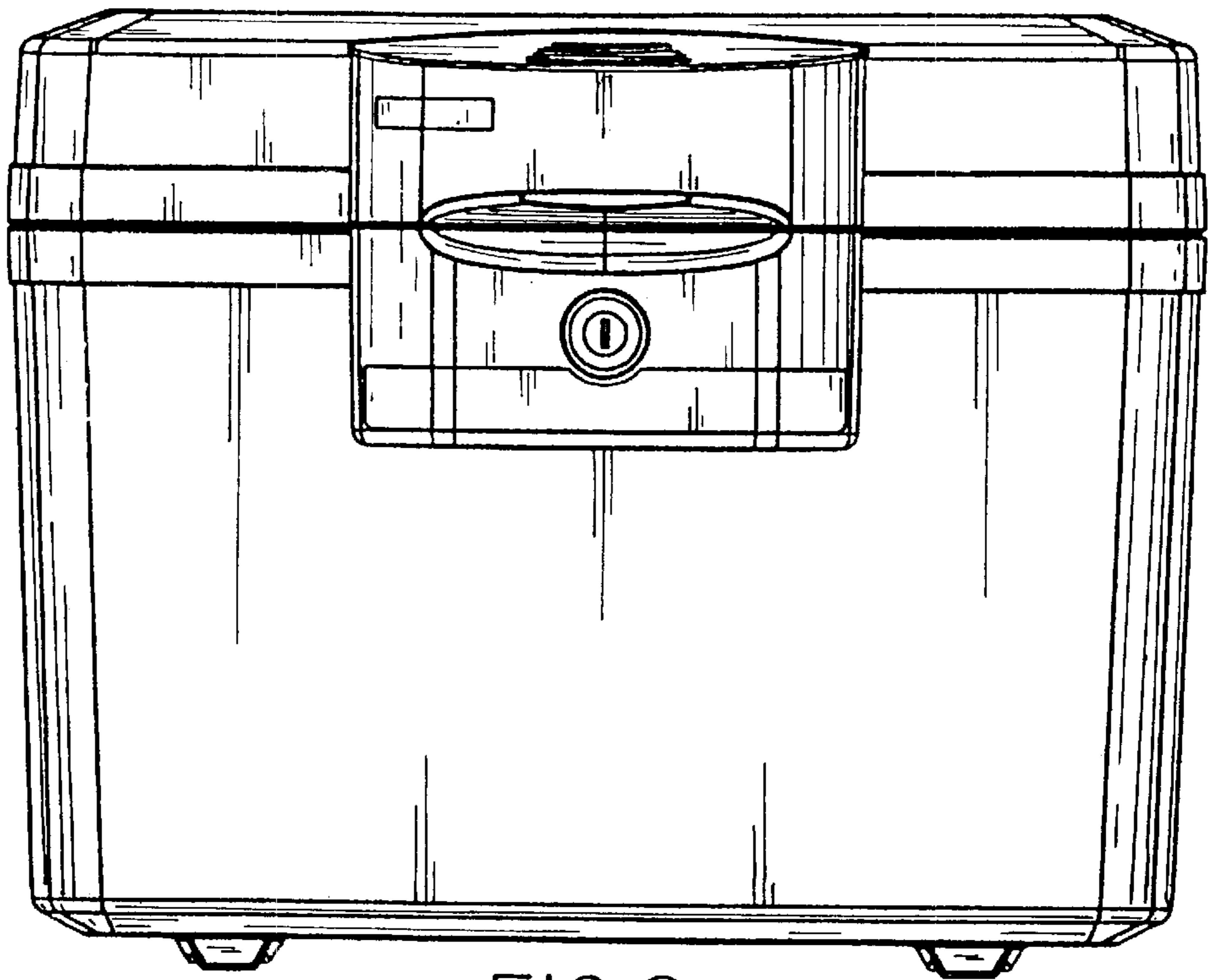

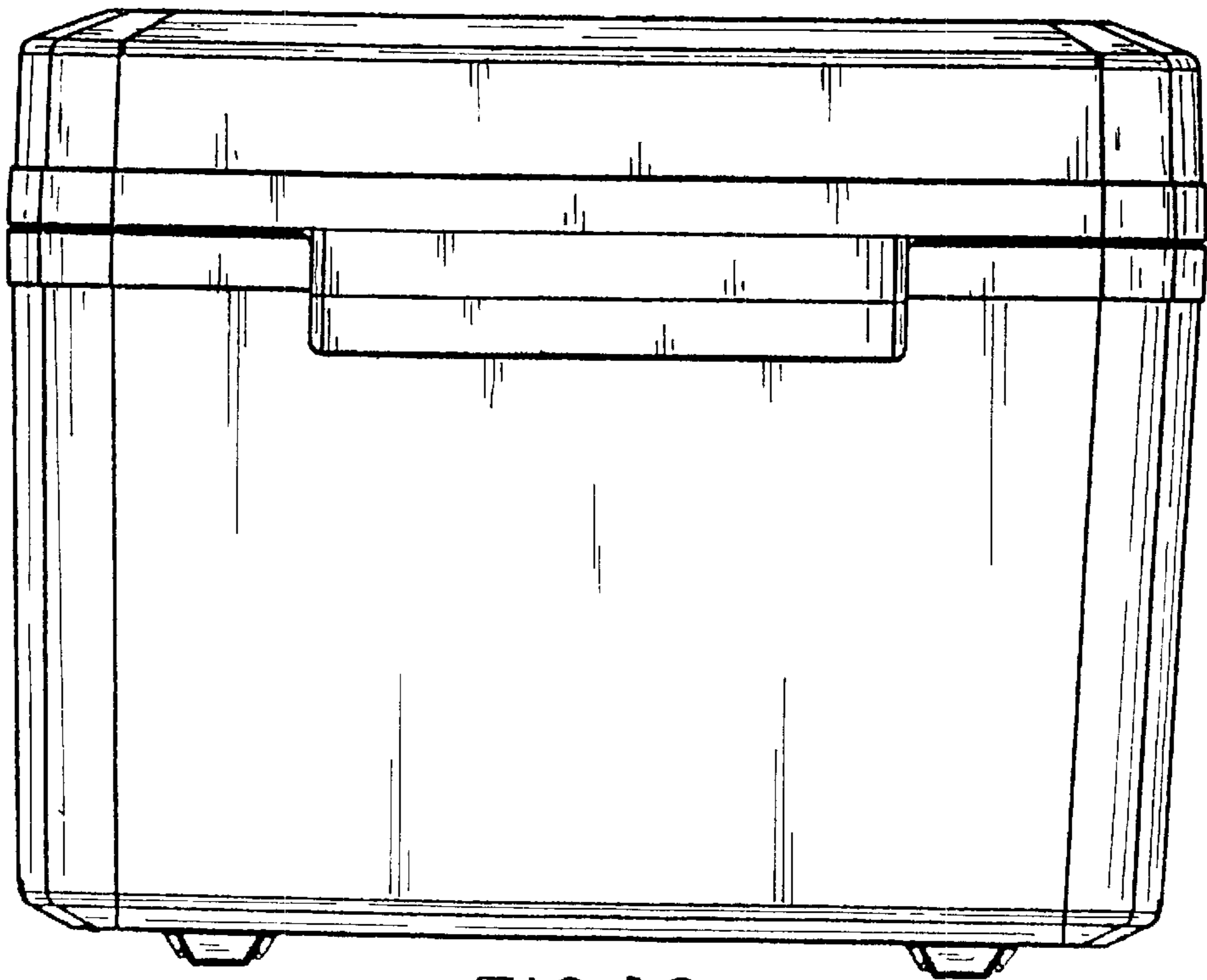

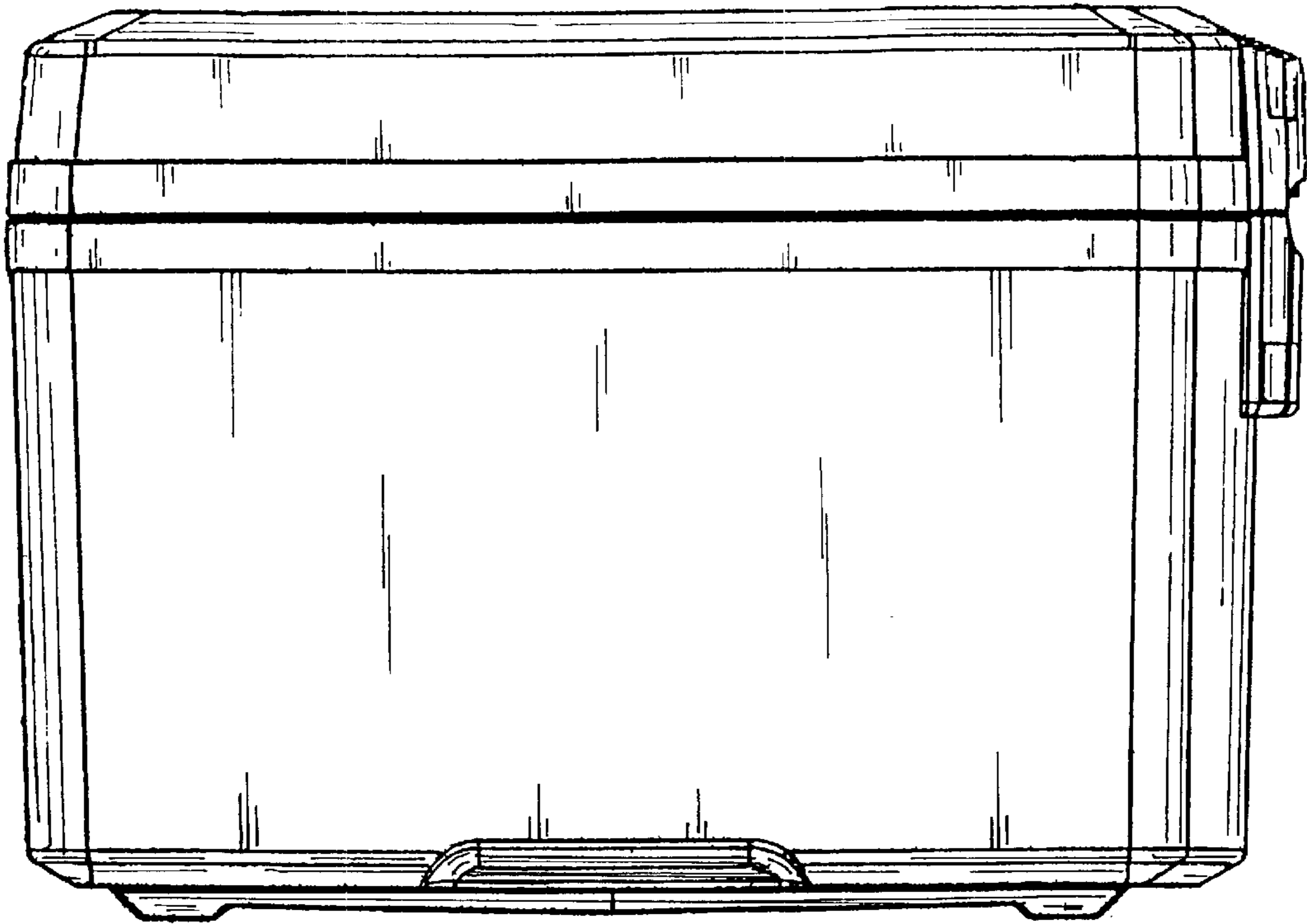

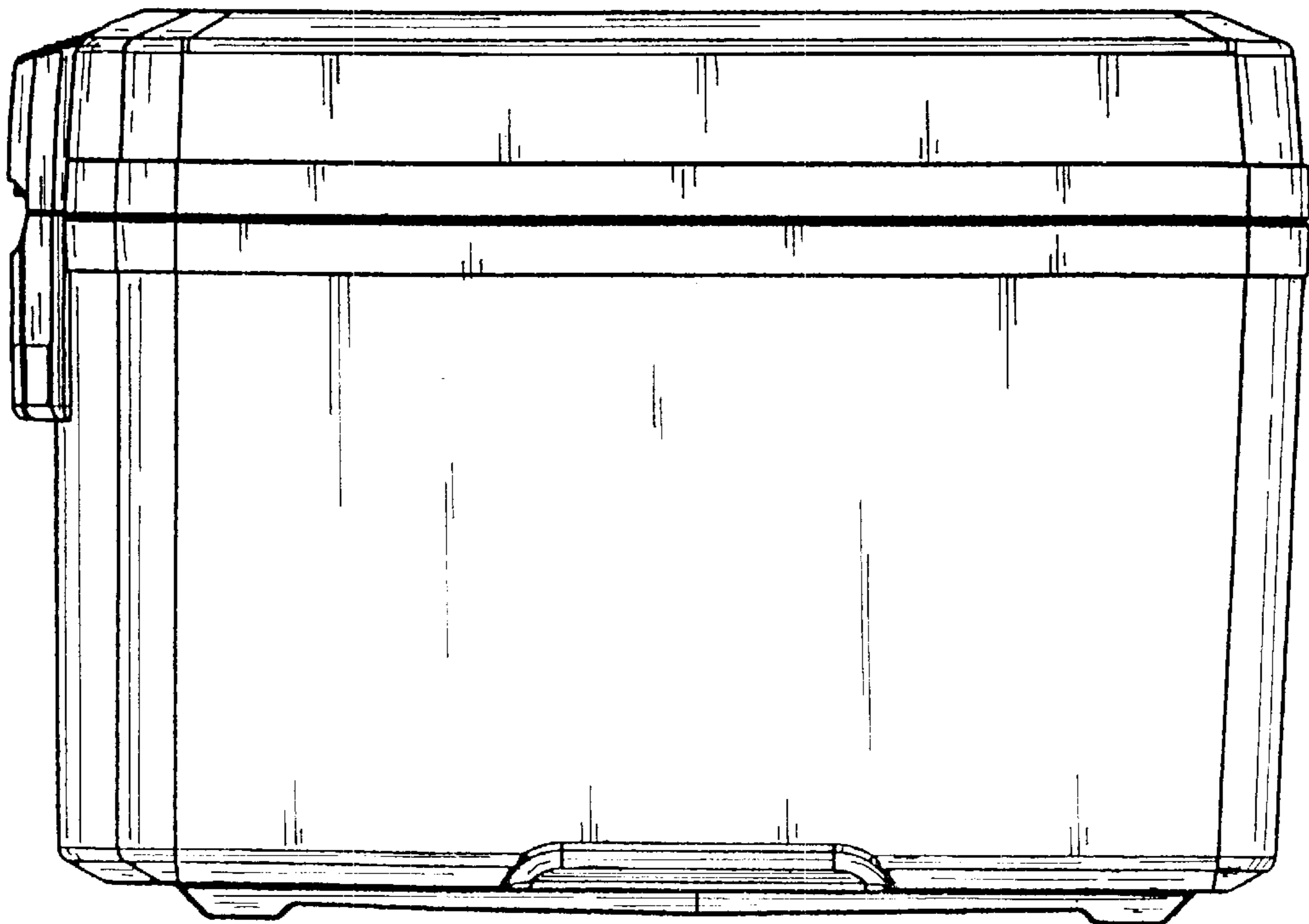

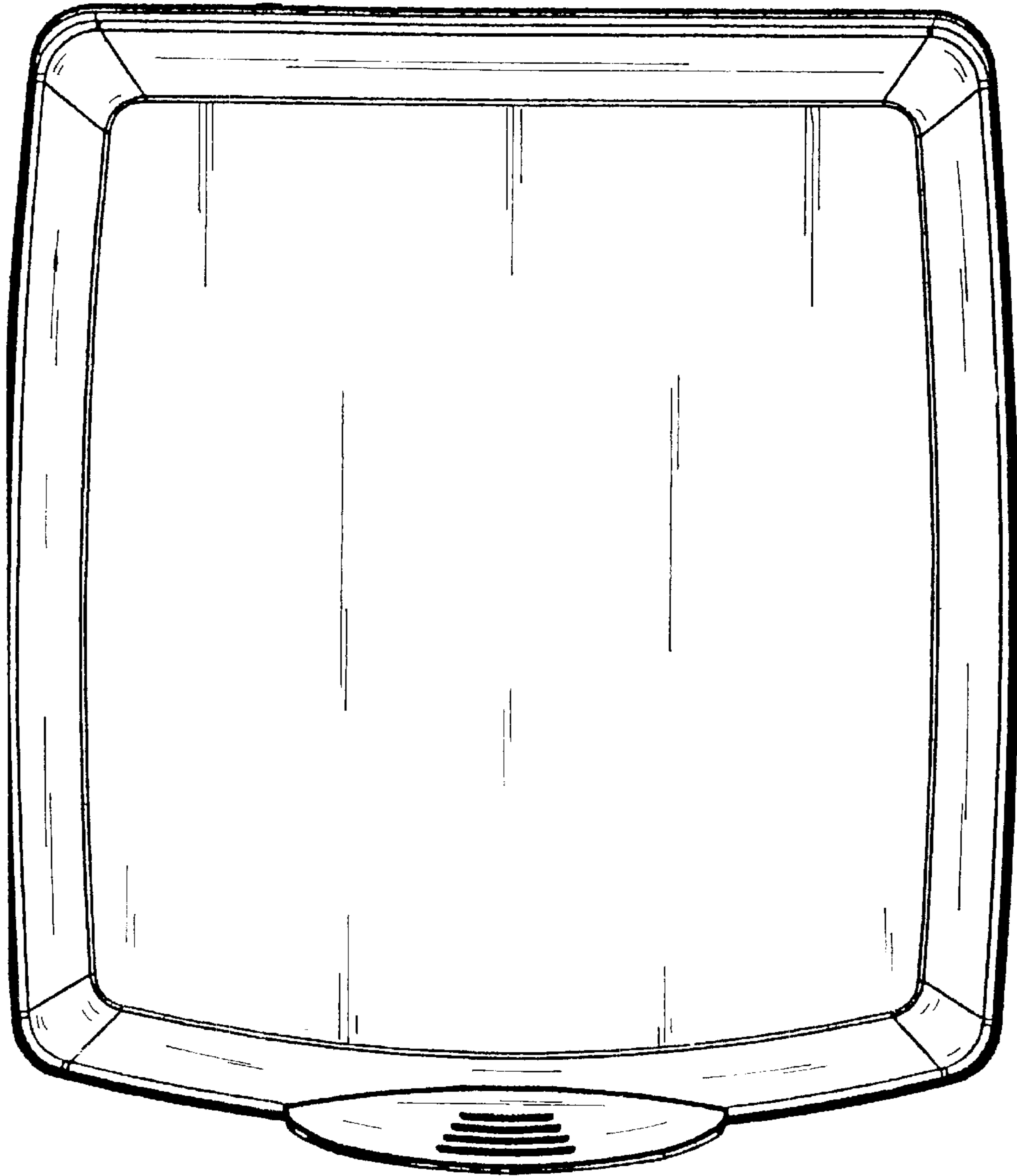

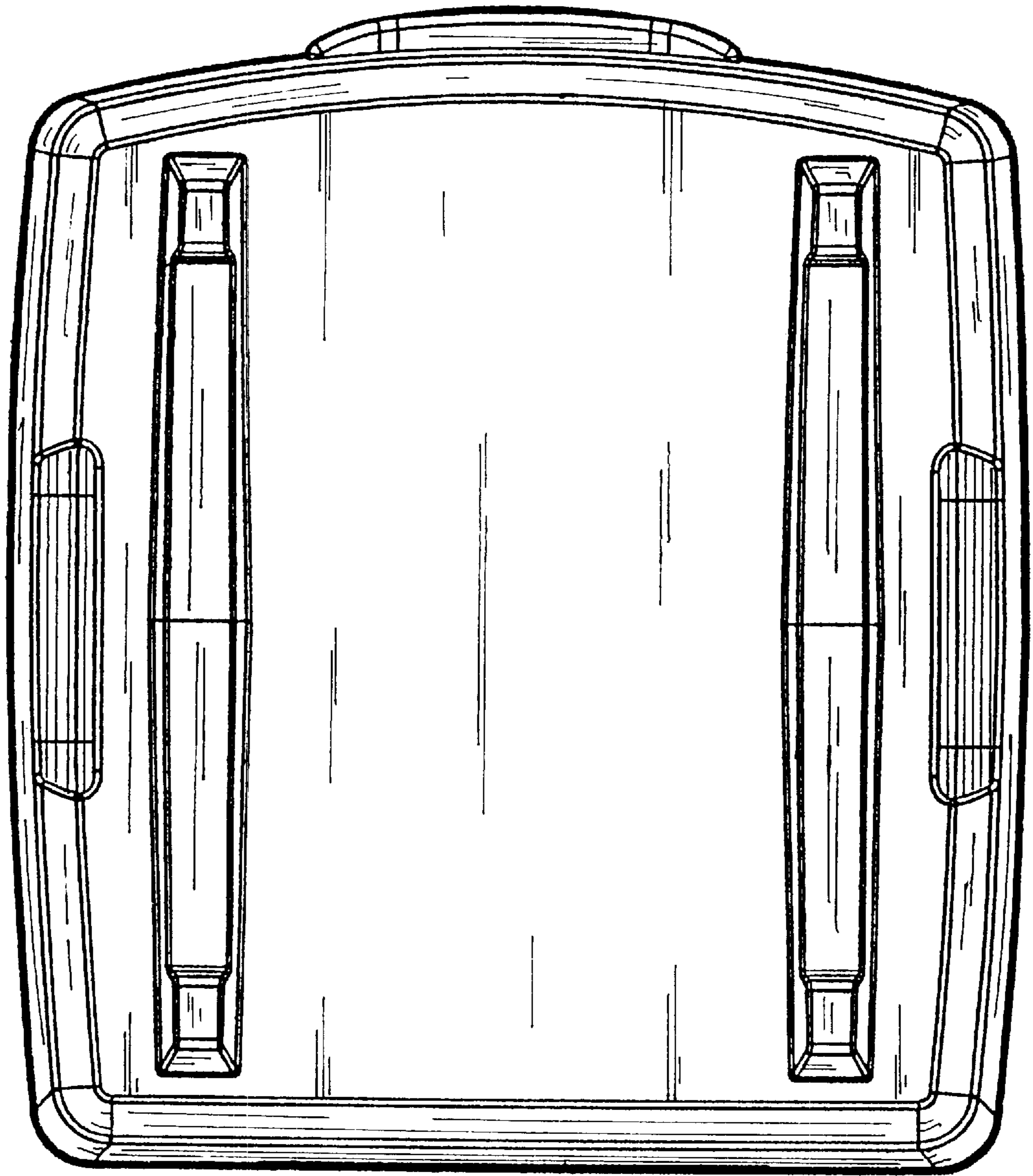
