FIG. 1 is a perspective view of a musician's stage box showing my new design, with the top and bottom covers removed and a sliding tray in the bottom compartment extended;

FIG. 2 top plan view thereof;

FIG. 5 is a rear elevation view thereof;

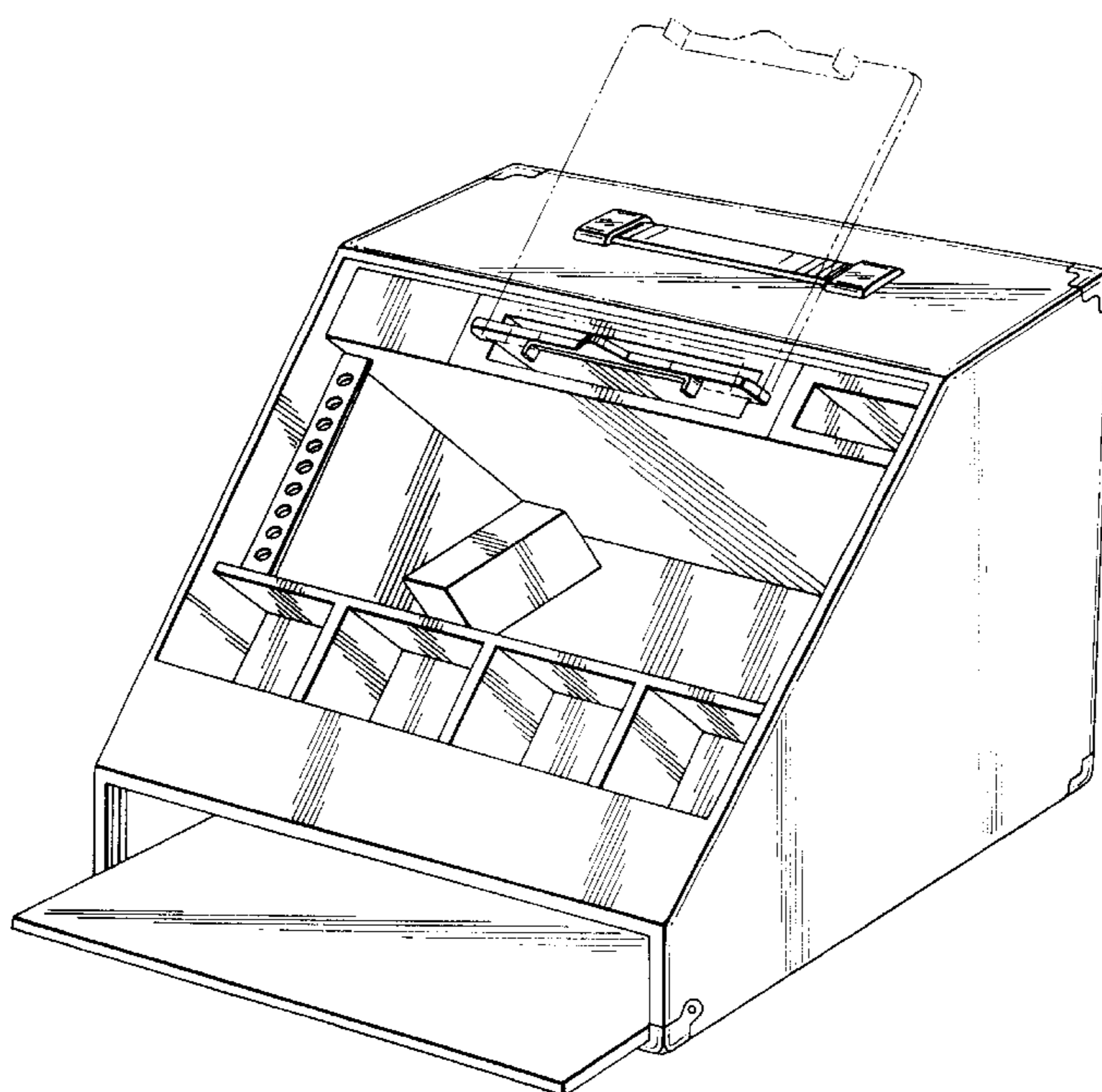
FIG. 6 is a right side elevation view thereof;

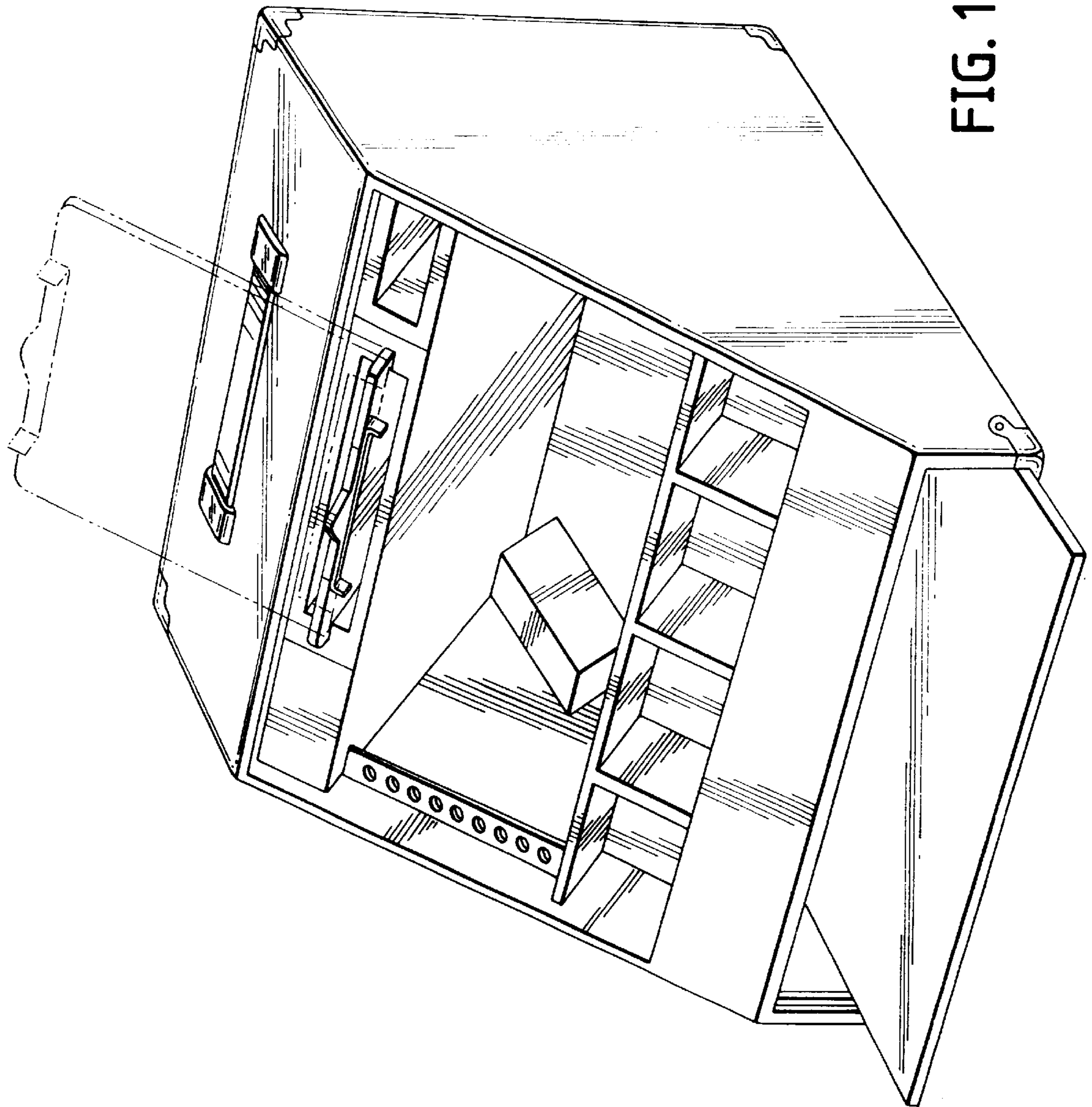

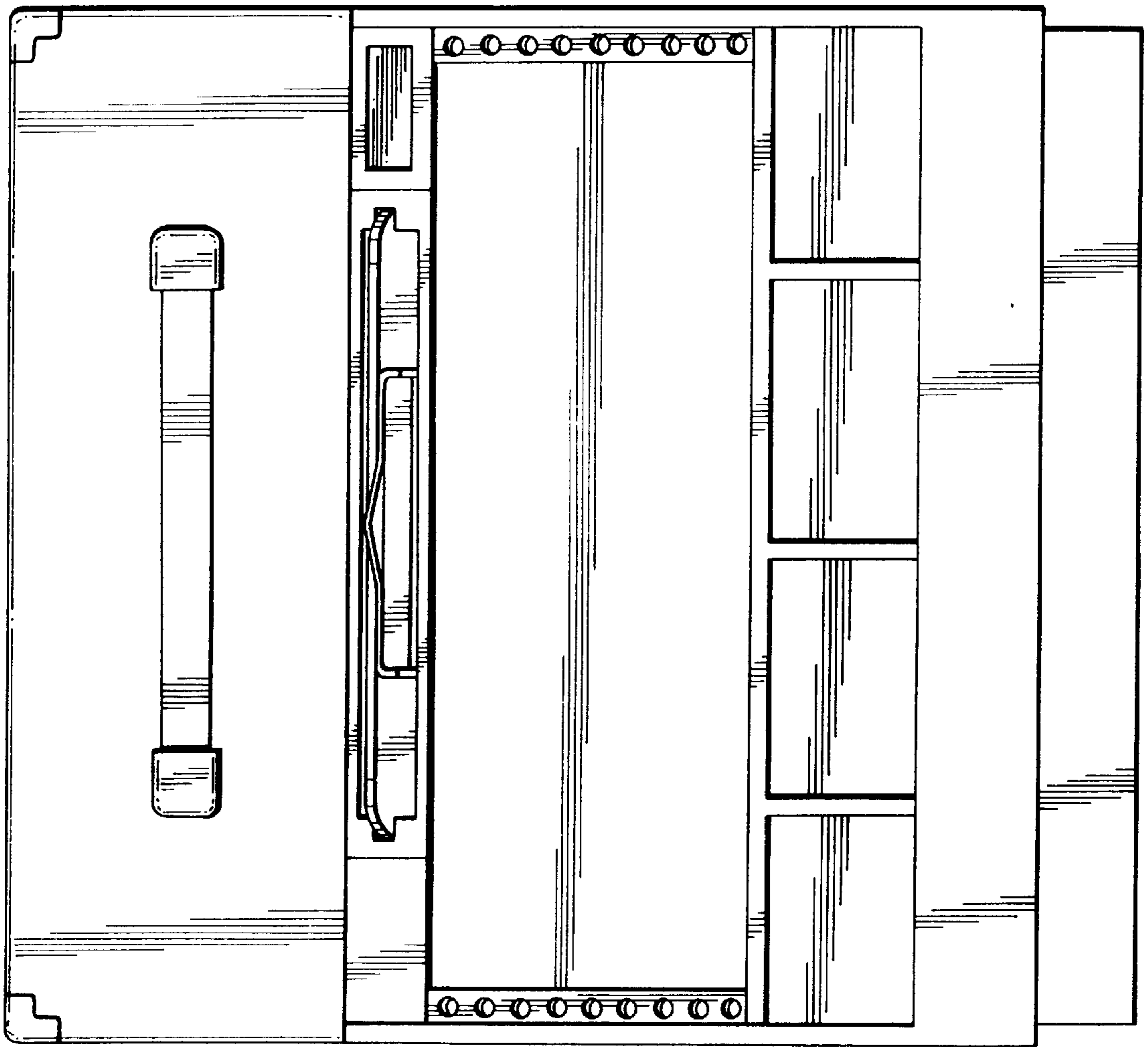

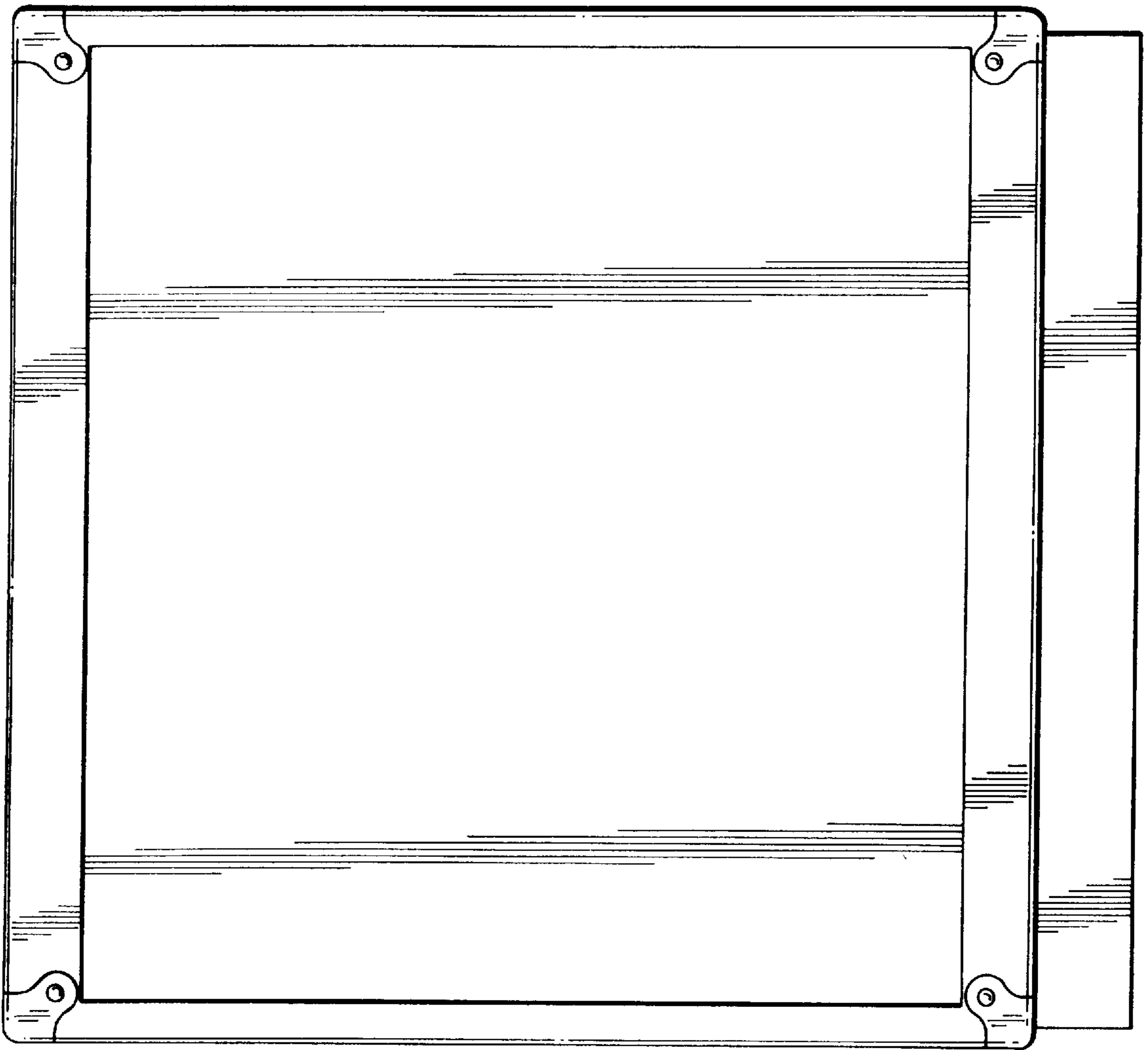

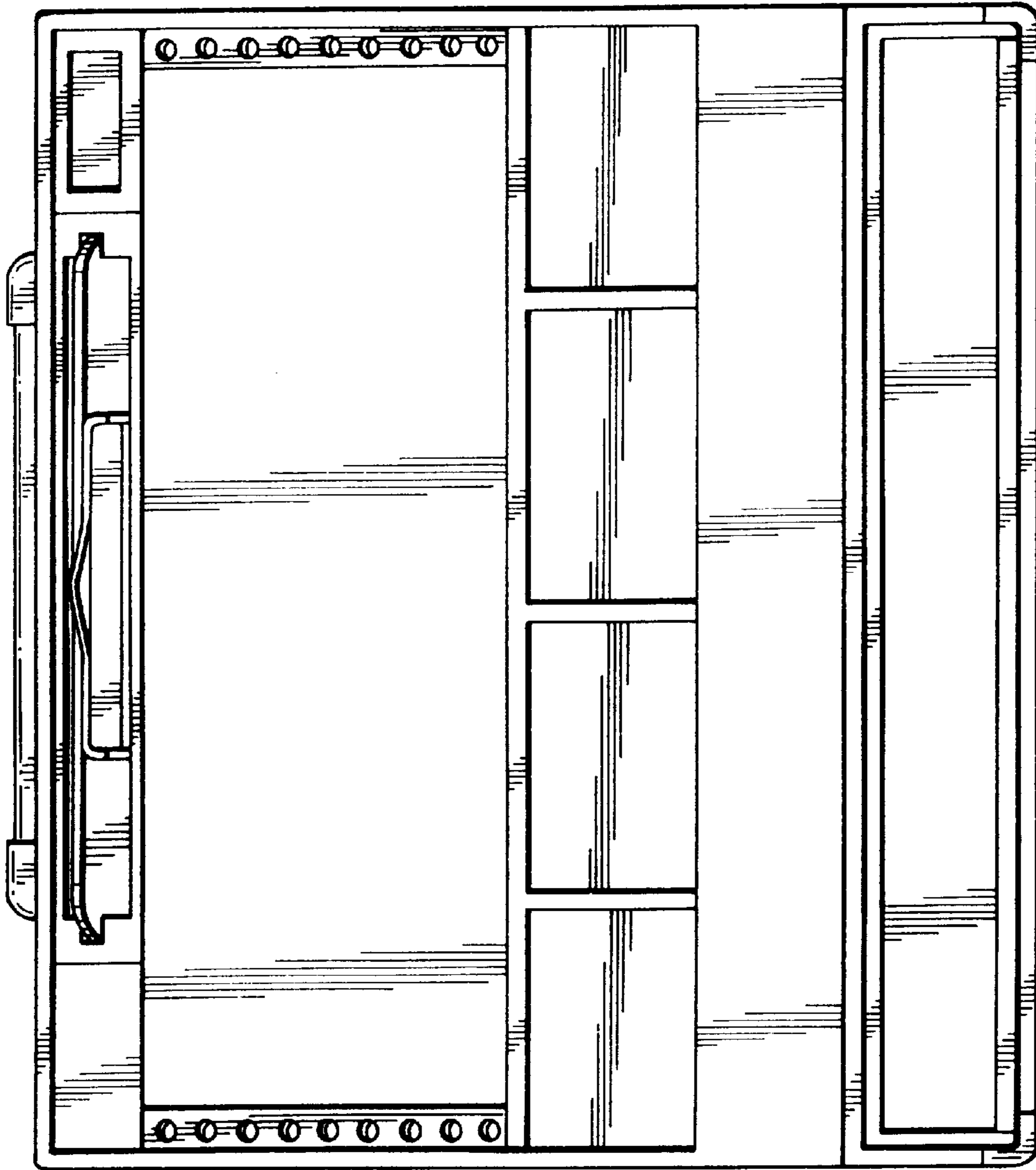

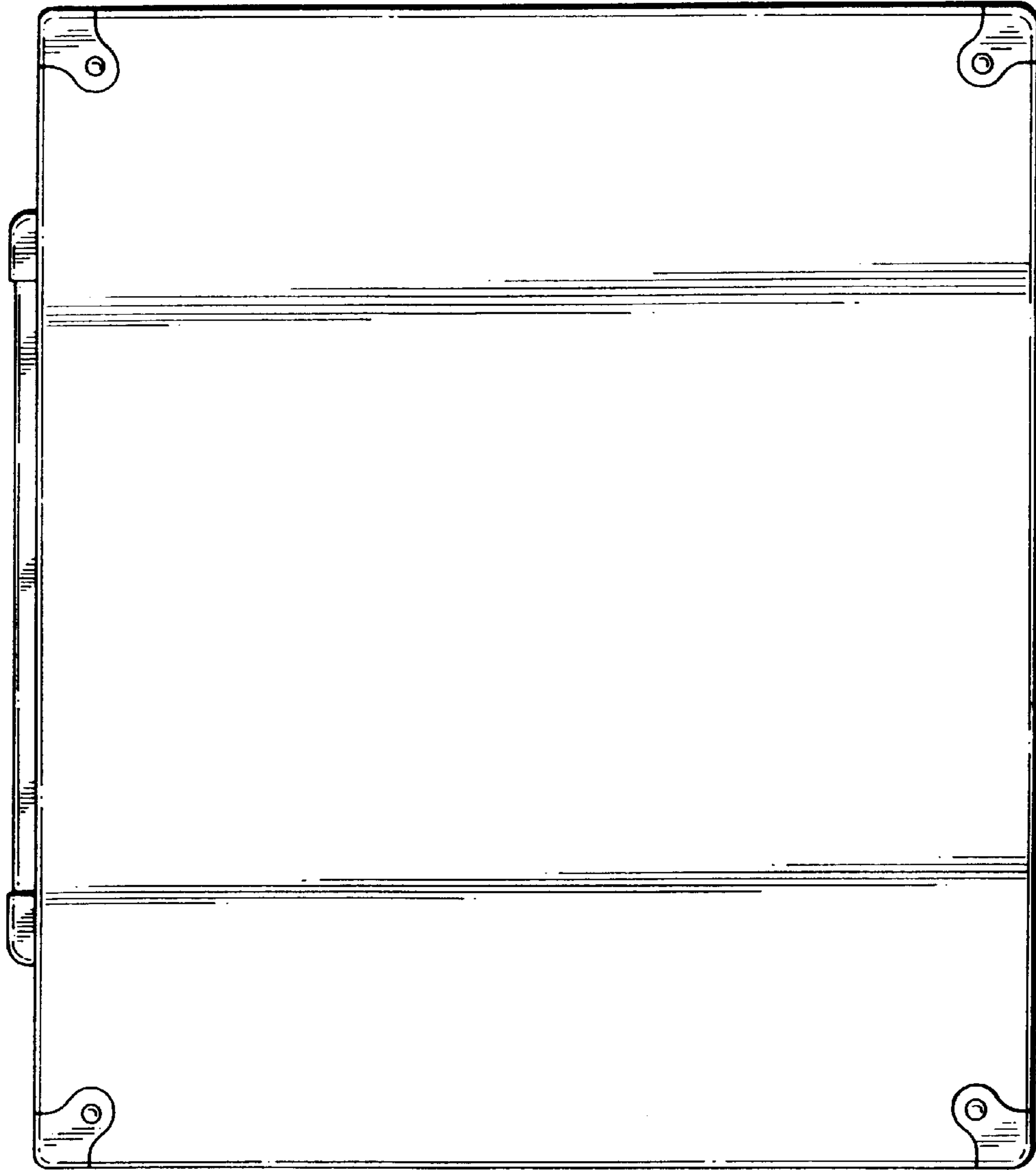

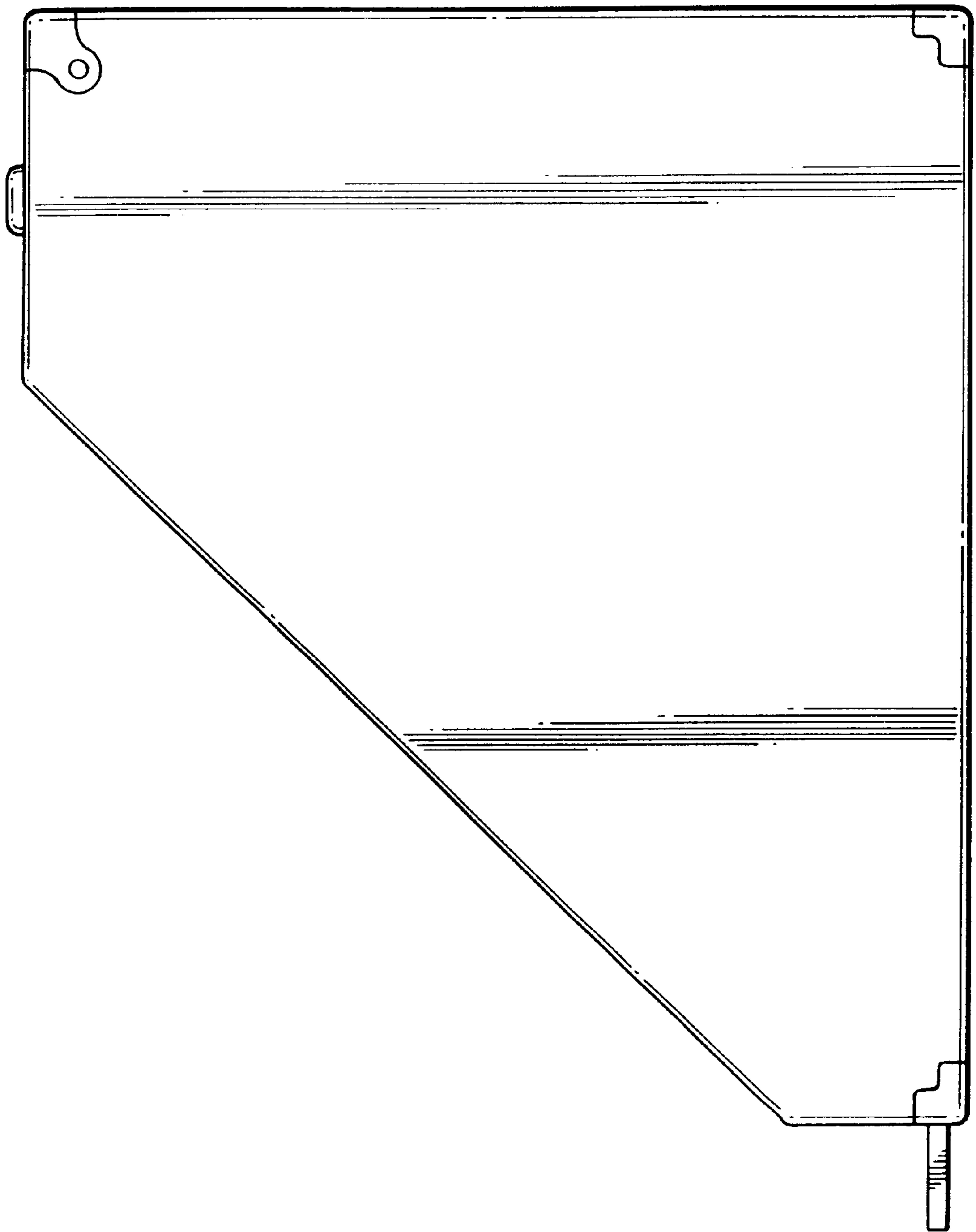

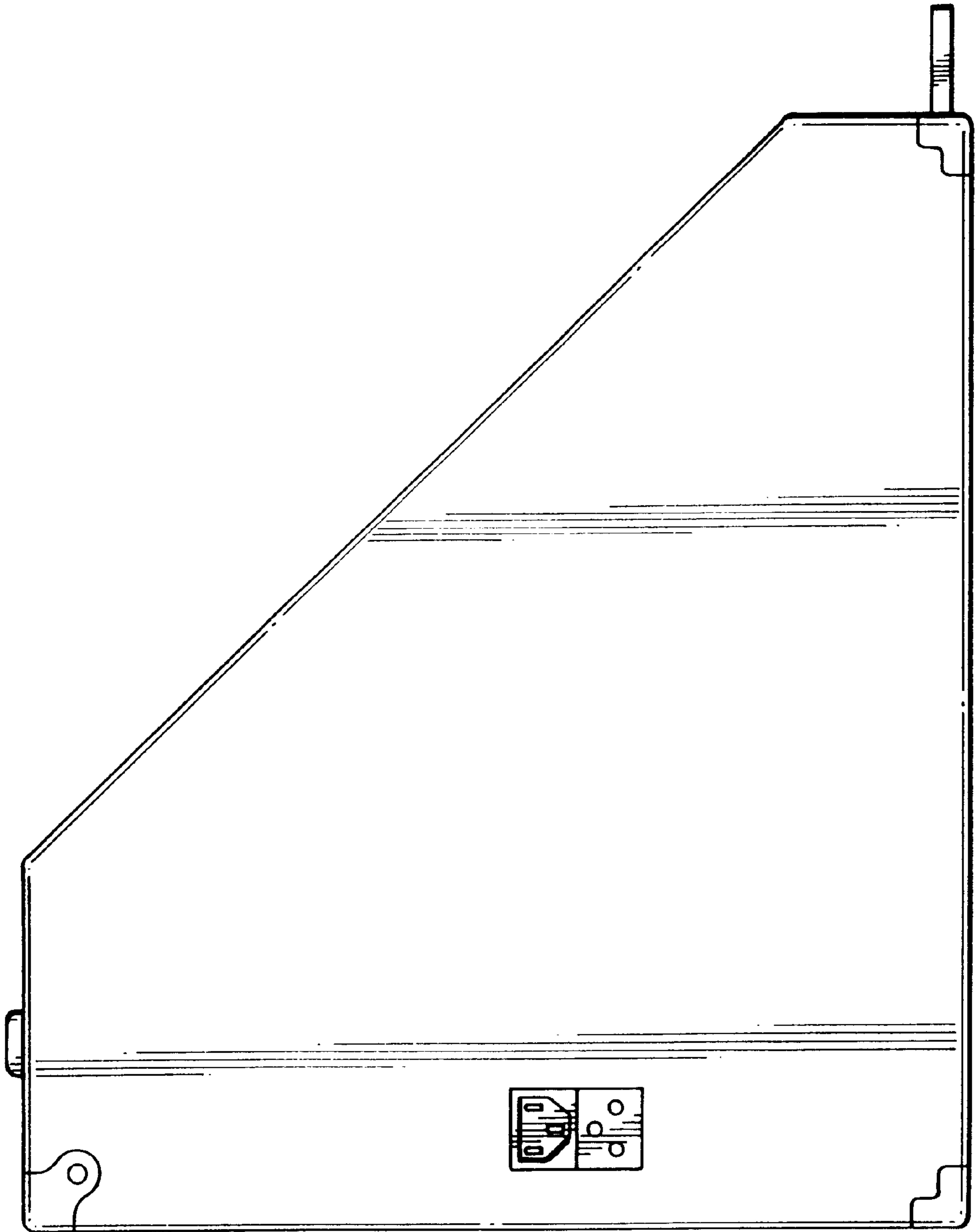

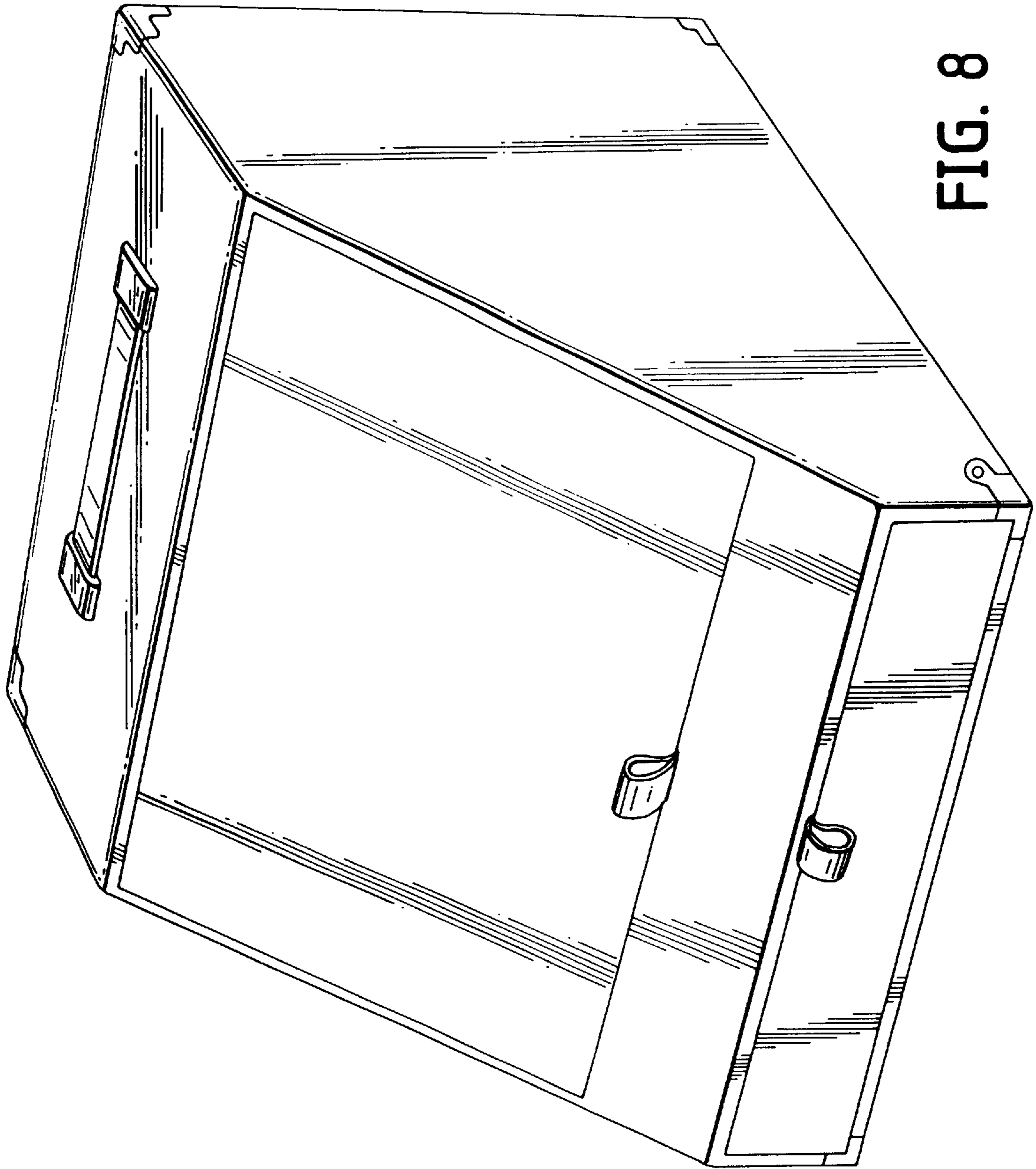
