FIG. 1 is a perspective view of a bench;

FIG. 2 is a top view thereof;

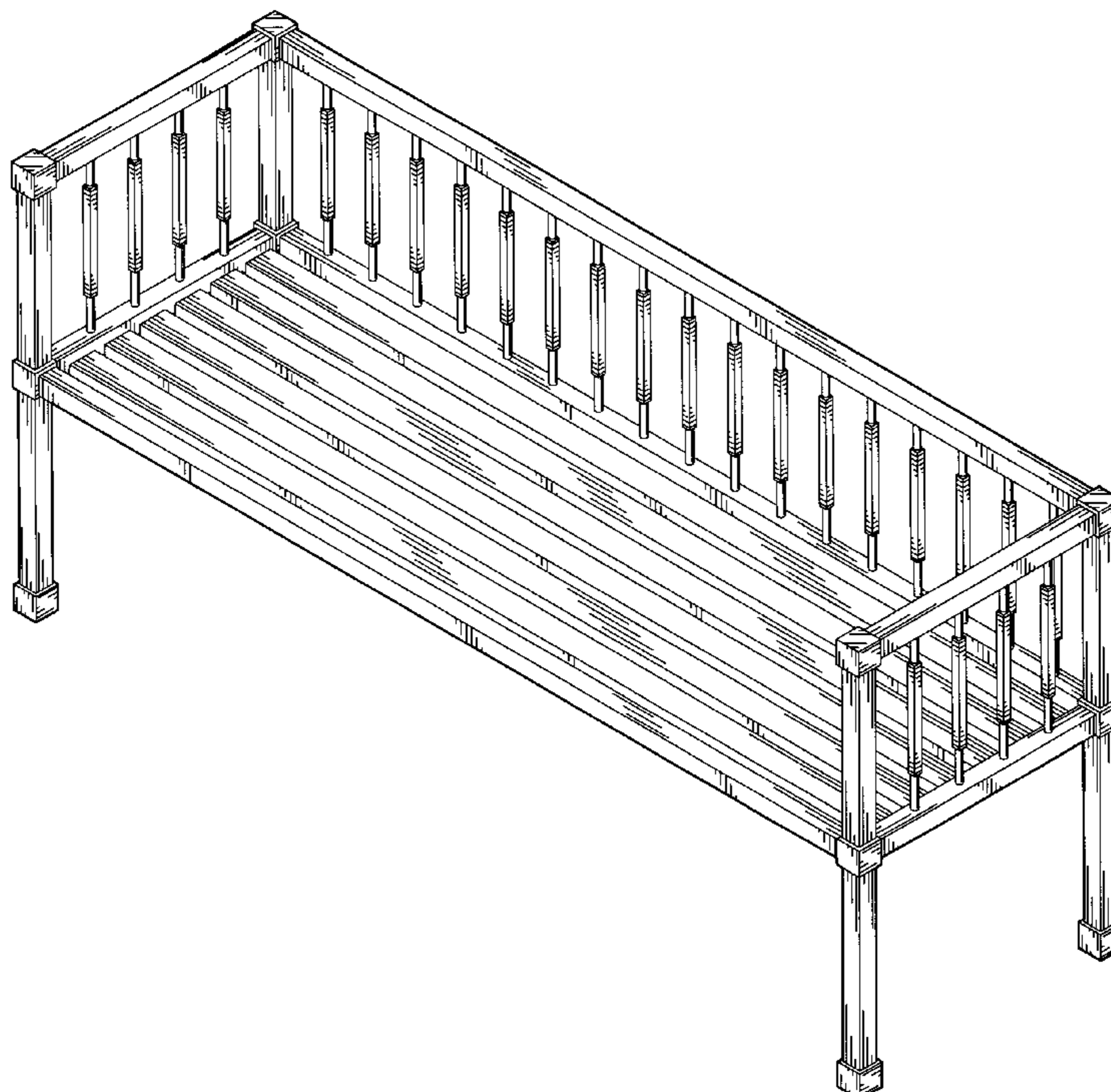
FIG. 3 is a front elevational view thereof;

minate length which is the sole difference between it and
FIGS. 1 through 5.

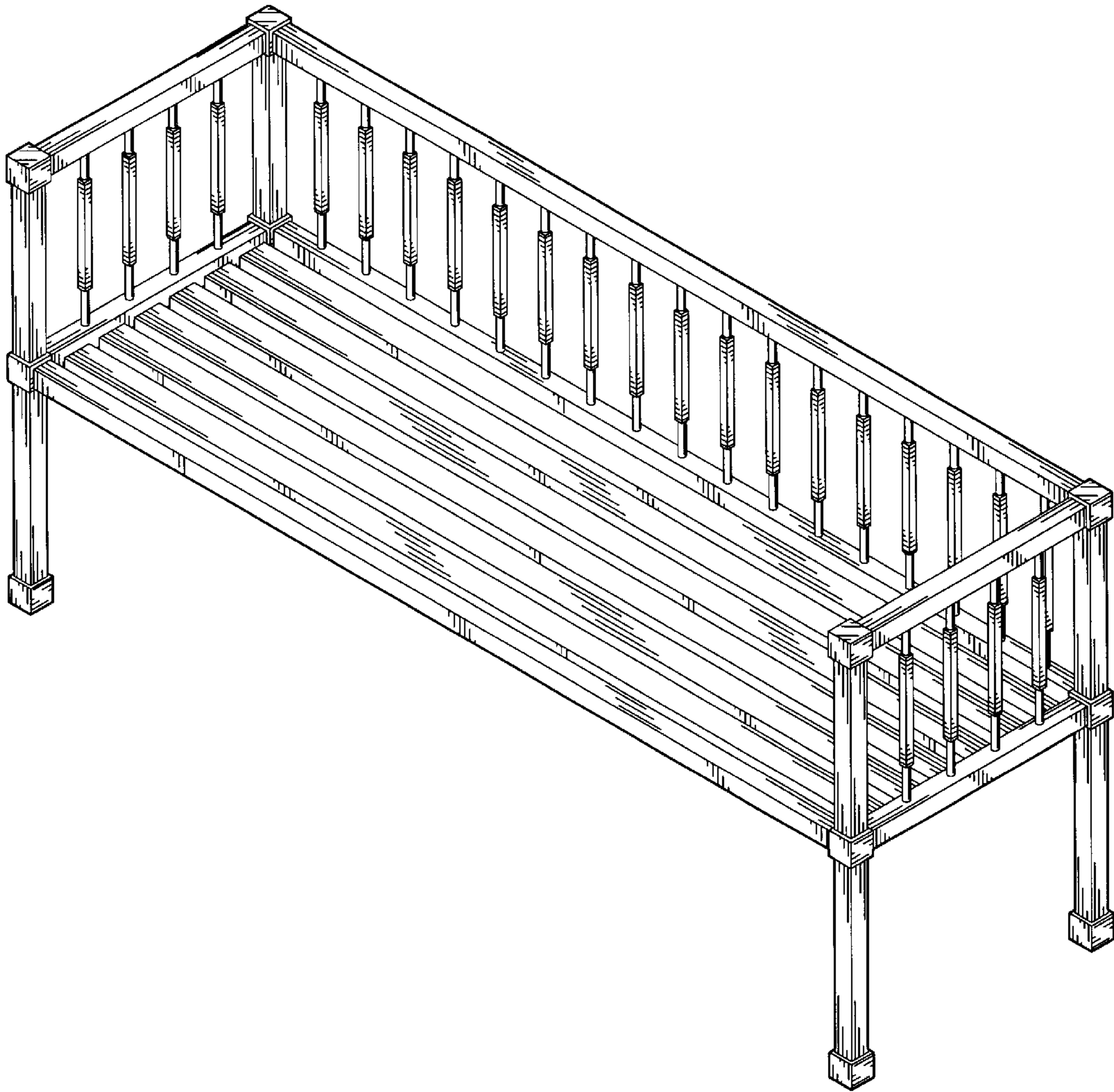

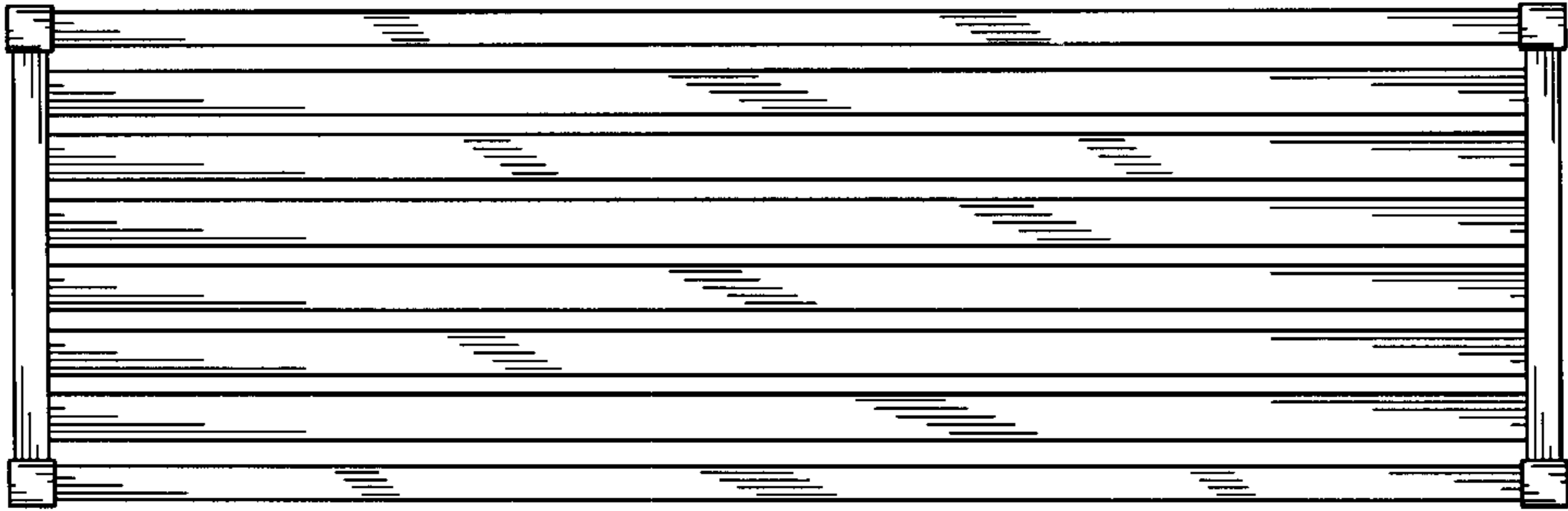

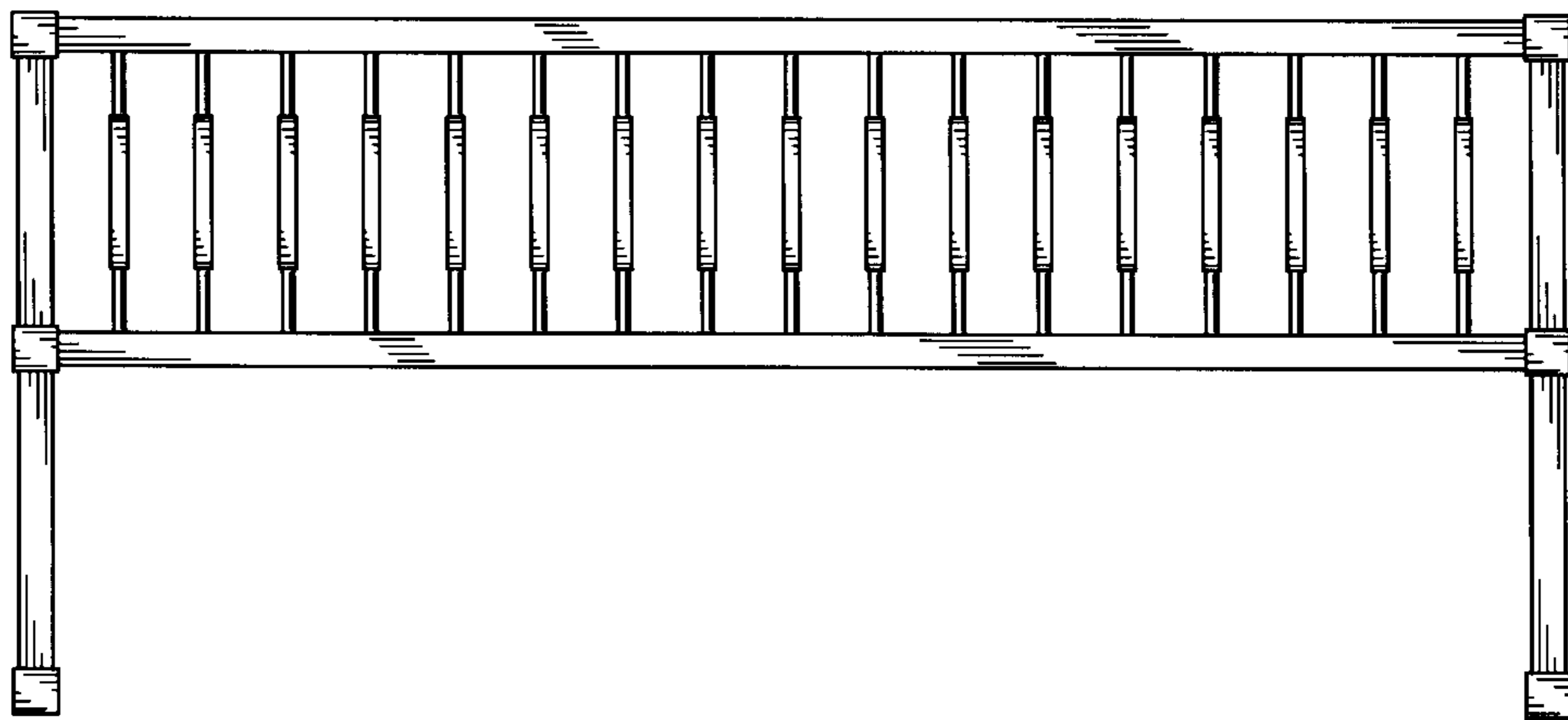

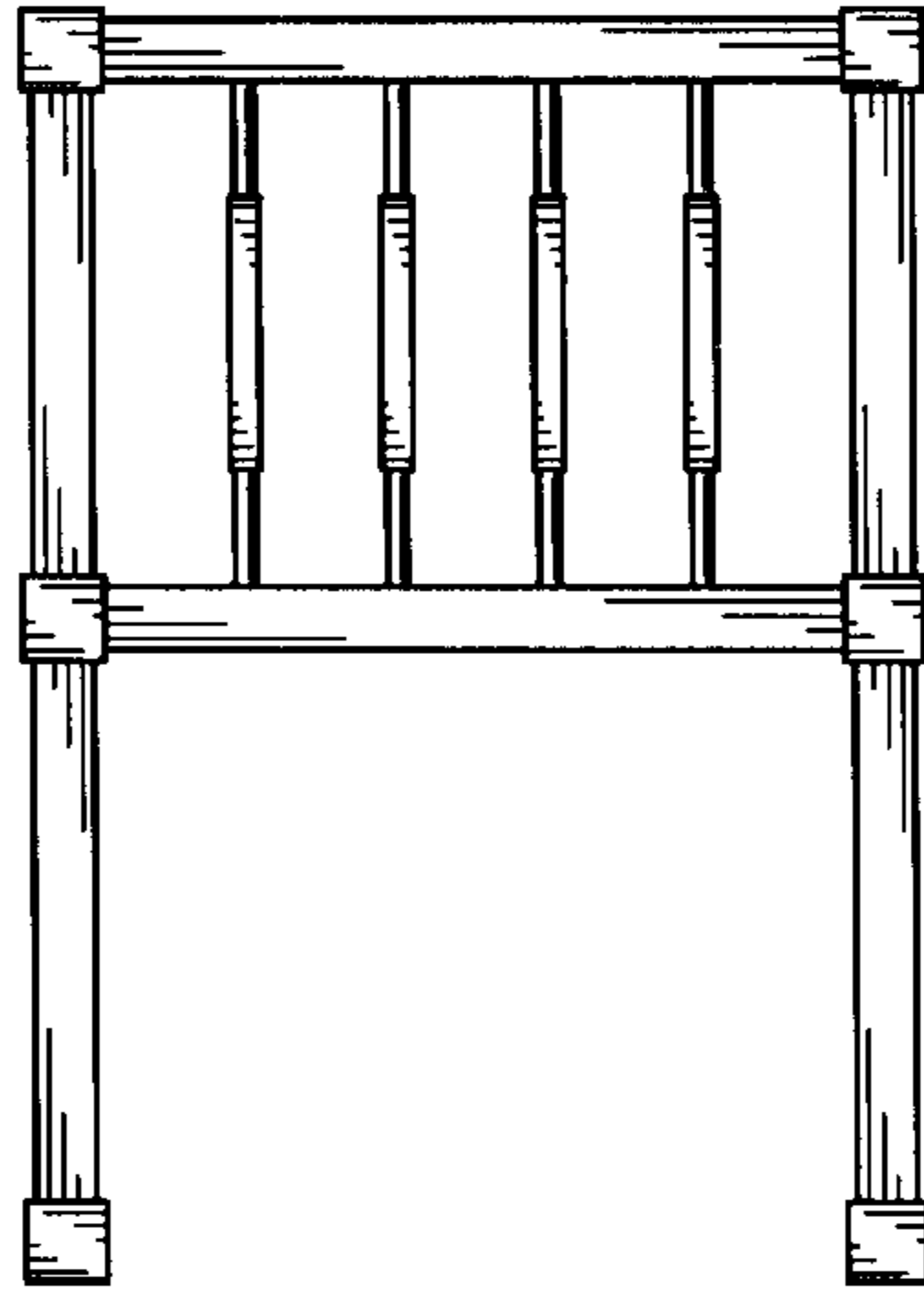

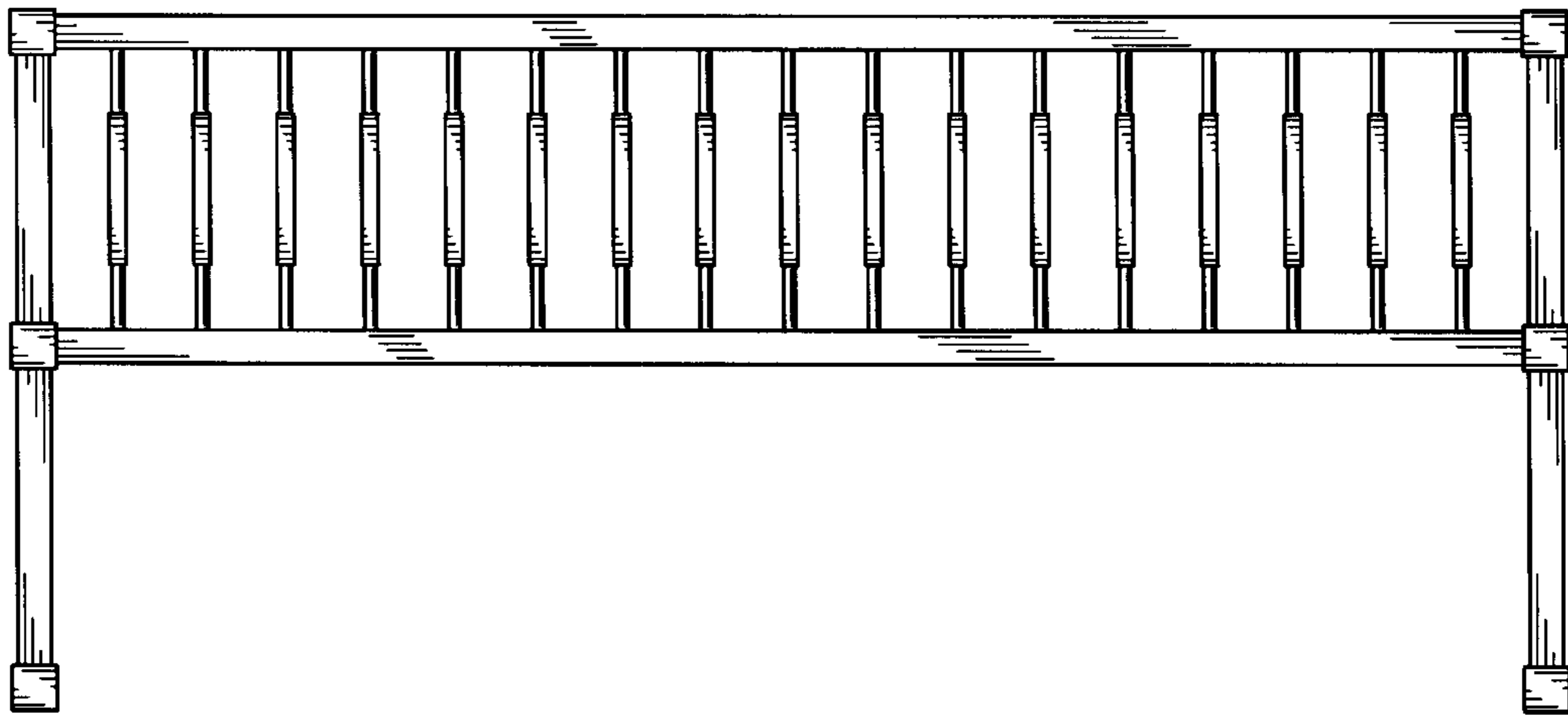

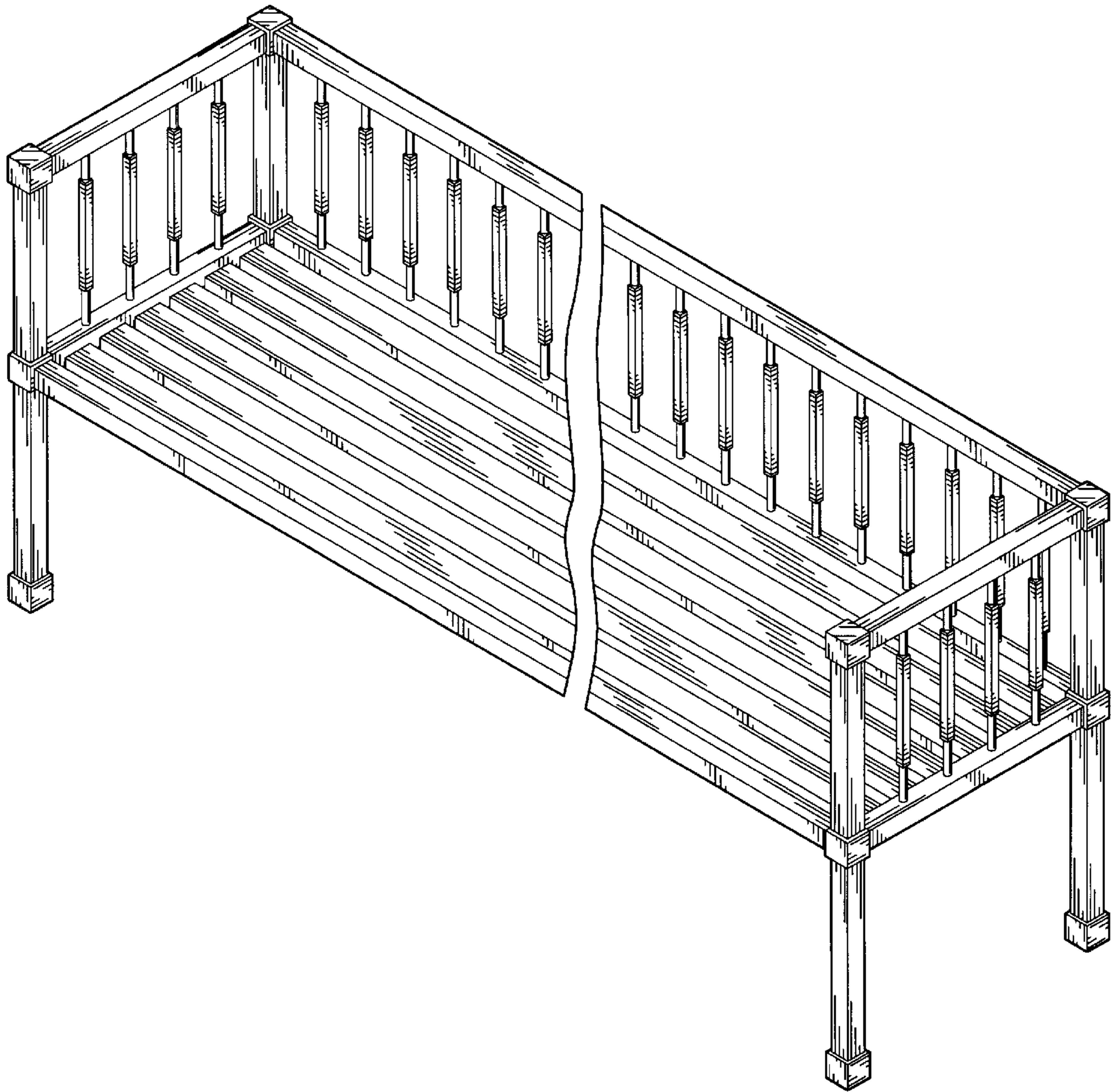
