**DESCRIPTION**

FIG. 1 is a top perspective view of a crib end board showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a side elevation view thereof, the opposite side being a mirror image thereof; and,  
FIG. 5 is an enlarged sectional view taken along line 5—5 of FIG. 3.  
The bottom and rear views (not shown) form no part of the claimed design.

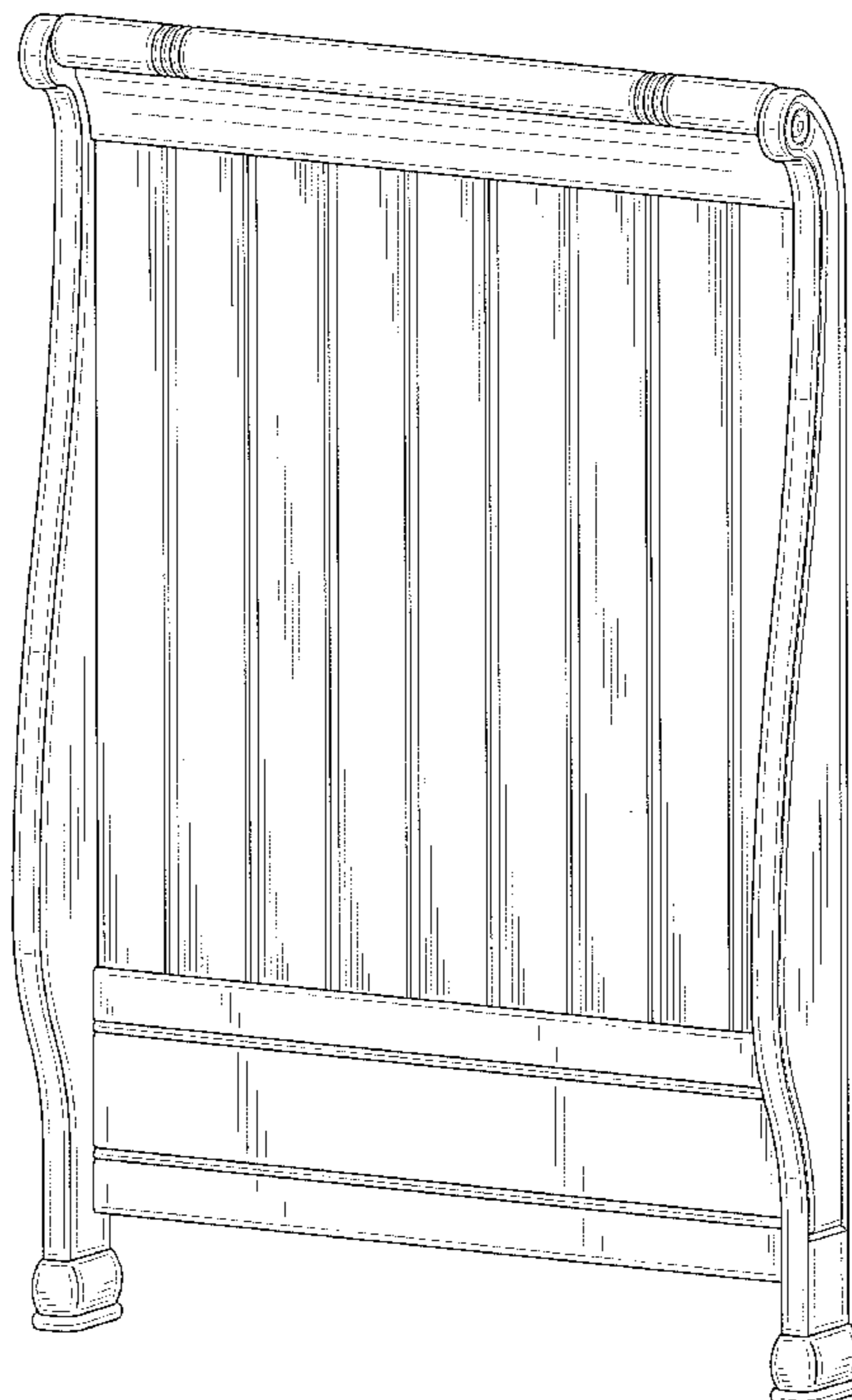

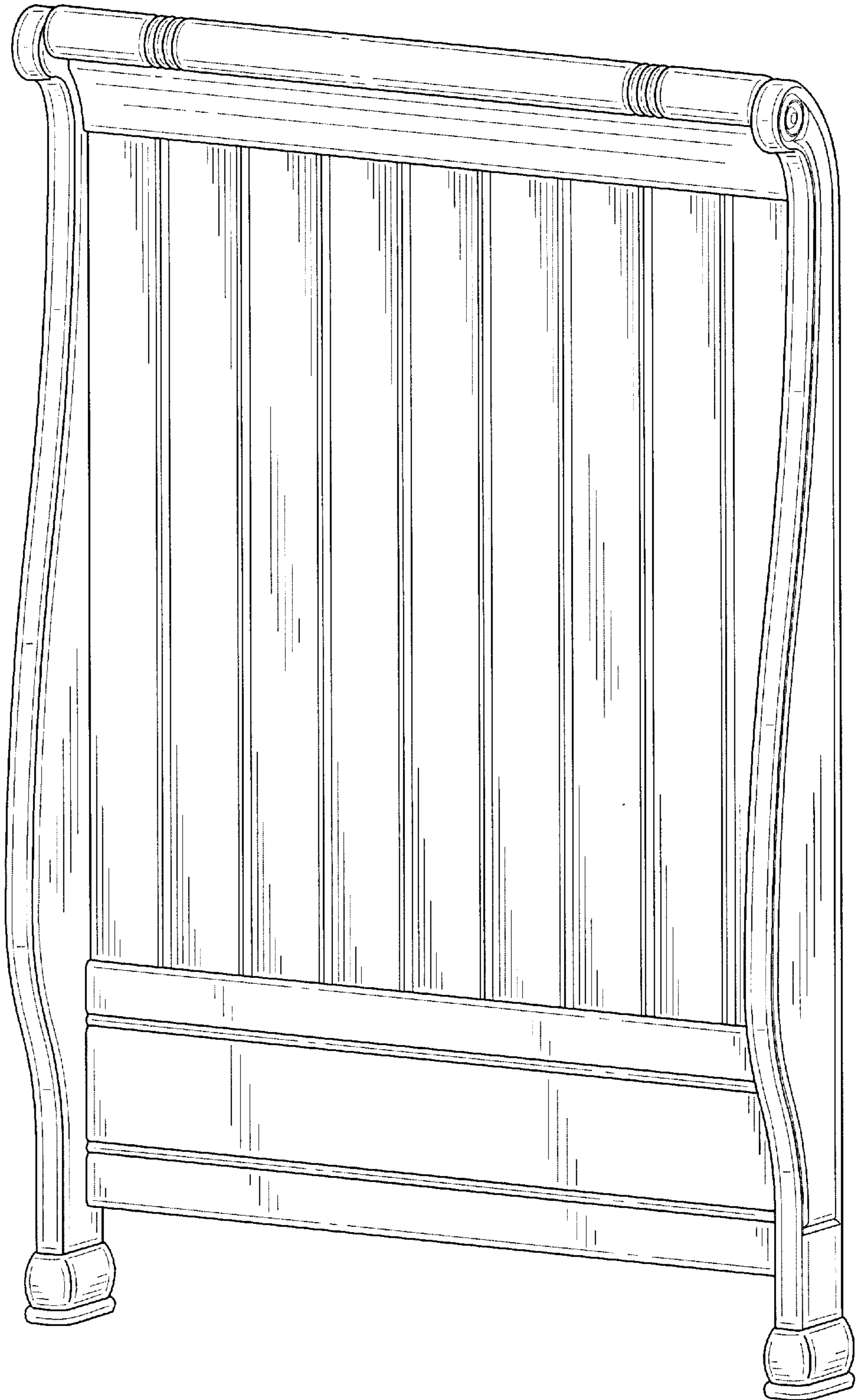

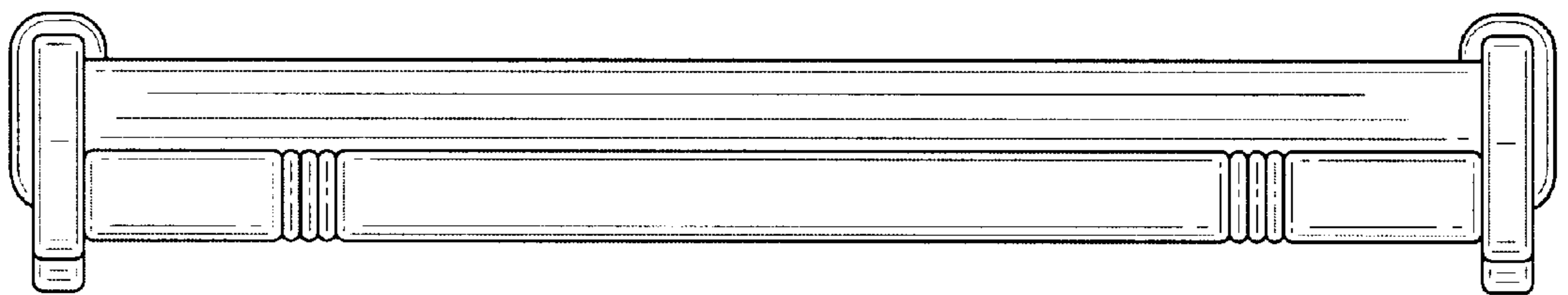

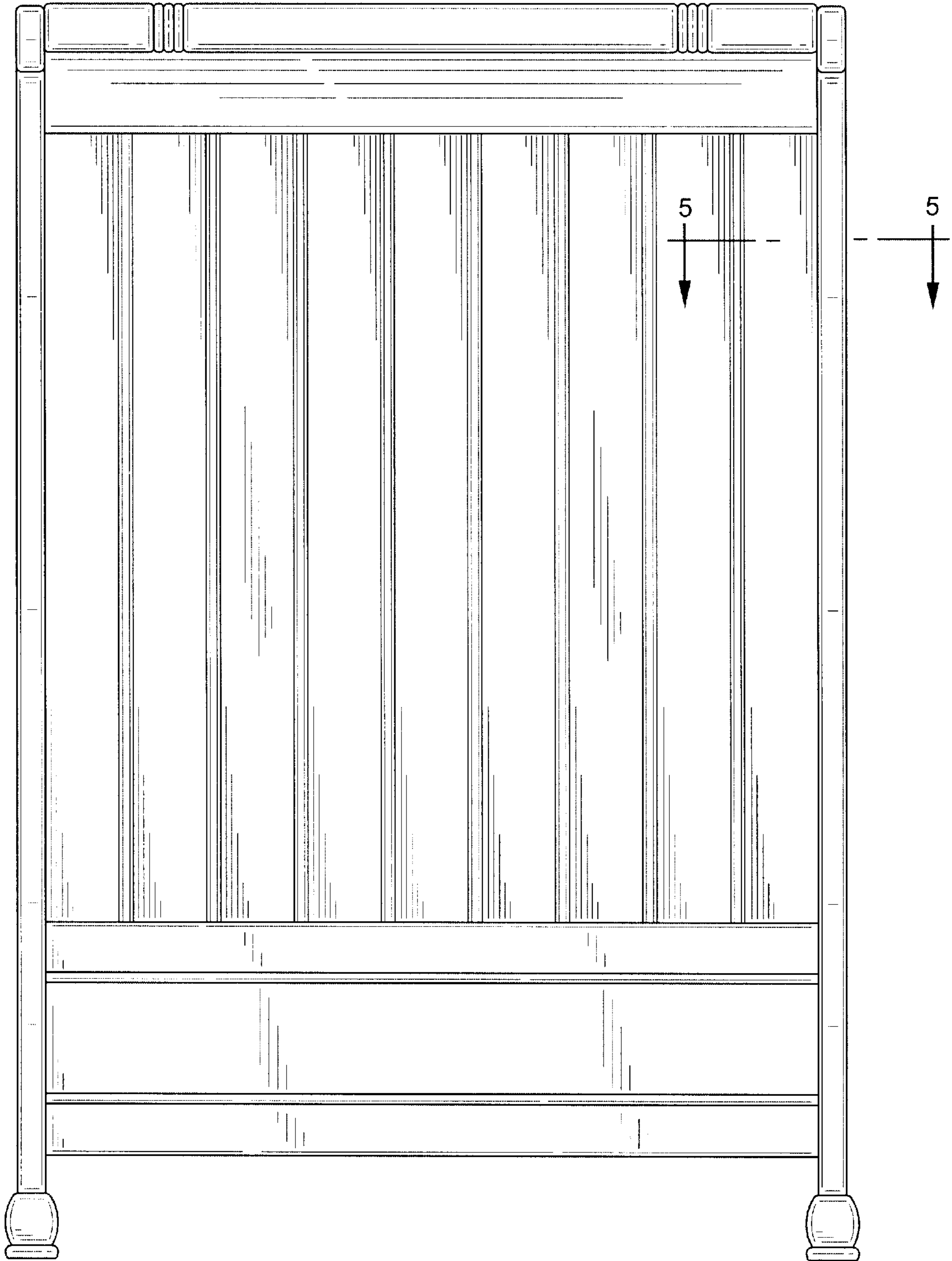

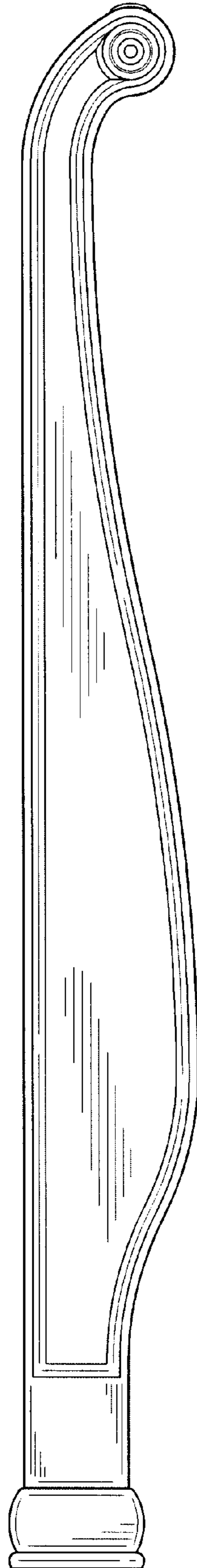
