(57) **CLAIM**

The ornamental design for a holding cabinet, as shown.

DESCRIPTION

FIG. 1 is a front view of a holding cabinet, according to an embodiment of the design.

FIG. 2 is a front view of a lower portion of the holding cabinet of FIG. 1, according to an embodiment of the design.

FIG. 3 is a front view of an upper portion of the holding cabinet of FIG. 1, according to an embodiment of the design.

FIG. 4 is a back view of the lower portion of the holding cabinet of FIG. 1, according to an embodiment of the design.

FIG. 5 is a back view of the upper portion of the holding cabinet of FIG. 1, according to an embodiment of the design.

FIG. 6 is a right side view of the holding cabinet of FIG. 1, according to an embodiment of the design.

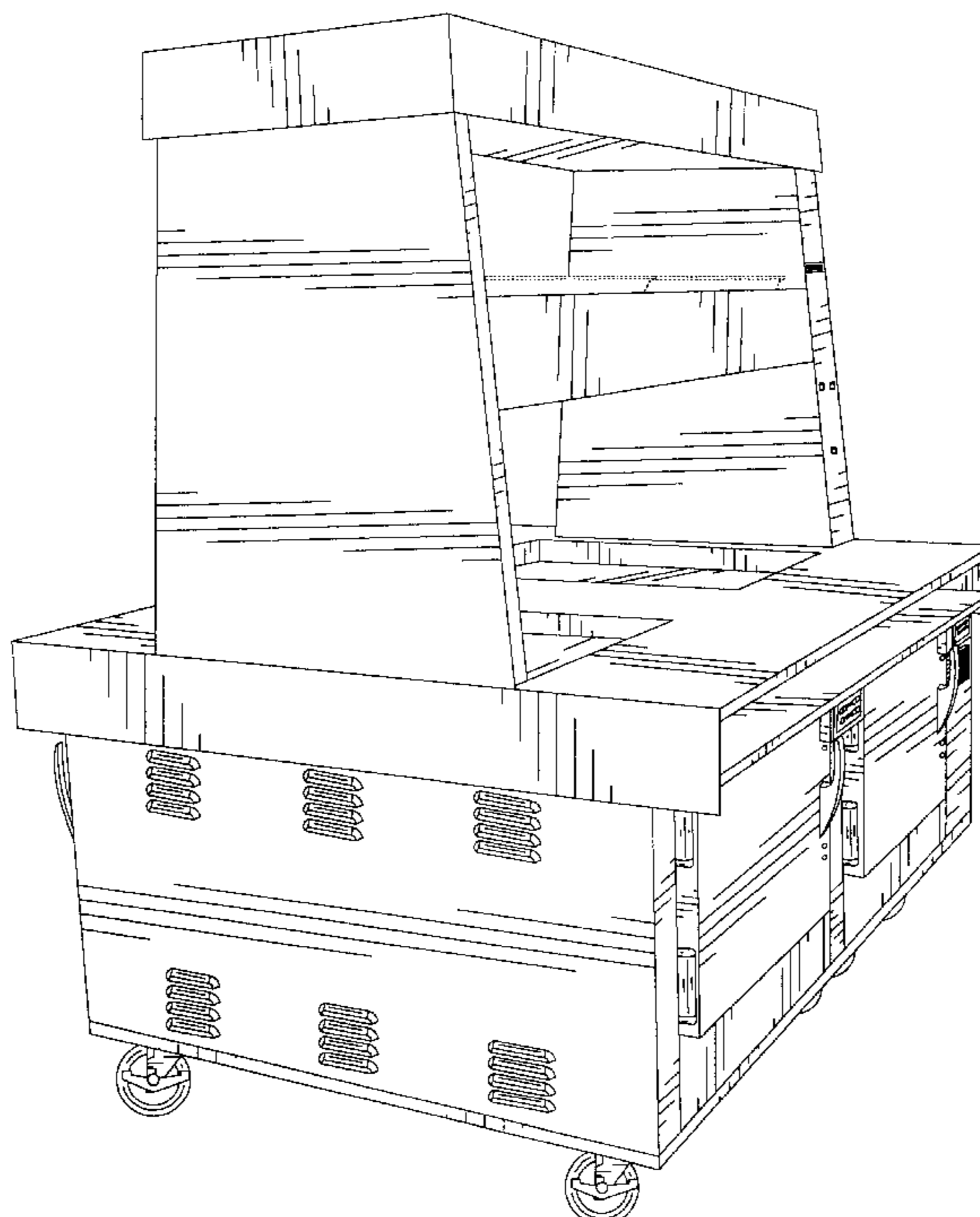
FIG. 7 is a left side view of the holding cabinet of FIG. 1, according to an embodiment of the design.

FIG. 8 is front perspective view of the holding cabinet of FIG. 1, according to an embodiment of the design; and,

FIG. 9 is back perspective view of the holding cabinet of FIG. 1, according to an embodiment of the design.

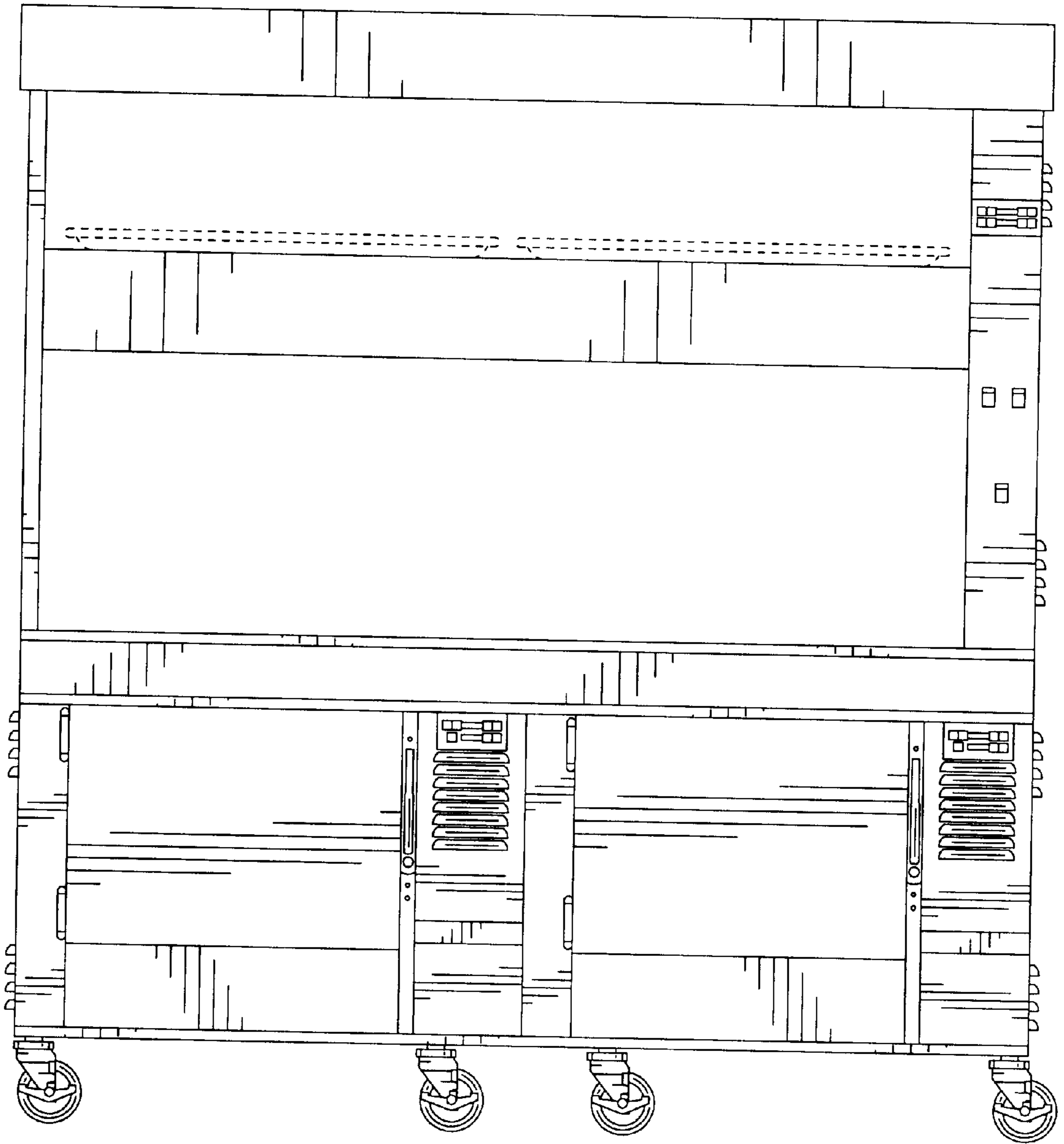

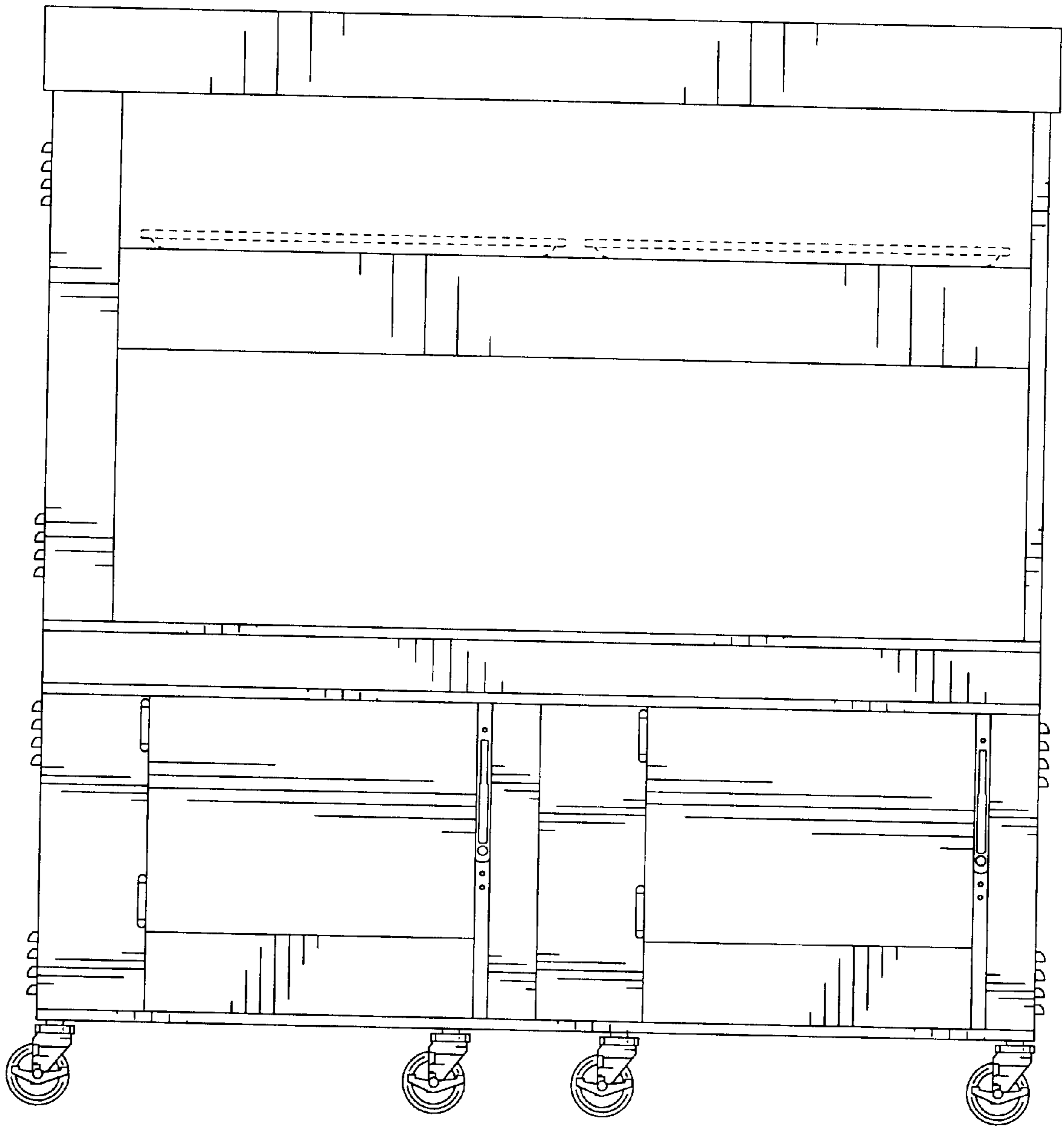

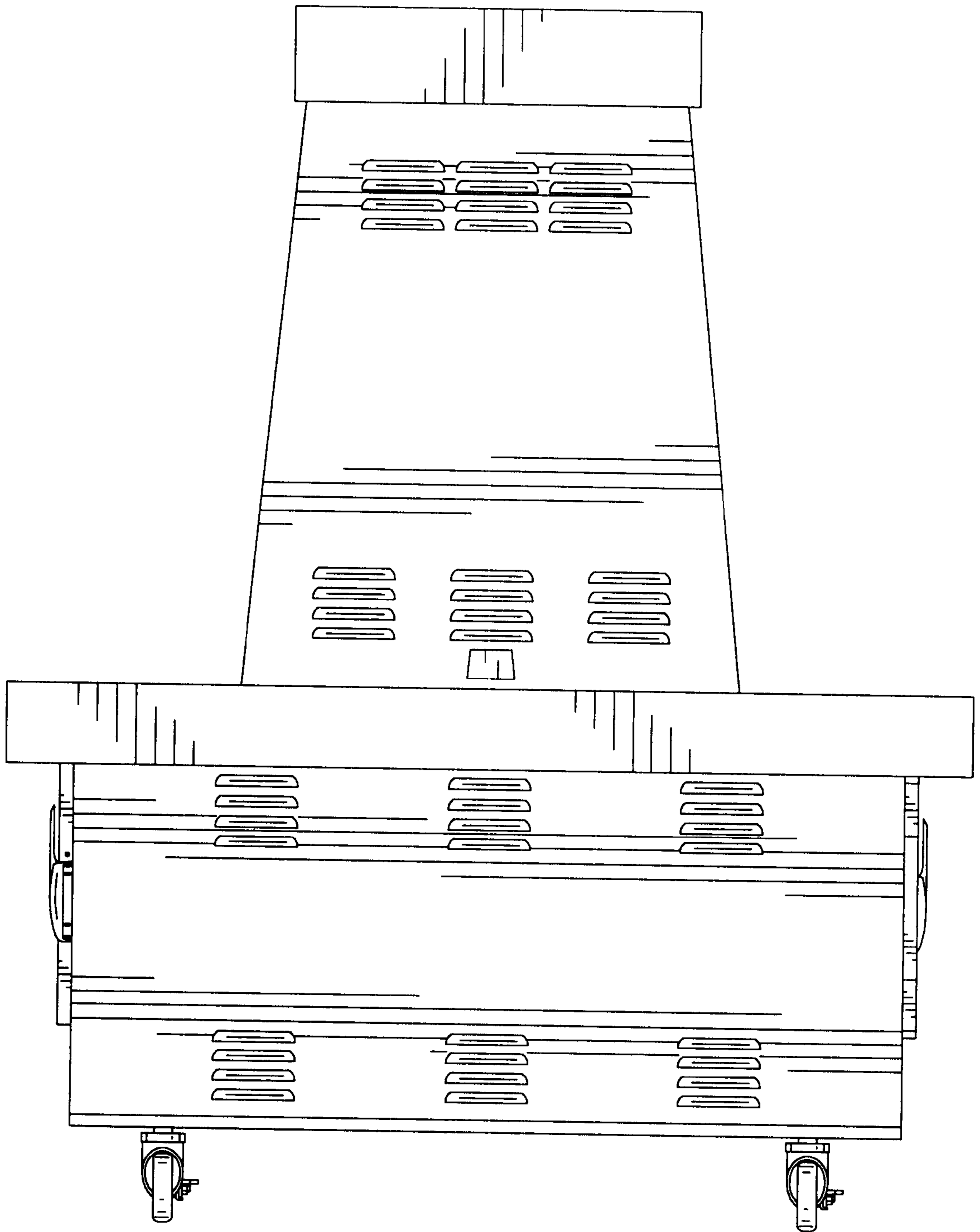

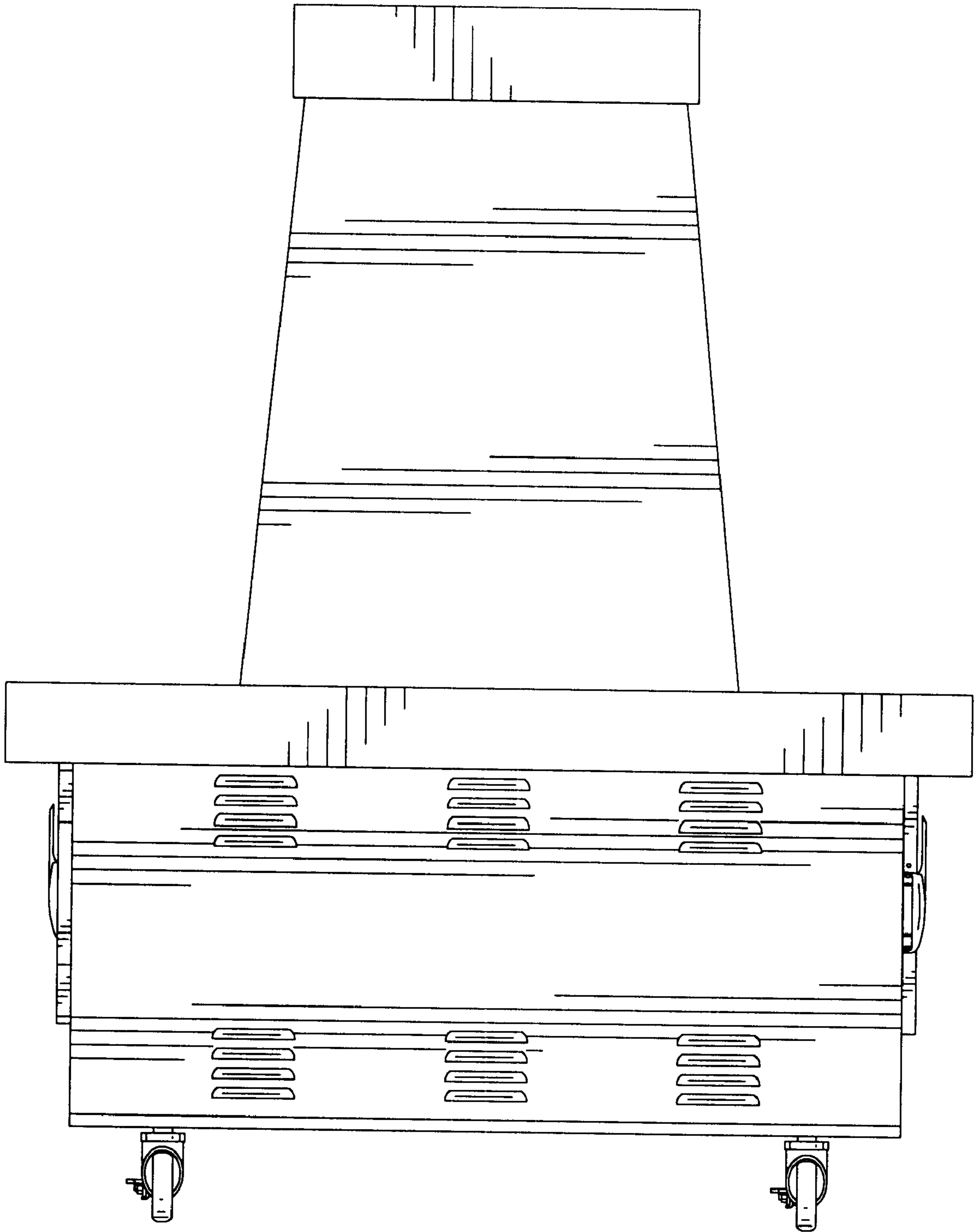

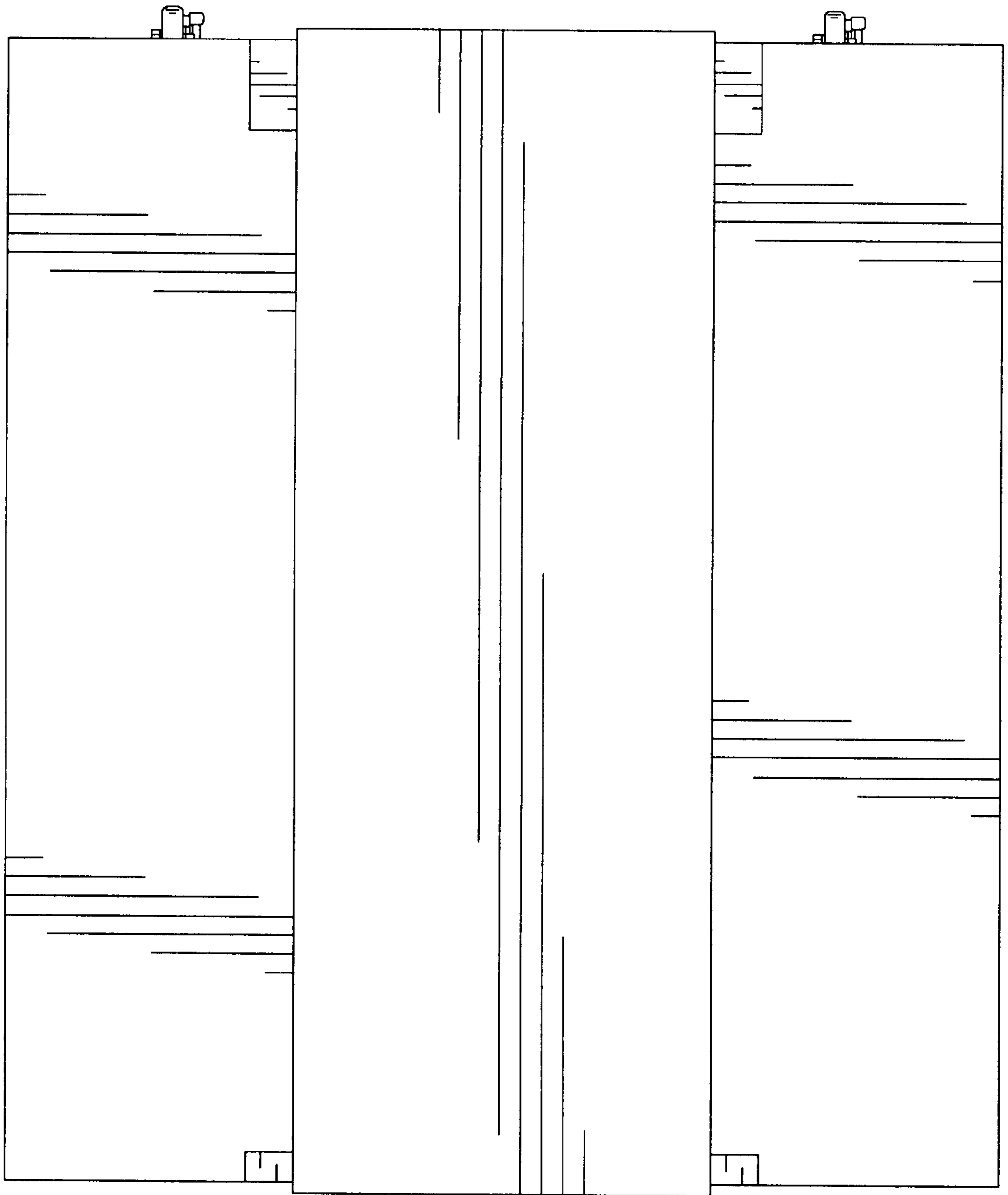

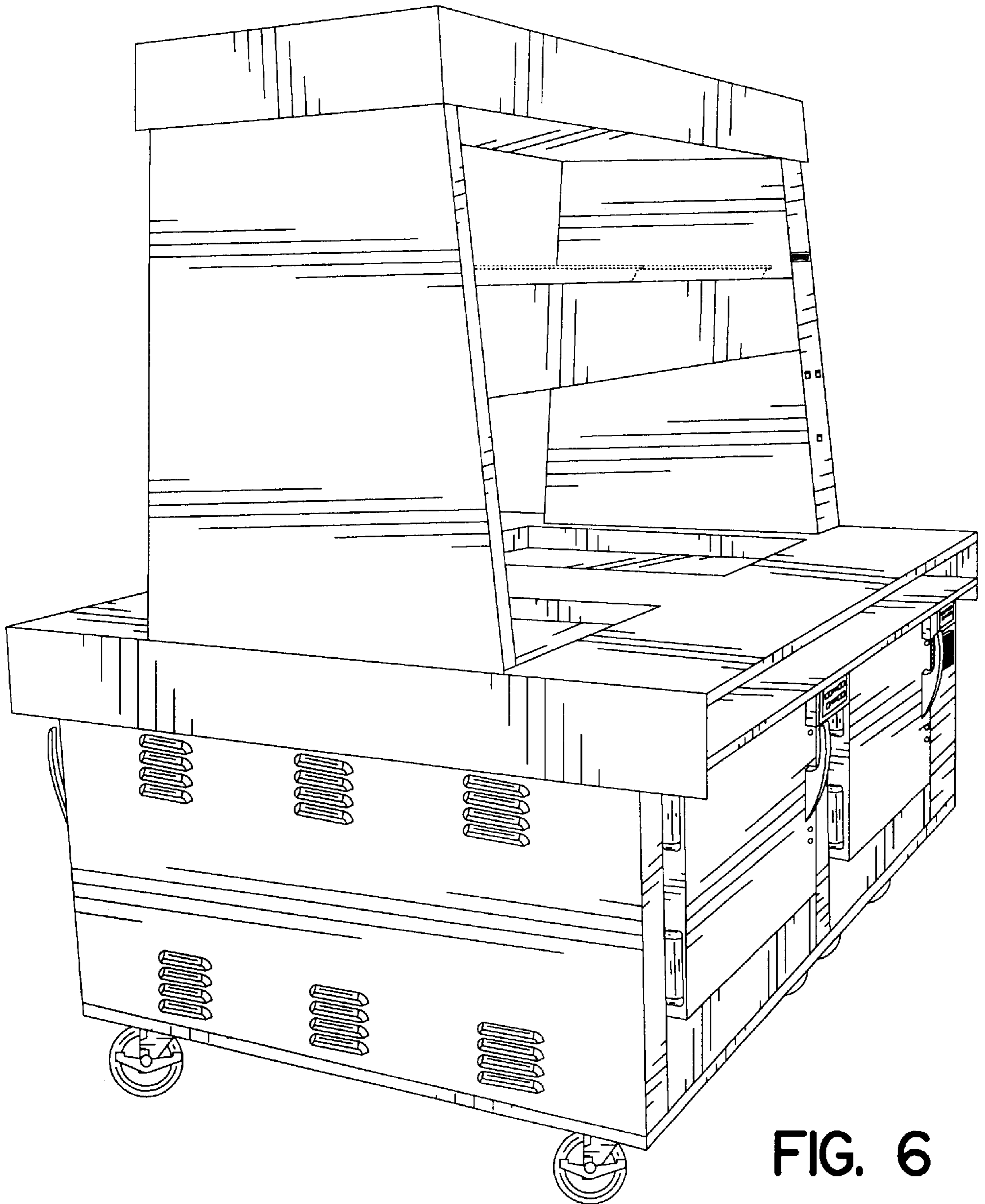
