(57) **CLAIM**

The ornamental design for a latch protector for cylindrical door lock, as shown and described.

**DESCRIPTION**

FIG. 1 is a generally front perspective view of a latch protector for cylindrical door lock, showing our new design; FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image;

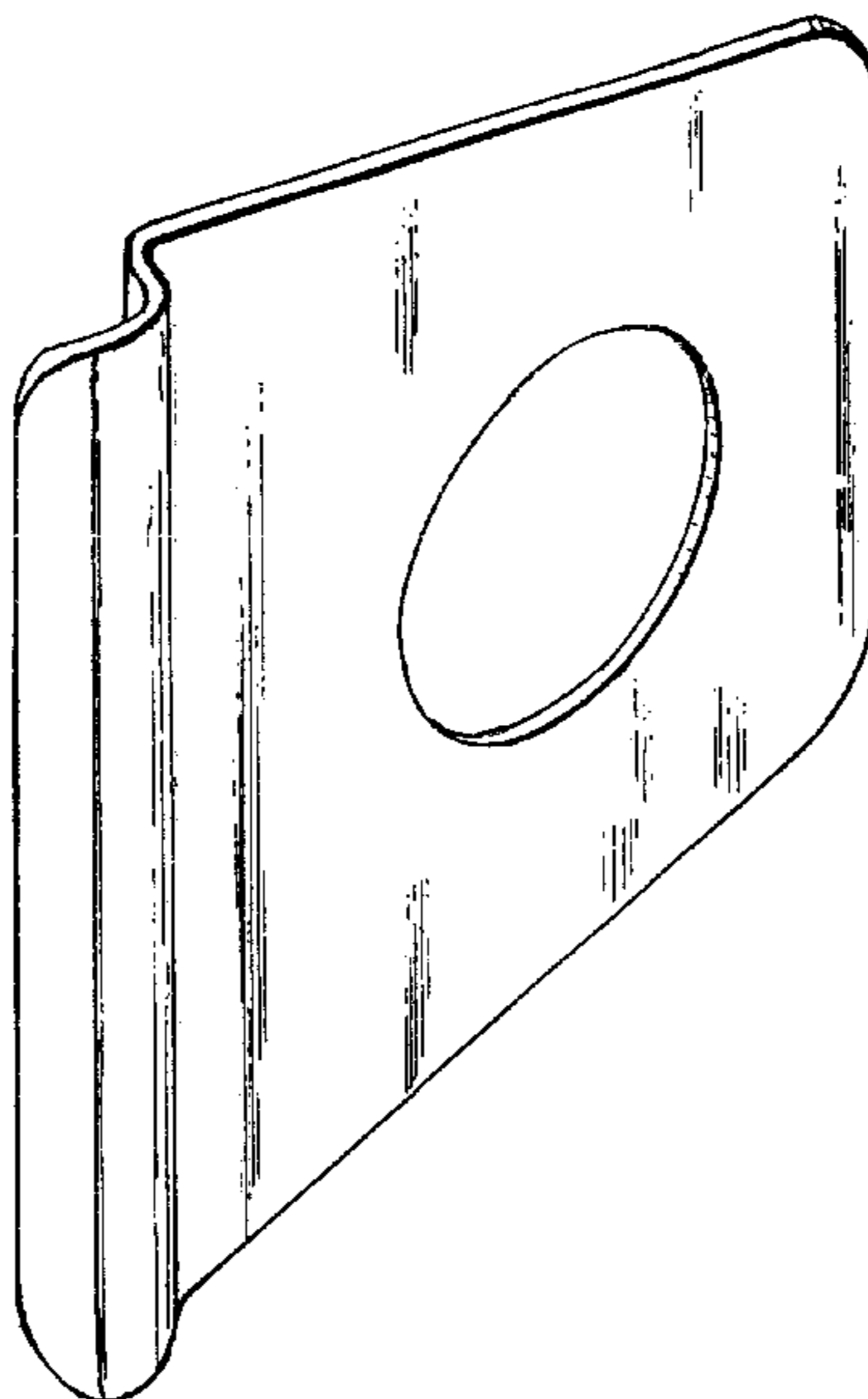
FIG. 3 is a front elevation view thereof;

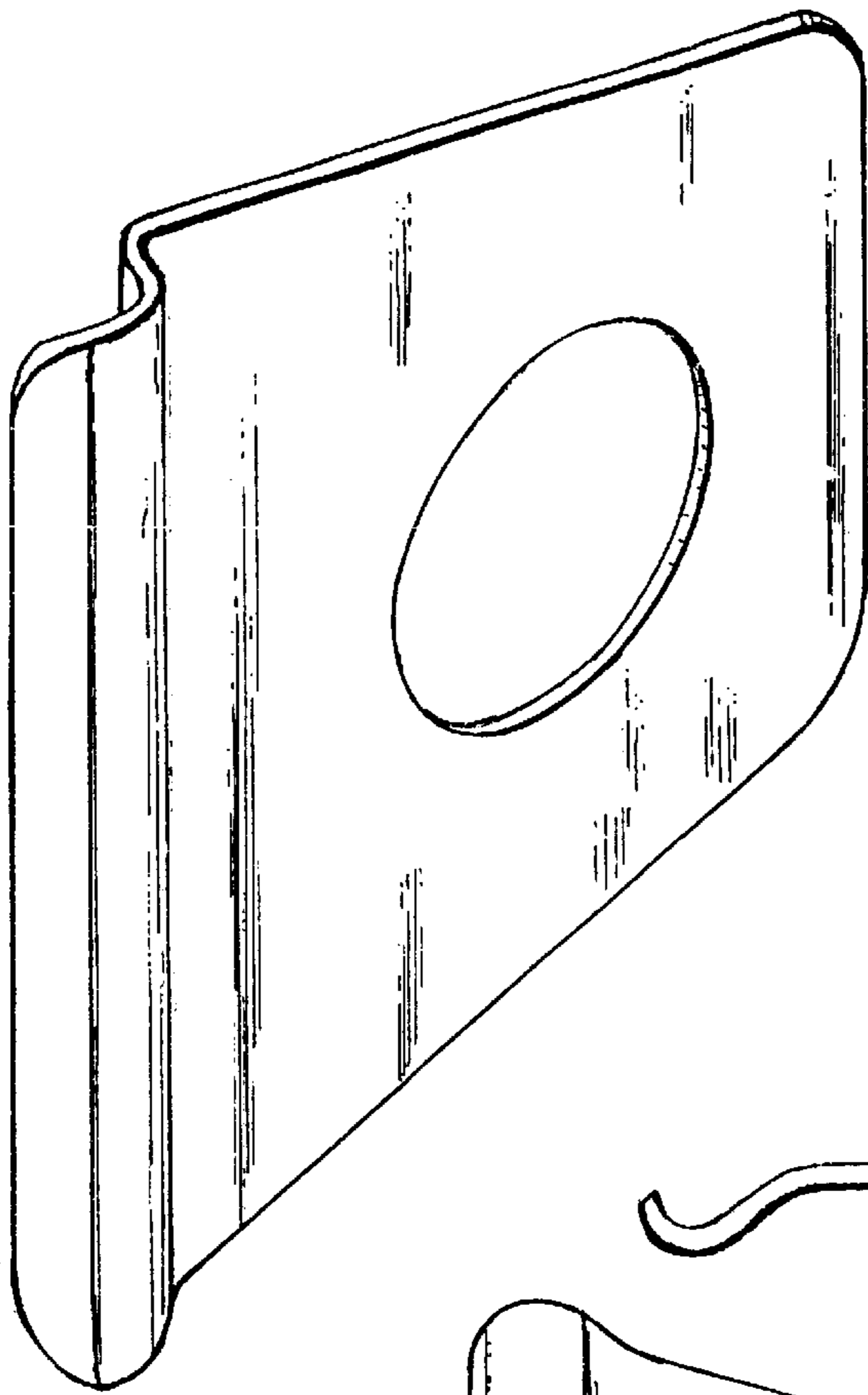

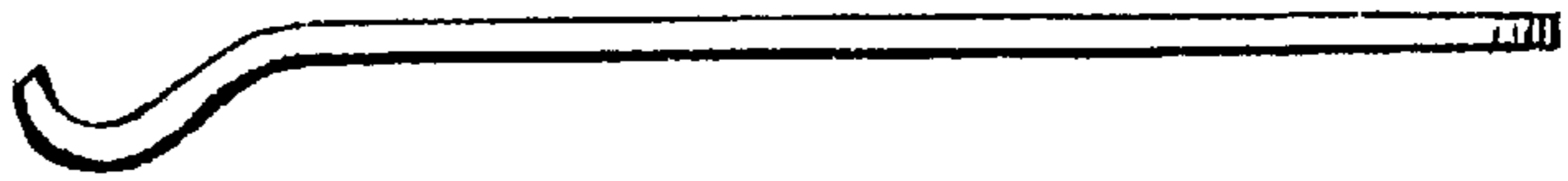

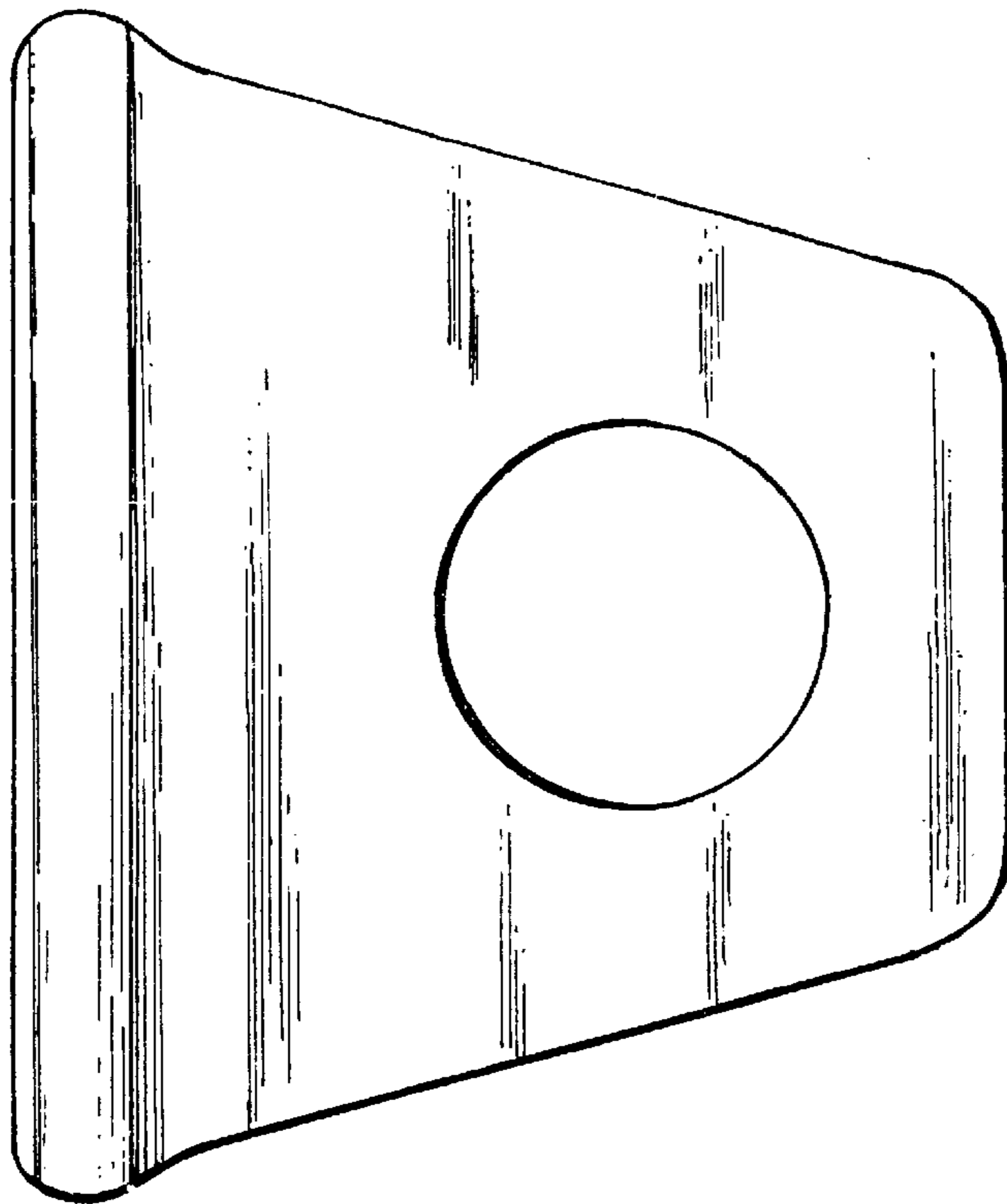

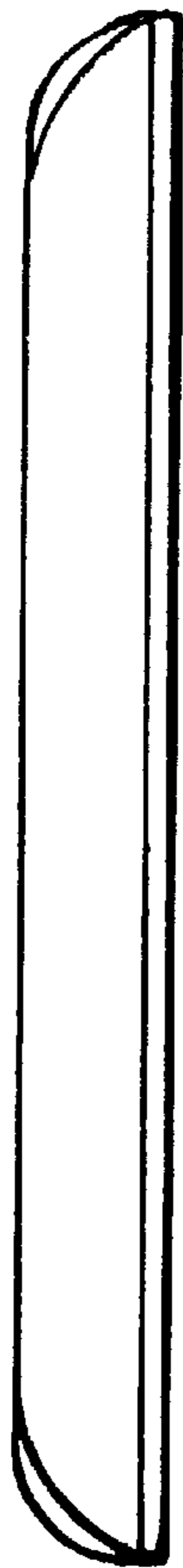
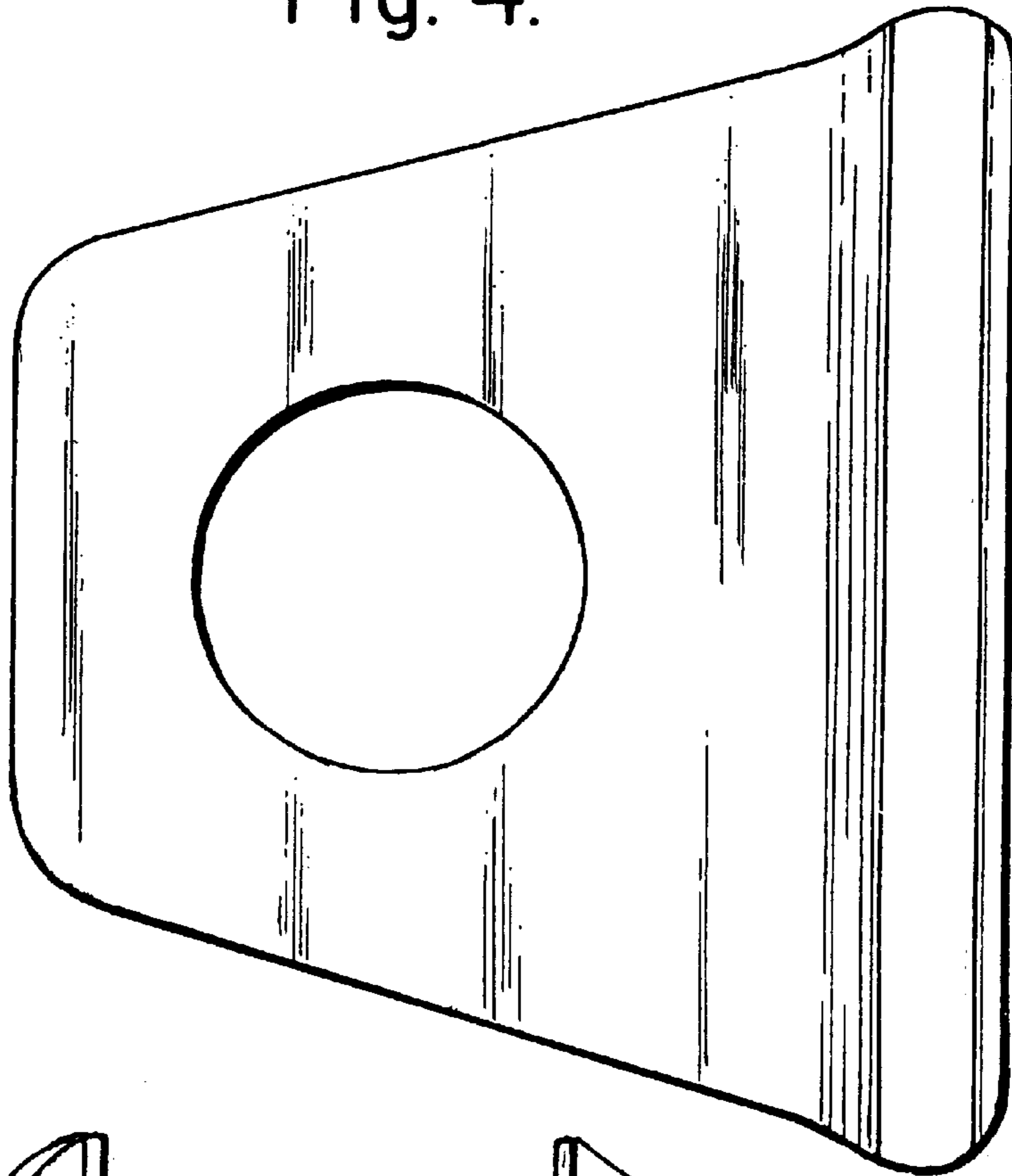
