FIG. 14 is a top plan view of the connector of FIG. 9; and, FIG. 15 is a bottom plan view of the connector of FIG. 9. The broken line showing of the lanyard, buckle and spring clip is for illustrative purposes only and forms no part of the claimed design.

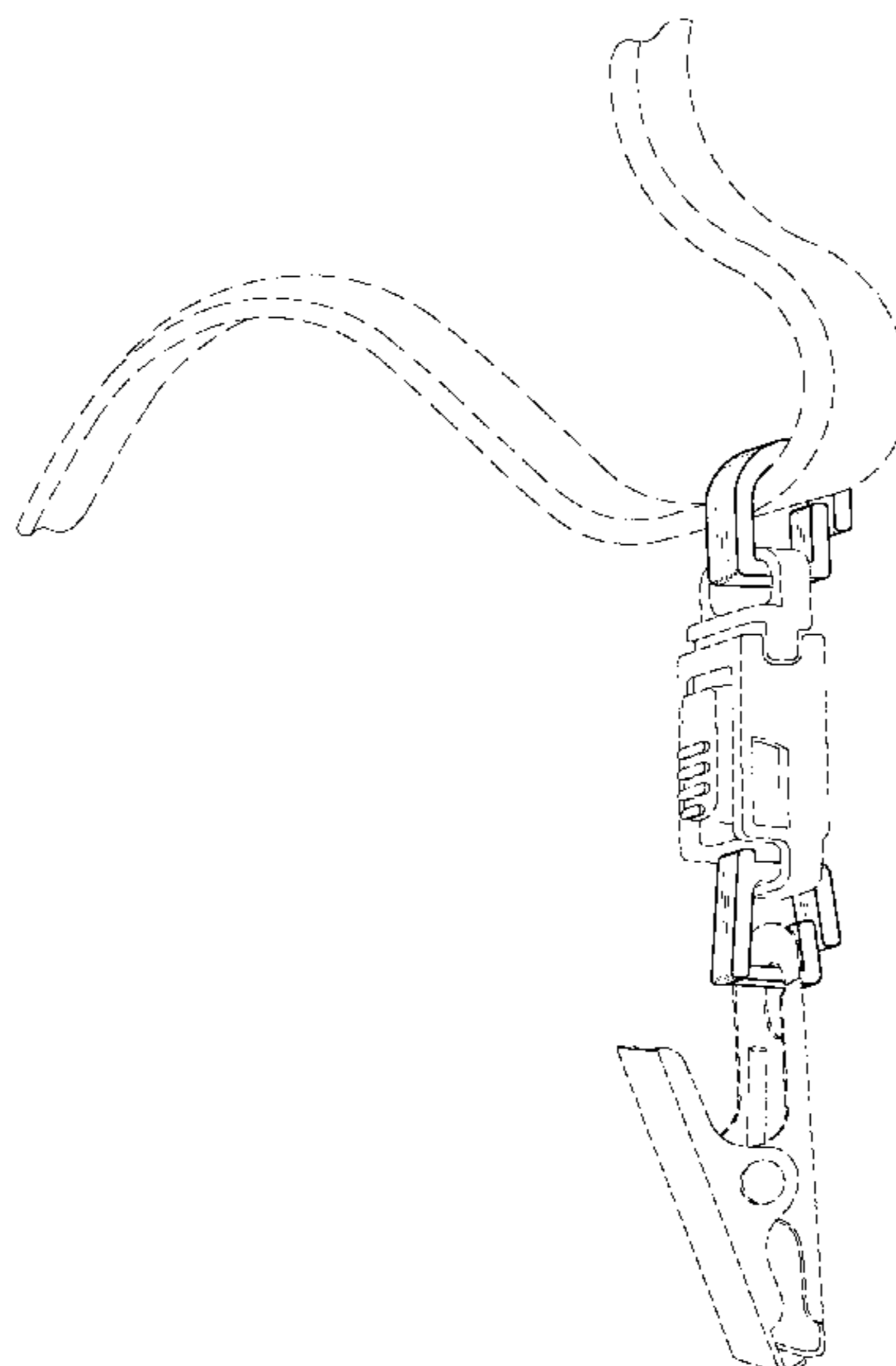

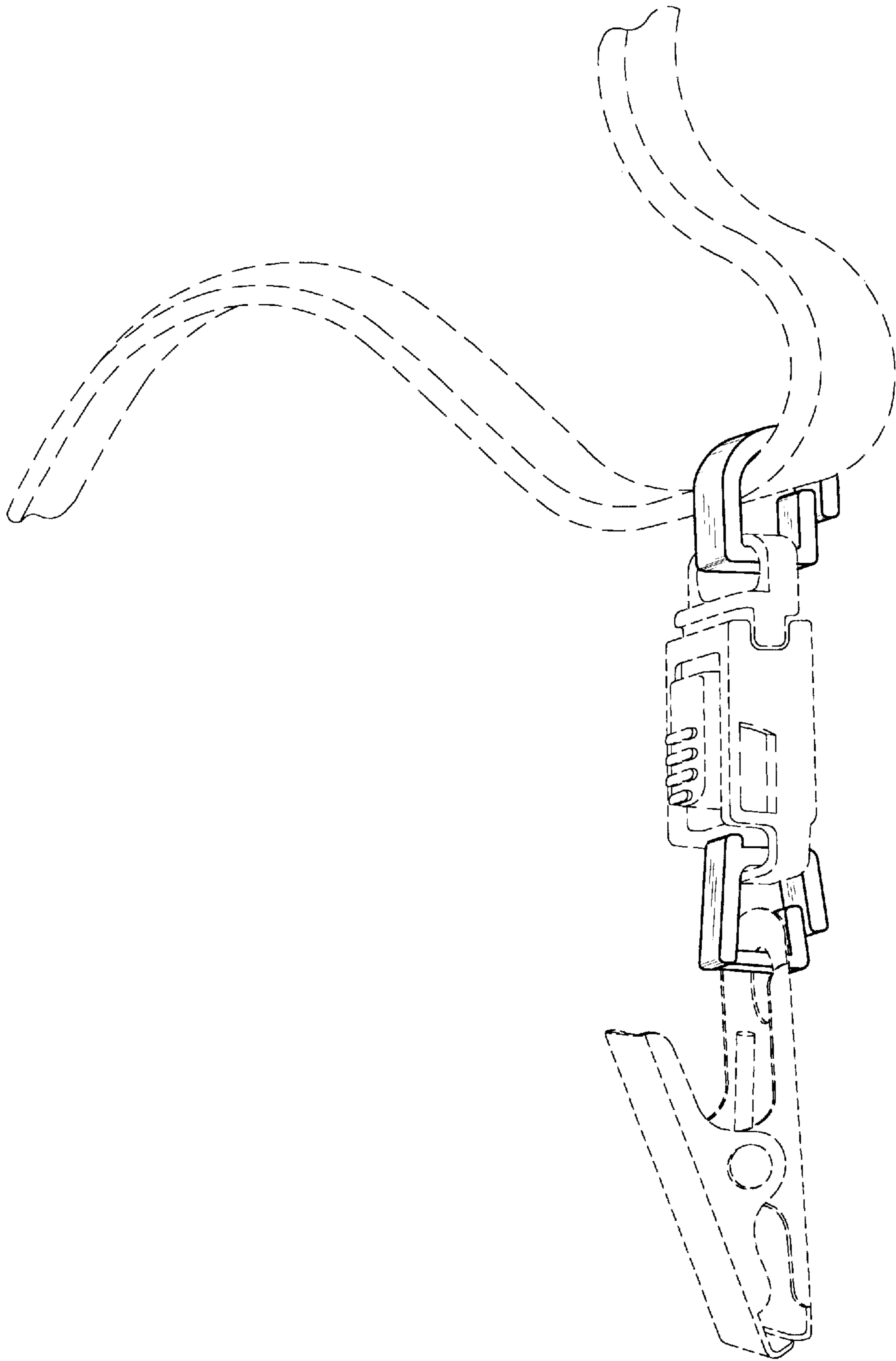

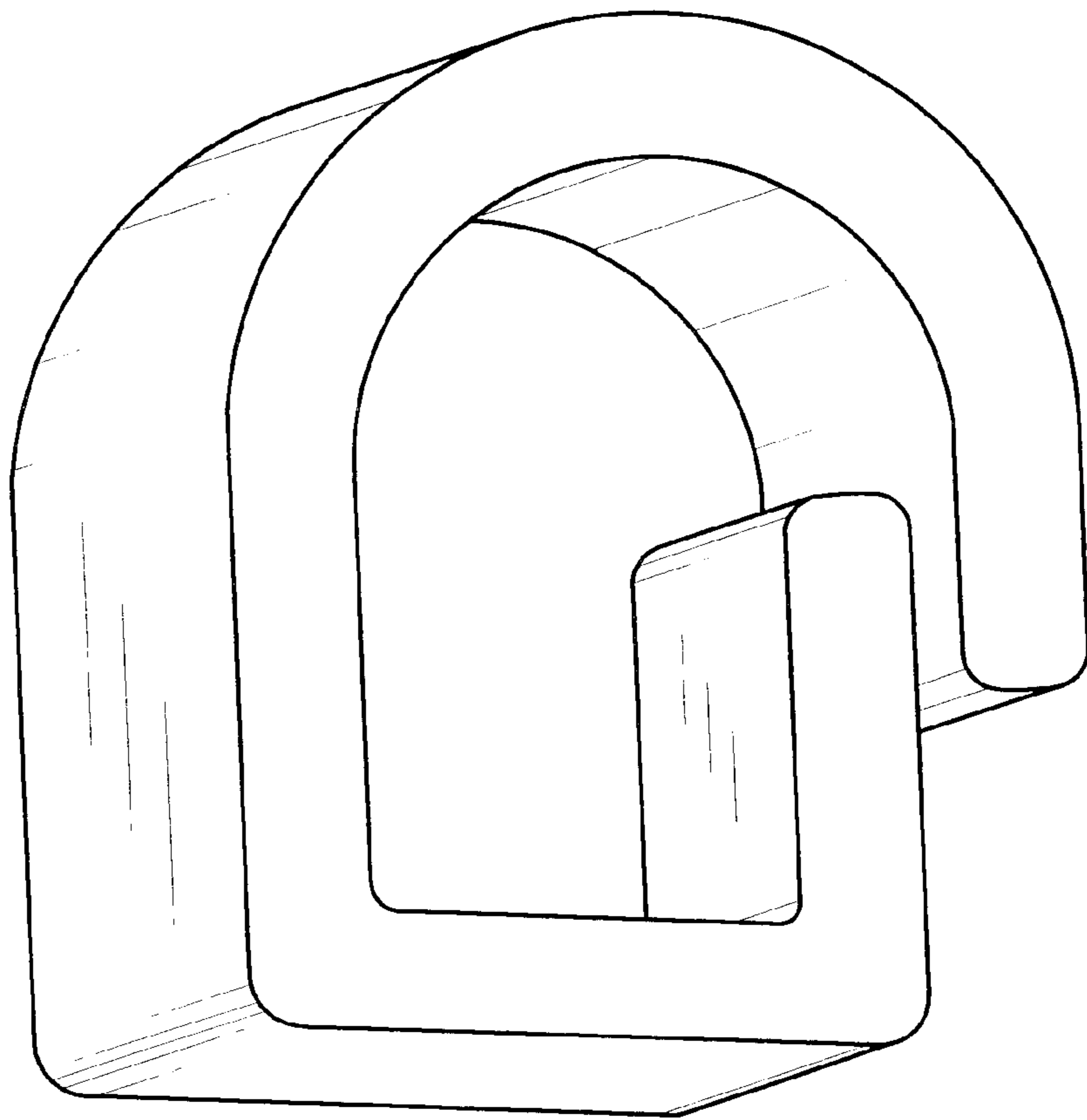

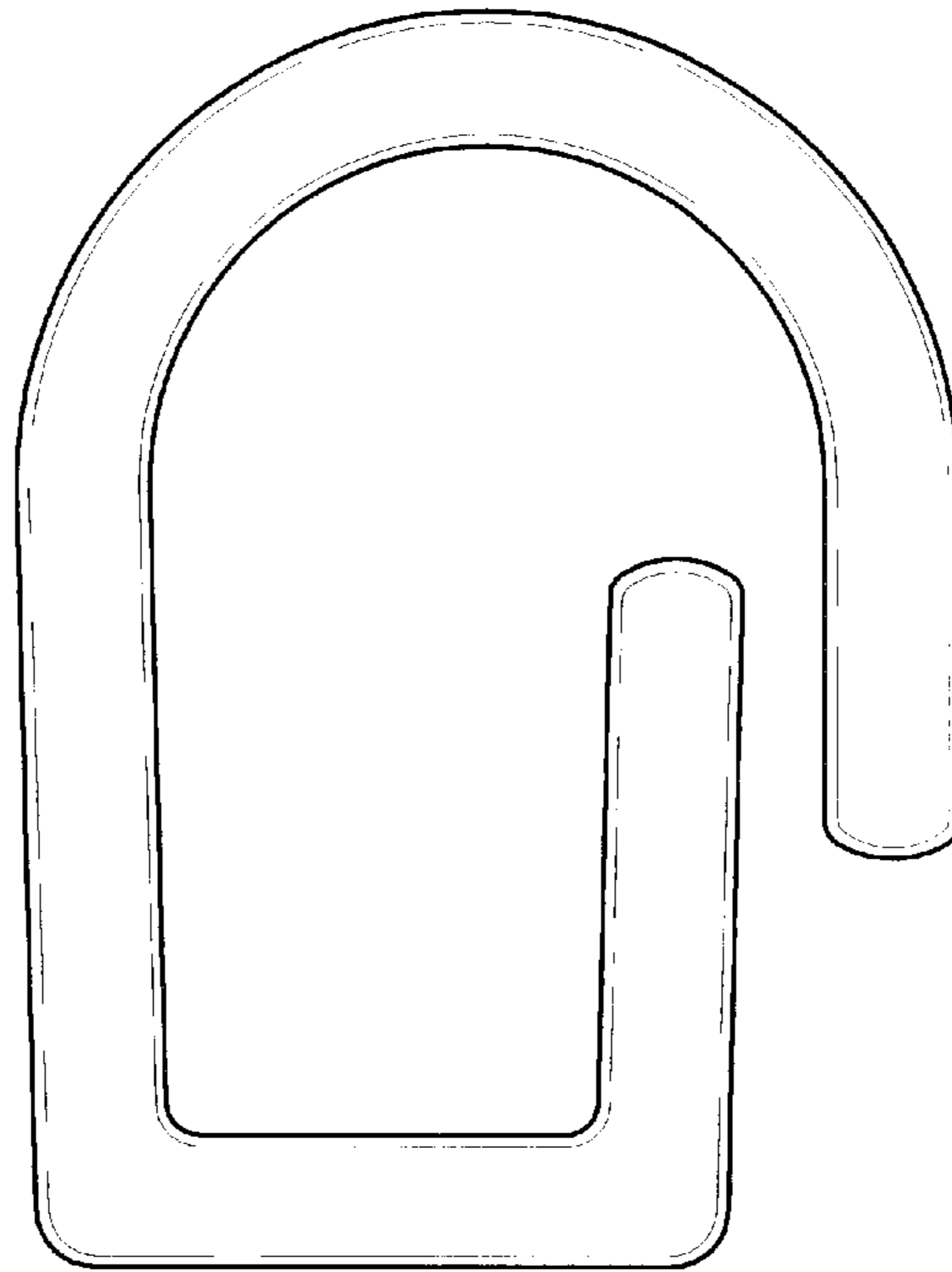




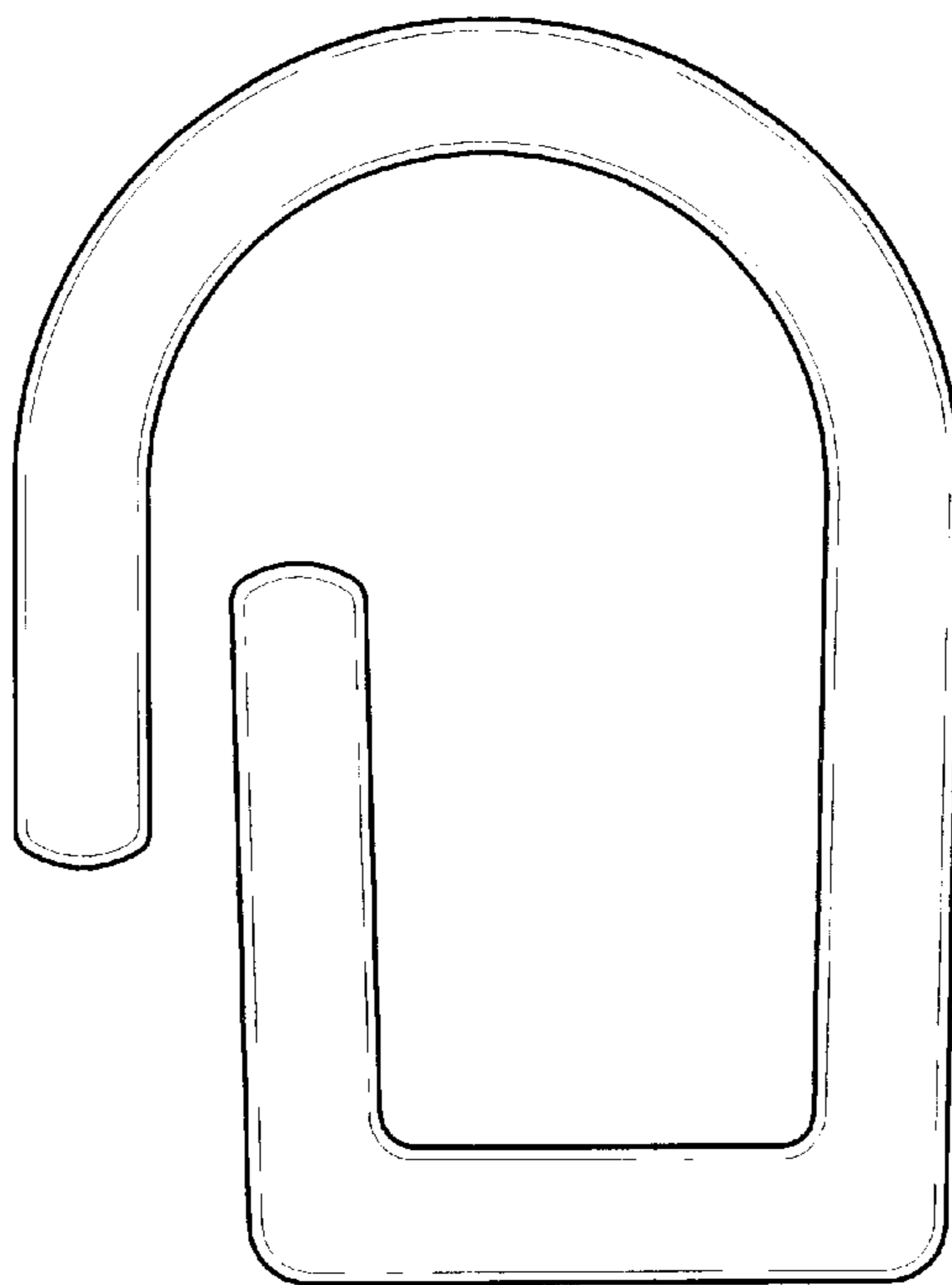

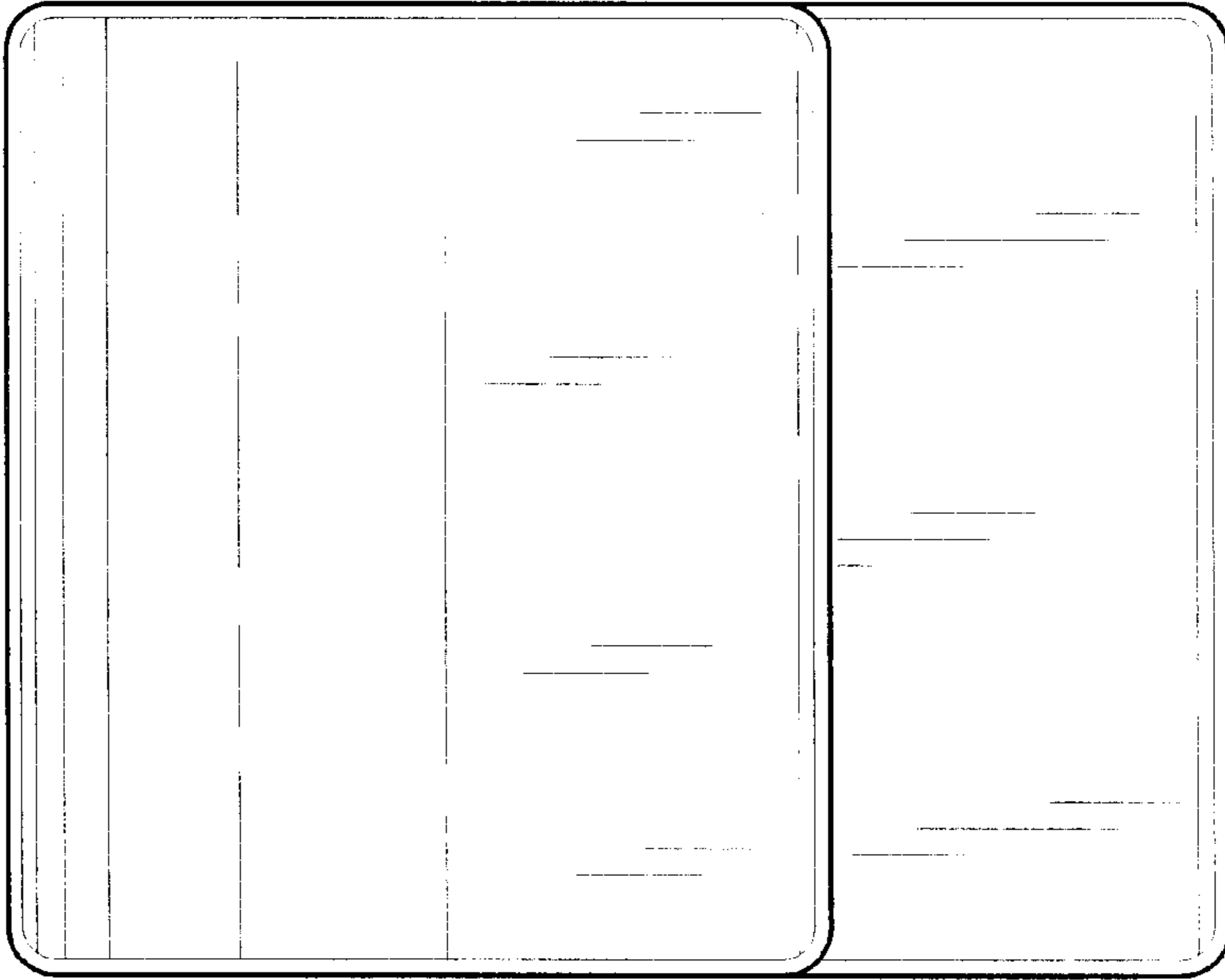

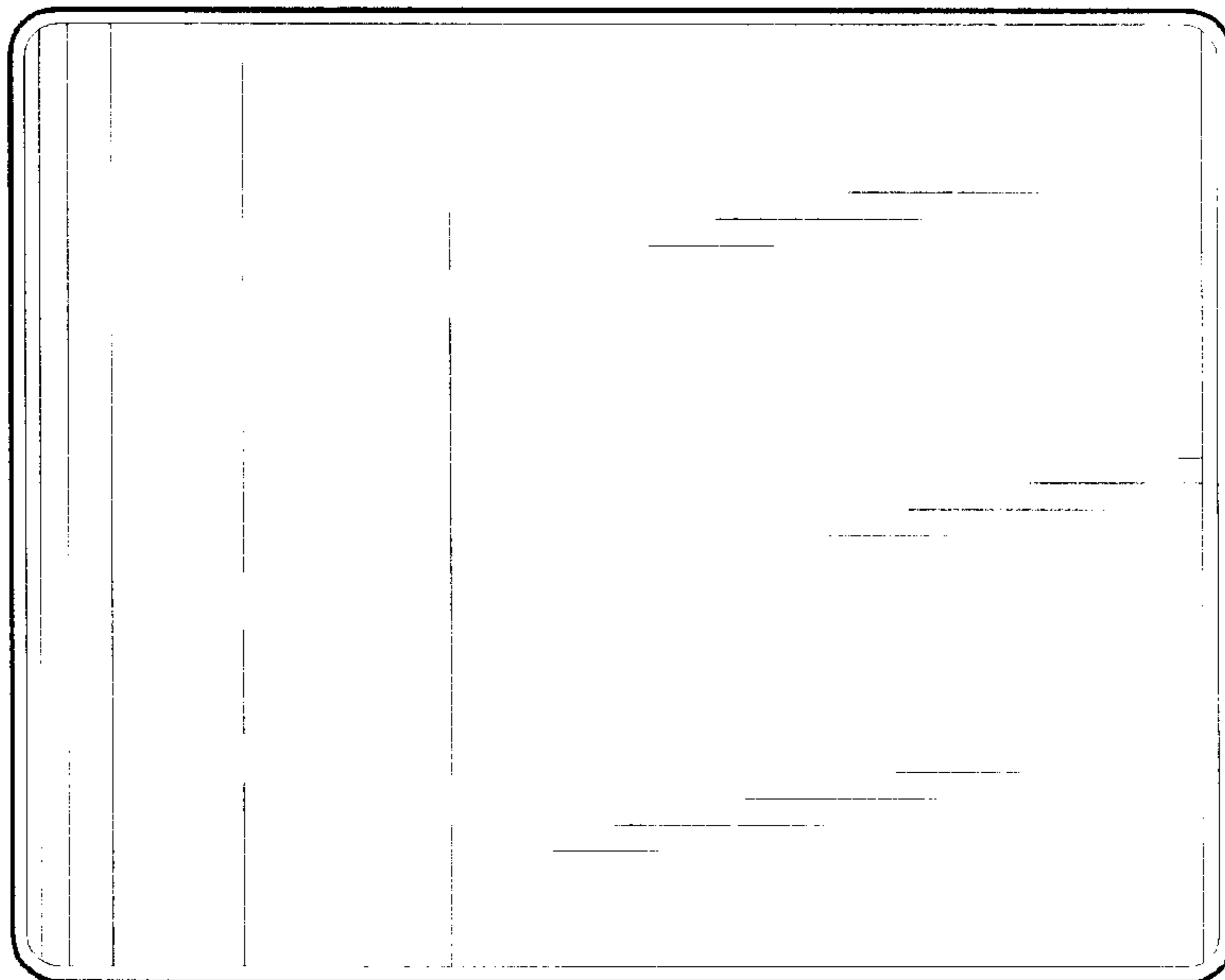

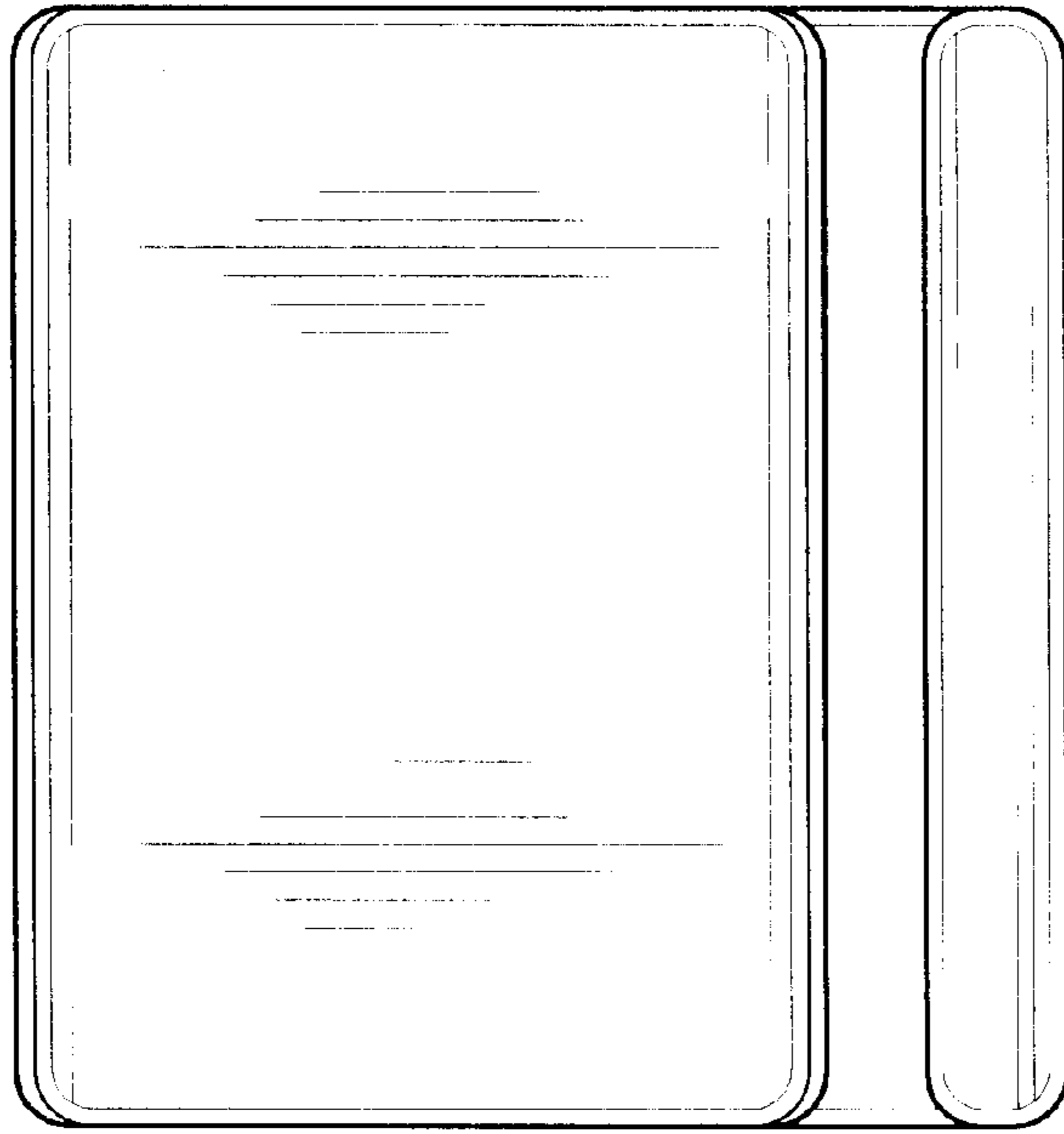

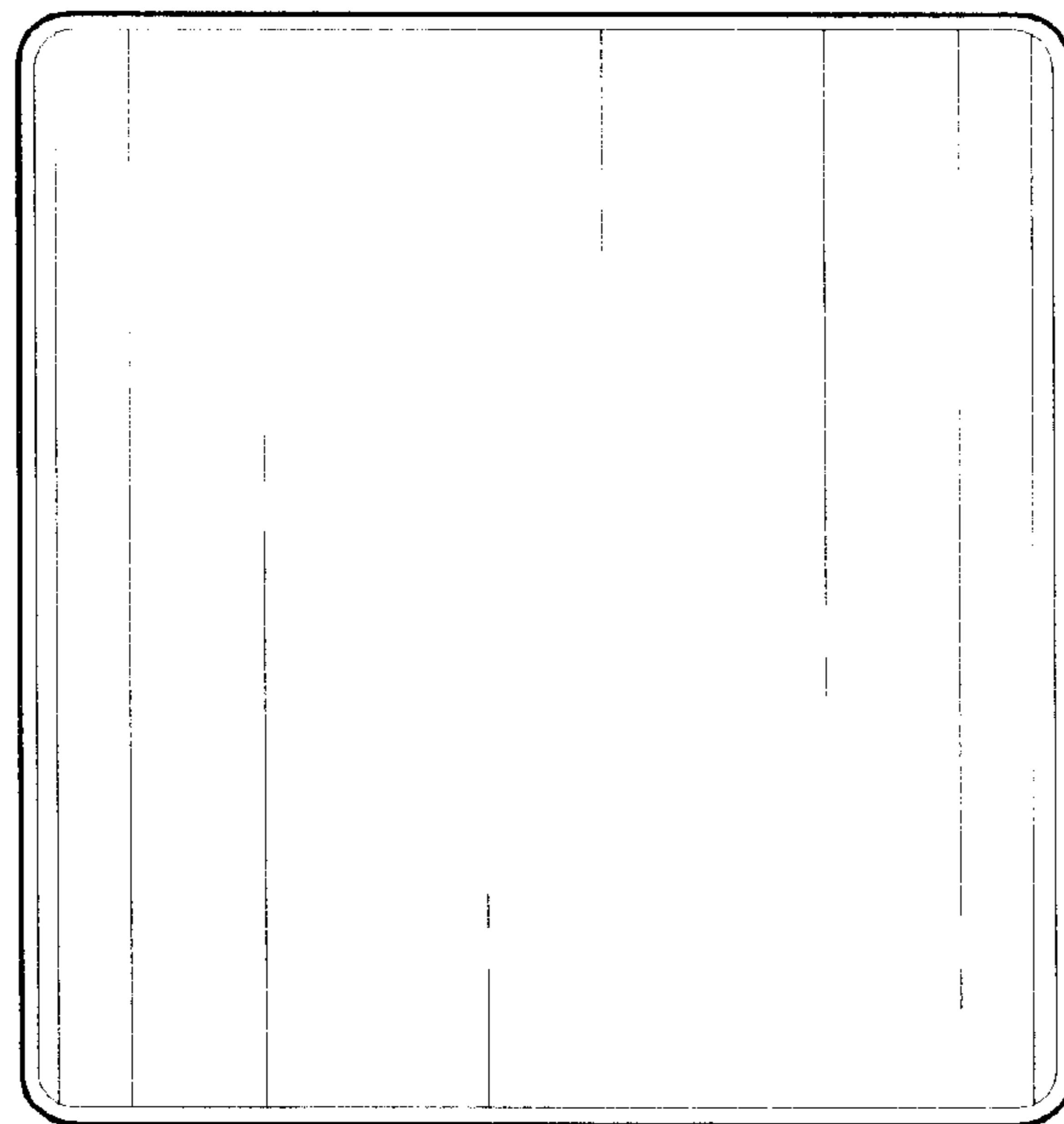

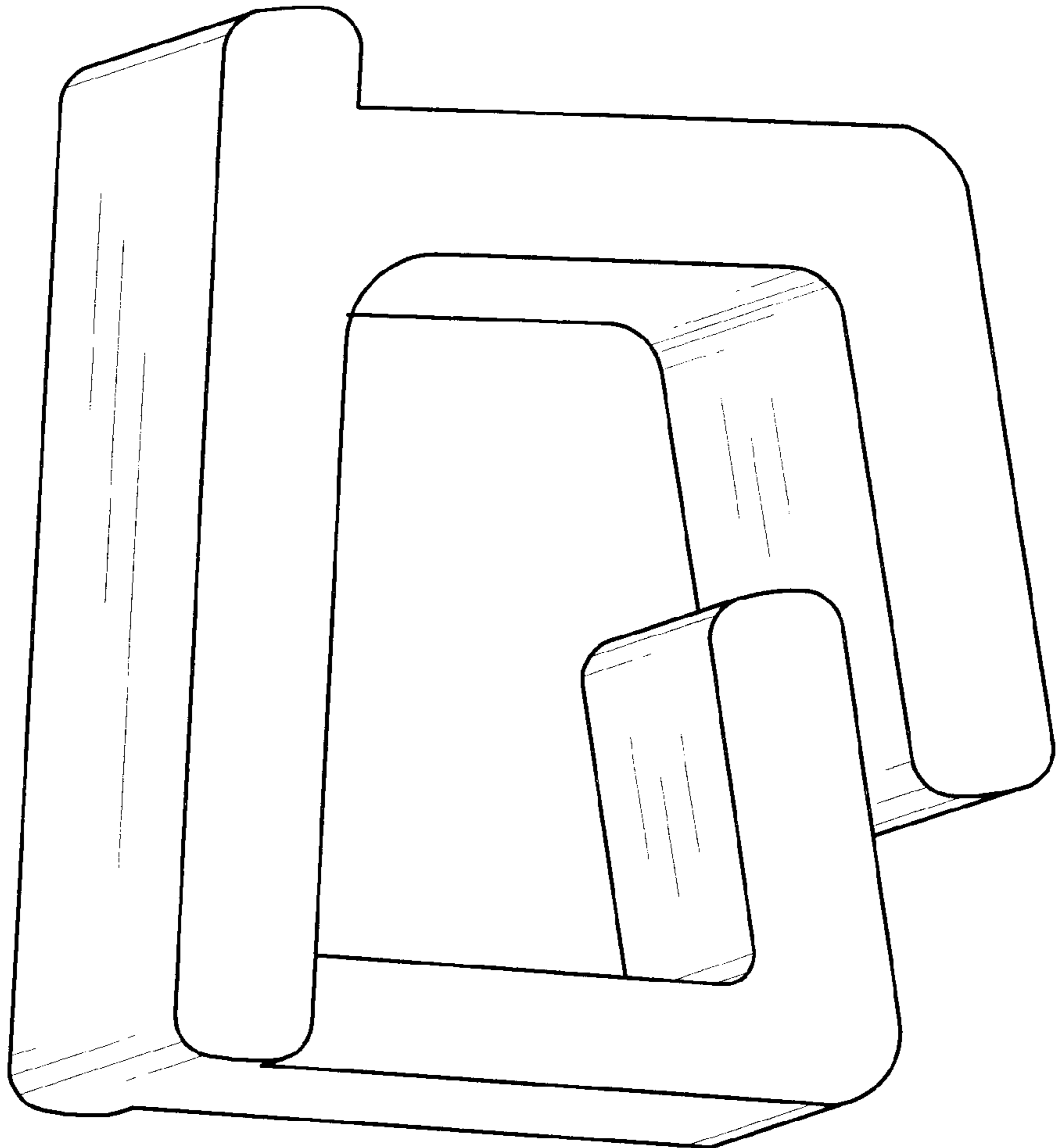

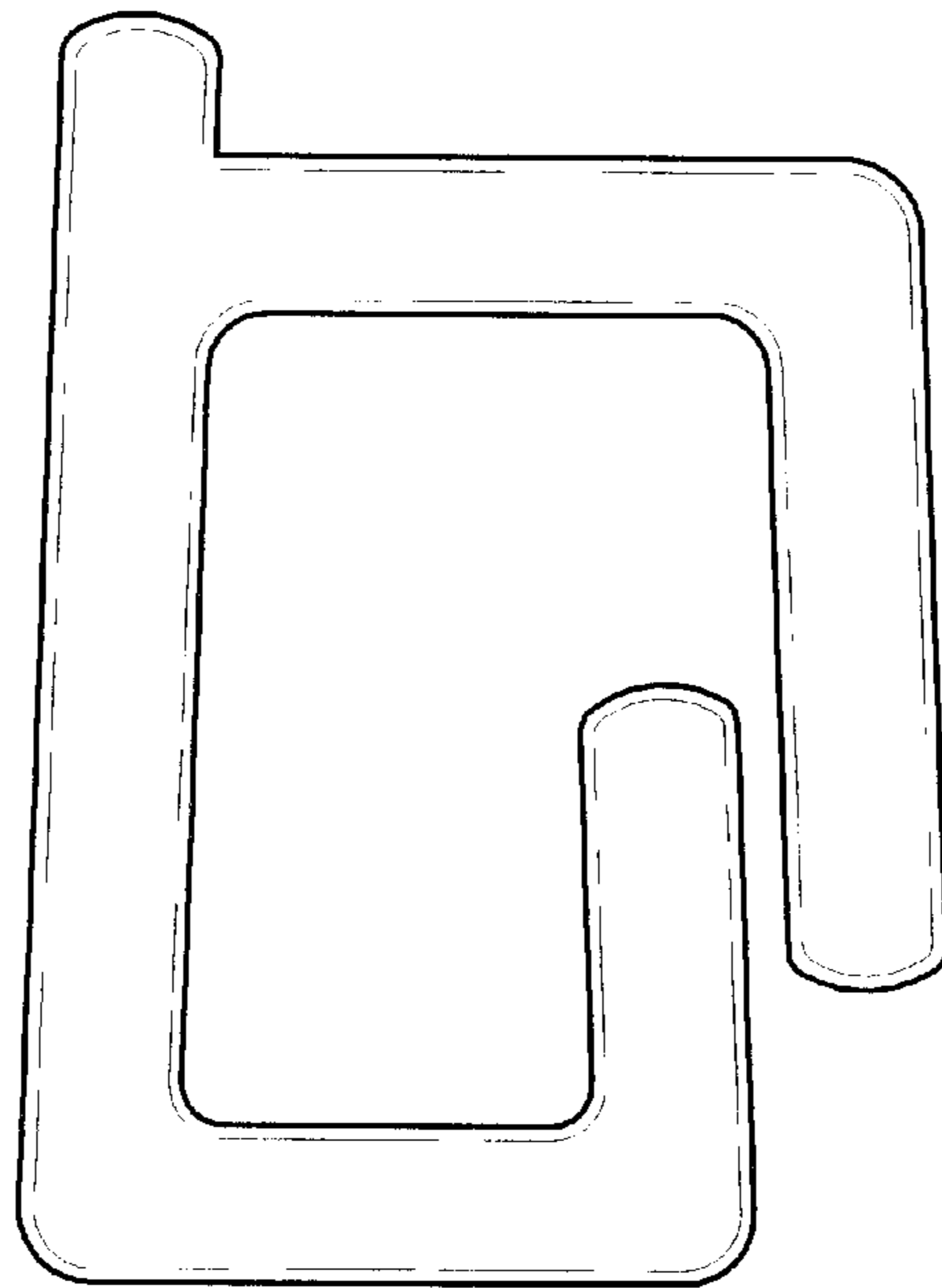

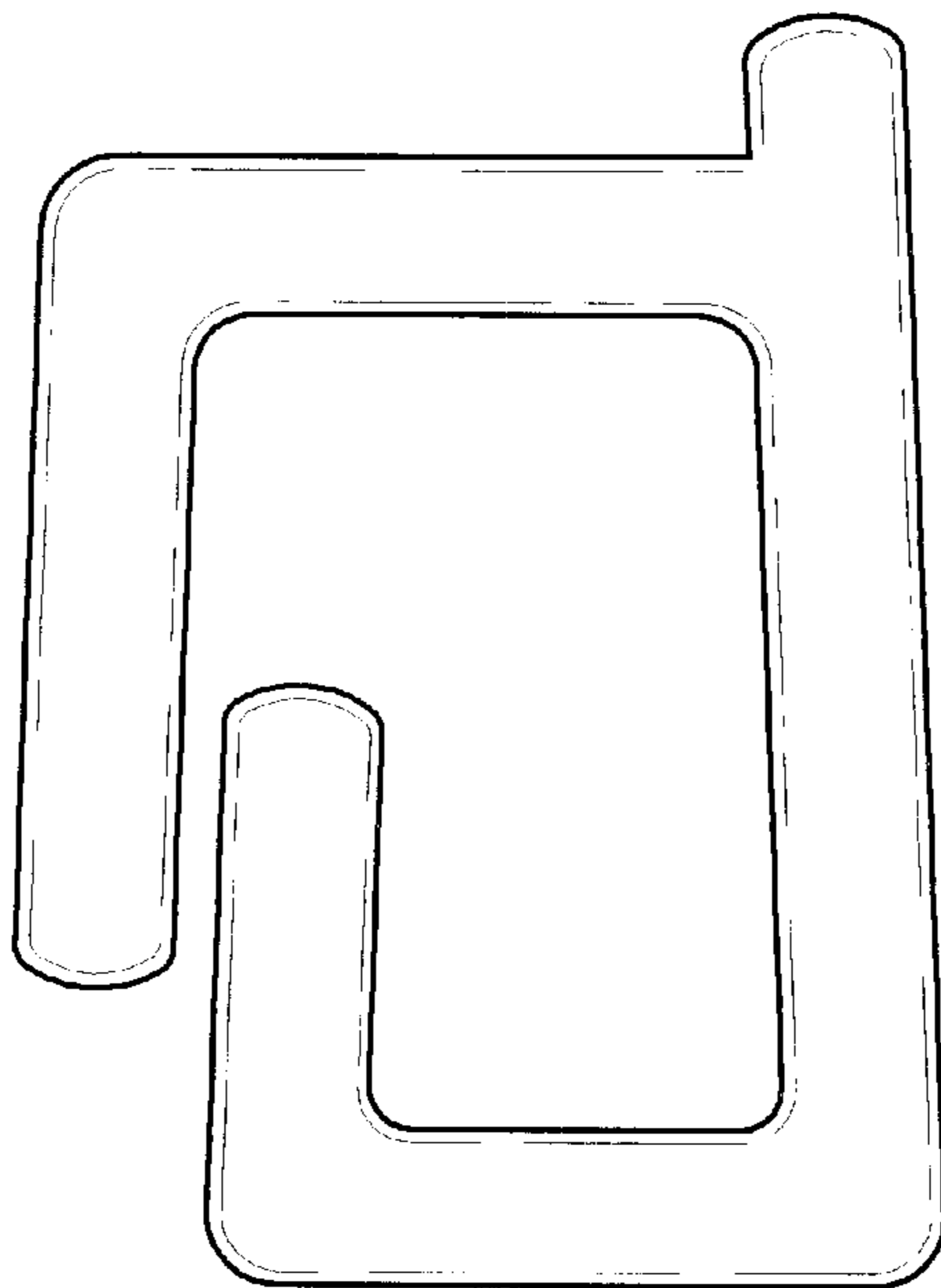

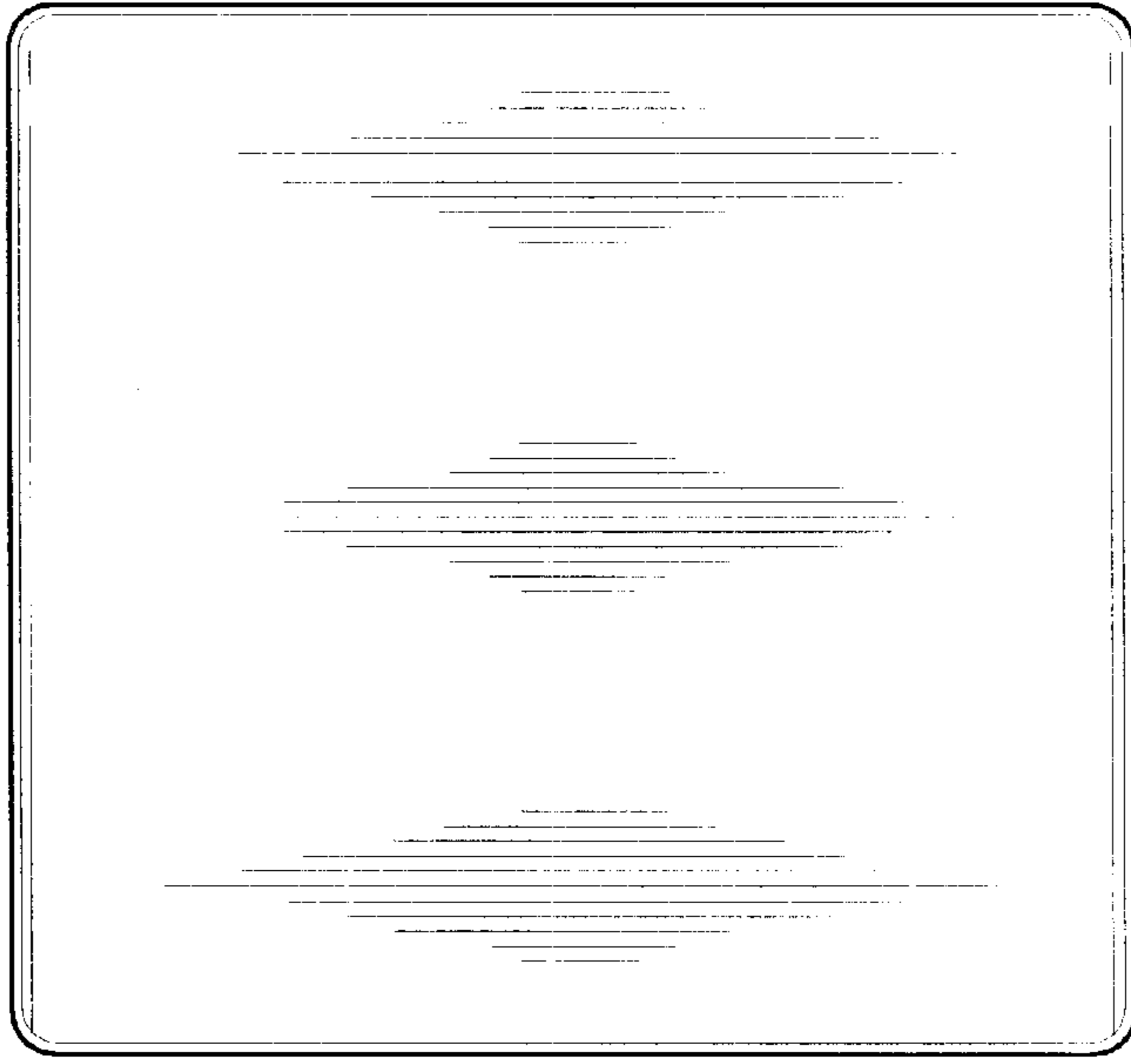

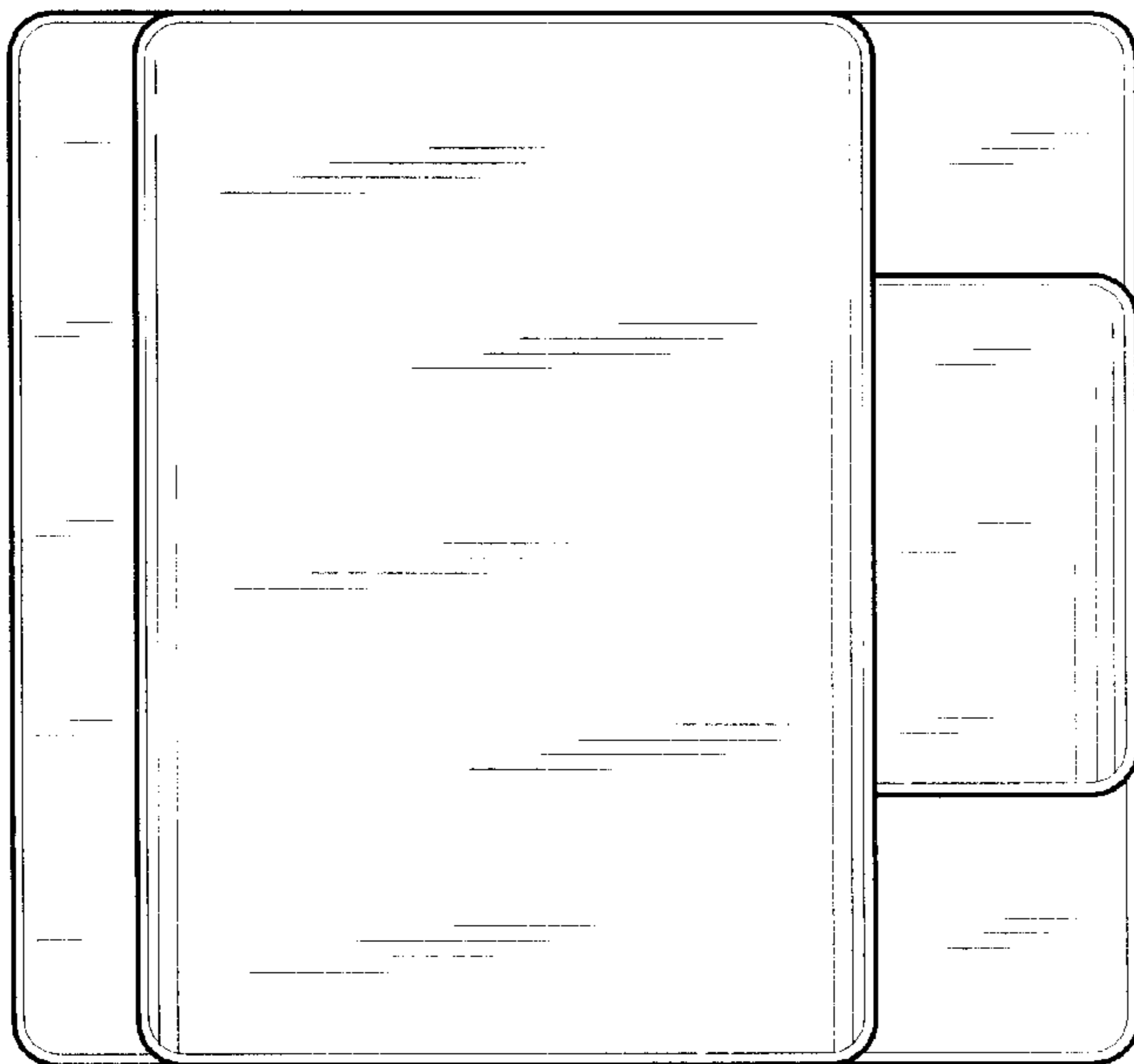

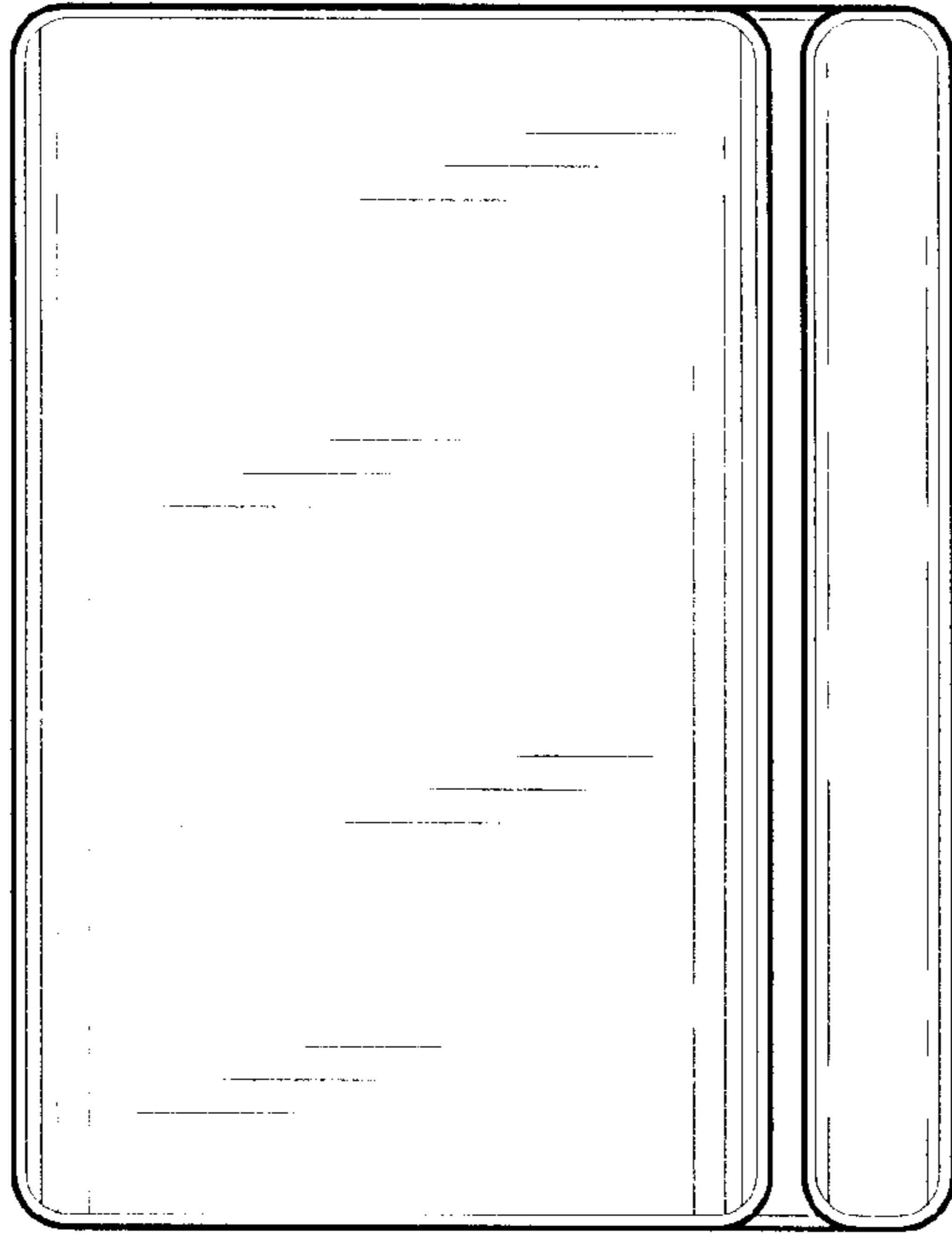




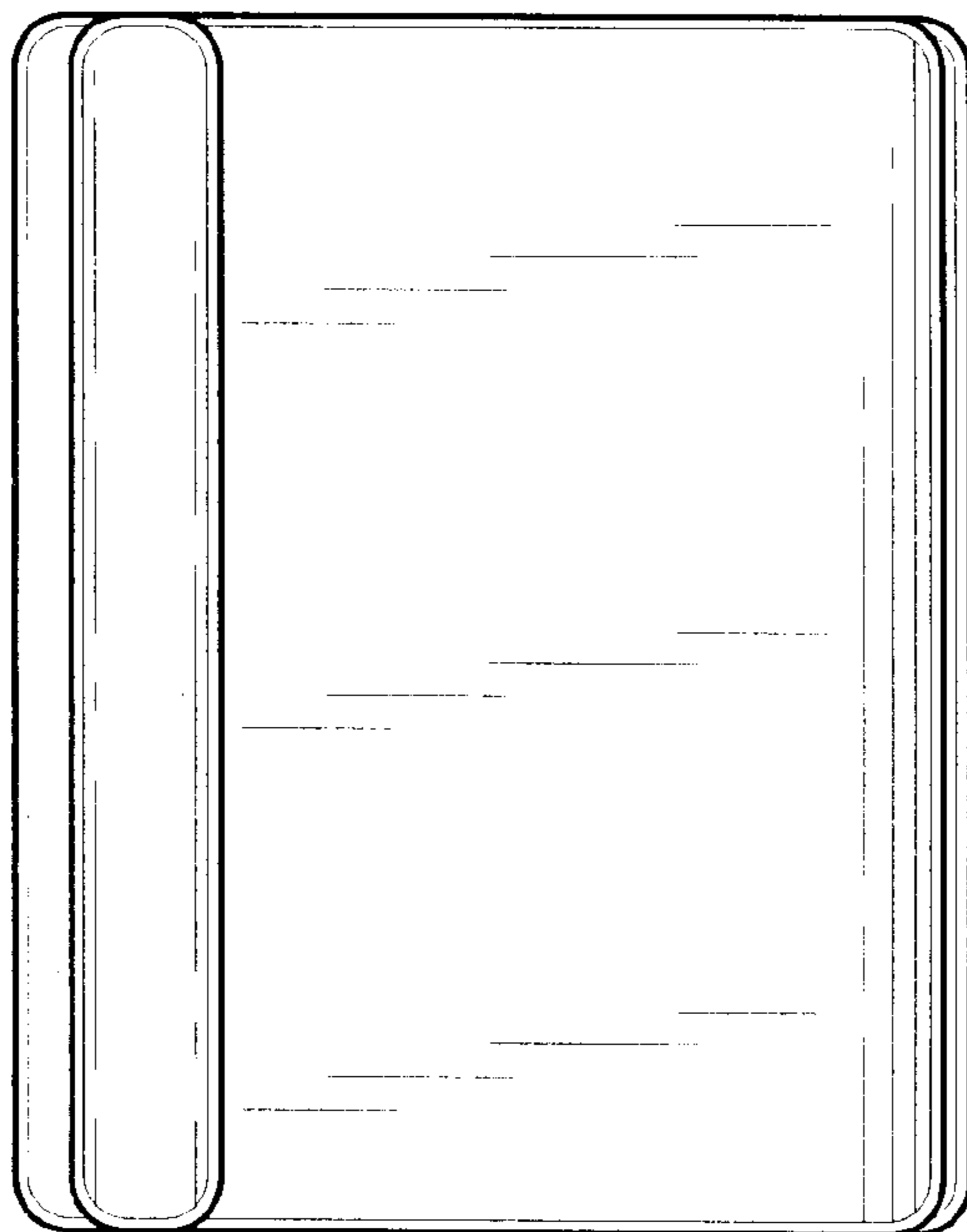
