FIG. 3 is an opposite side view thereof;

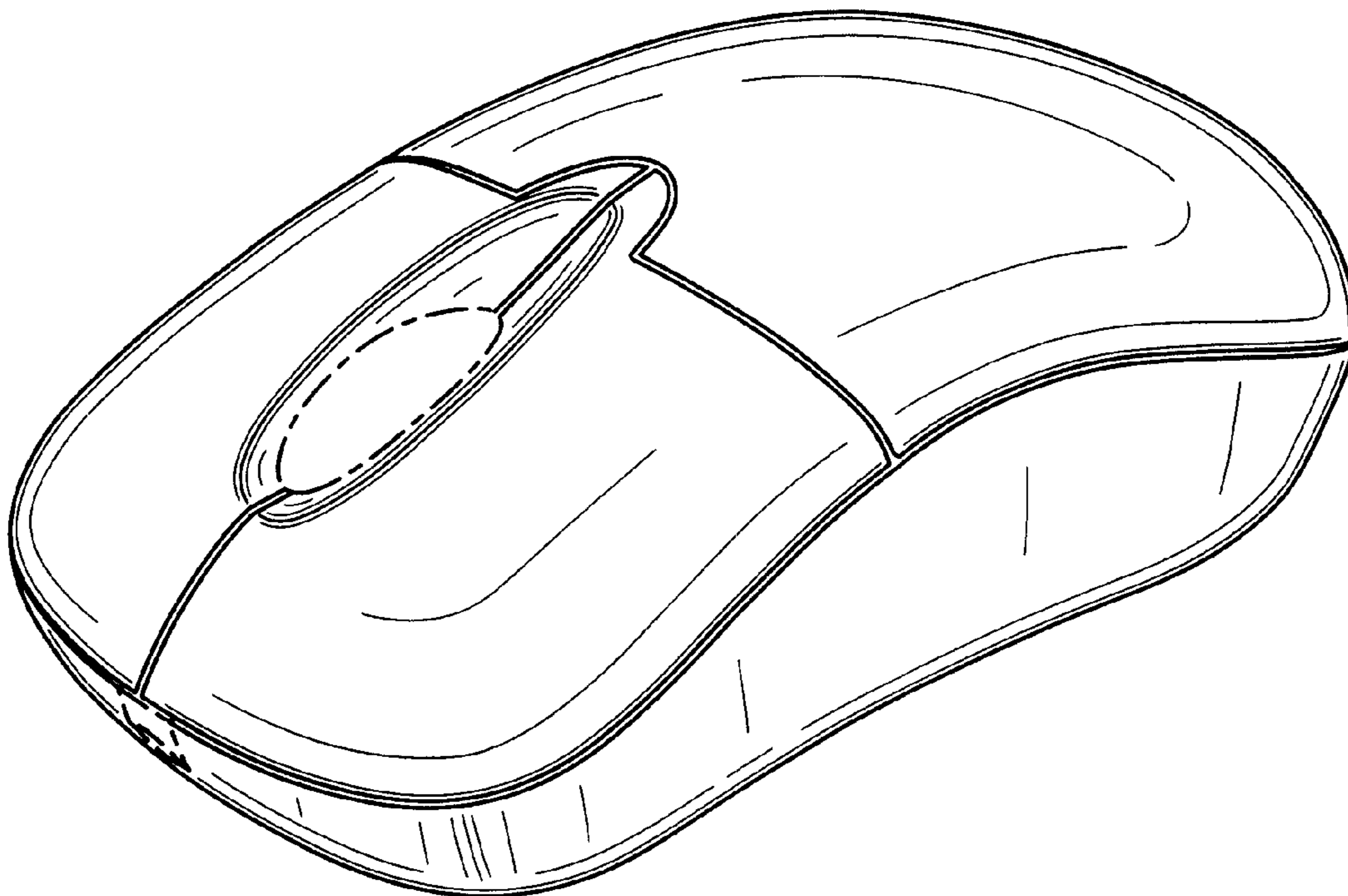
FIG. 4 is a front view thereof;

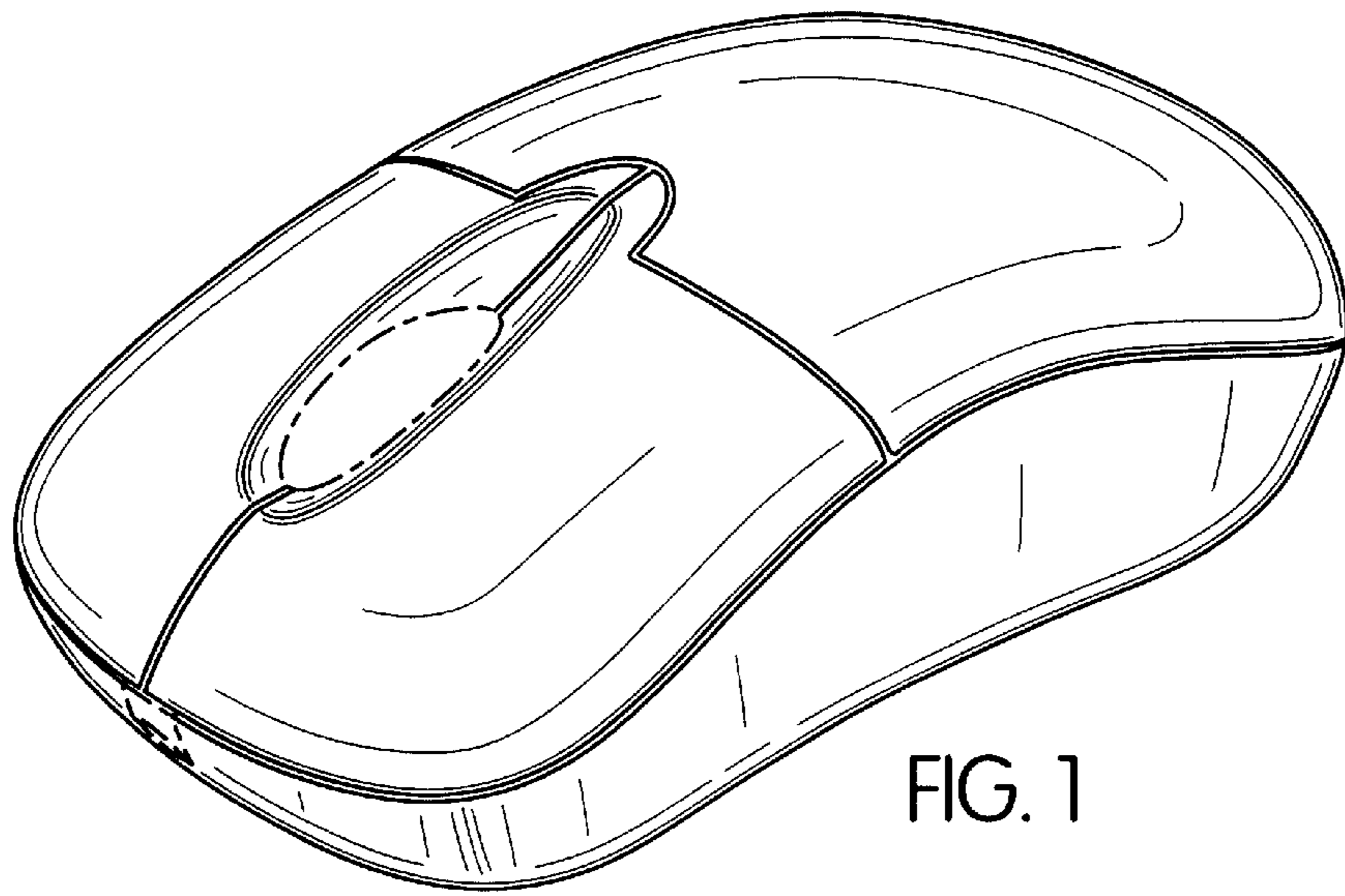

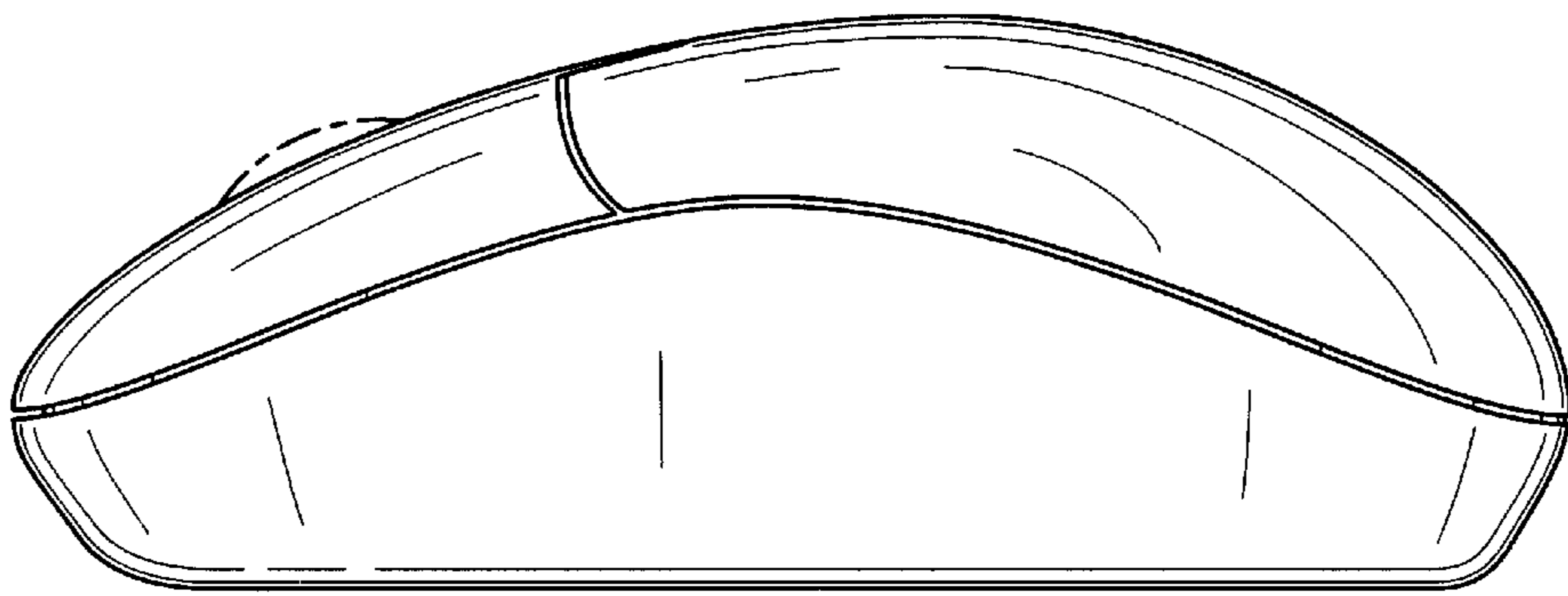

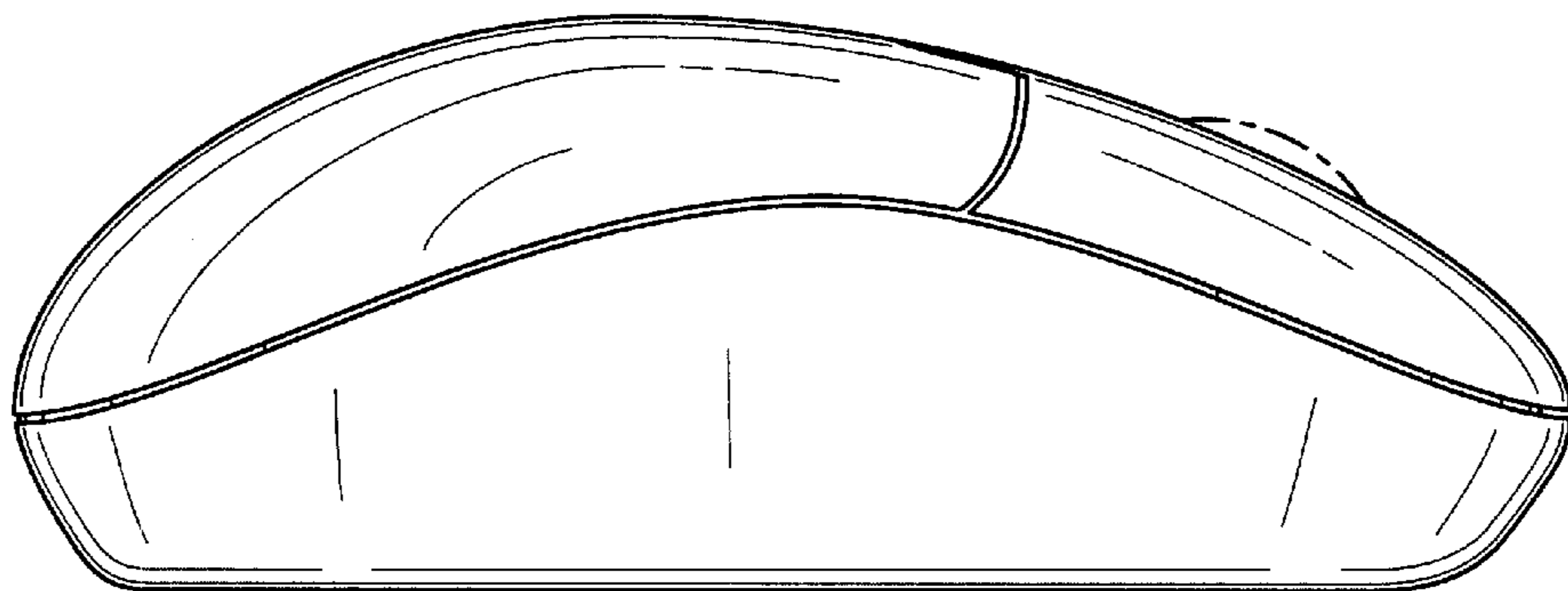

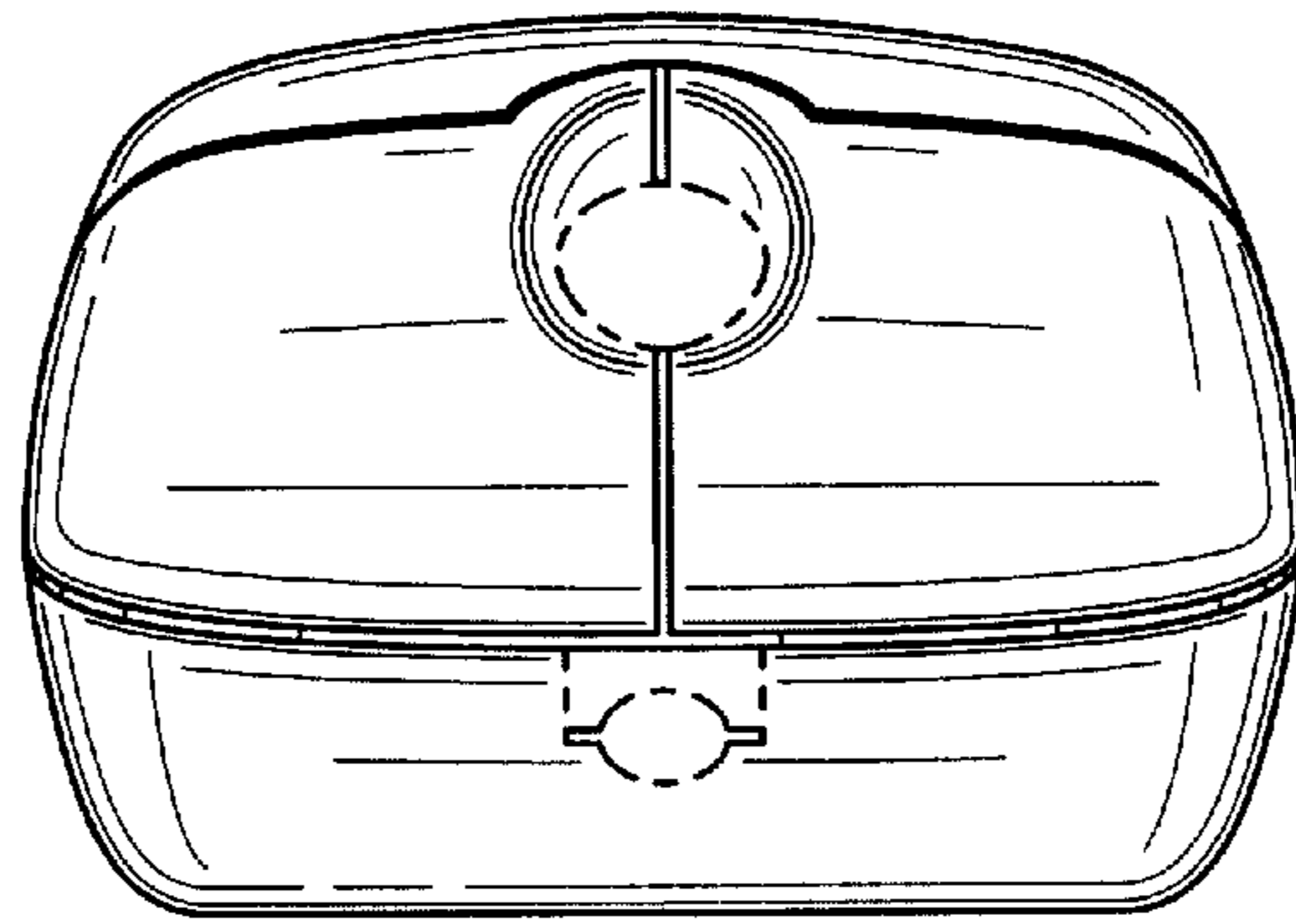

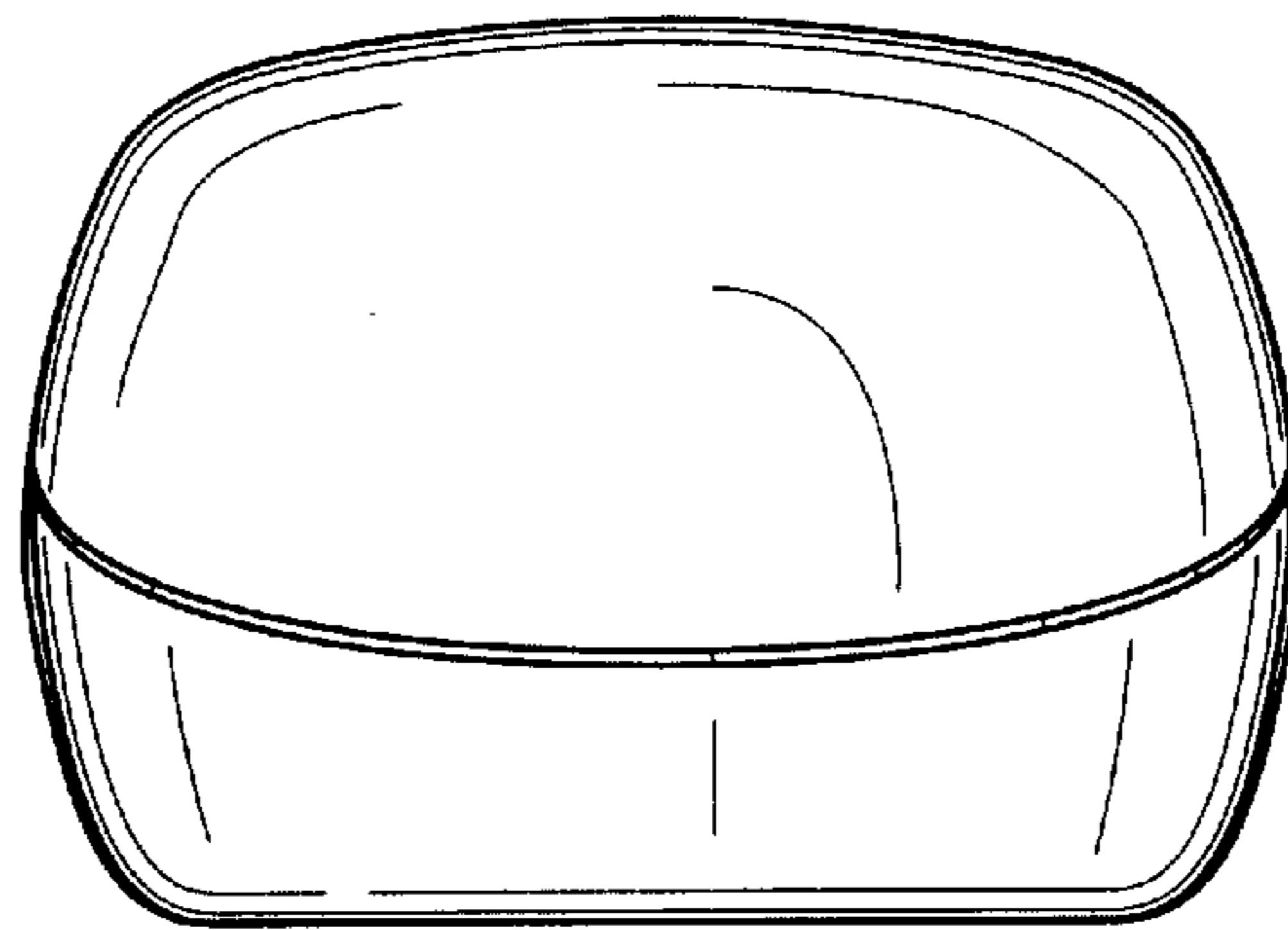

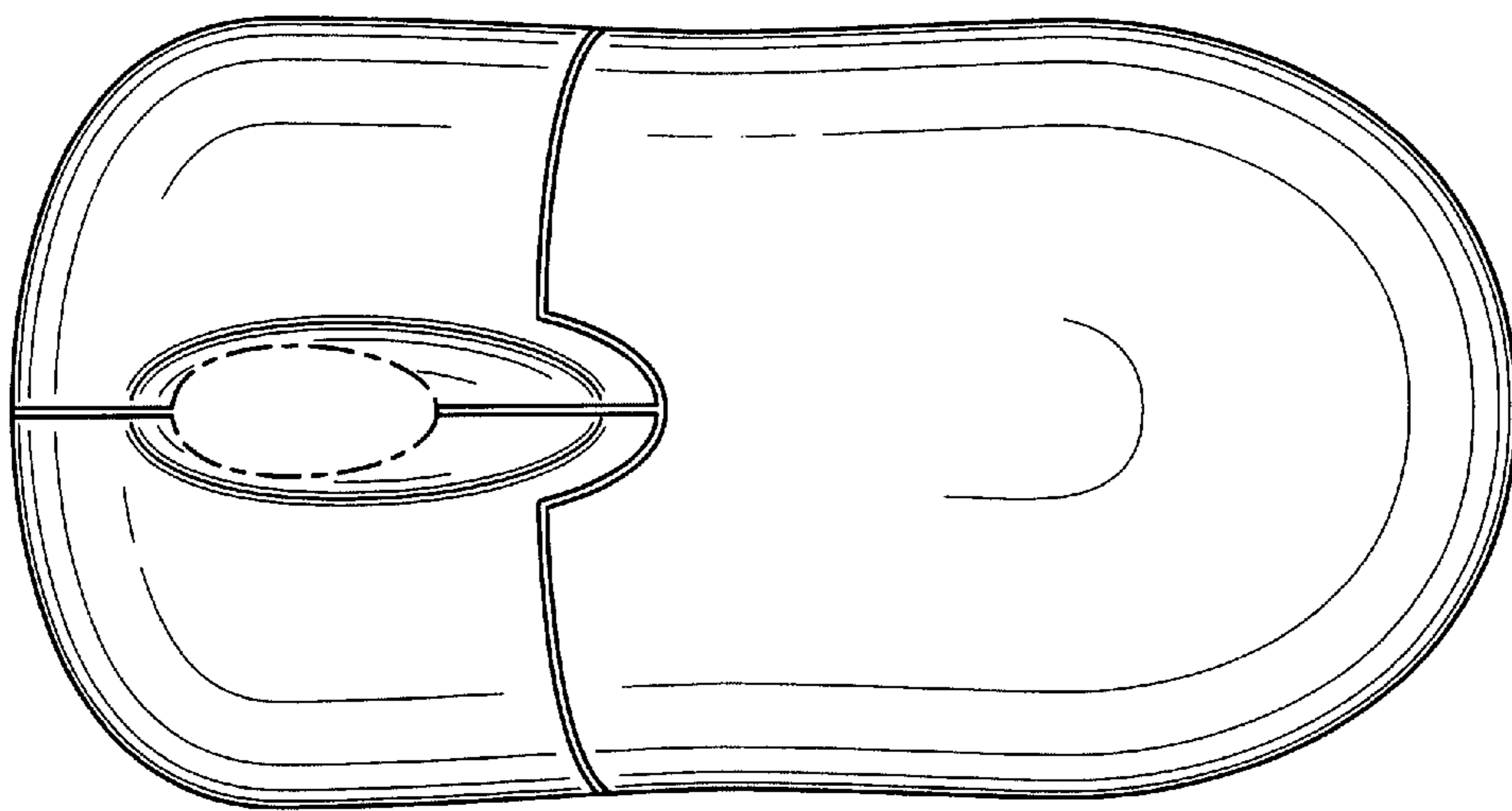
