(57) **CLAIM**

The ornamental design for an envelope pack, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the erected envelope pack showing my new design;

FIG. 2 is a bottom perspective view of the erected envelope pack showing my new design;

FIG. 3 is a top plan view of the blank of the envelope pack shown in FIGS. 1 and 2;

FIG. 4 is a top side elevational view of the blank shown in FIG. 3;

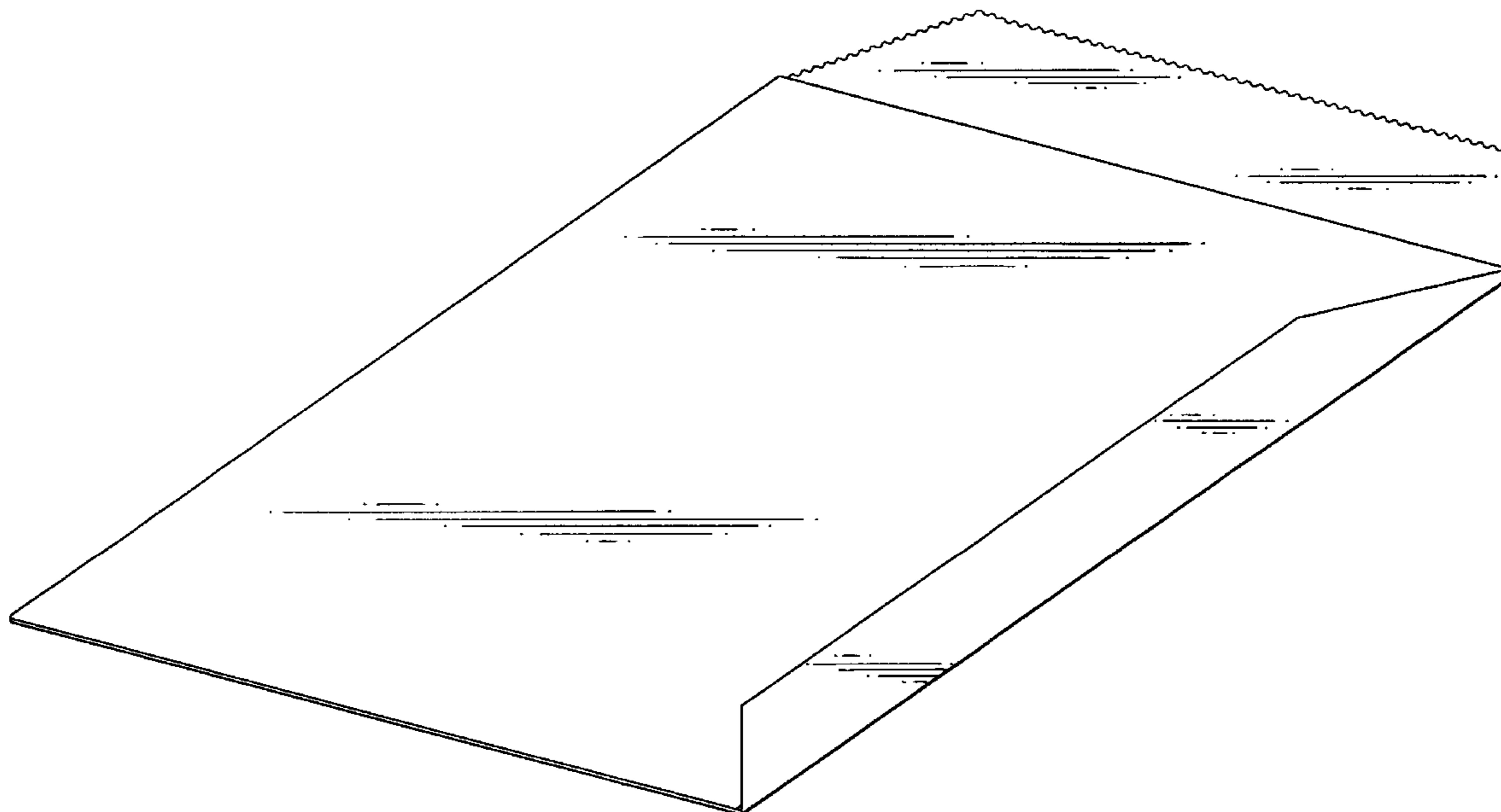
FIG. 5 is a bottom side elevational view of the blank shown in FIG. 3;

FIG. 6 is a left side elevational view of the blank shown in FIG. 3;

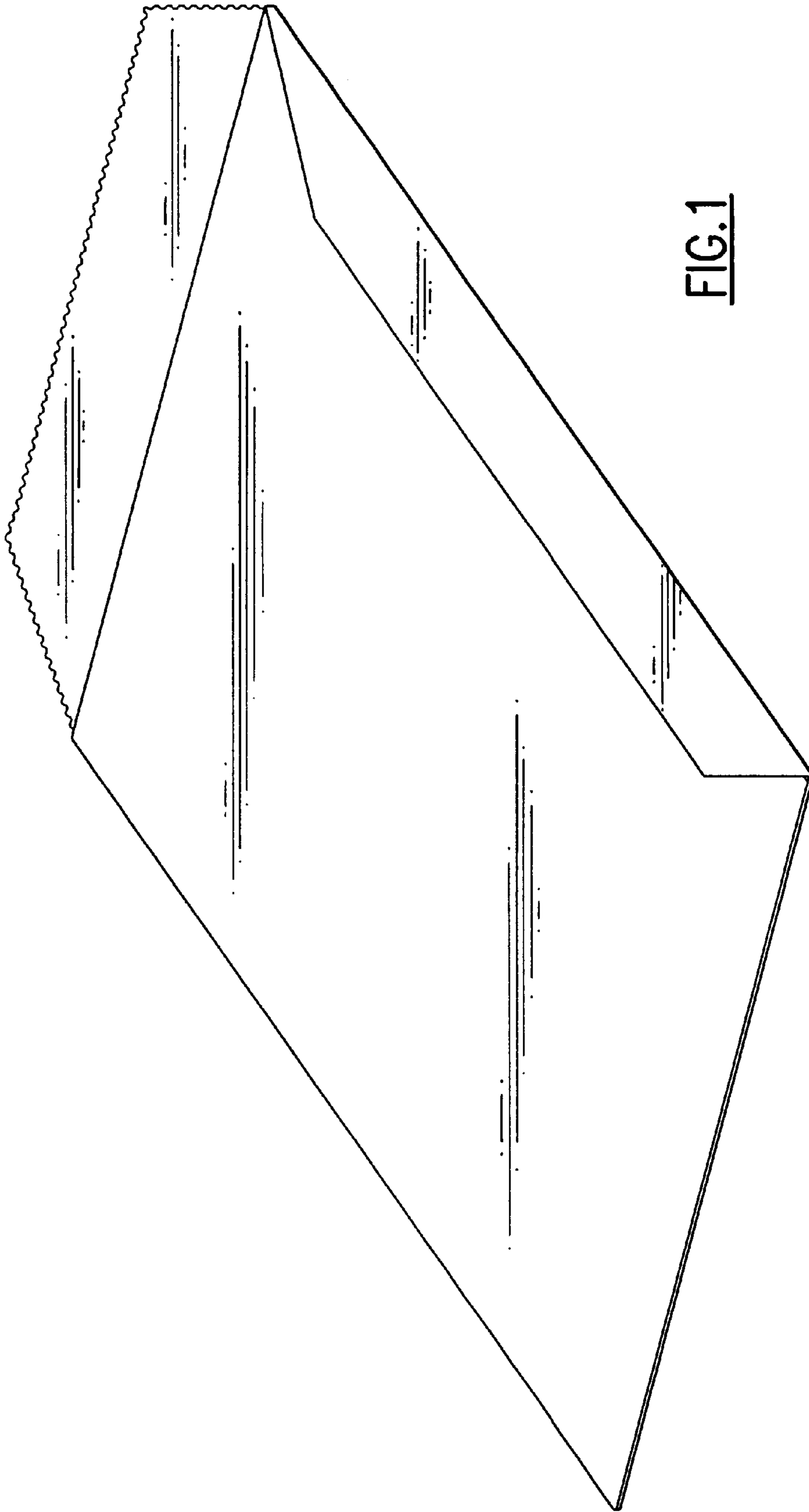

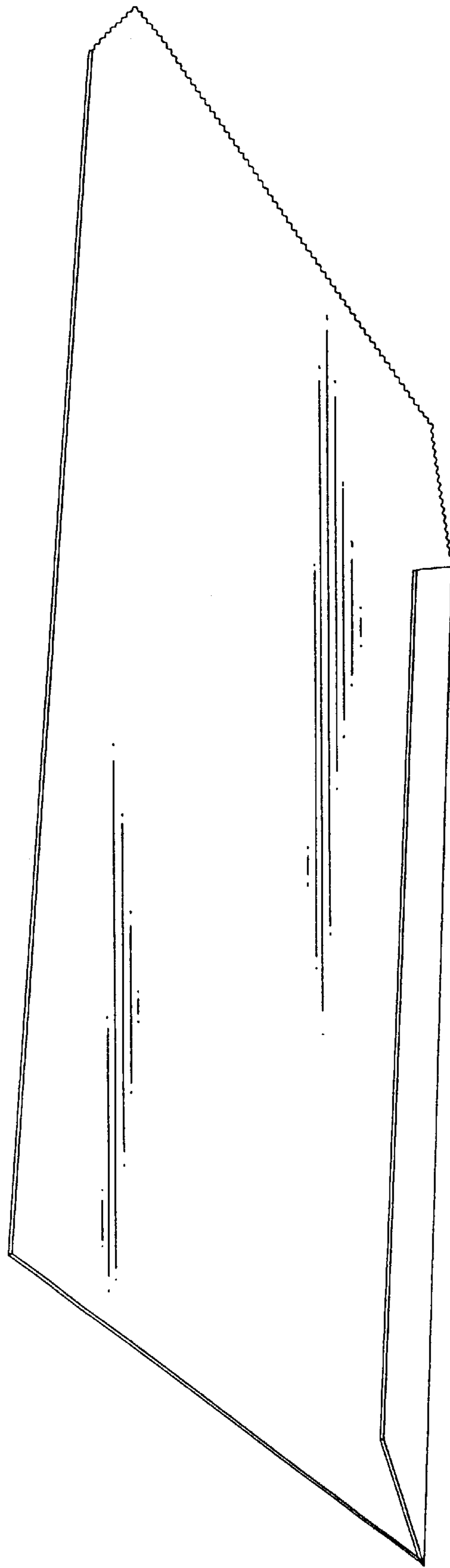

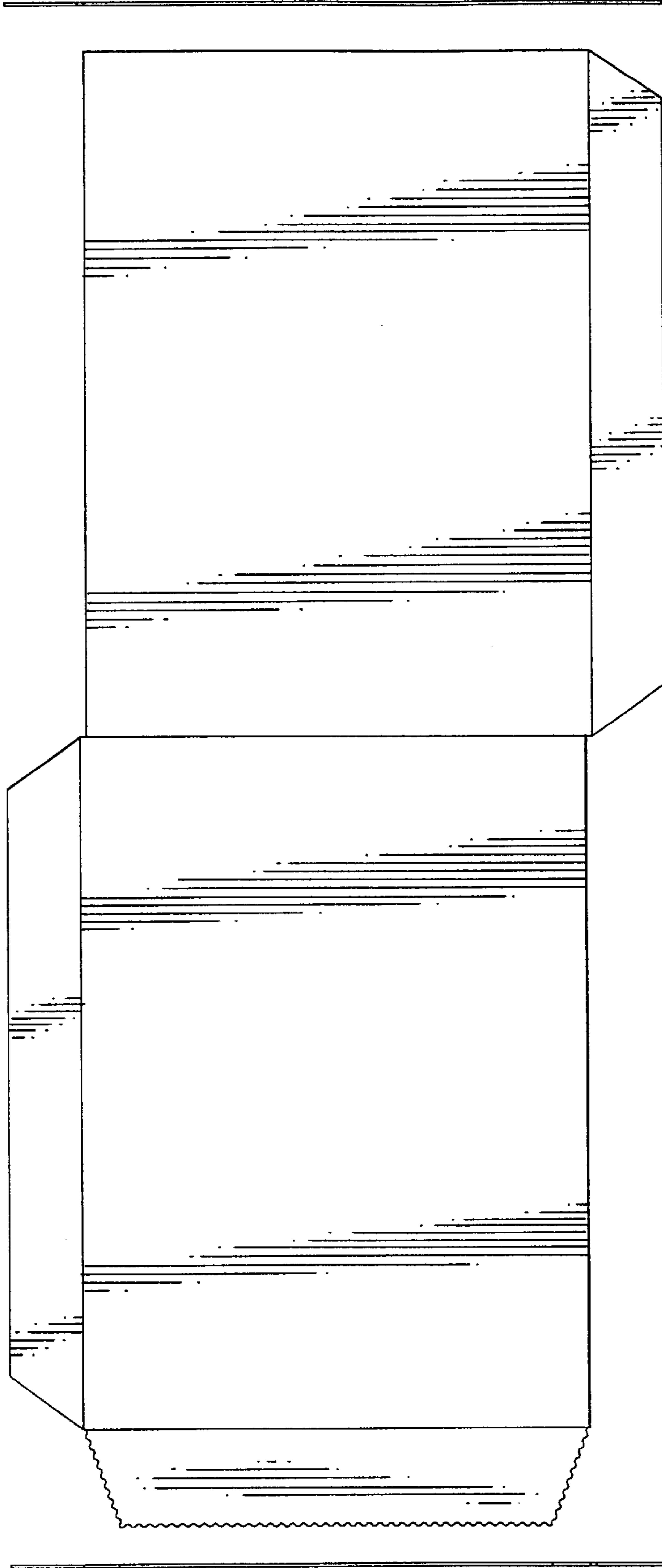

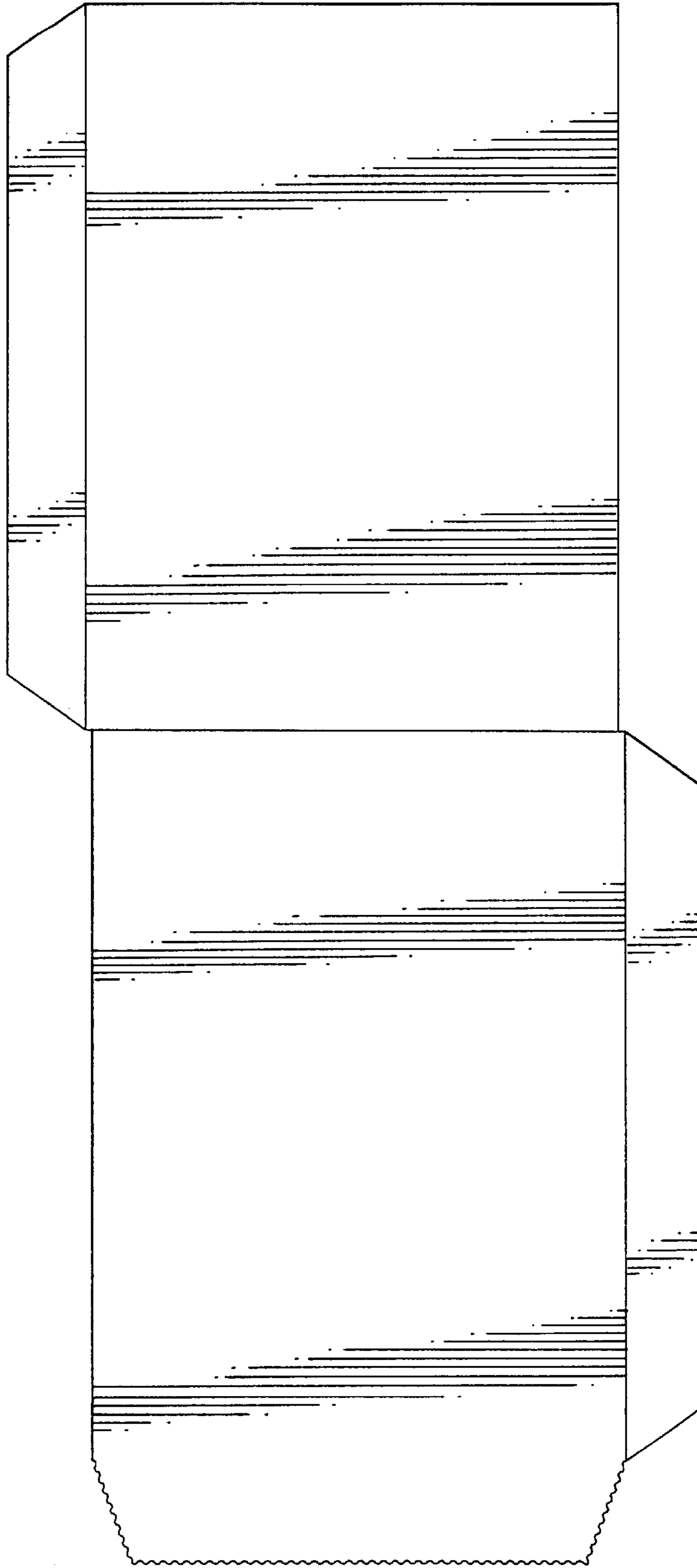
