The ornamental design for a footwear sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear sole embodying my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a left side elevational view thereof;

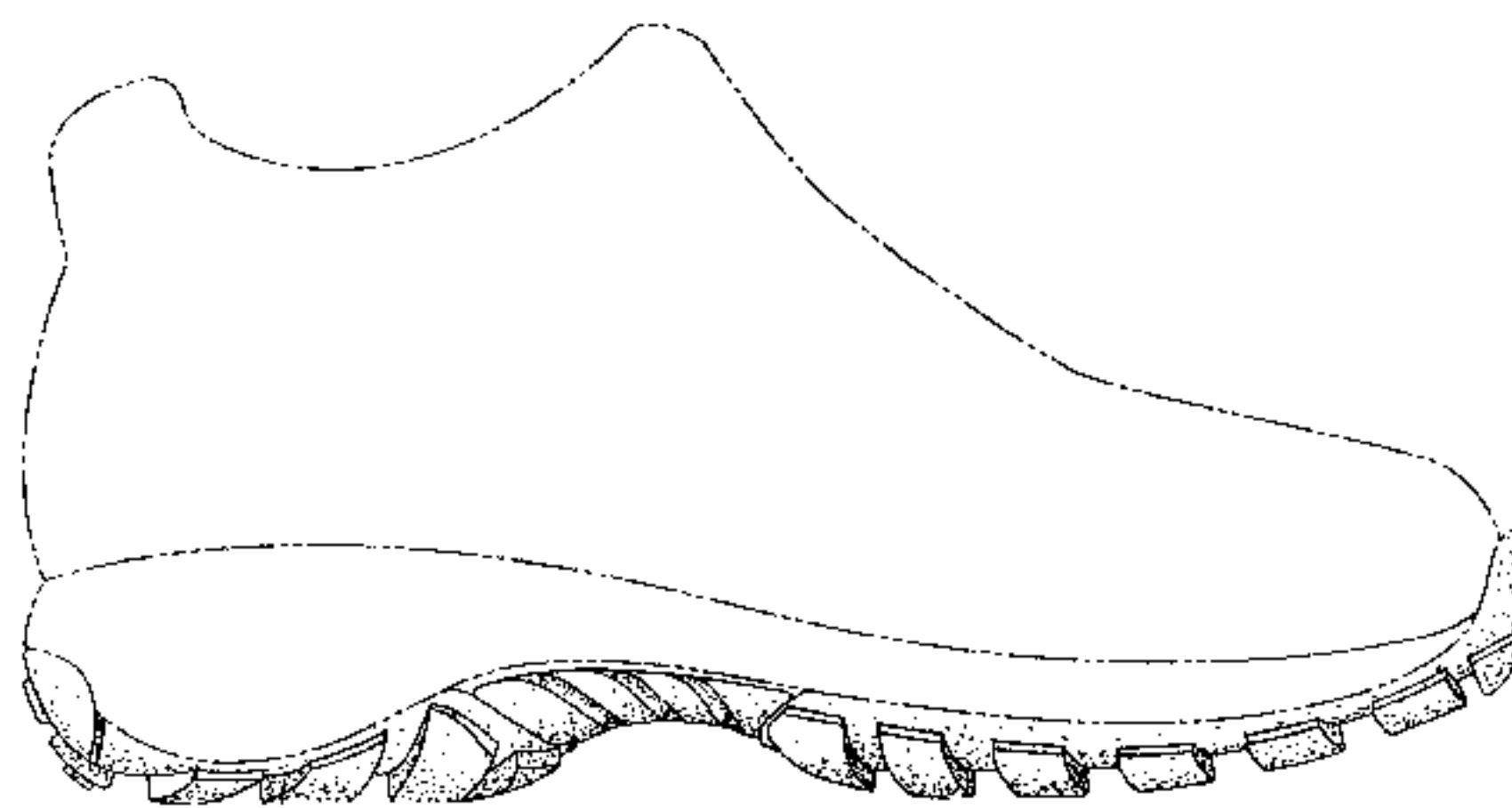
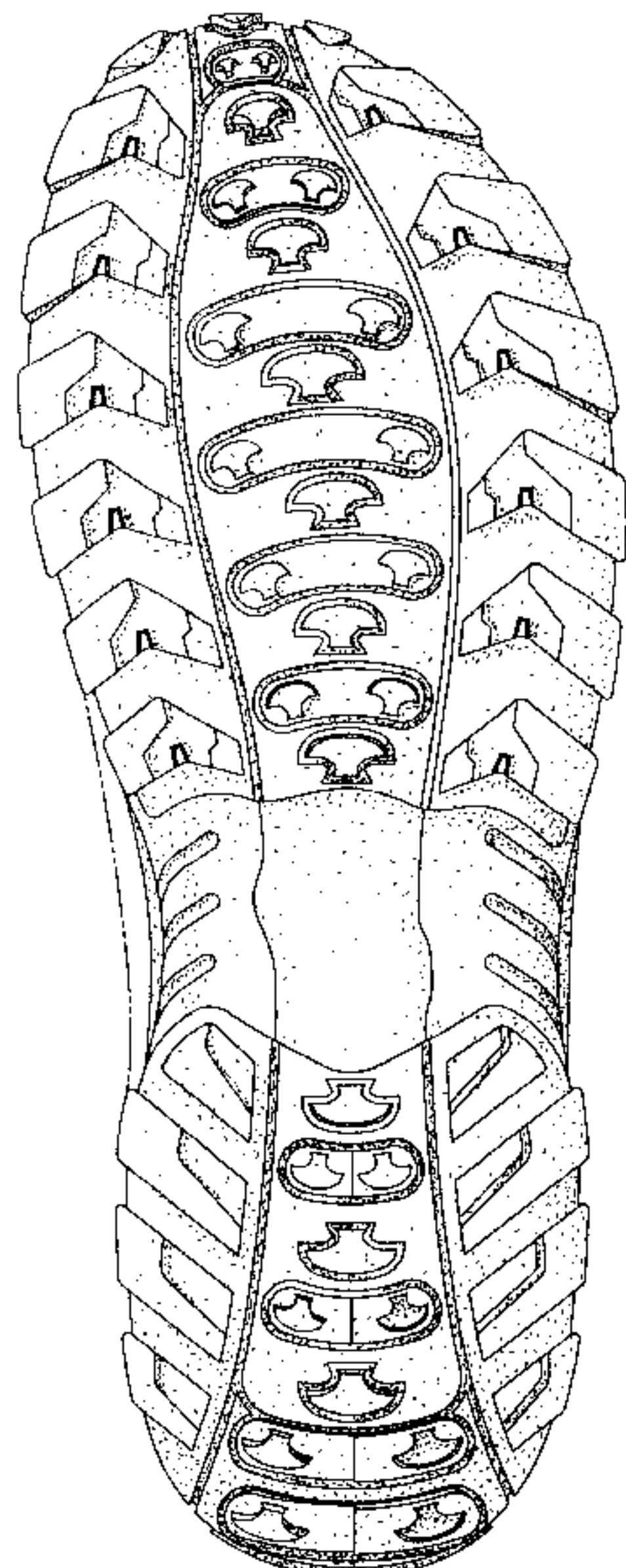
FIG. 4 is a right side elevational view thereof;

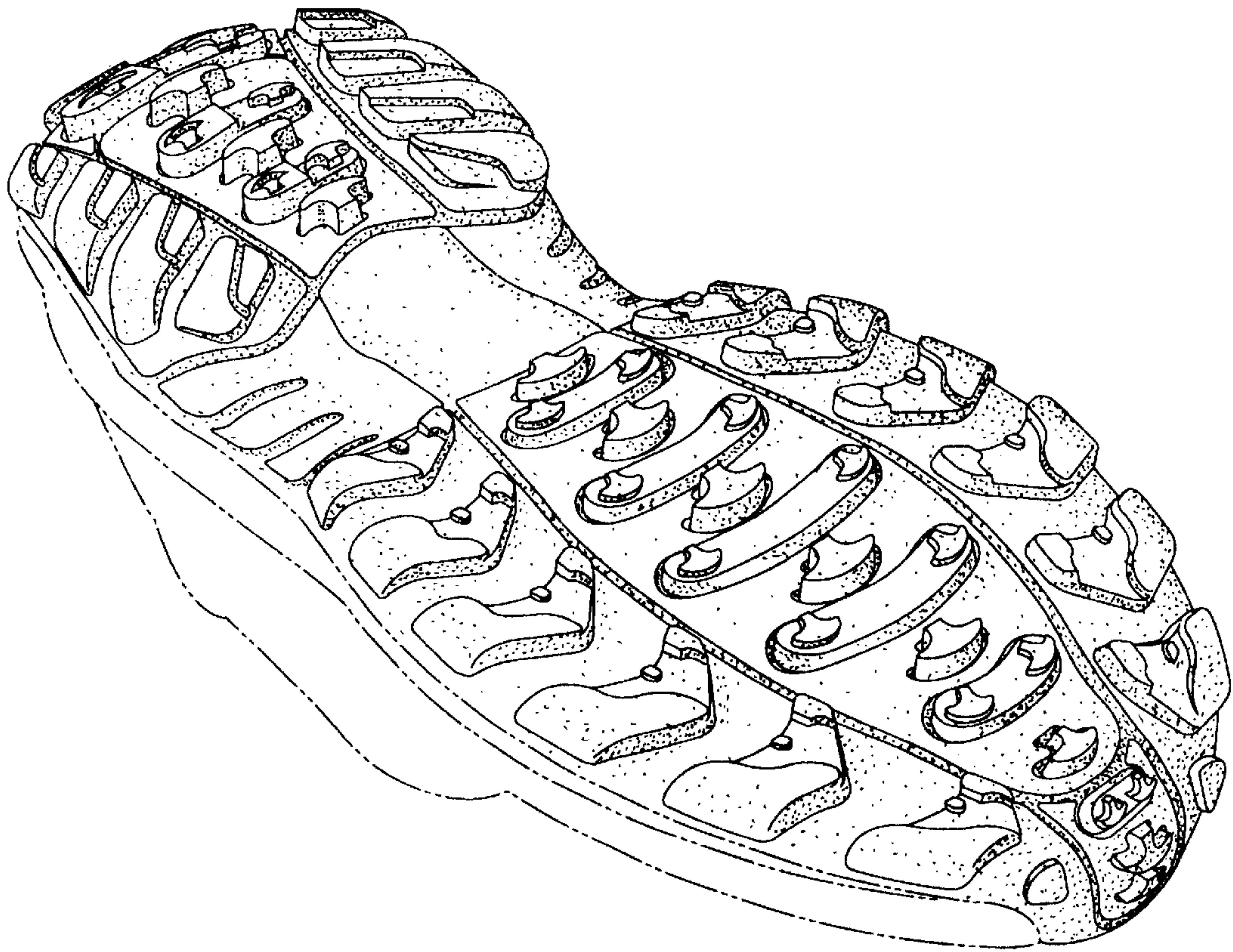

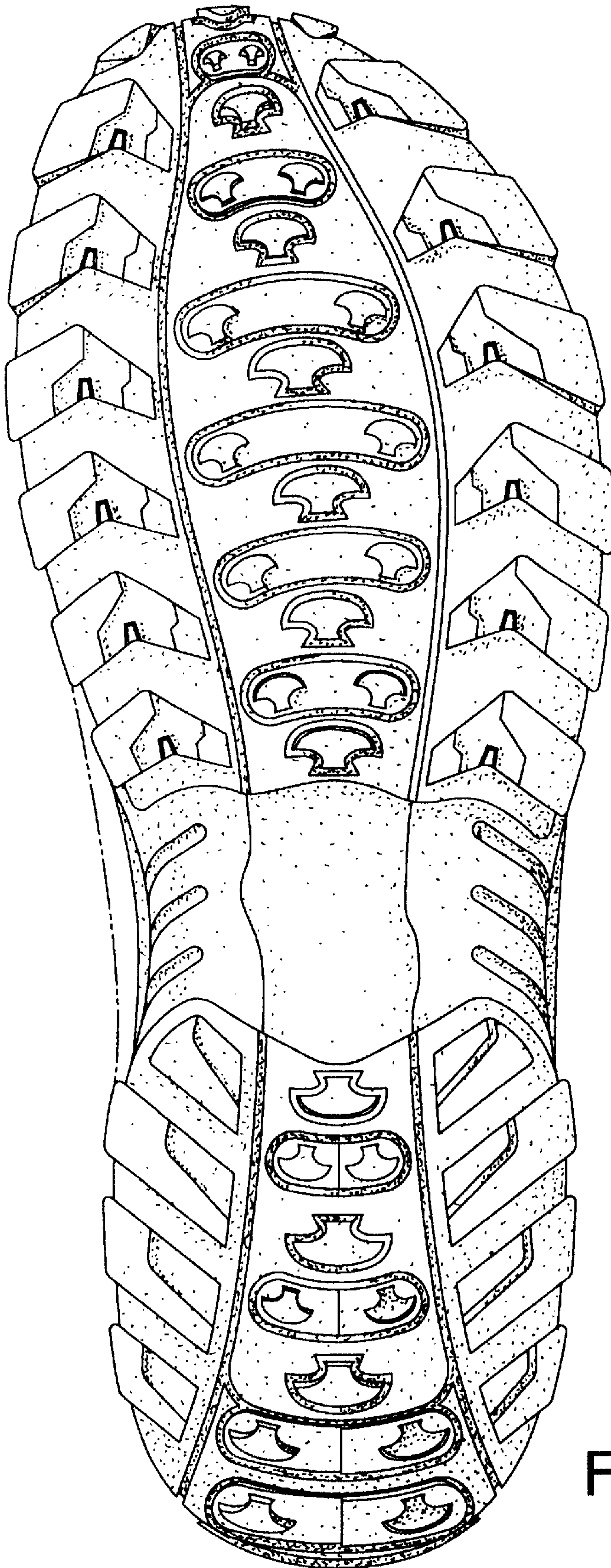

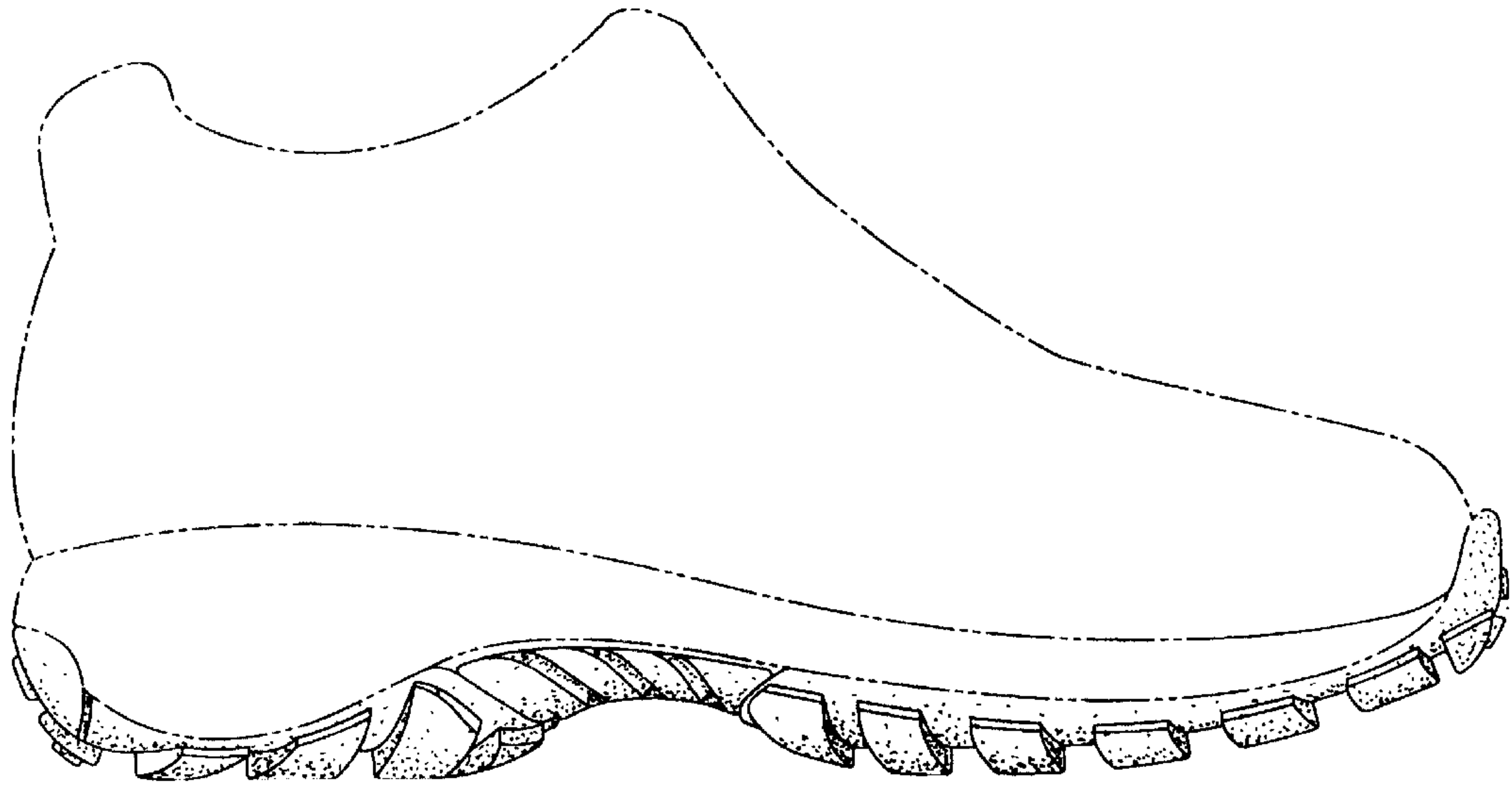

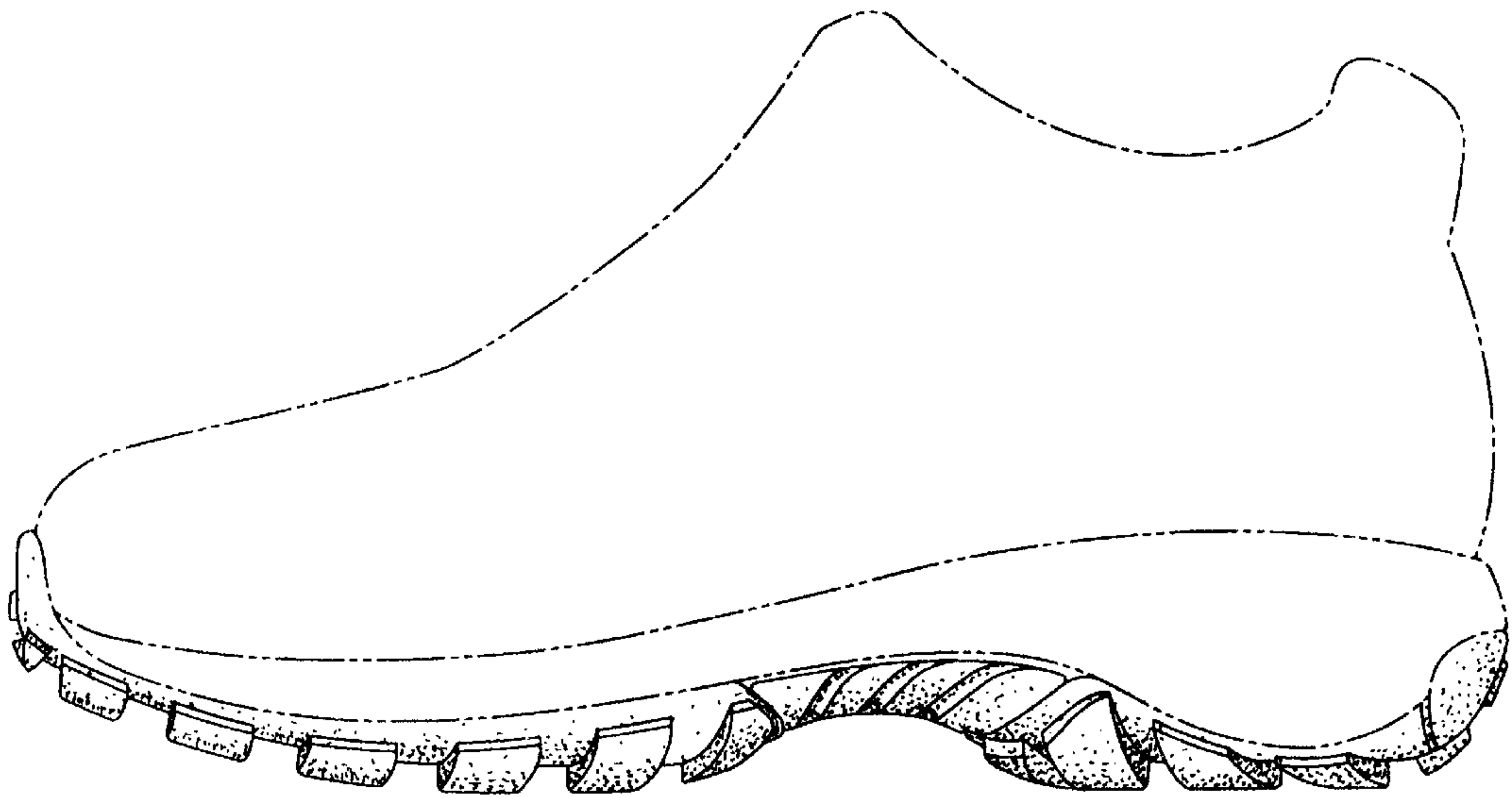

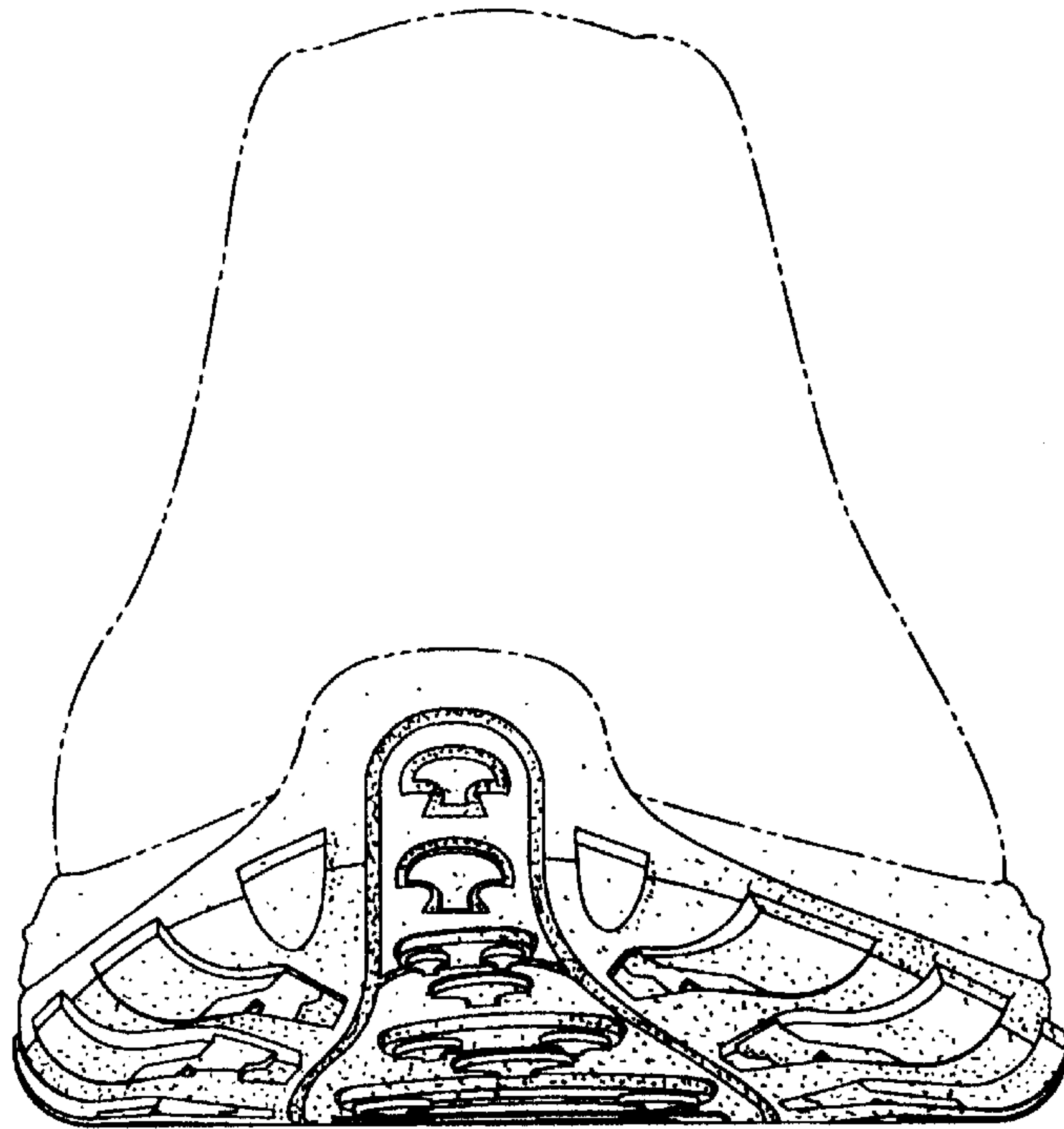

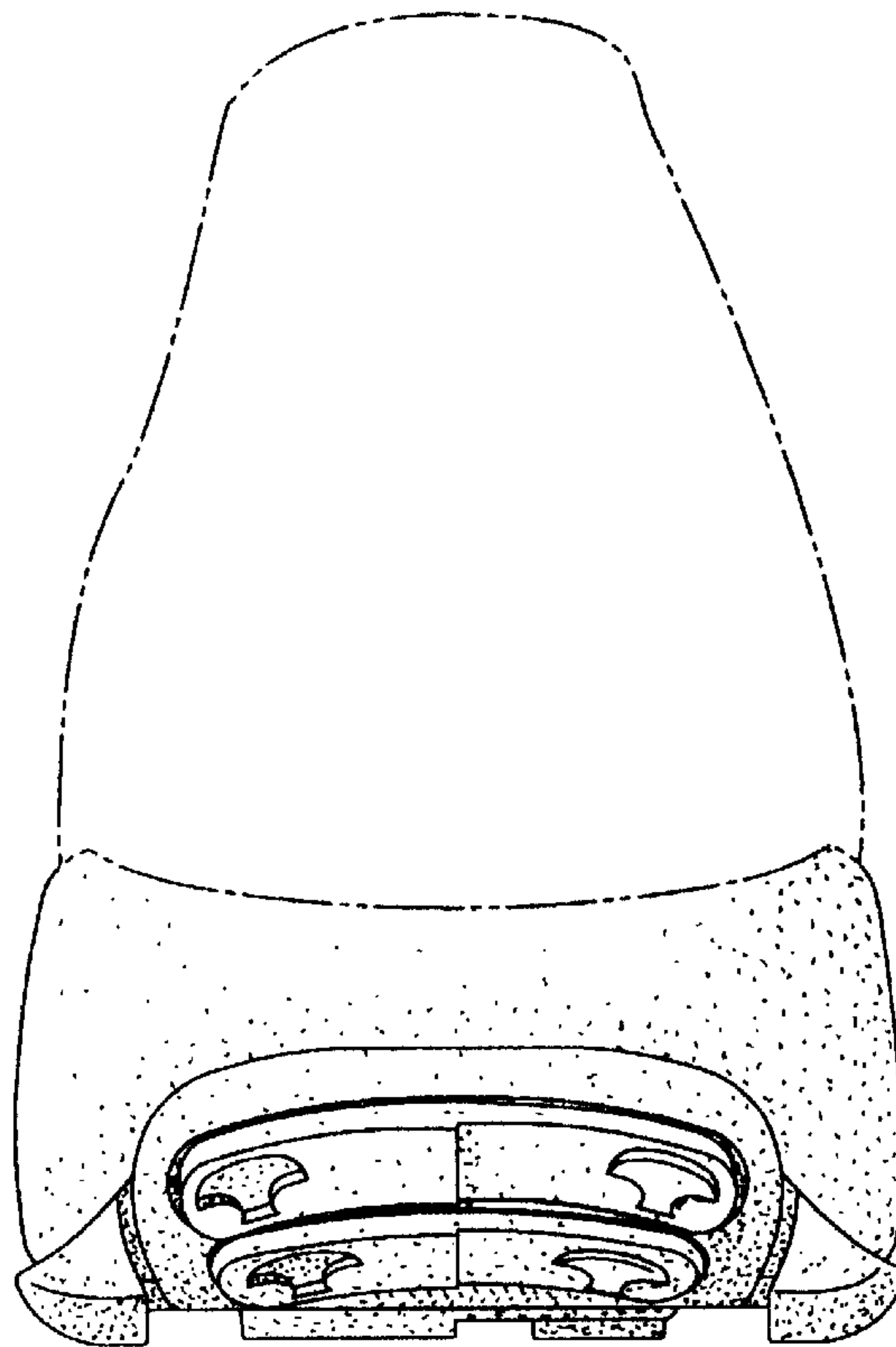
