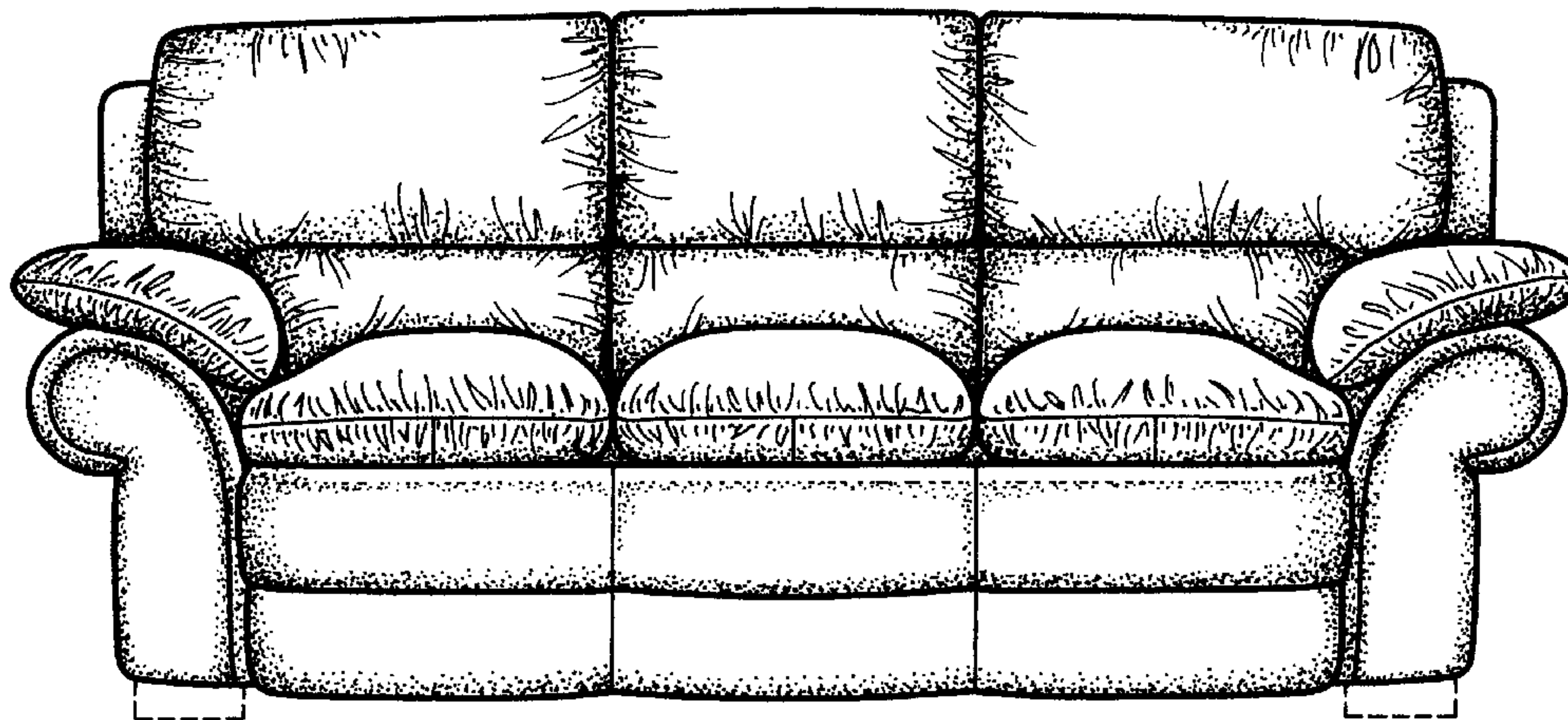
(57) **CLAIM**

The ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a left, front perspective view of a sofa showing my new design;
 FIG. 2 is a right, rear perspective view of the embodiment of FIG. 1;
 FIG. 3 is a front elevation view of the embodiment of FIG. 1;
 FIG. 4 is a left, side elevation view of the embodiment of FIG. 1, with the right side elevational view being a mirror image thereof;
 FIG. 5 is a rear elevation view of the embodiment of FIG. 1;
 FIG. 6 is a front elevation view of a second embodiment of the sofa depicted in FIG. 1;
 FIG. 7 is a left, side elevation view of the embodiment of FIG. 6, with the right side elevational view being a mirror image thereof; and,
 FIG. 8 is a rear elevation view of the embodiment of FIG. 6.
 The broken line disclosure is for illustrative purposes only and forms no part of the claimed design.

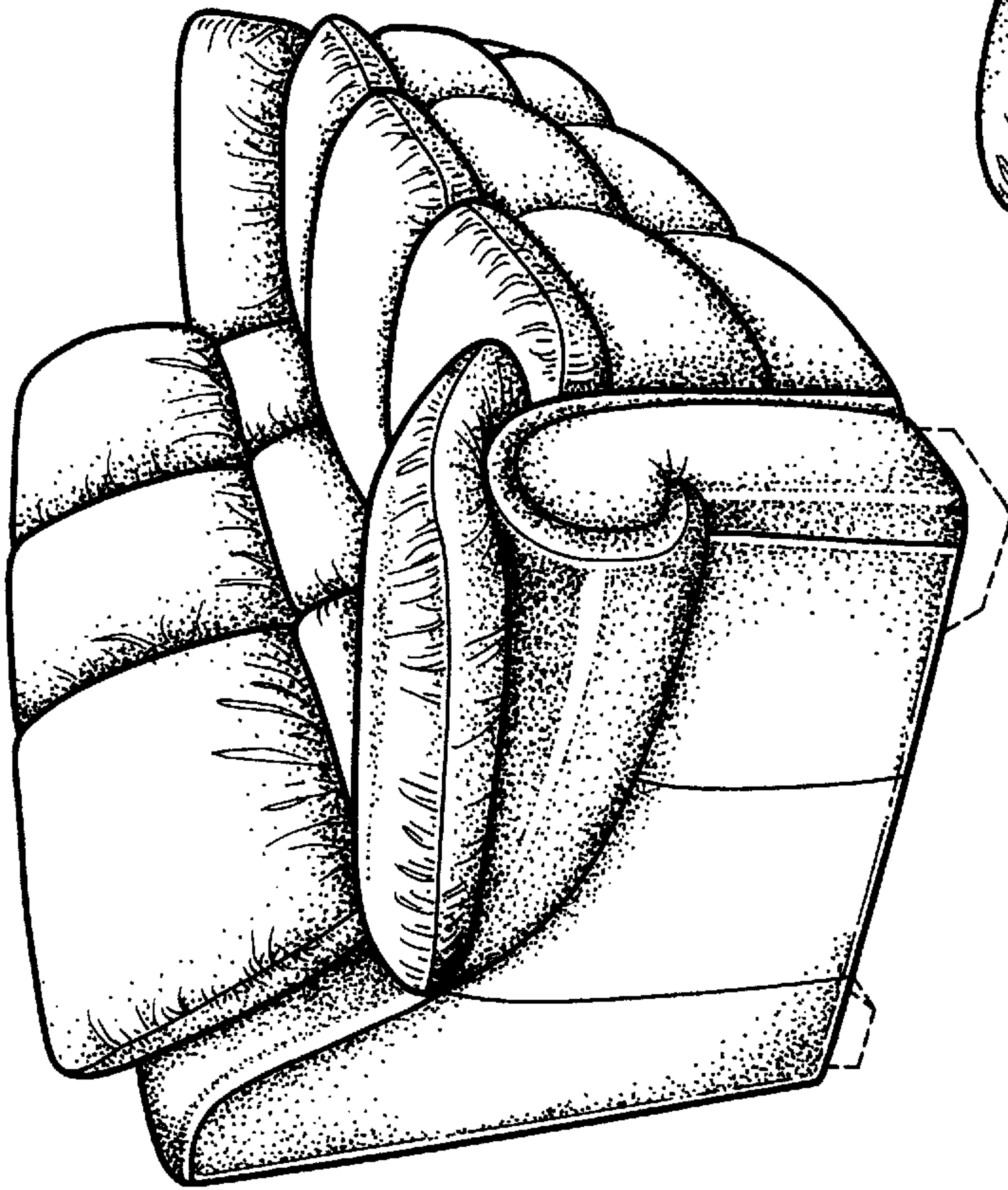

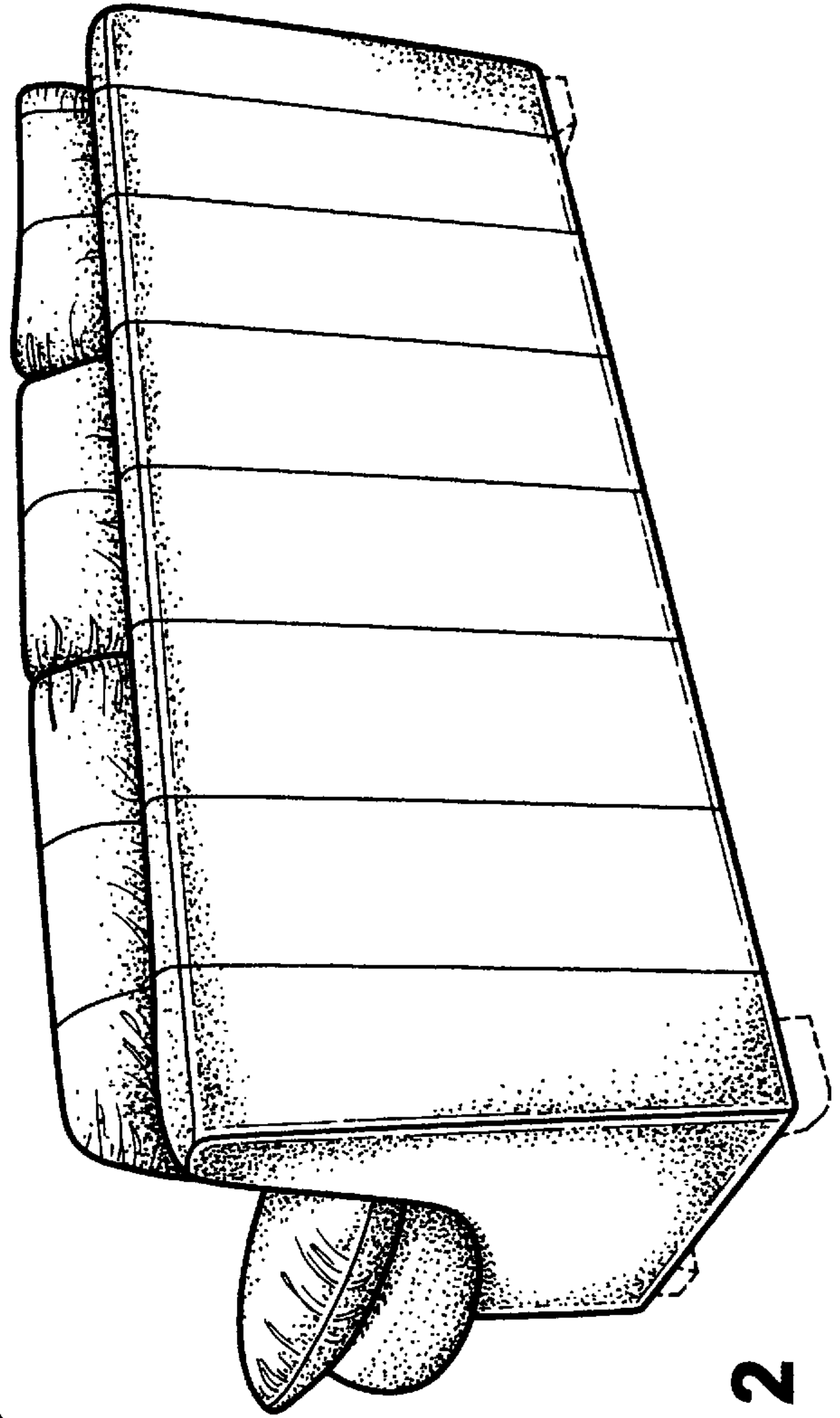

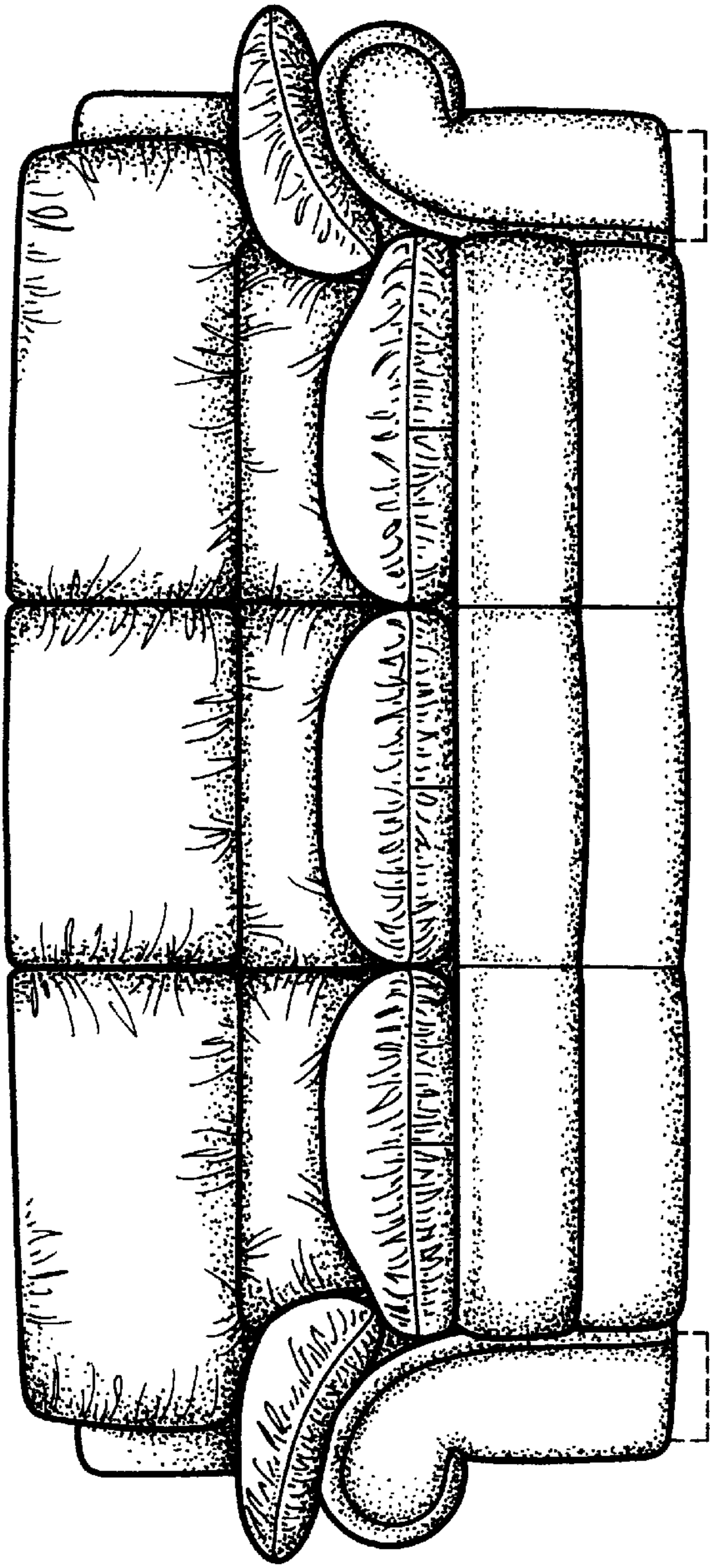

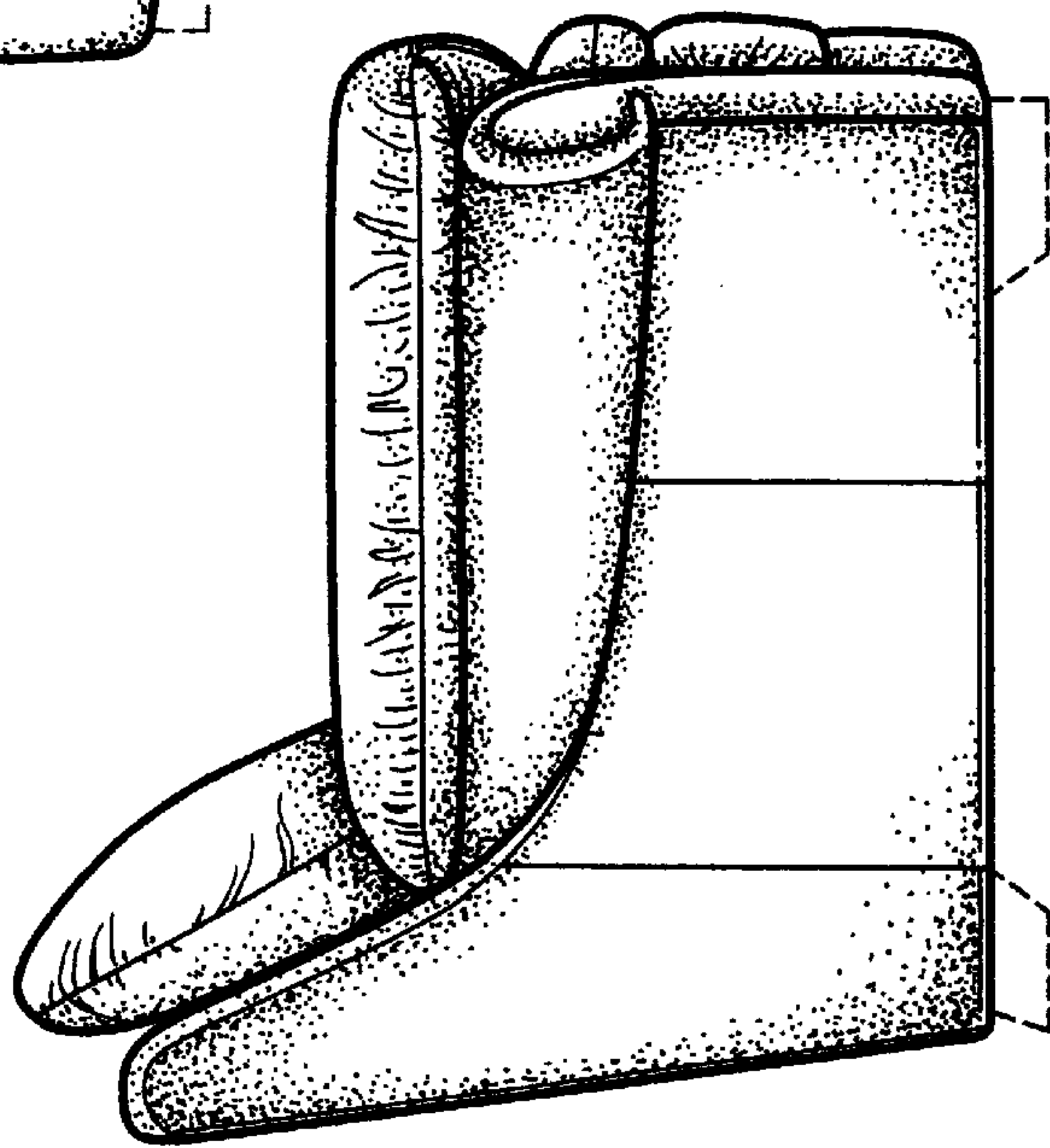

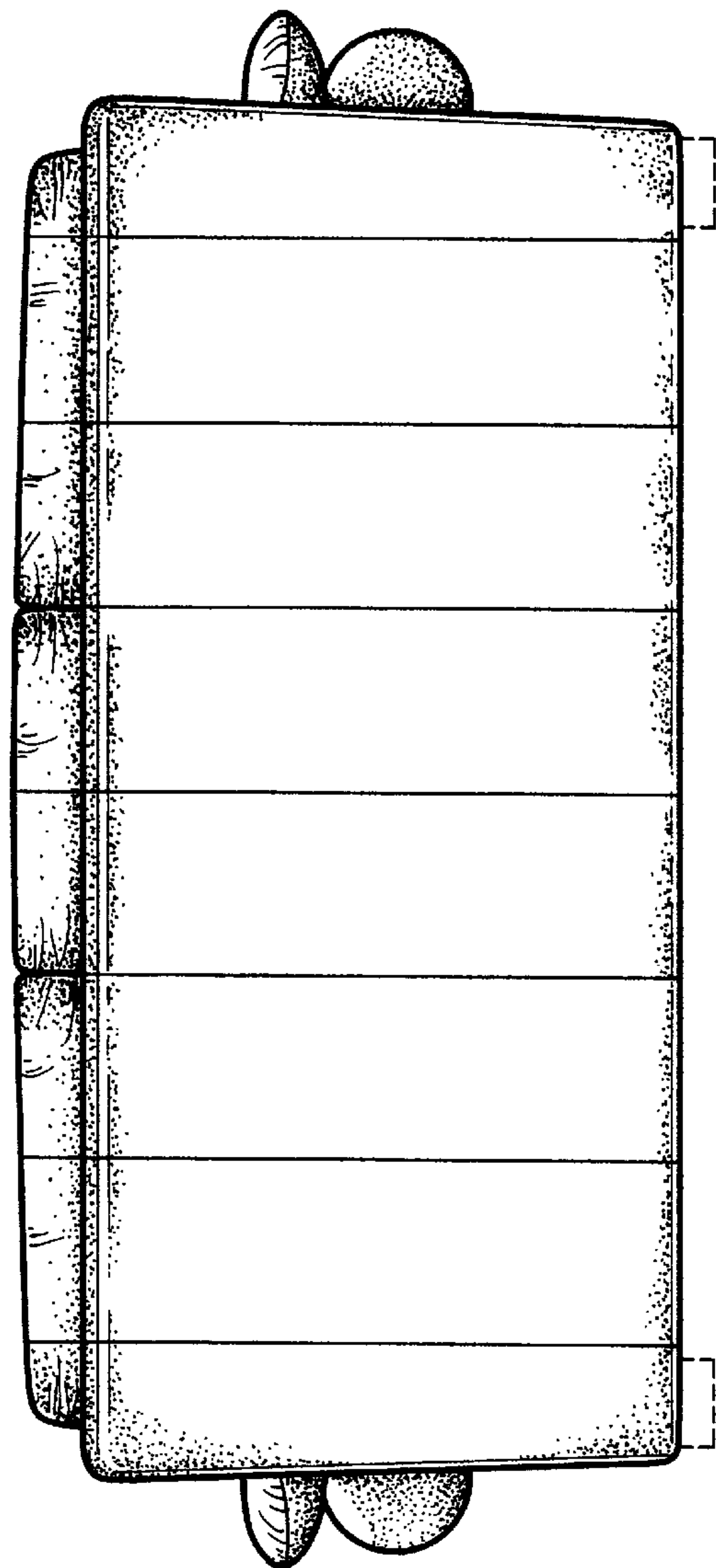

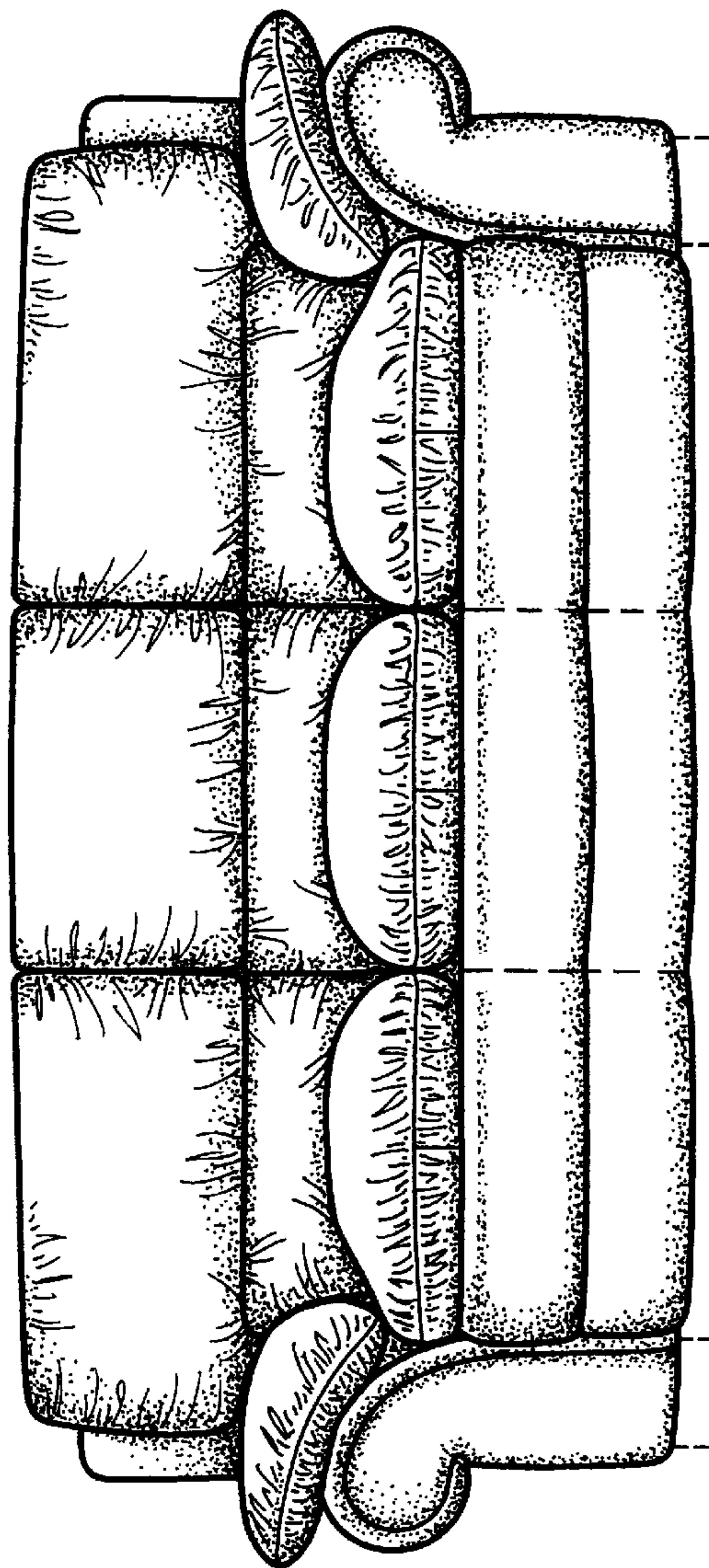

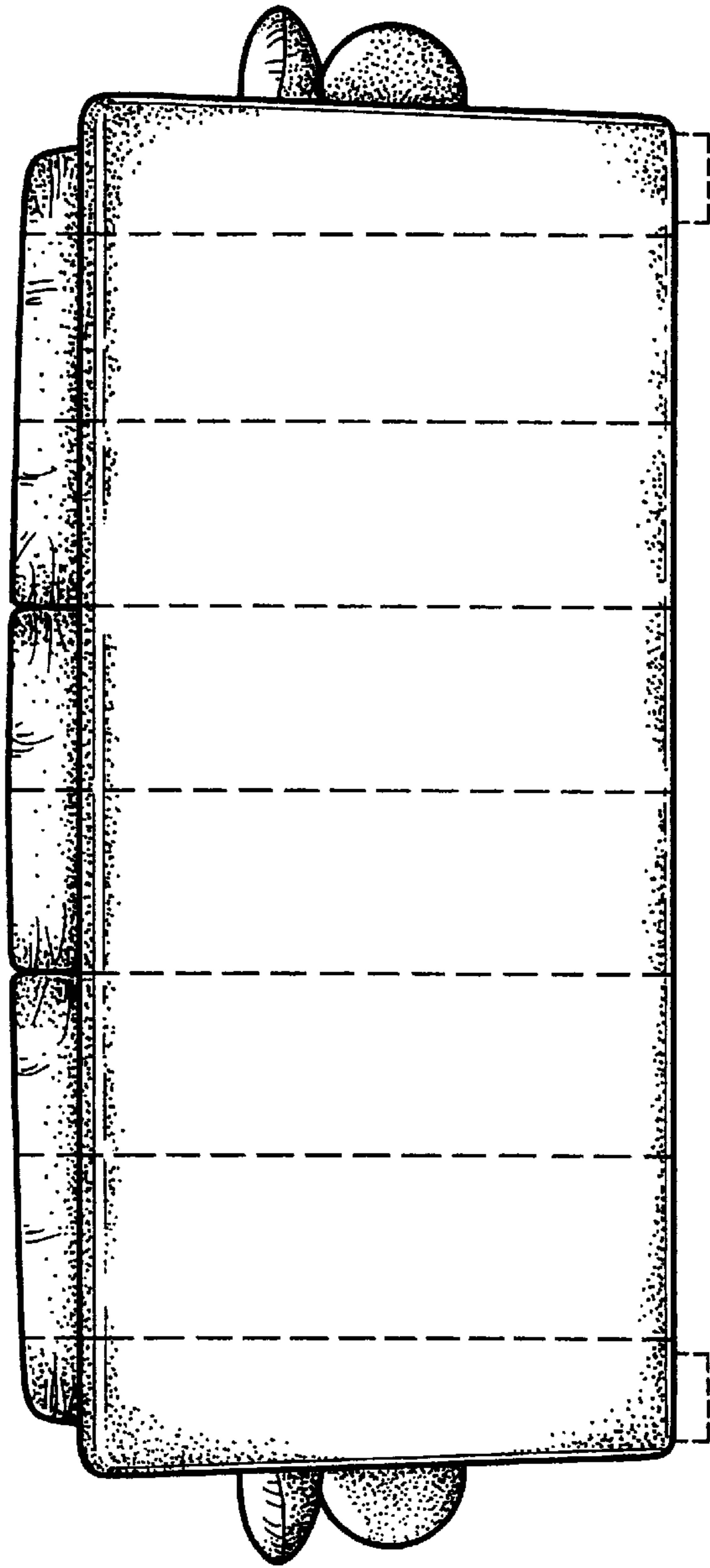

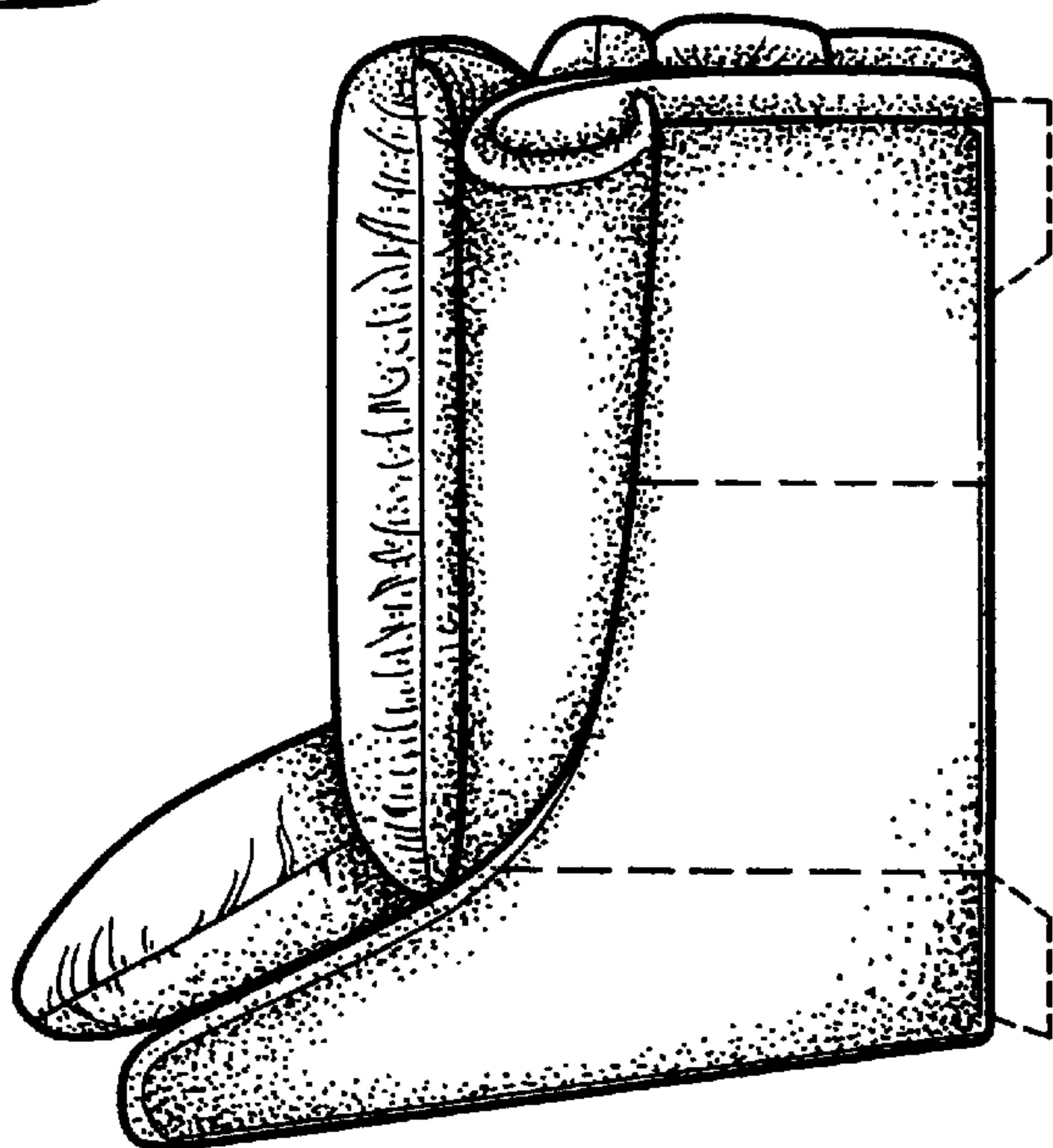
