FIG. 10 is a perspective view of the claimed design shown on another cooking vessel;

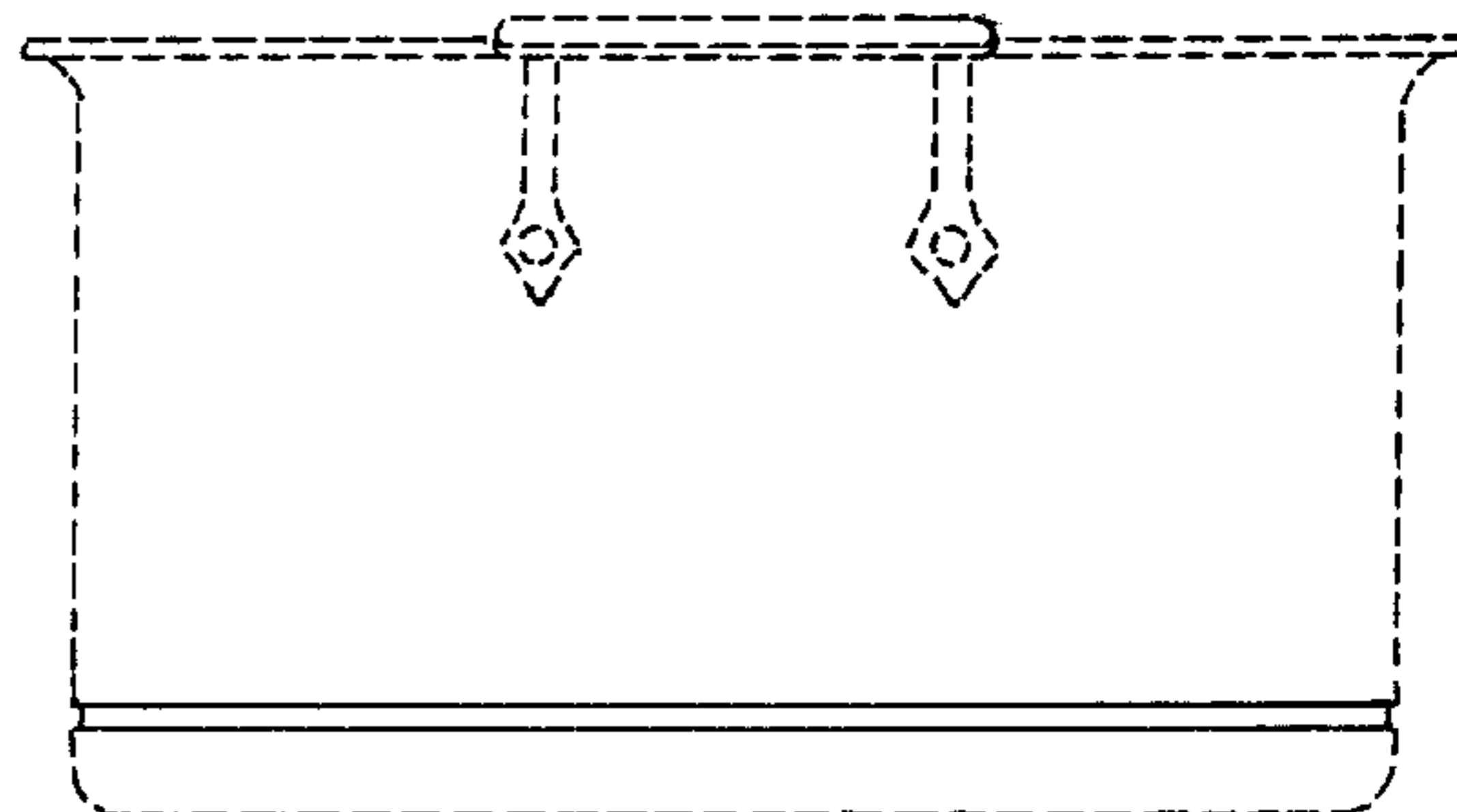
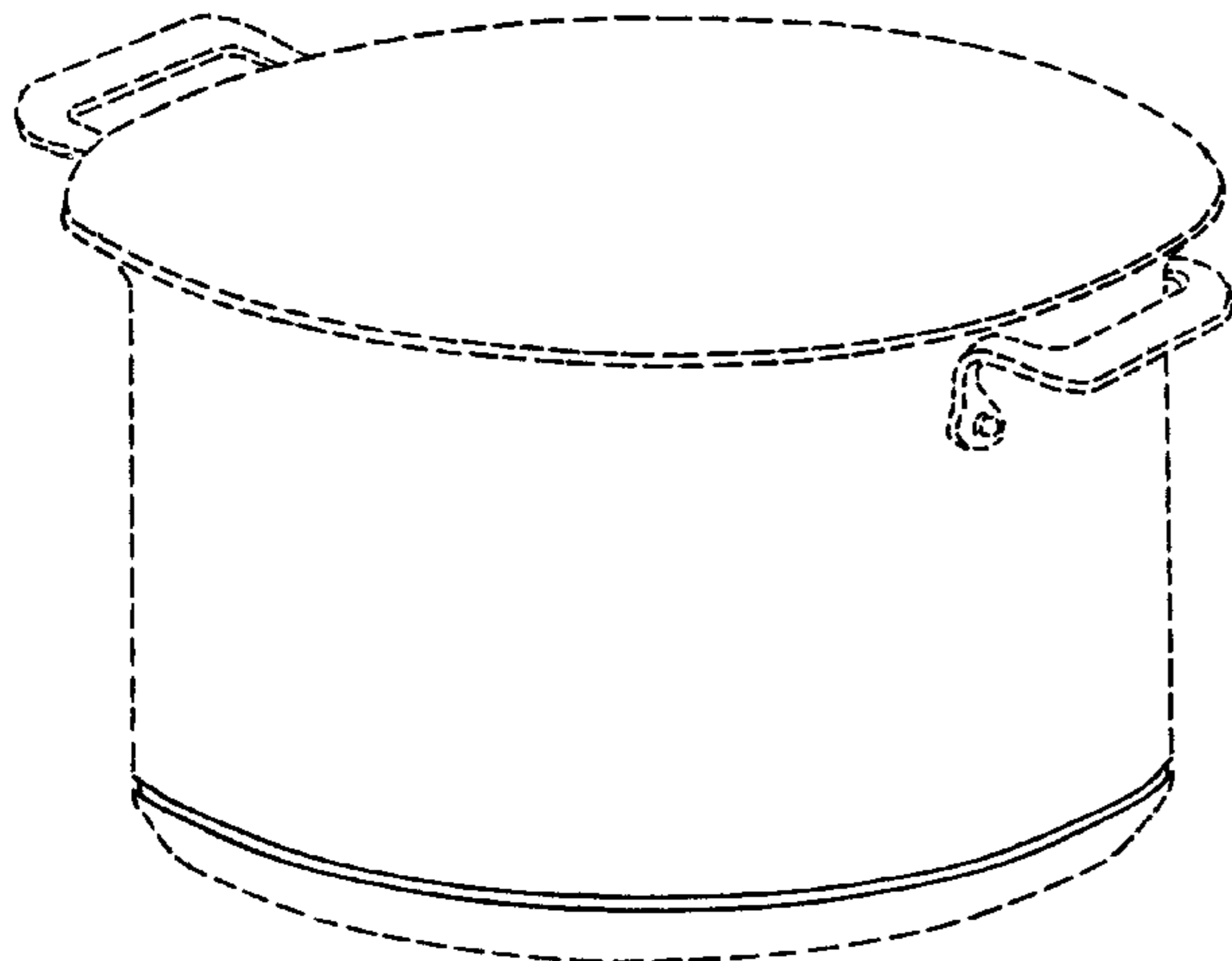
FIG. 11 is a perspective view of the claimed design shown on another cooking vessel; and,

As shown in the appended drawings, the ornamental design of my invention is directed to an indented golden copper colored band formed around the outer periphery on a lower portion of the vessel. It is understood that the golden copper colored band shown in FIGS. 1-2 extends around the circumference of the vessel. FIGS. 1-12 are not lined to show the color for ease for illustration.

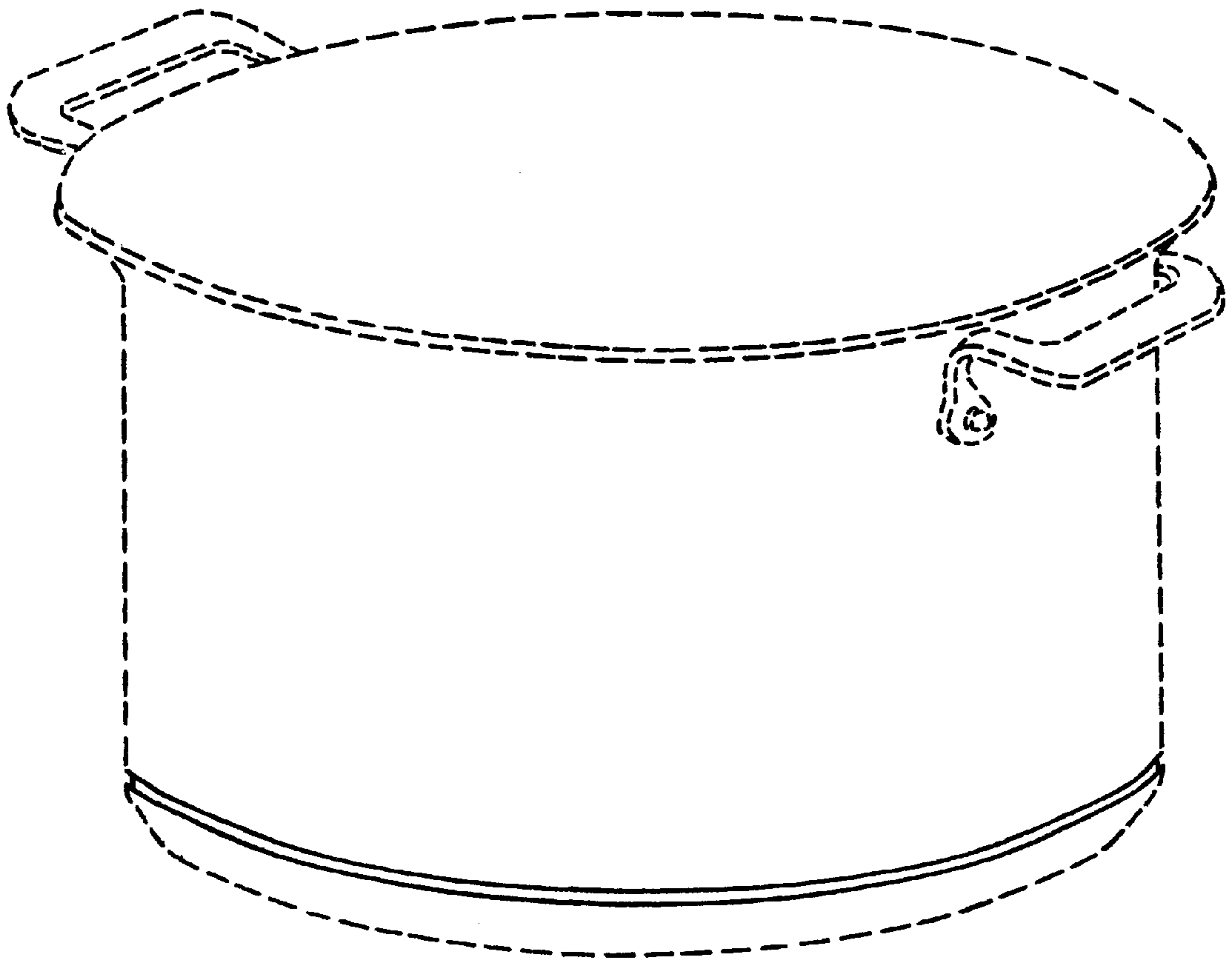

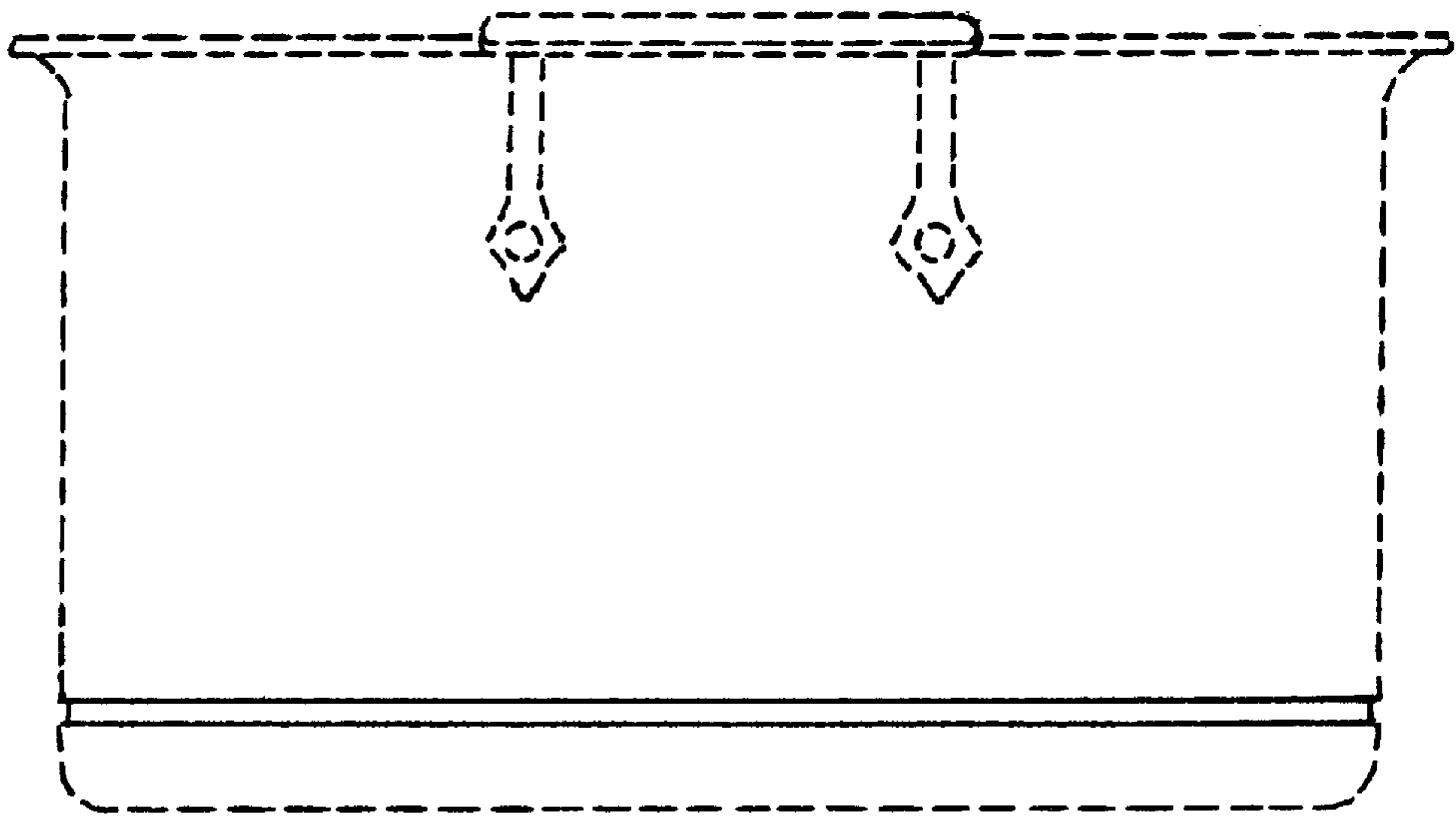

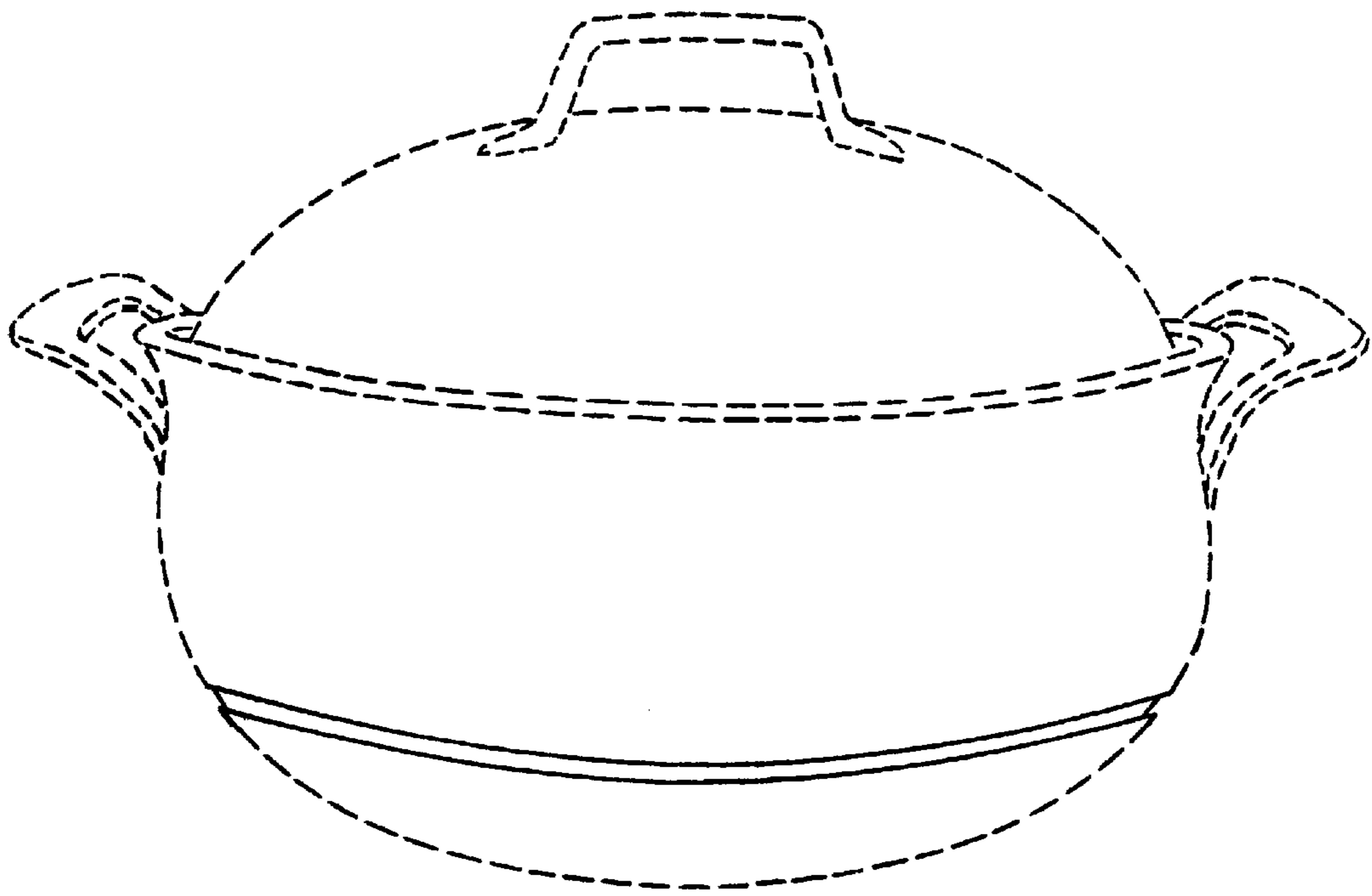

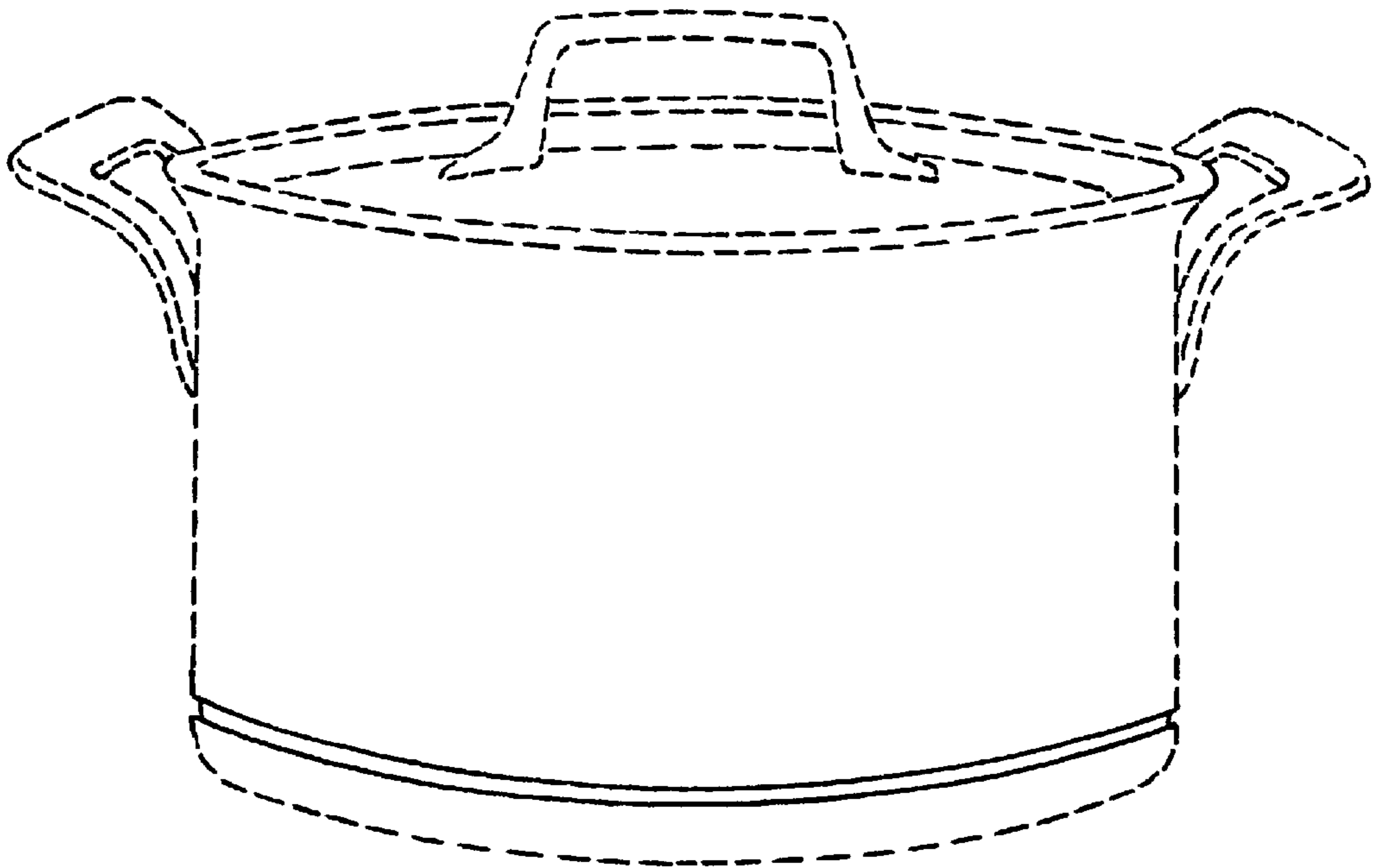

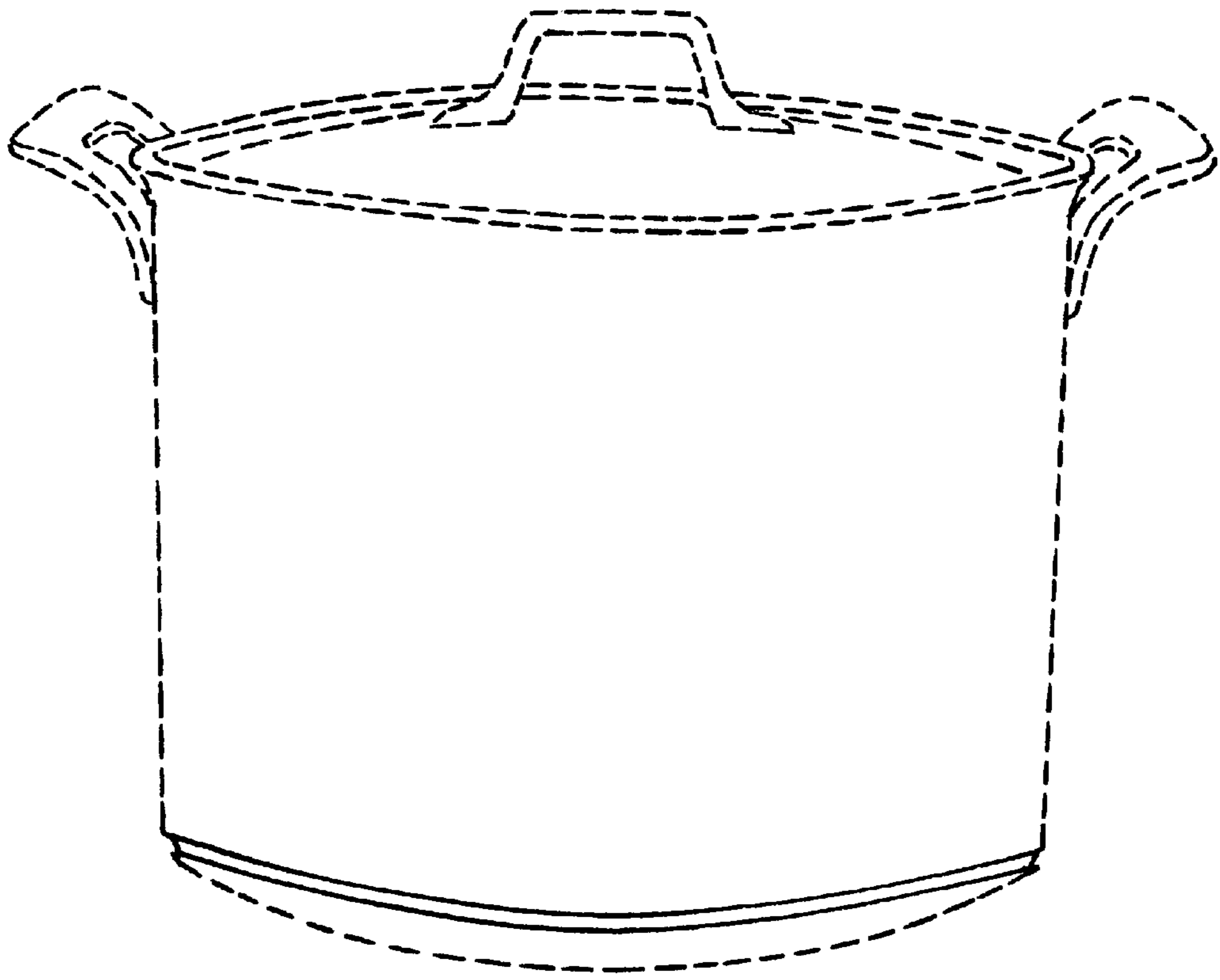

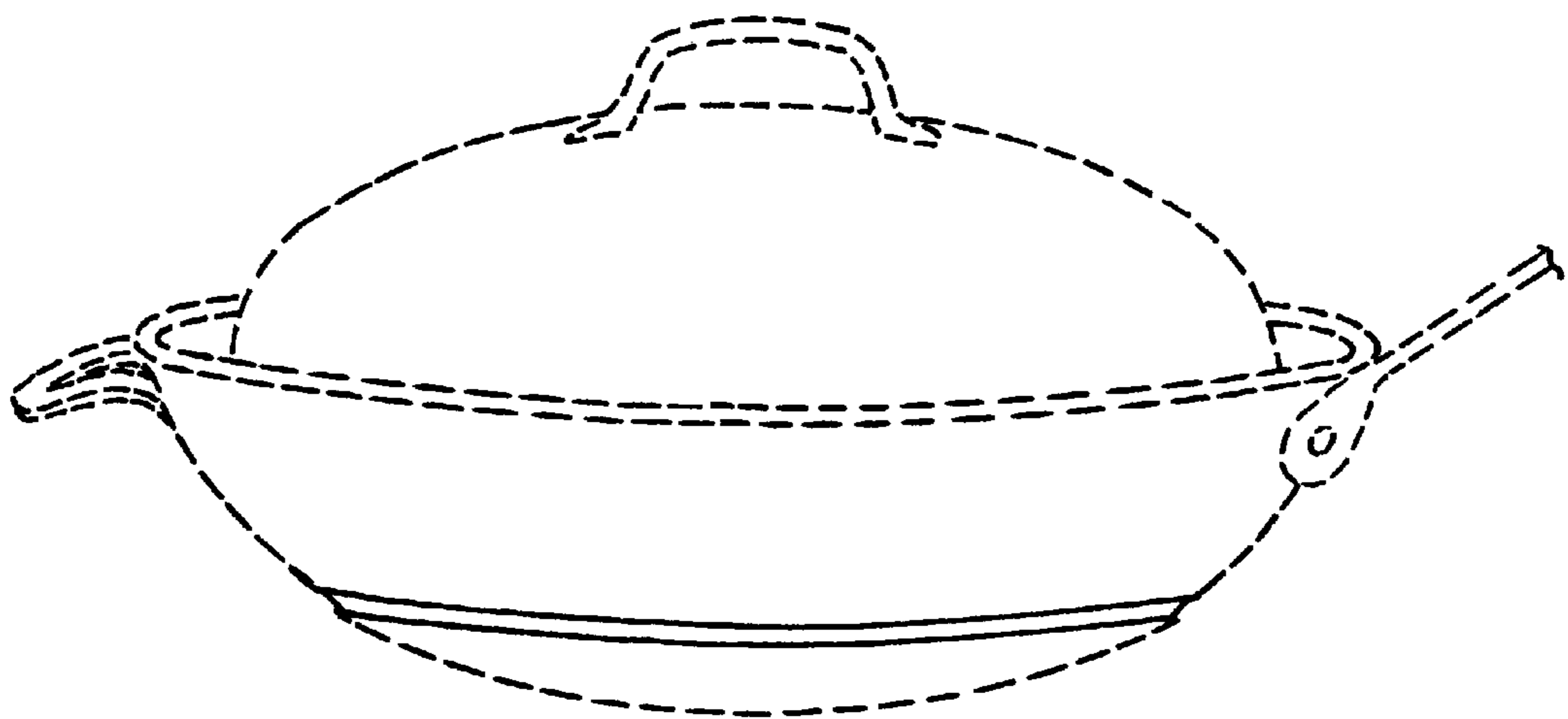

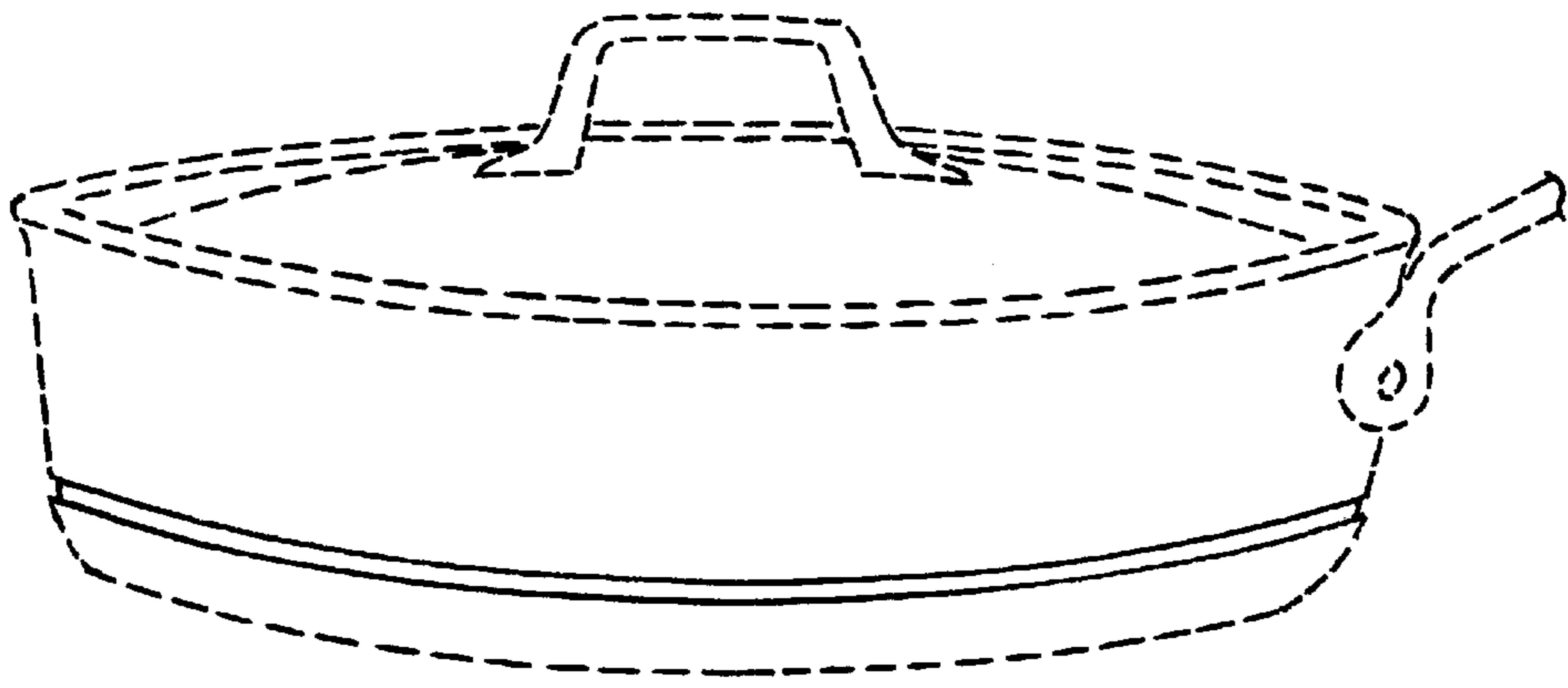

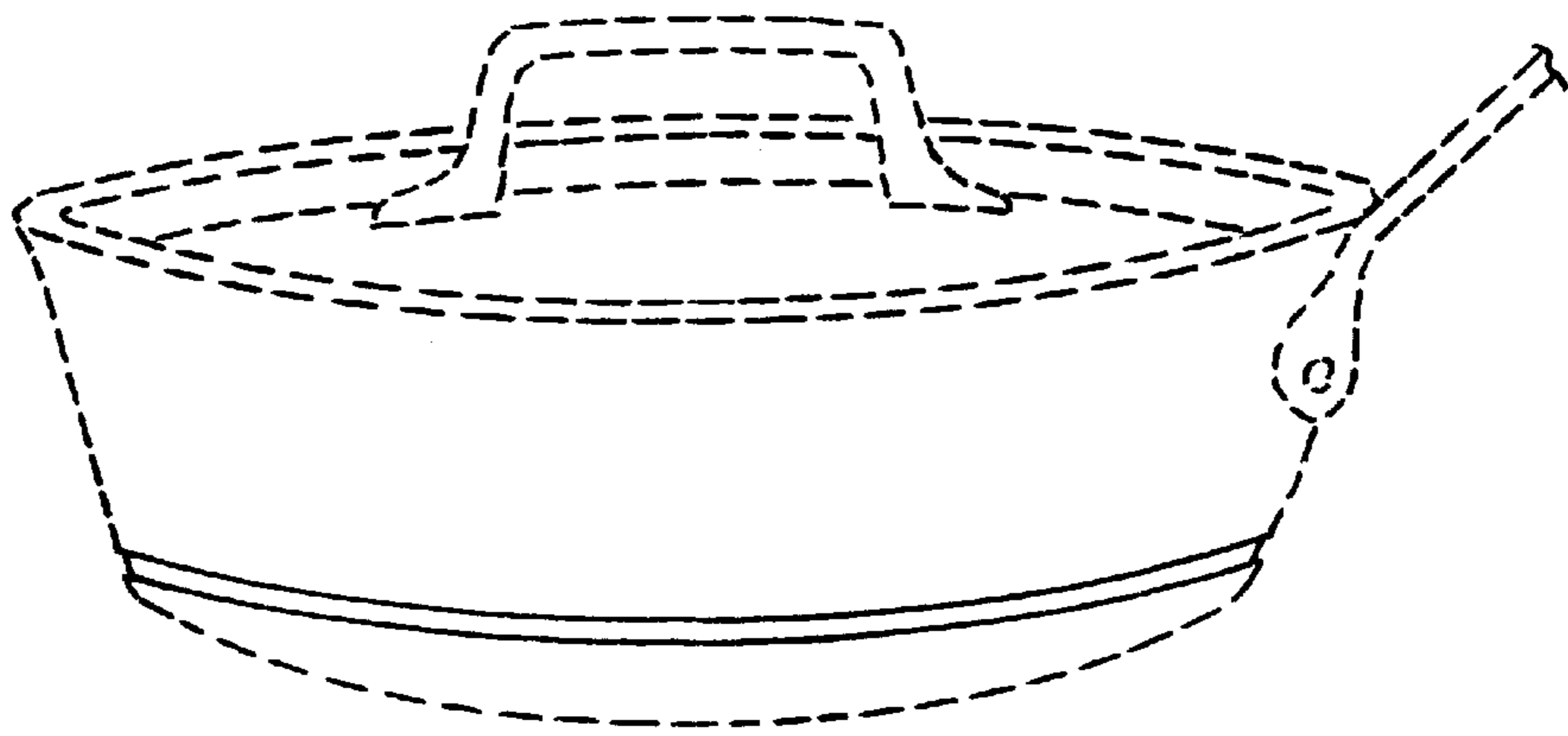

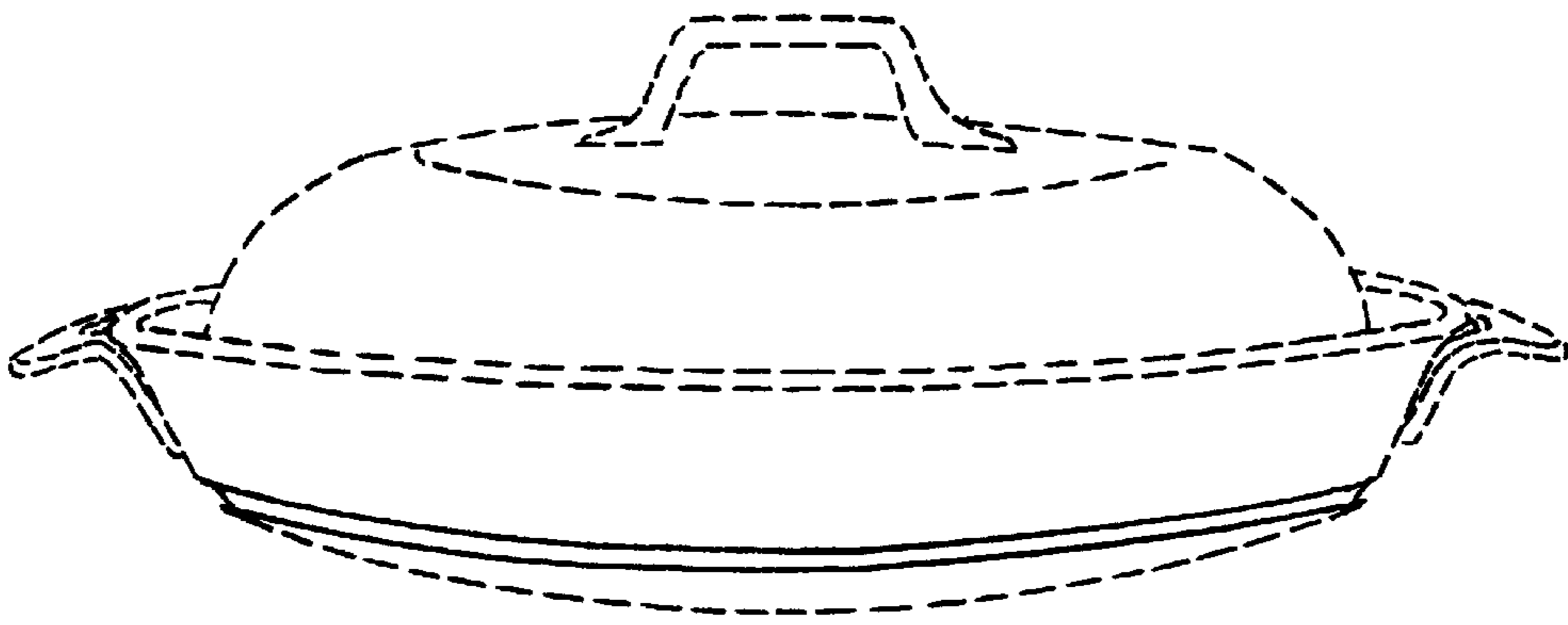

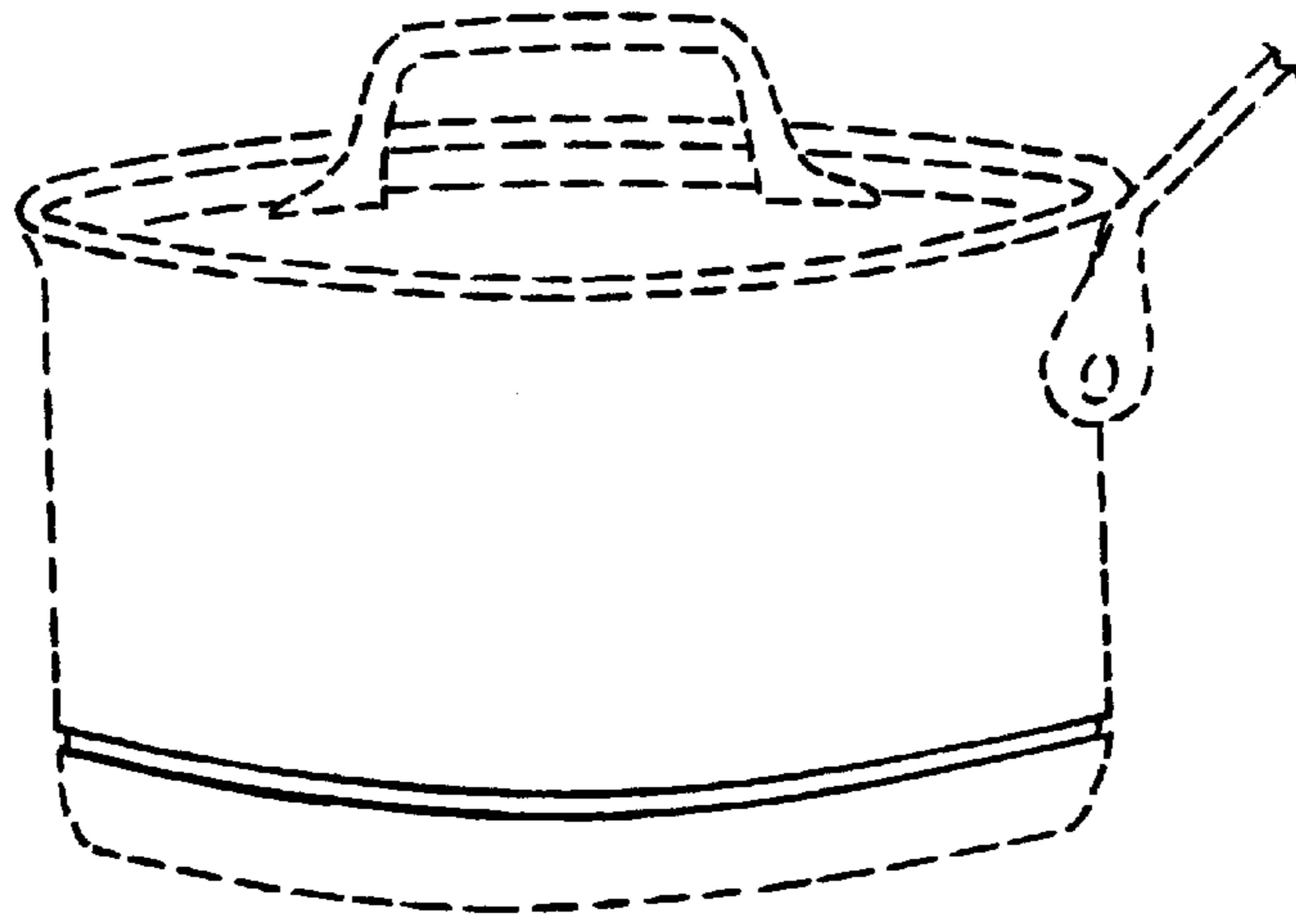

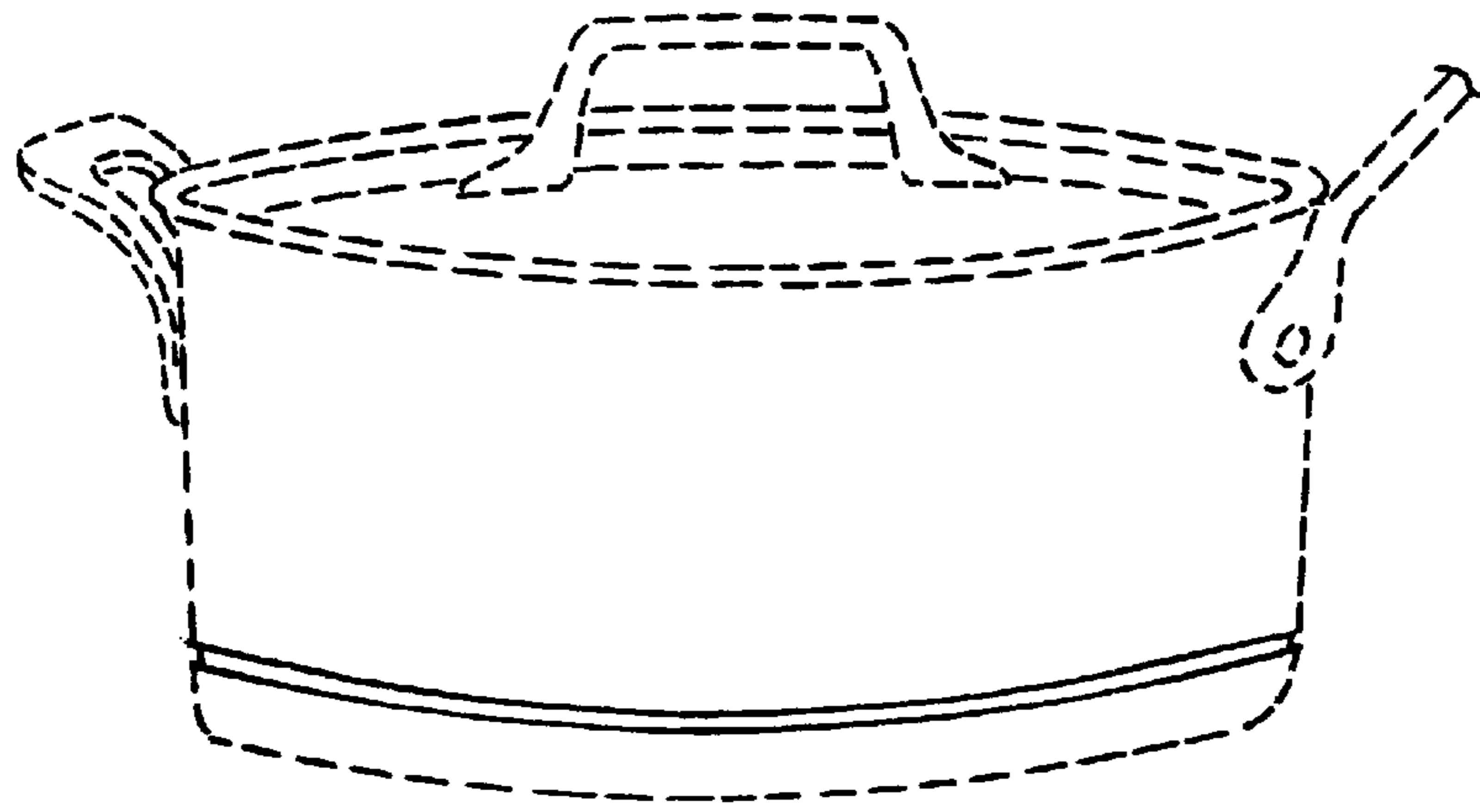

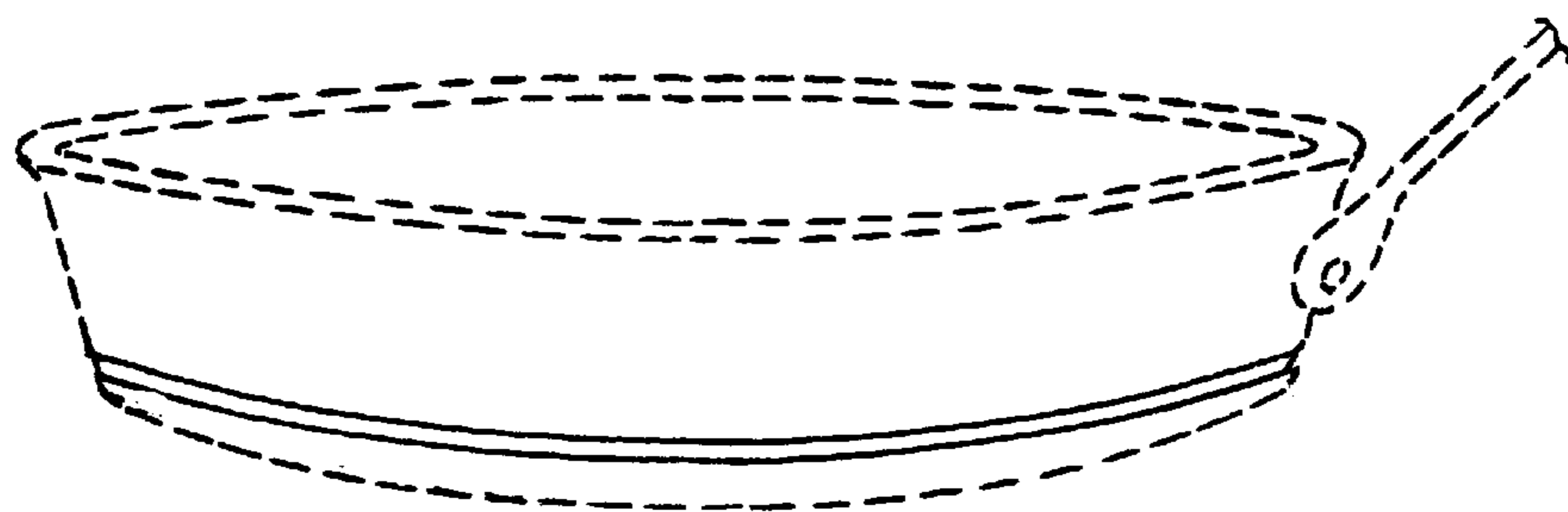
