(57) **CLAIM**

The ornamental design for a devilled egg plate, as shown.

DESCRIPTION

FIG. 1 is perspective view of the devilled egg plate embodying the novel design;

FIG. 2 is a top view of the devilled egg plate;

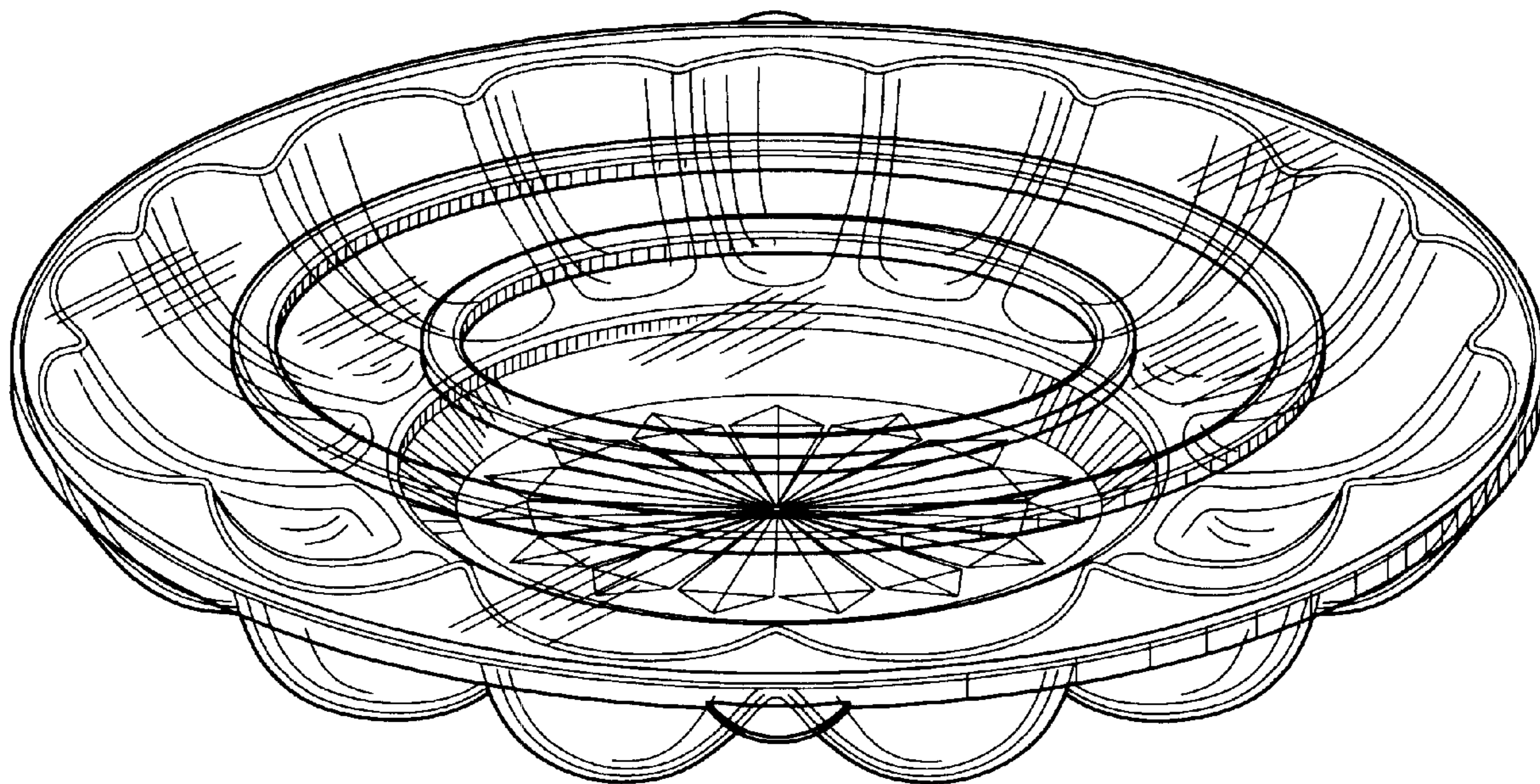
FIG. 3 is an elevation view of the devilled egg plate;

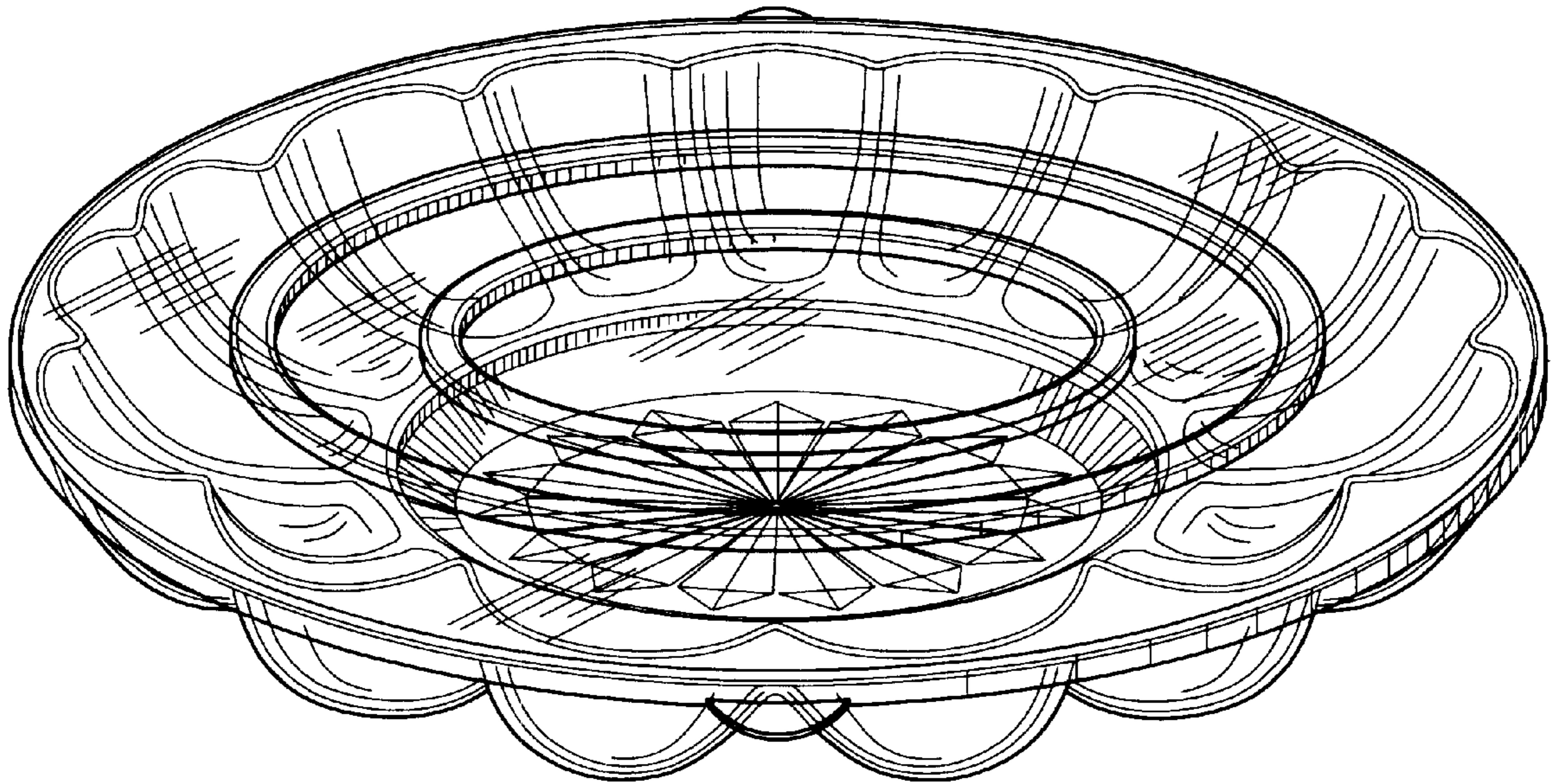

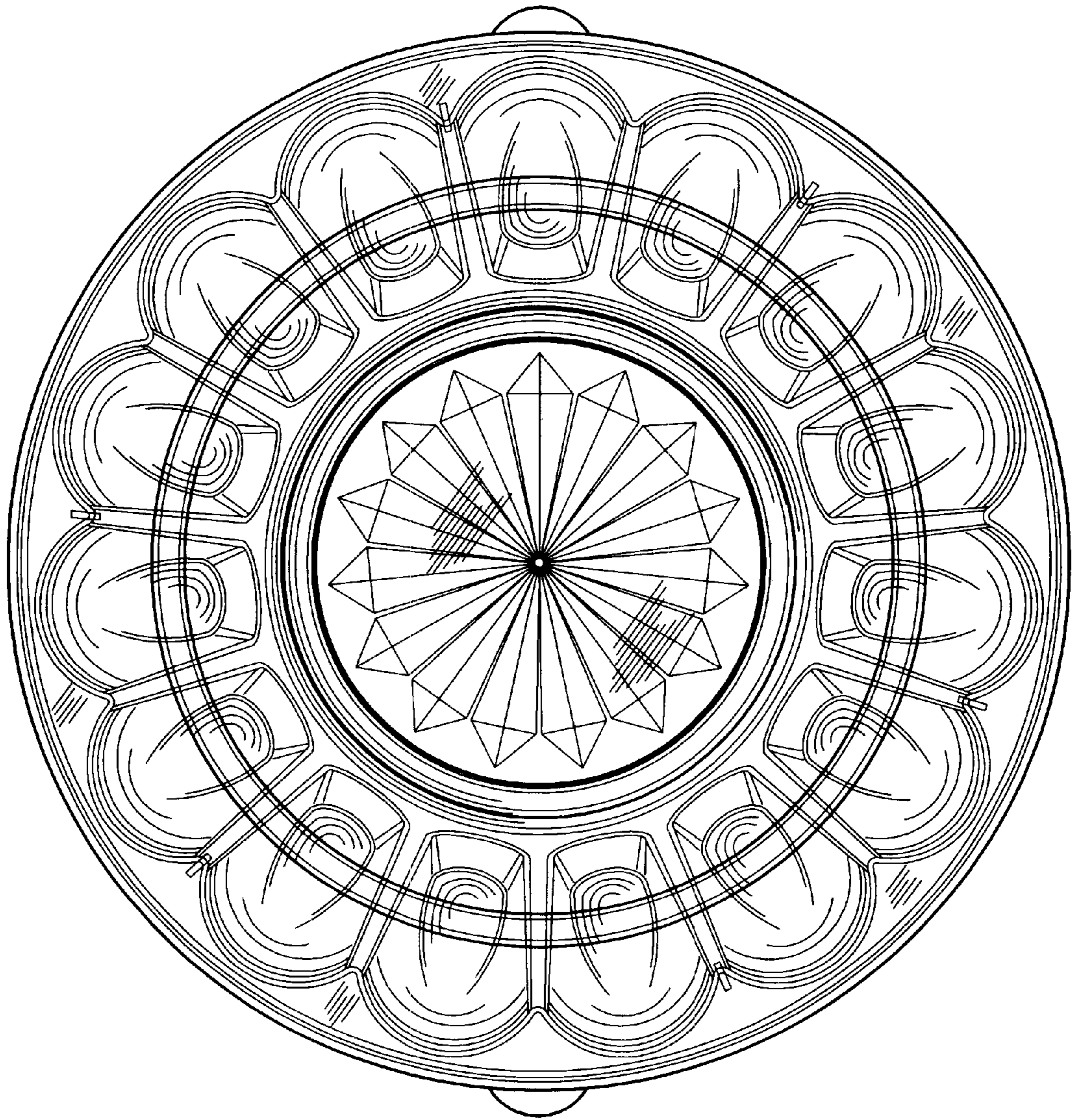

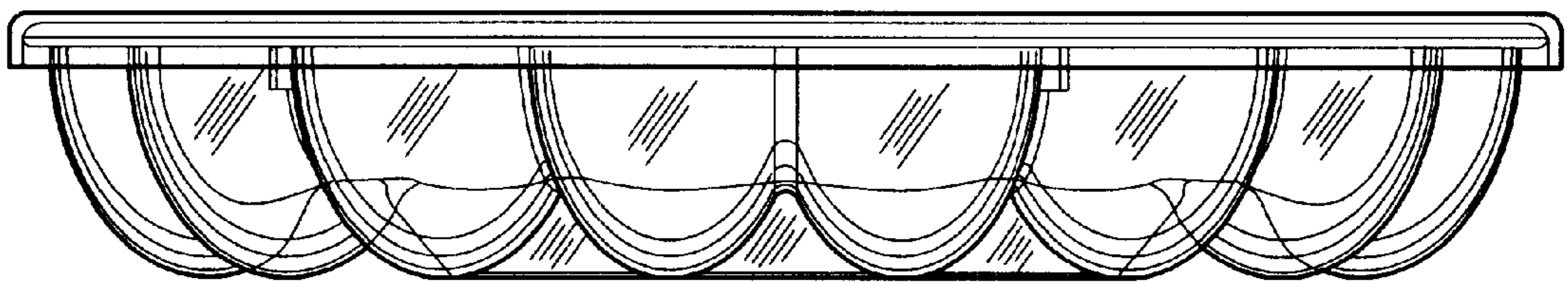

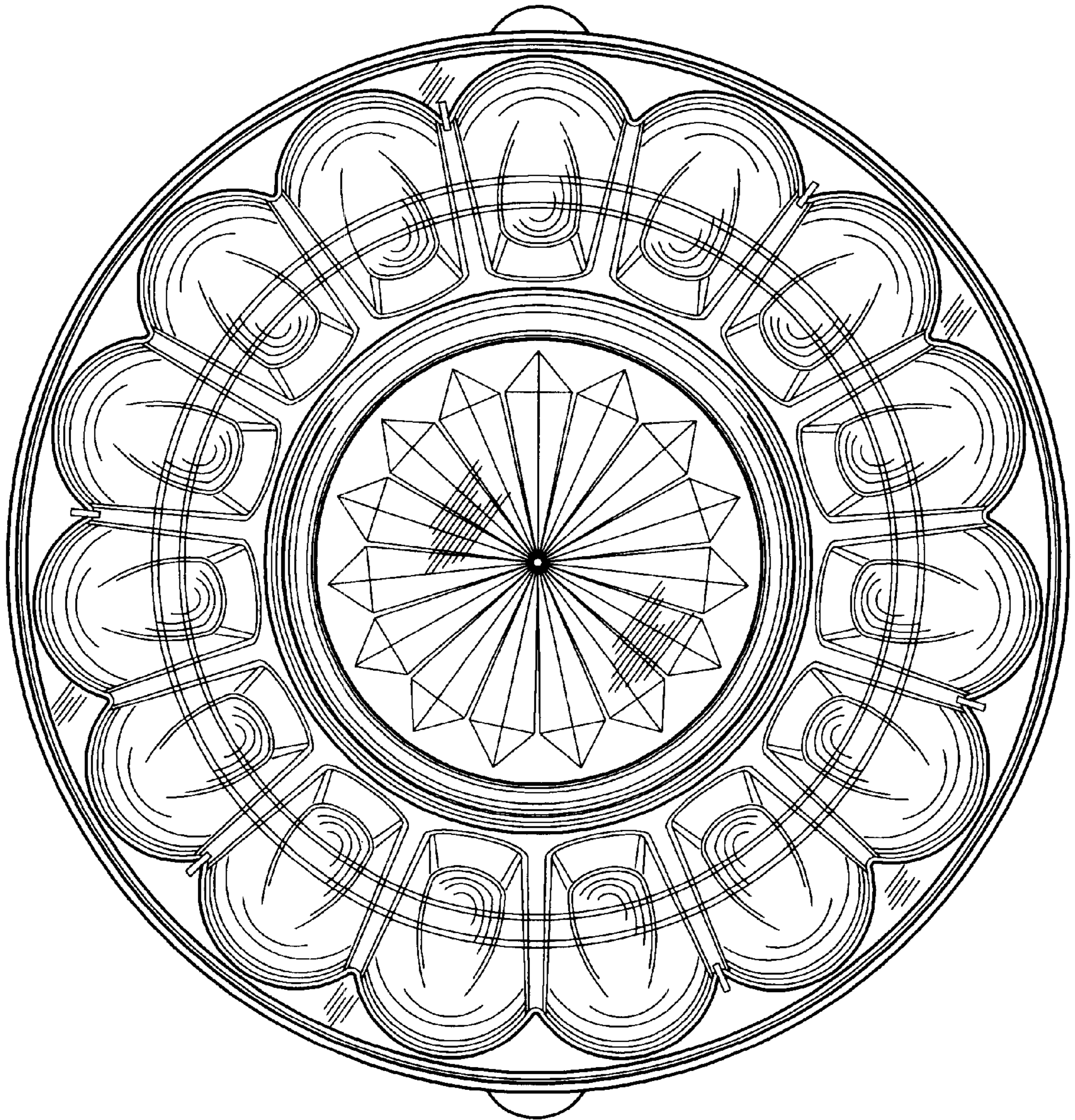

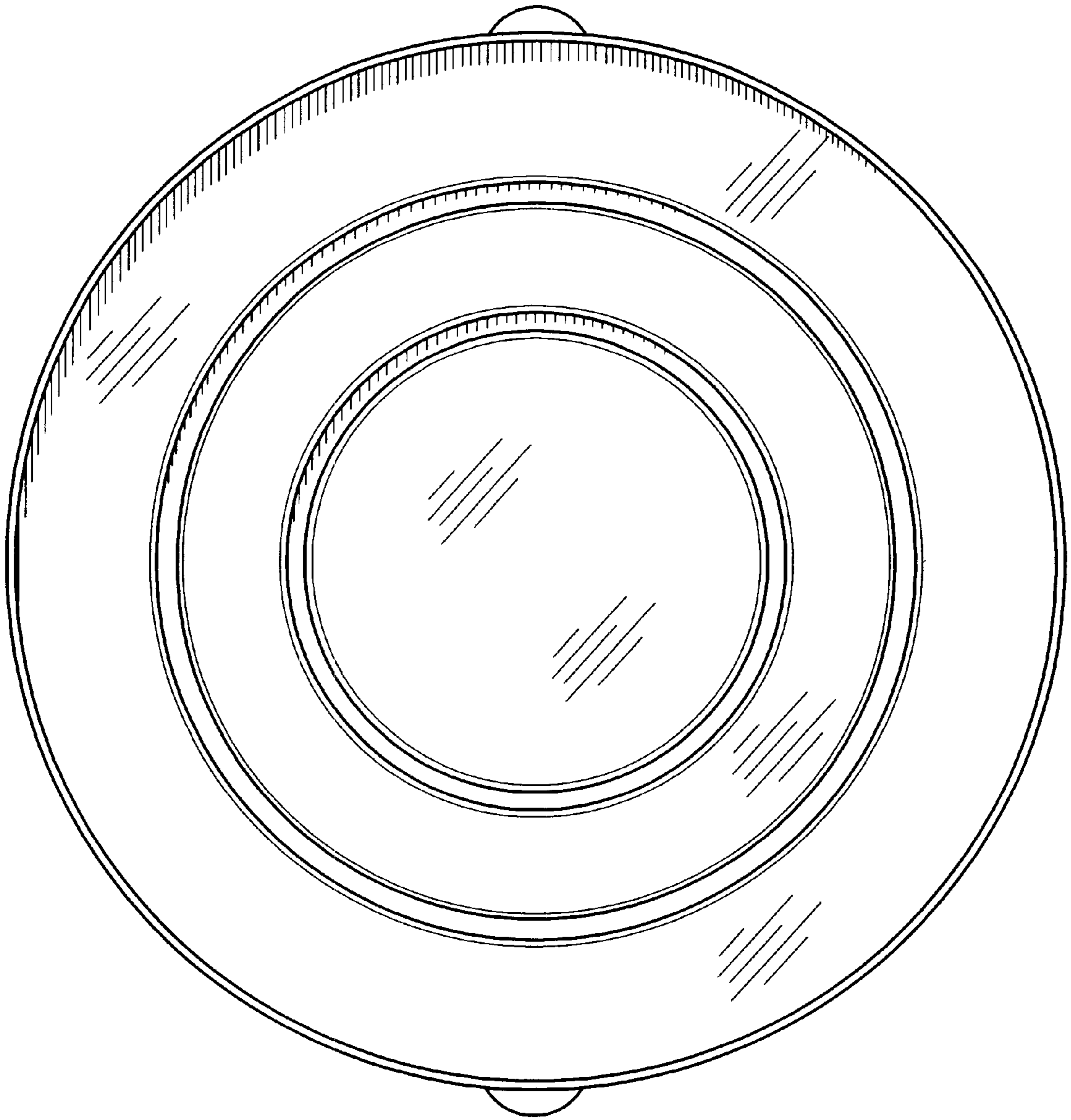

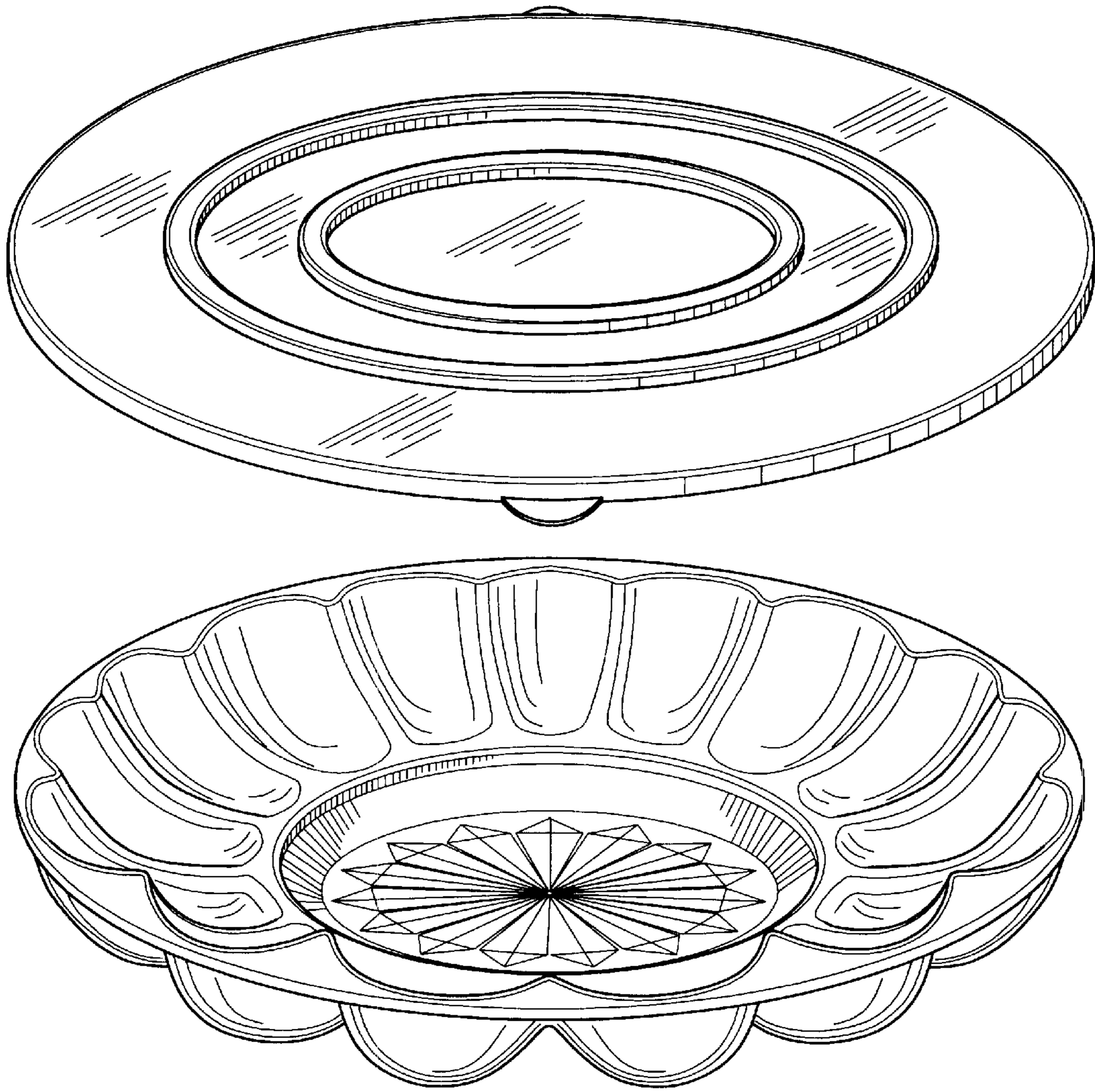
