(57) **CLAIM**

The ornamental design for an antiperspirant and/or deodorant product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an antiperspirant and/or deodorant product showing the new design;

FIG. 2 is a top plan view of the antiperspirant and/or deodorant product of FIG. 1;

FIG. 3 is a front elevation view of the antiperspirant and/or deodorant product of FIG. 1, the rear elevation view being a mirror image thereof;

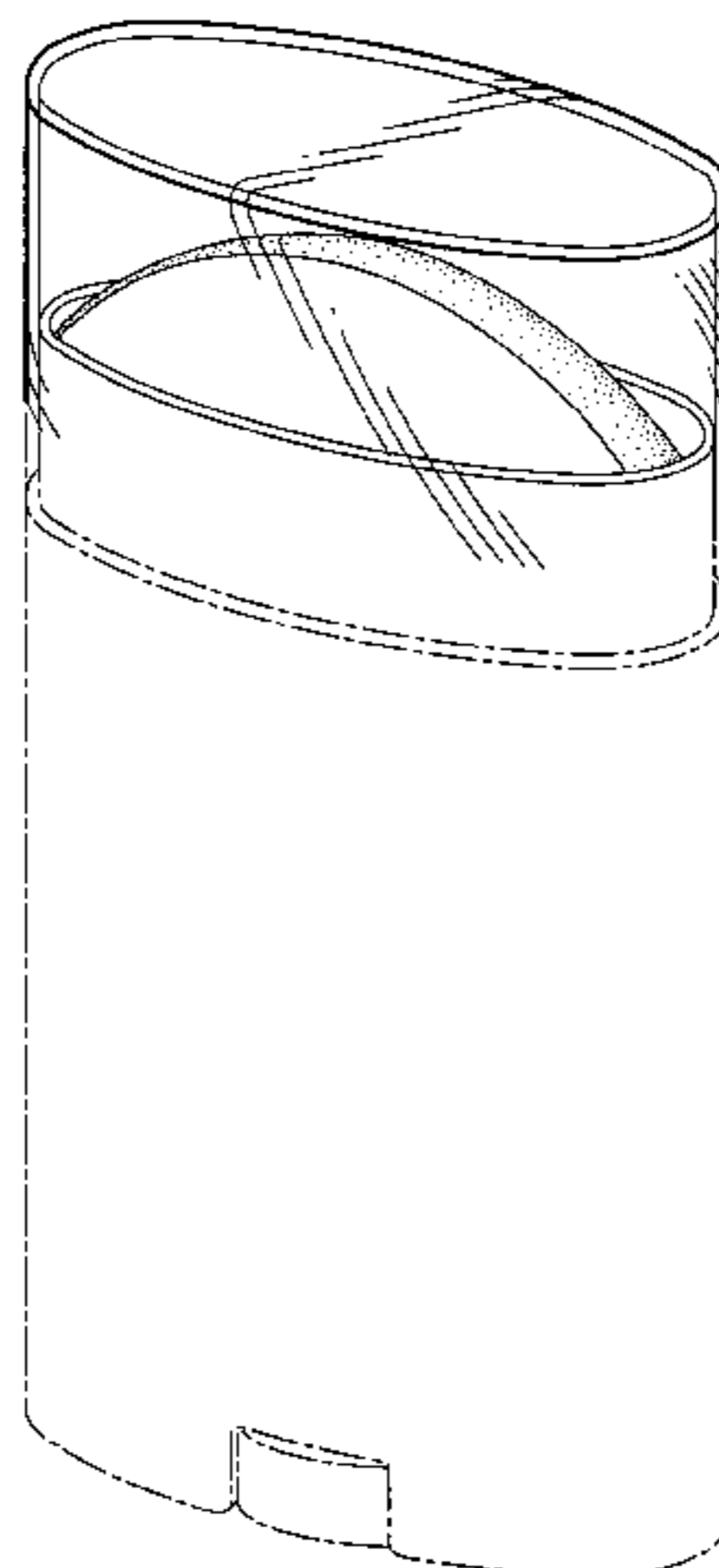
FIG. 4 is a side elevation view of the antiperspirant and/or deodorant product of FIG. 1, the other side elevation view being a mirror image thereof; and,

FIG. 5 is a bottom plan view of the antiperspirant and/or deodorant product of FIG. 1.

The broken lines showing the bottom portion of the container beneath the broken line boundary are for illustrative purposes only and form no part of the claimed design.

The stippling represents a surface having a color that contrasts with the color of the surface that does not include stippling. The stippled surface and contrasting surface can be seen through the cap.

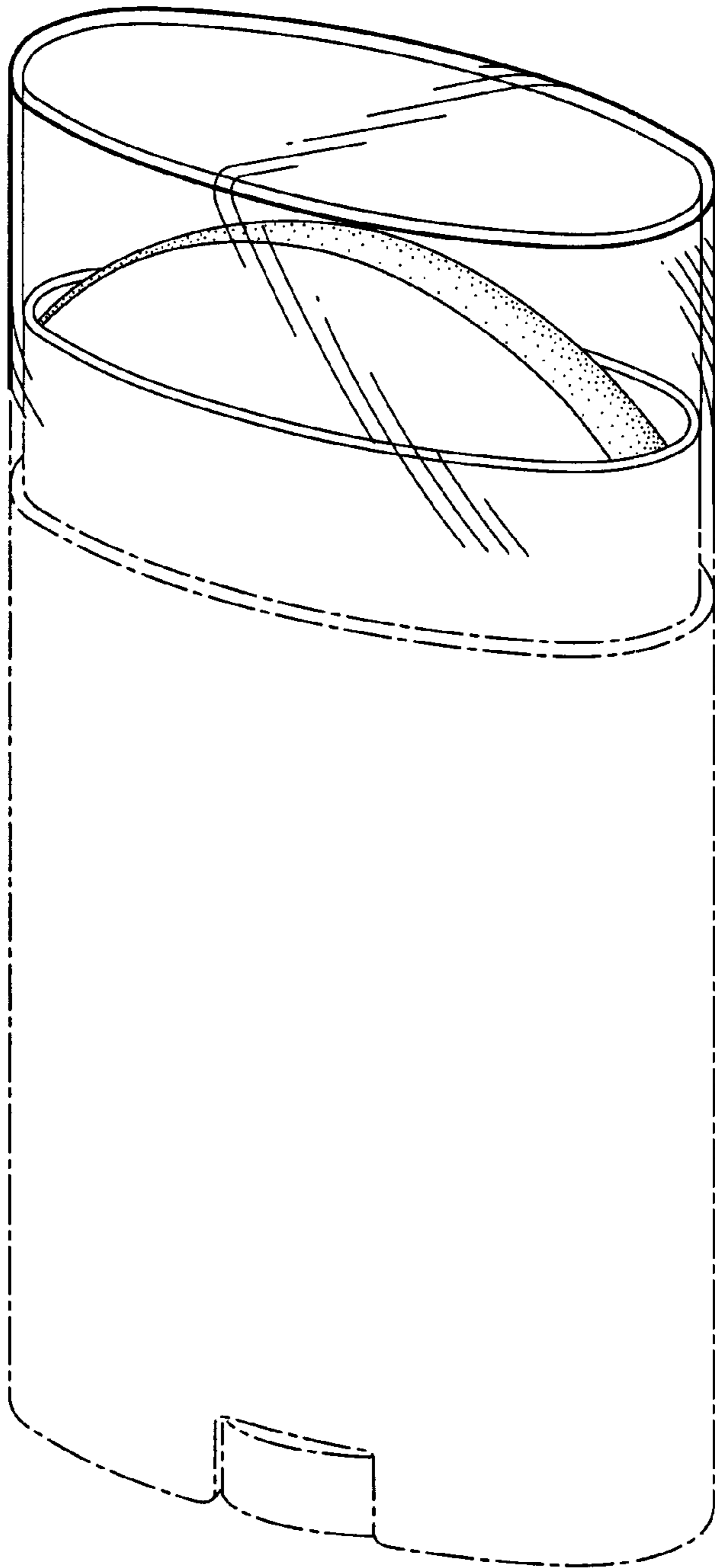

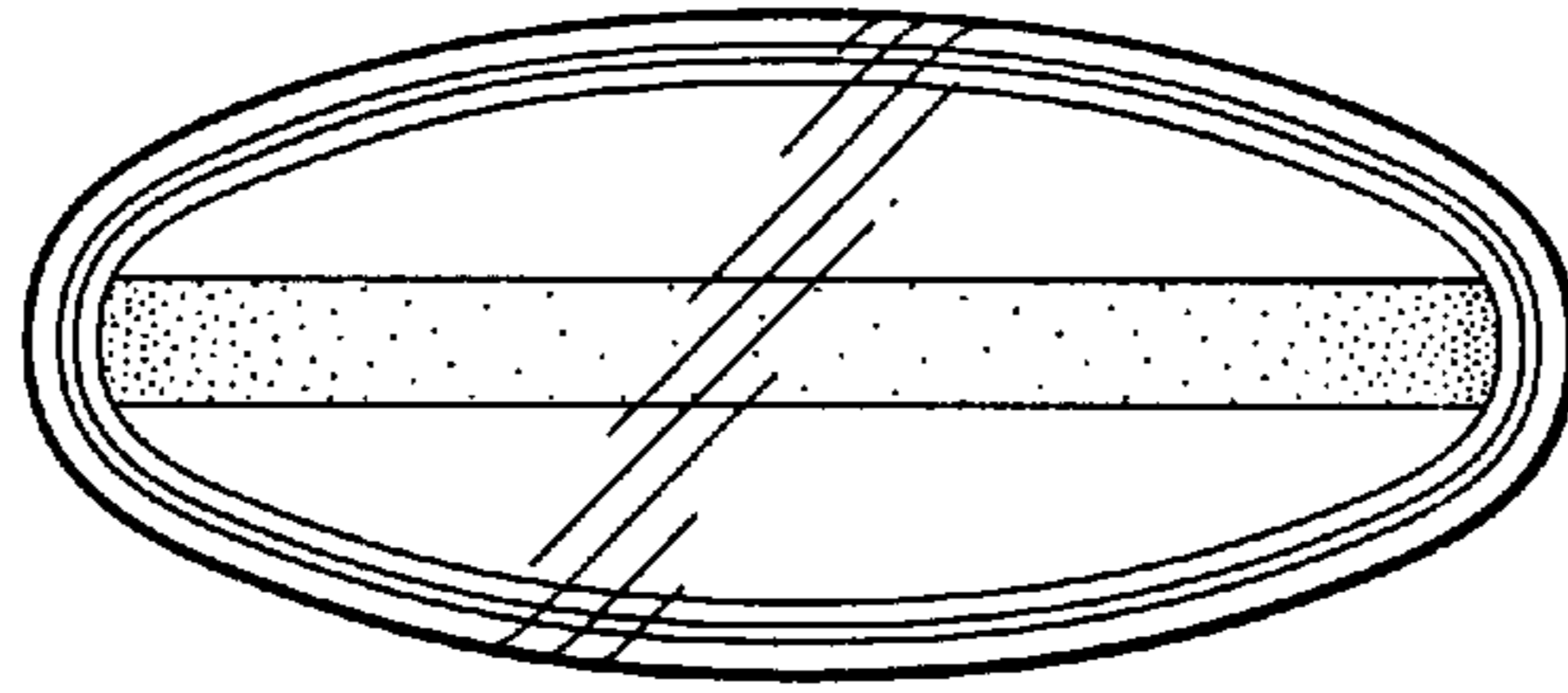

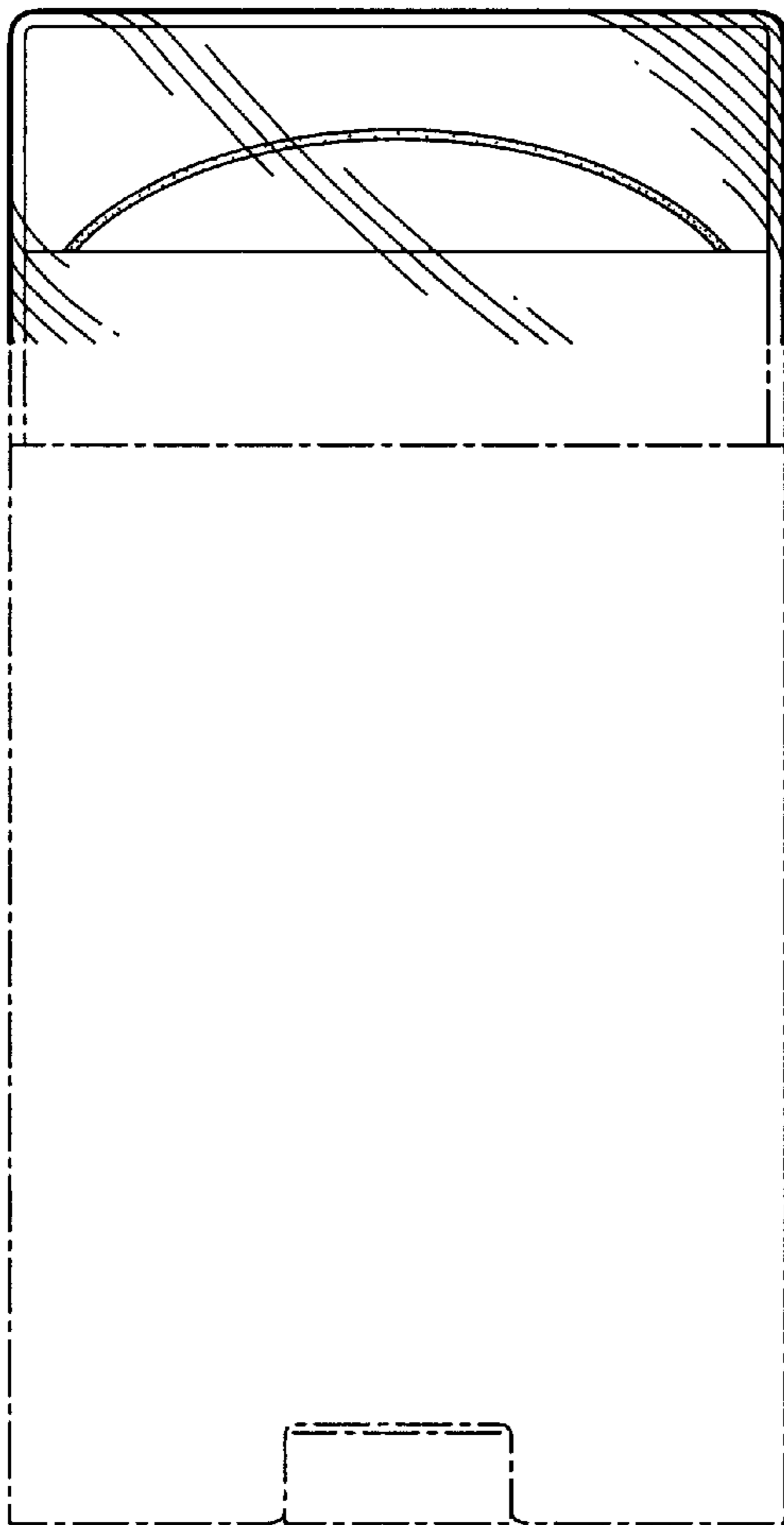

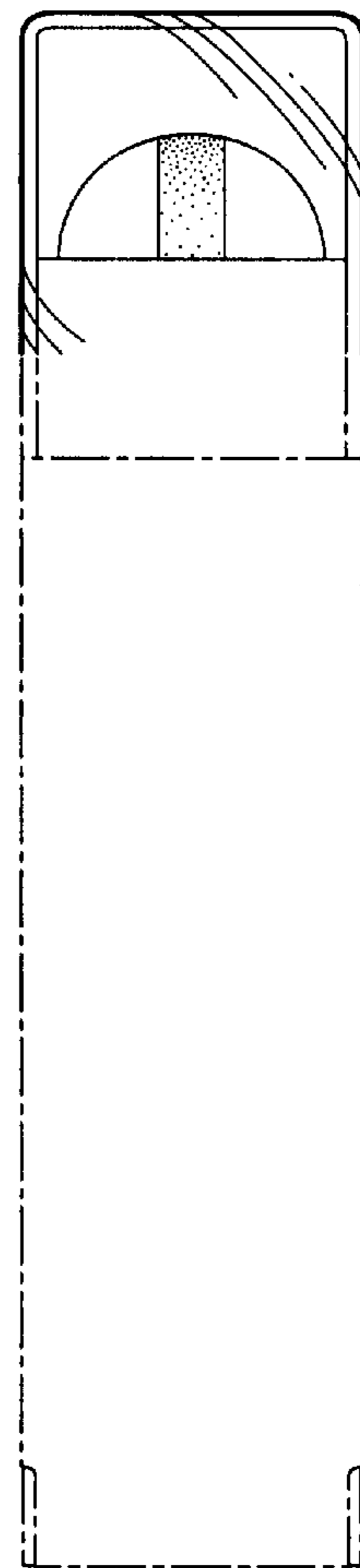
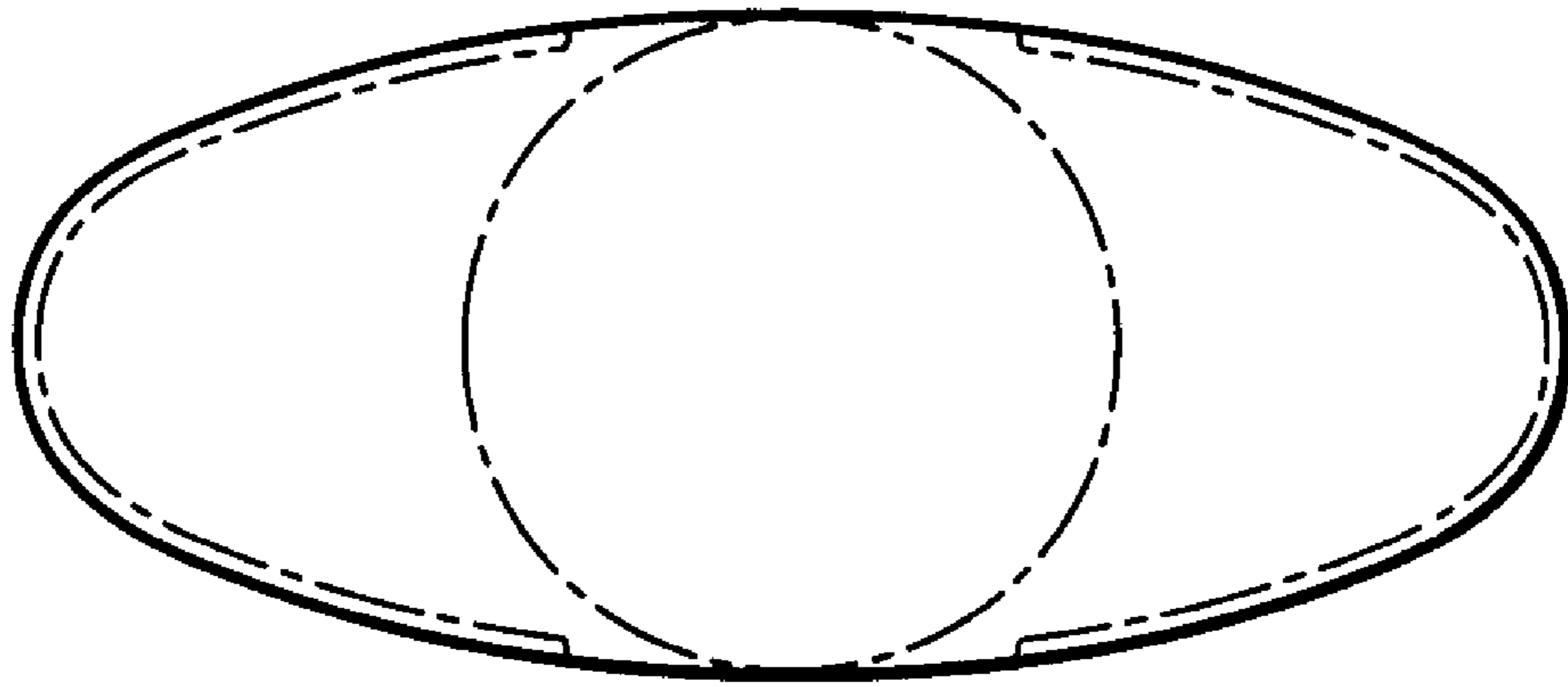
