The ornamental design for the container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective side view of a container embodying our design;  
FIG. 2 is a front elevational view of the design in FIG. 1;  
FIG. 3 is a right side elevational view of the design in FIG. 1;  
FIG. 4 is a rear elevational view of the design in FIG. 1;  
FIG. 5 is a top plan view of the design in FIG. 1; and,  
FIG. 6 is a bottom view of the system of FIG. 1.

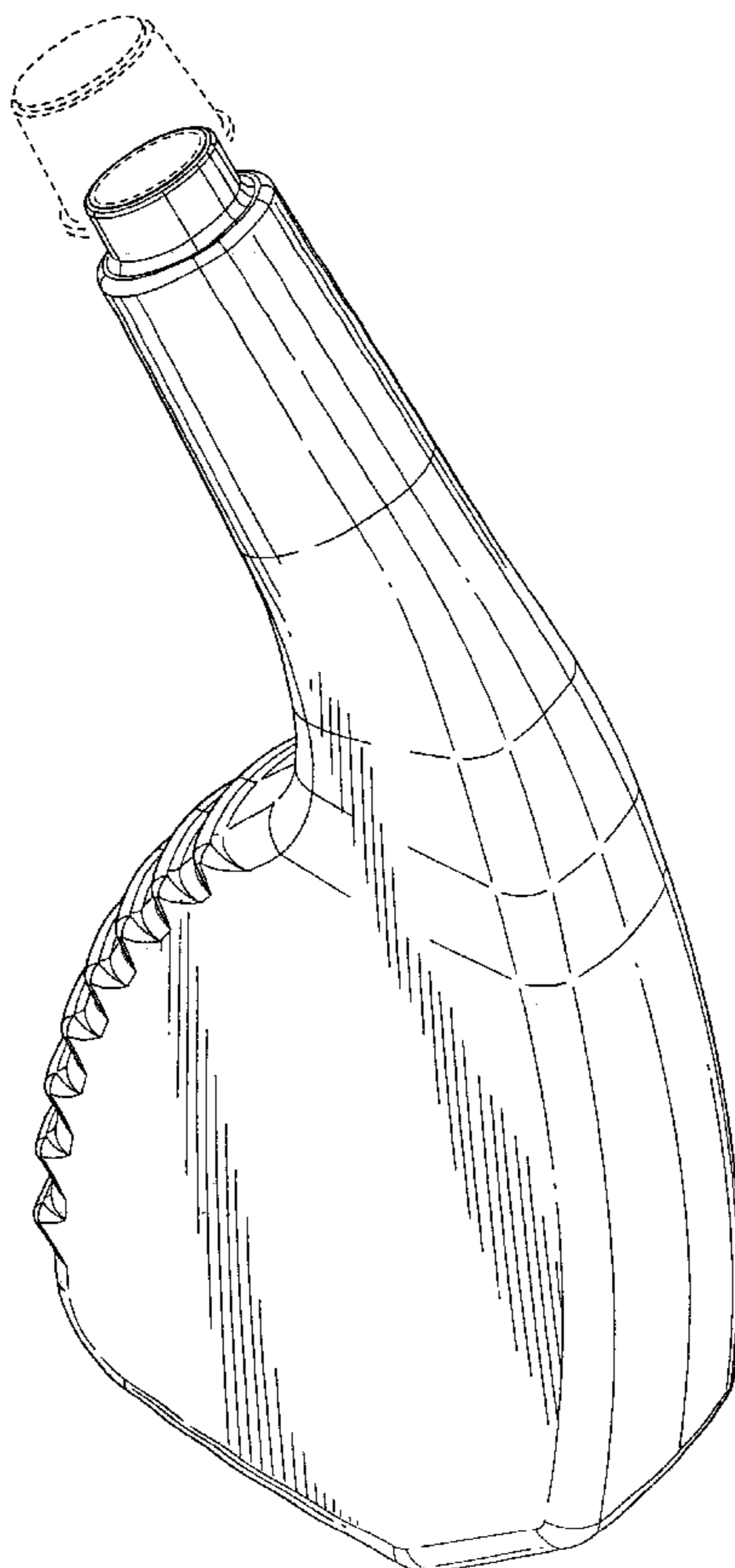

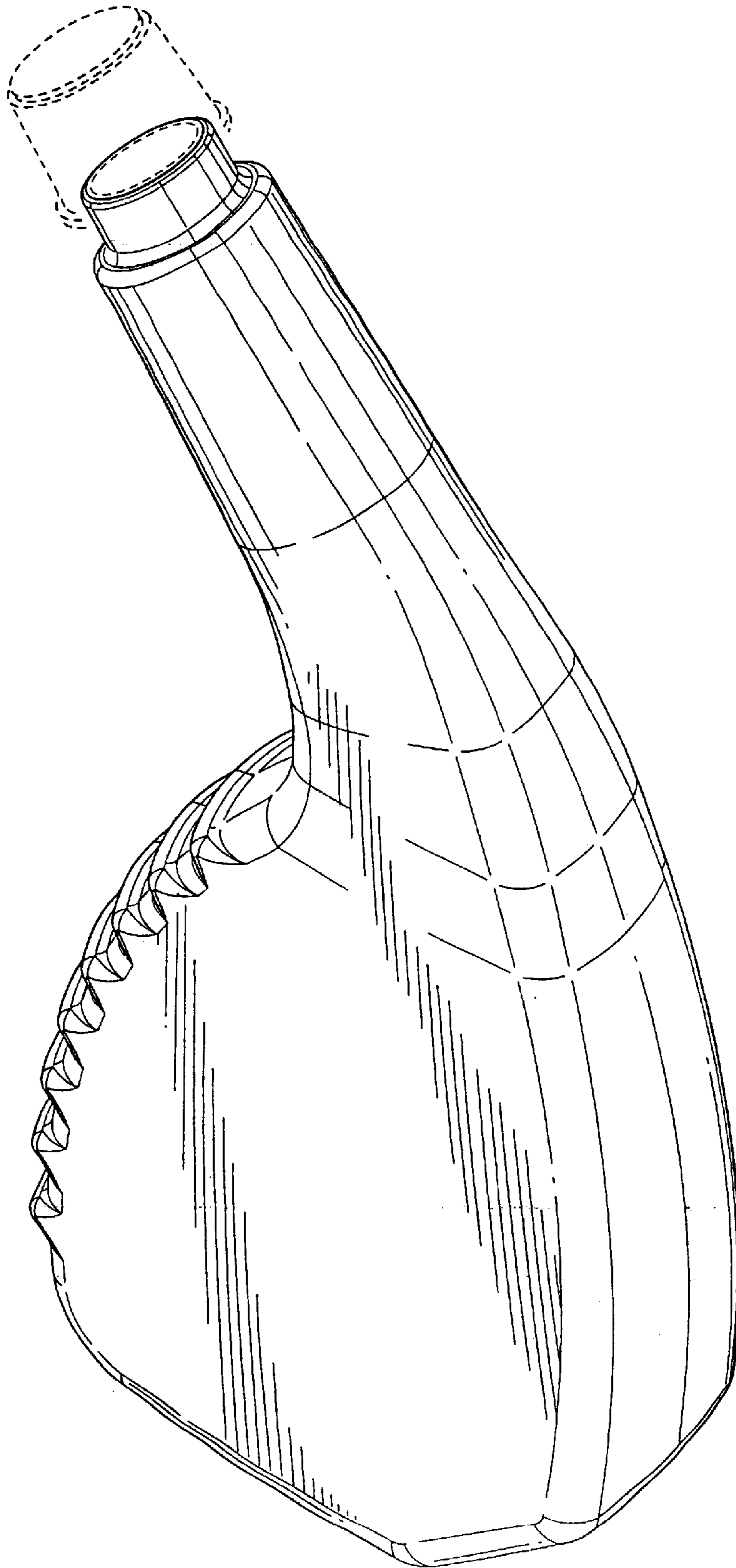

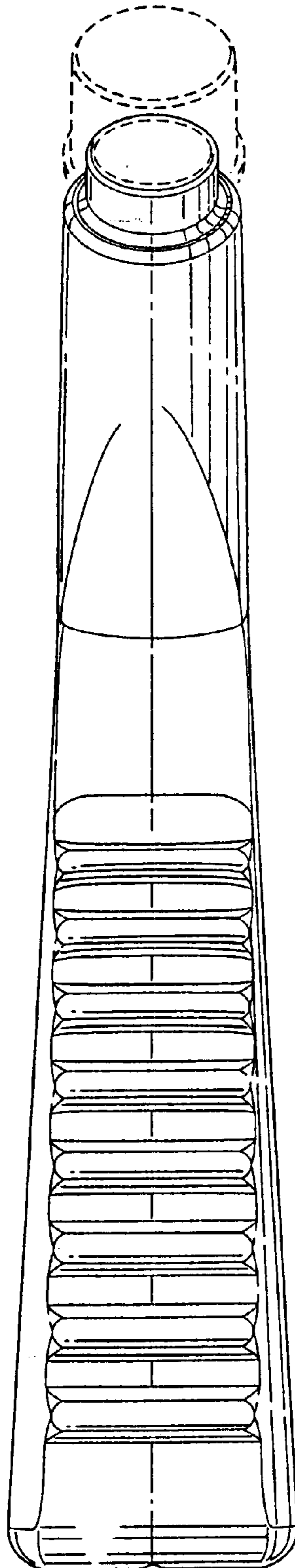

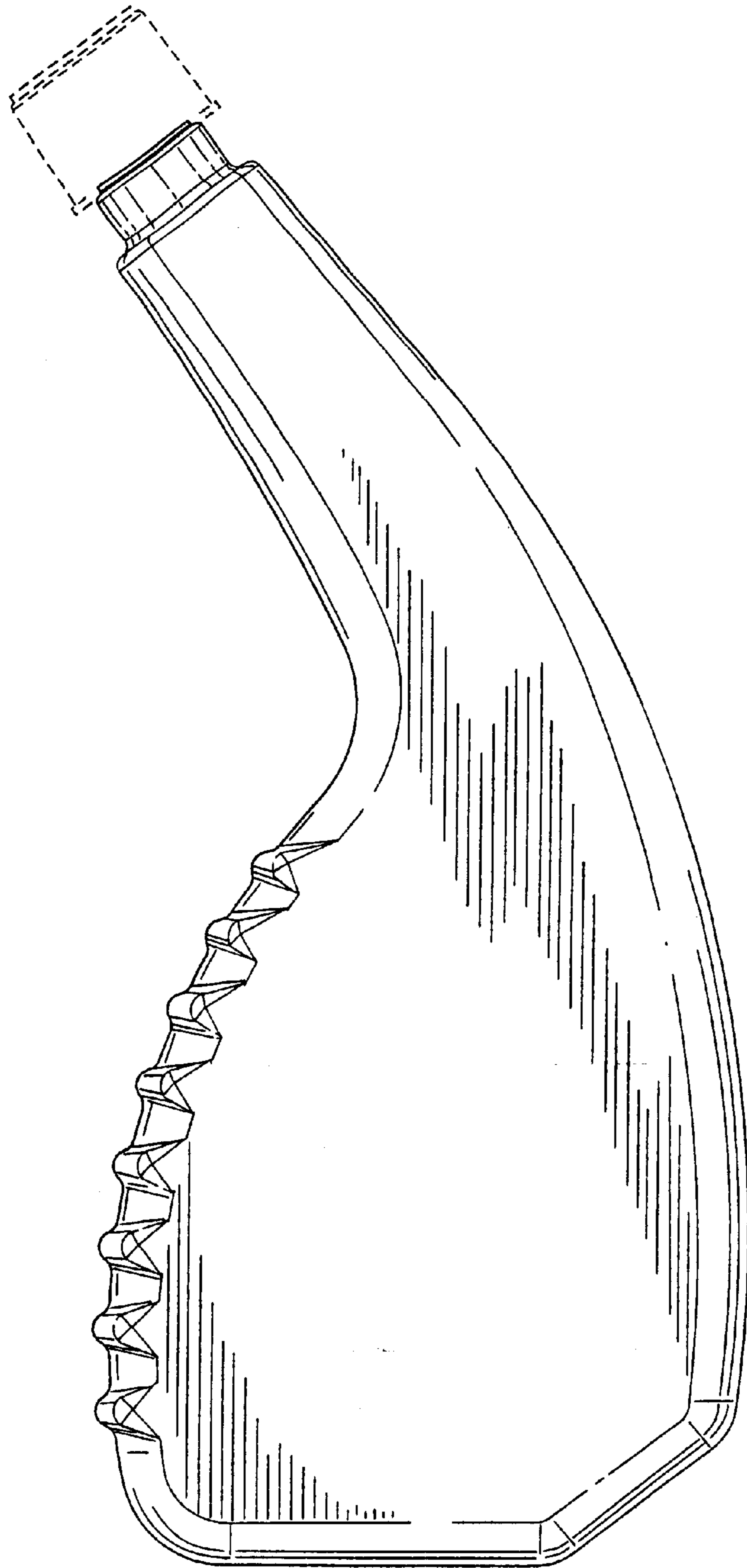

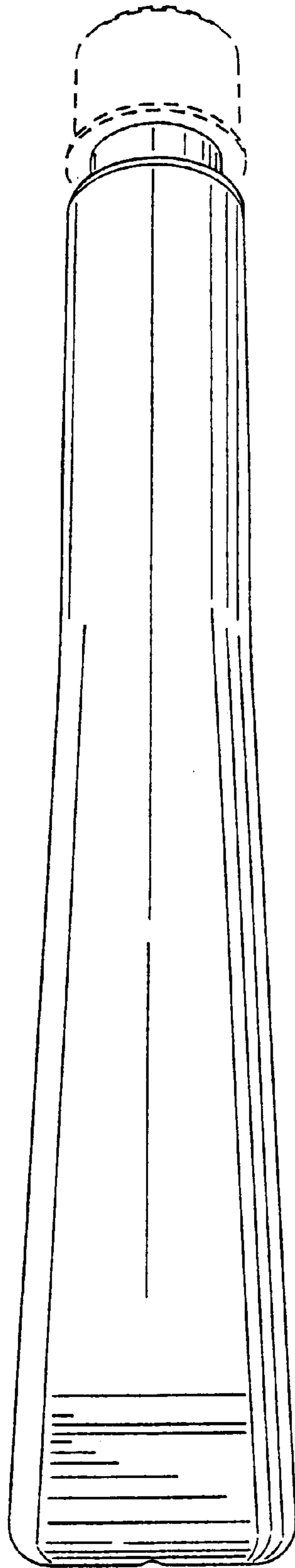

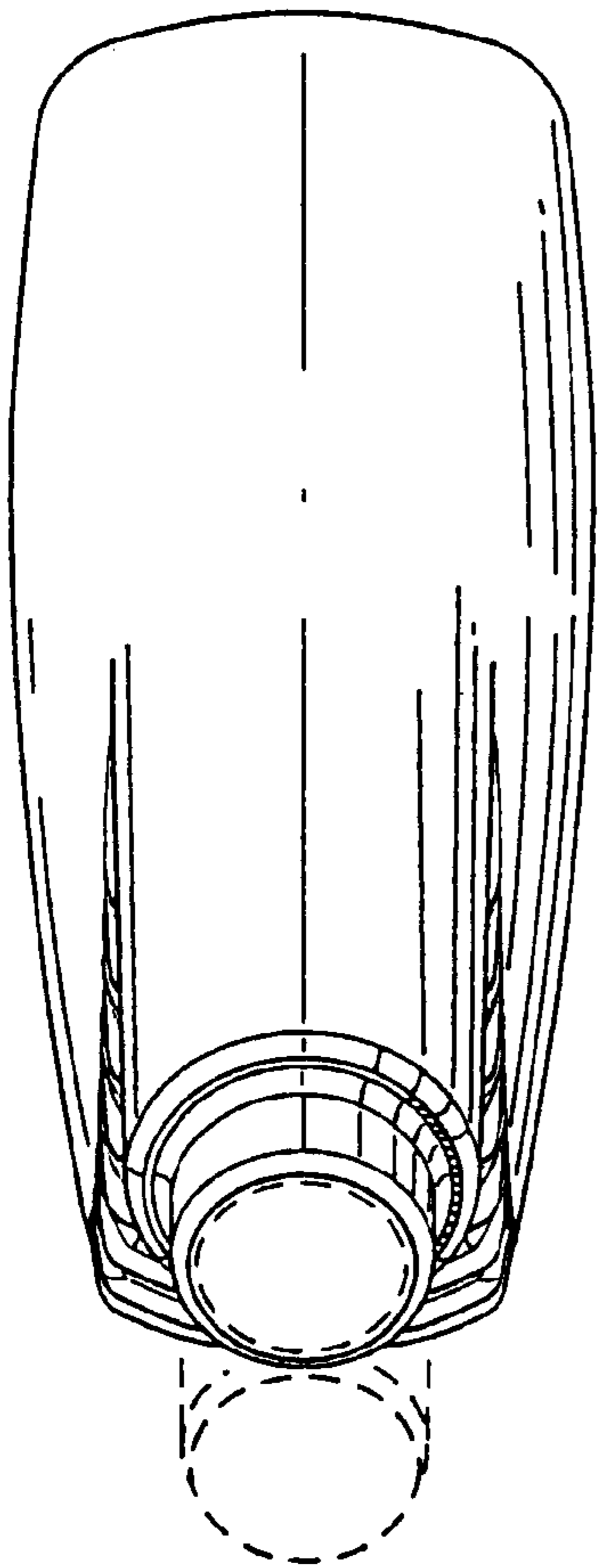
