**DESCRIPTION**

FIG. 1 is a front elevational view of the vehicle window shade of the present invention;

FIG. 2 is a rear elevational view of the vehicle window shade of FIG. 1;

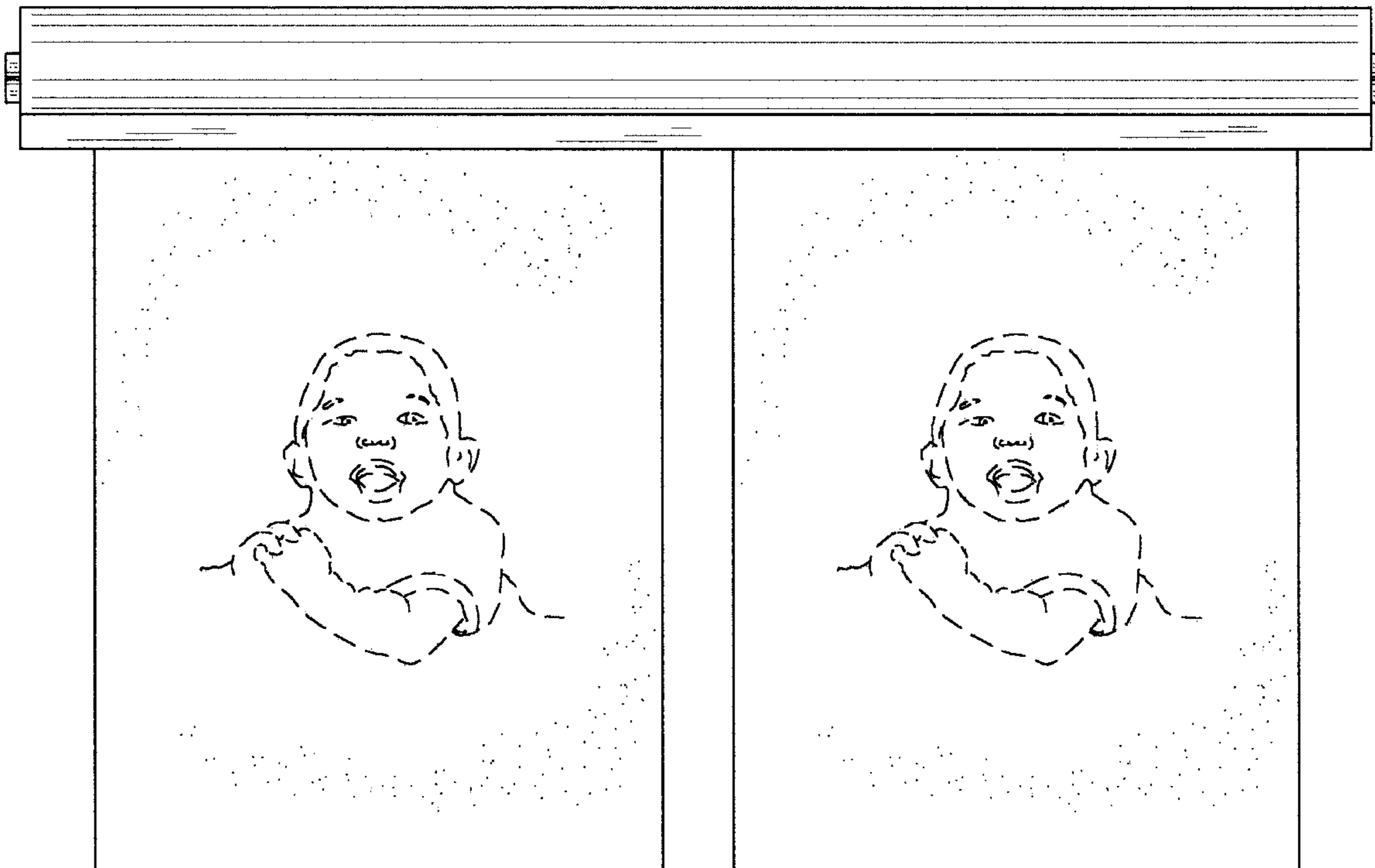
FIG. 3 is a right side elevational view of the vehicle window shade of FIG. 1, the left view being a mirror image thereof;

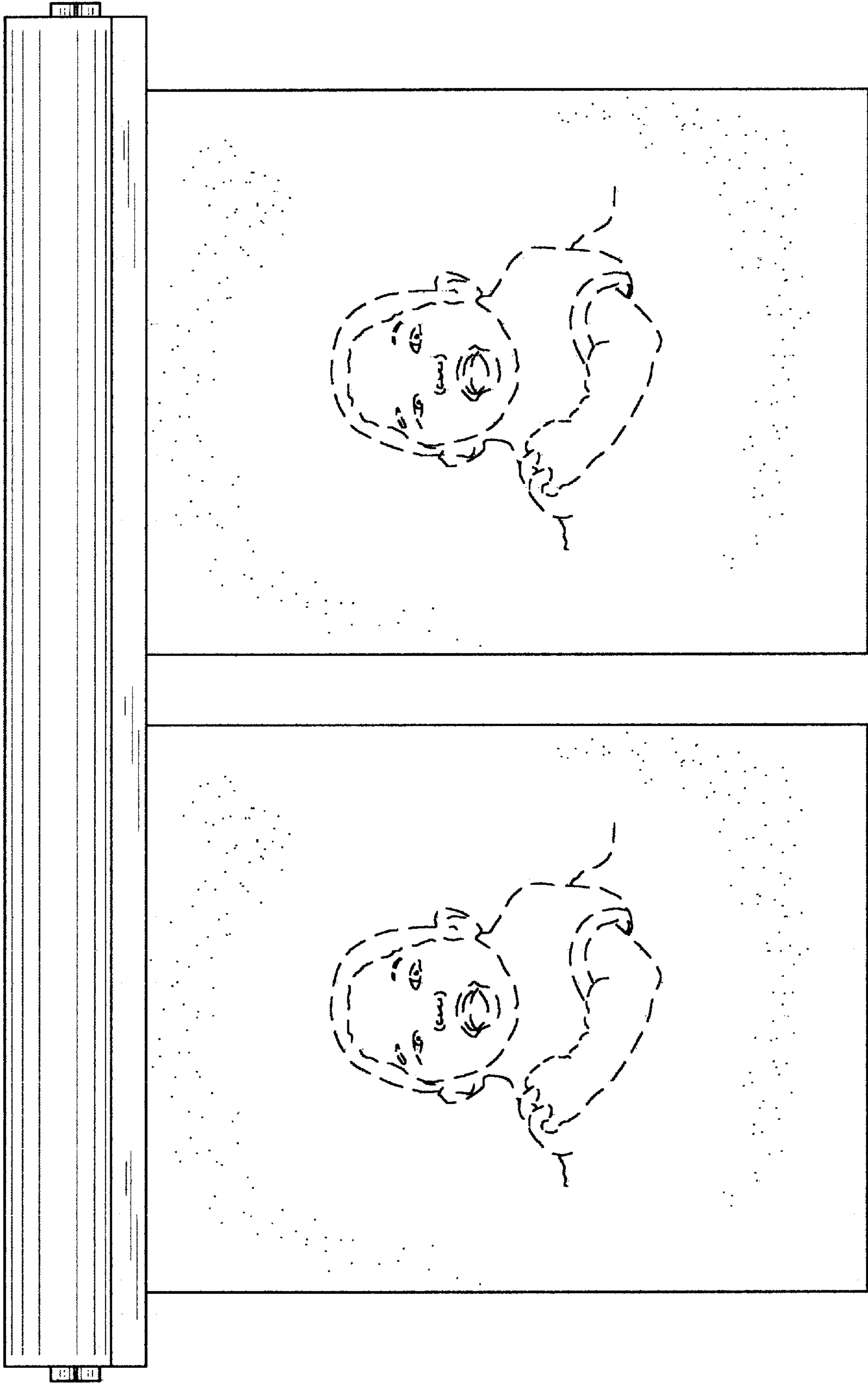

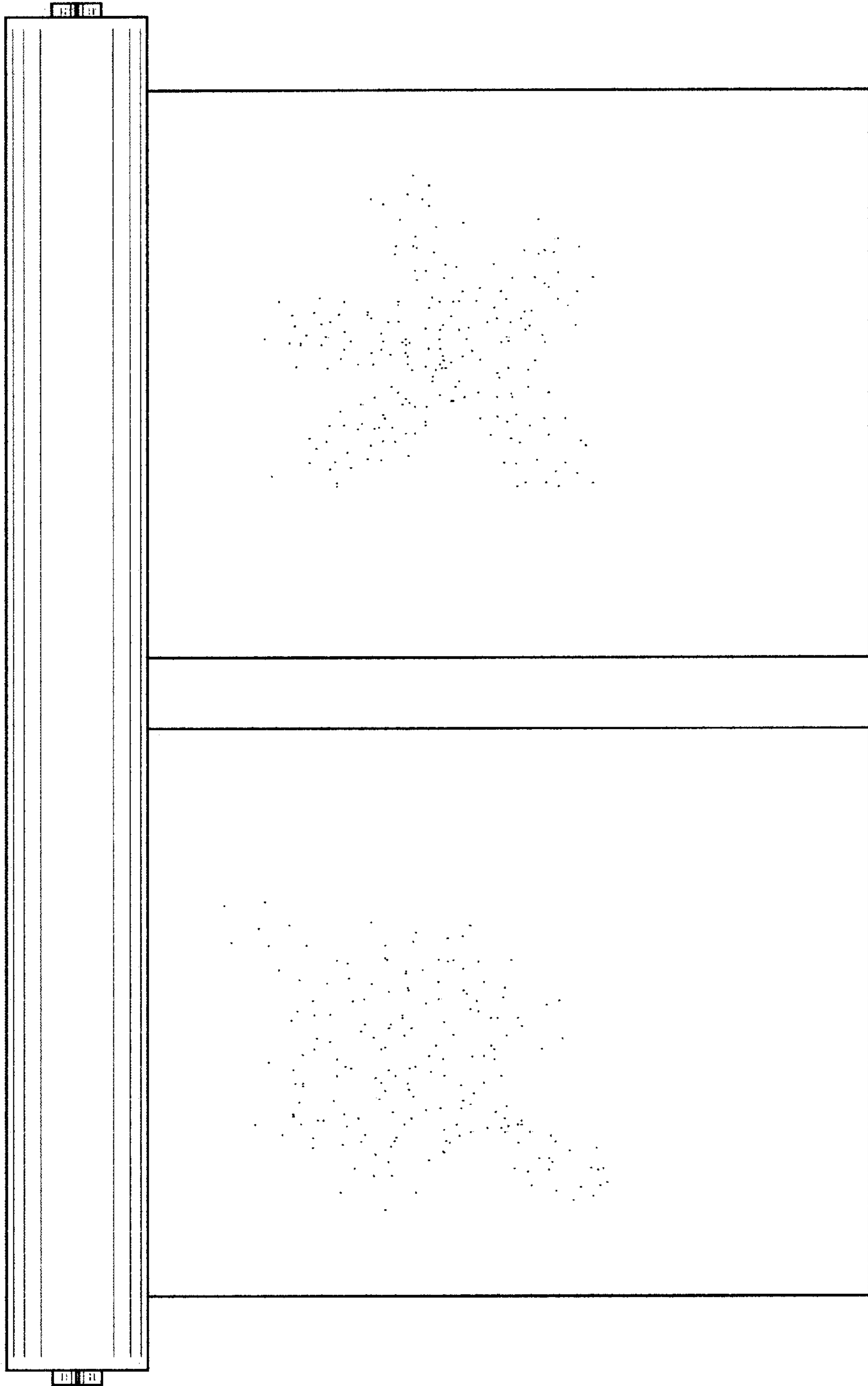

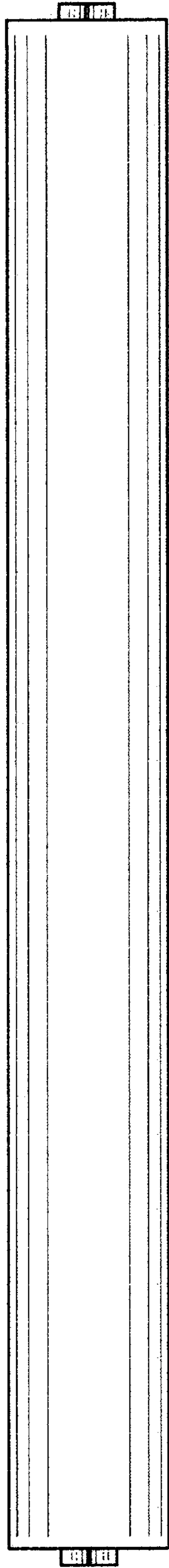
