(57) **CLAIM**

The ornamental design for an automobile tire, as shown and
described.

DESCRIPTION

FIG. 1 is a front view of the automobile tire, showing the
new design, the rear view, top plan view and the bottom plan
view appearing the same as the front view;

FIG. 2 is a right side view of the automobile tire;

FIG. 3 is a fragmentary front view of the tire, showing in
enlargement the portion of 3—3 in FIG. 1; and,

FIG. 4 is a sectional view, taken on line 4—4 of FIG. 3.

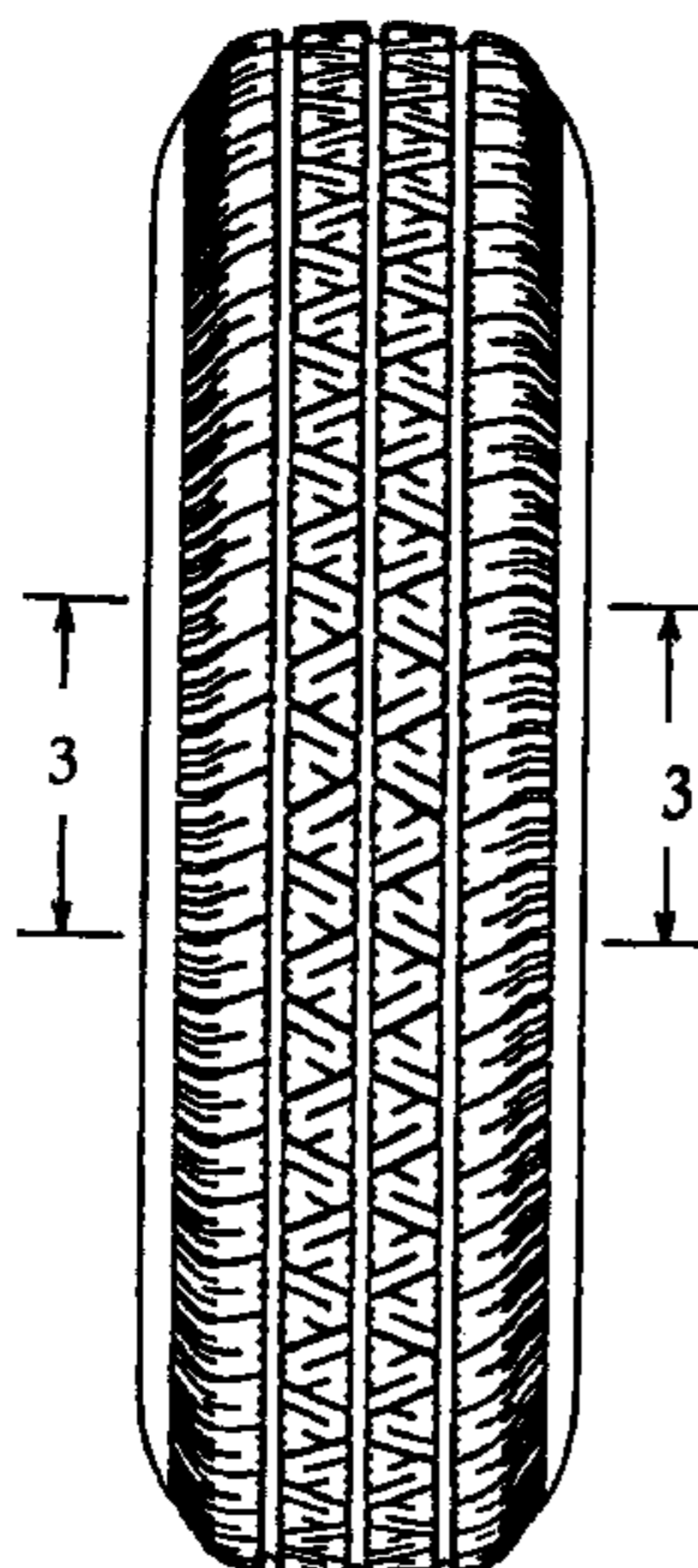

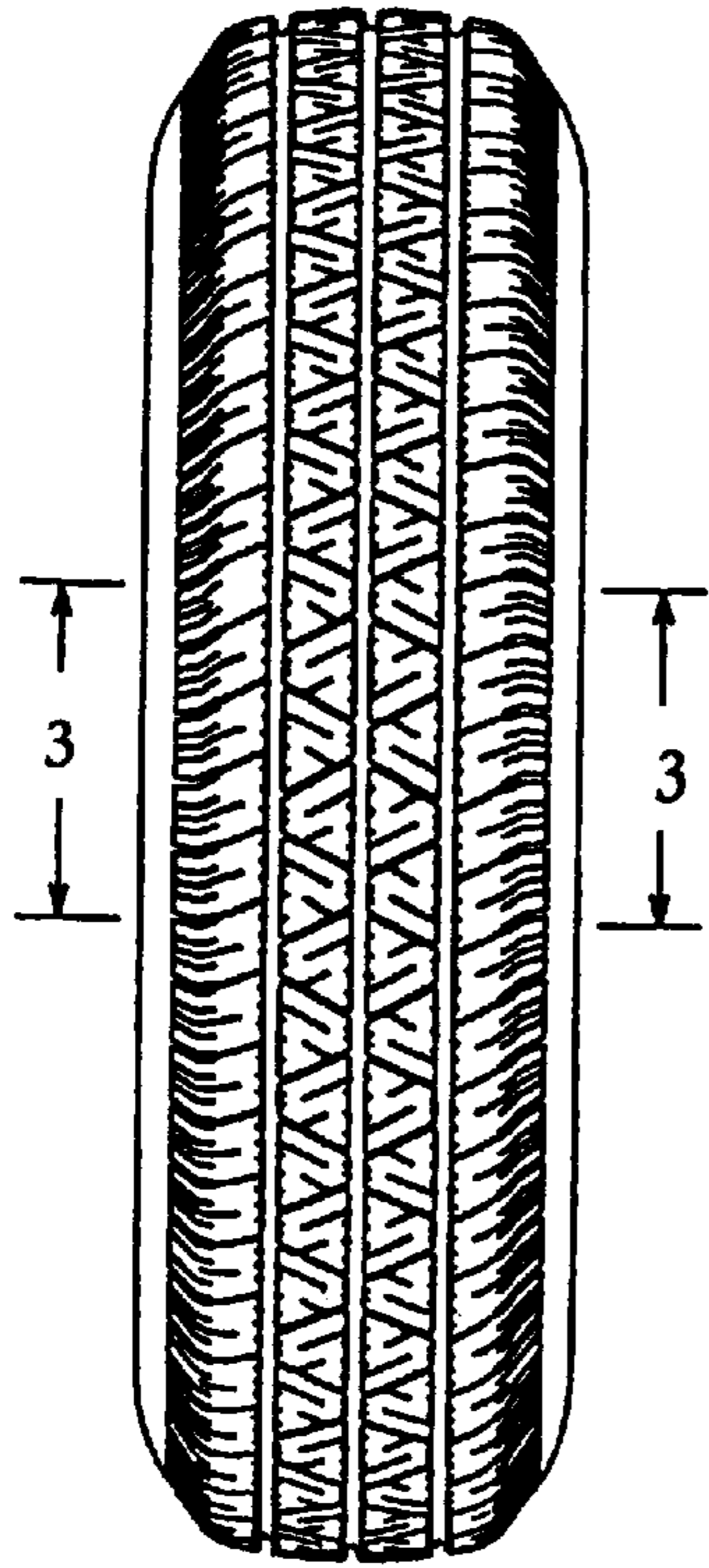

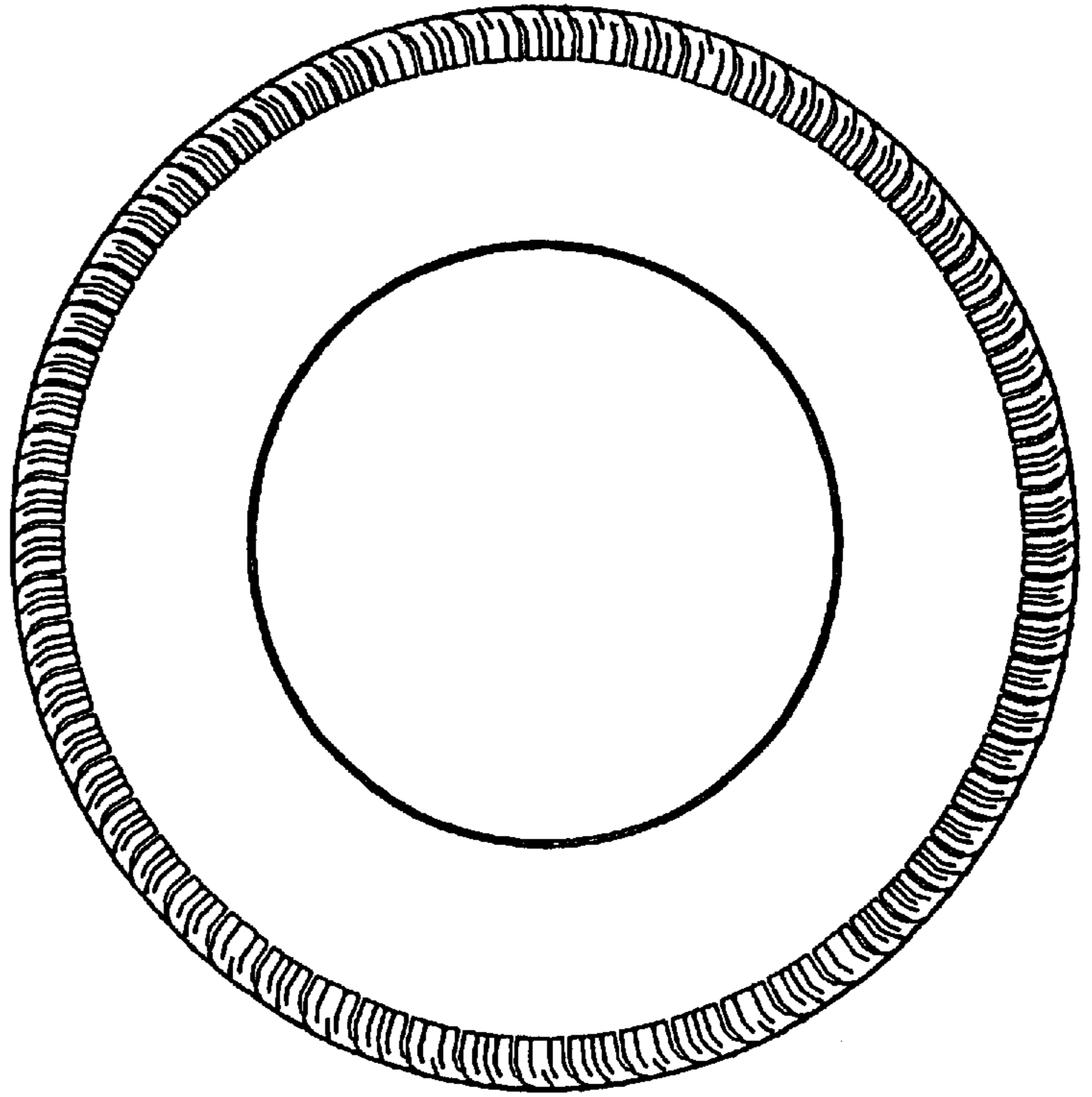

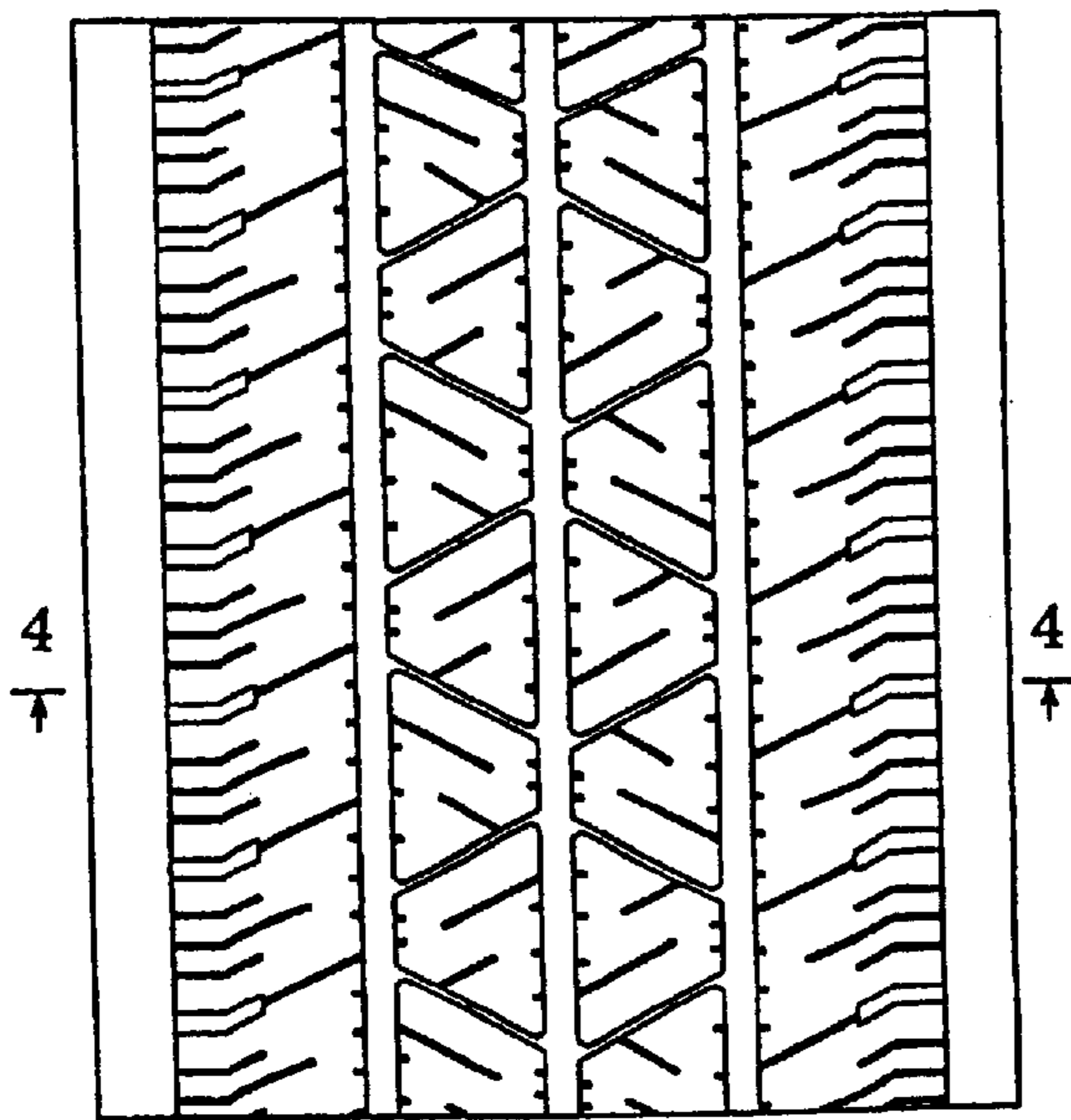
