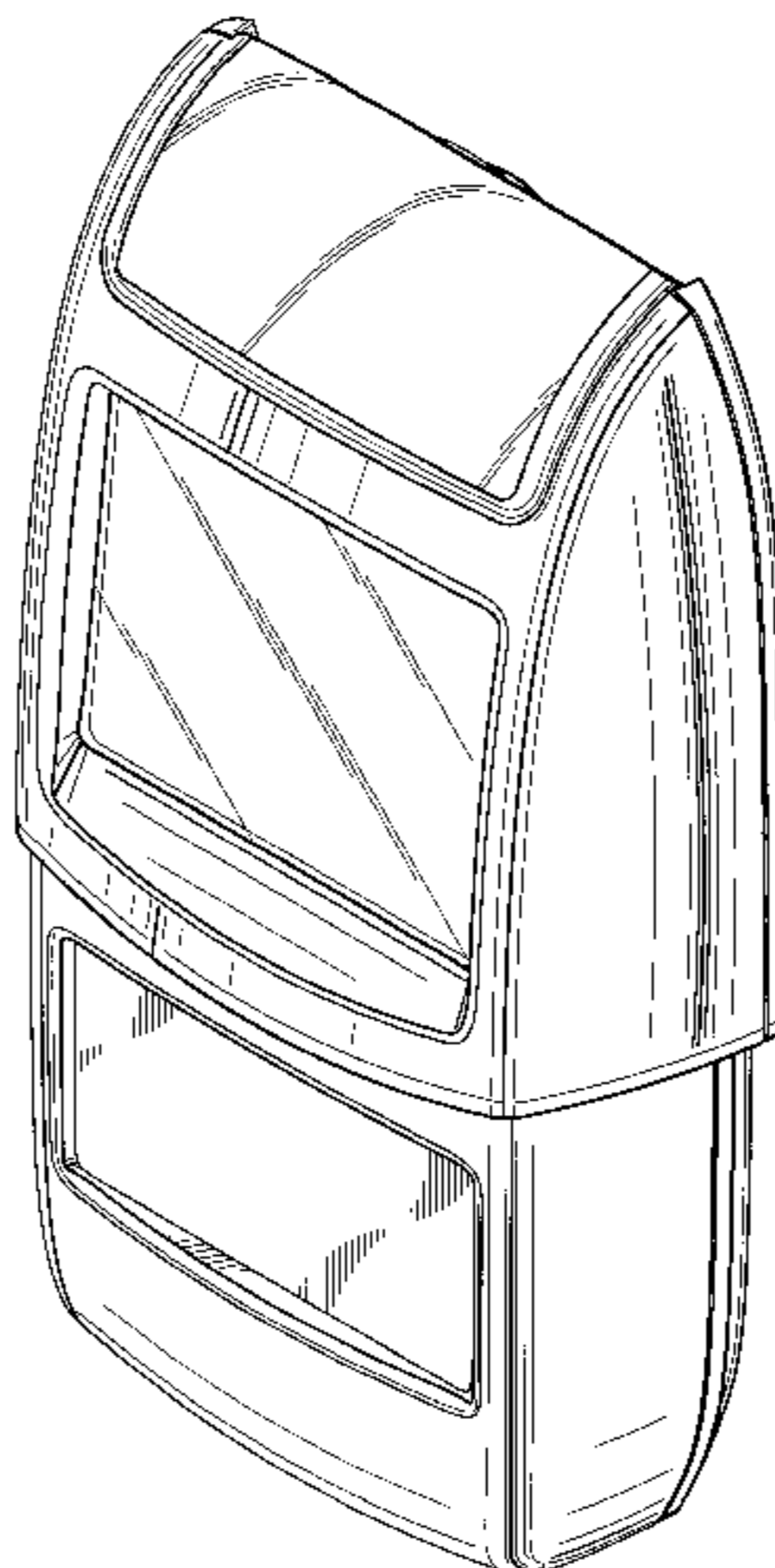
(57) **CLAIM**

The ornamental design for a "wall mounted audiovisual device", as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the wallmounted audiovisual device of the instant invention;

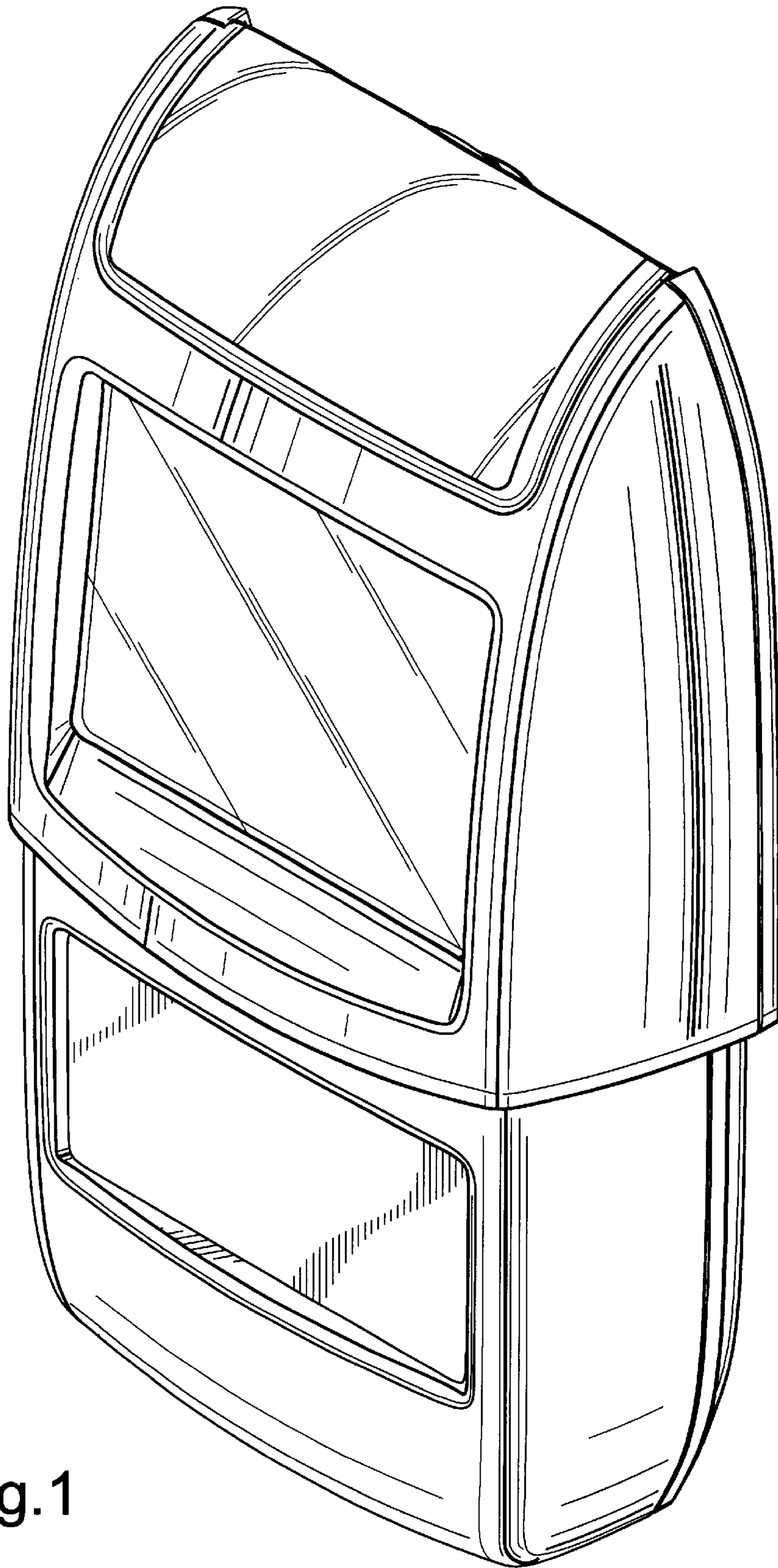

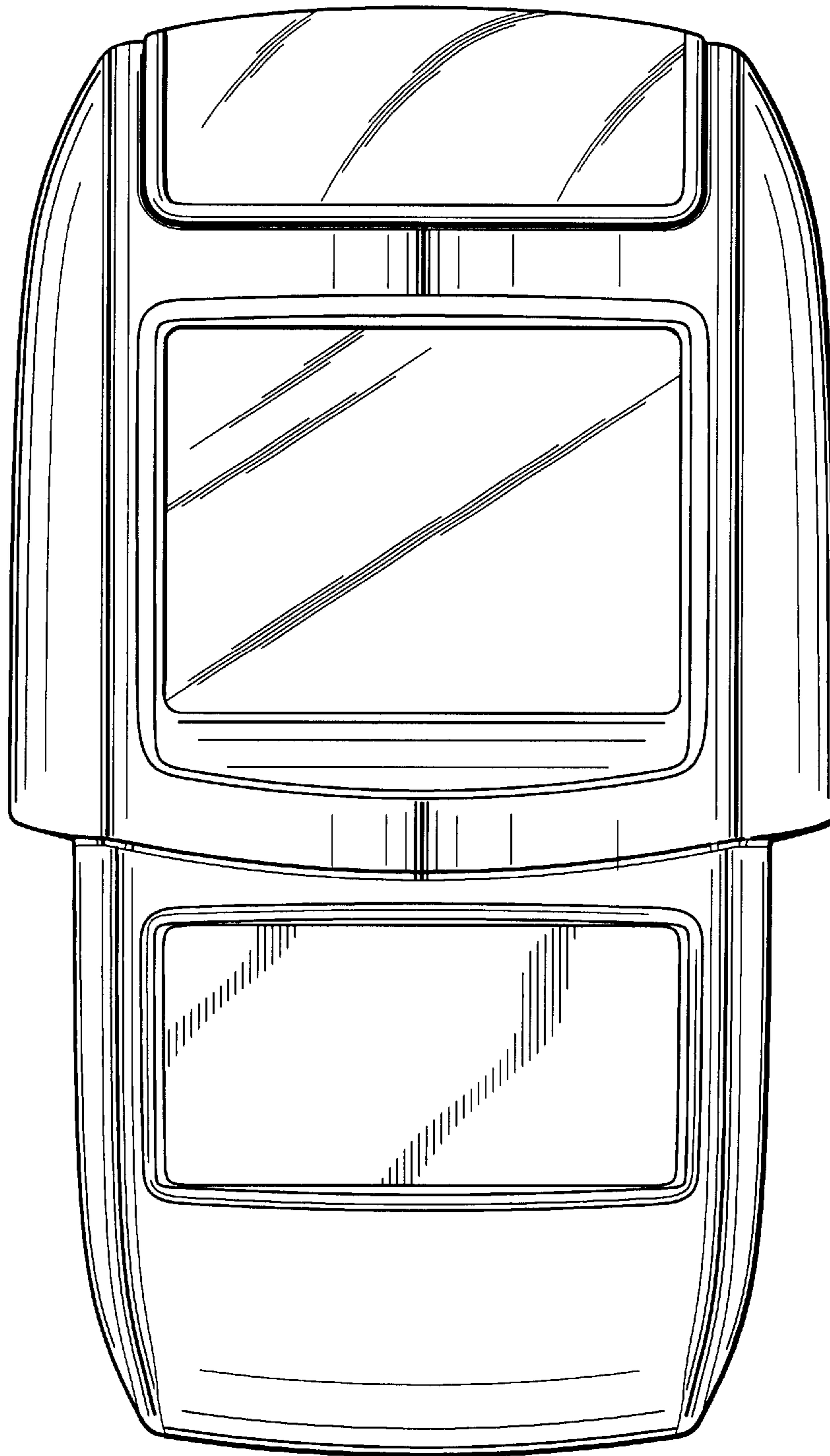

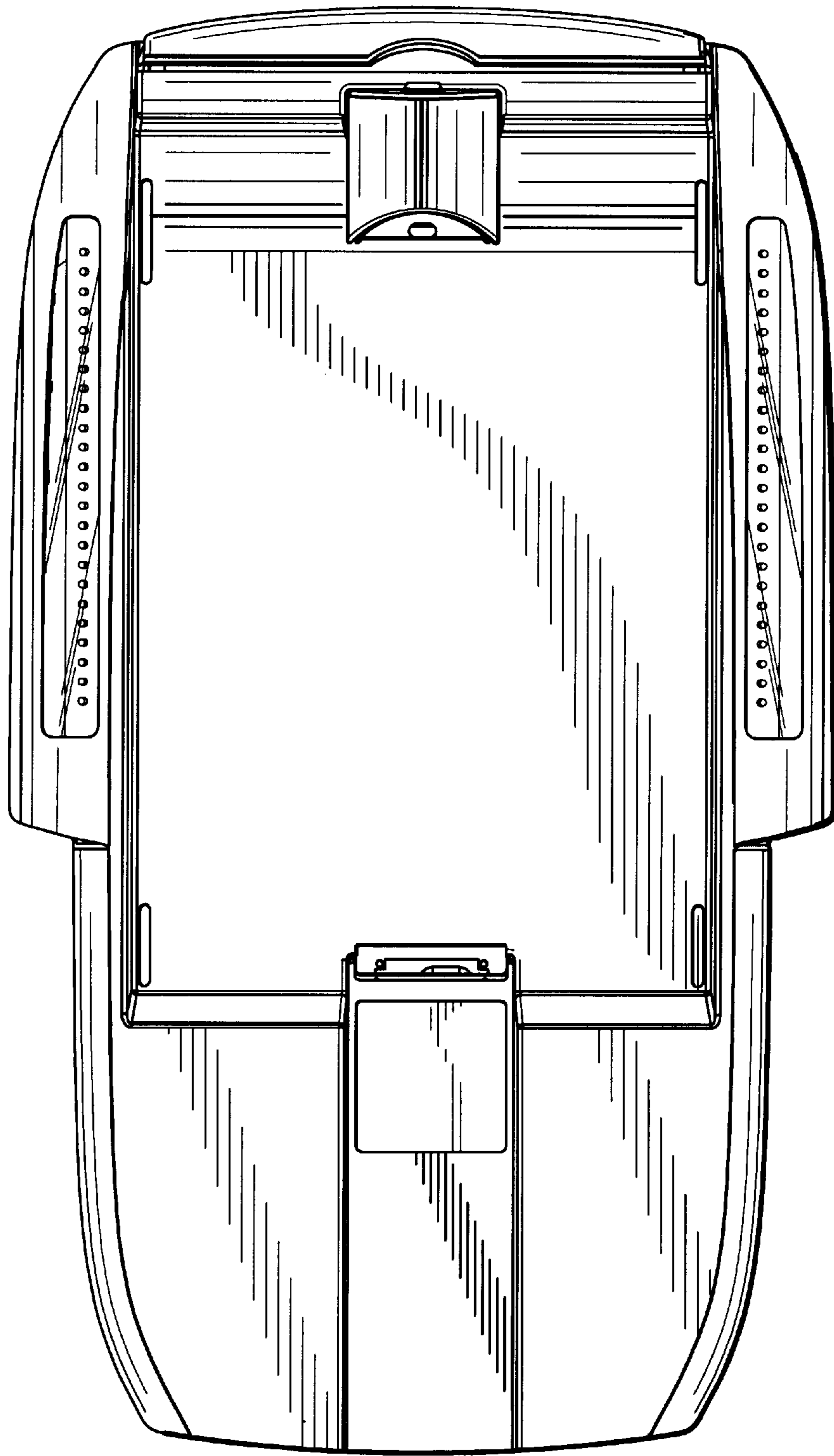

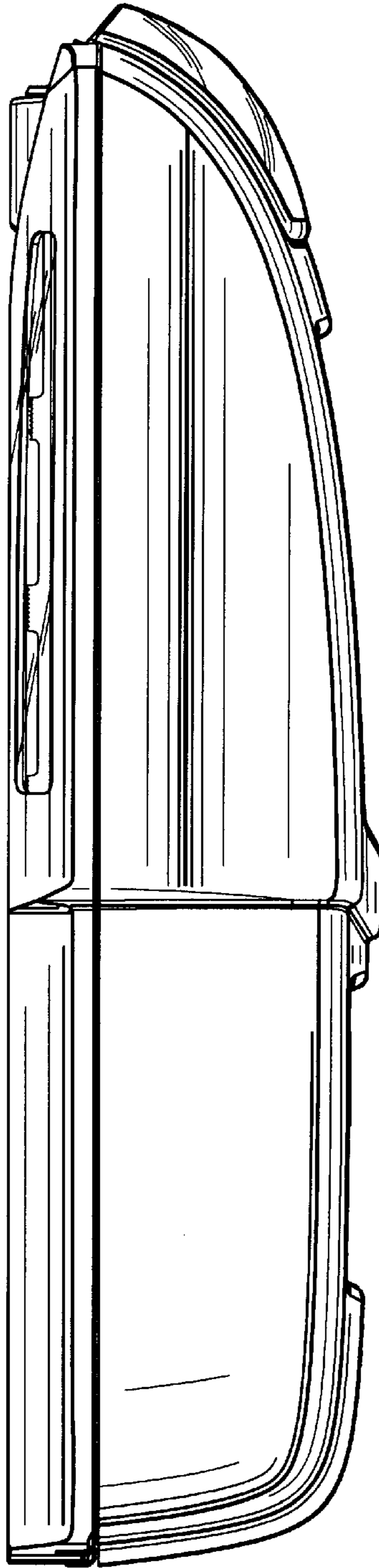

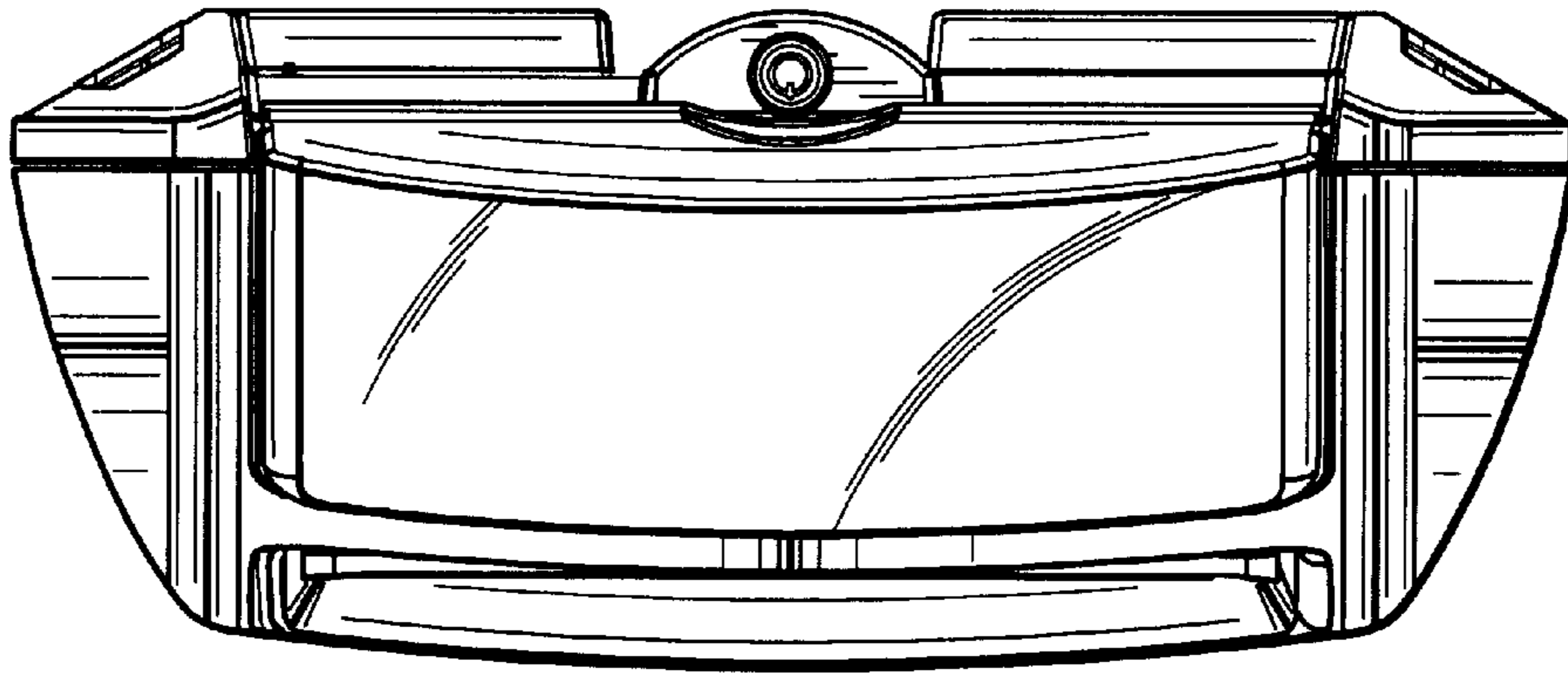

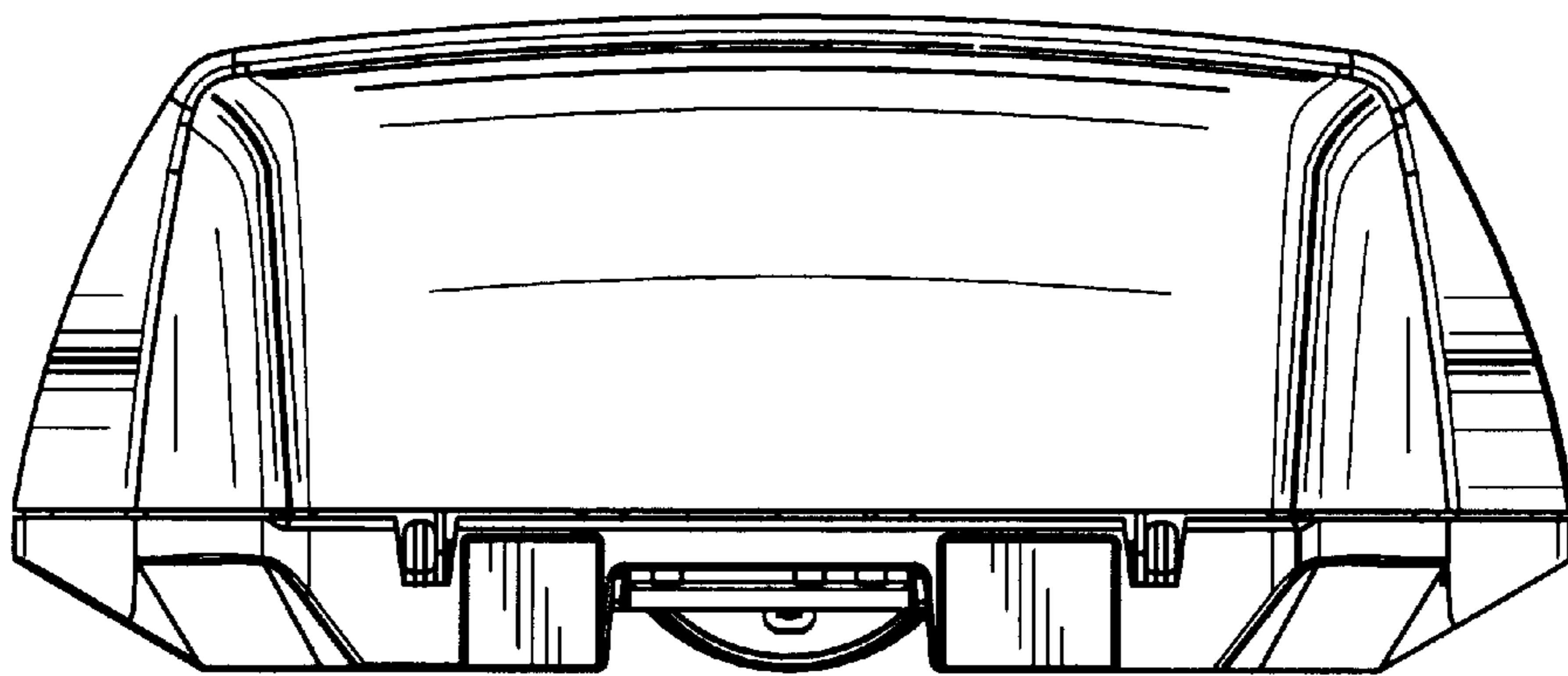
