(57) **CLAIM**

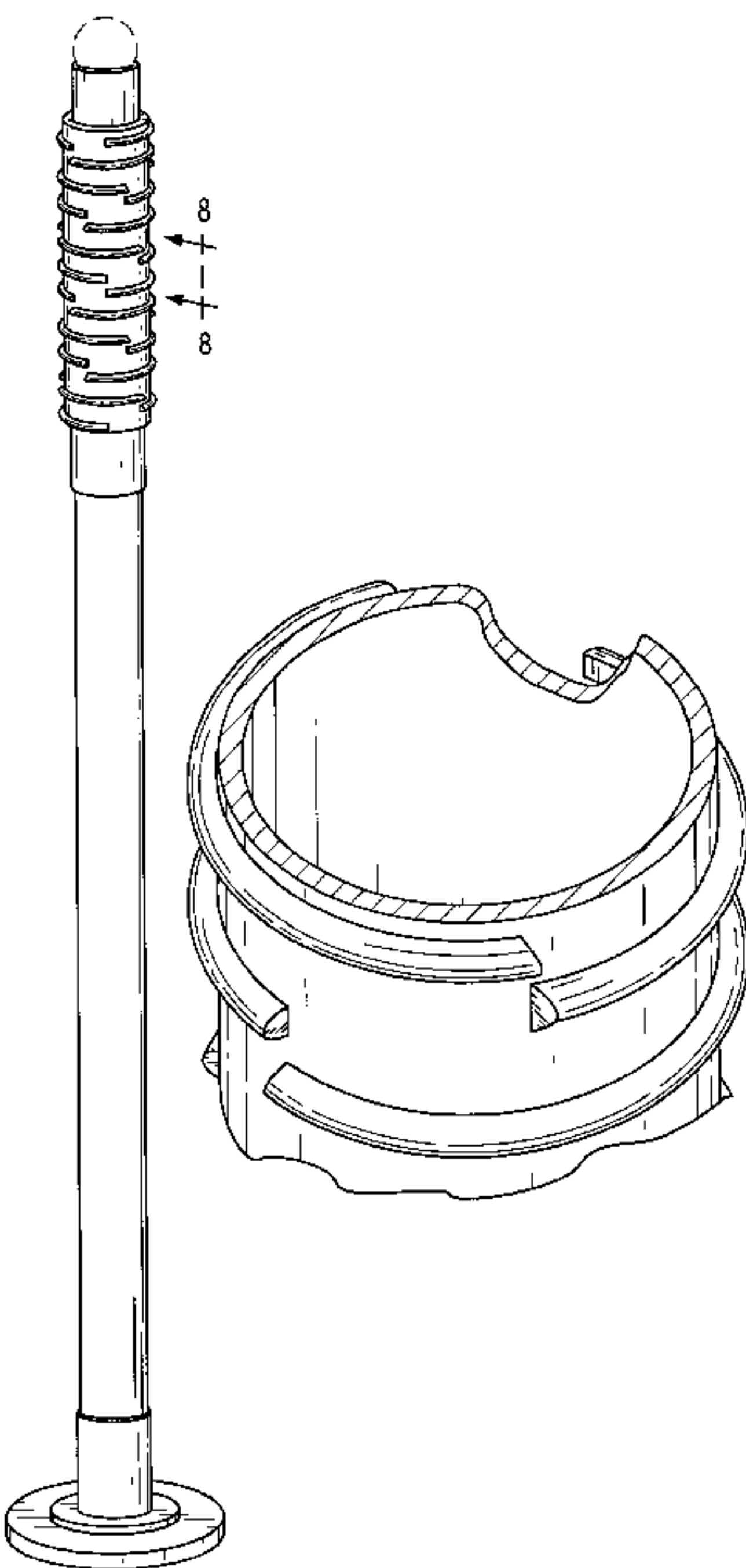
The ornamental design for a musical keyboard, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a musical keyboard showing
one embodiment of my new design;

FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is an enlarged partial sectional view of the musical
keyboard shown in FIG. 1, taken along the line 8—8 of FIG.
1;
FIG. 9 is a perspective view of the musical keyboard
showing a second embodiment of my new design, the keys
on the musical keyboard having a different shape than the
keys in the first embodiment;
FIG. 10 is an enlarged partial sectional view of the musical
keyboard shown in FIG. 9, taken along the line 10—10 of
FIG. 9.
FIG. 11 is a perspective view of a musical keyboard showing
a third embodiment of my new design, the keys being
arranged on the musical keyboard so as to be seen as a mirror
image of the keys in the first embodiment;
FIG. 12 is a front elevational view thereof;
FIG. 13 is a rear elevational view thereof;
FIG. 14 is a right side elevational view thereof;
FIG. 15 is a left side elevational view thereof;
FIG. 16 is a top plan view thereof;
FIG. 17 is a bottom plan view thereof; and,
FIG. 18 is an enlarged partial sectional view of the musical
keyboard shown in FIG. 11, taken along the line 18—18 of
FIG. 11.
The portions of the musical keyboard shown in phantom are
for illustration purposes only and form no part of the claimed
invention.
The musical keyboard is intended to be used as part of an
electronic musical instrument or system.

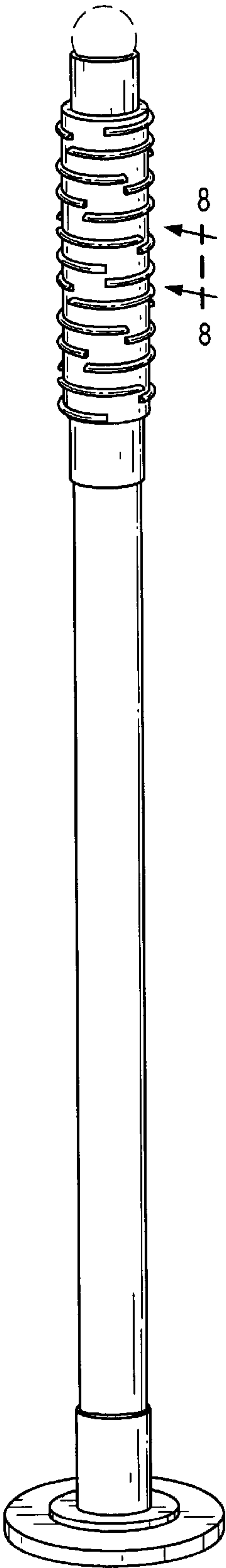

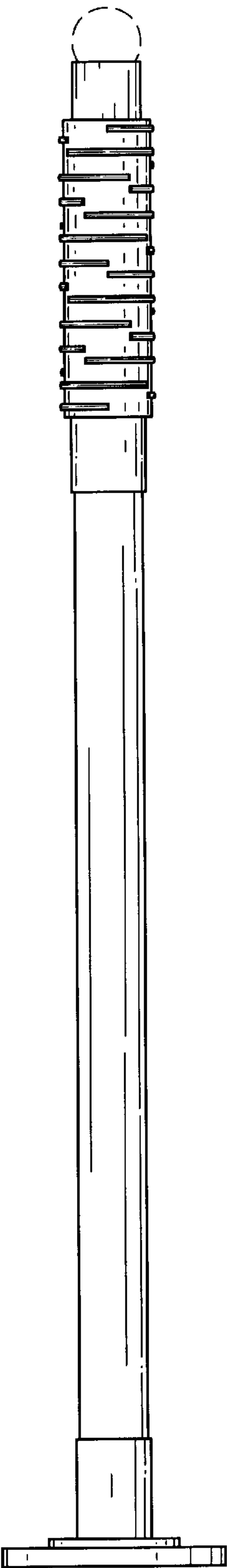

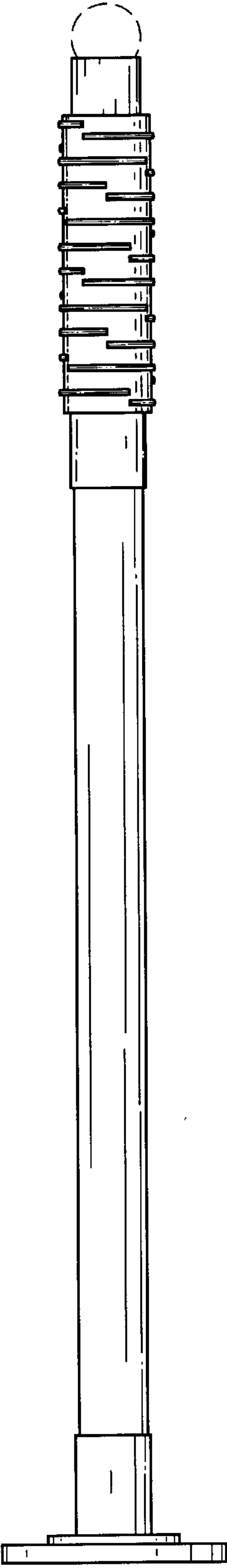

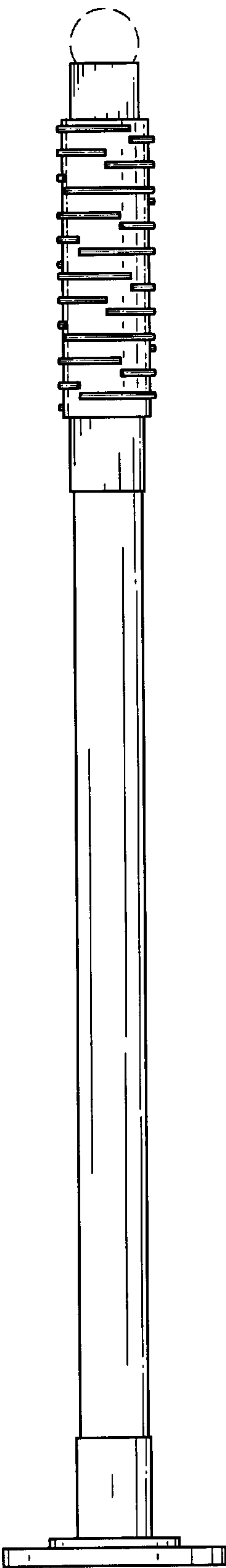

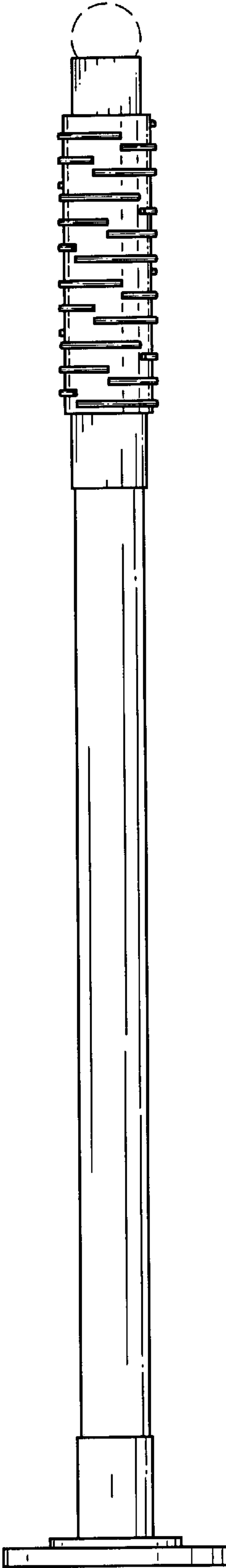

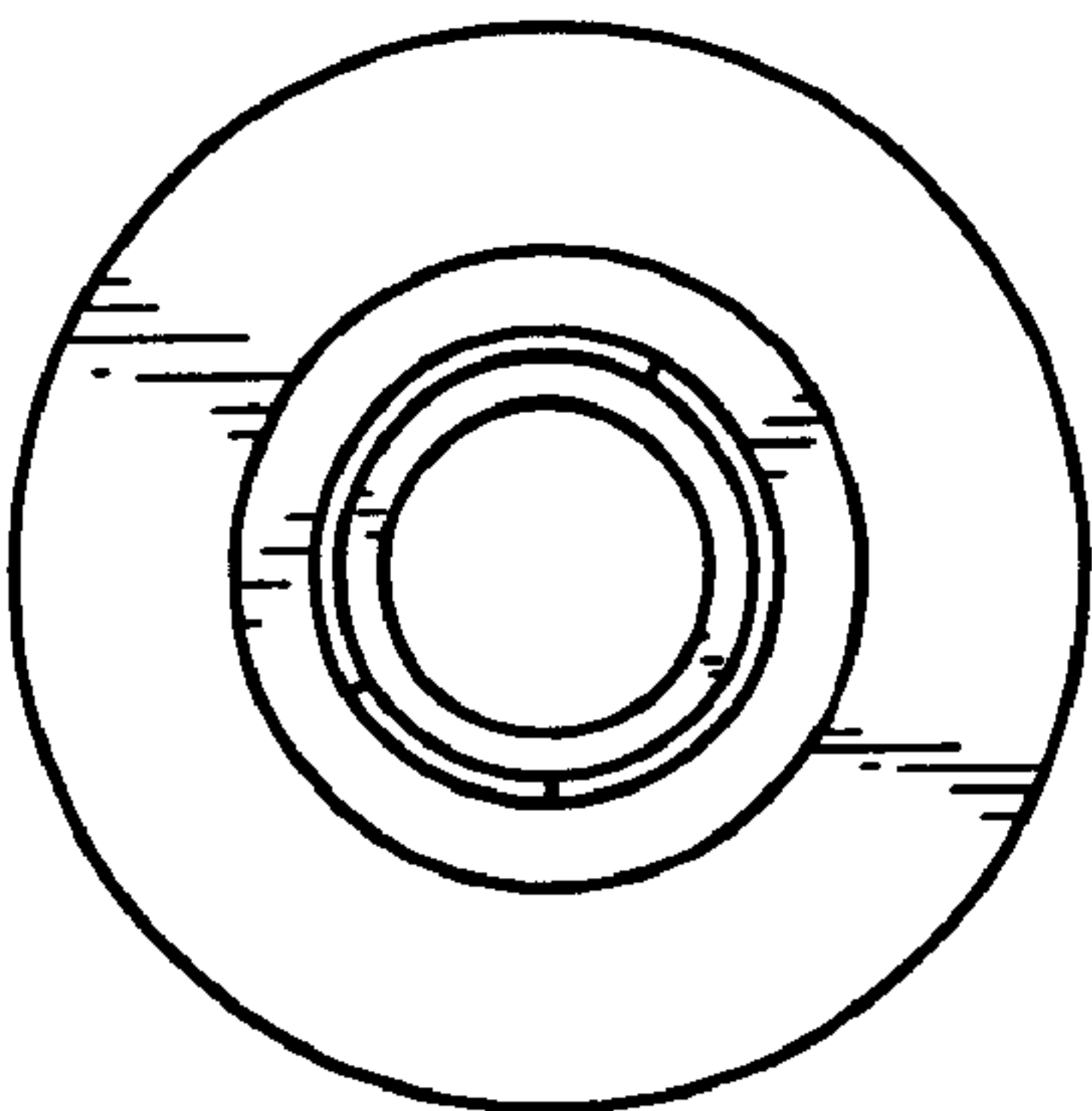

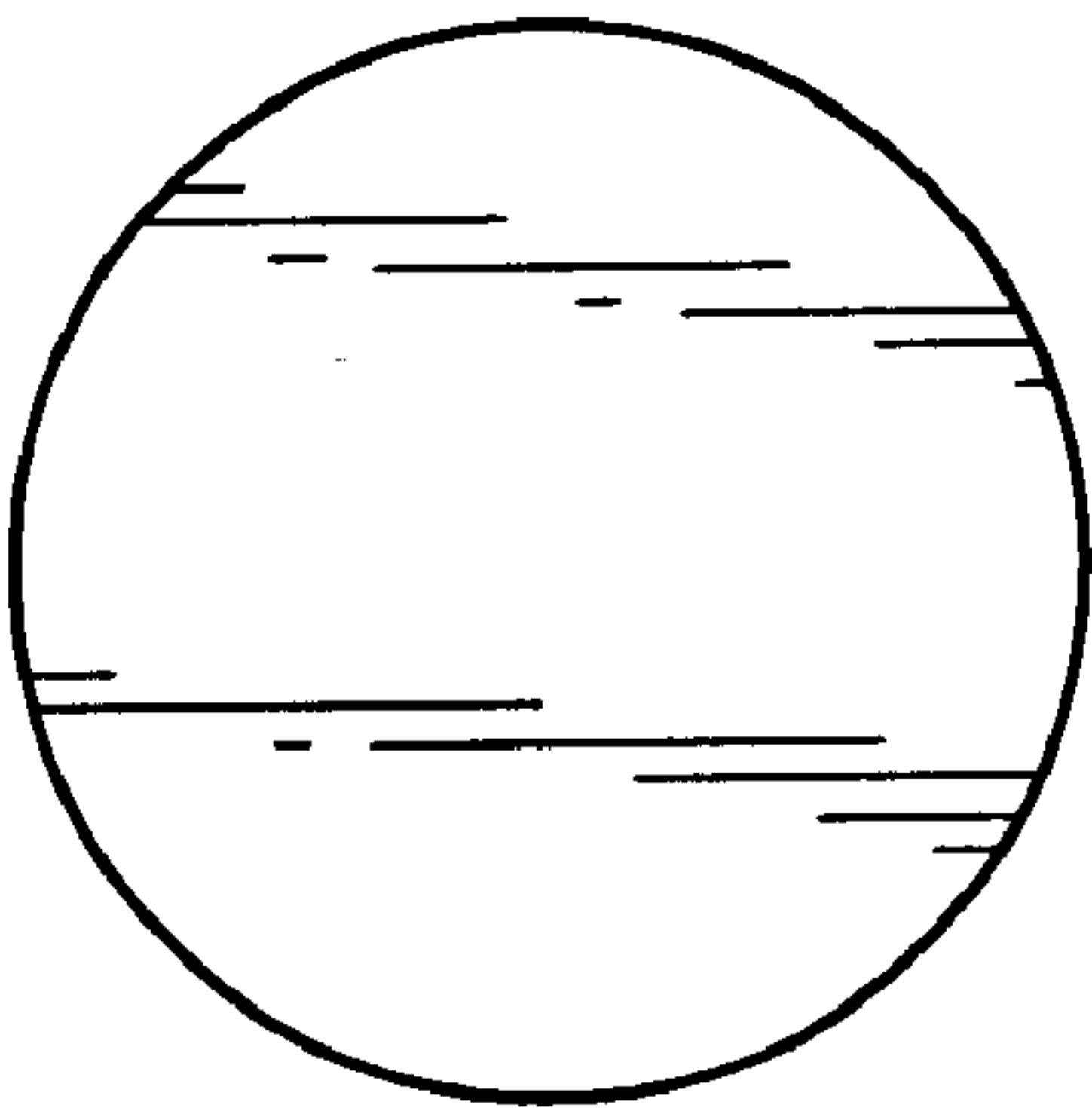

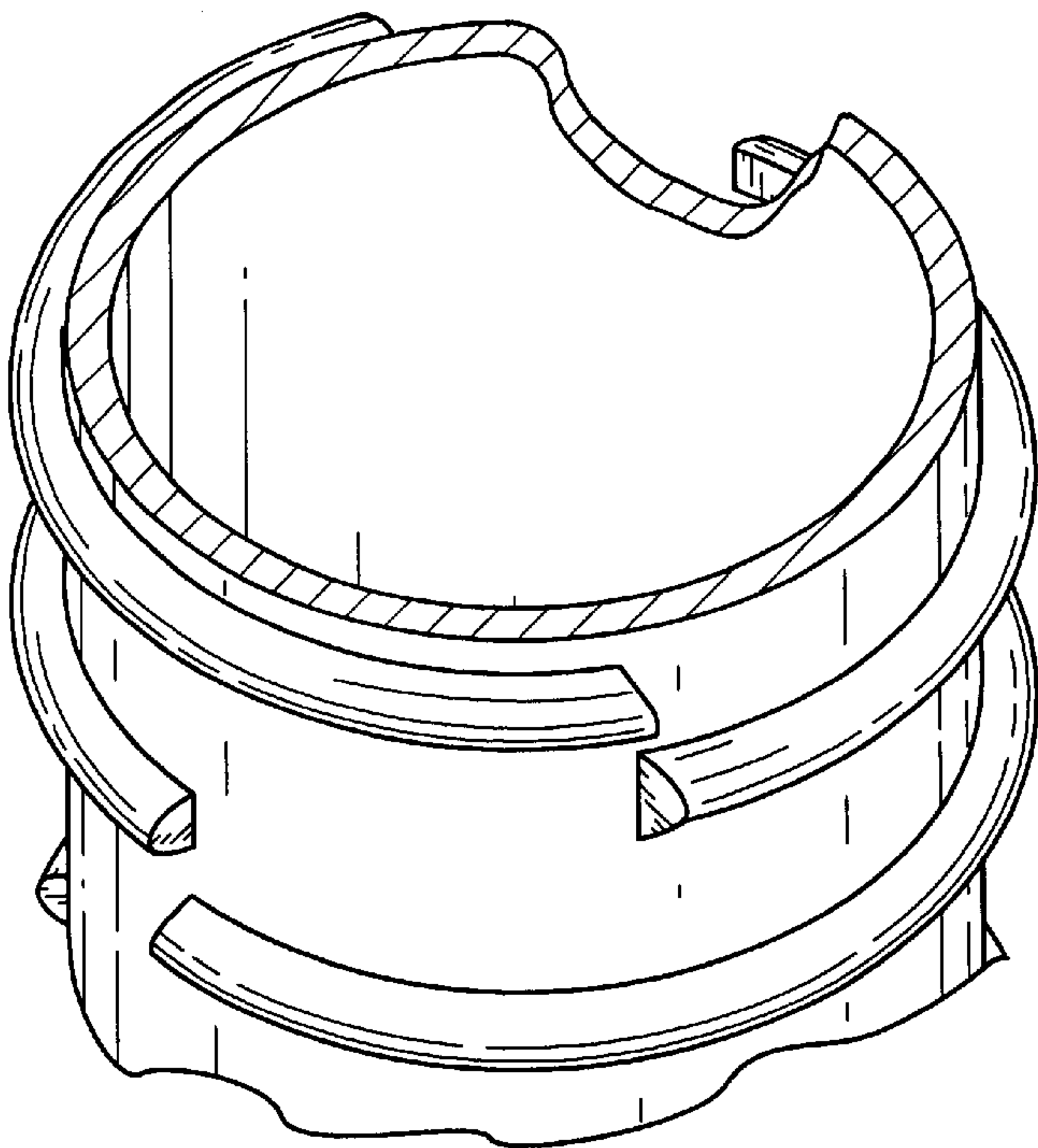

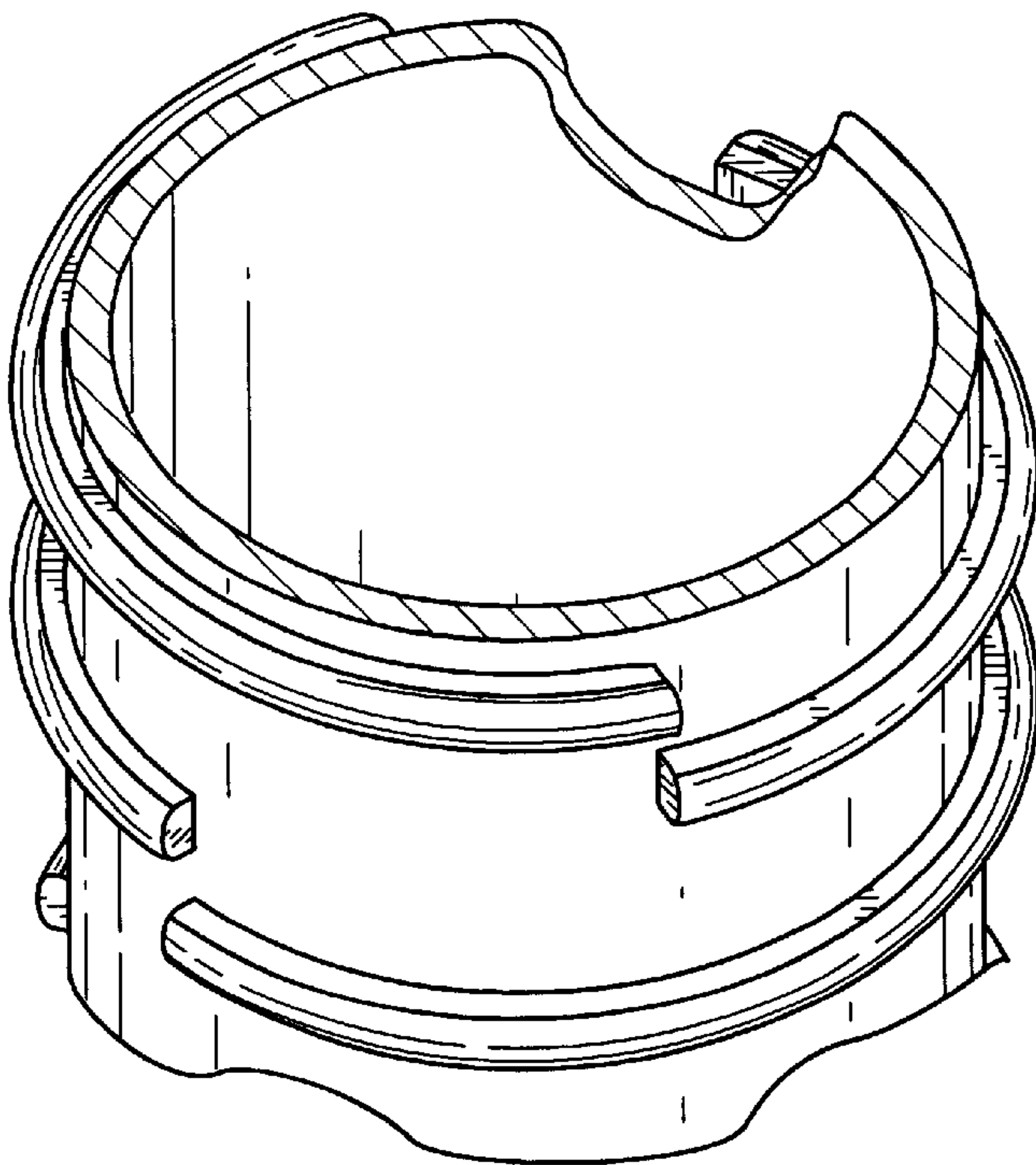

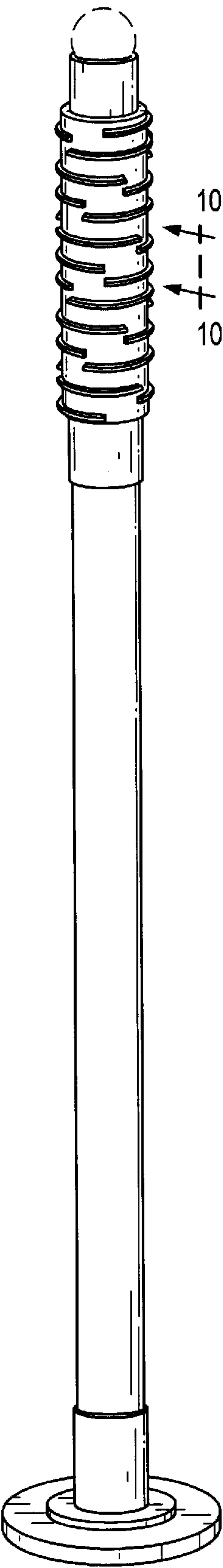

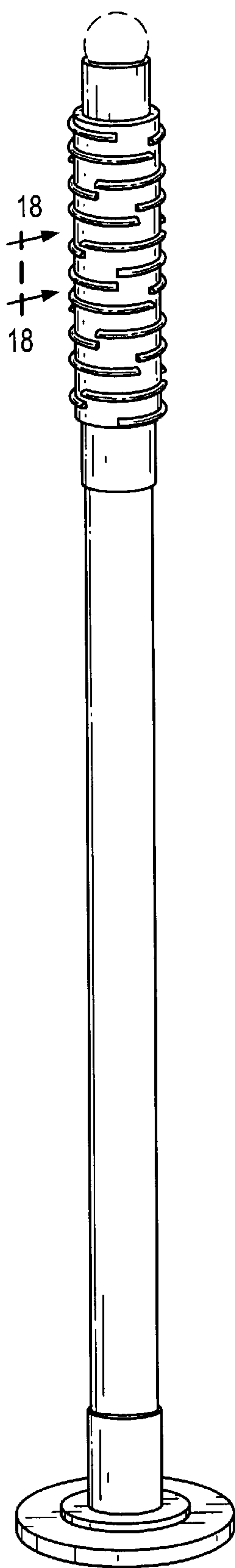

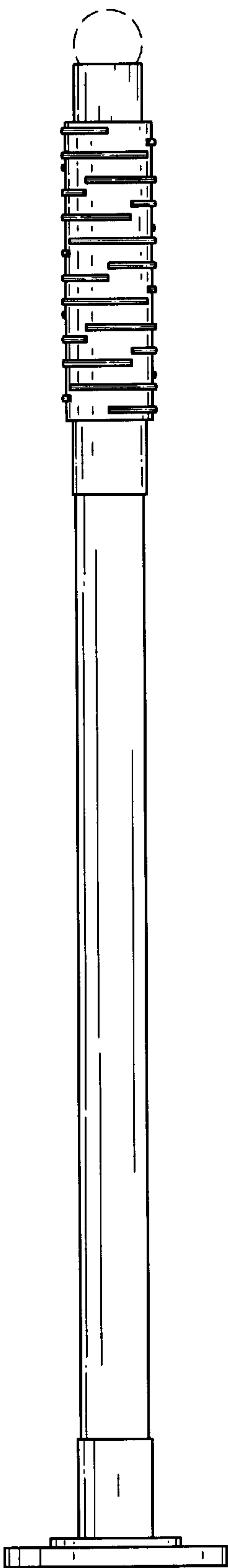

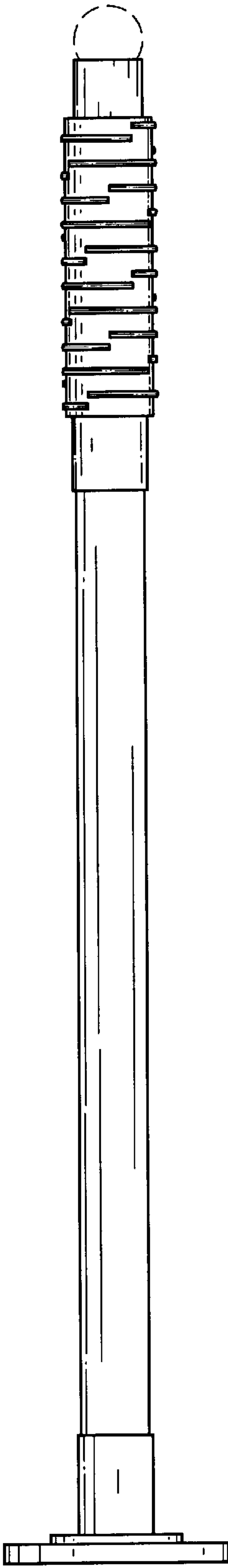

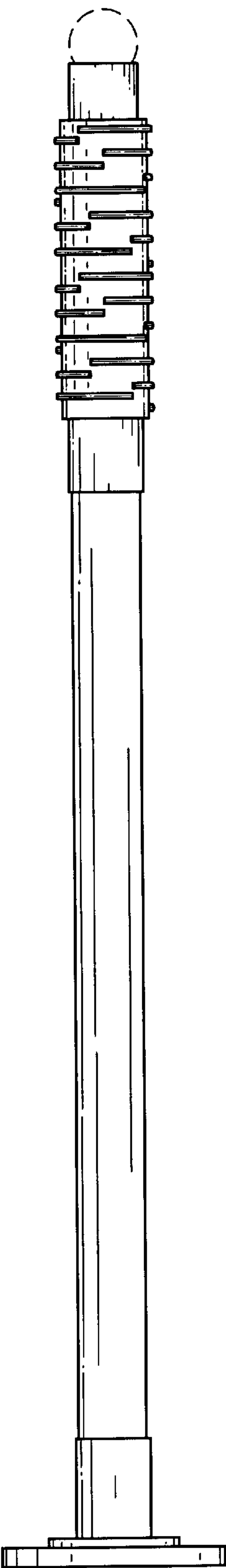

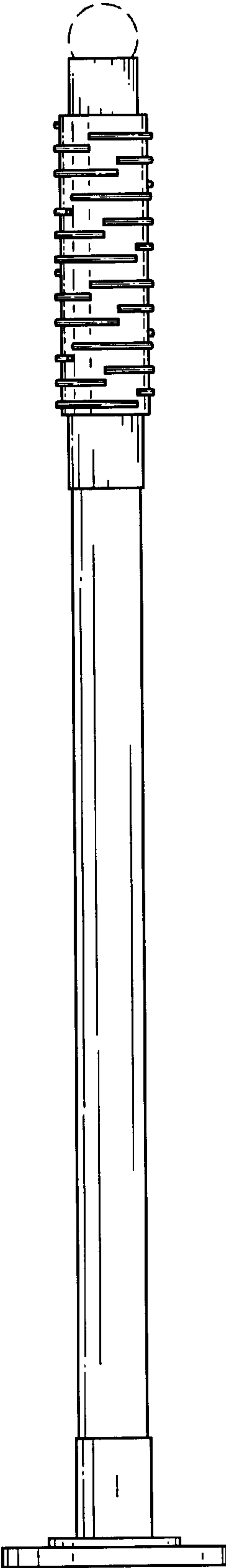

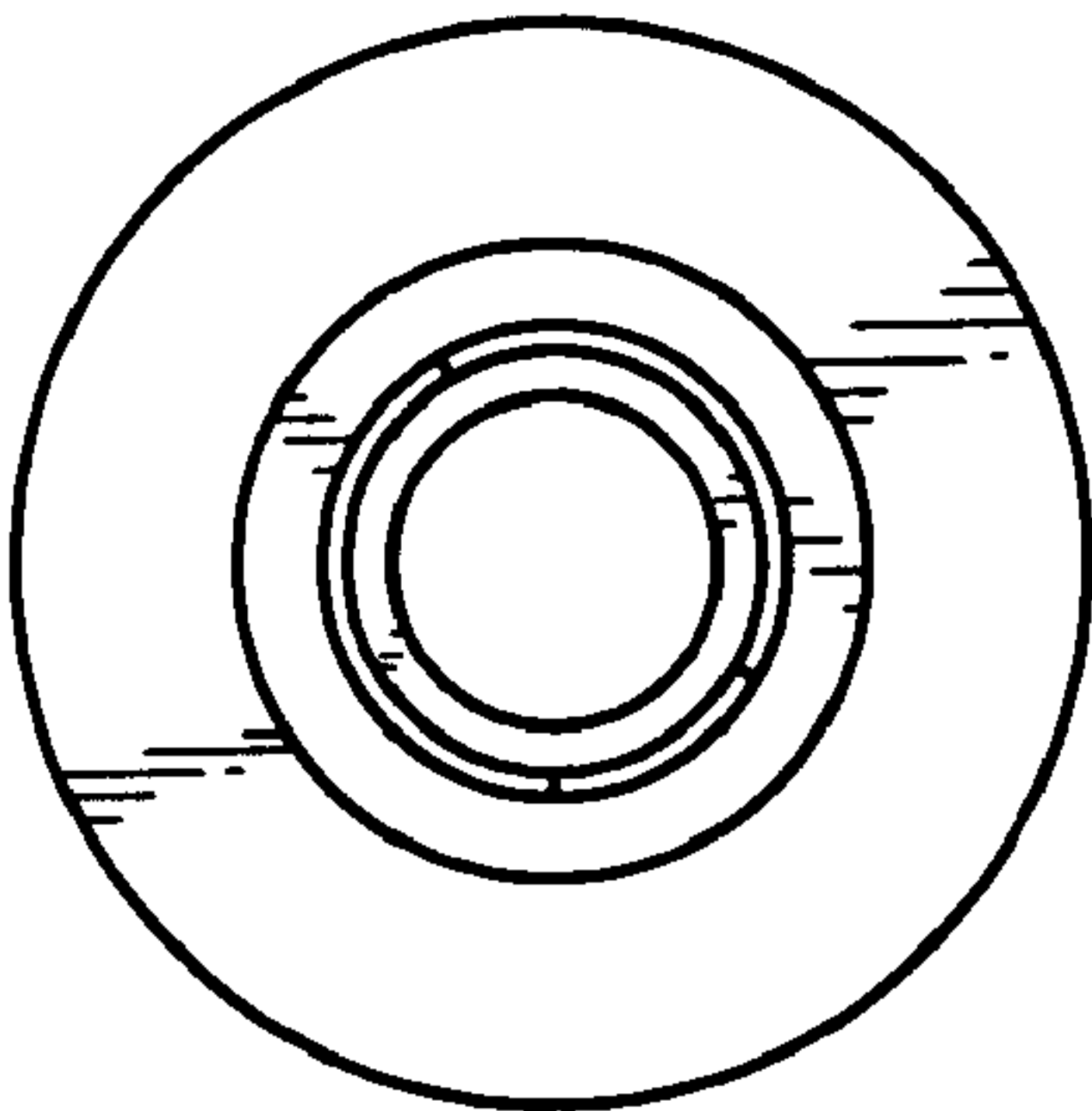

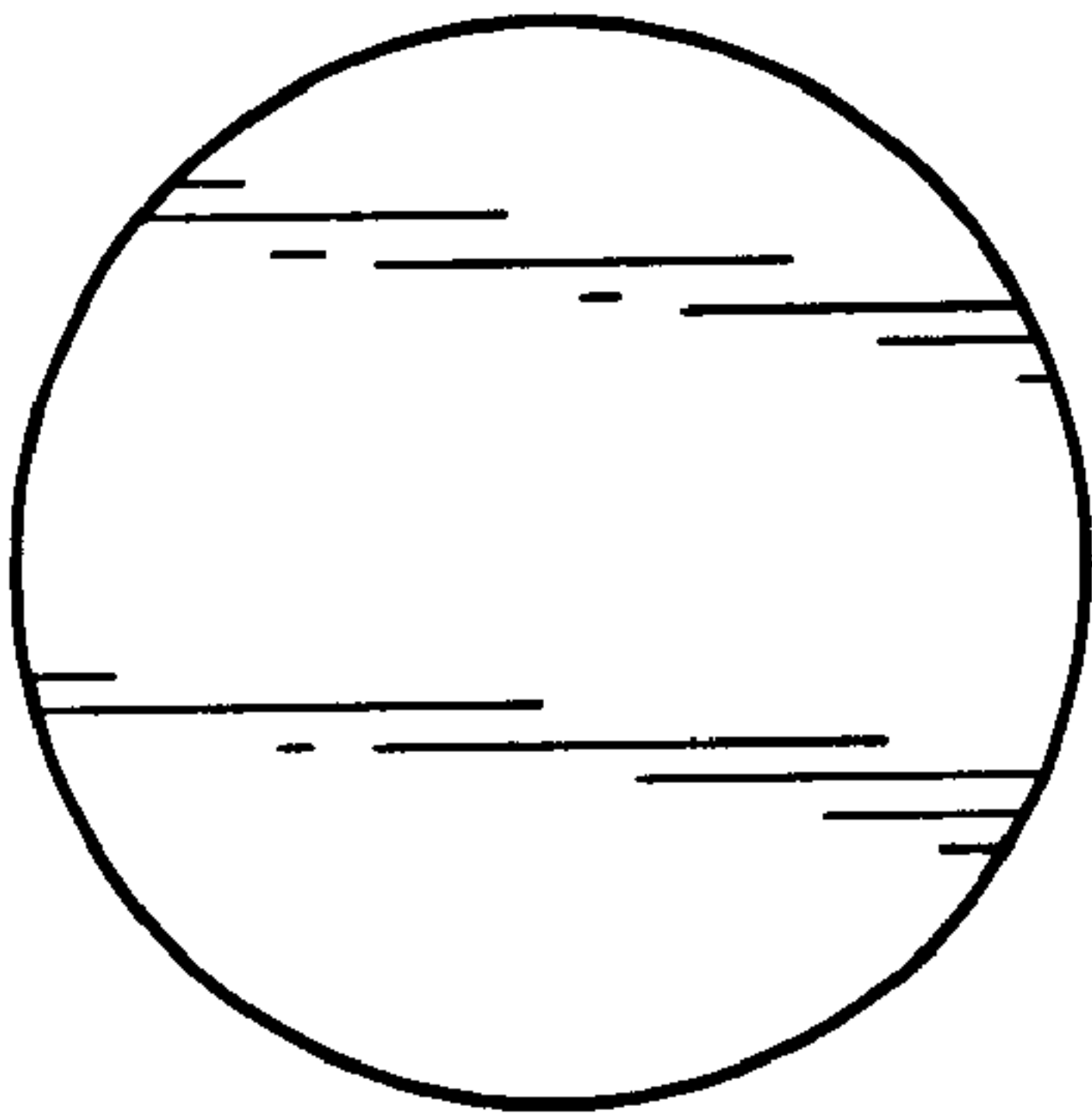

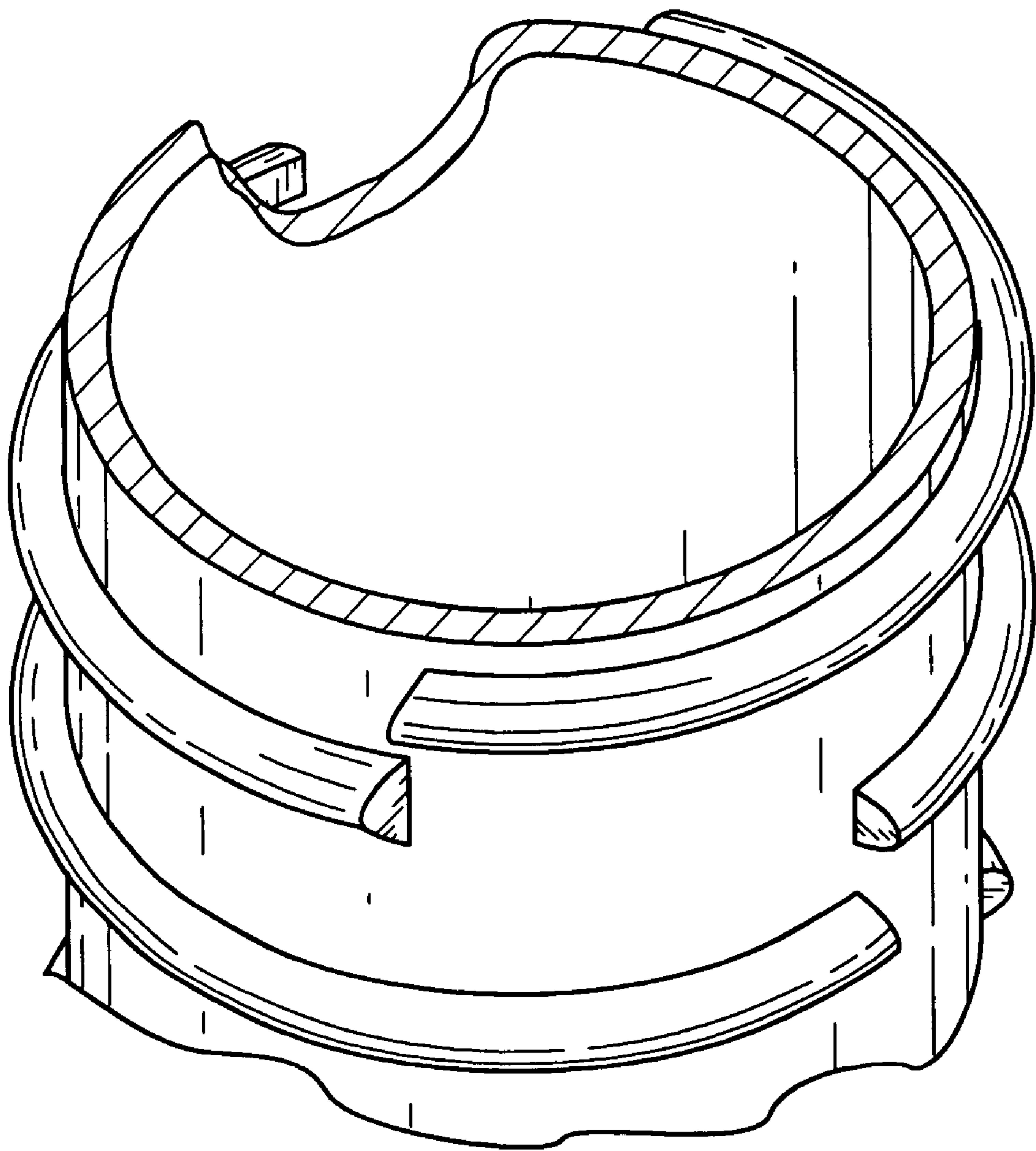
