(57) **CLAIM**

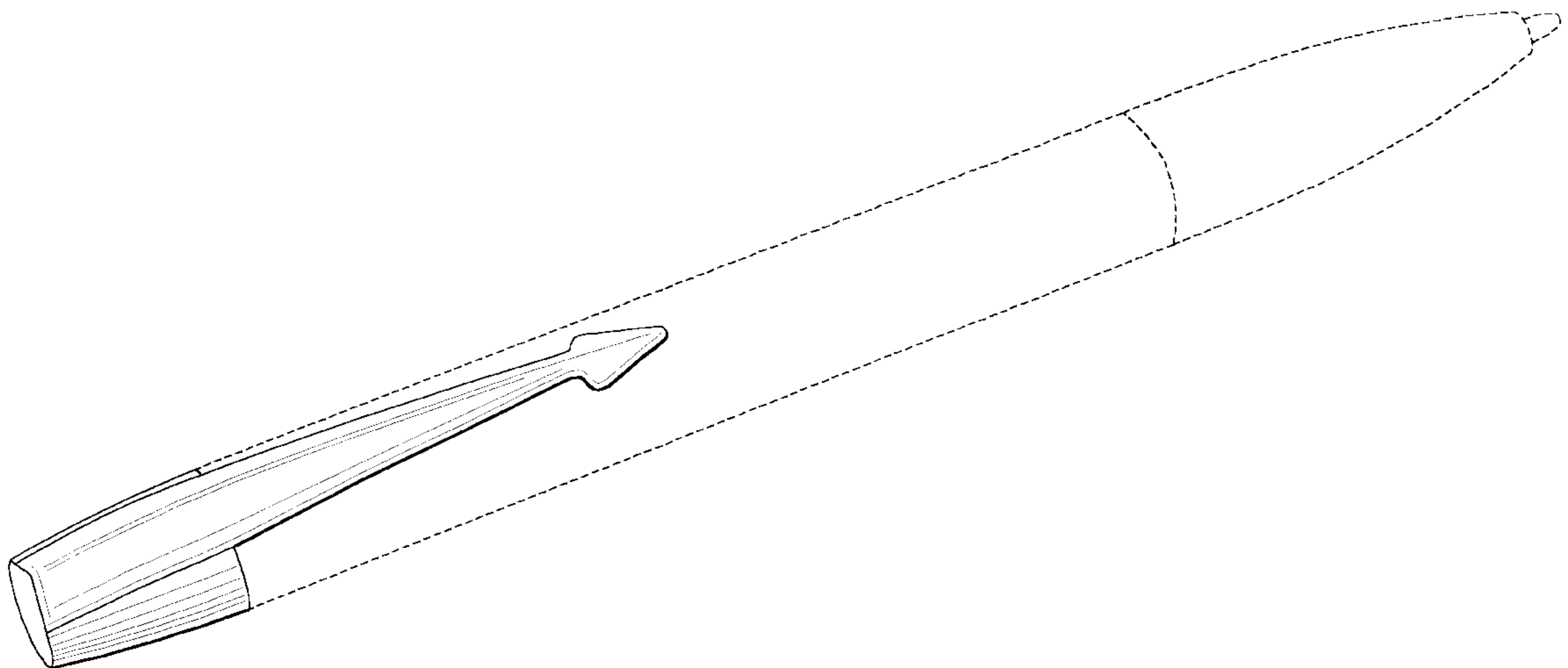
The ornamental design for a “clip and shroud for a writing instrument”, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view taken from the front and above showing our new design;
FIG. 2 is a left side elevational view, the right side elevational view being a mirror image thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a plan view.

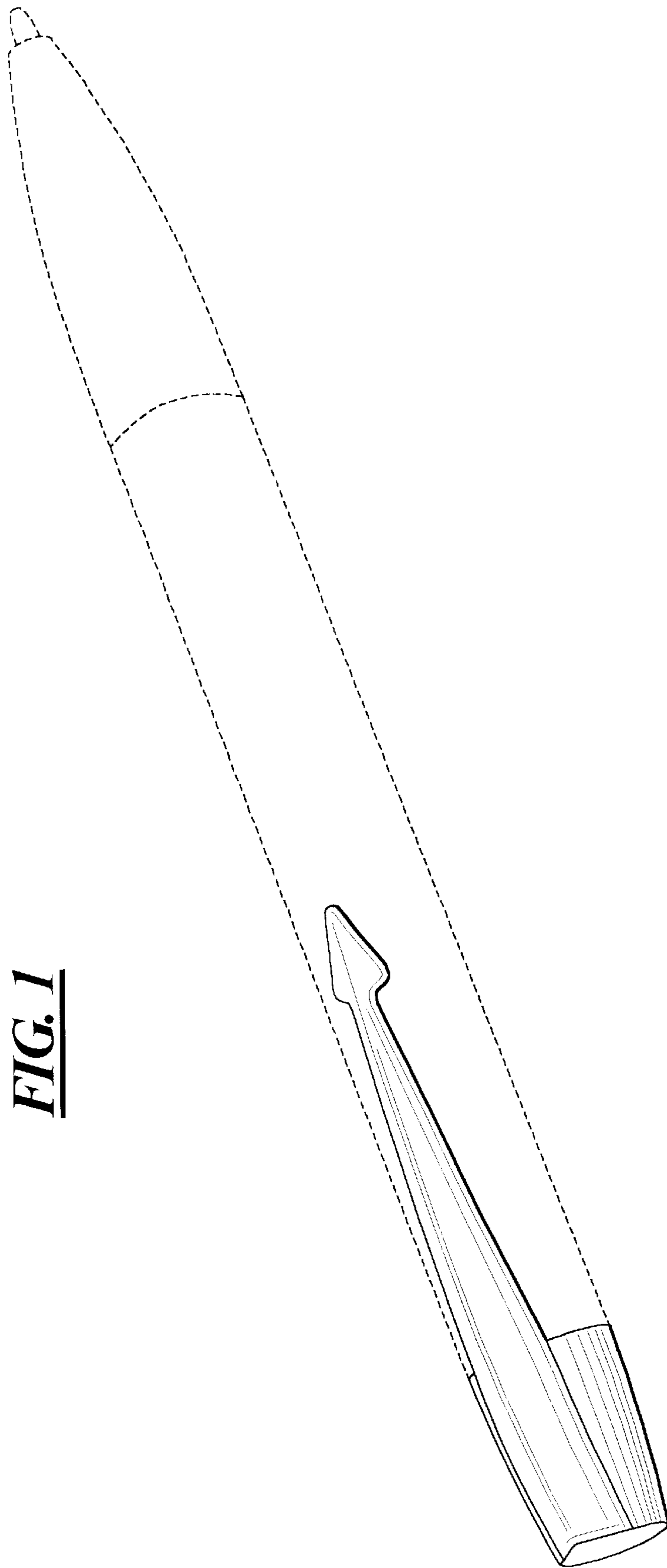
