(57) **CLAIM**

The ornamental design for radial seal filter element with press-on fin structure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottom, side and front of a first embodiment of the radial seal filter element with press-on fin structure; the filter element having a closed end cap;

FIG. 2 is a front elevation view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 3 is a rear elevation view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 4 is a right side elevation view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 5 is a left side elevation view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 6 is a top plan view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 7 is a bottom plan view of the first embodiment of the radial seal filter element with press-on fin structure;

FIG. 8 is a perspective view of the bottom, side and front of a second embodiment of a radial seal filter element with press-on fin structure, the second embodiment having a closed end cap similar to the first embodiment, with various features illustrated in phantom;

FIG. 9 is a front elevation view of the second embodiment of the radial seal filter element with press-on fin structure;

FIG. 10 is a rear elevation view of the second embodiment of the radial seal filter element with press-on fin structure;

FIG. 11 is a right side elevation view of the second embodiment of the radial seal filter element with press-on fin structure;

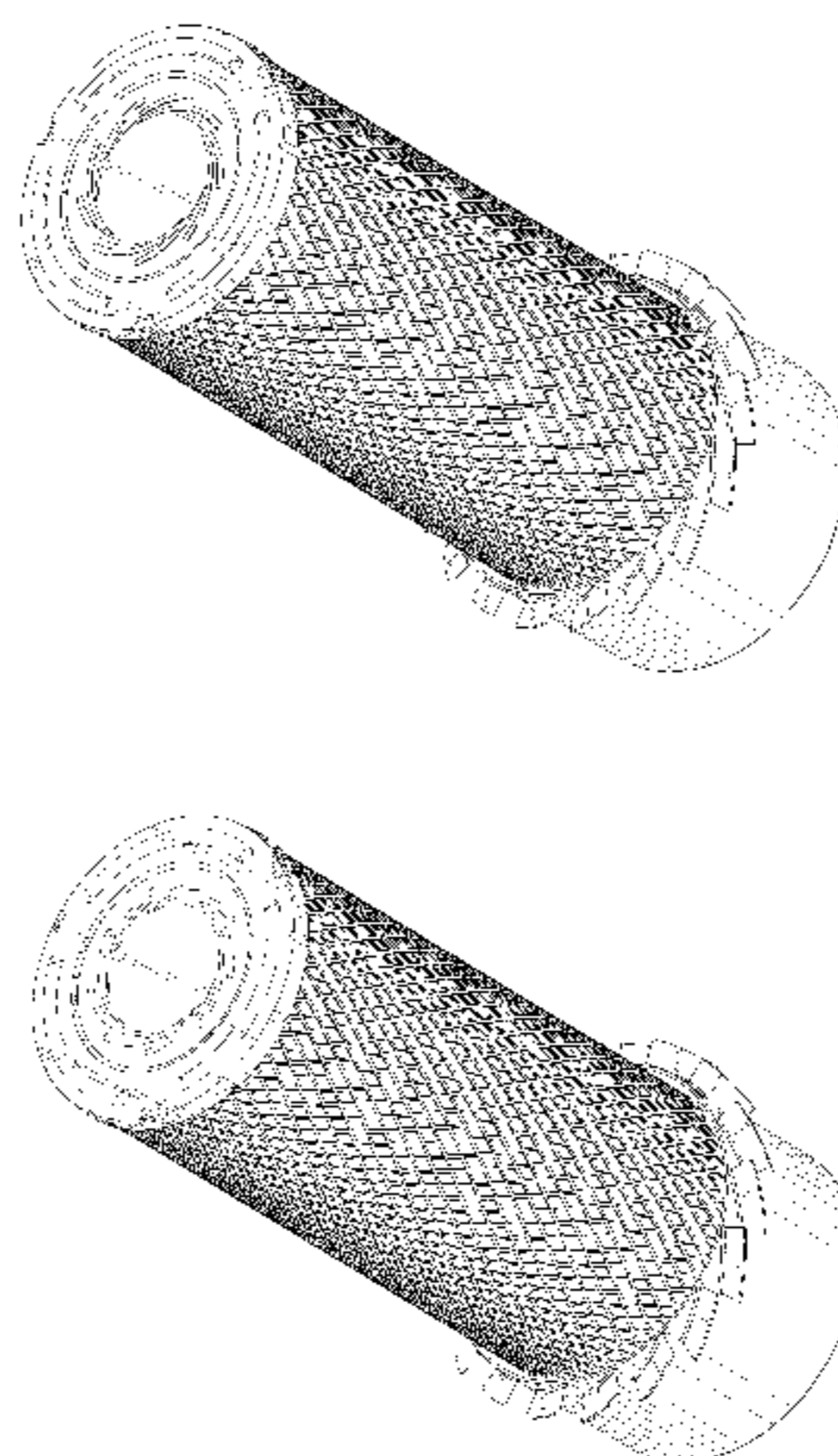
FIG. 12 is a left side elevation view of the second embodiment of the radial seal filter element with press-on fin structure;

FIG. 13 is a top plan view of the second embodiment of the radial seal filter element with press-on fin structure; and,

FIG. 14 is a bottom plan view of the second embodiment of the radial seal filter element with press-on fin structure.

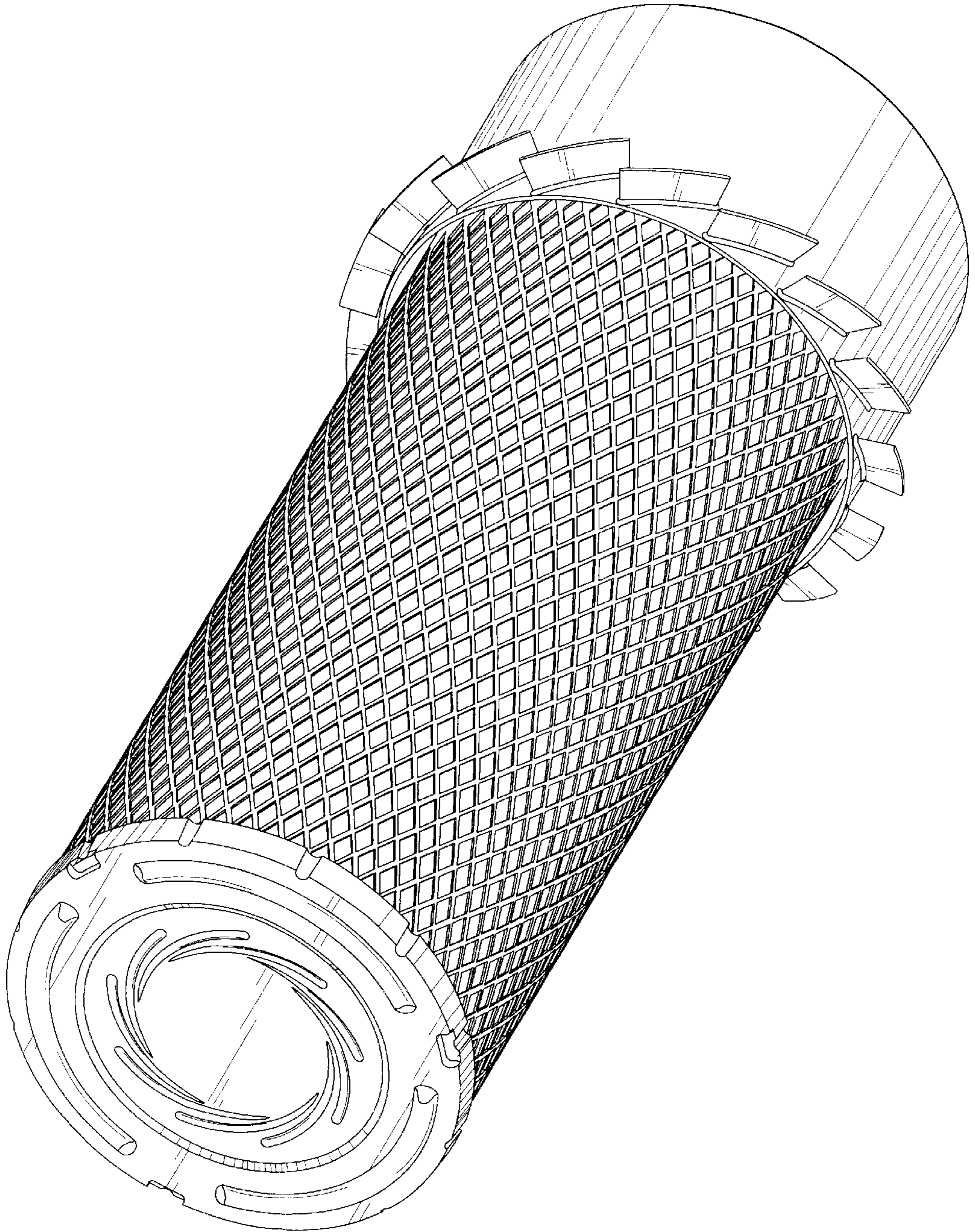

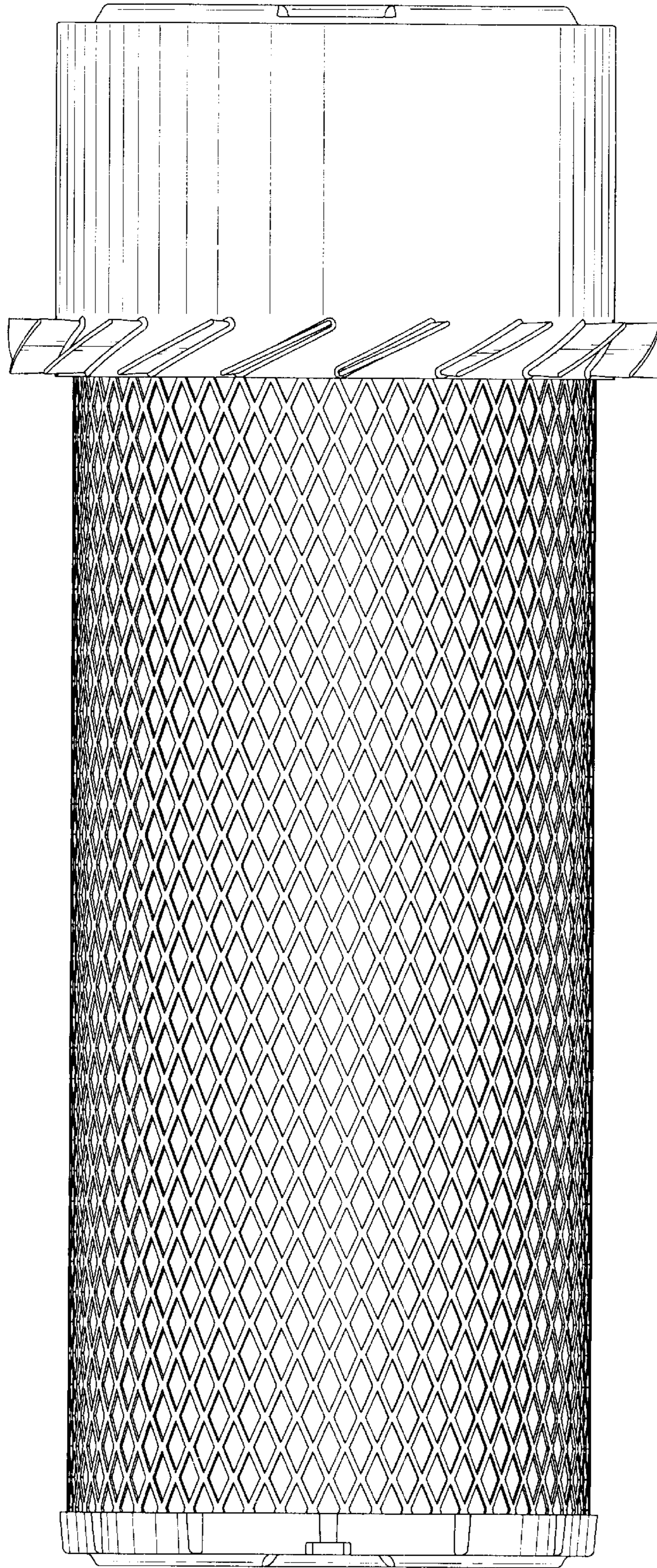

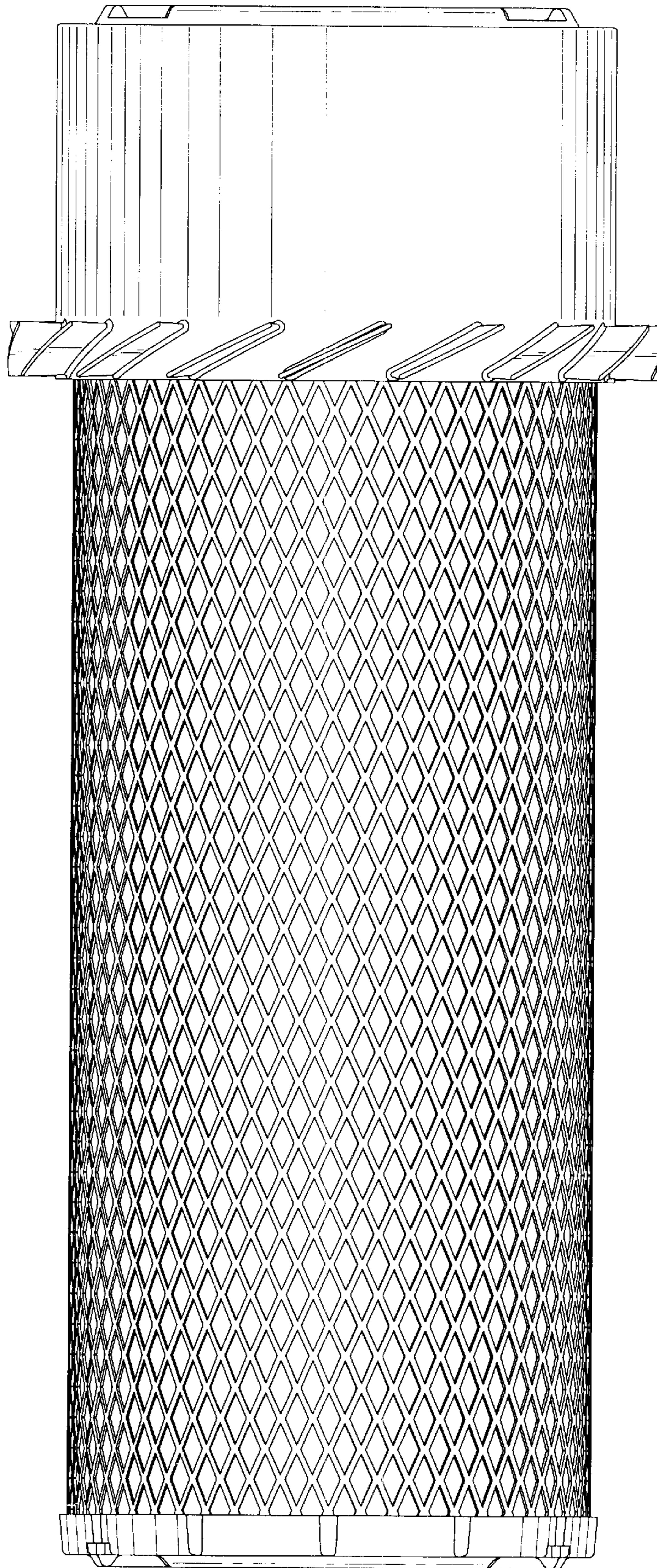

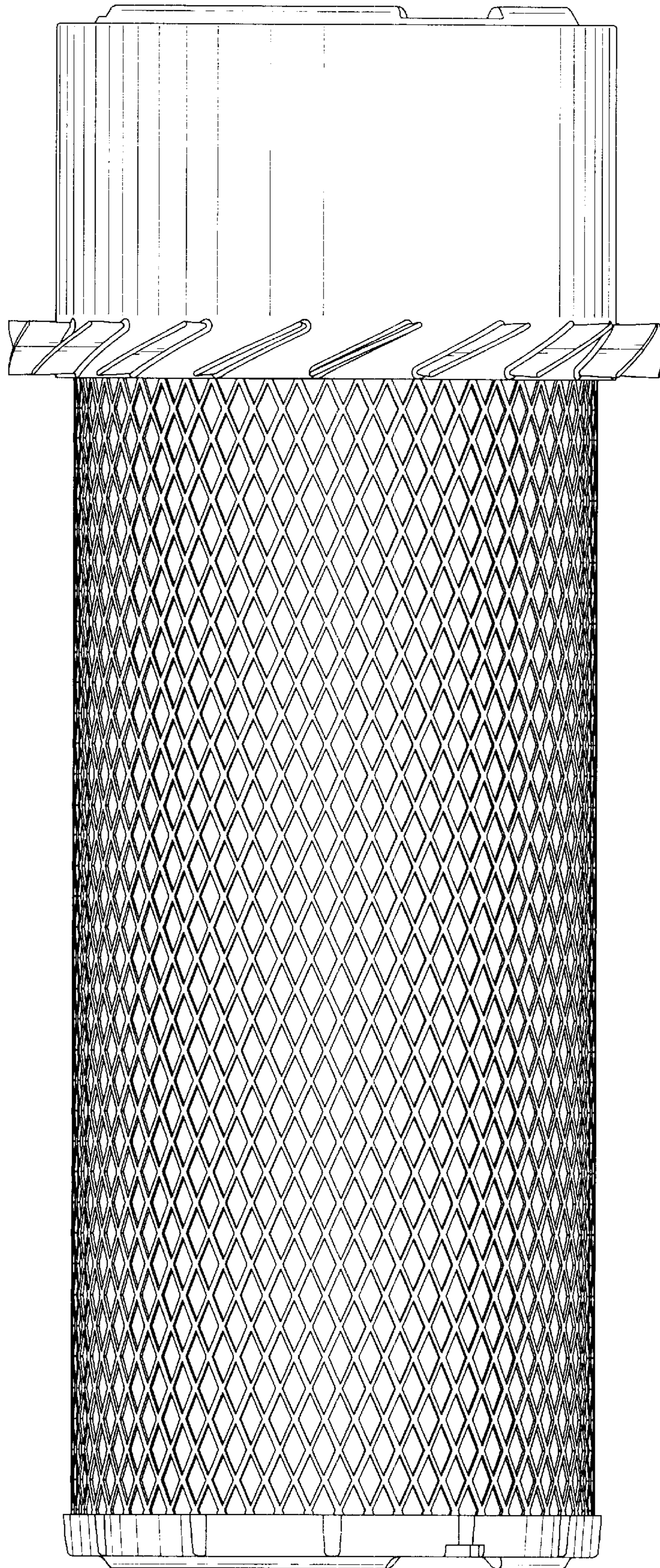

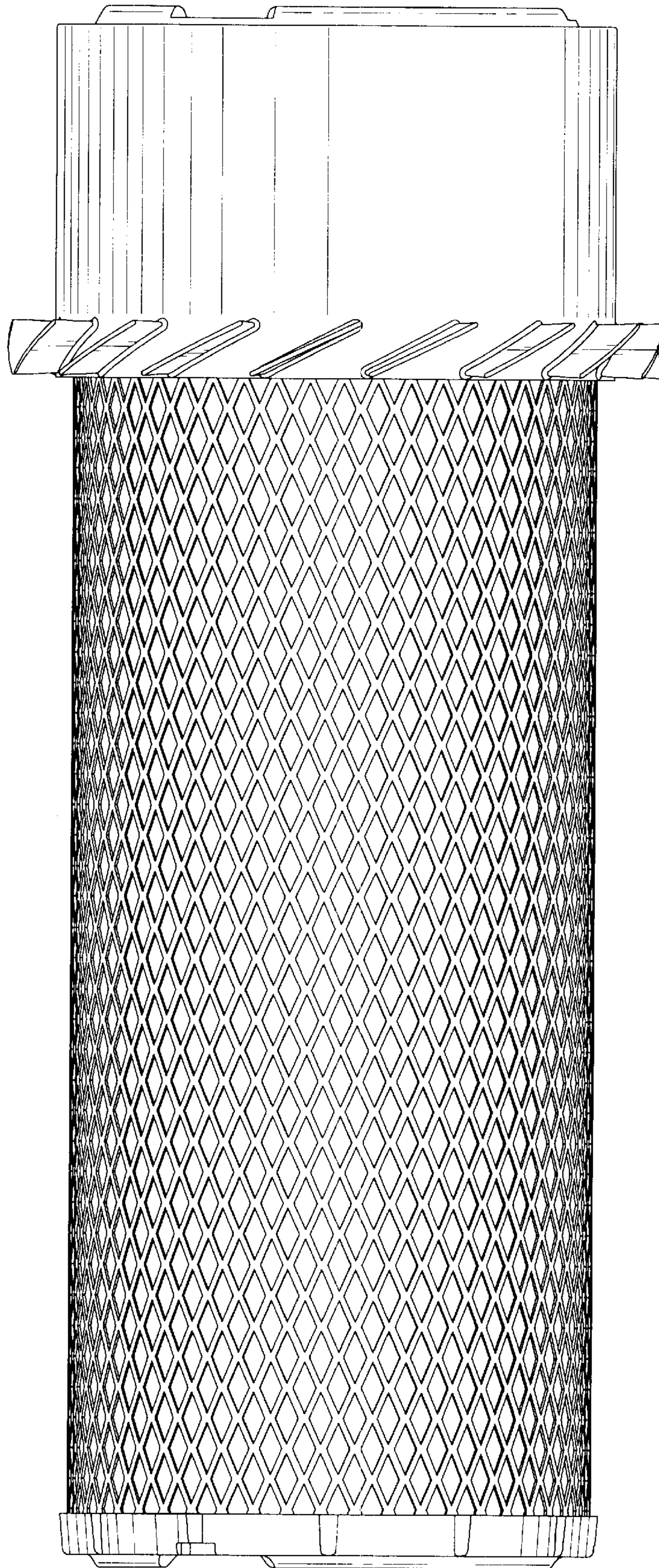

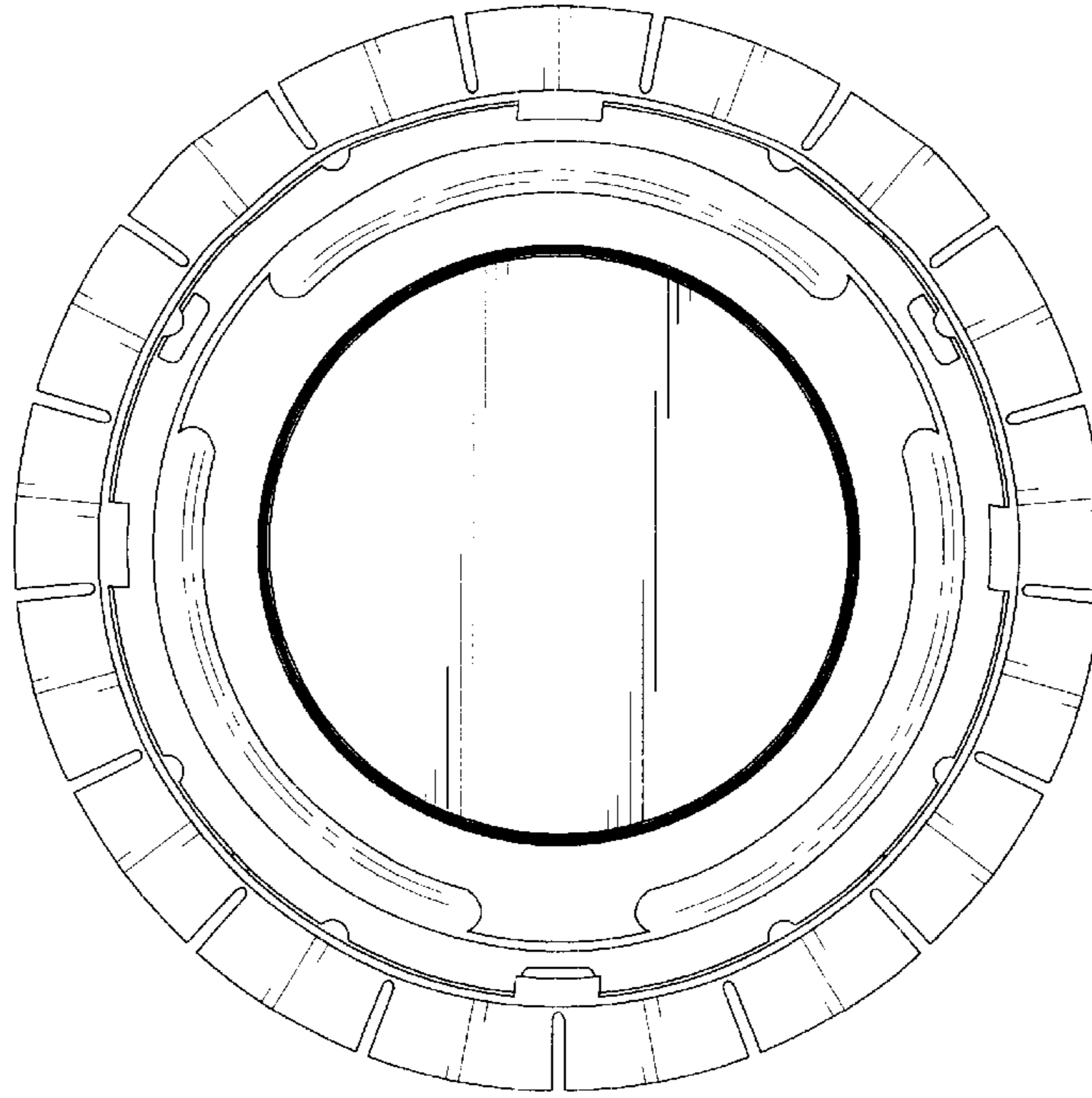
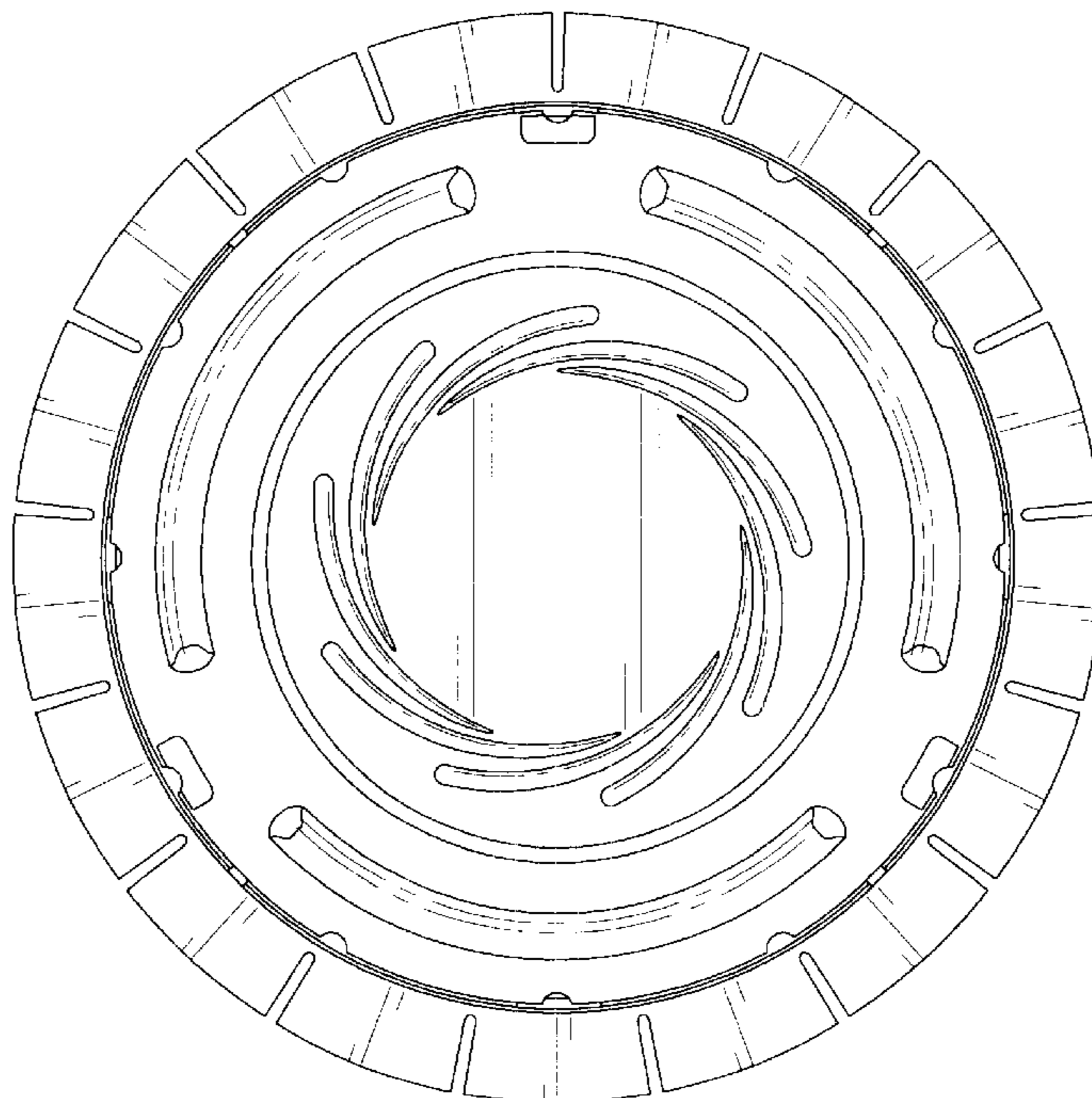

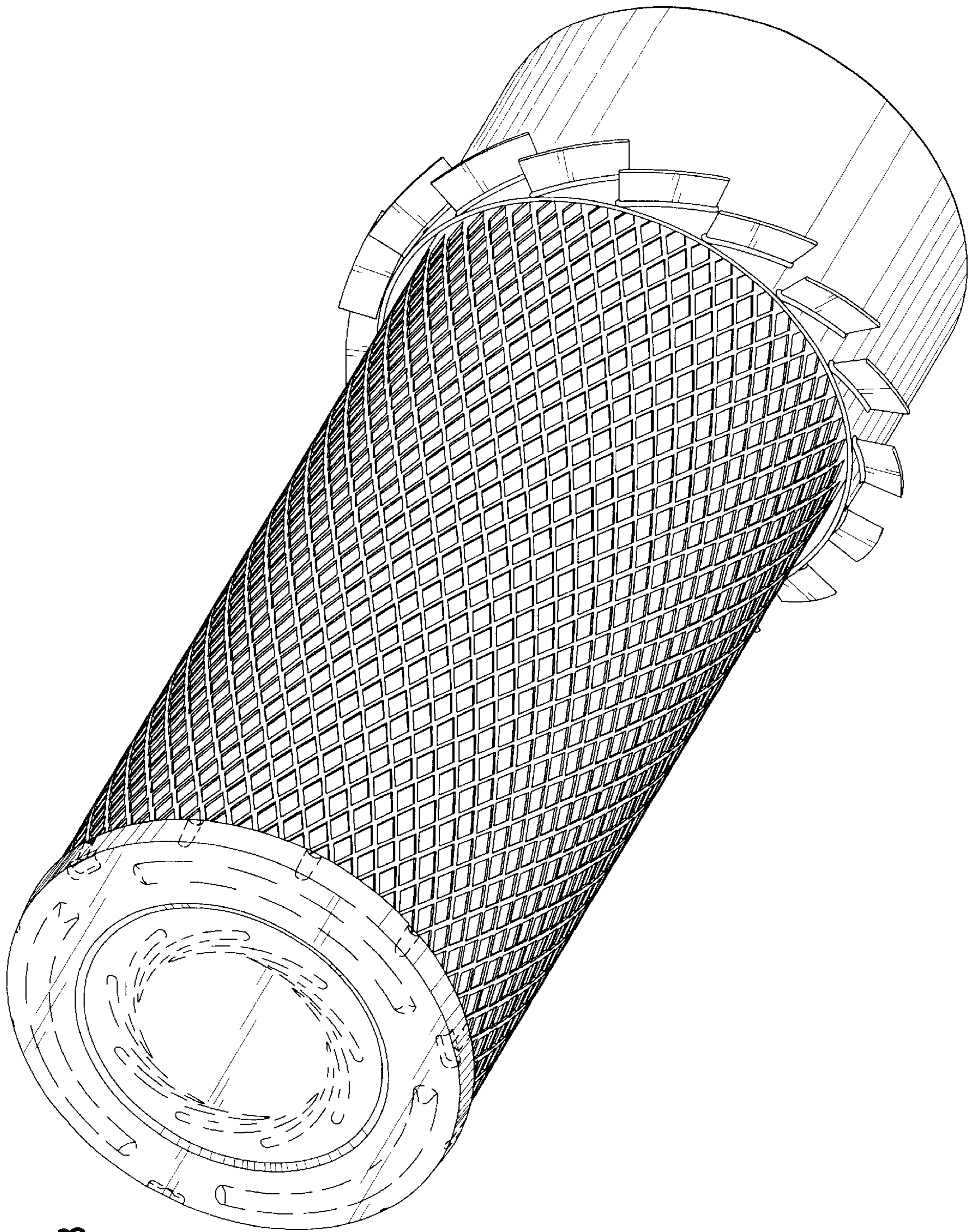

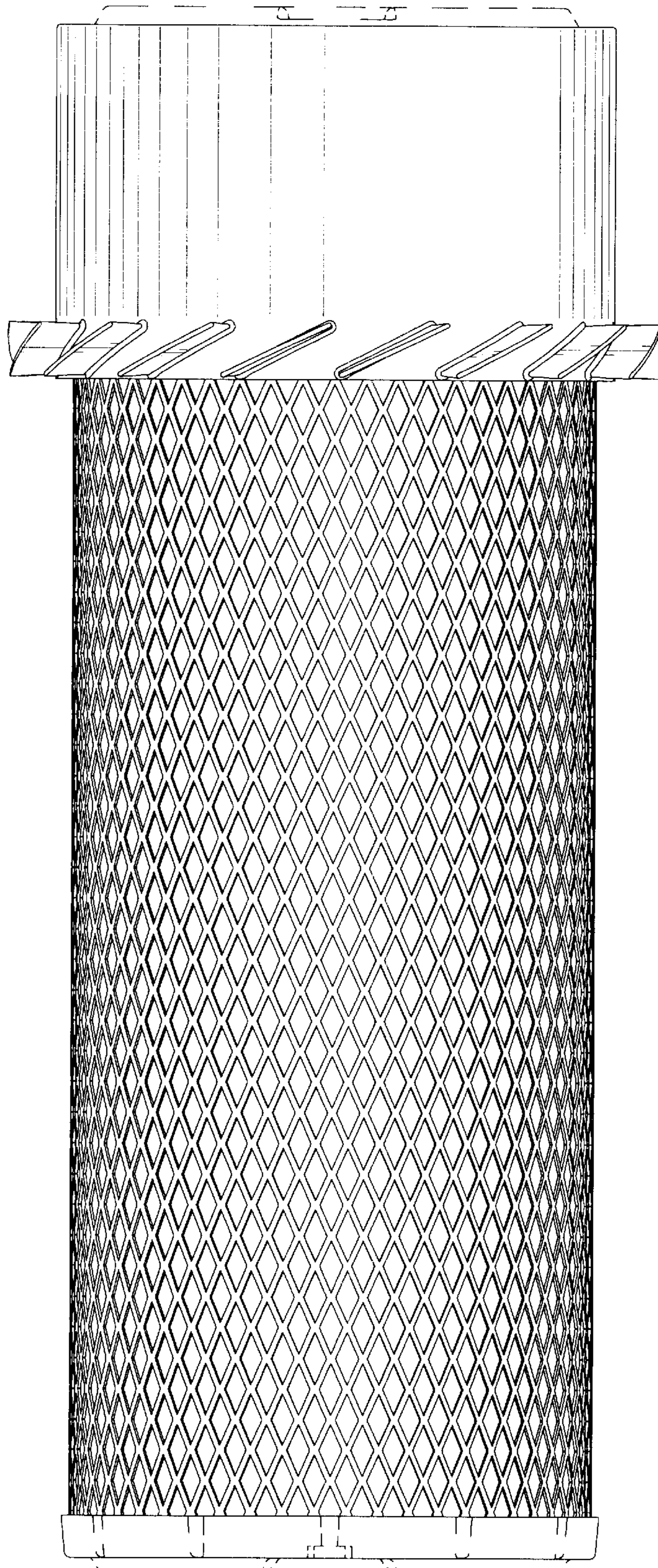

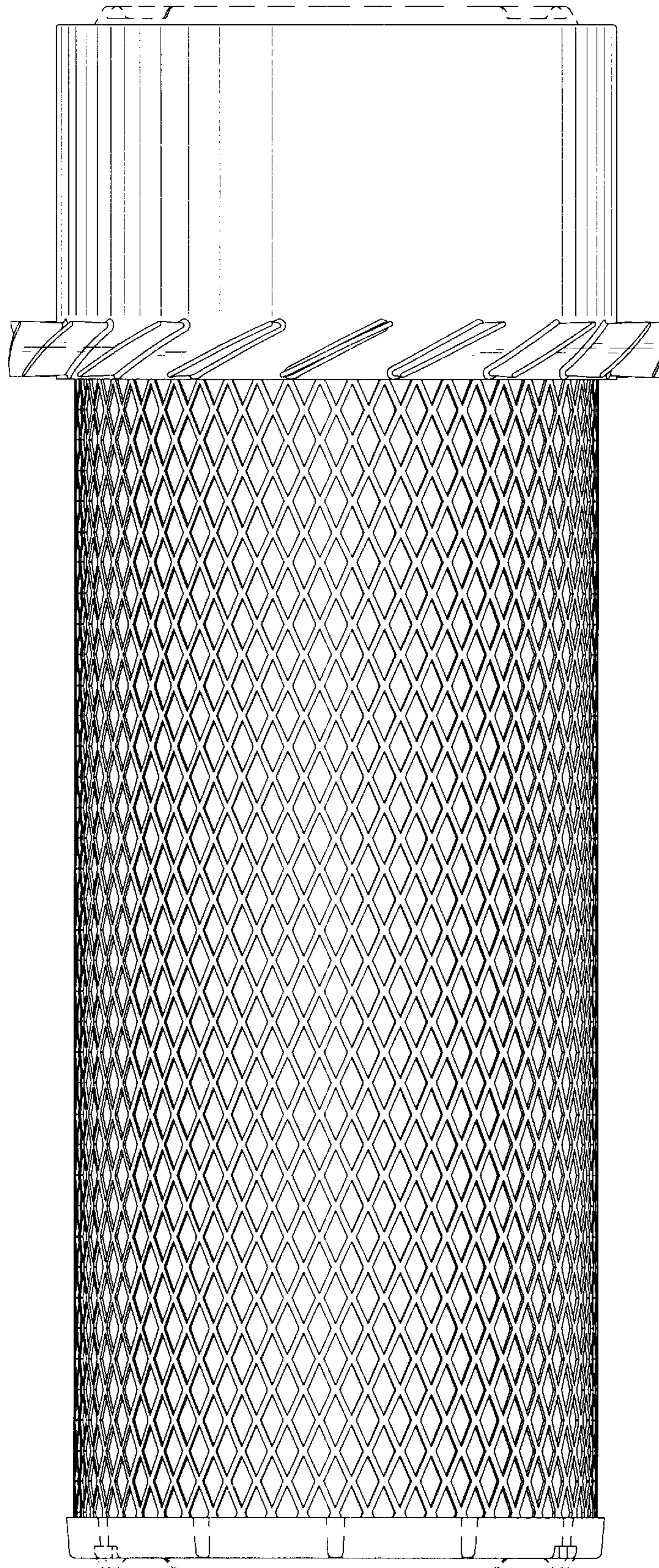

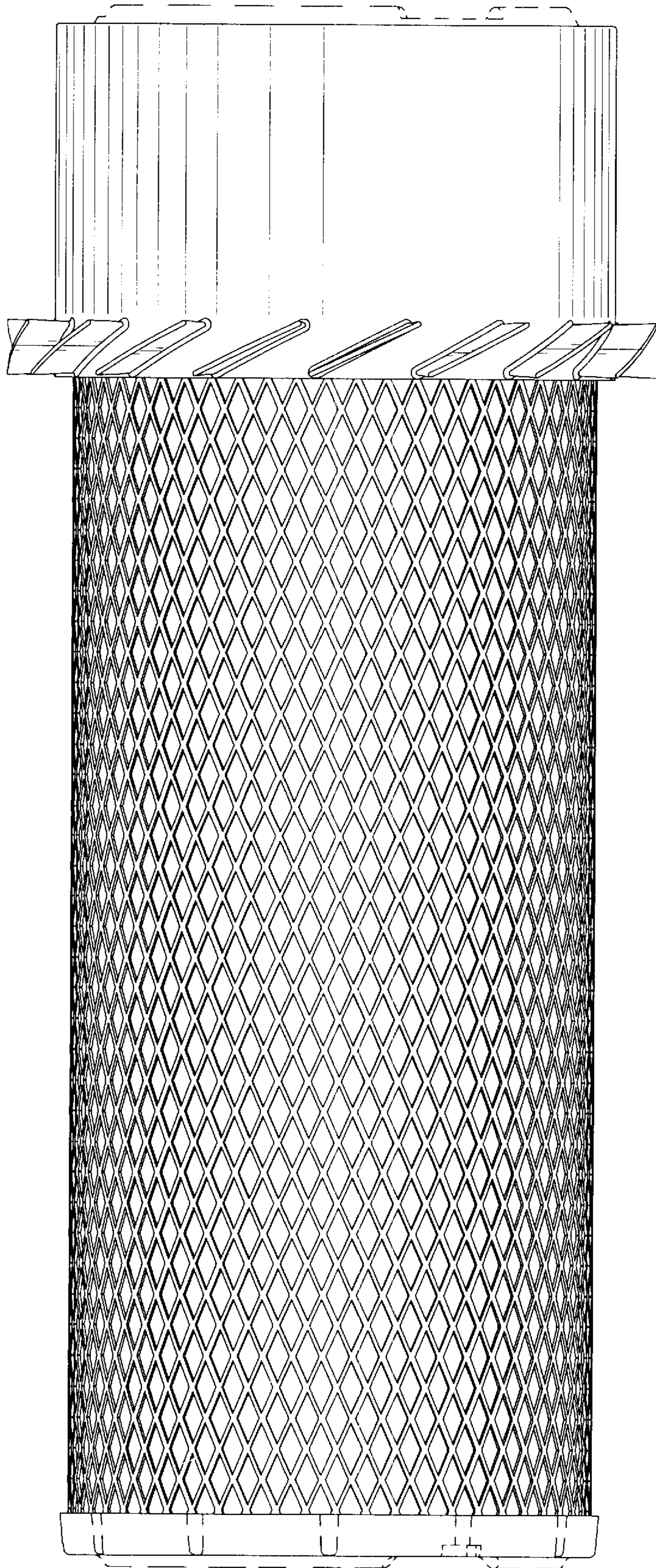

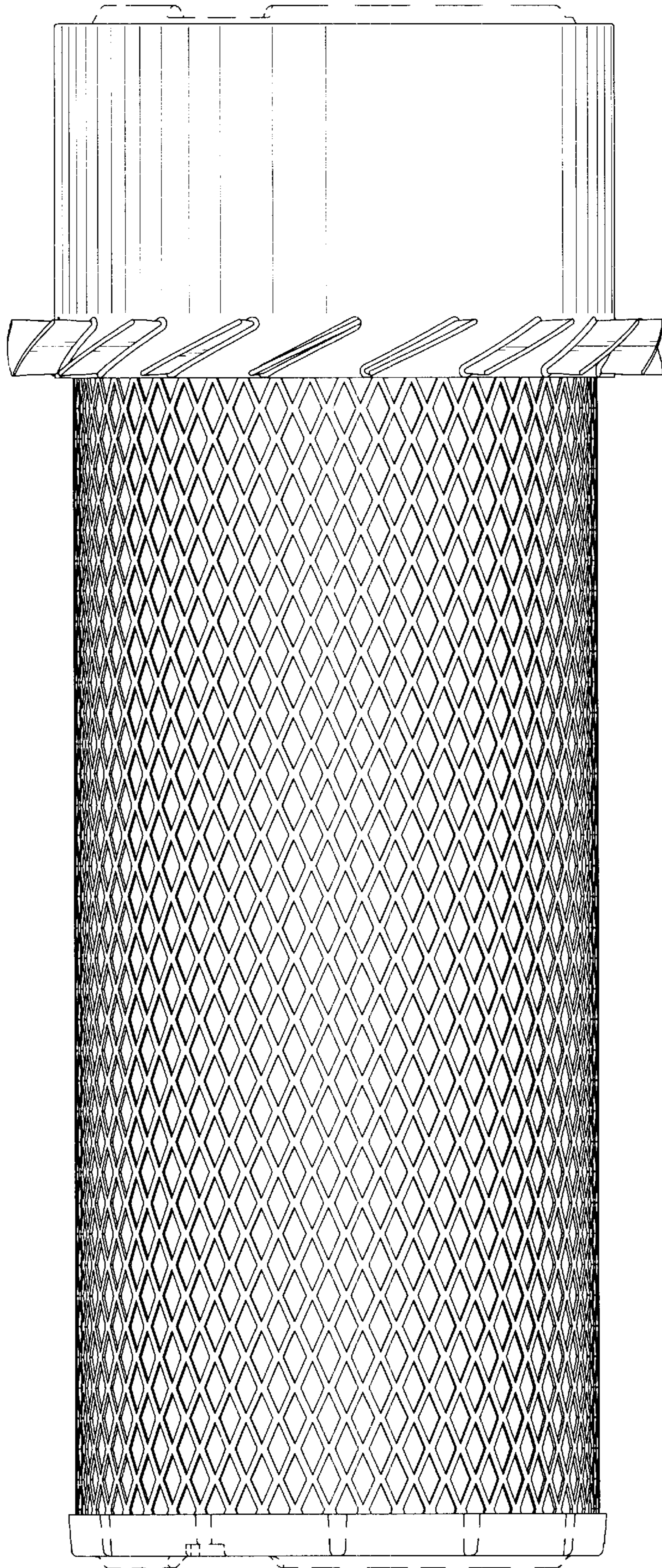

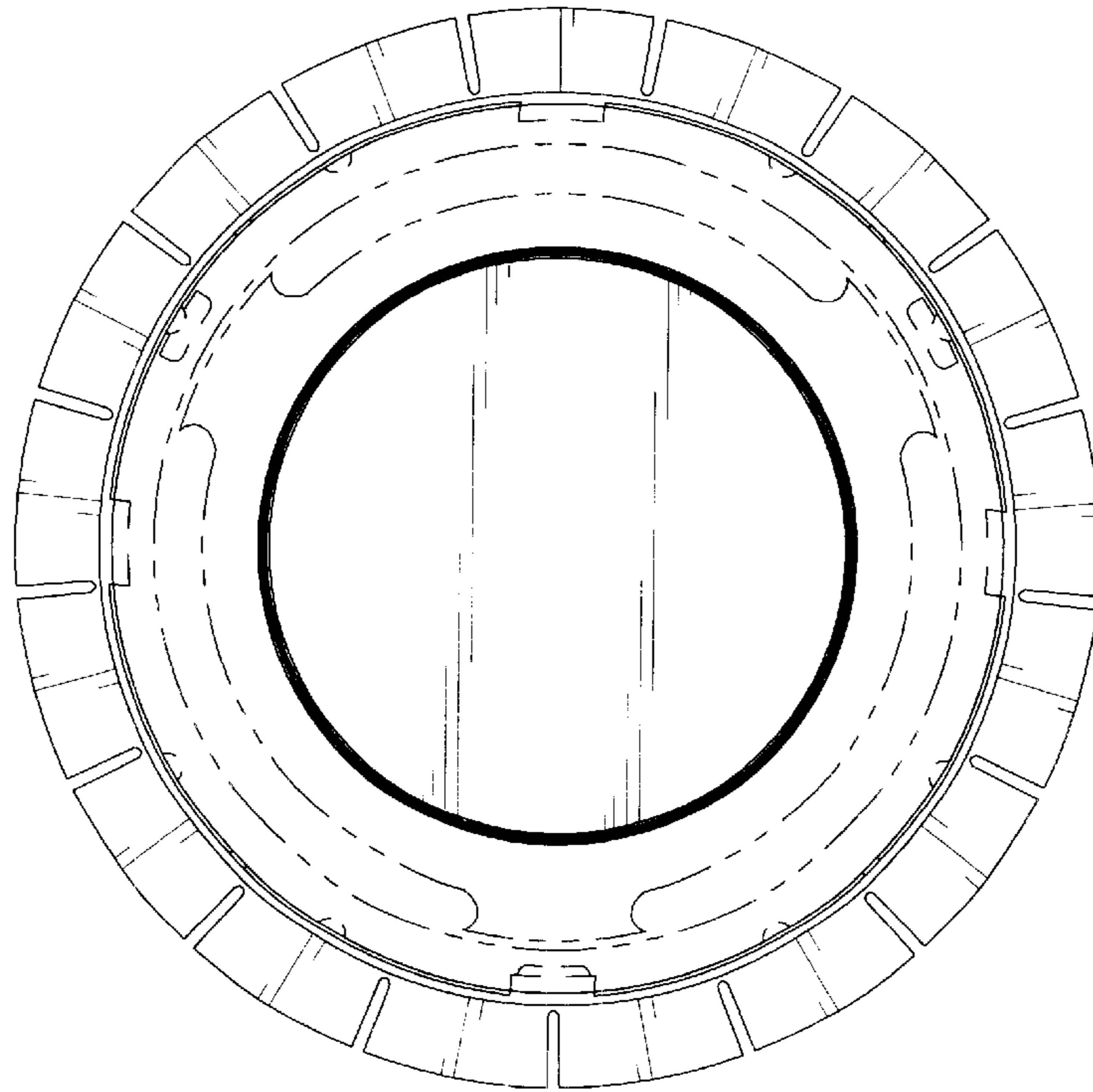
