(57) **CLAIM**

The ornamental design for a blood pressure monitor, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing our new design for a blood pressure monitor;

FIG. 2 is a rear view of the blood pressure monitor of FIG. 1;

FIG. 3 is a top view of the blood pressure monitor of FIG. 1;

FIG. 4 is a bottom view of the blood pressure monitor of FIG. 1;

FIG. 5 is a right side view of the blood pressure monitor of FIG. 1;

FIG. 6 is a left side view of the blood pressure monitor of FIG. 1;

FIG. 7 is a first perspective view of the blood pressure monitor of FIG. 1;

FIG. 8 is a cross-sectional view of the blood pressure monitor taken along line 8—8 of FIG. 3;

FIG. 9 is a front view of the blood pressure monitor of FIG. 1 in which the connector terminal cover is shown open;

FIG. 10 is a top side view of the blood pressure monitor of FIG. 1 in which the connector terminal cover is shown open;

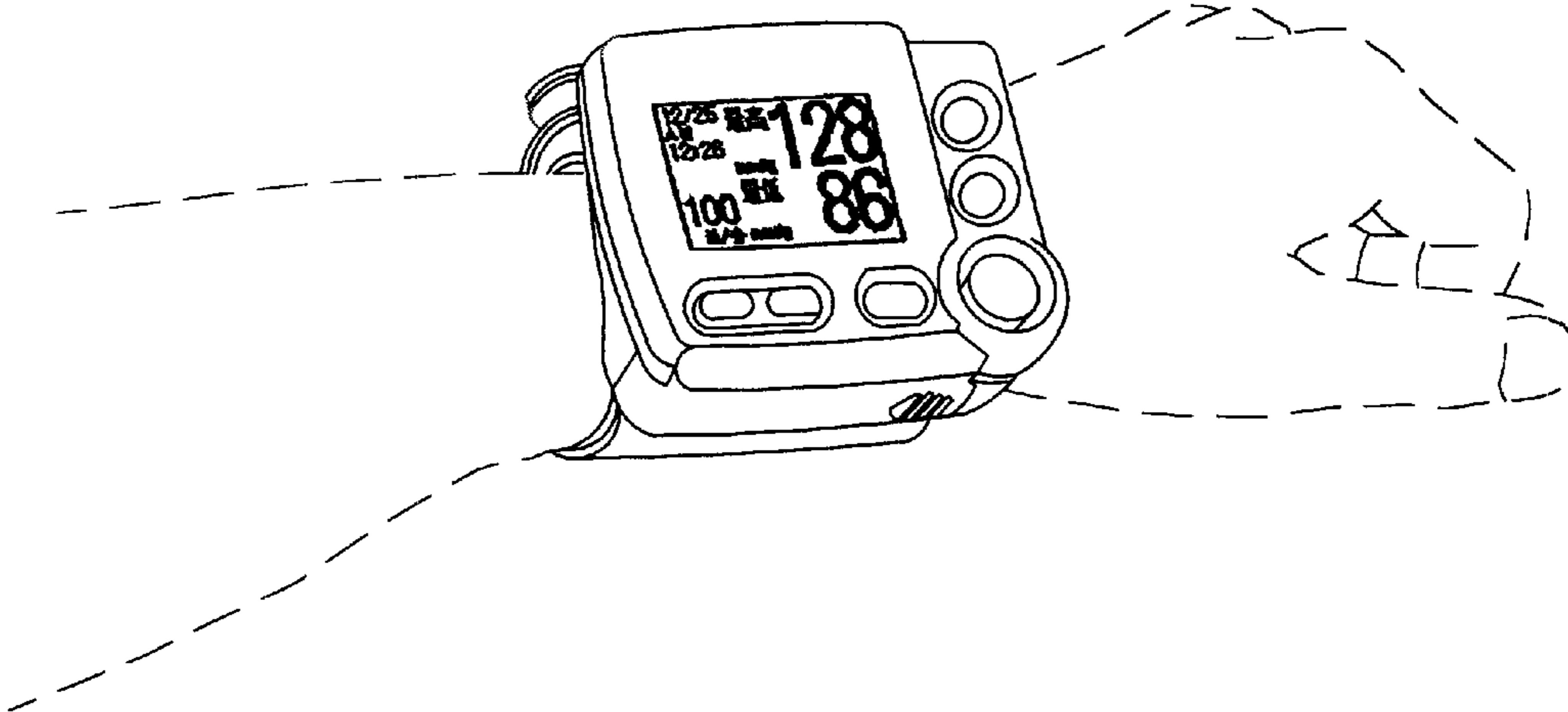
FIG. 11 is a right side view of the blood pressure monitor of FIG. 1 in which the connector terminal cover is shown open;

FIG. 12 is a front view of the blood pressure monitor of FIG. 1 showing the liquid crystal display; and,

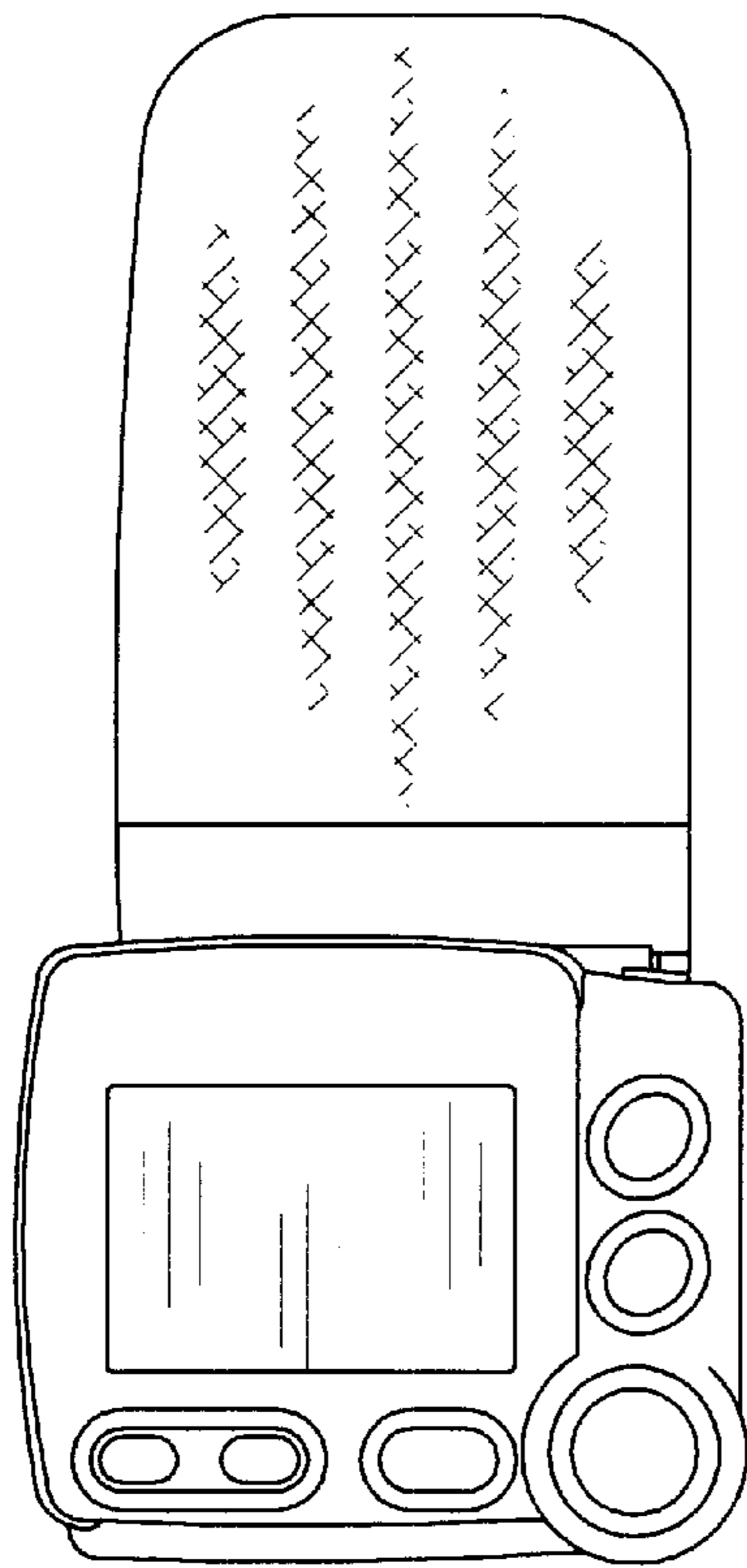

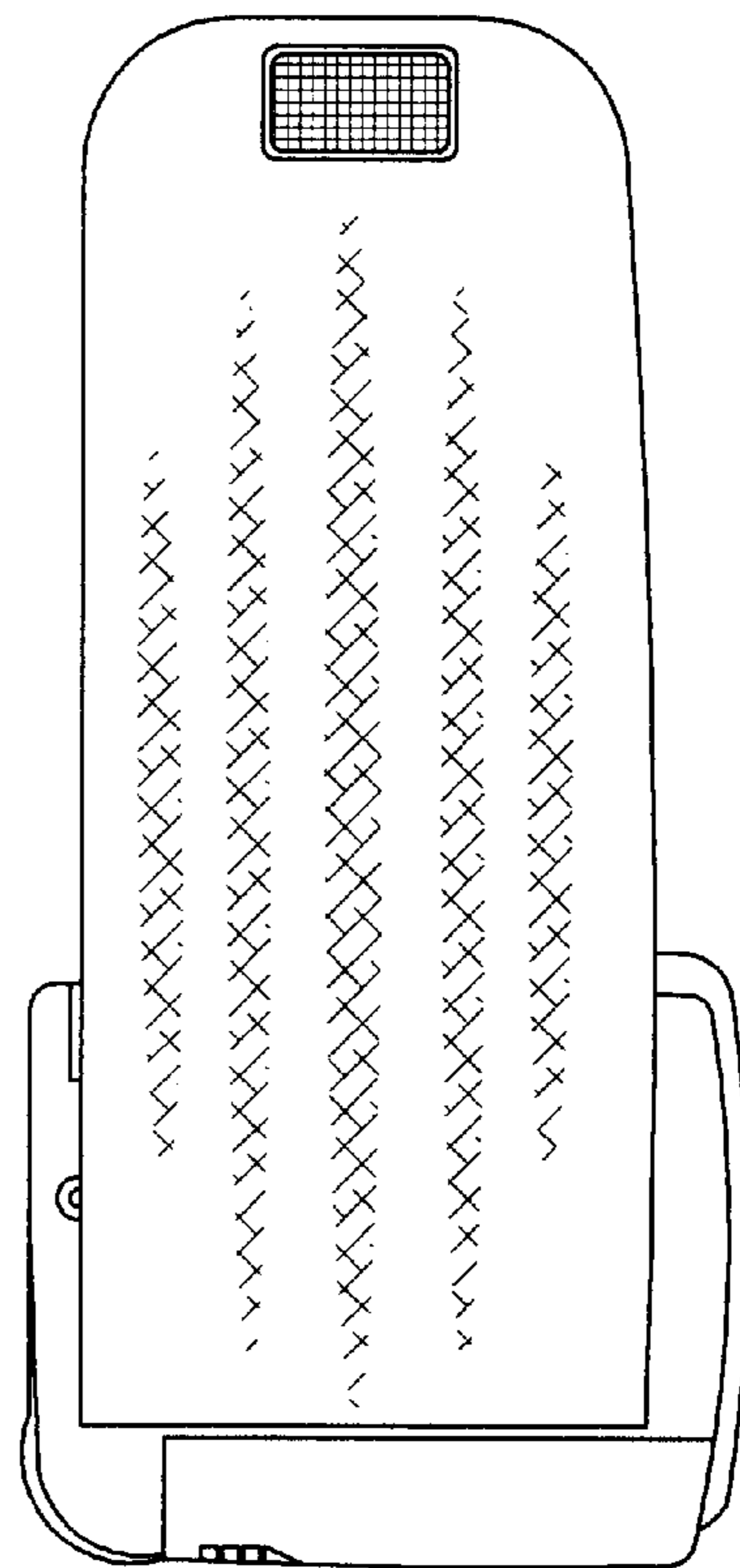

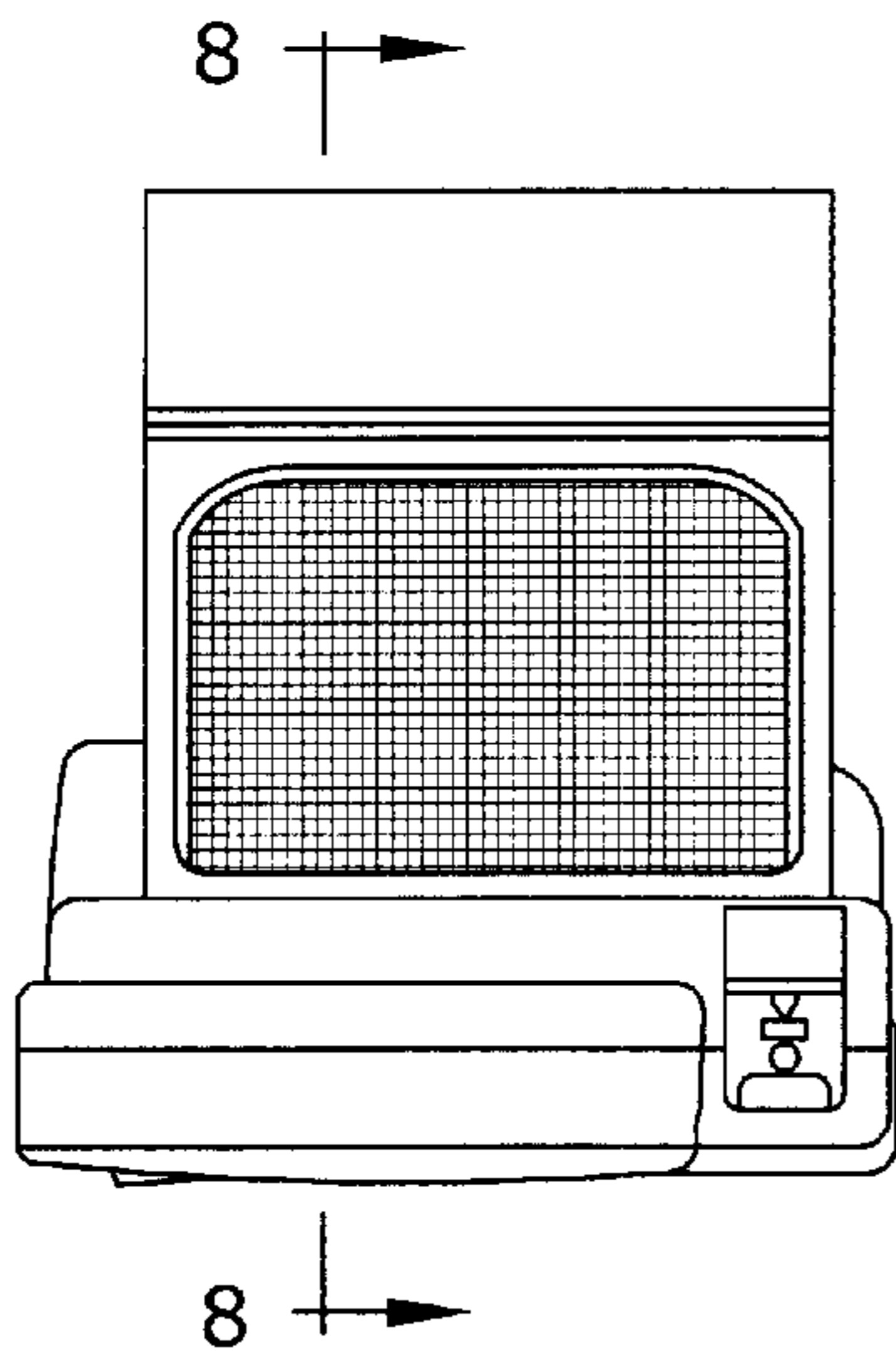

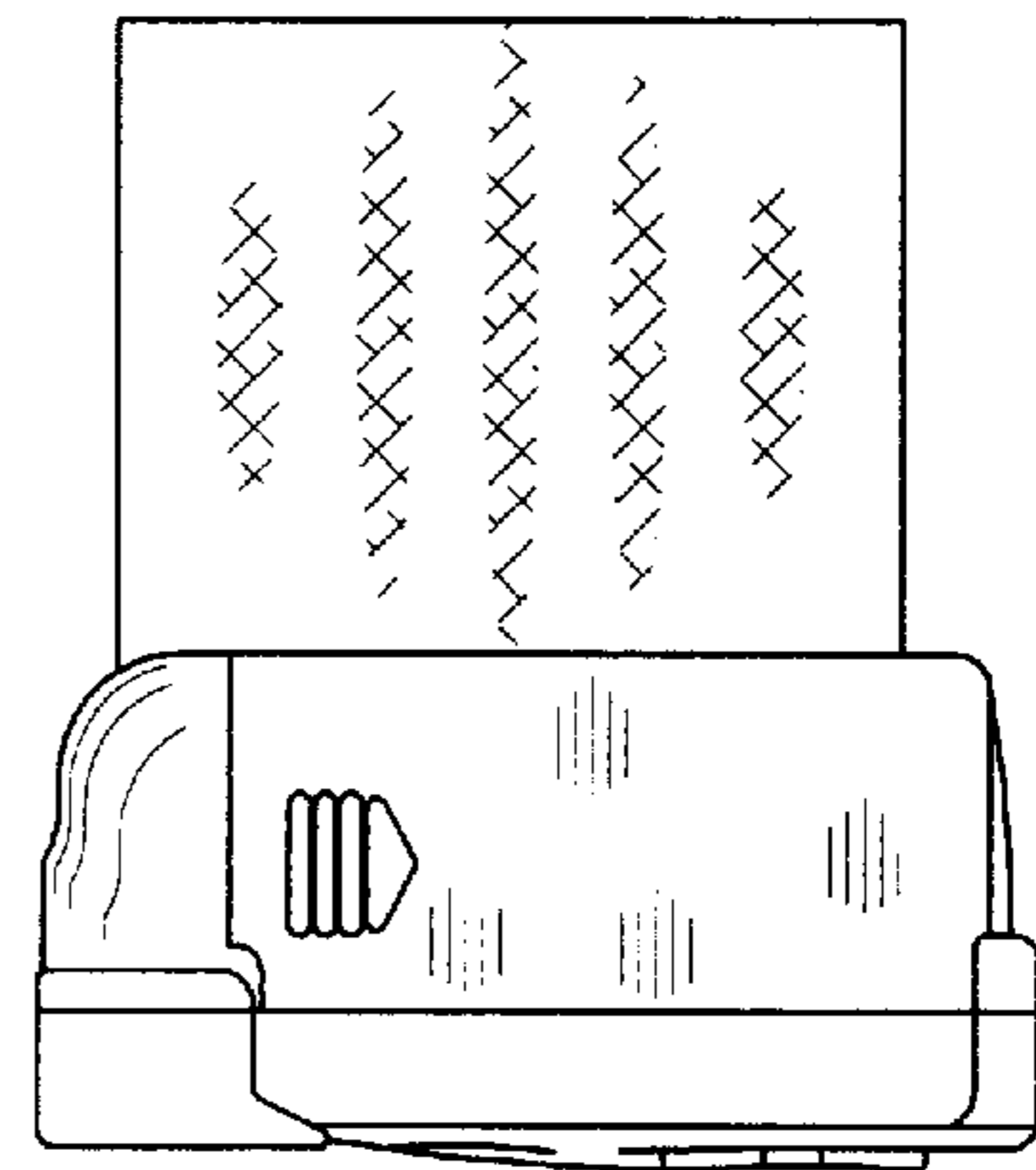
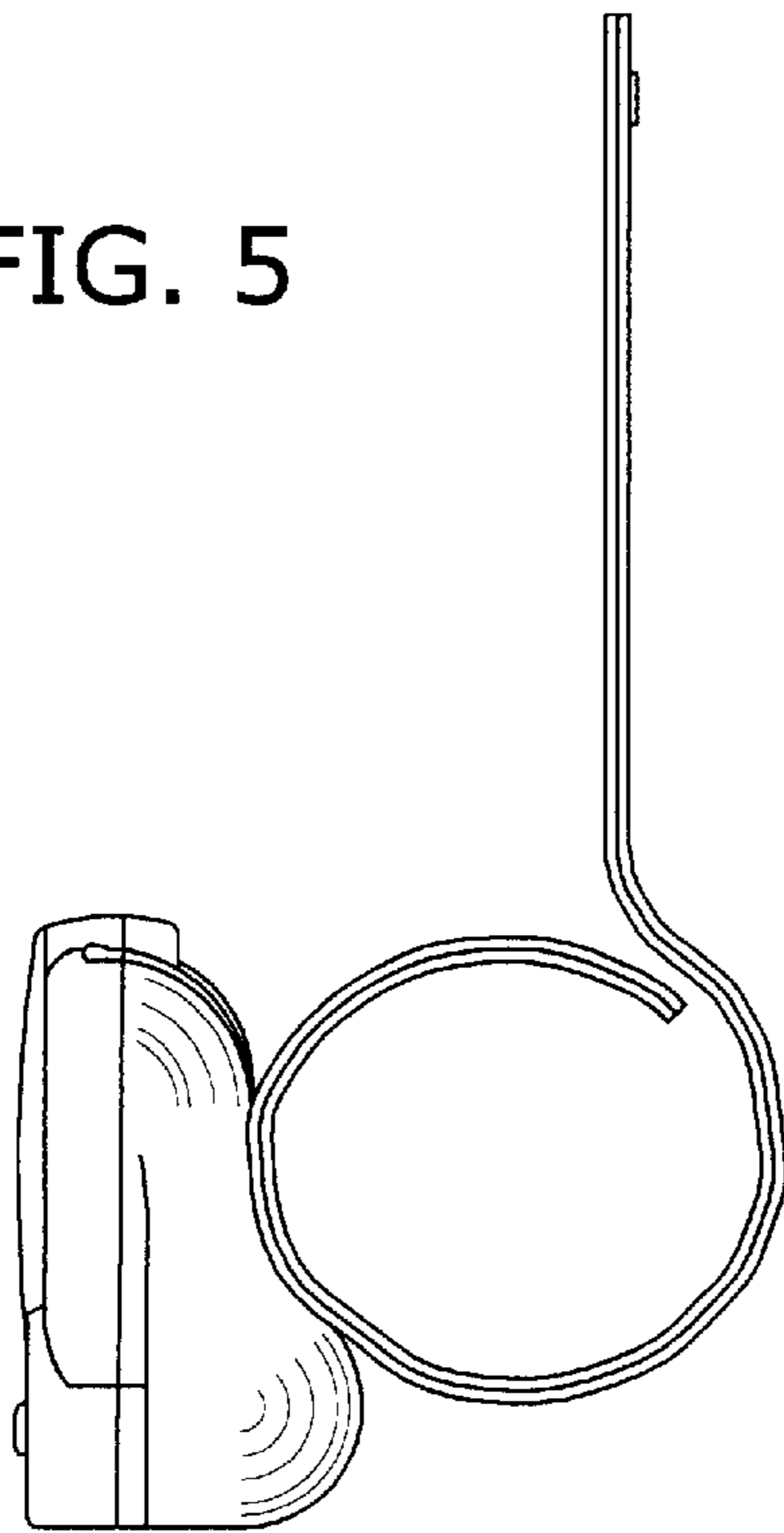

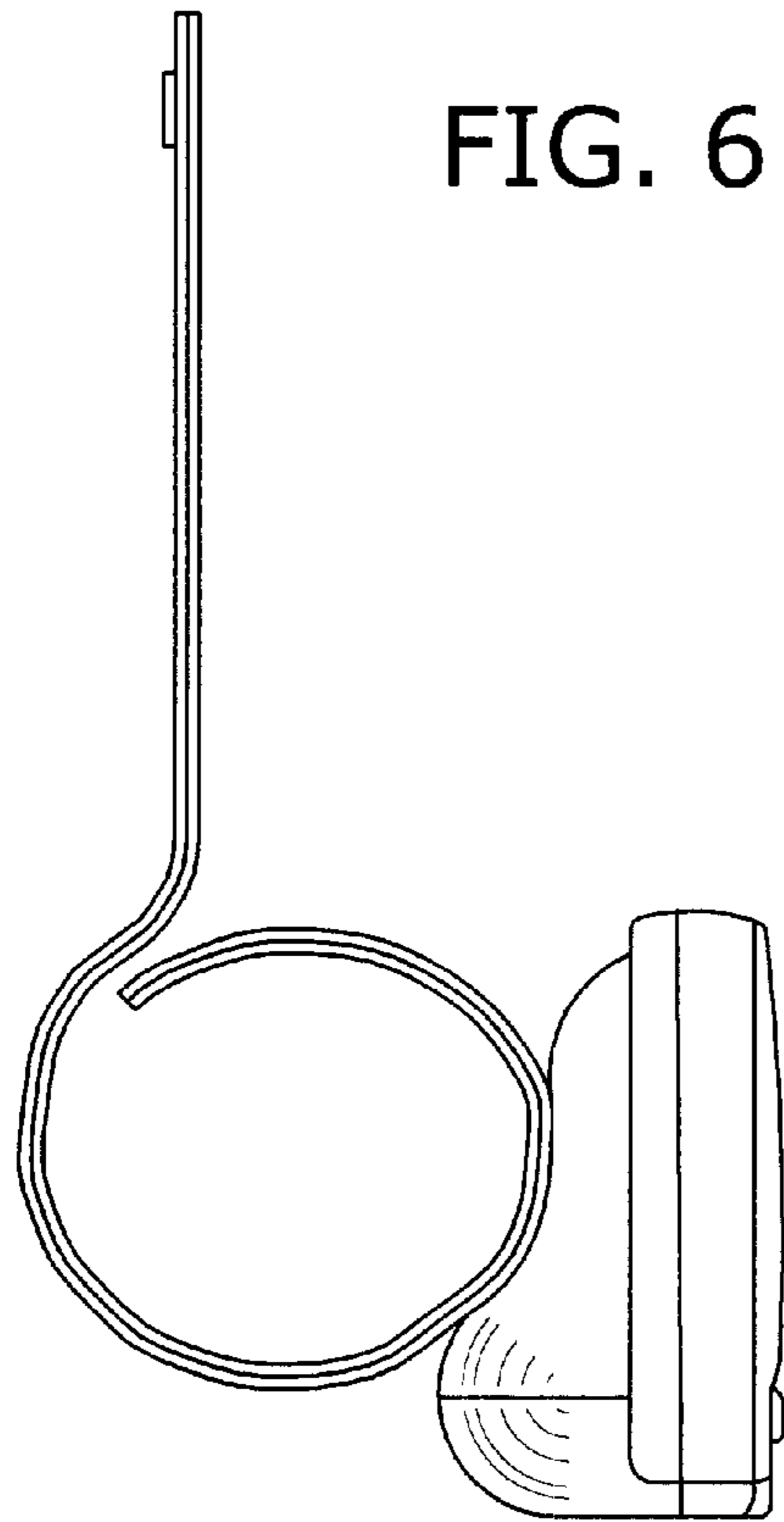
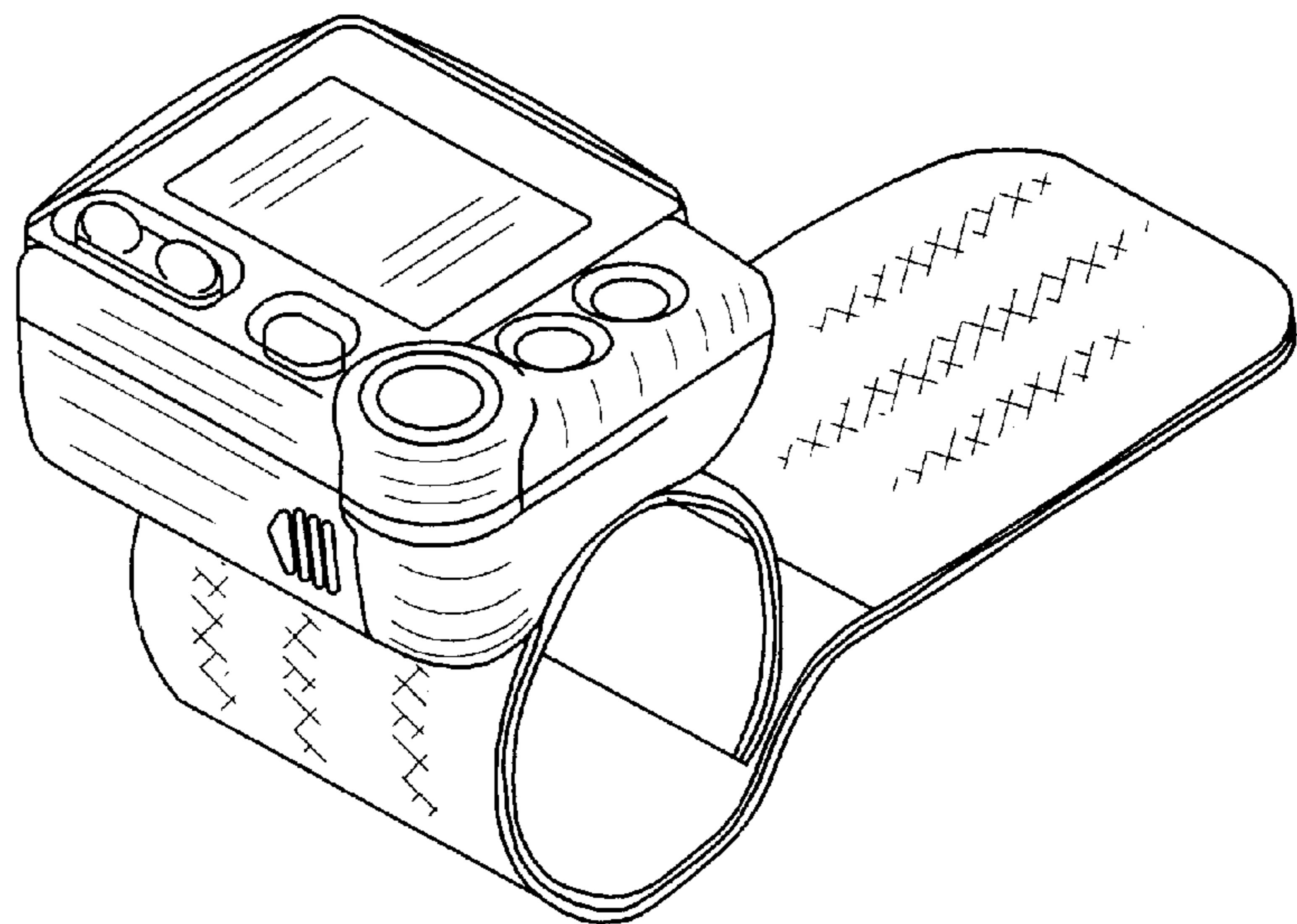

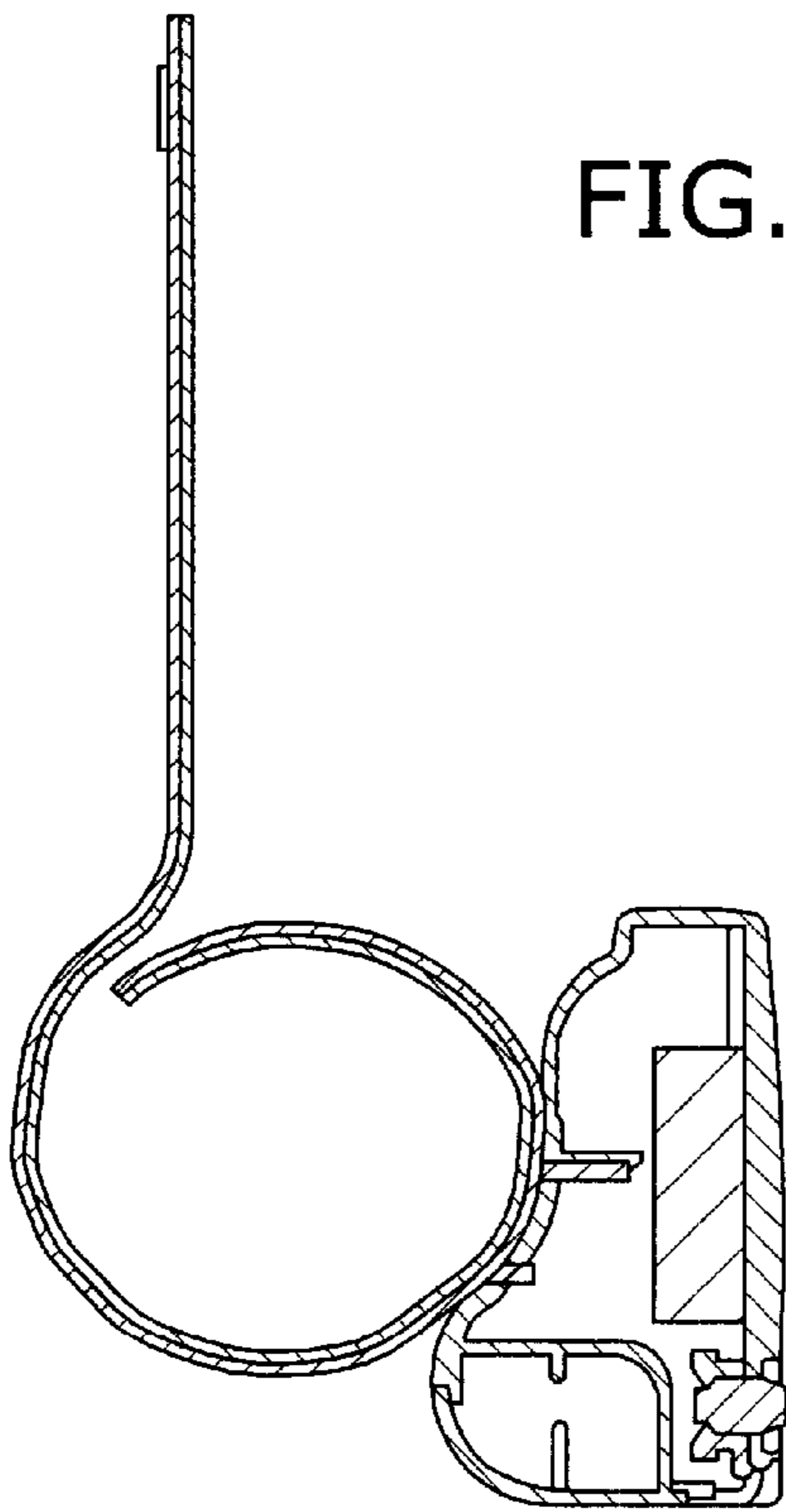

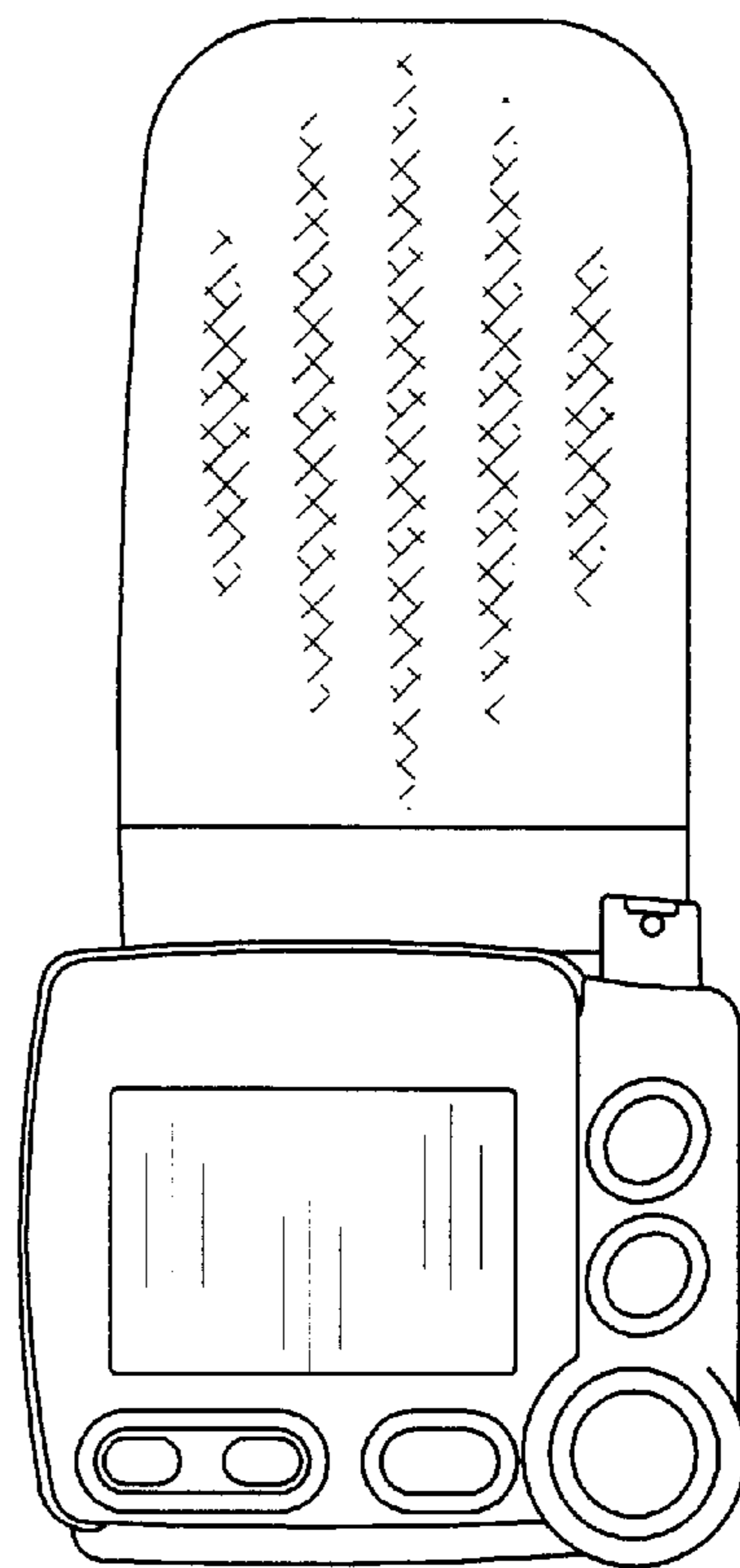

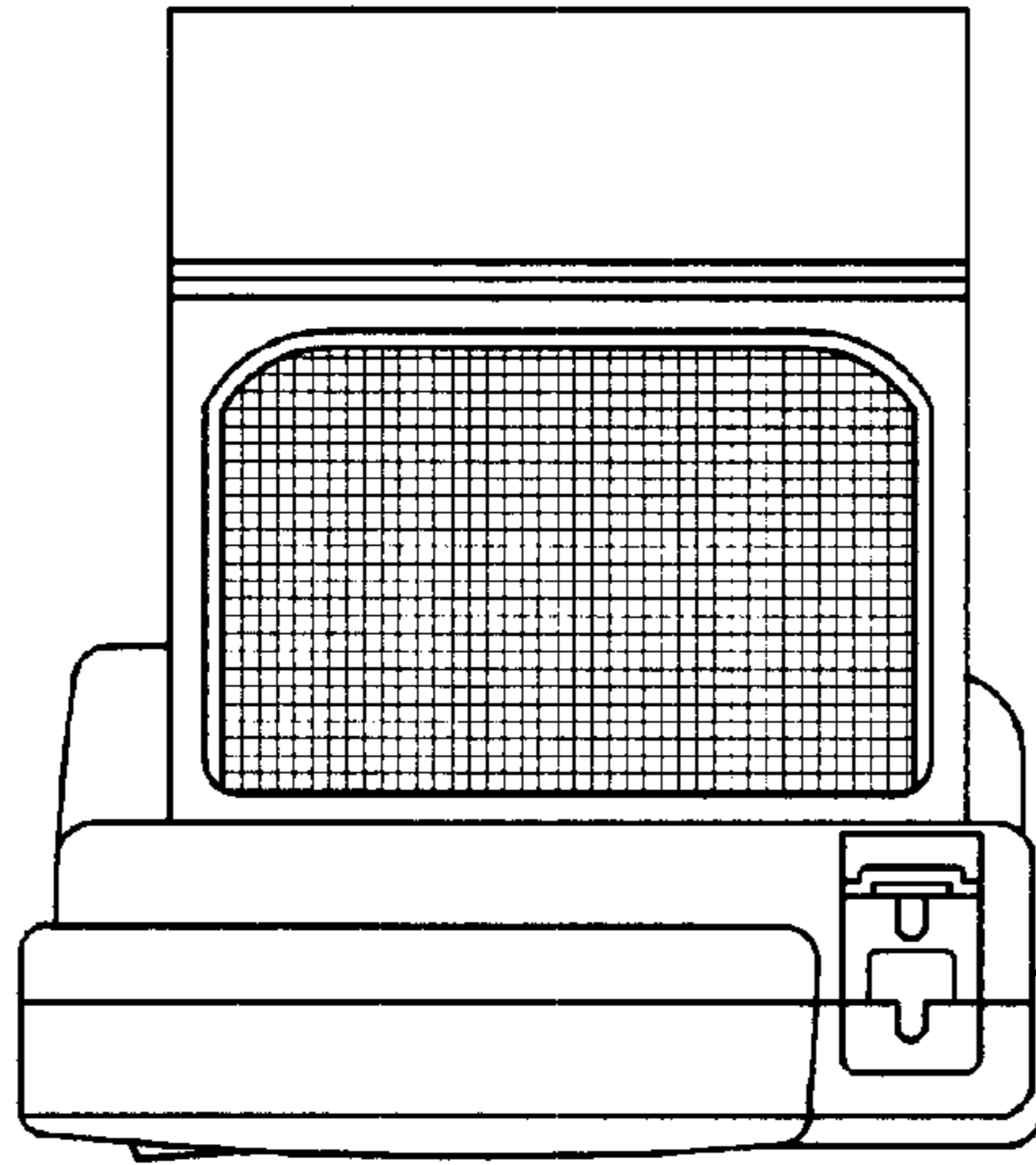

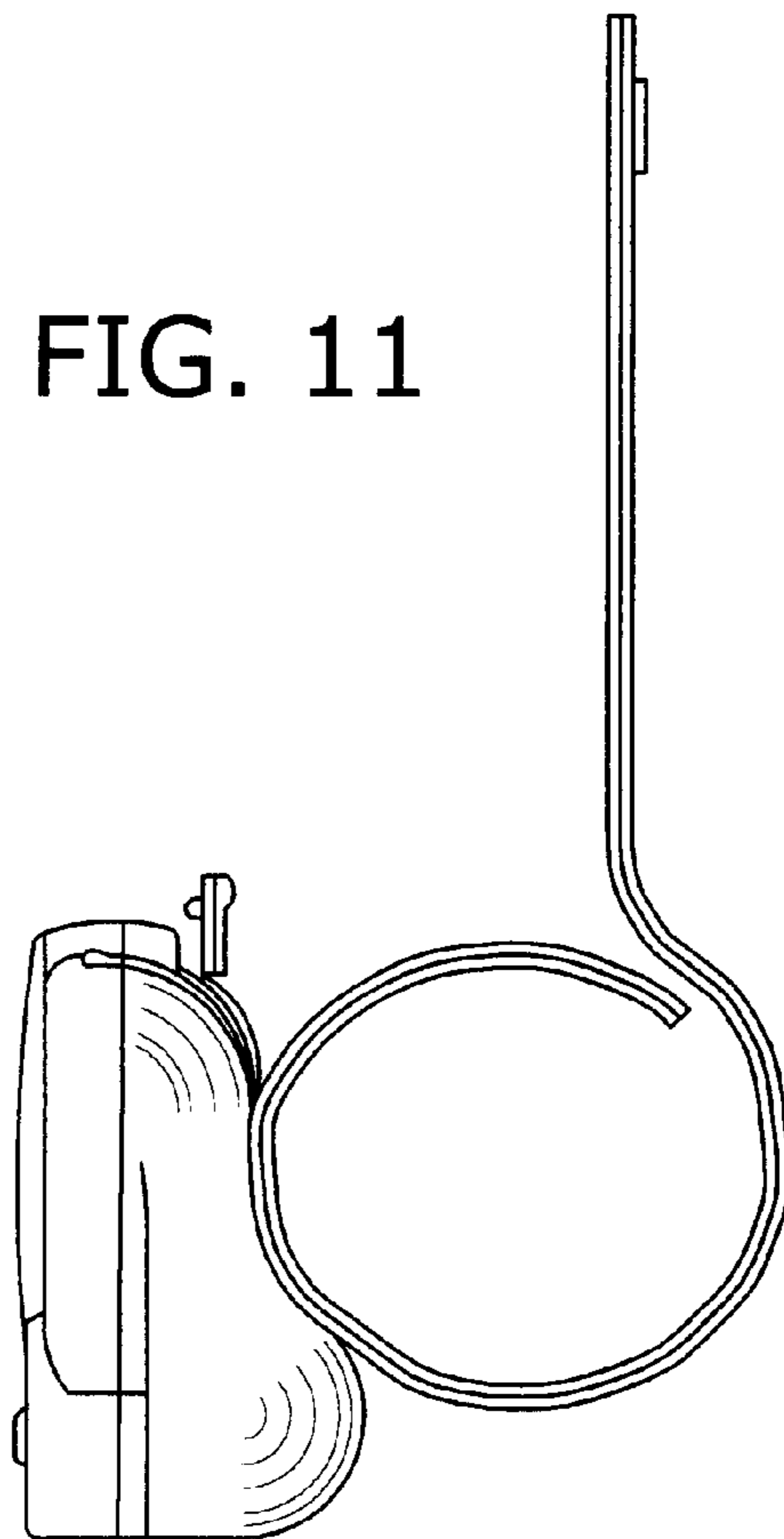

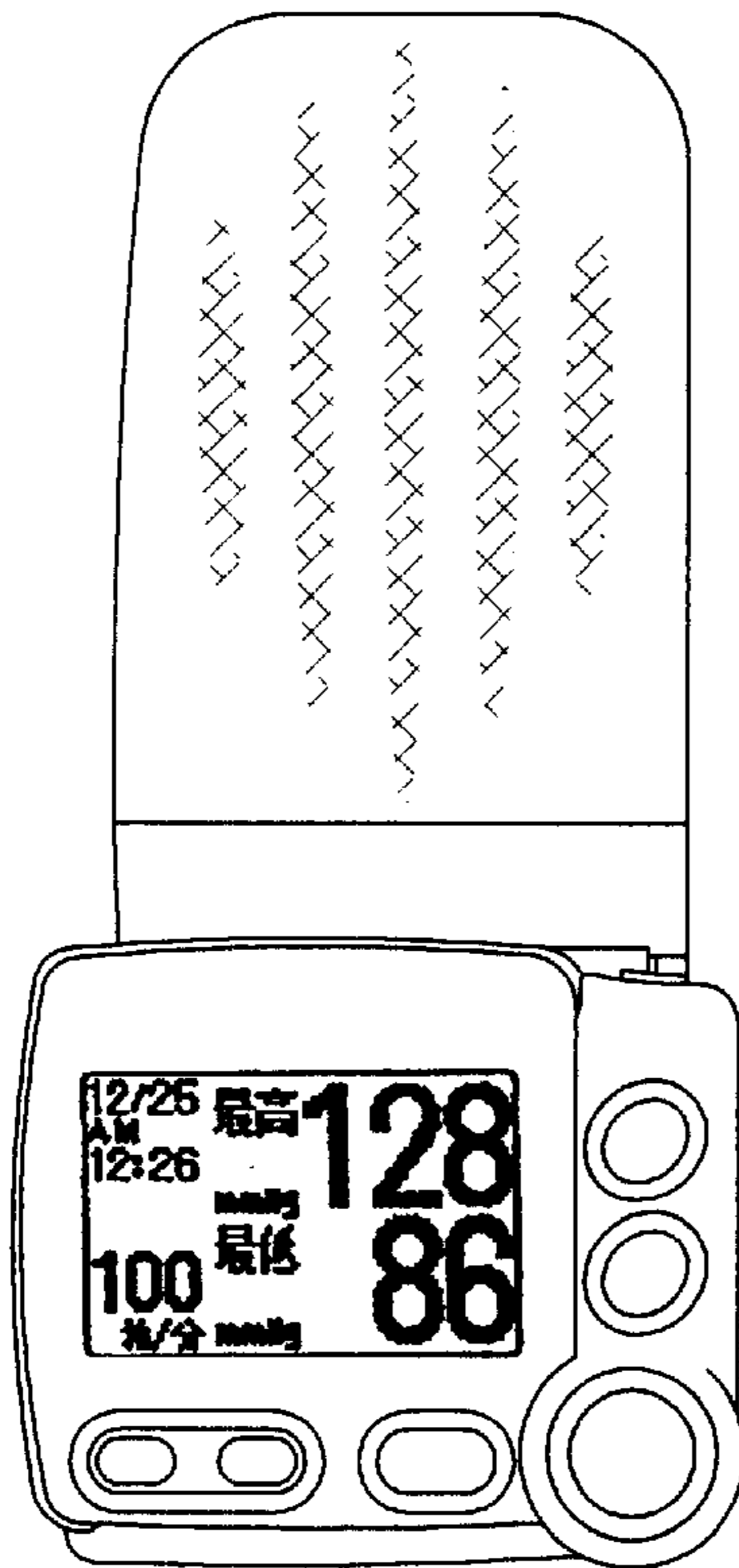
