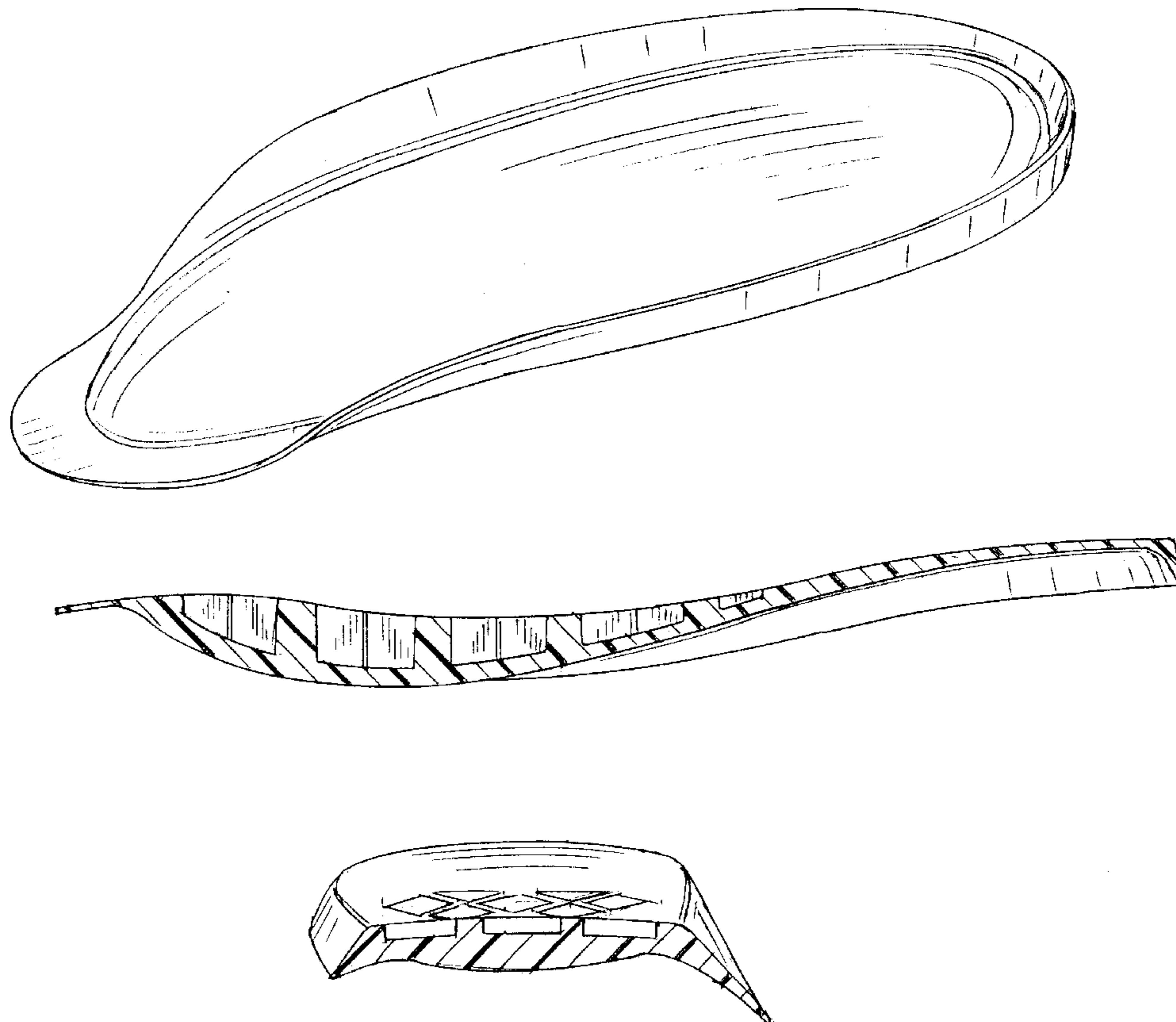

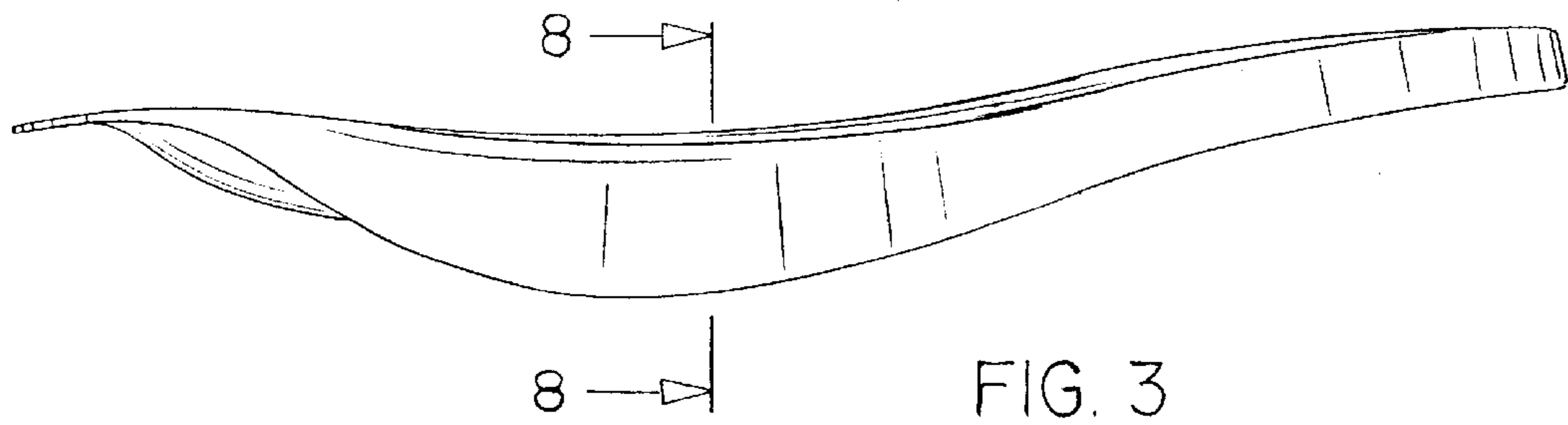
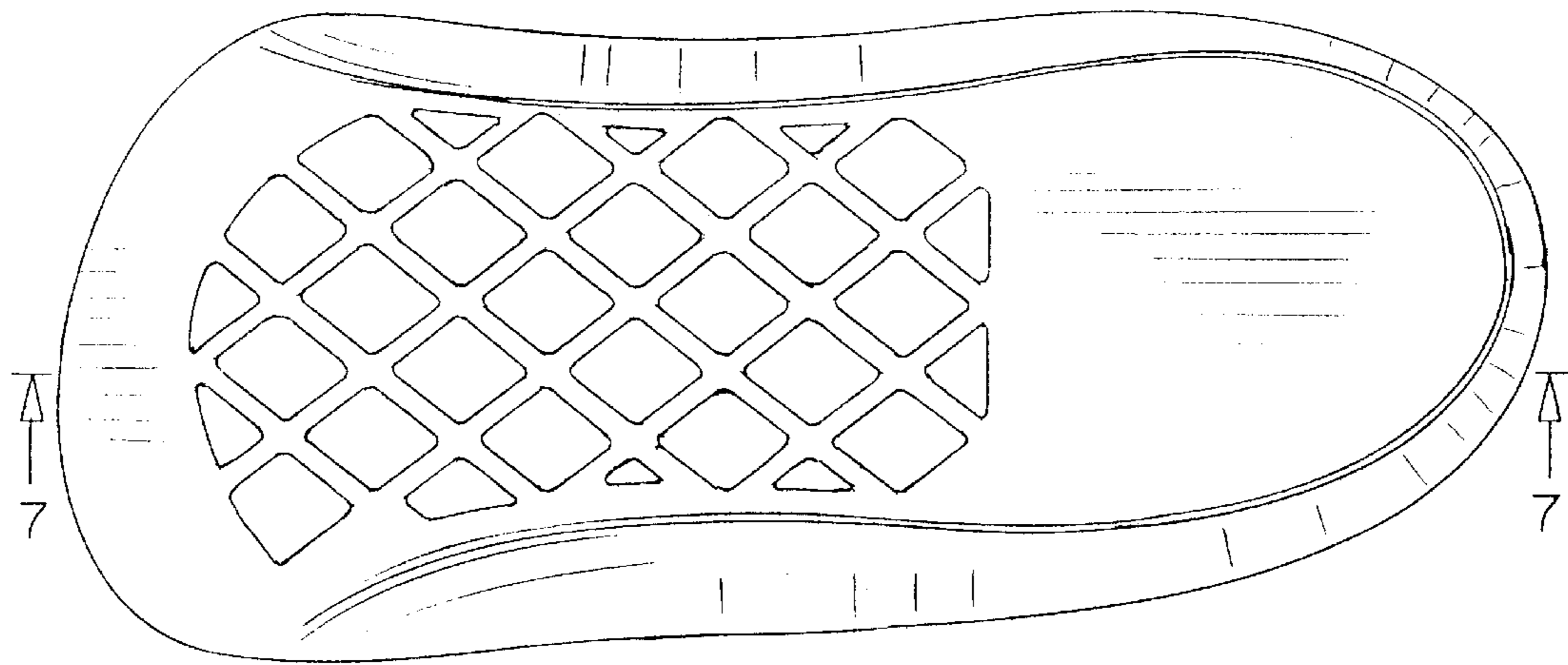
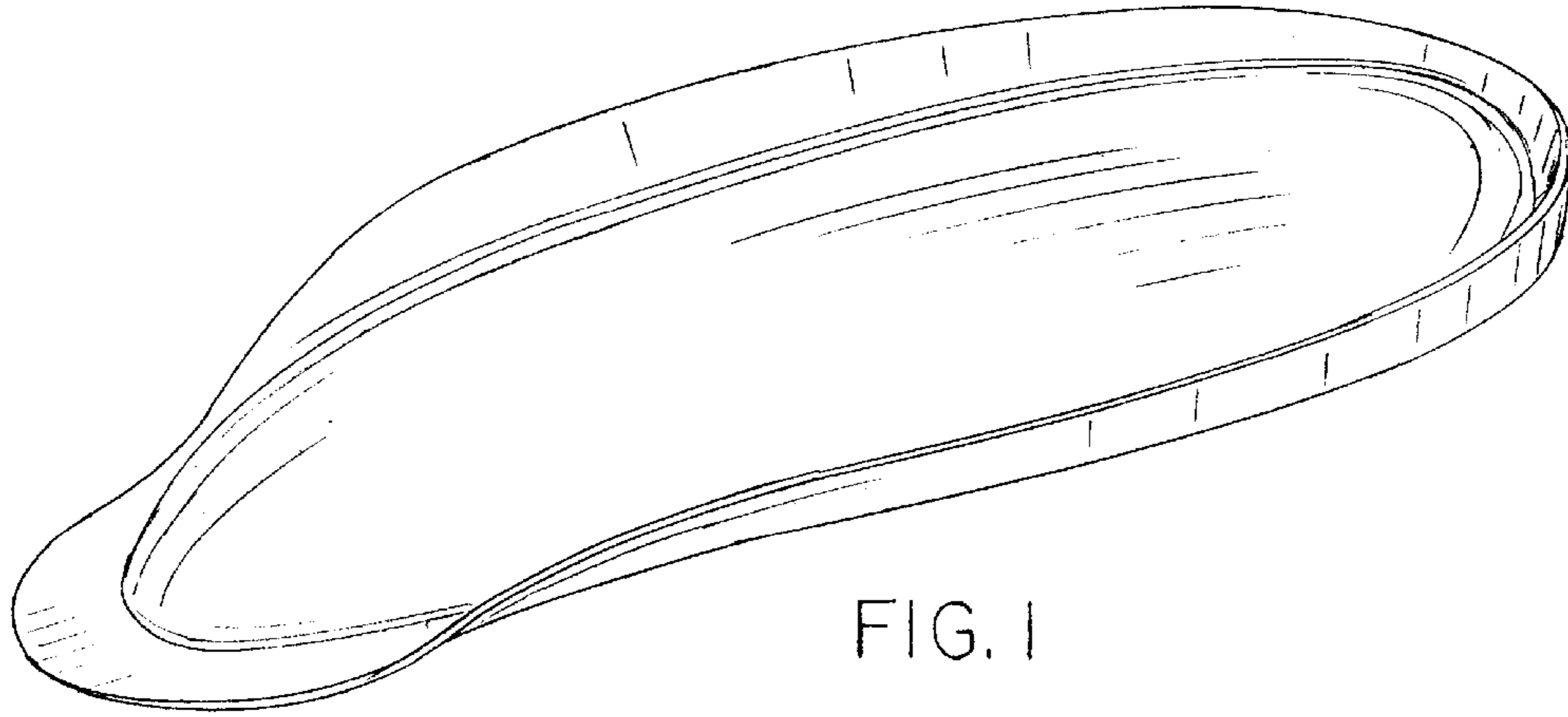
The ornamental design for an arch support, as shown.

**DESCRIPTION**

FIG. 1 is a top perspective view of an arch support, showing my new design, the right hand support being shown and the left hand support being a mirror image thereof;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a front end view thereof;  
 FIG. 6 is a rear end view thereof;  
 FIG. 7 is a sectional view taken on line 7—7 of FIG. 2; and,  
 FIG. 8 is a sectional view taken on line 8—8 of FIG. 3.

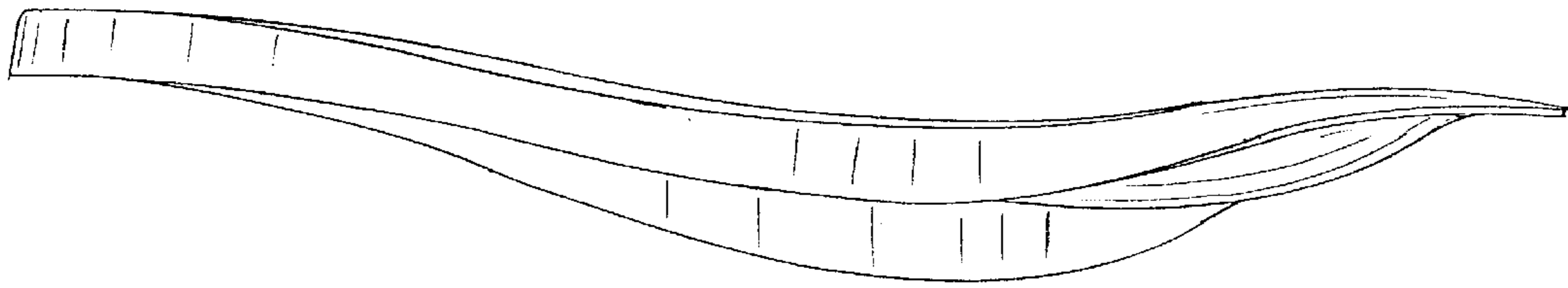

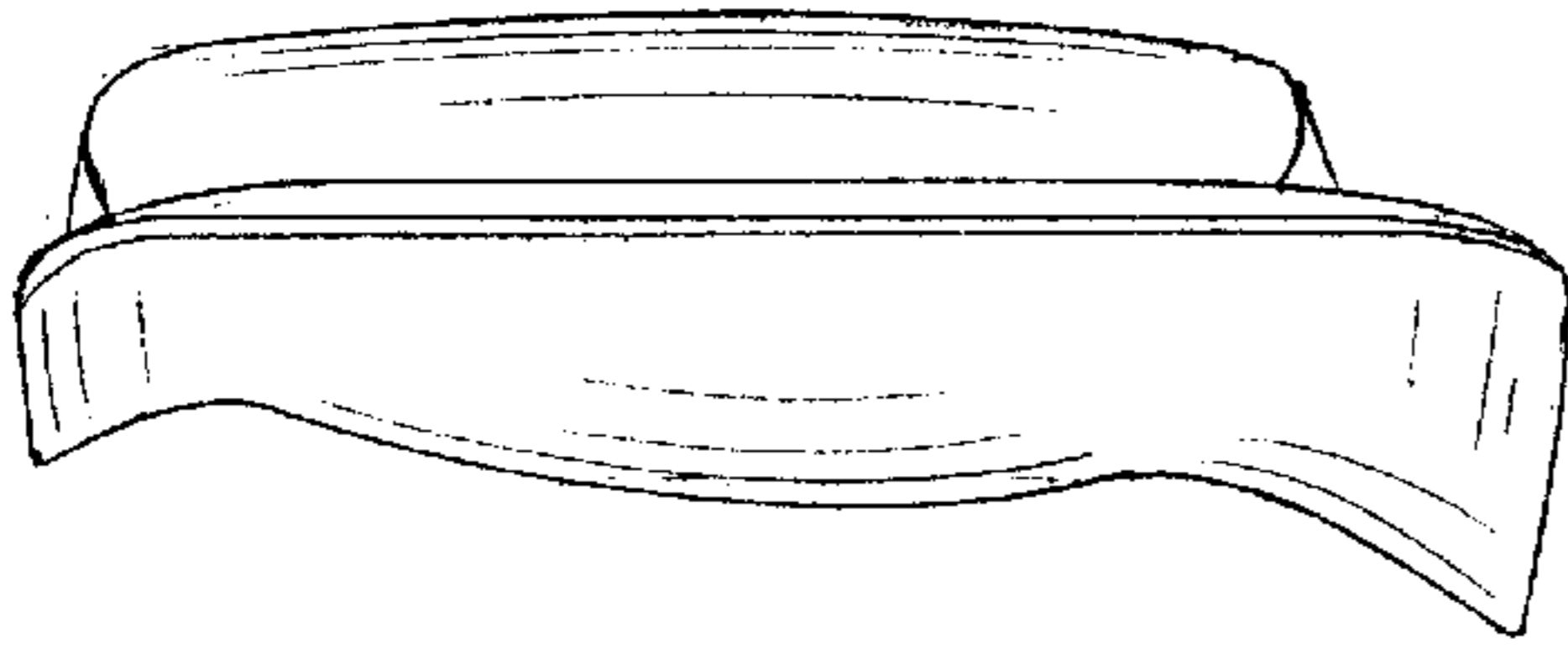

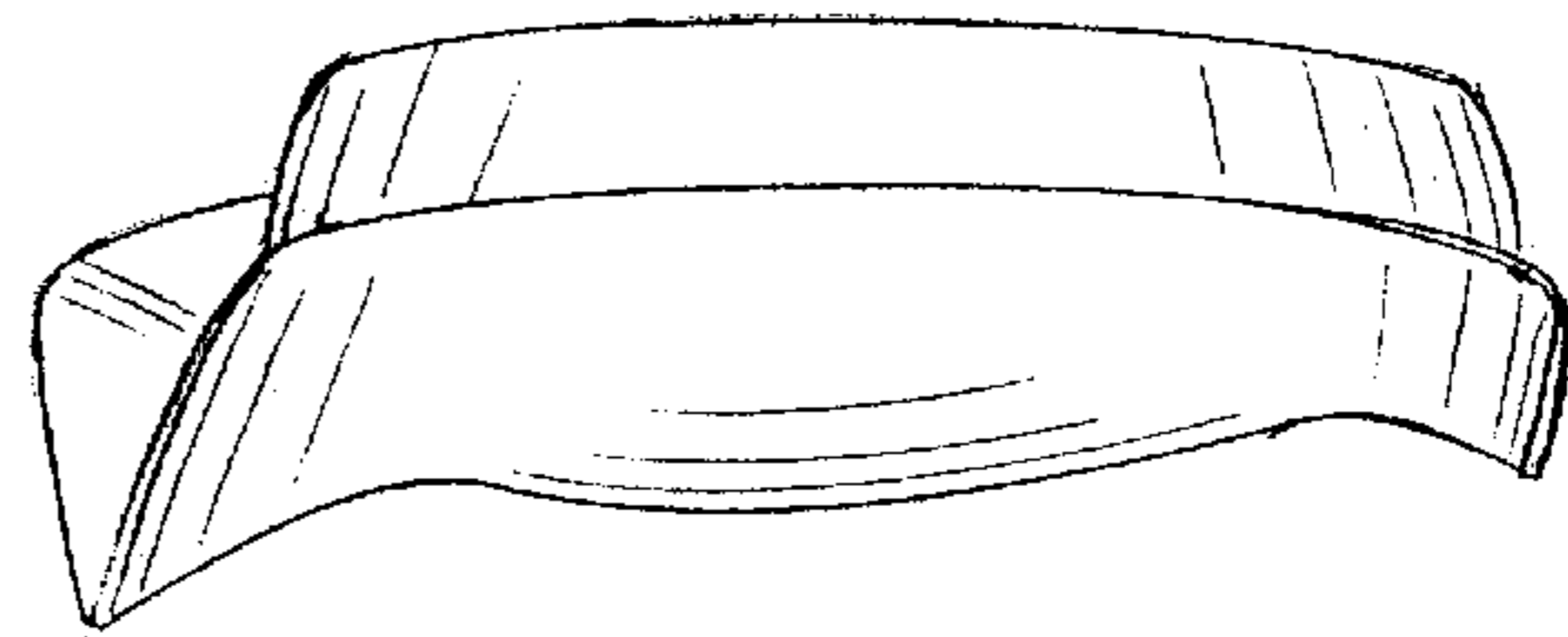

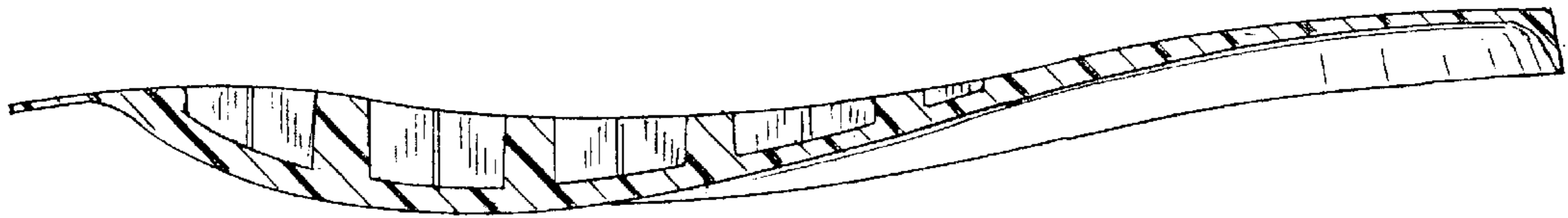

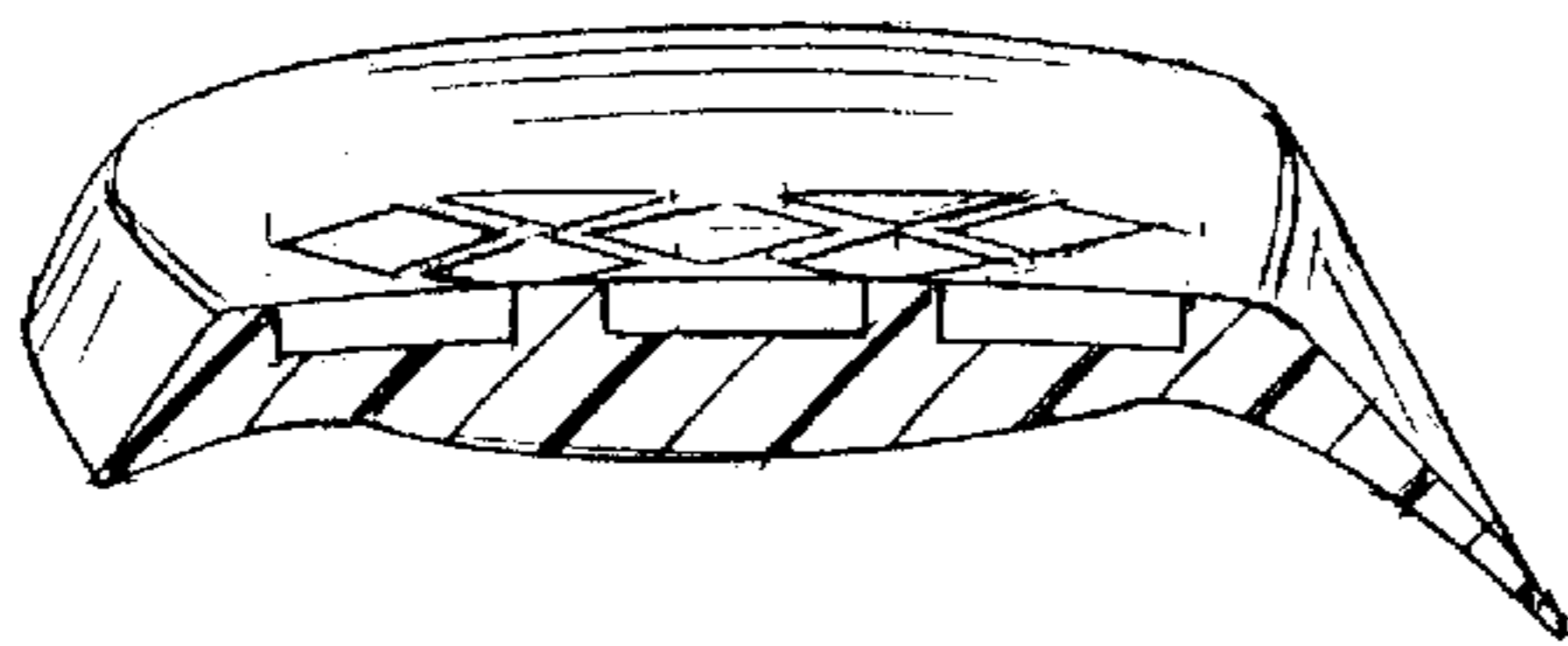
