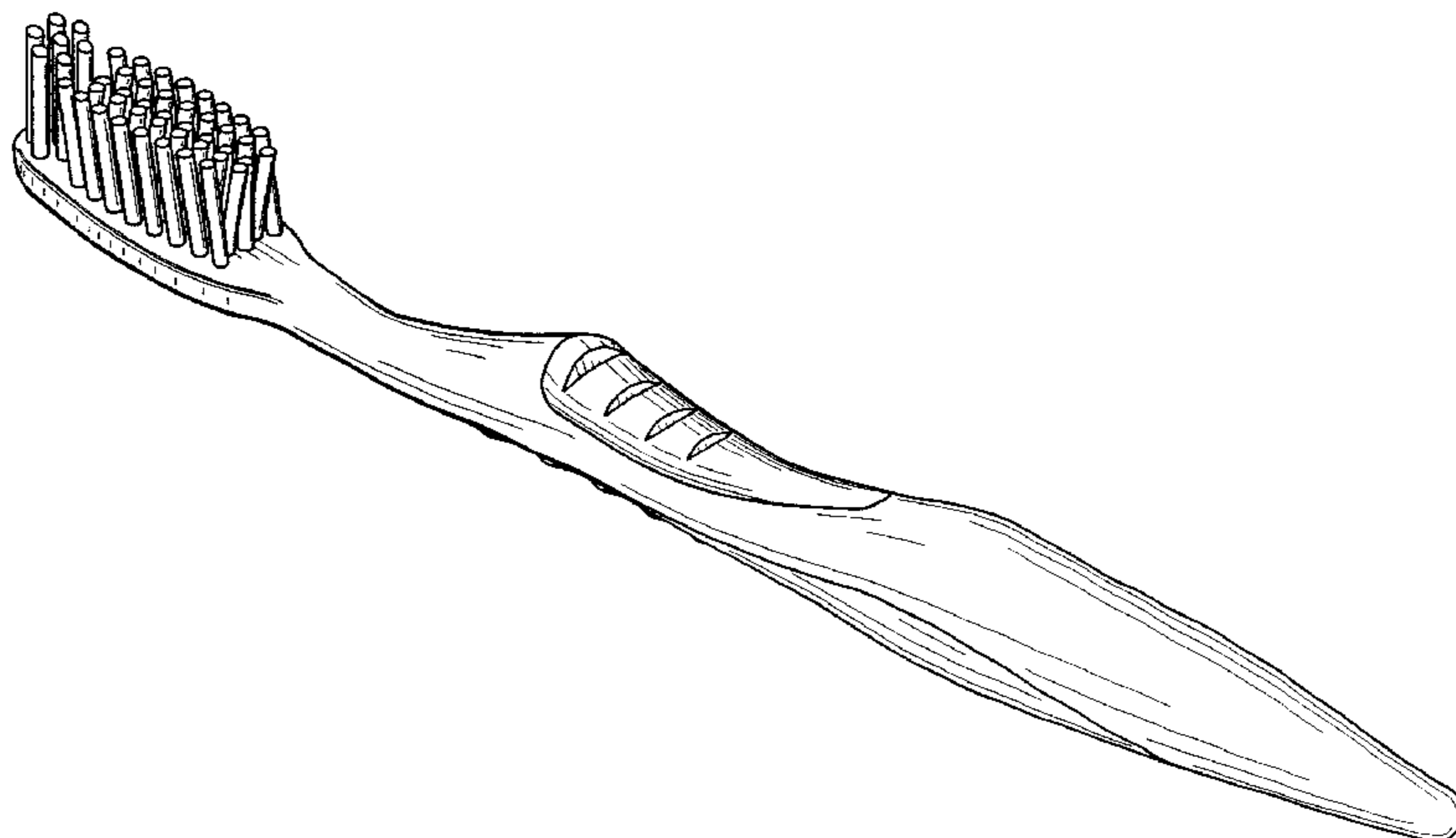
(57) **CLAIM**

The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the left side of a toothbrush showing our design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a left side elevational view thereof, it being understood that the right side view is a mirror image;  
 FIG. 5 is a view from the head end thereof;  
 FIG. 6 is a view from the handle end thereof;  
 FIG. 7 is a perspective view from the left side of a second embodiment of the design shown in FIGS. 1-6;  
 FIG. 8 is a top plan view thereof;  
 FIG. 9 is a bottom plan view thereof;  
 FIG. 10 is a left side elevational view thereof, it being understood that the right side view is a mirror image;  
 FIG. 11 is a view from the head end thereof;  
 FIG. 12 is a view from the handle end thereof;  
 FIG. 13 is a perspective view from the left side of a third embodiment of the design shown in FIGS. 1-6;  
 FIG. 14 is a top plan view thereof;  
 FIG. 15 is a bottom plan view thereof;  
 FIG. 16 is a left side elevational view thereof, it being understood that the right side view is a mirror image;  
 FIG. 17 is a view from the head end thereof;  
 FIG. 18 is a view from the handle end thereof;  
 FIG. 19 is a perspective view from the left side of a fourth embodiment showing a handle of our toothbrush, with the broken line showing bristles being of illustrative purposes only and forming no part of this embodiment;  
 FIG. 20 is a top plan view thereof;  
 FIG. 21 is a bottom plan view thereof;  
 FIG. 22 is a left side elevational view thereof, it being understood that the right side view is a mirror image;  
 FIG. 23 is a view from the head end thereof; and,  
 FIG. 24 is a view from the handle end thereof.

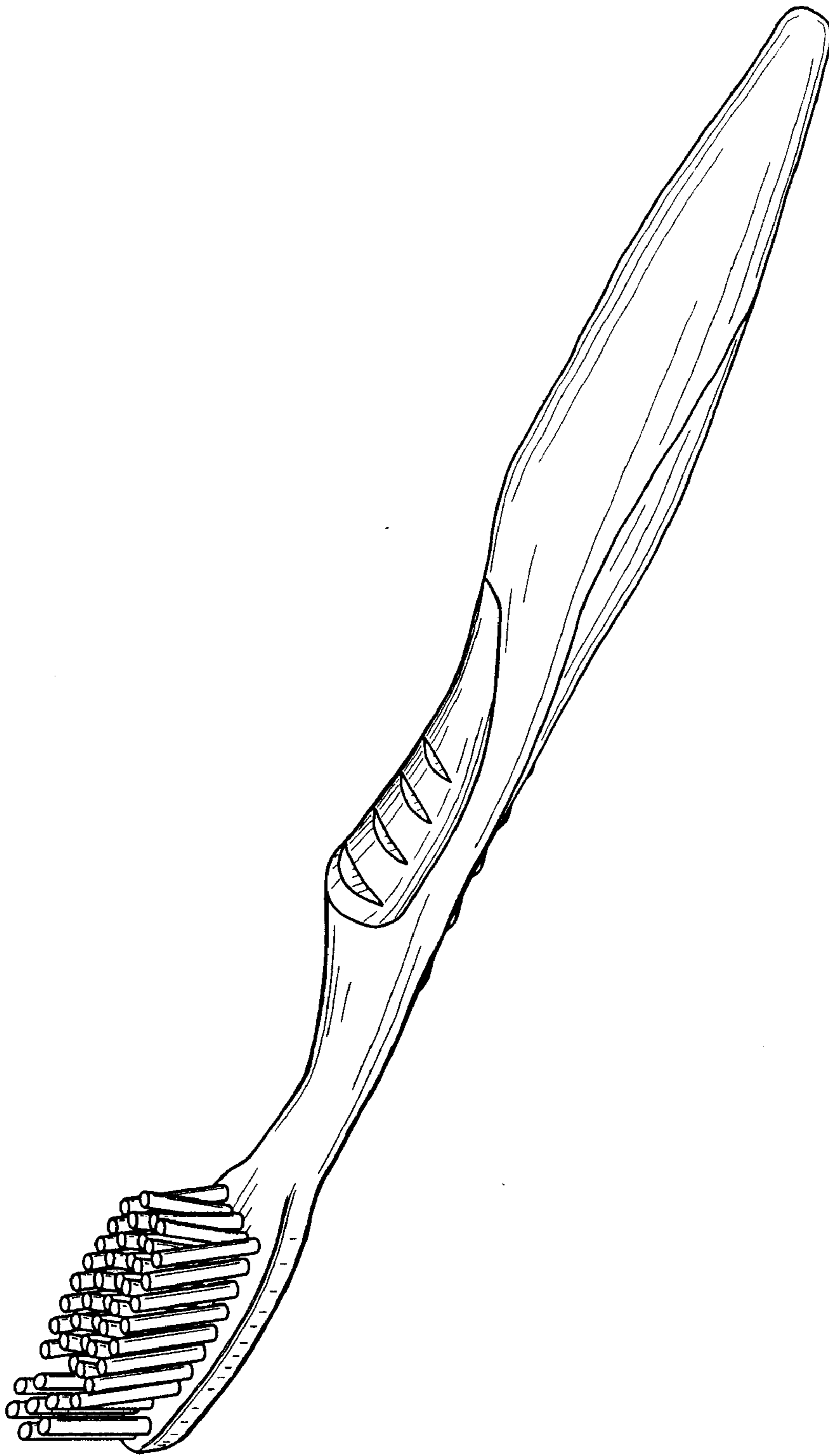

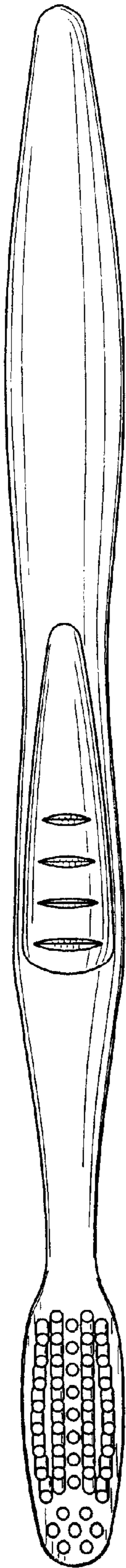

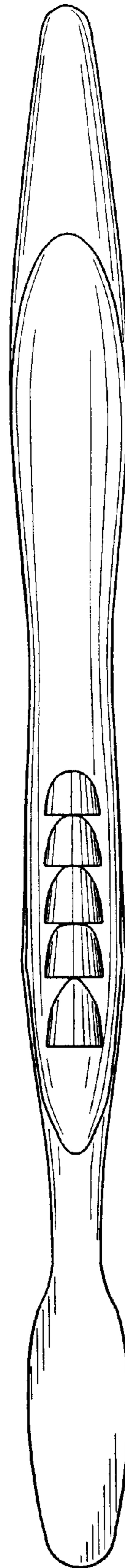

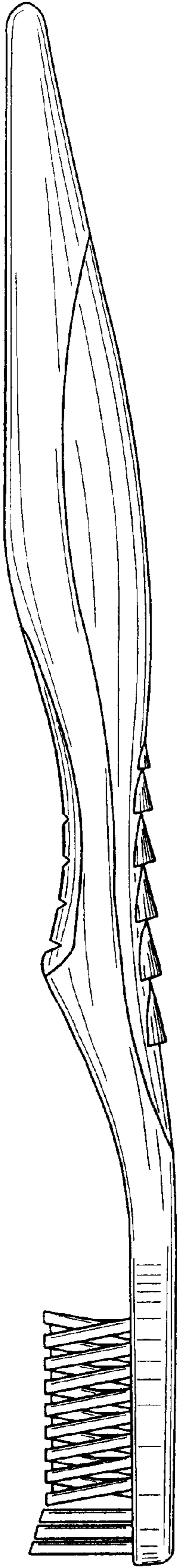

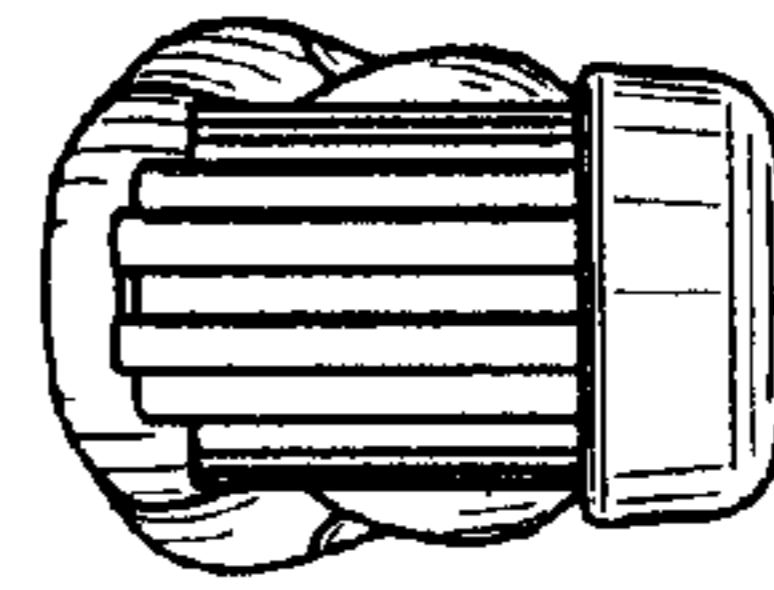

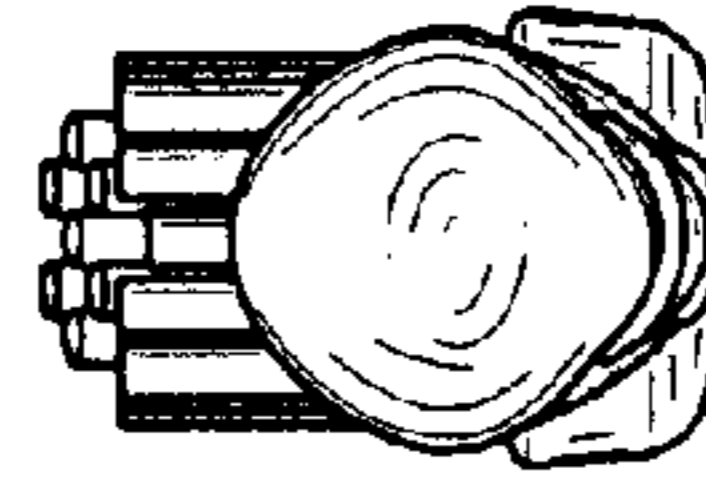

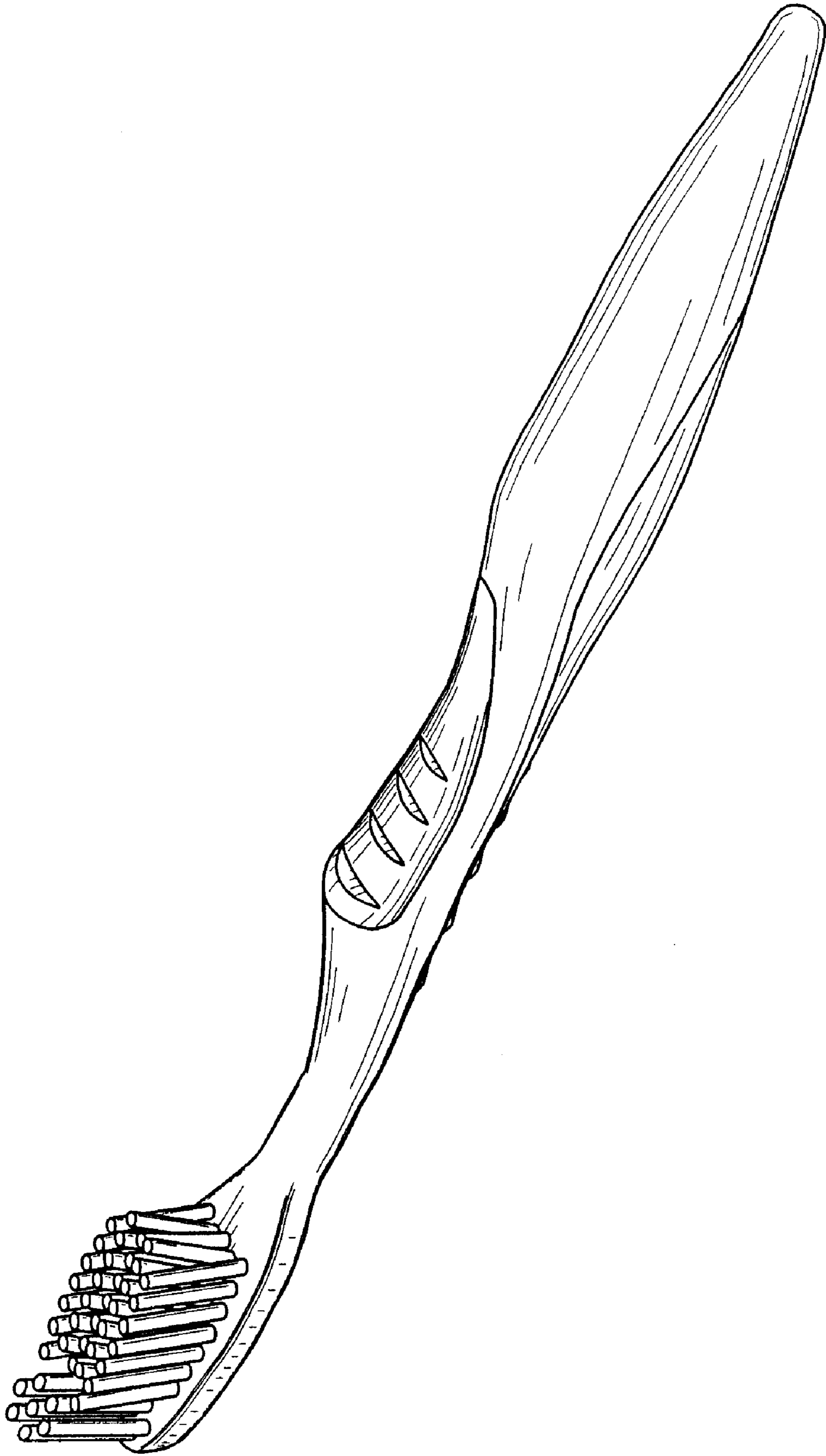

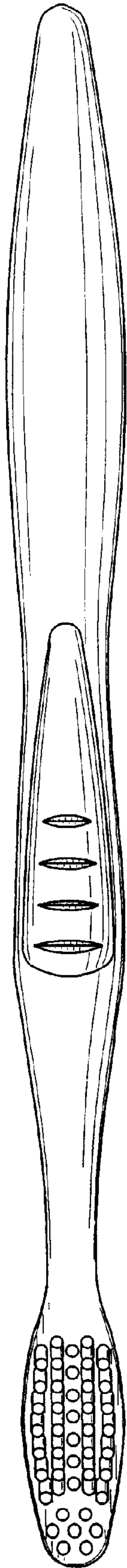

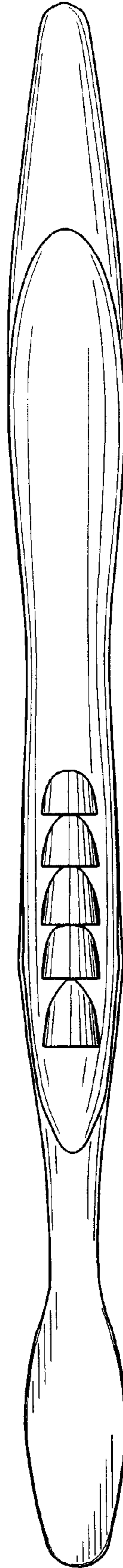

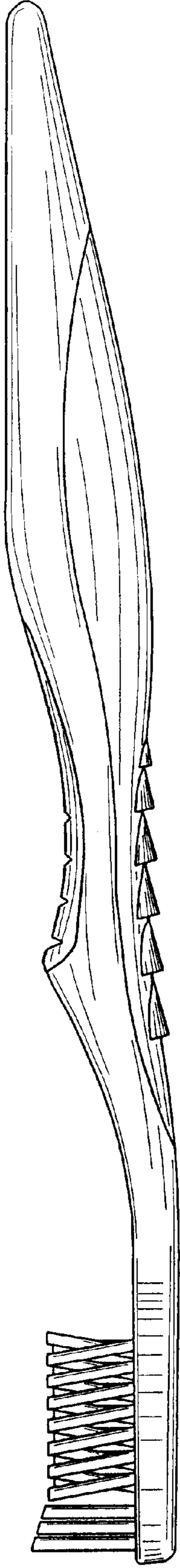

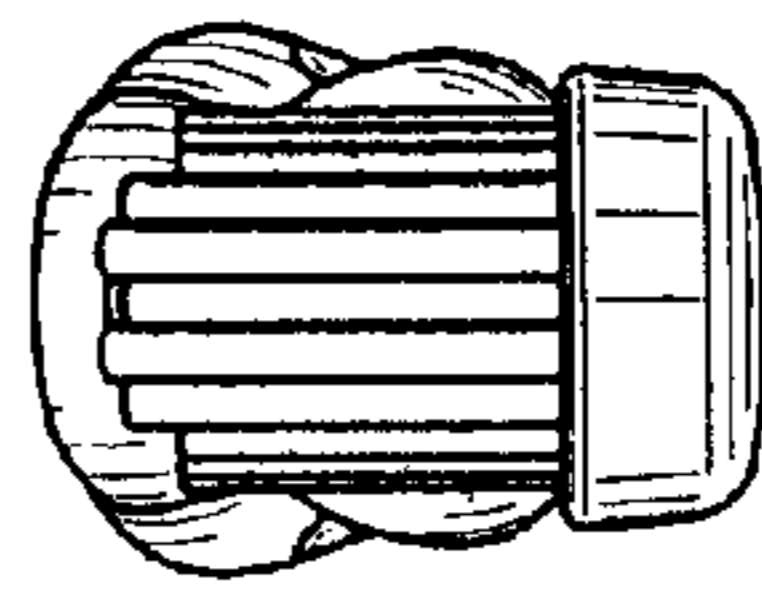

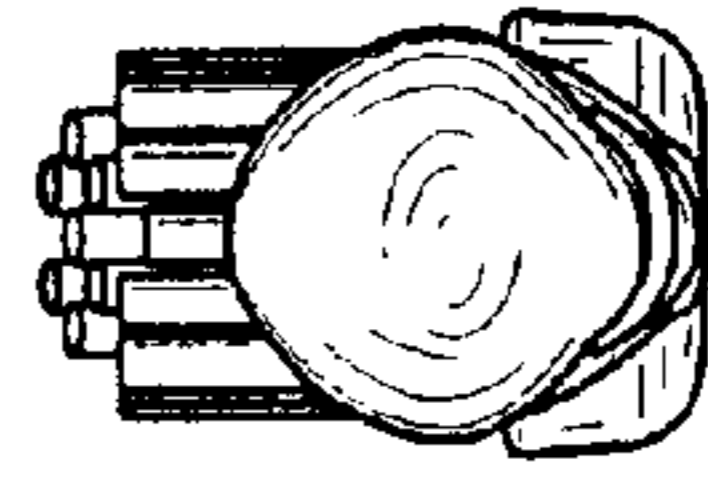

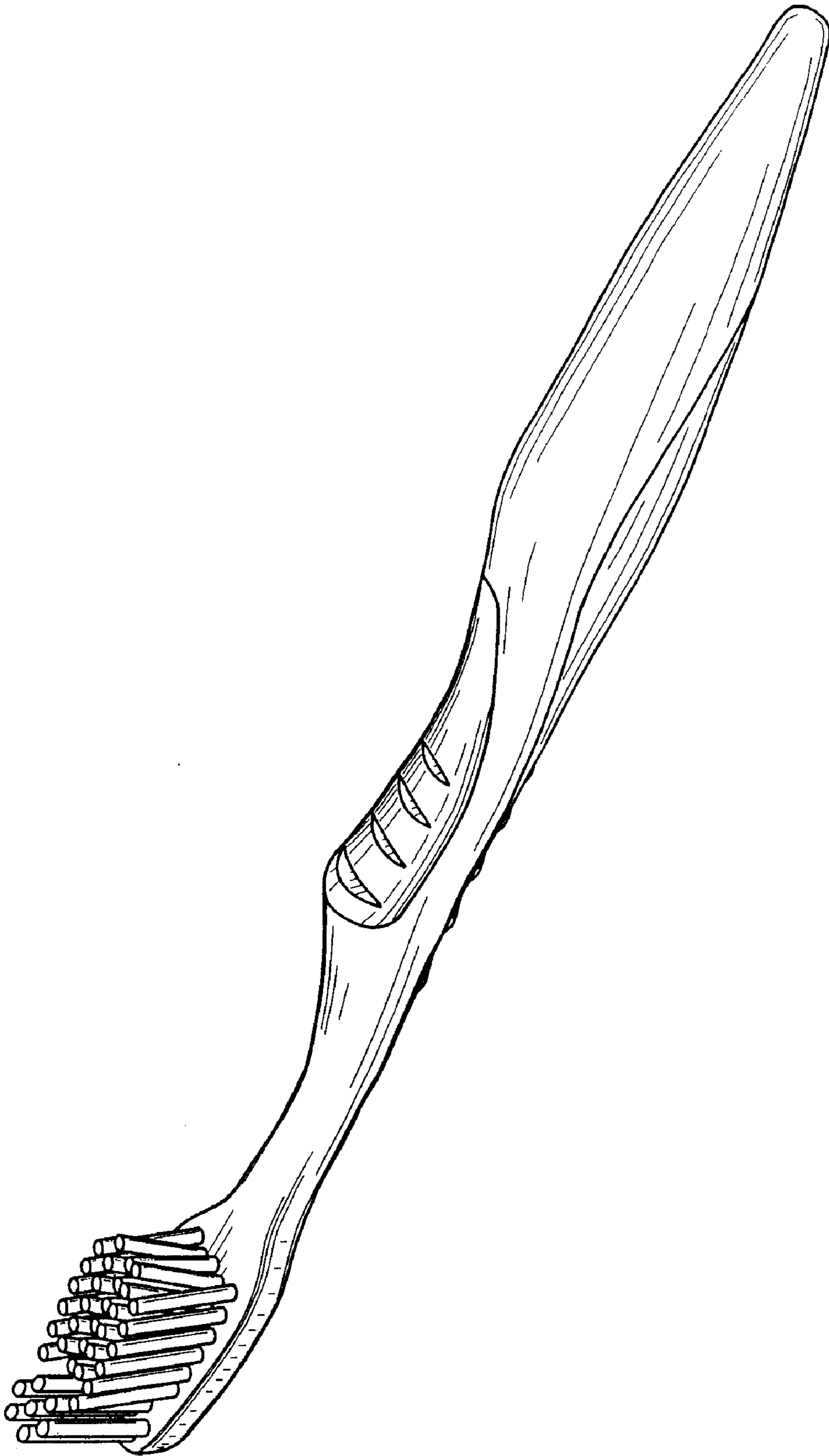

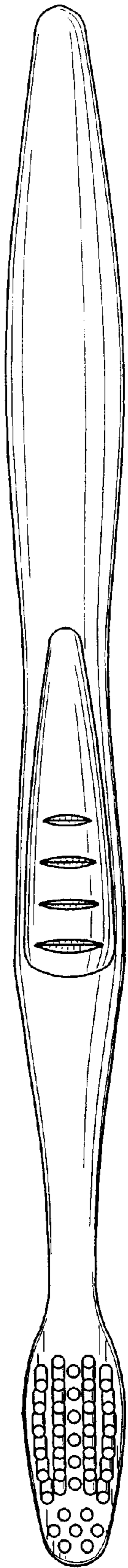

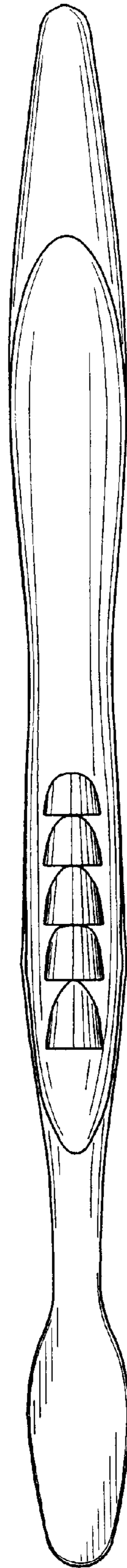

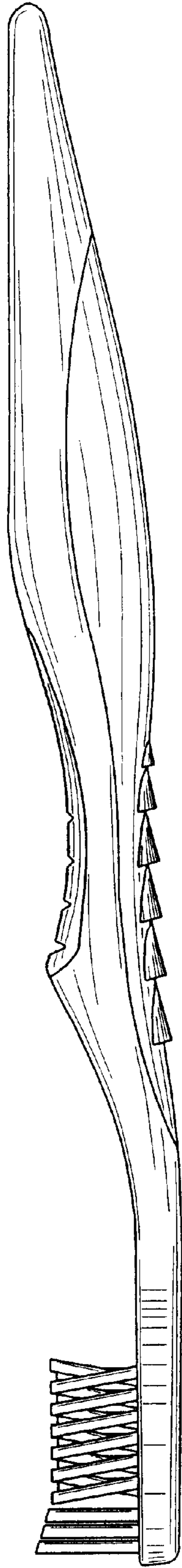

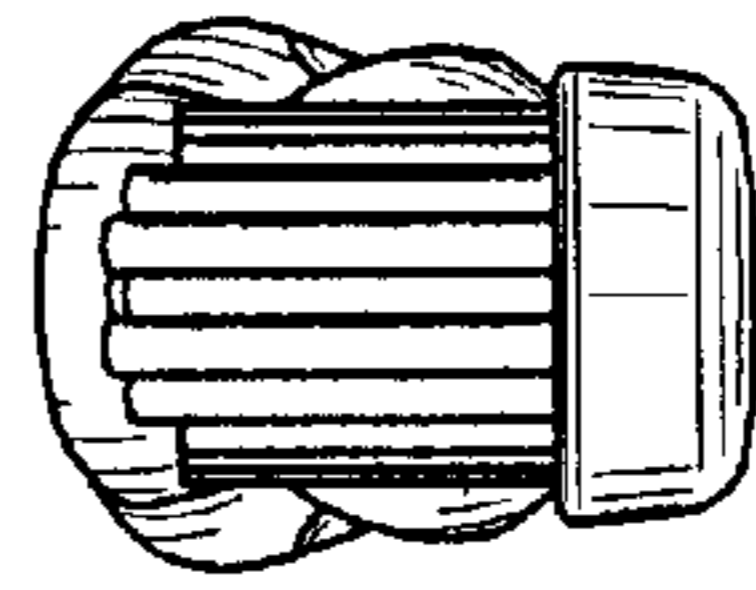

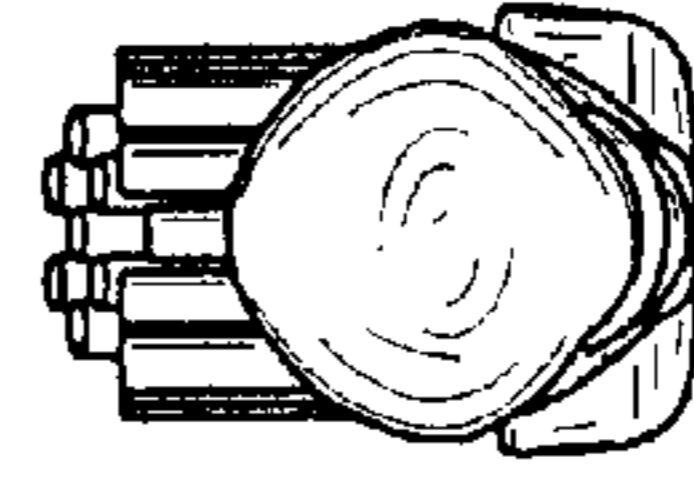

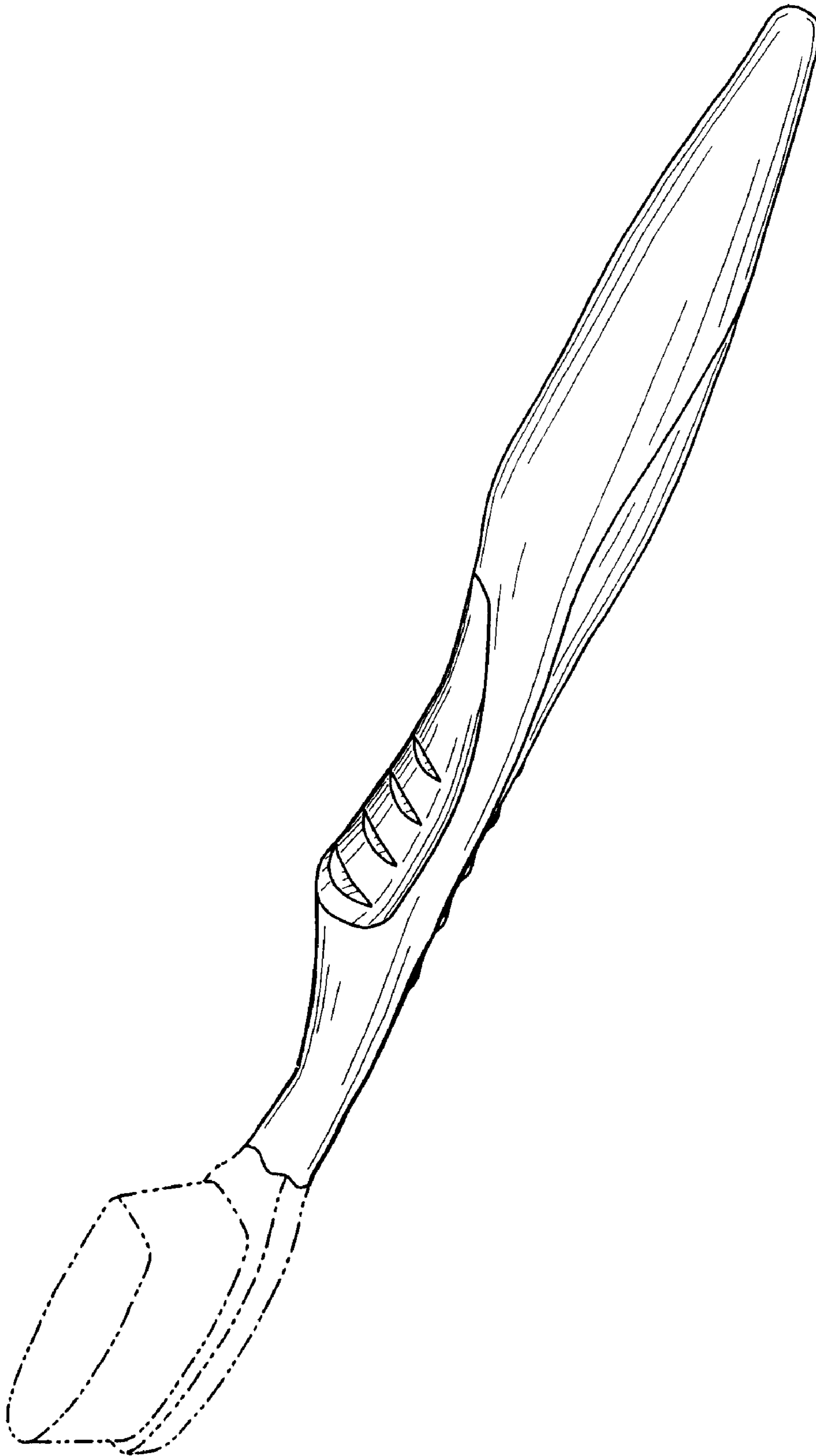

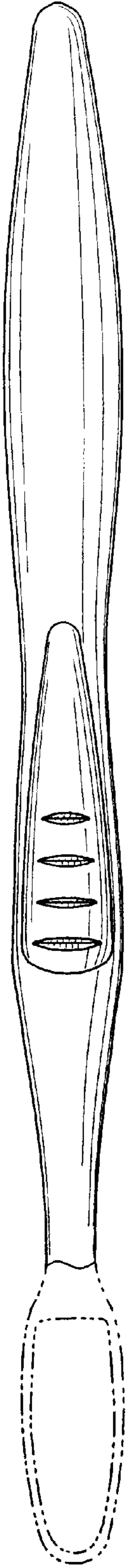

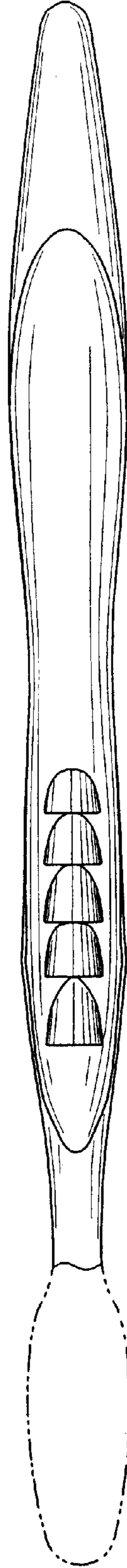

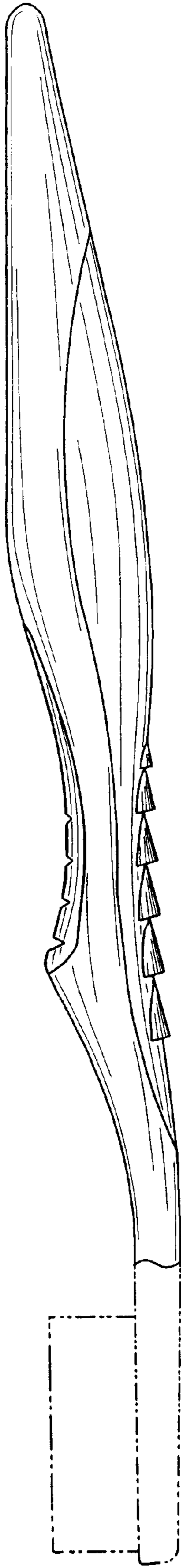

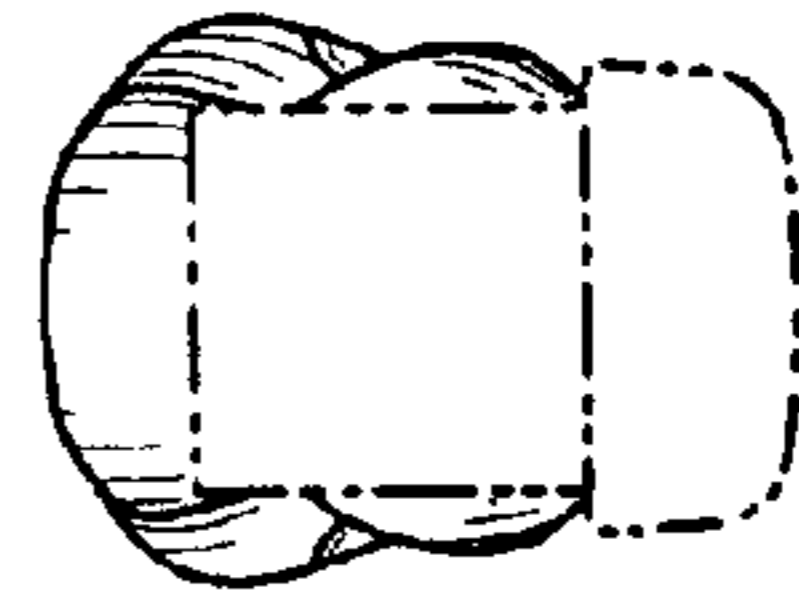

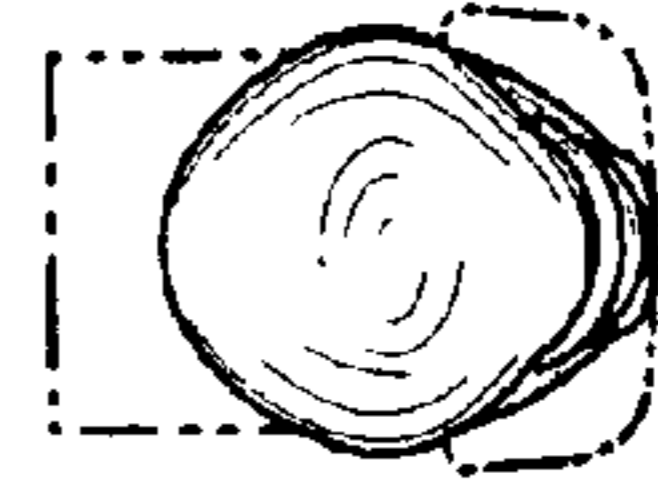
