(57) **CLAIM**

The ornamental design for a tool handle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation of a tool handle showing the new design;

FIG. 2 is an isometric view thereof;

FIG. 3 is a left end view thereof;

FIG. 4 is a right end view thereof;

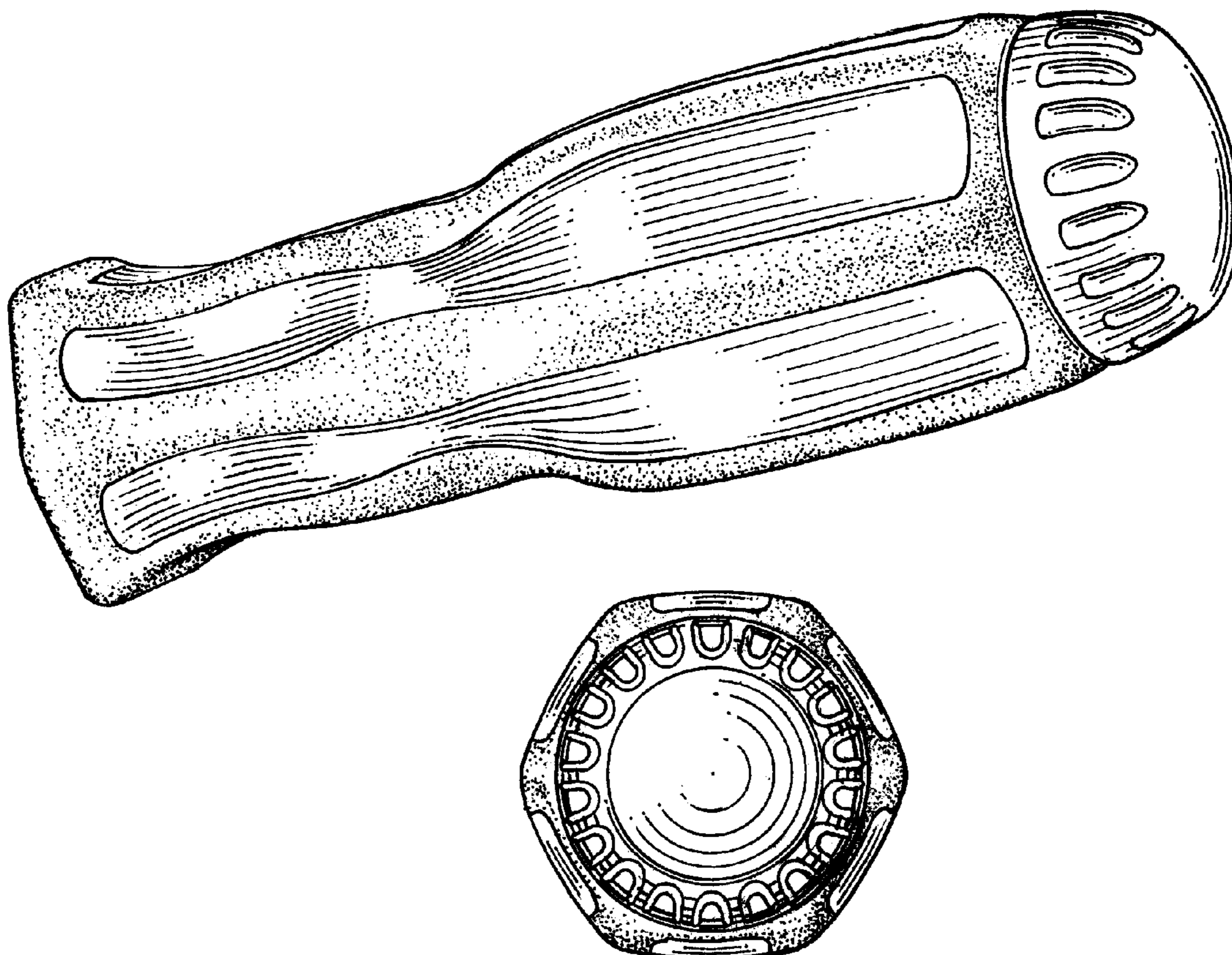
FIG. 5 is a side elevation thereof, as rotated by 90°;

FIG. 6 is an enlarged side elevation of the end cap portion of the tool handle of FIG. 1, the cap being shown separately for illustrative purposes only;

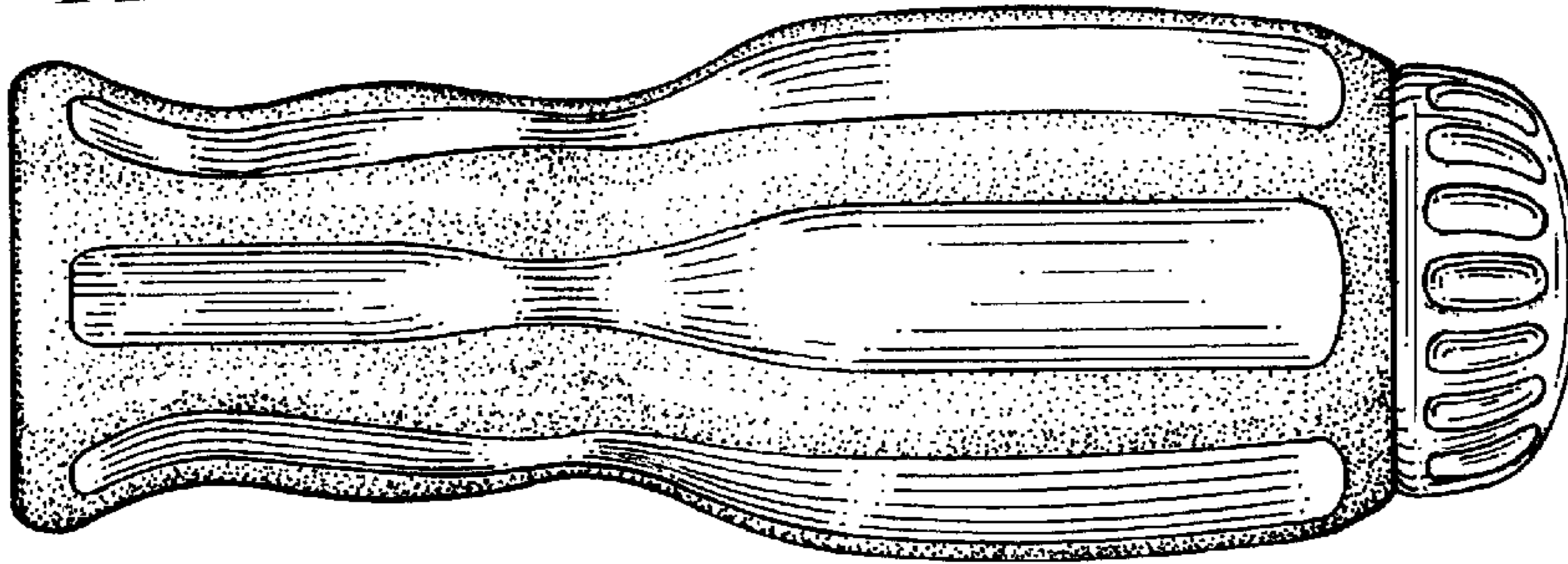
FIG. 7 is an end view of the cap of FIG. 6; and,

FIG. 8 is an opposite end view of the cap of FIG. 6.

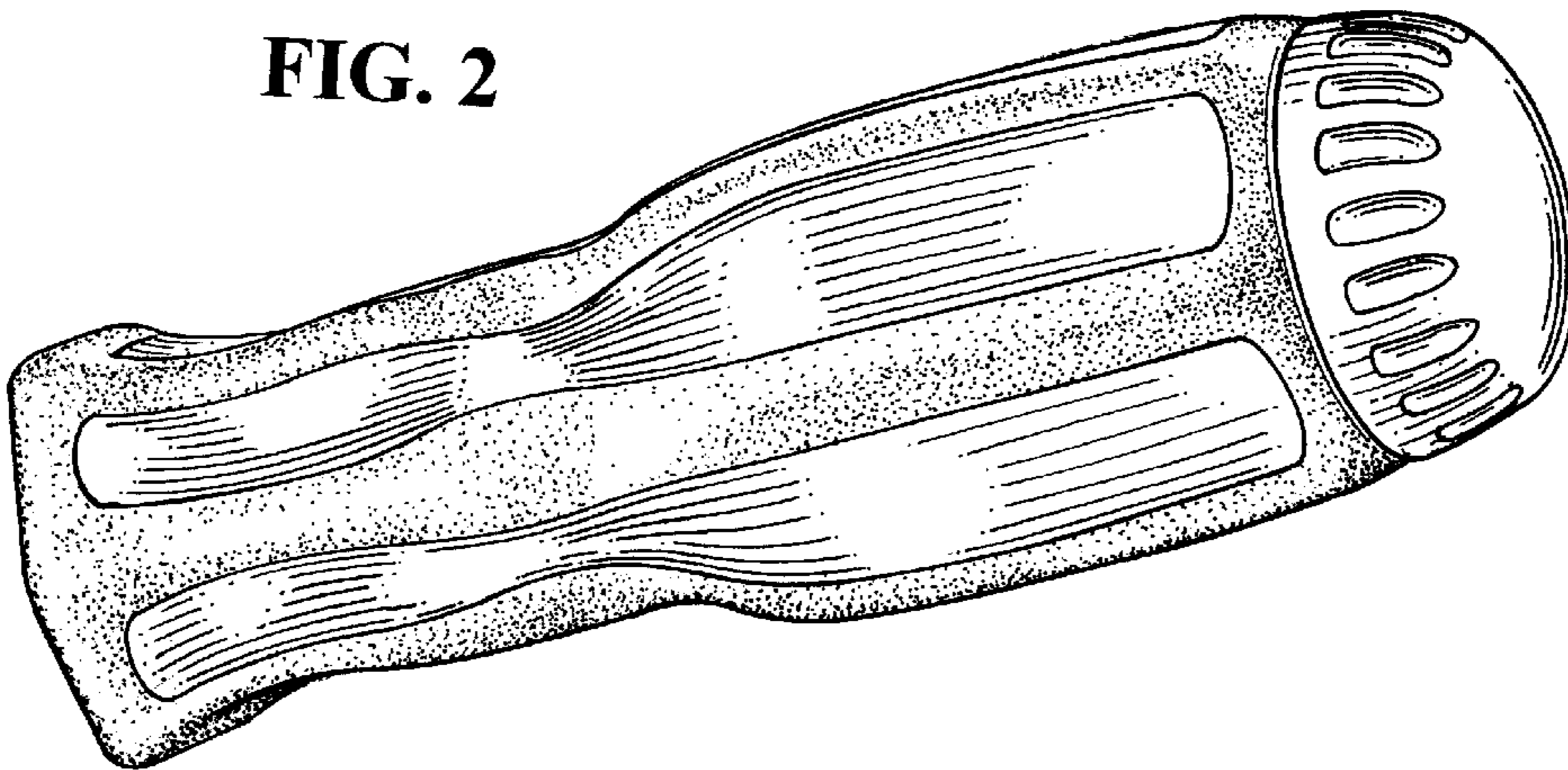

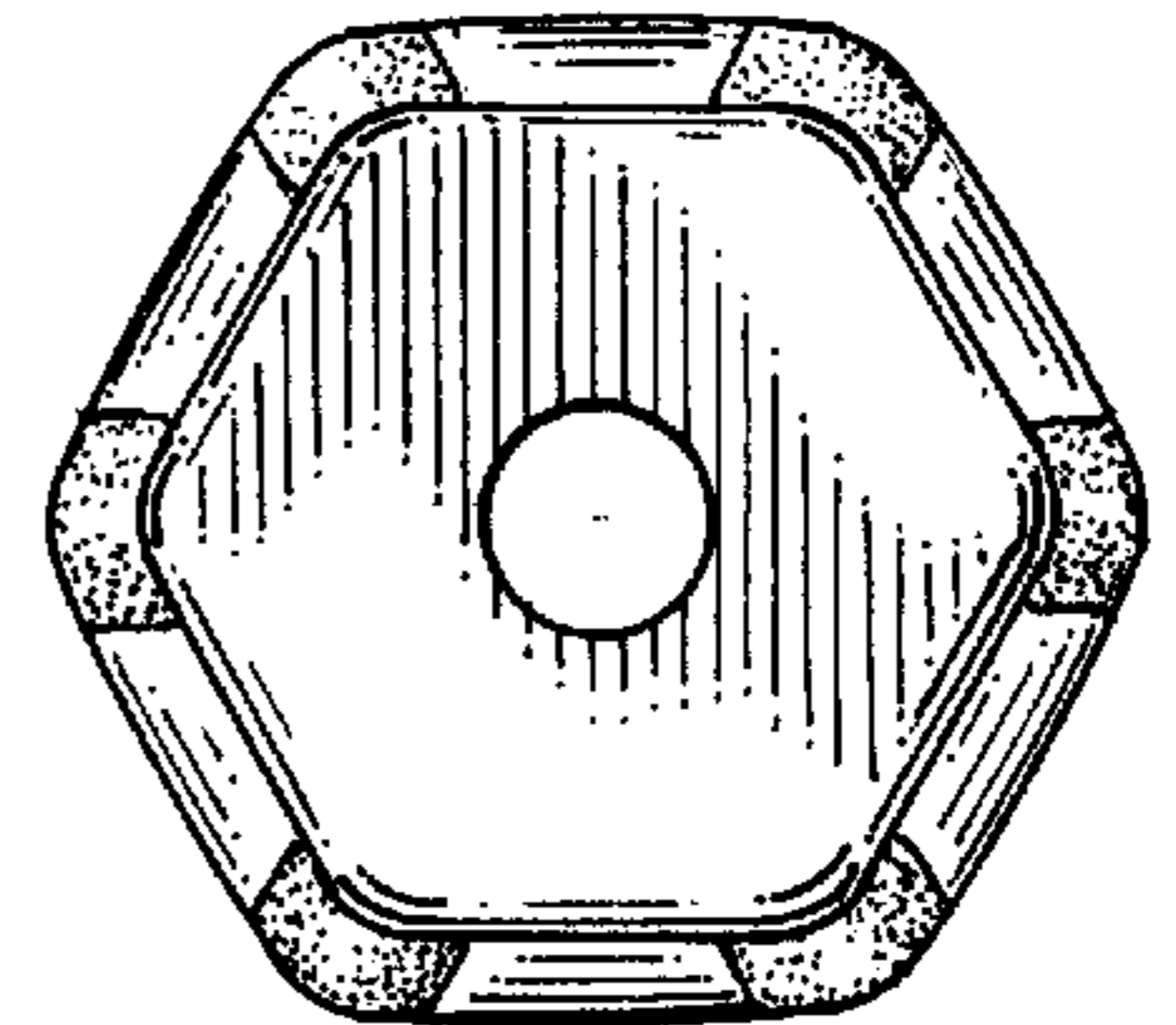

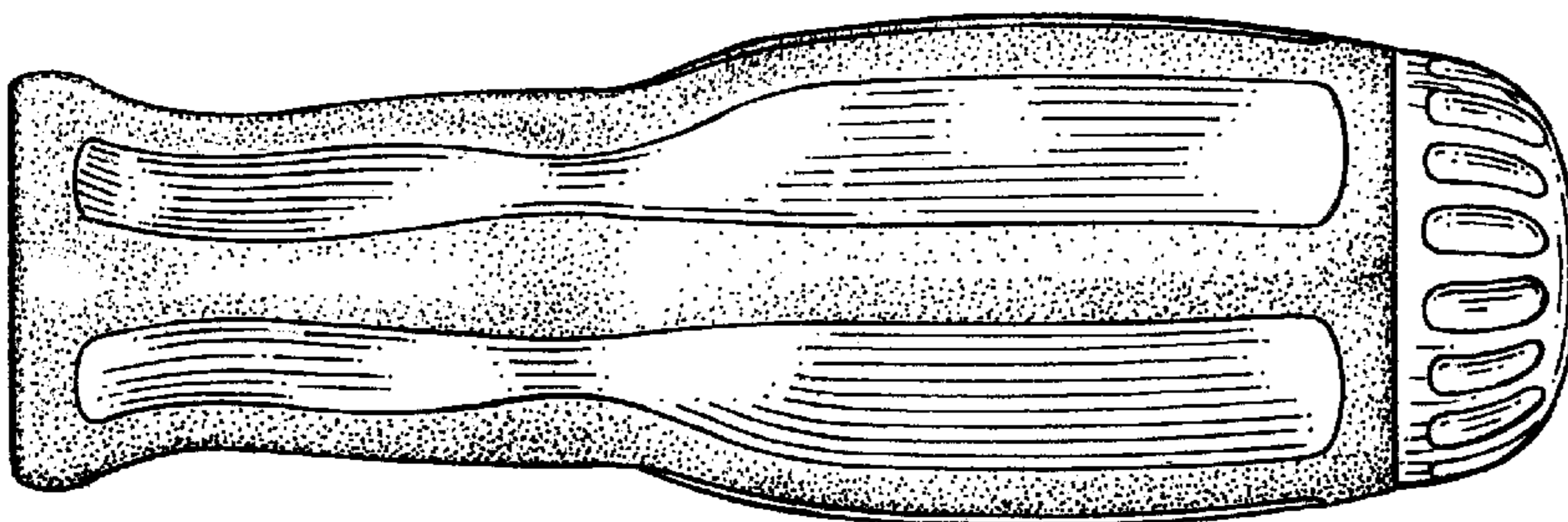

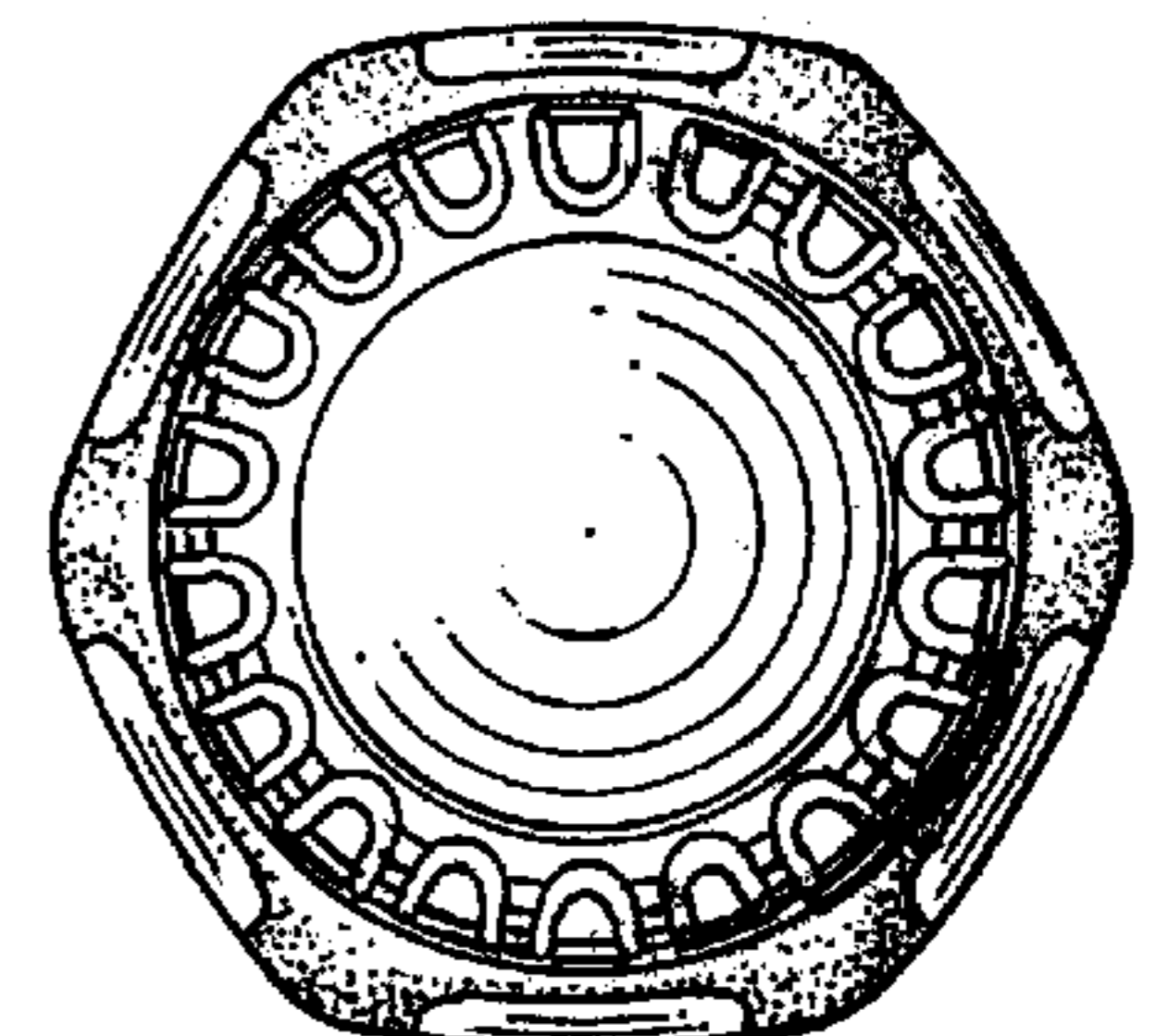

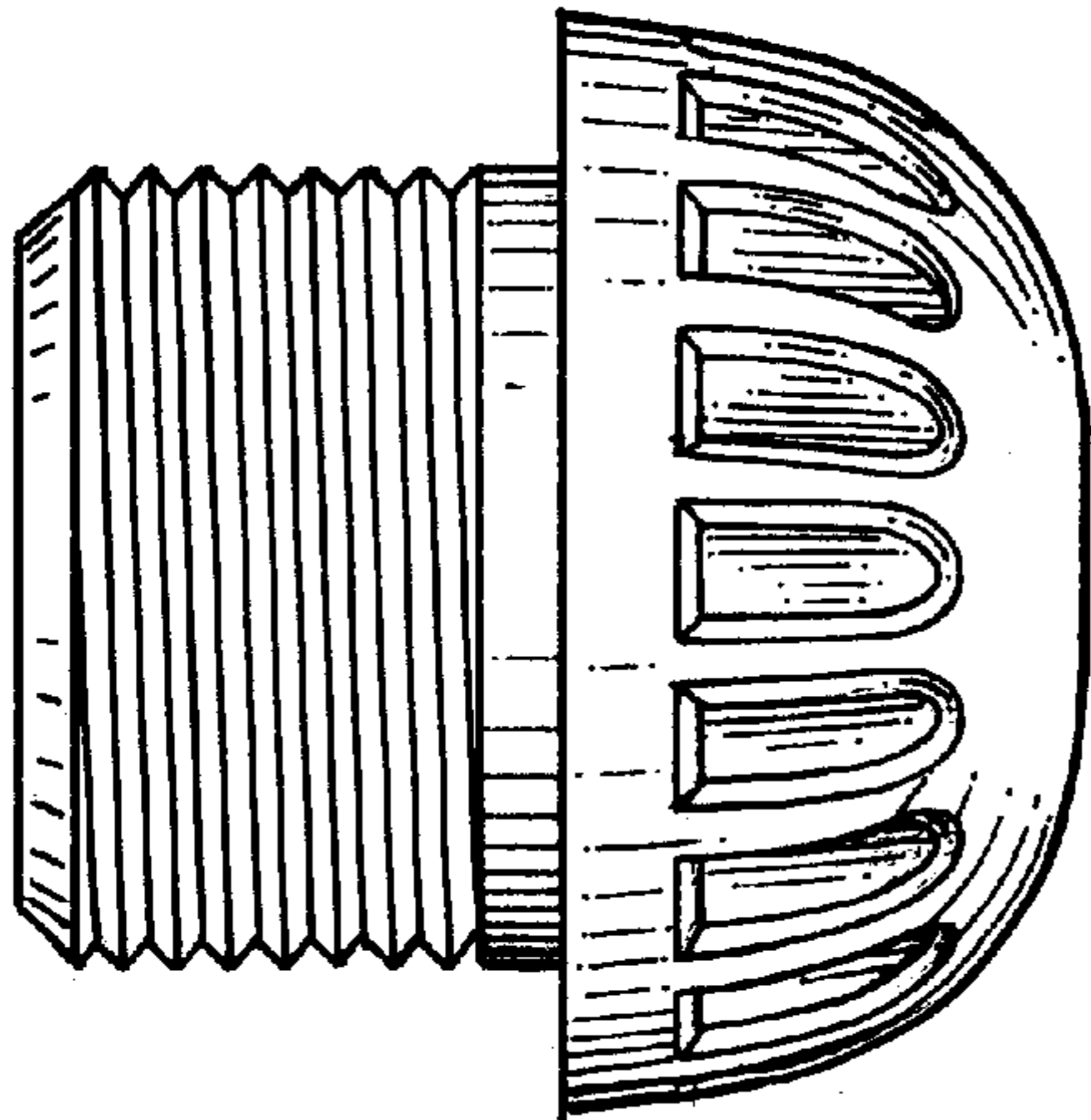

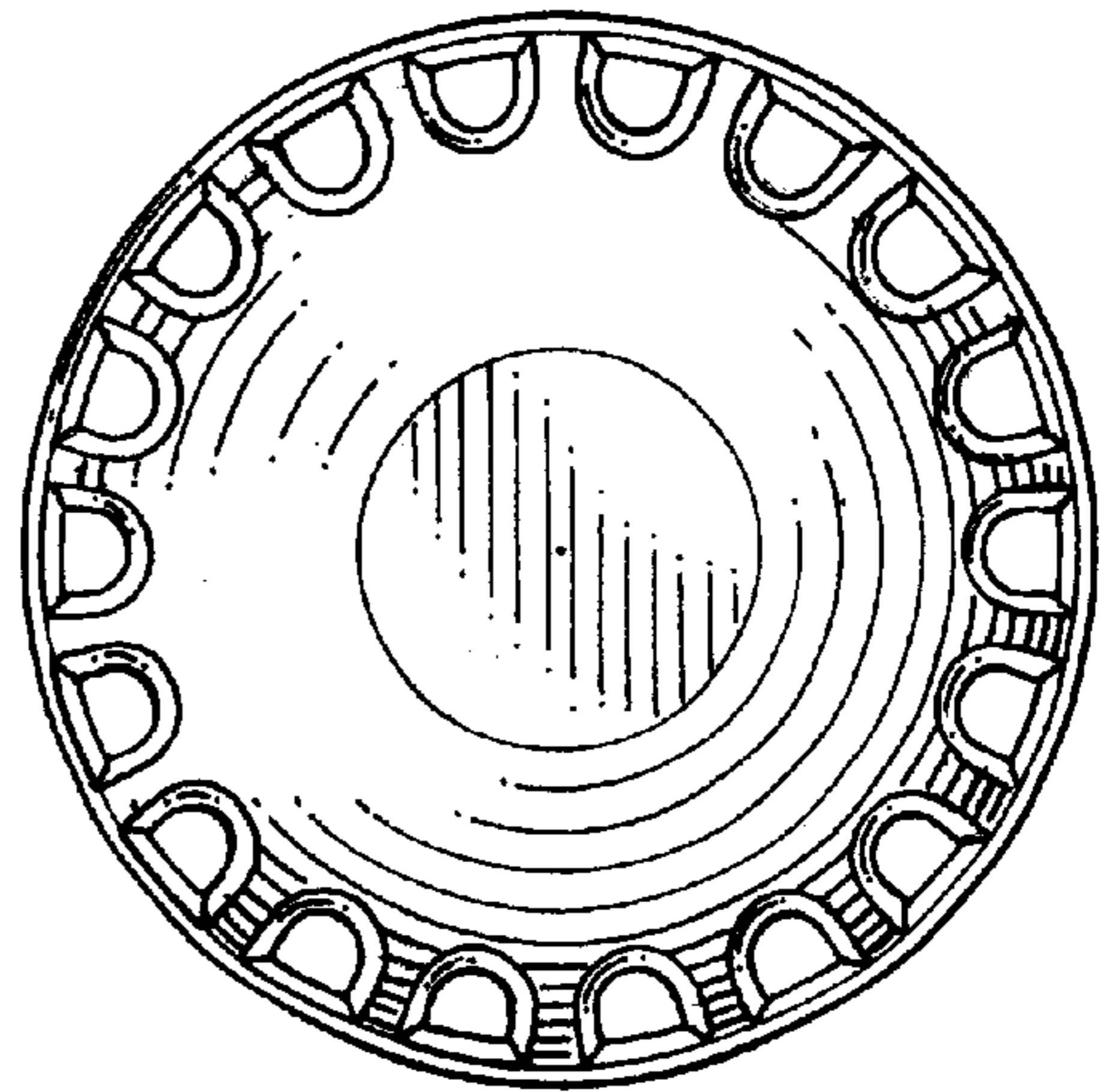
