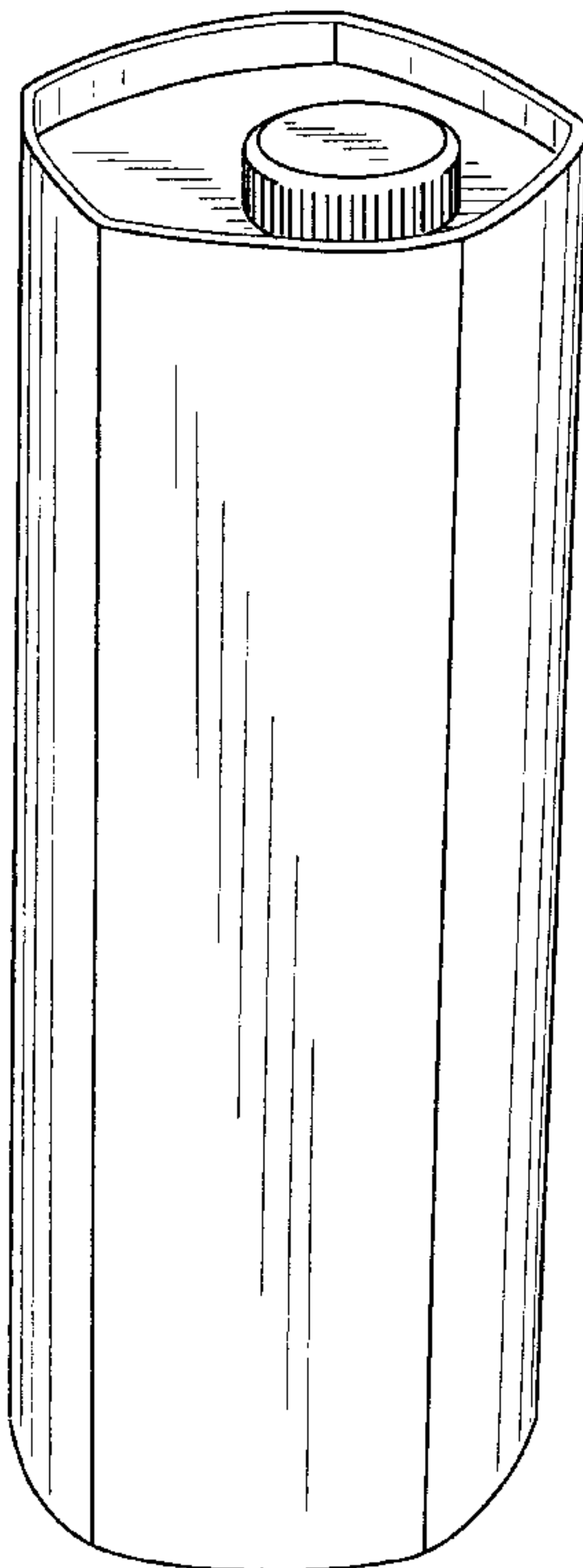
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a beverage package in accordance with the present invention;
 FIG. 2 is a side view of the beverage package shown in FIG. 1;
 FIG. 3 is a front view of the beverage package shown in FIG. 1;
 FIG. 4 is another side view of the beverage package shown in FIG. 1;
 FIG. 5 is a back view of the beverage package shown in FIG. 1;

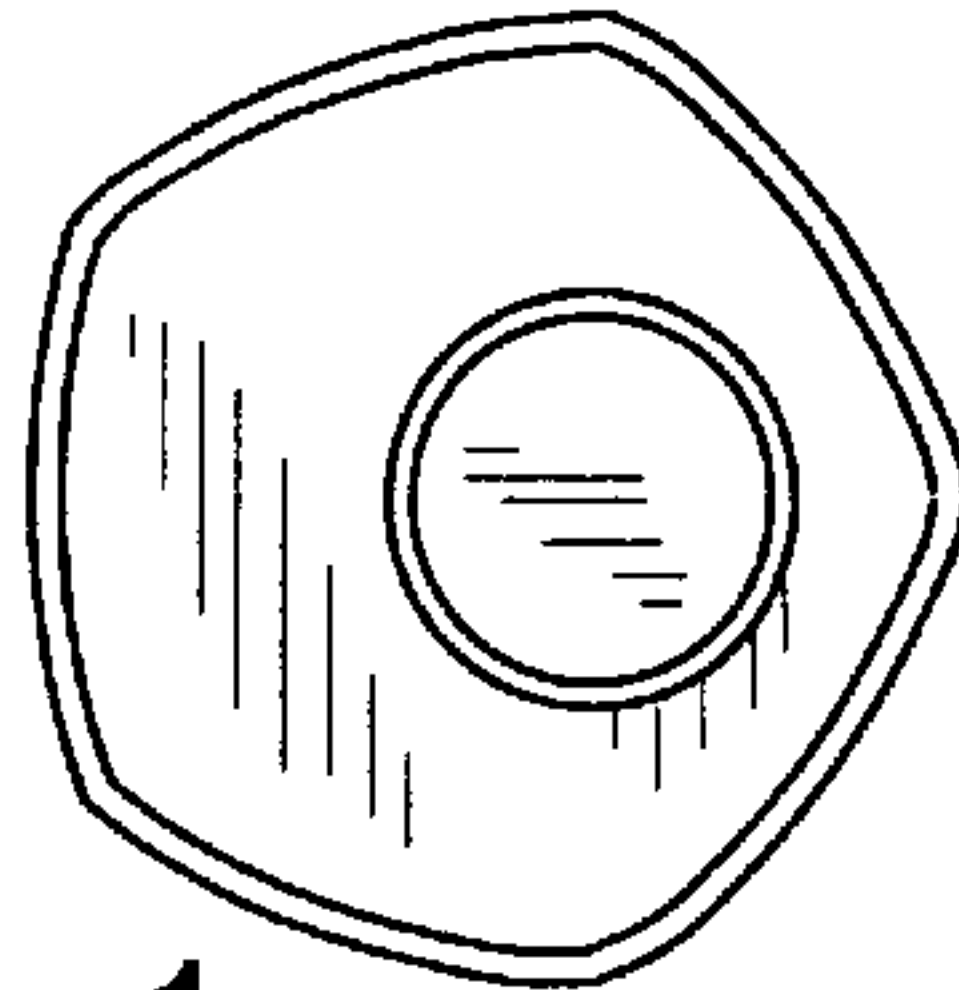

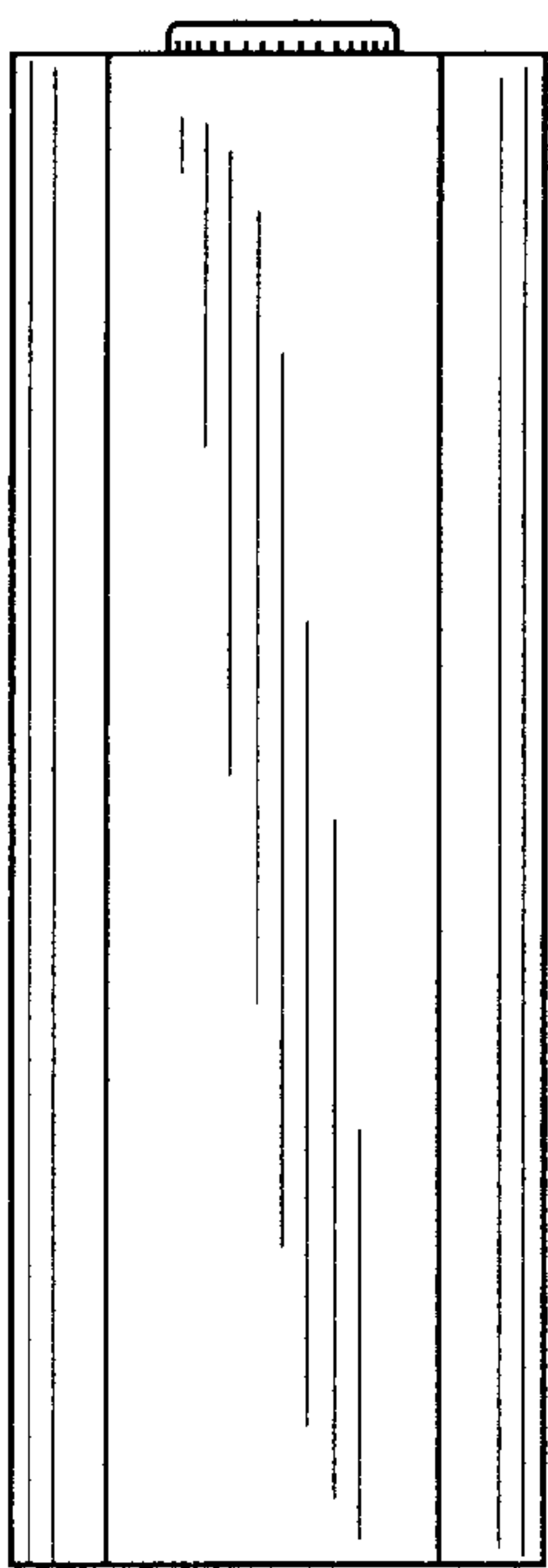

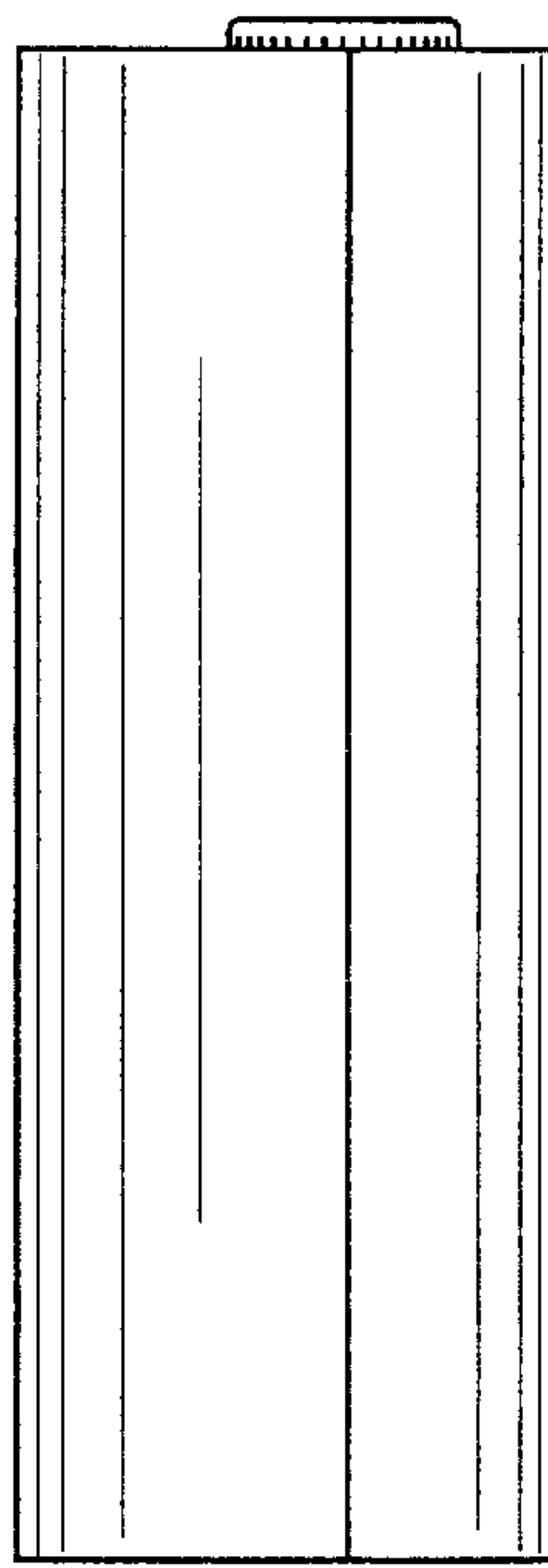

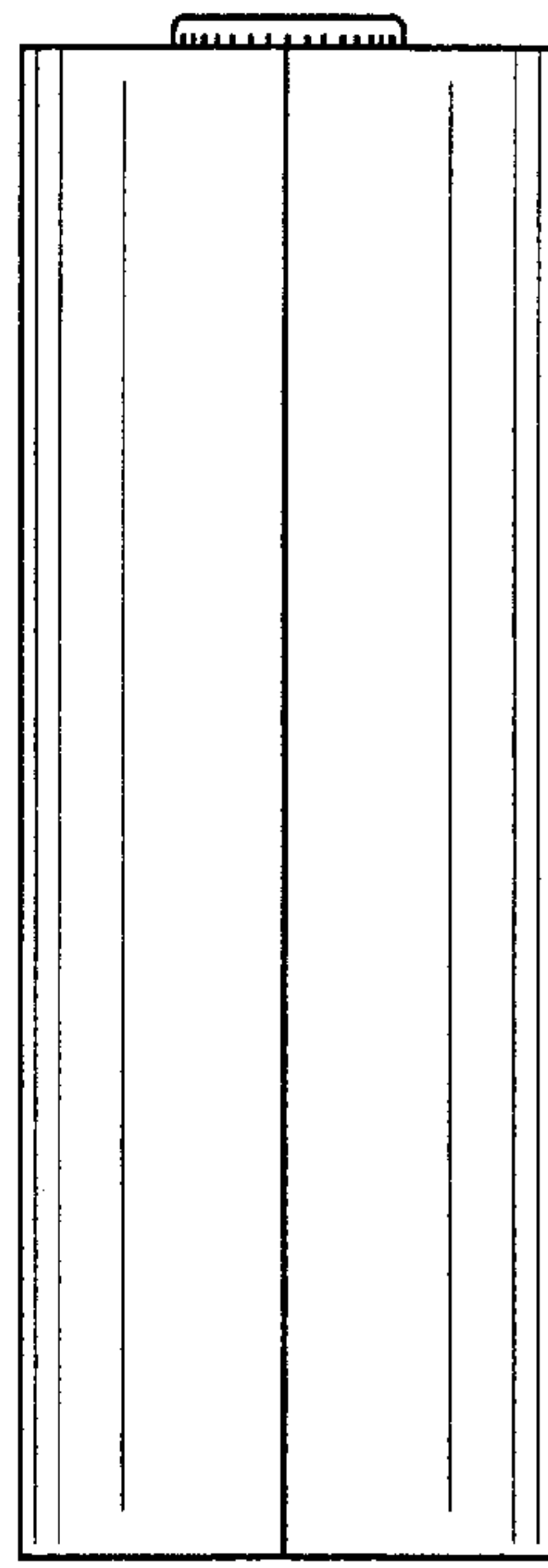

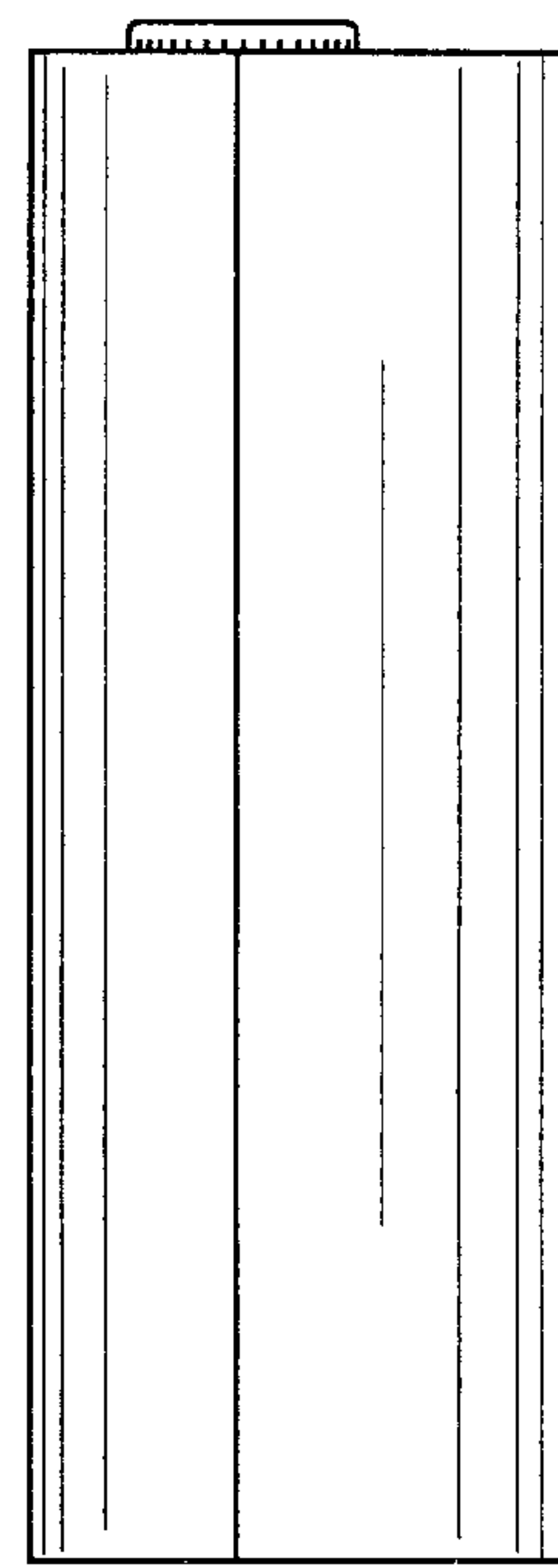

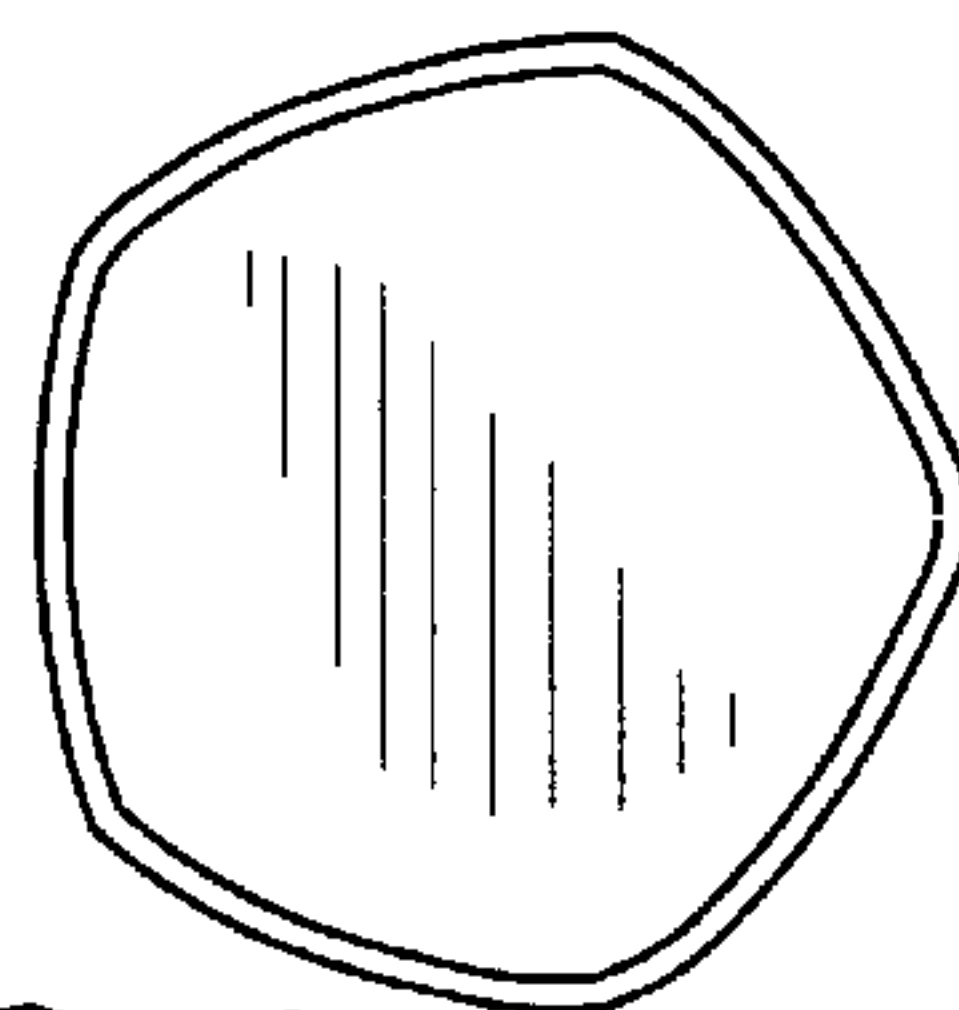

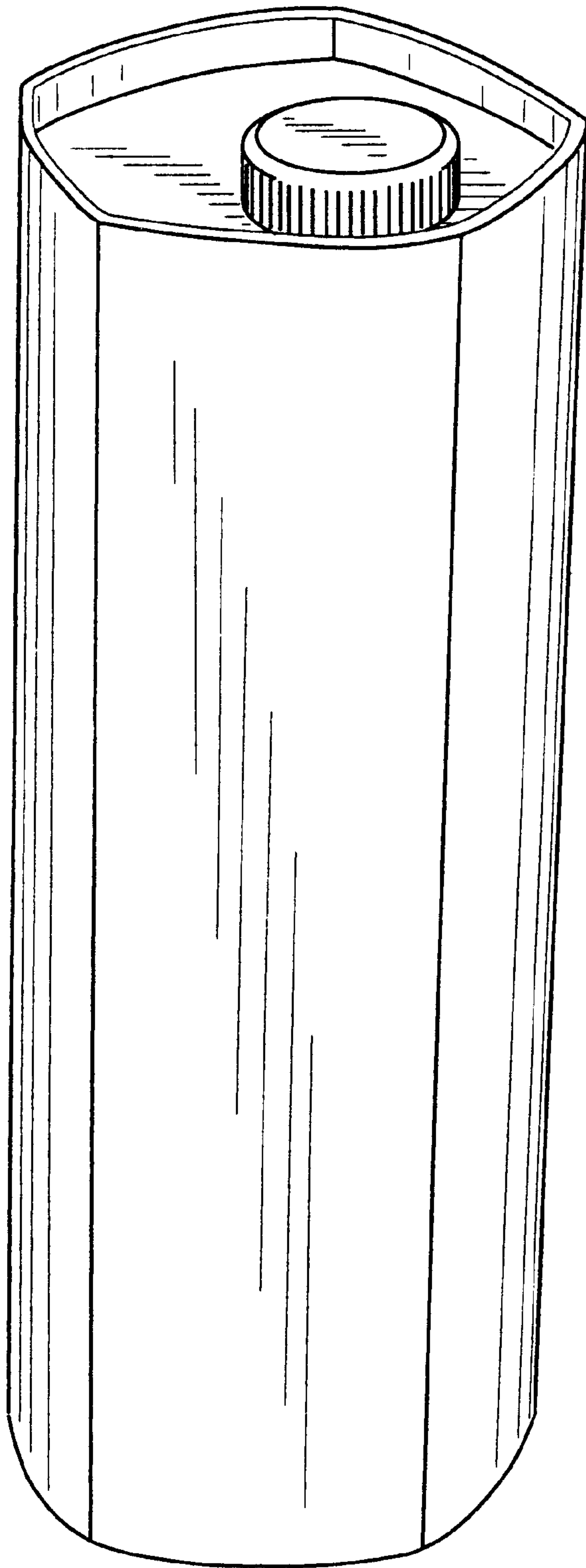
