The ornamental design for package, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a package according to the new design;
FIG. 2 is a right front perspective view thereof from a higher elevation than shown in FIG. 1;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a top plan view thereof
FIG. 5 is a back elevation view thereof; and,
FIG. 6 is a sectional view taken along line 6—6 of FIG 4.

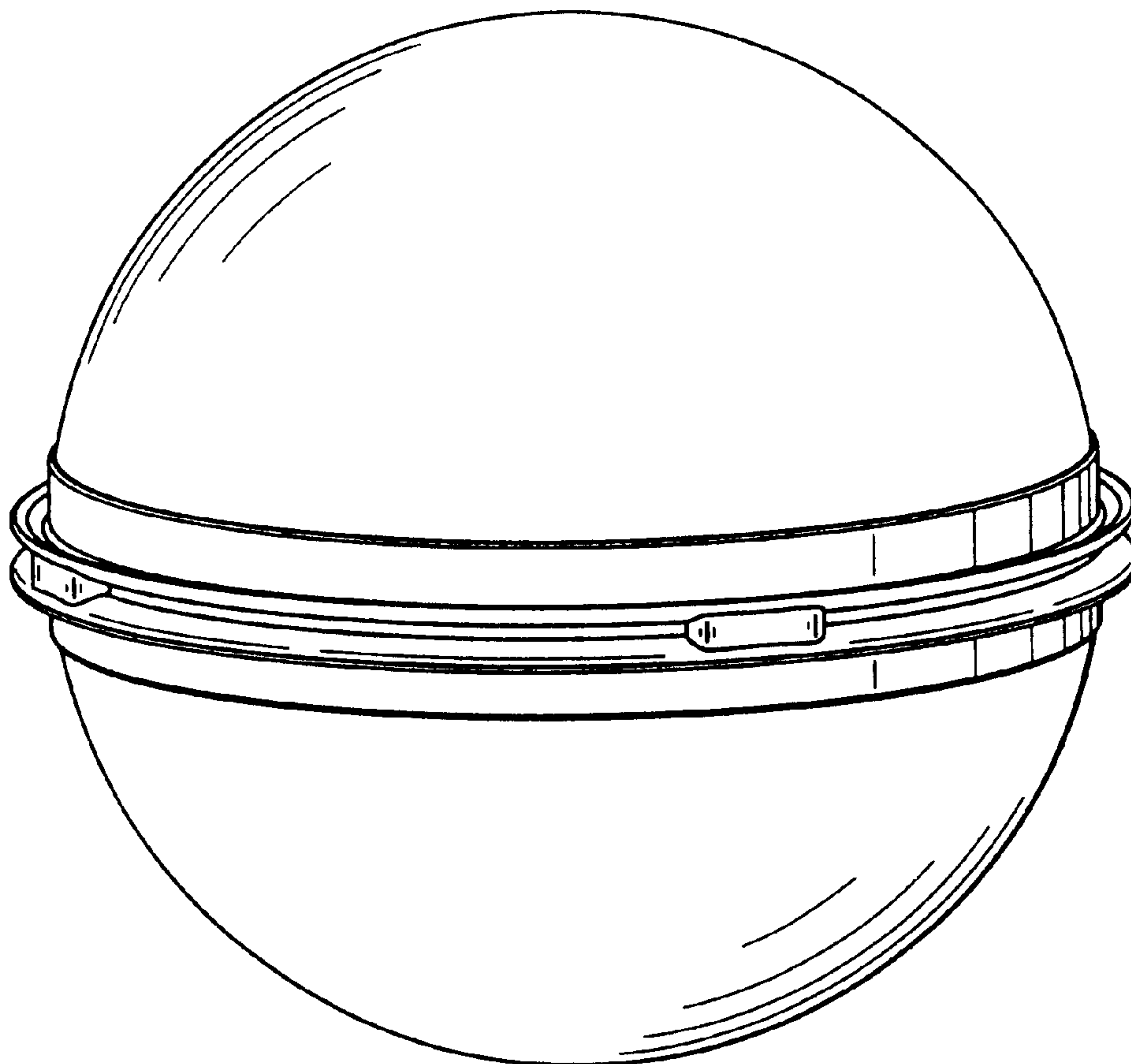

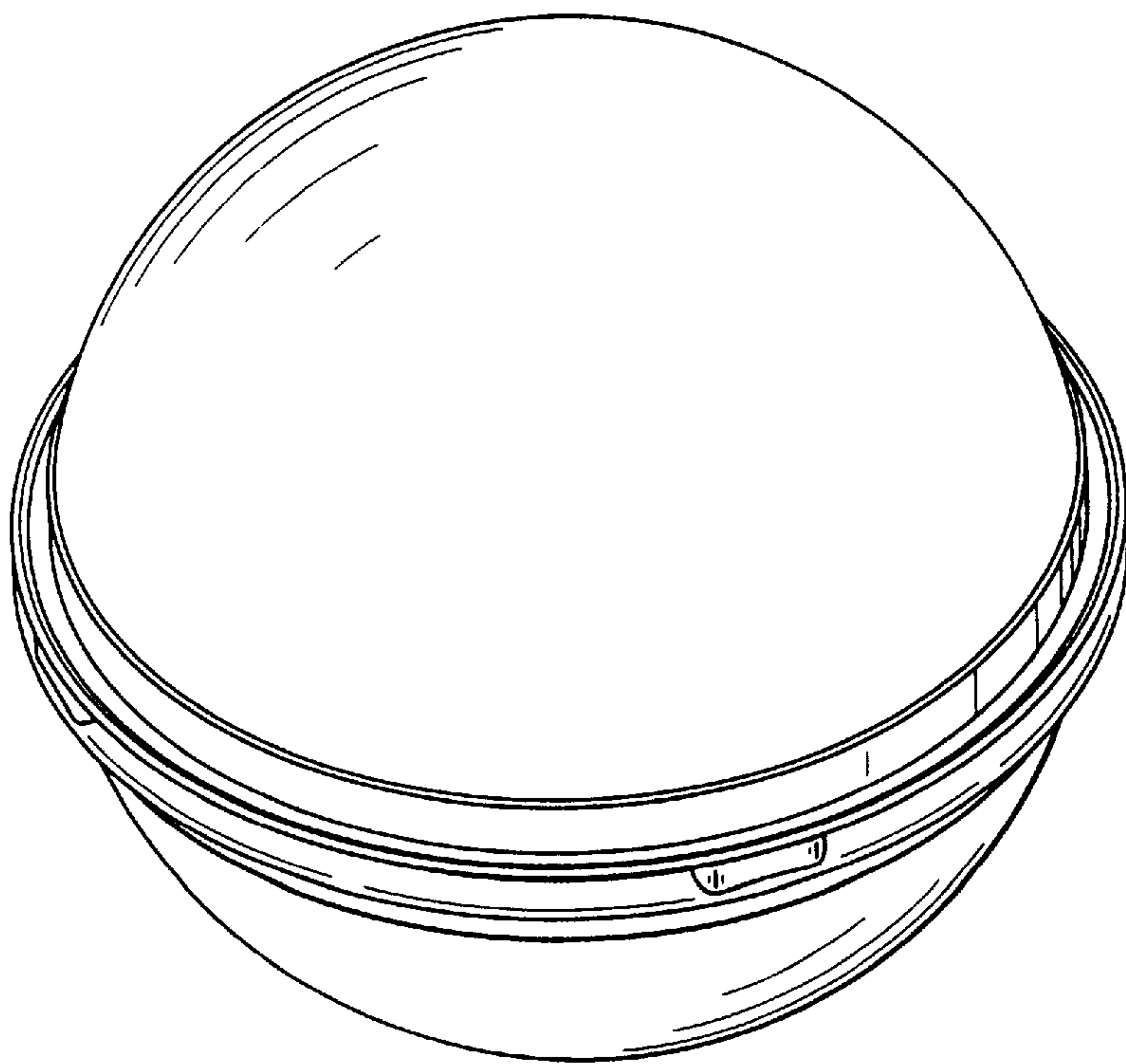
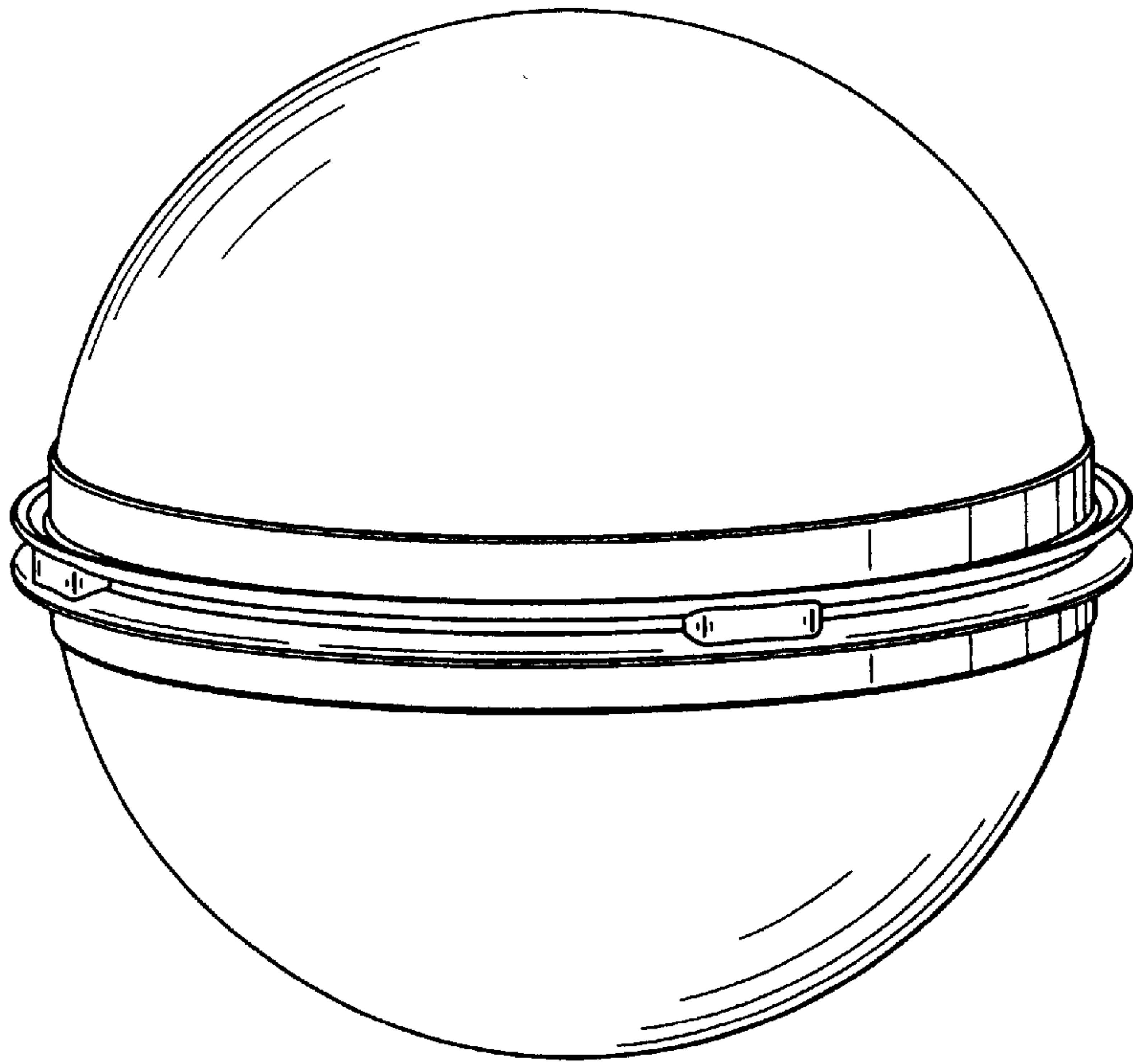

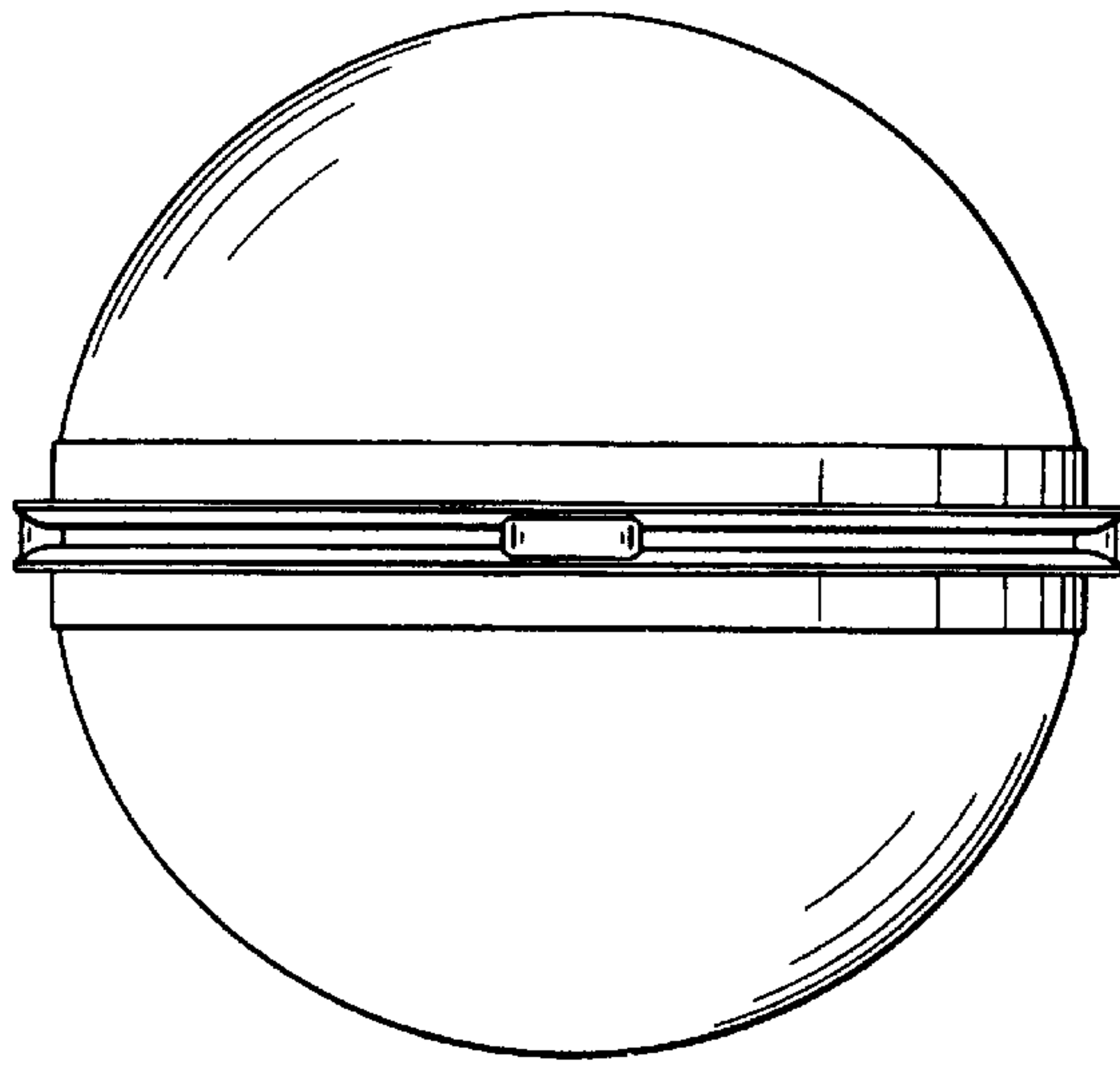

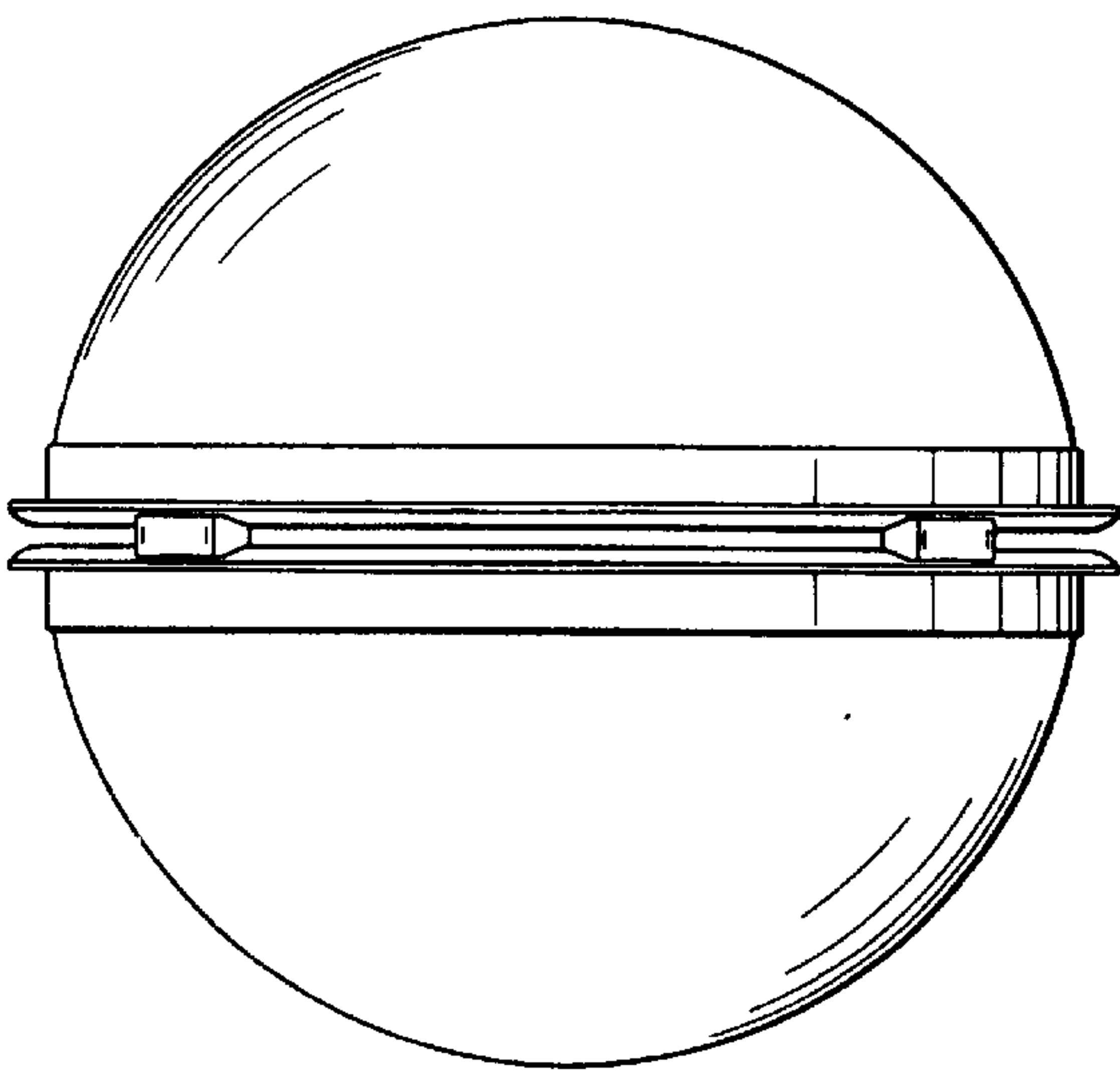
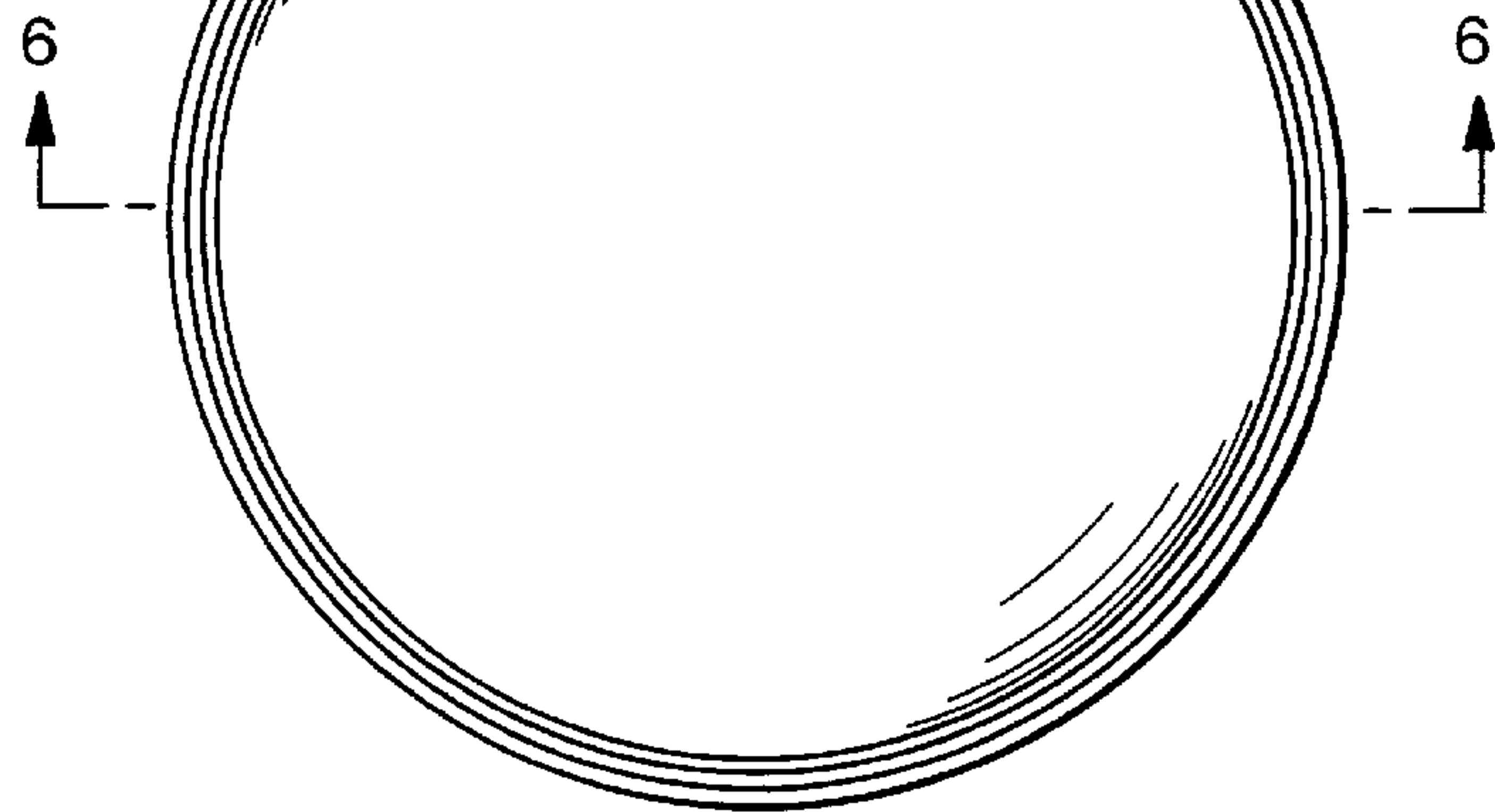
