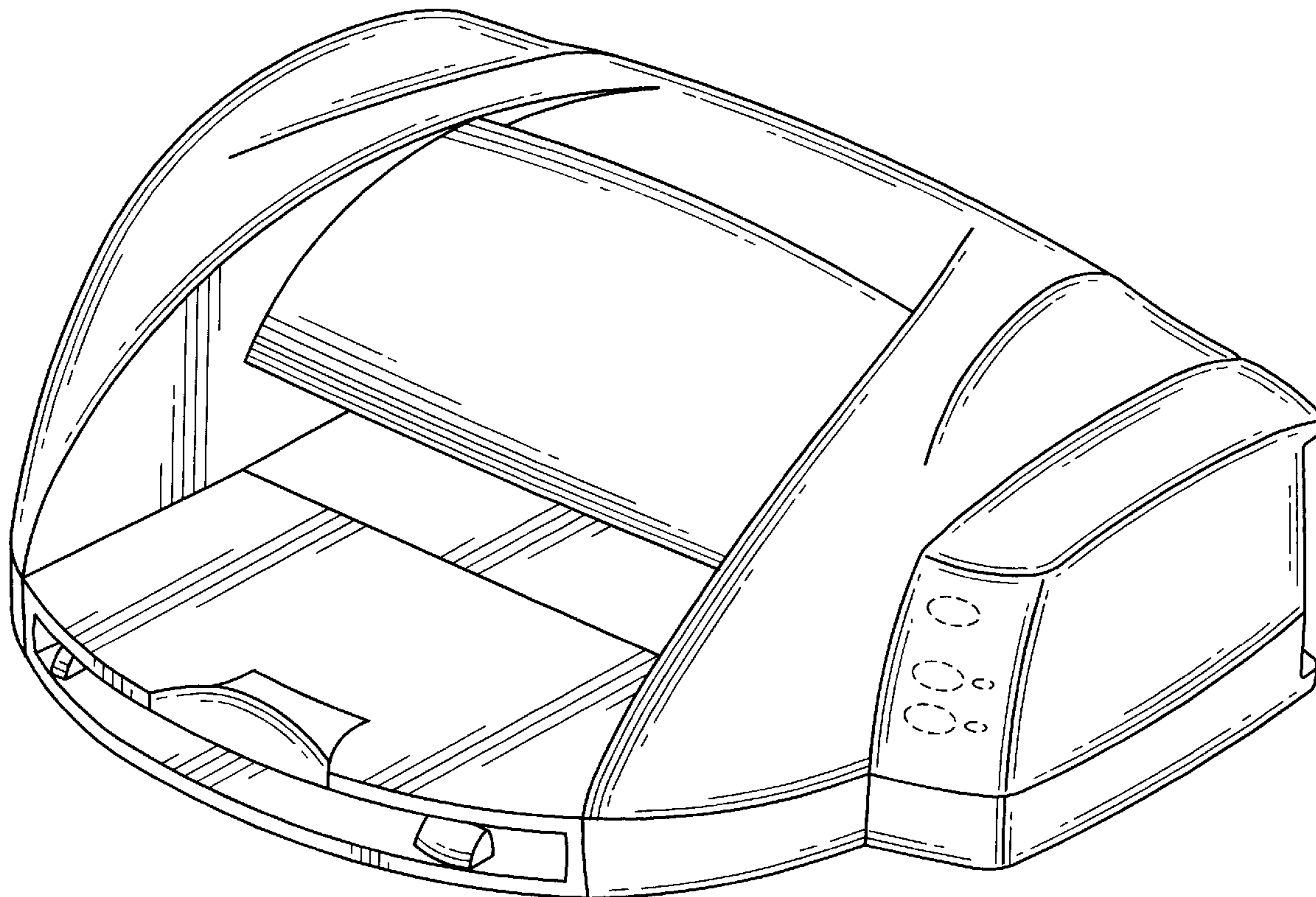
An ornamental design for an inkjet printer, substantially as shown and described.

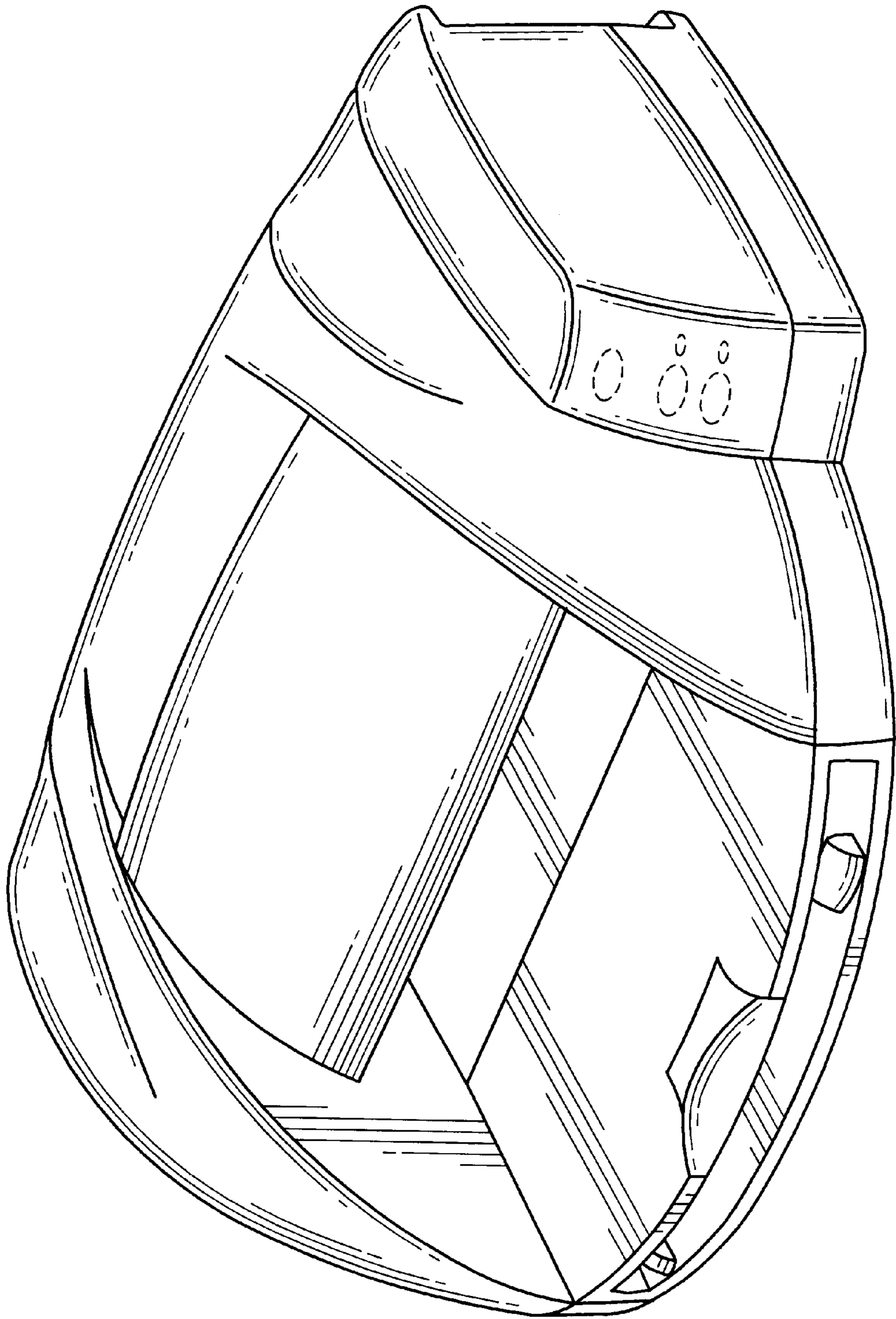

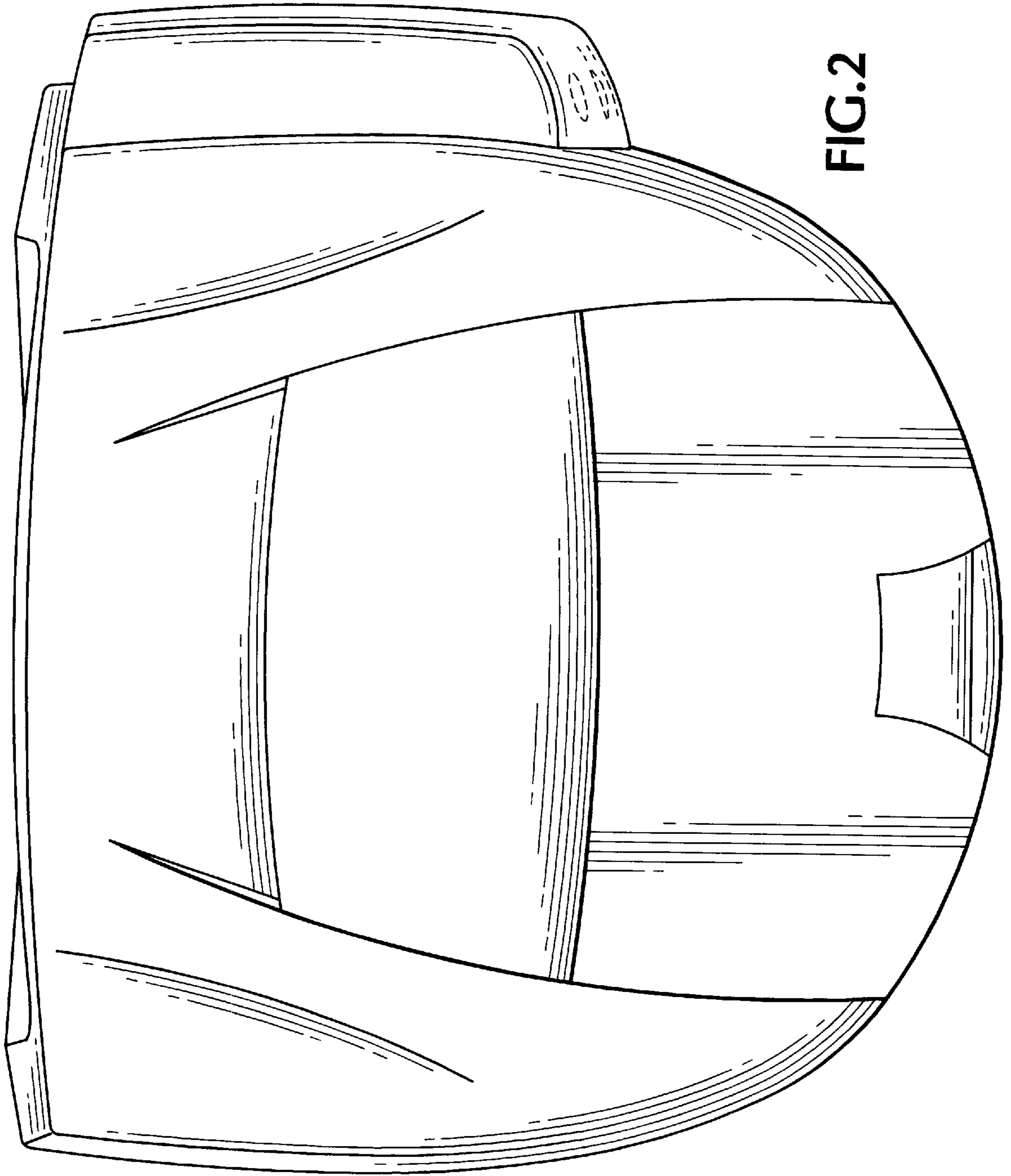

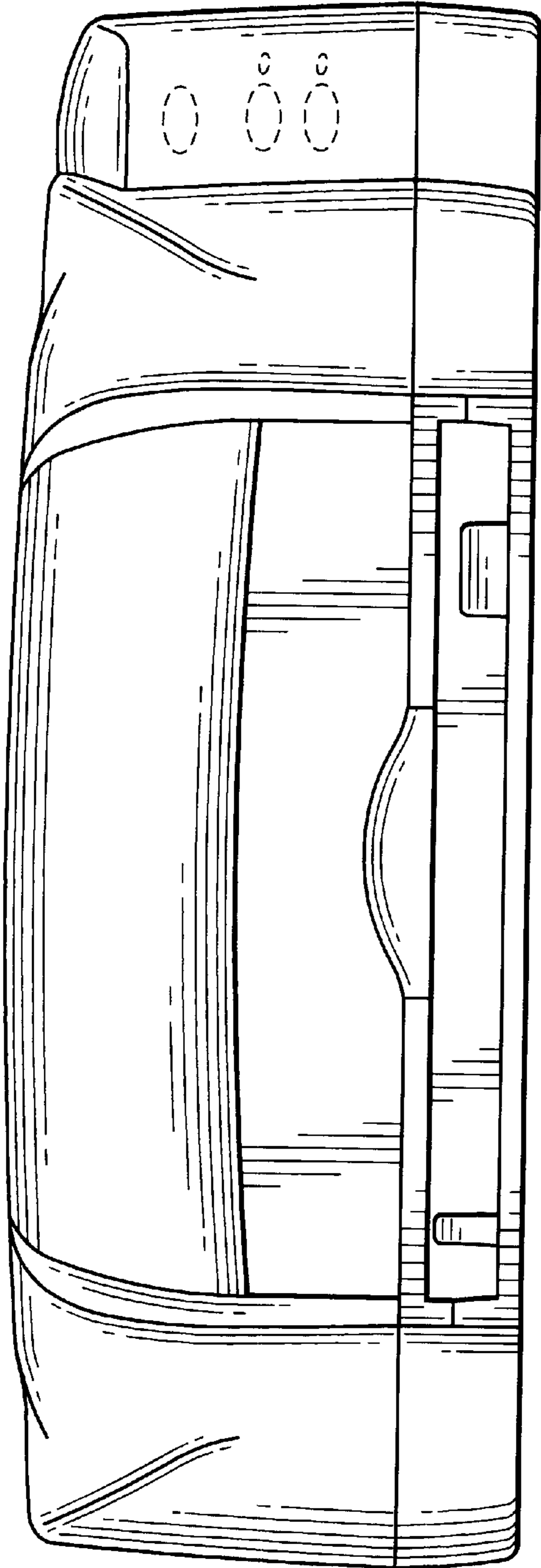

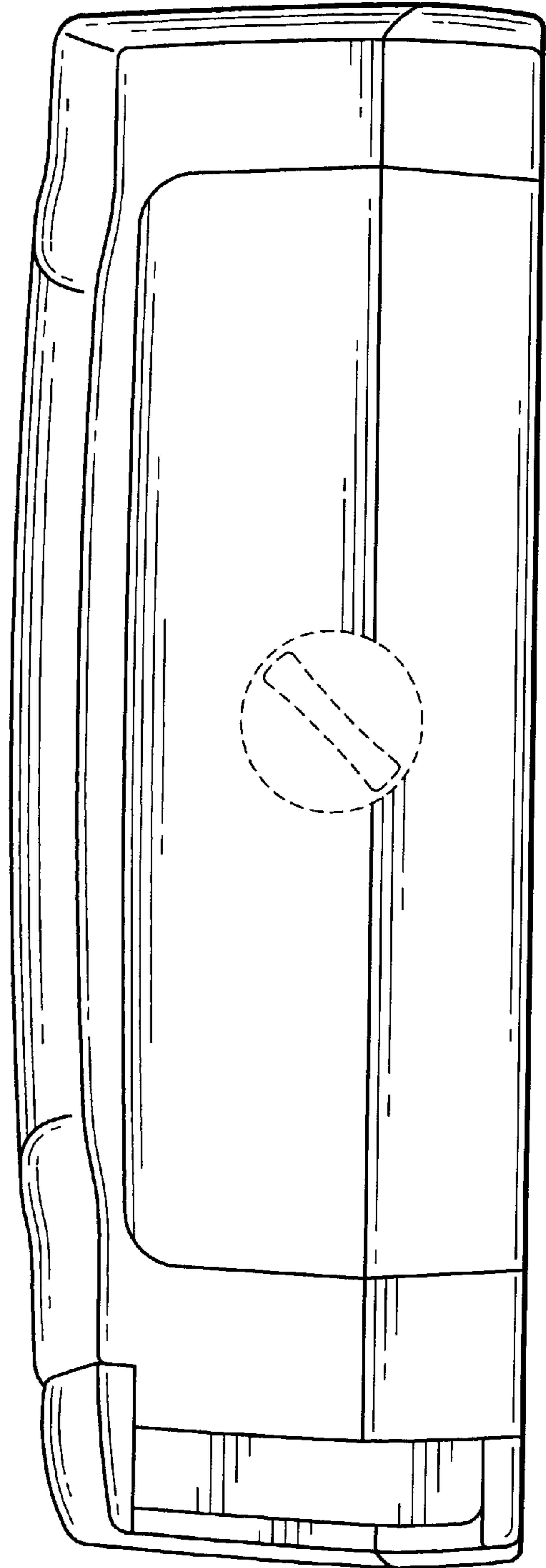

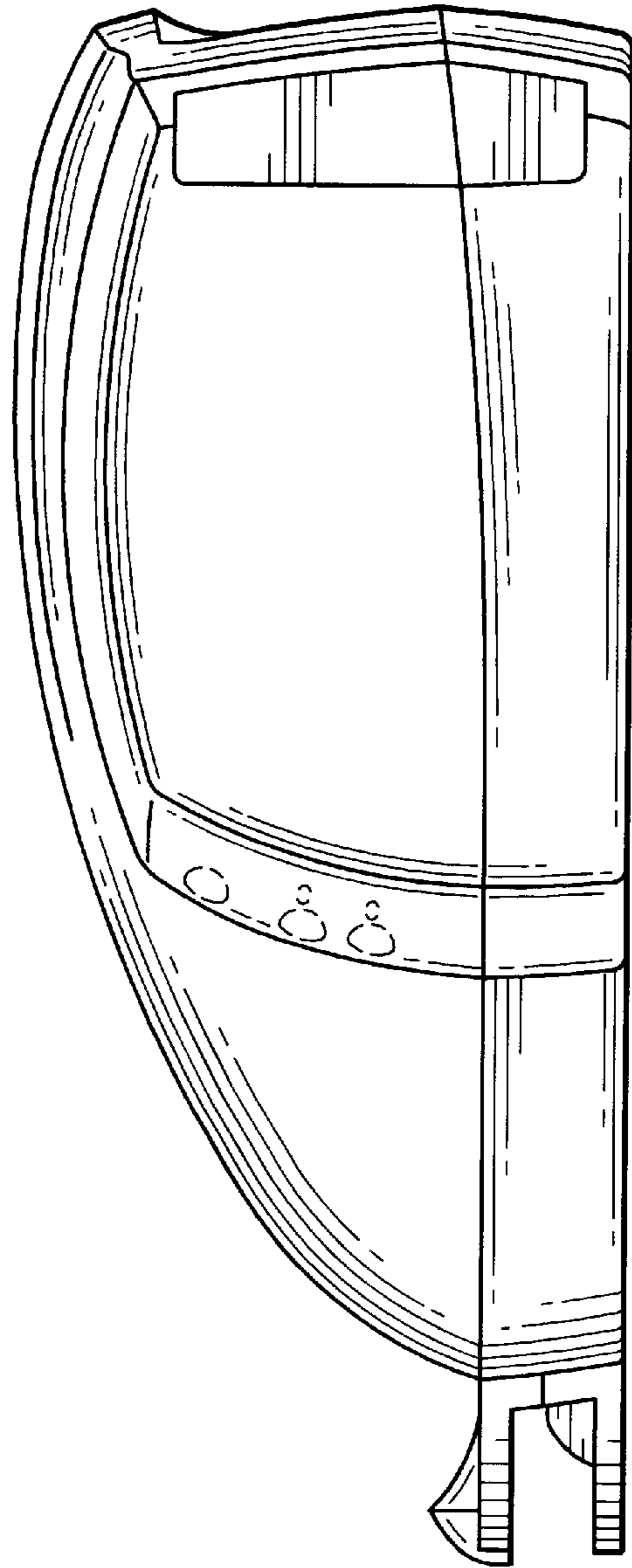
