FIG. 3 is a side view thereof, the opposite side view being similar thereto;

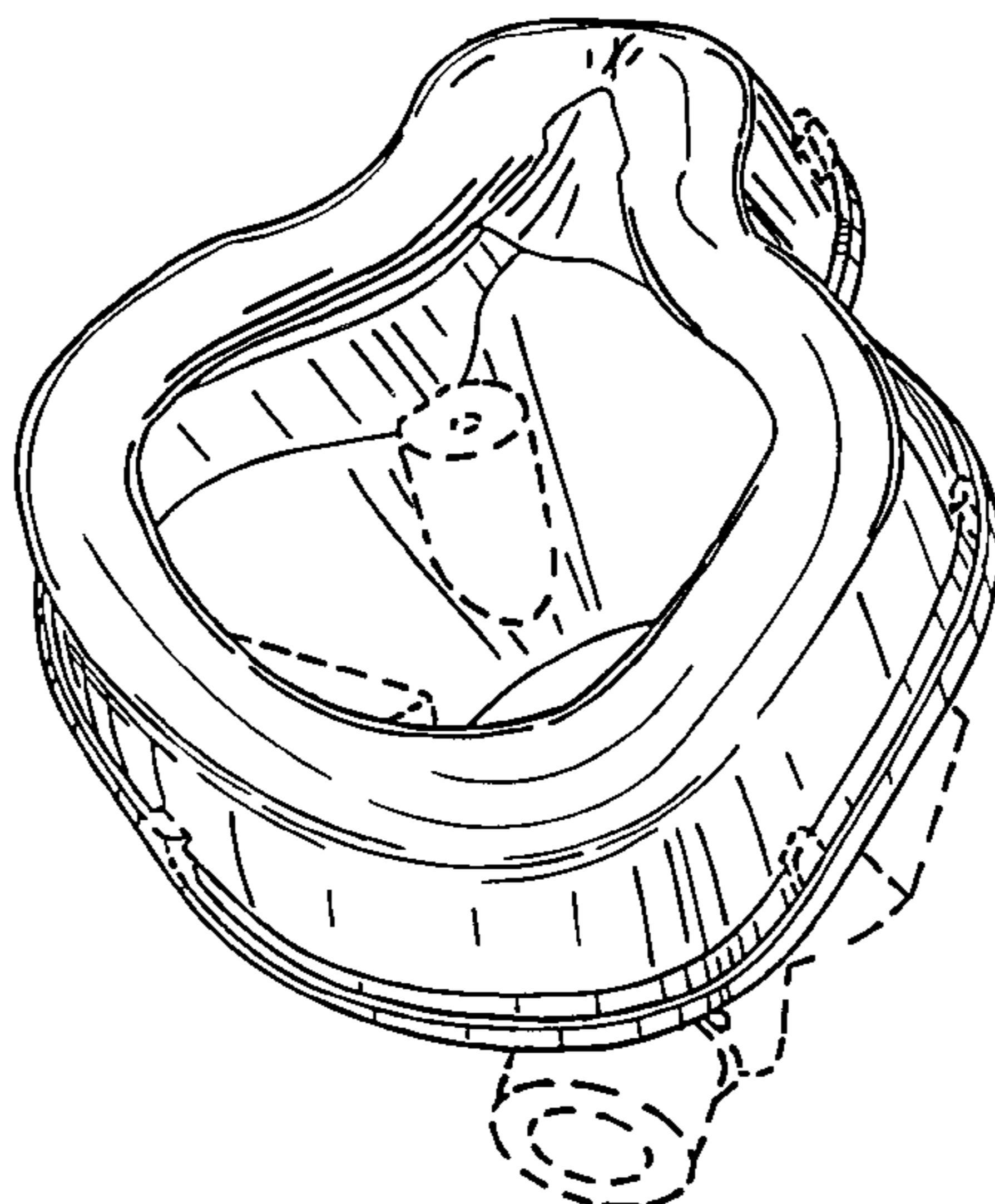
FIG. 4 is a top side view thereof;

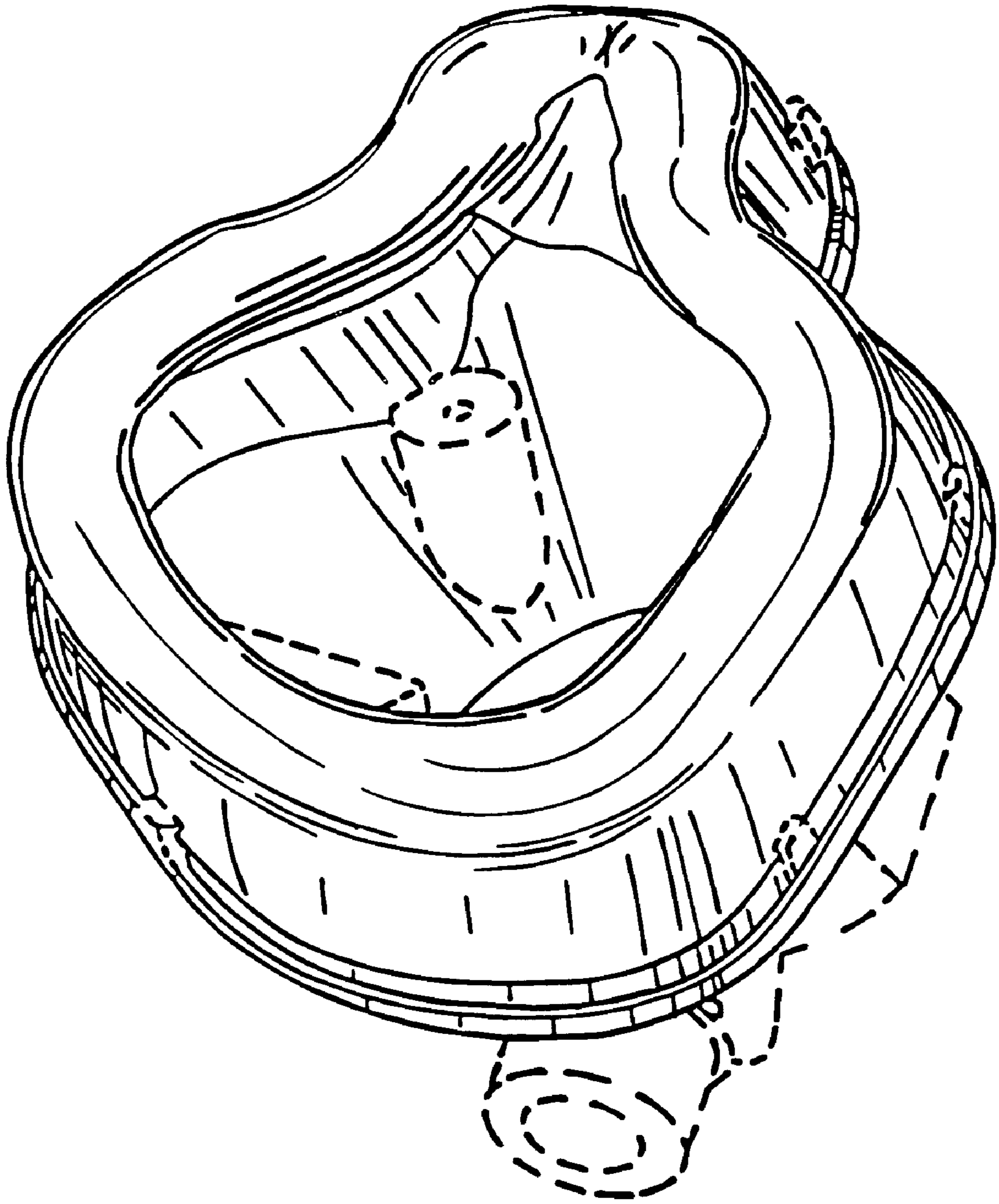

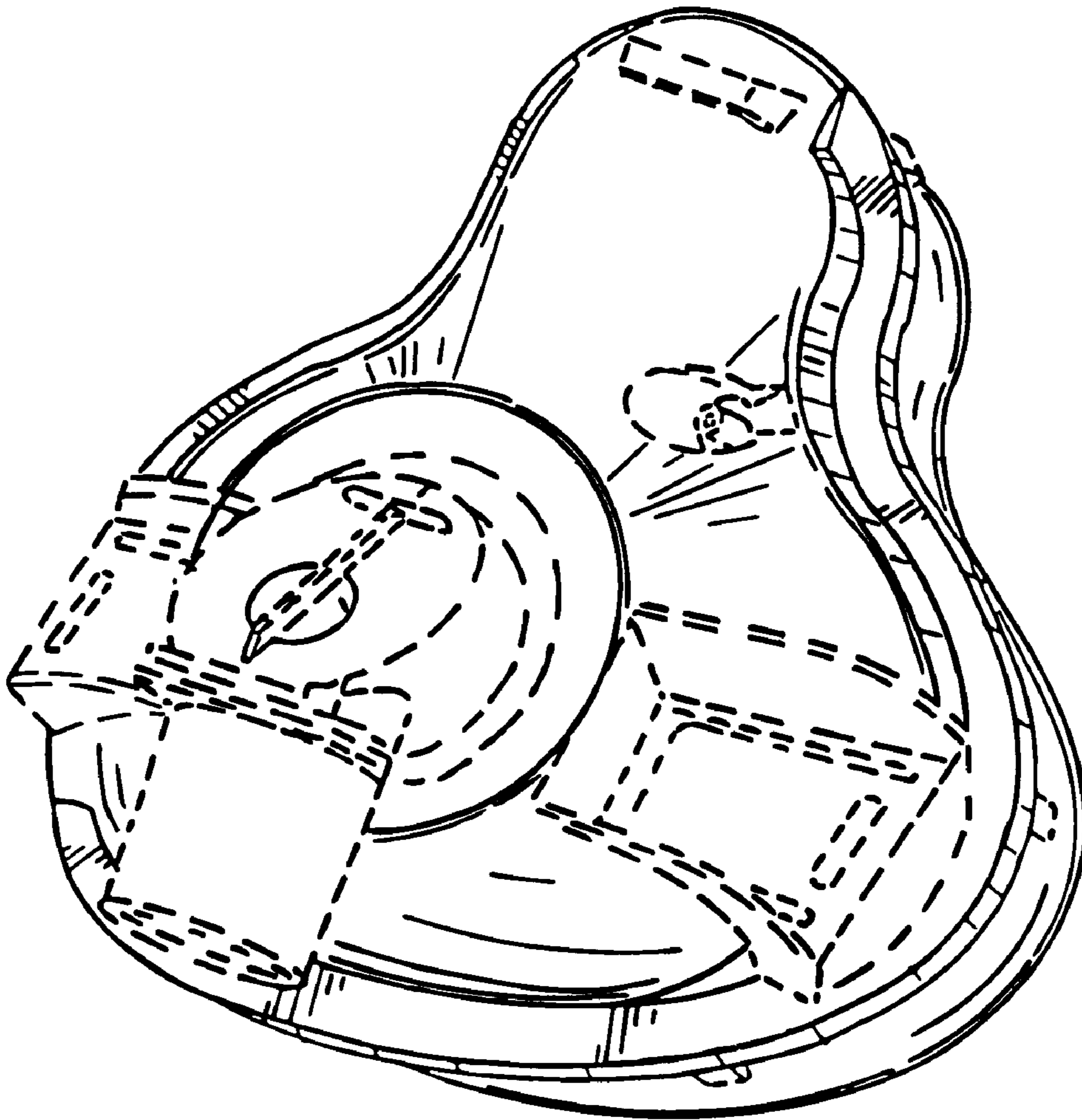

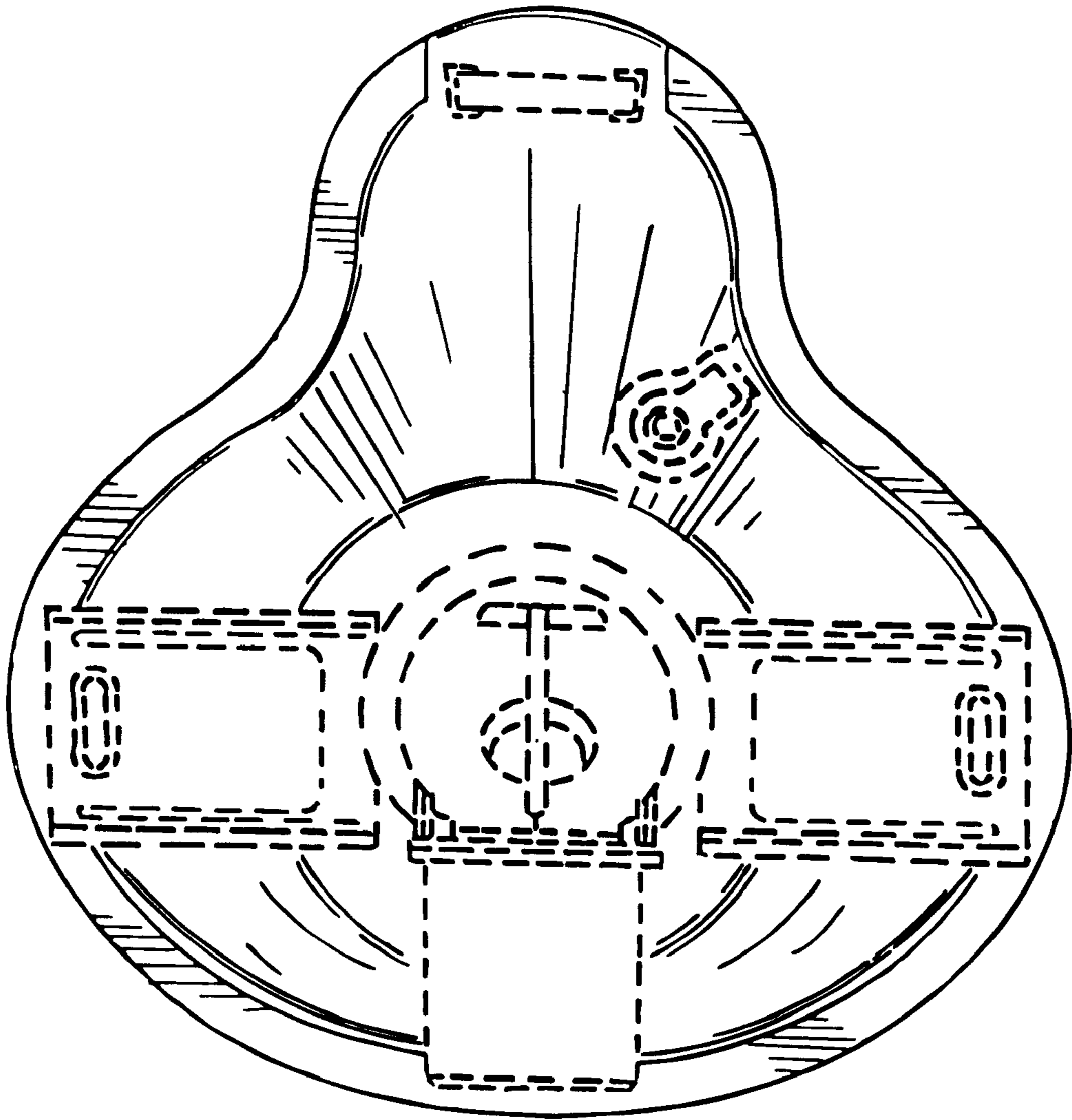

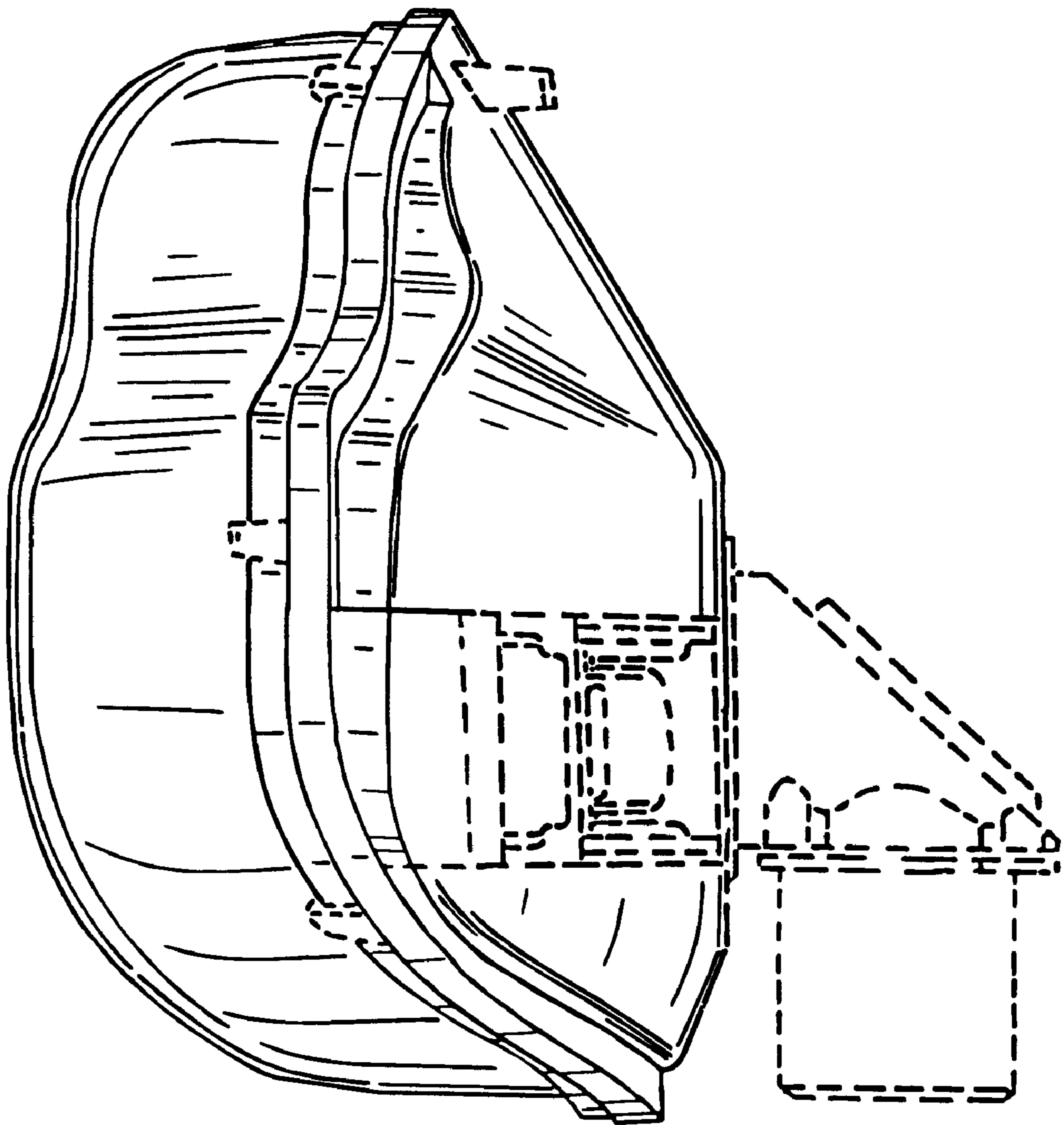
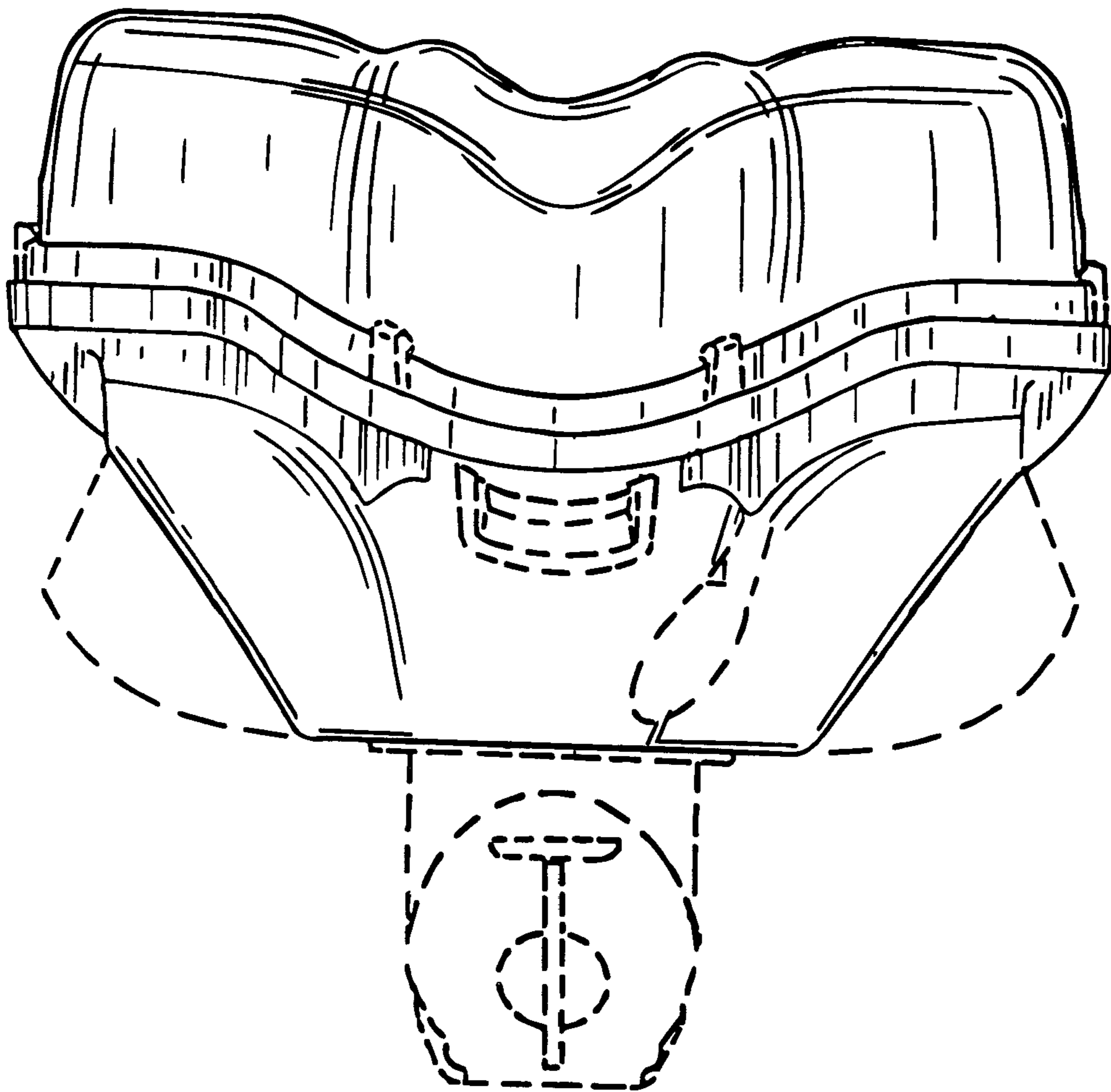
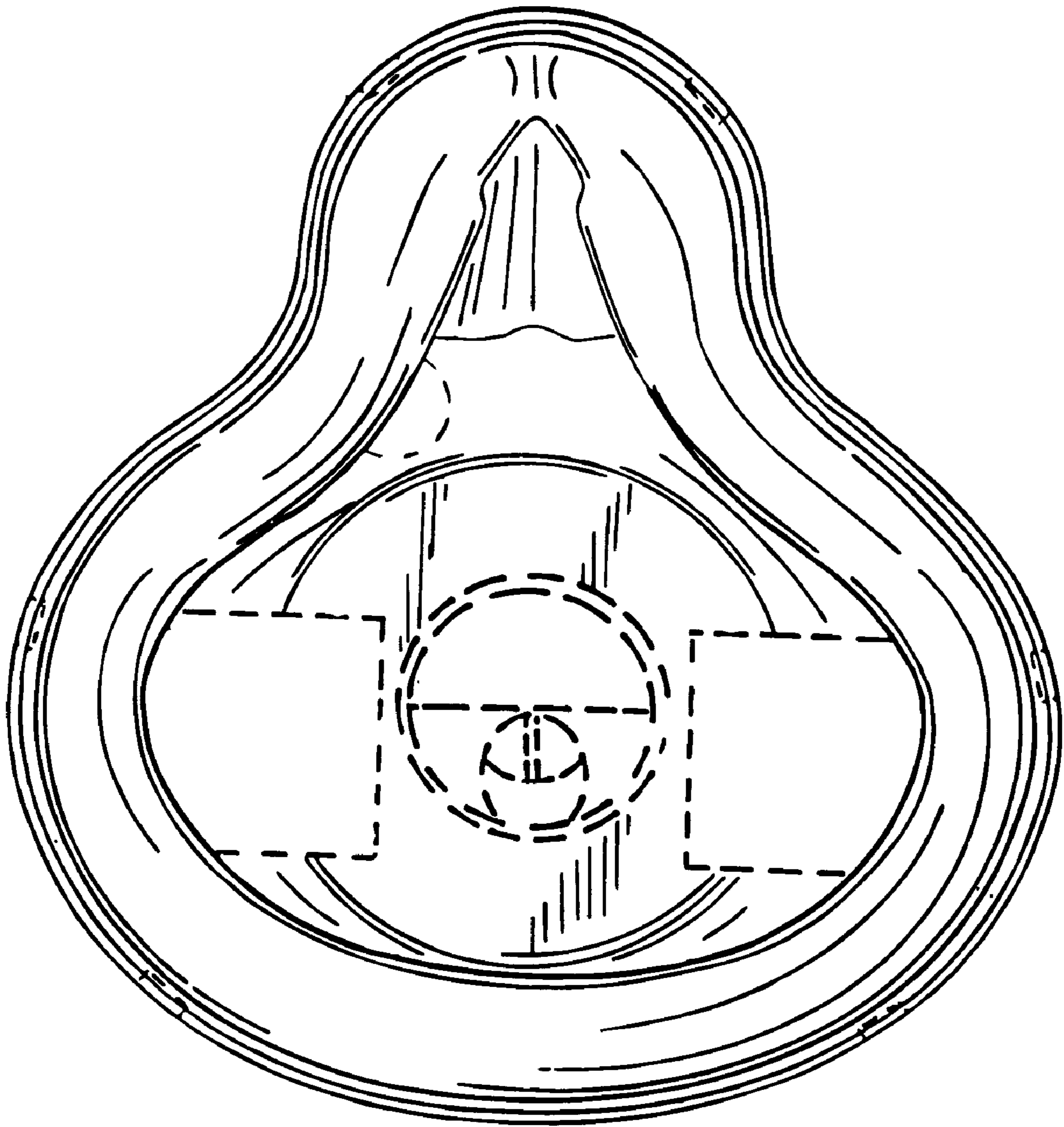
