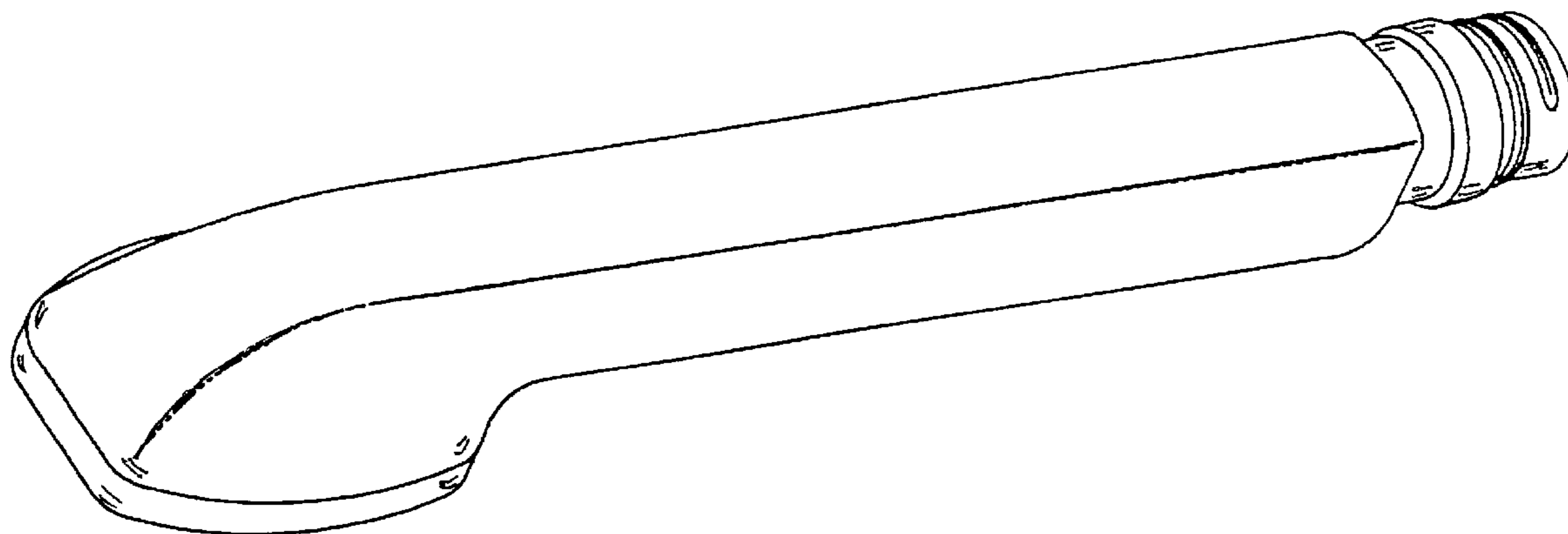
(57) **CLAIM**

The ornamental design for a handle for a lotion applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and right side perspective view of a handle for a lotion applicator showing my new design;  
 FIG. 2 is a fragmentary bottom plan view of the front end of the handle for a lotion applicator;  
 FIG. 3 is a front elevation thereof;  
 FIG. 4 is a top perspective view thereof;  
 FIG. 5 is a right side elevation thereof; and,  
 FIG. 6 is a bottom perspective view thereof.  
 The broken lines showing a rectangle on the handle for a lotion applicator in FIG. 5 are for illustrative purposes only and do not form part of the claimed design.

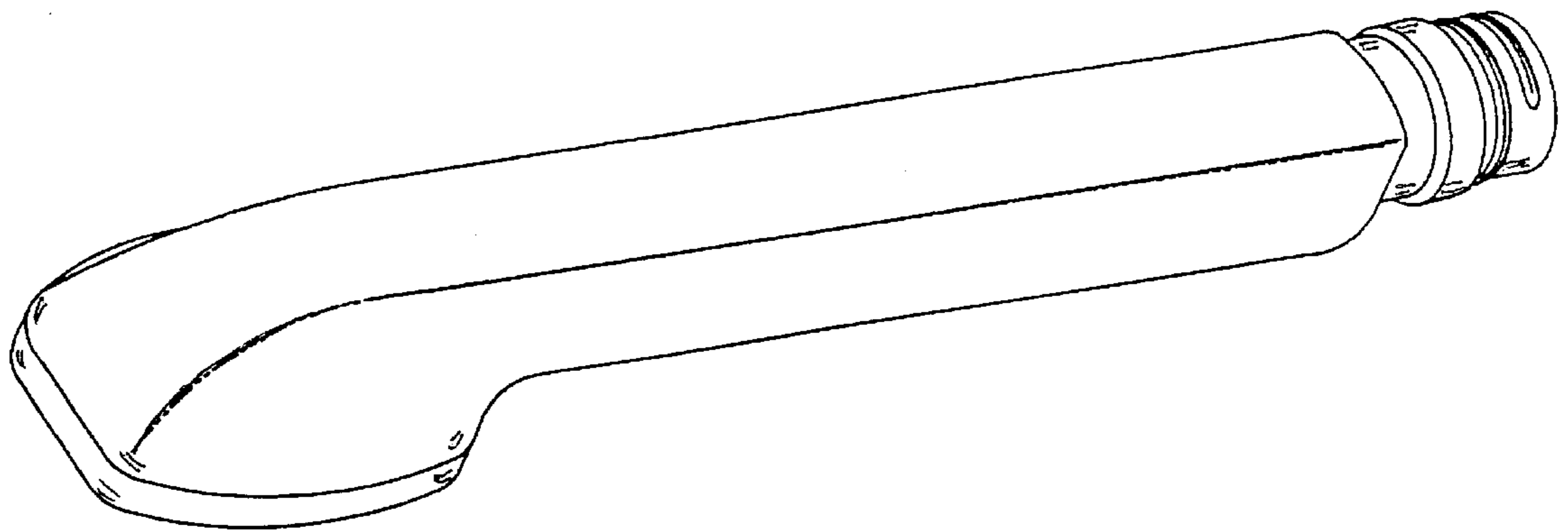

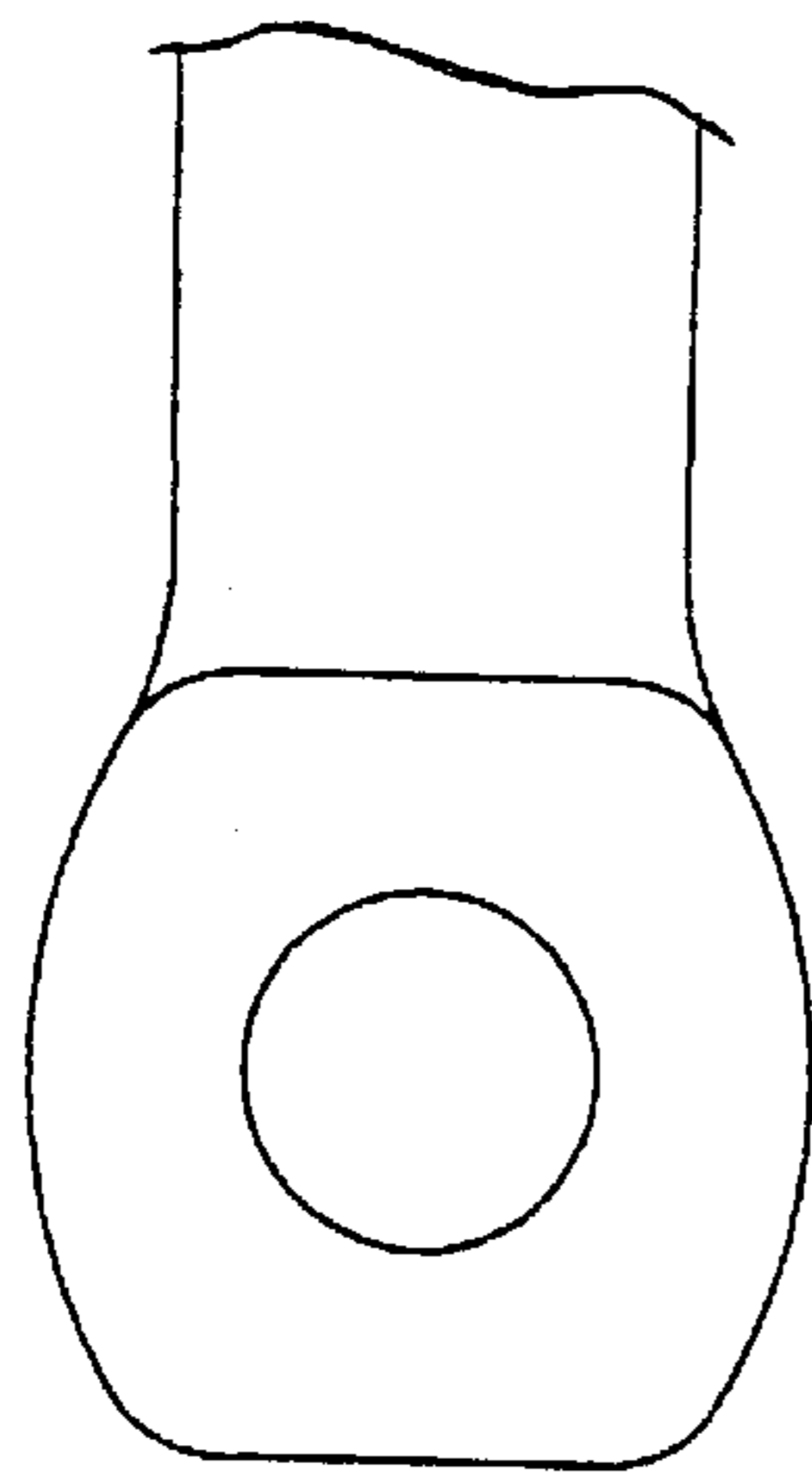

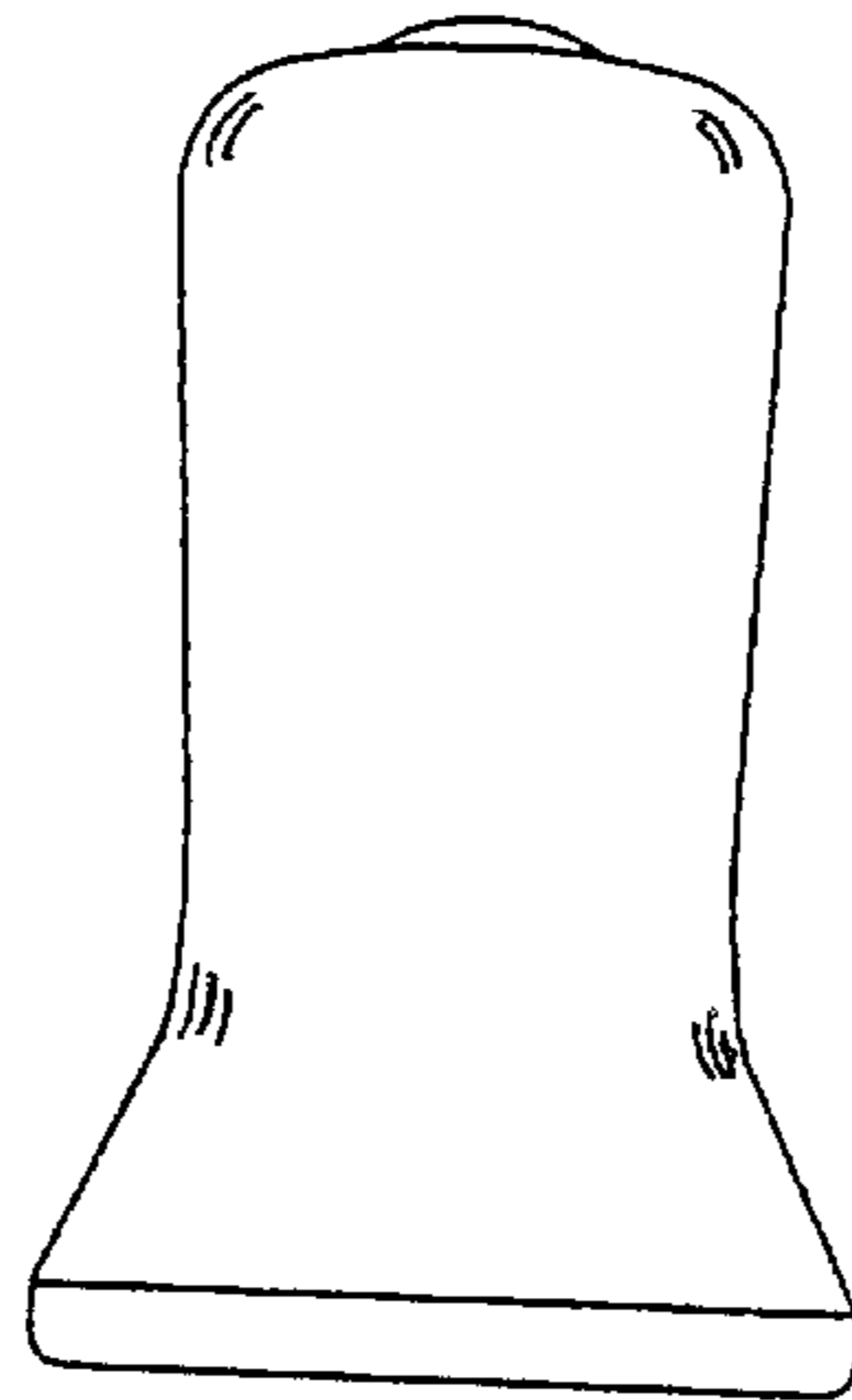

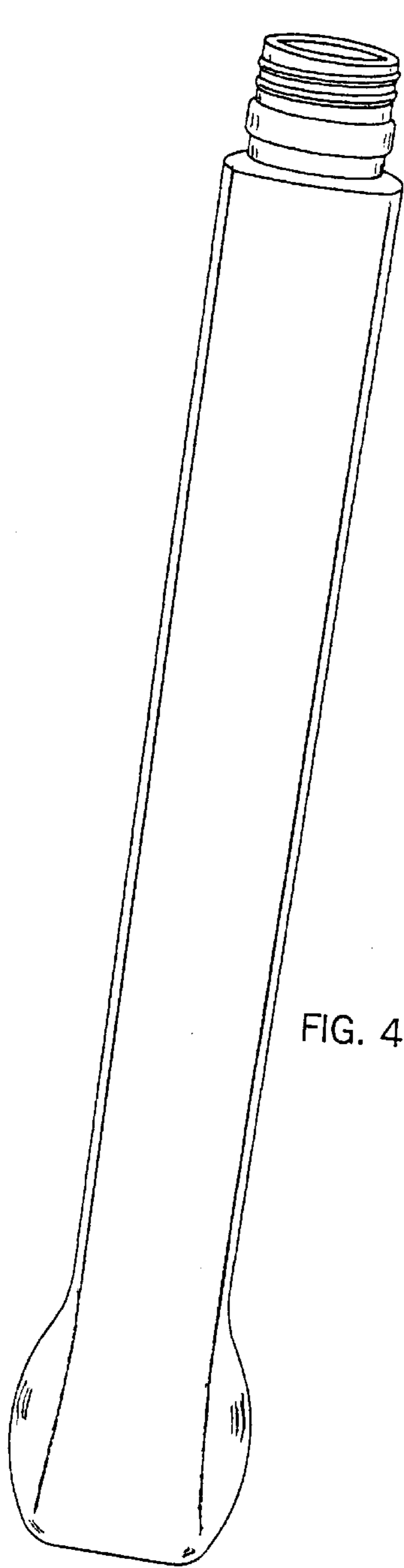

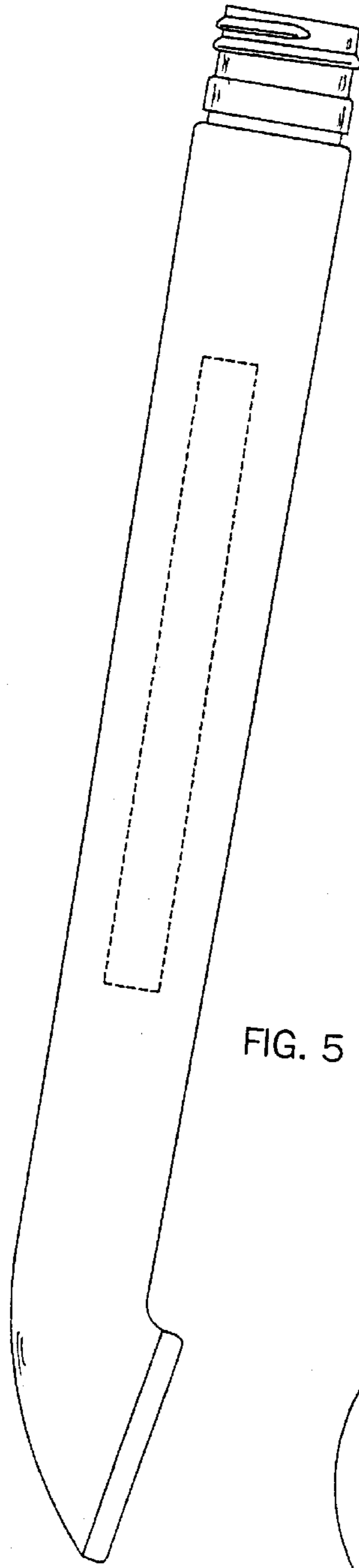

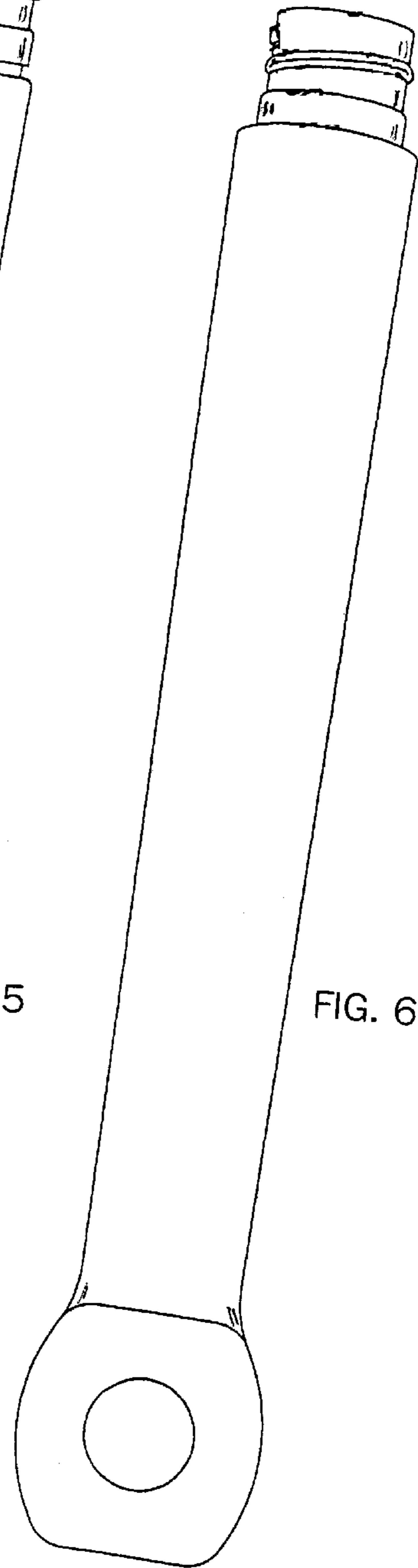
