DESCRIPTION

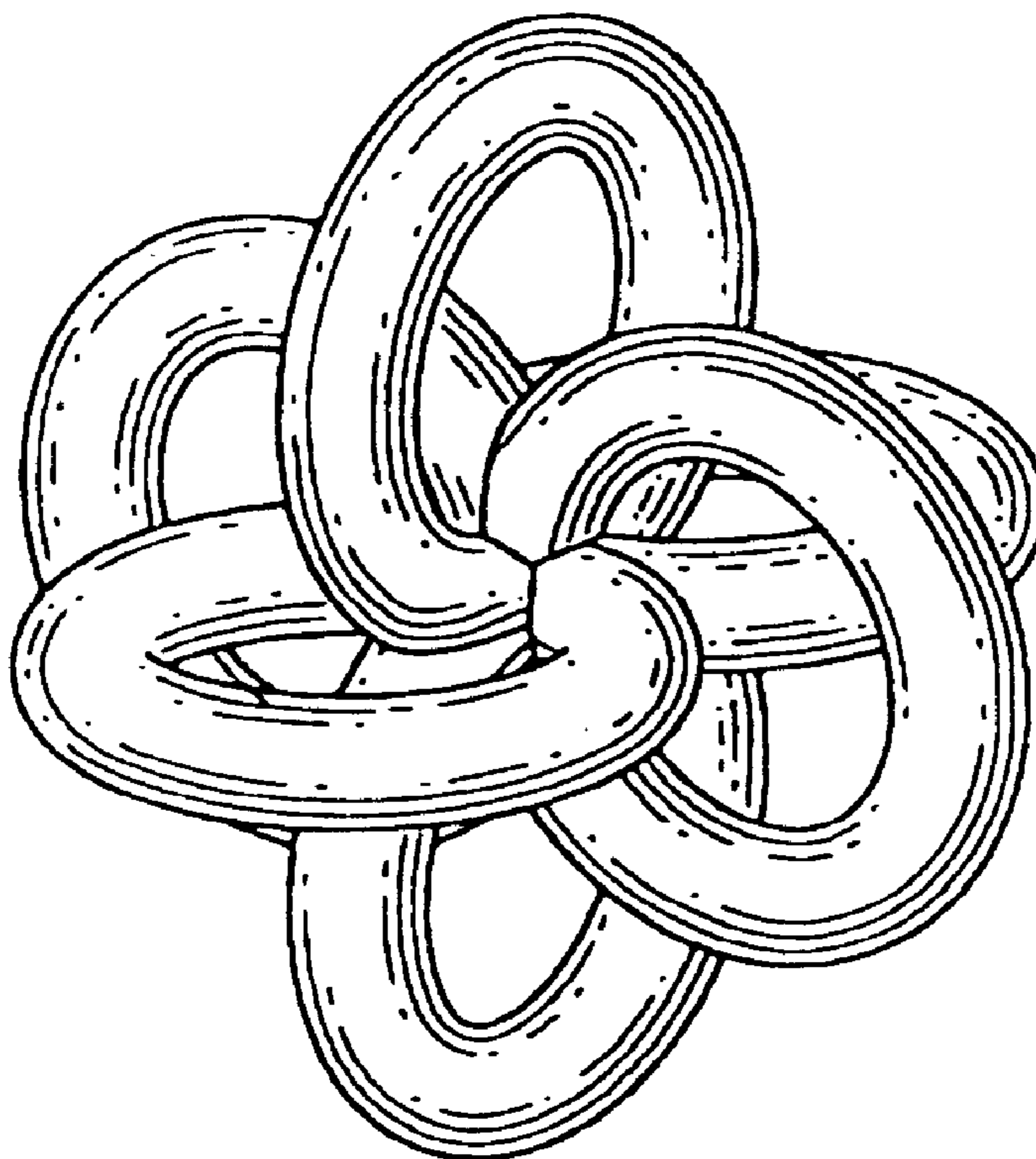
FIG. 1: is a perspective view of a pet toy showing my new design;

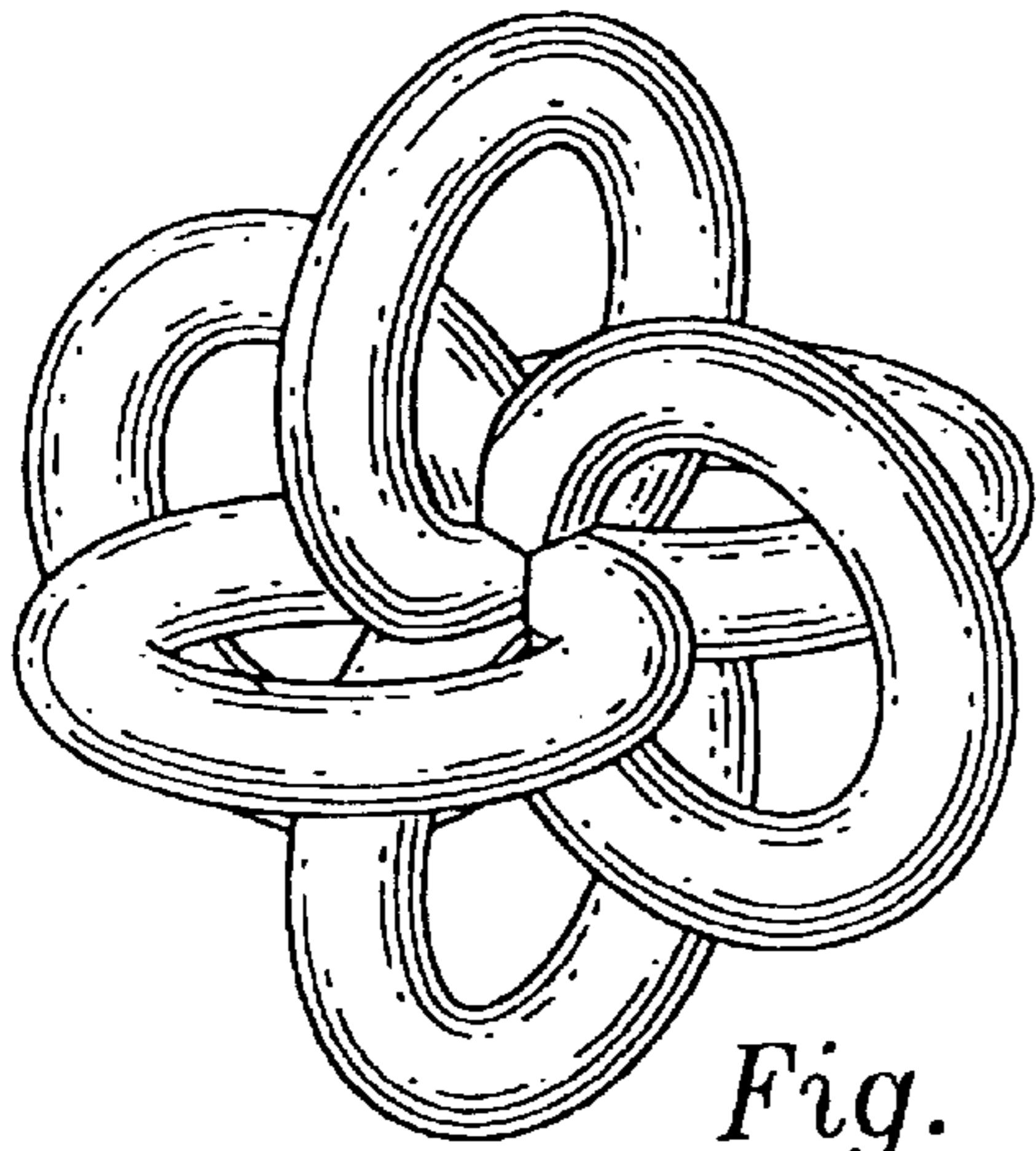

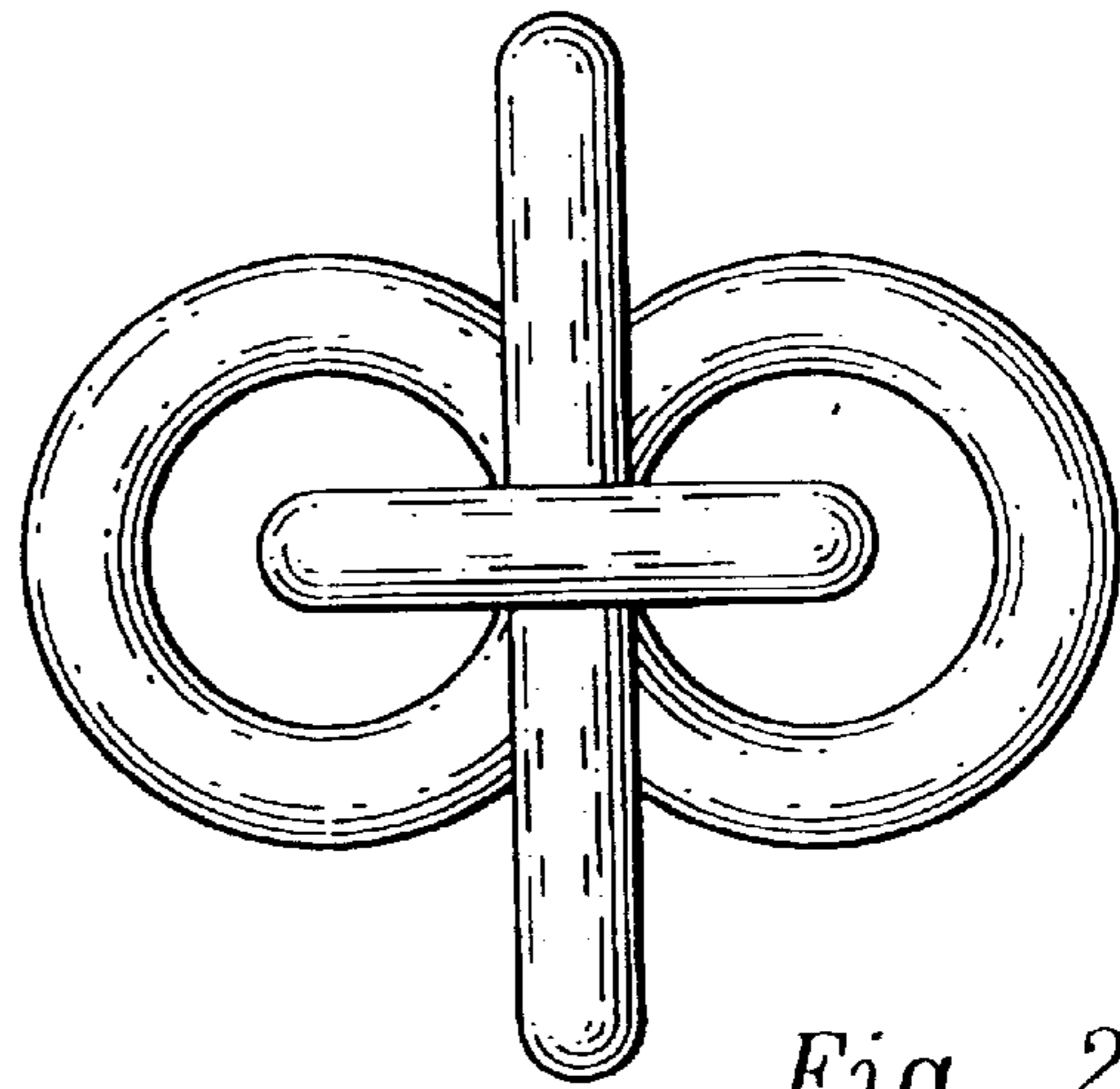

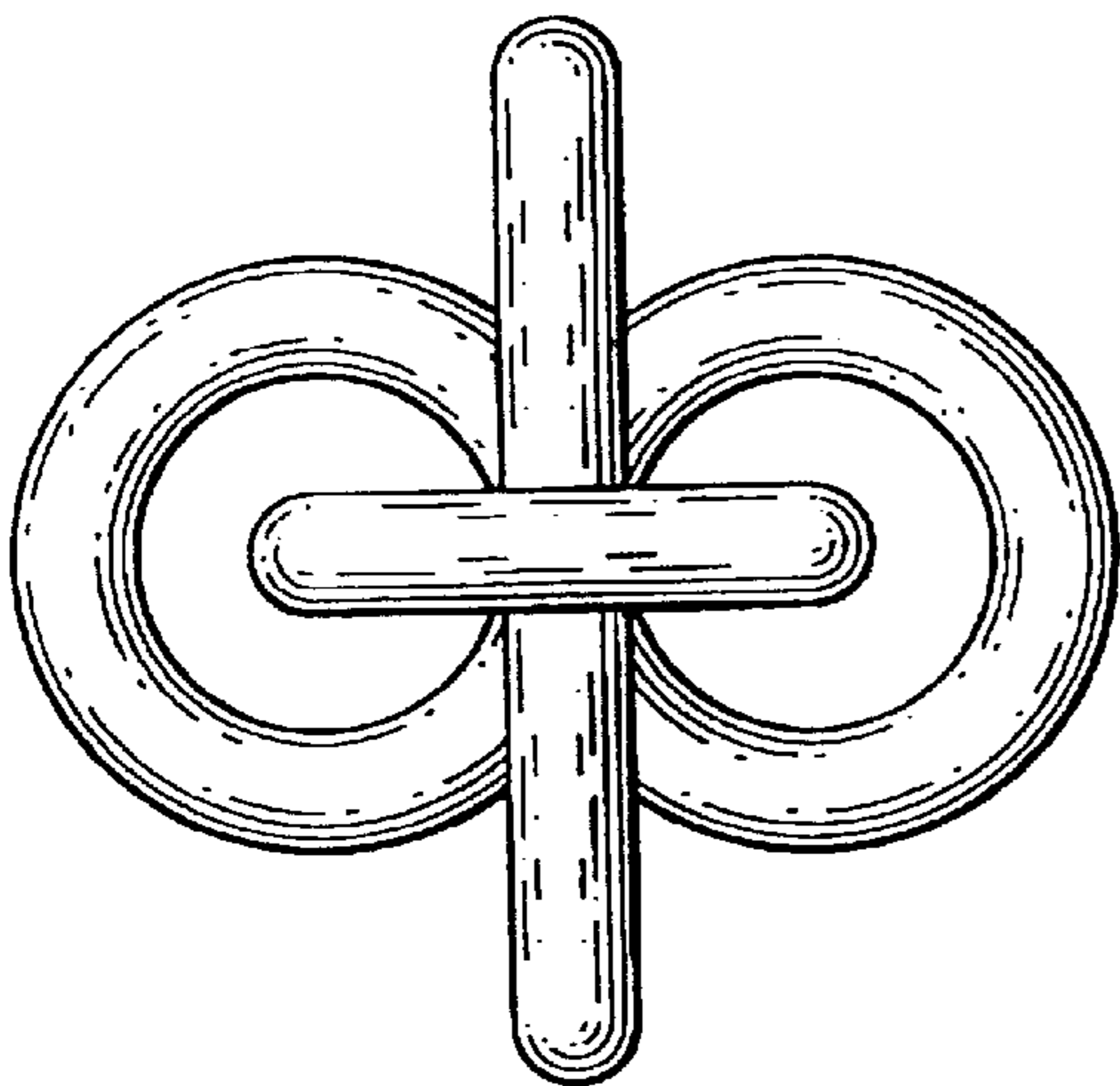

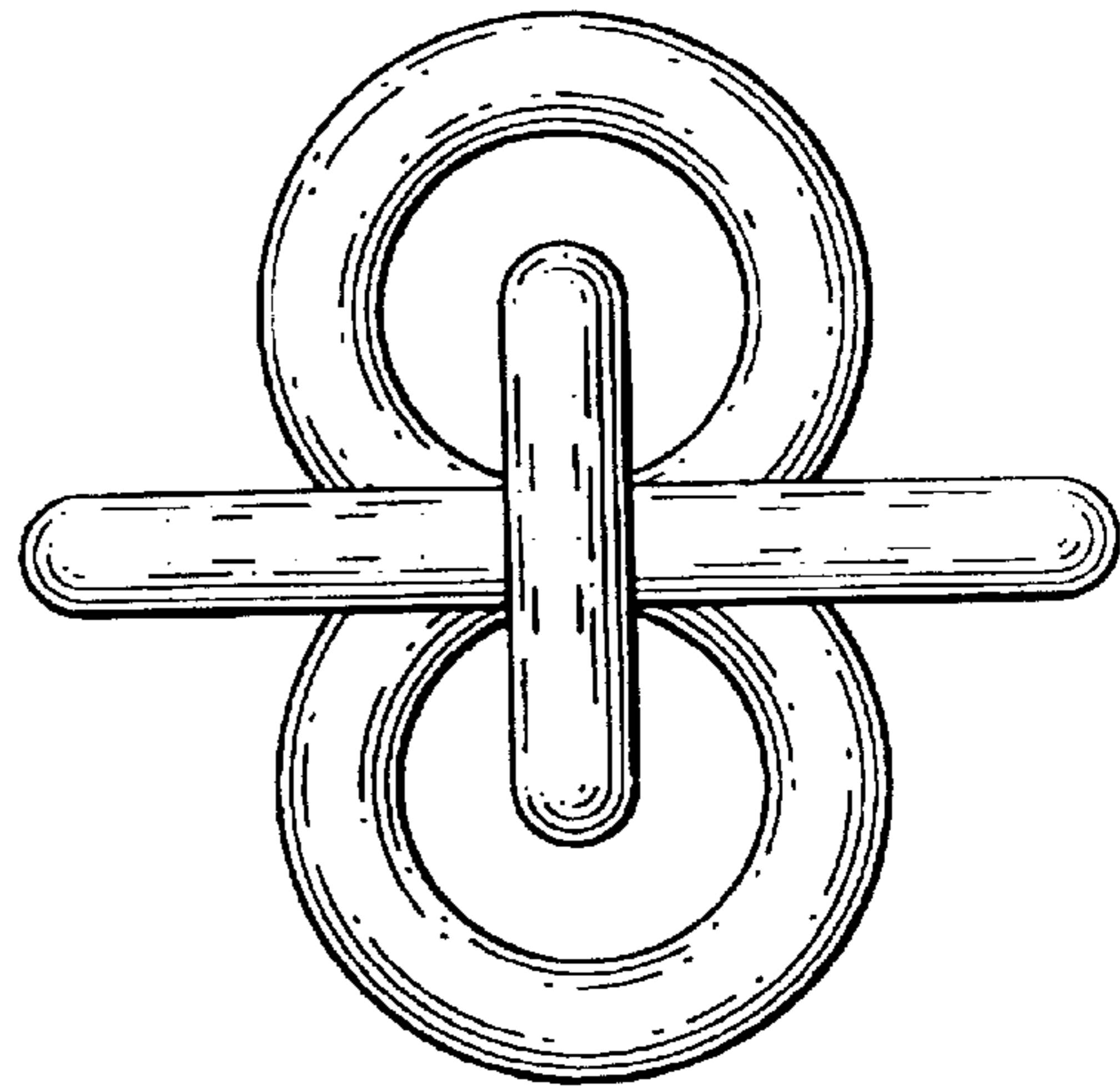
