DESCRIPTION

FIG. 1 is a side elevational view of a portion of a shoe sole showing my new design;

FIG. 4 is a bottom front perspective view thereof;

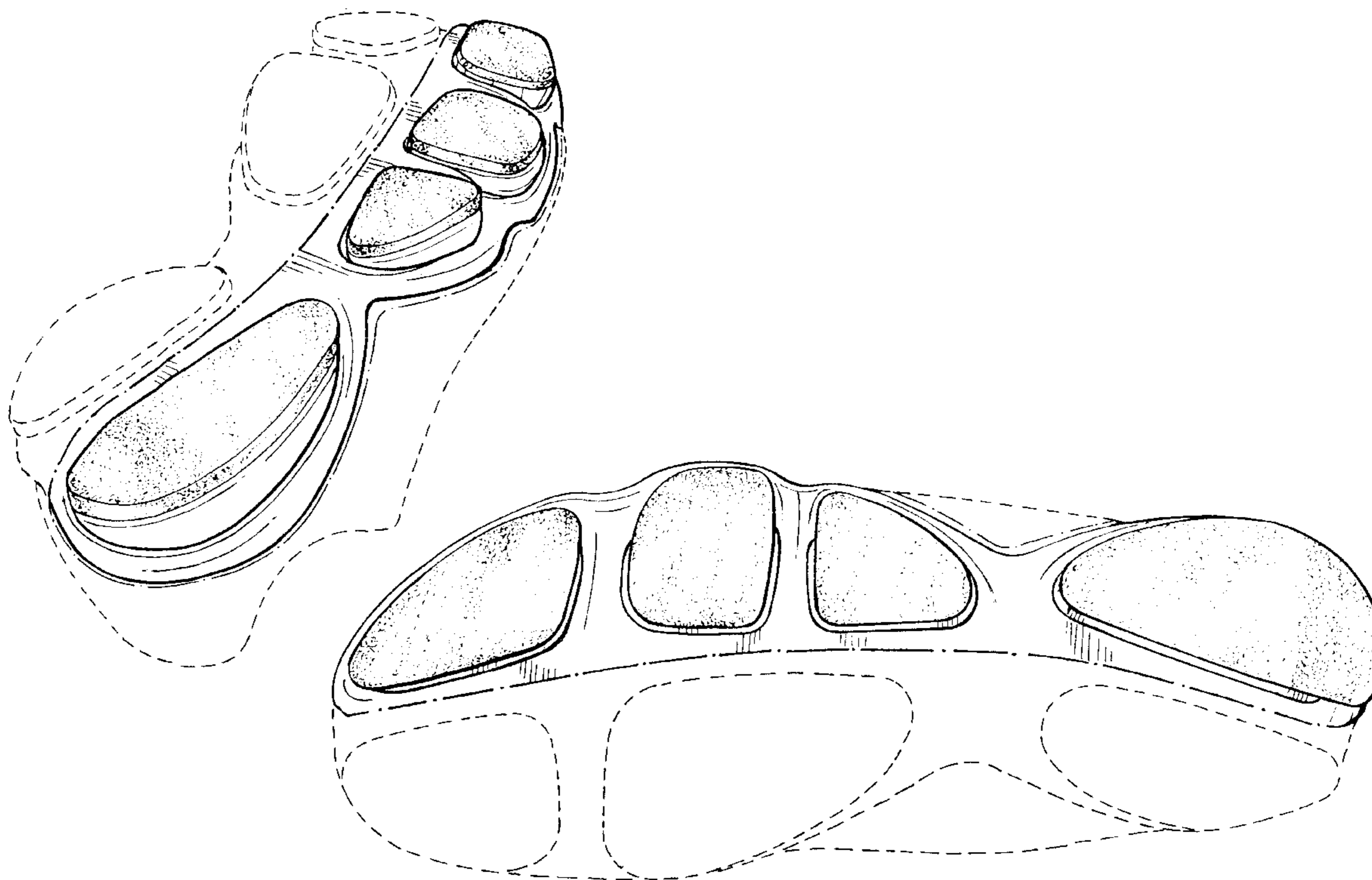
FIG. 5 is a top front perspective view thereof;

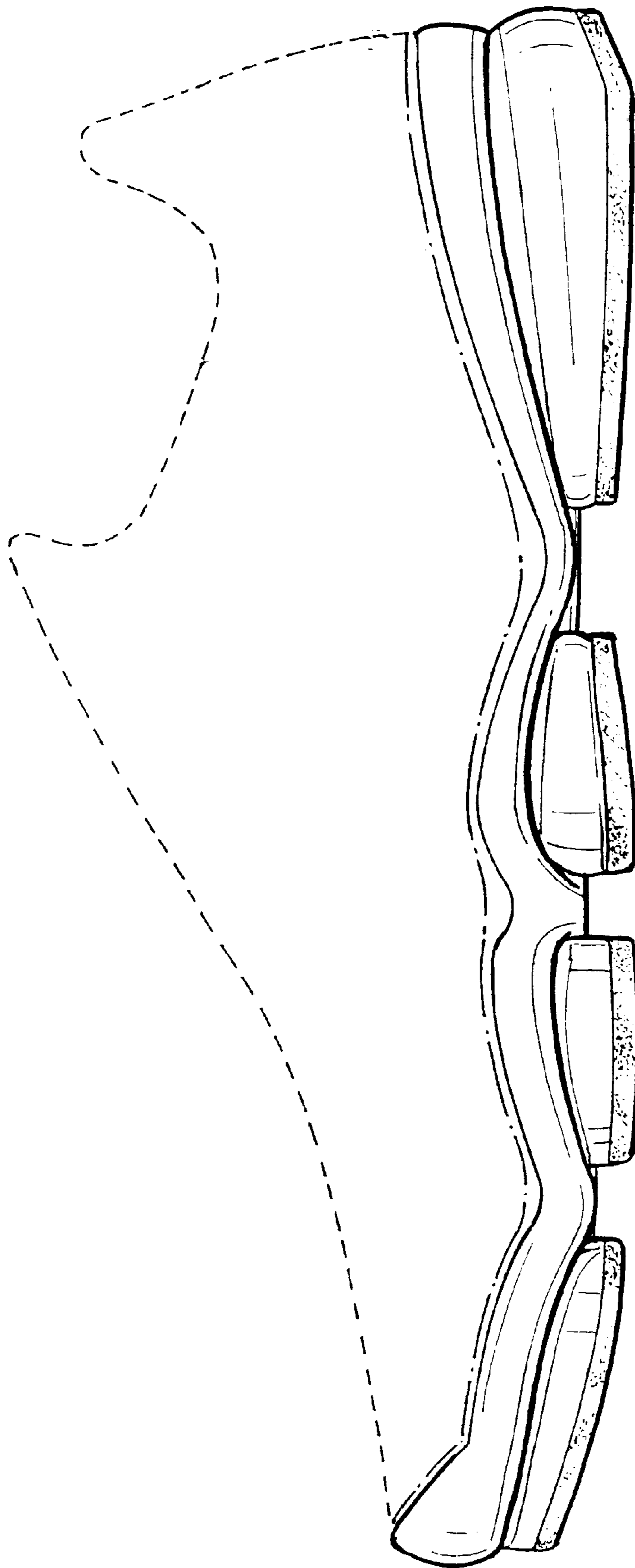

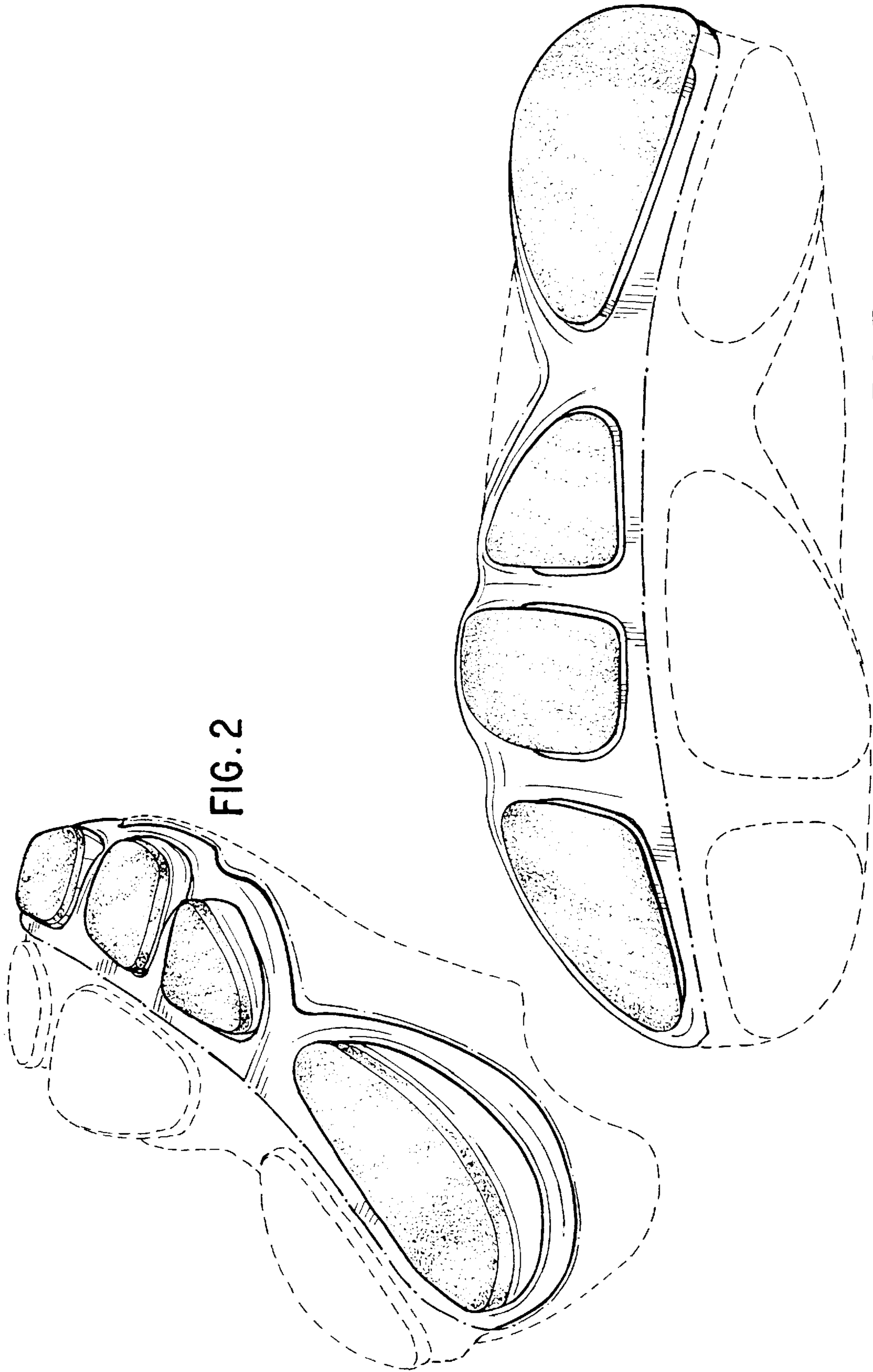

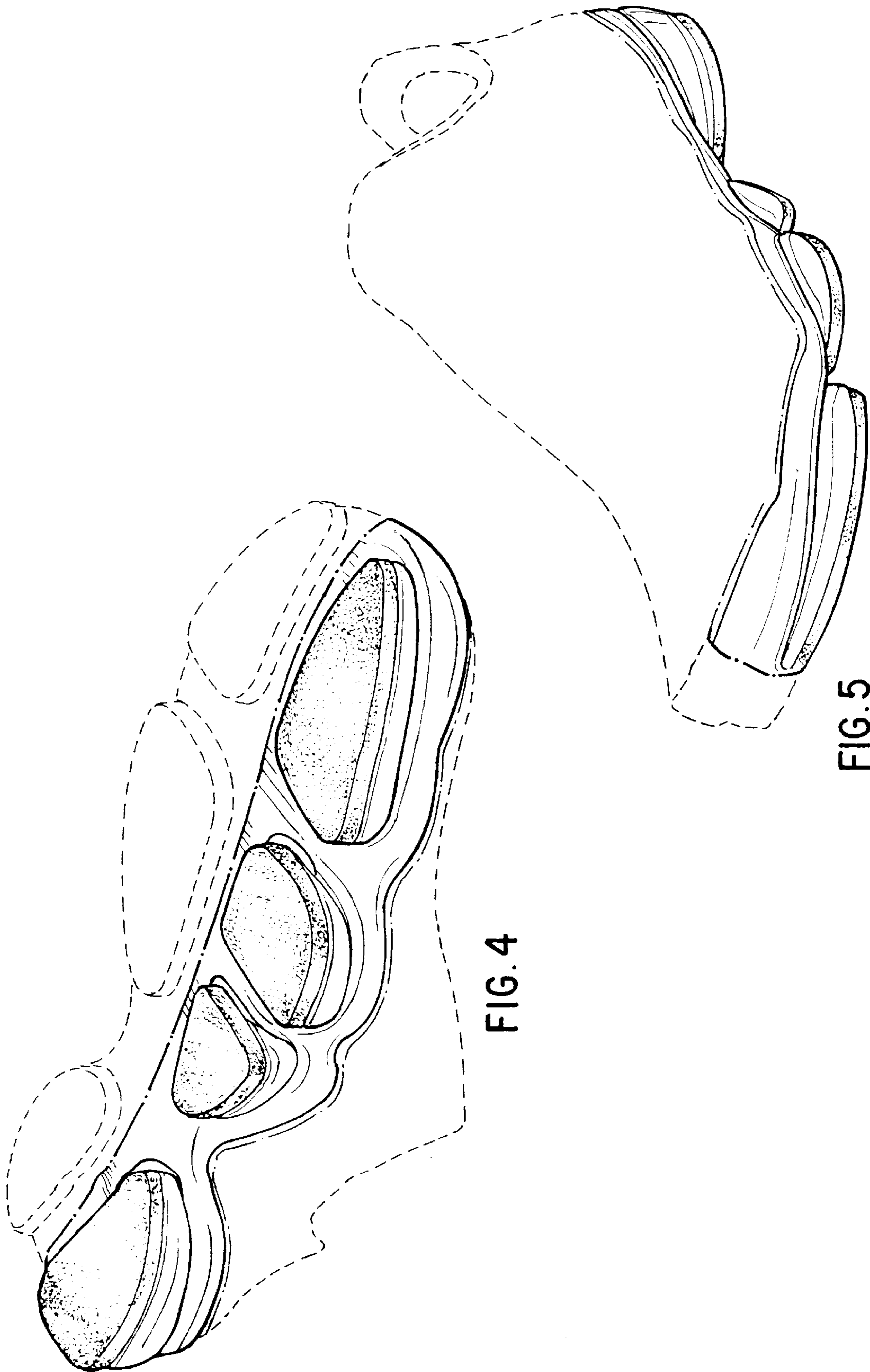

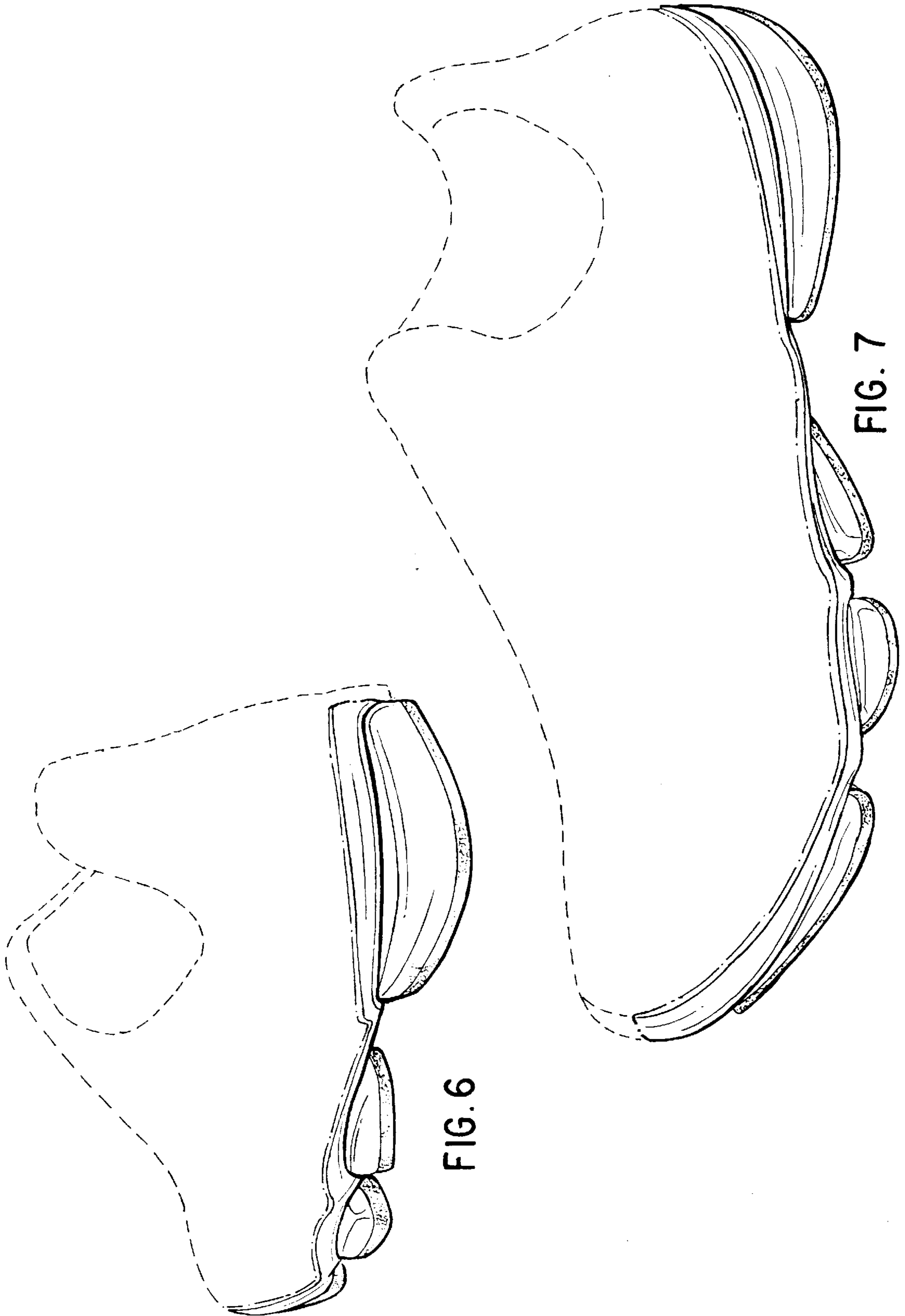
