DESCRIPTION

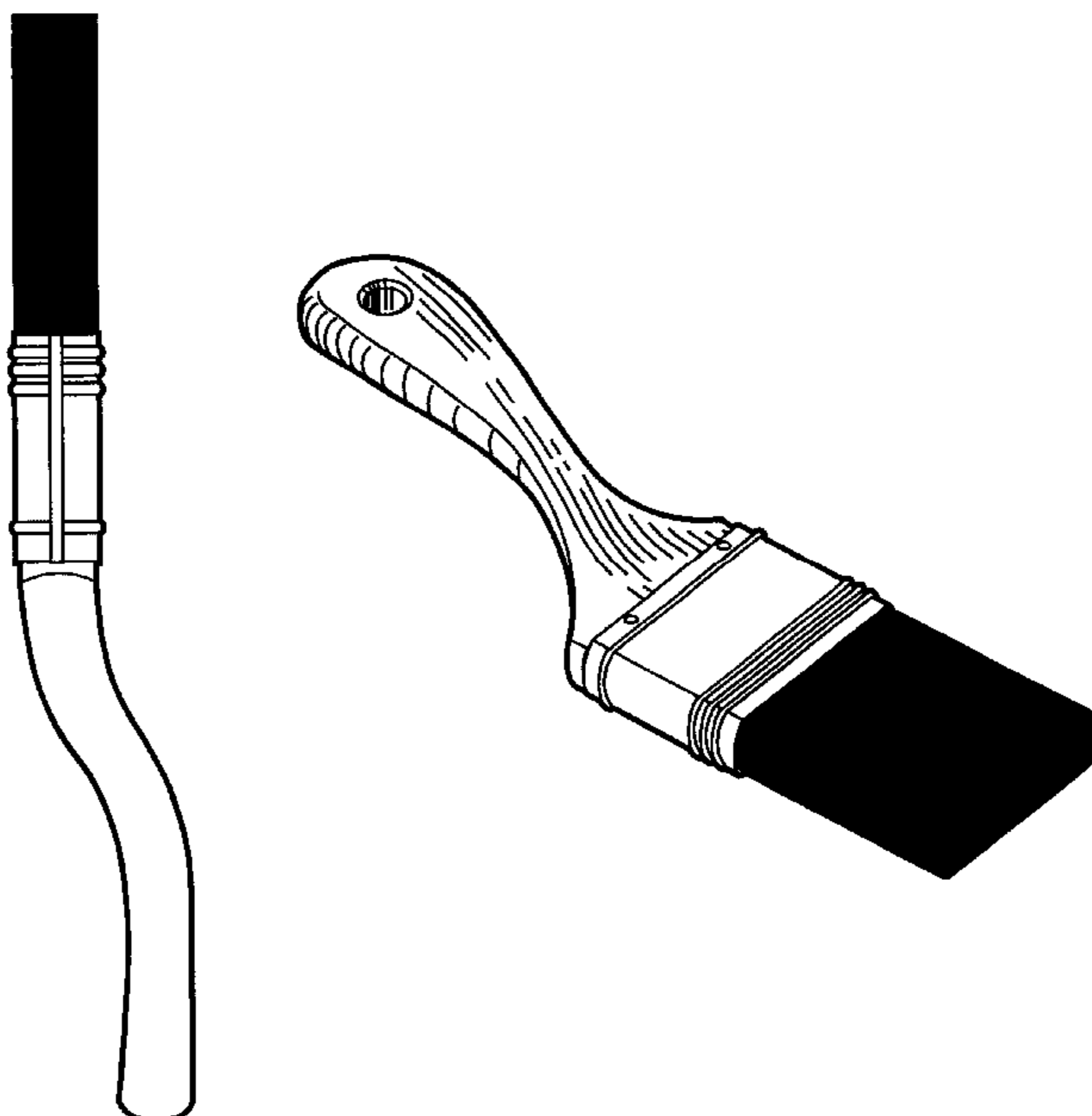

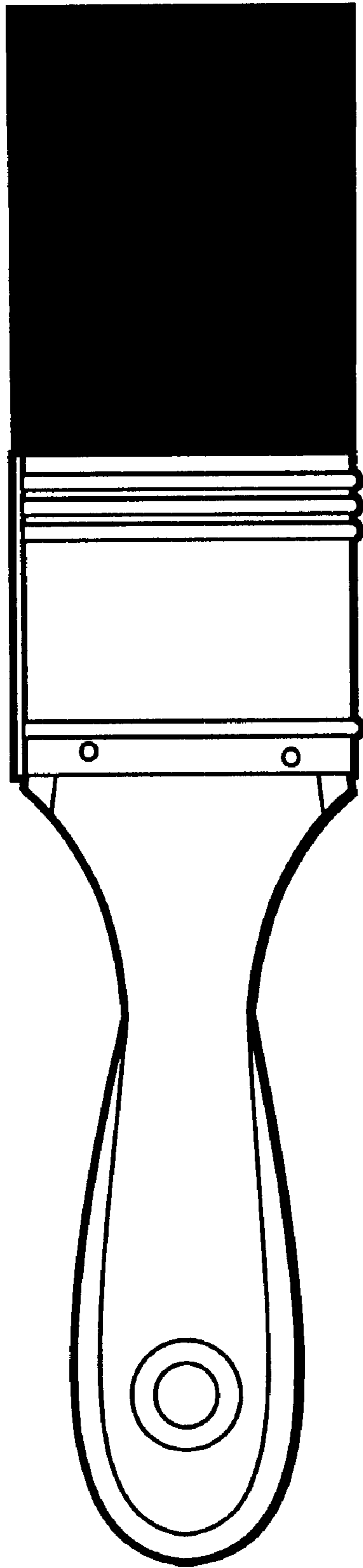
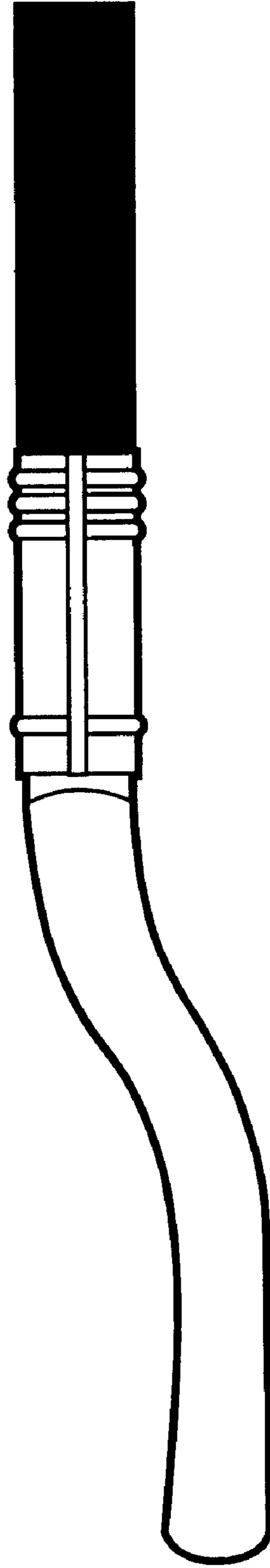

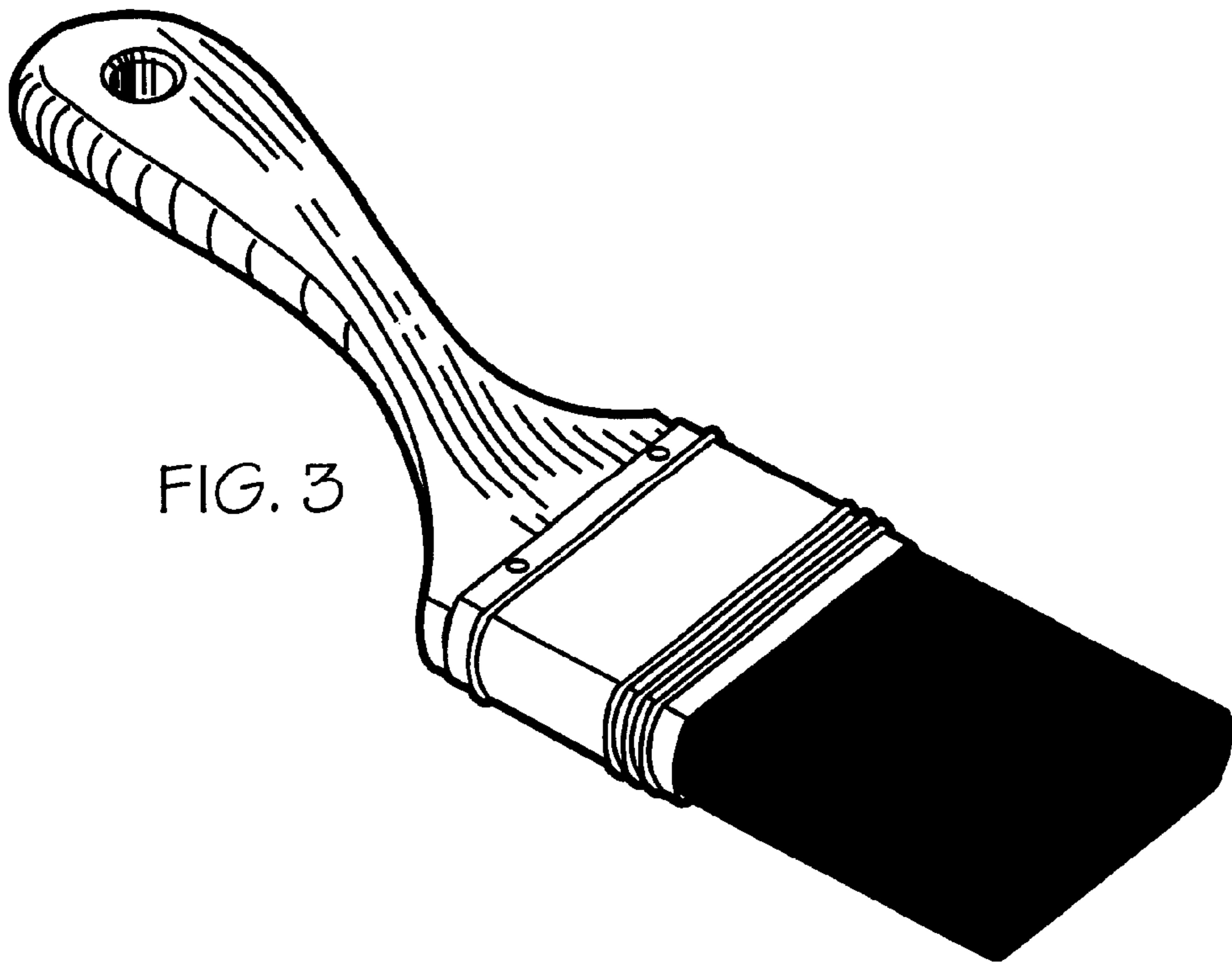

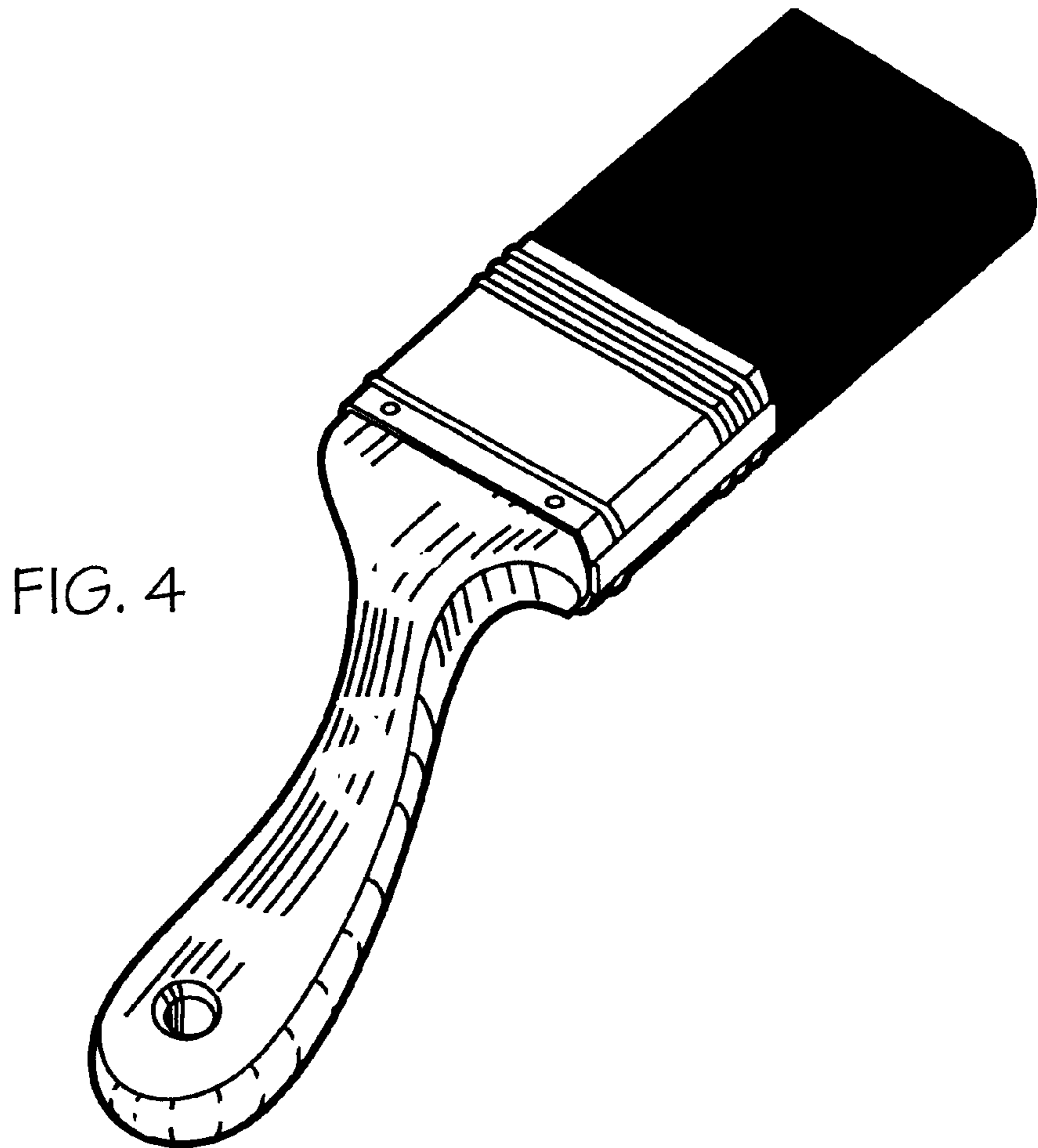

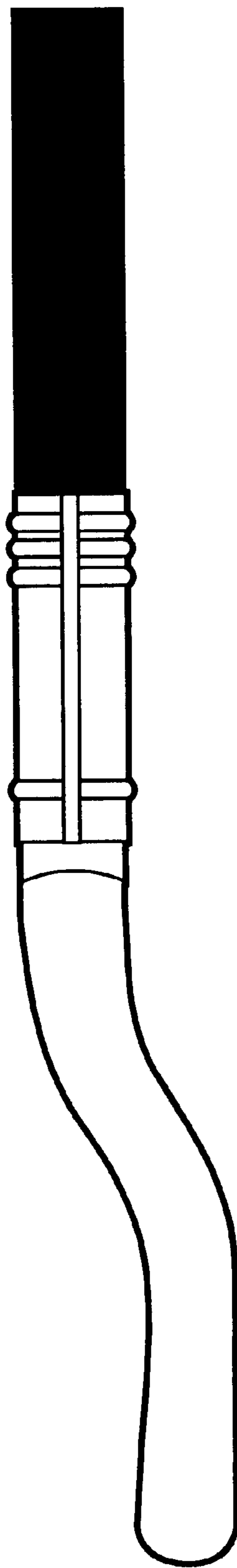
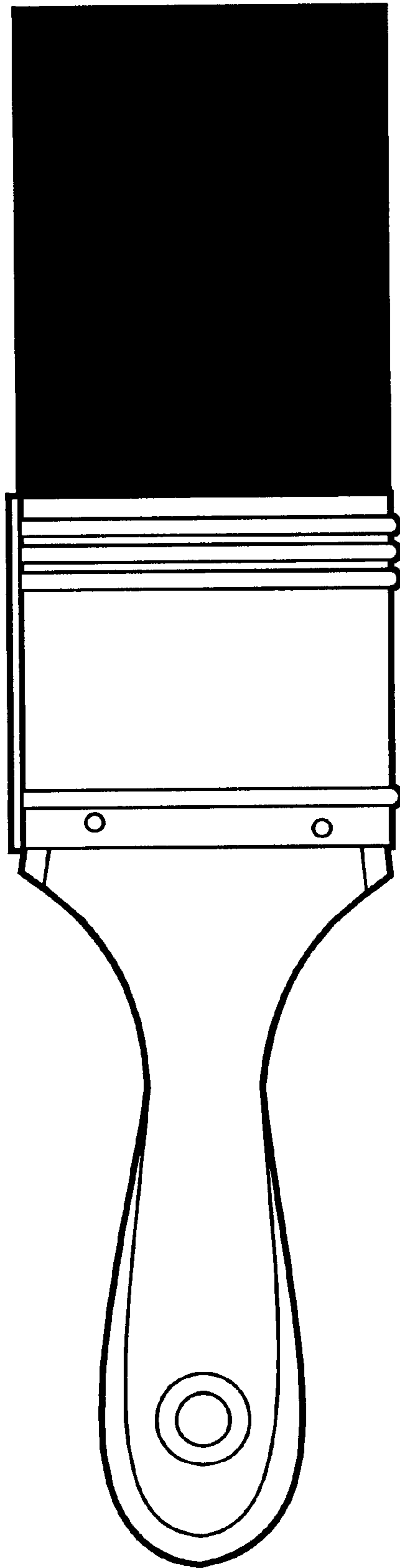

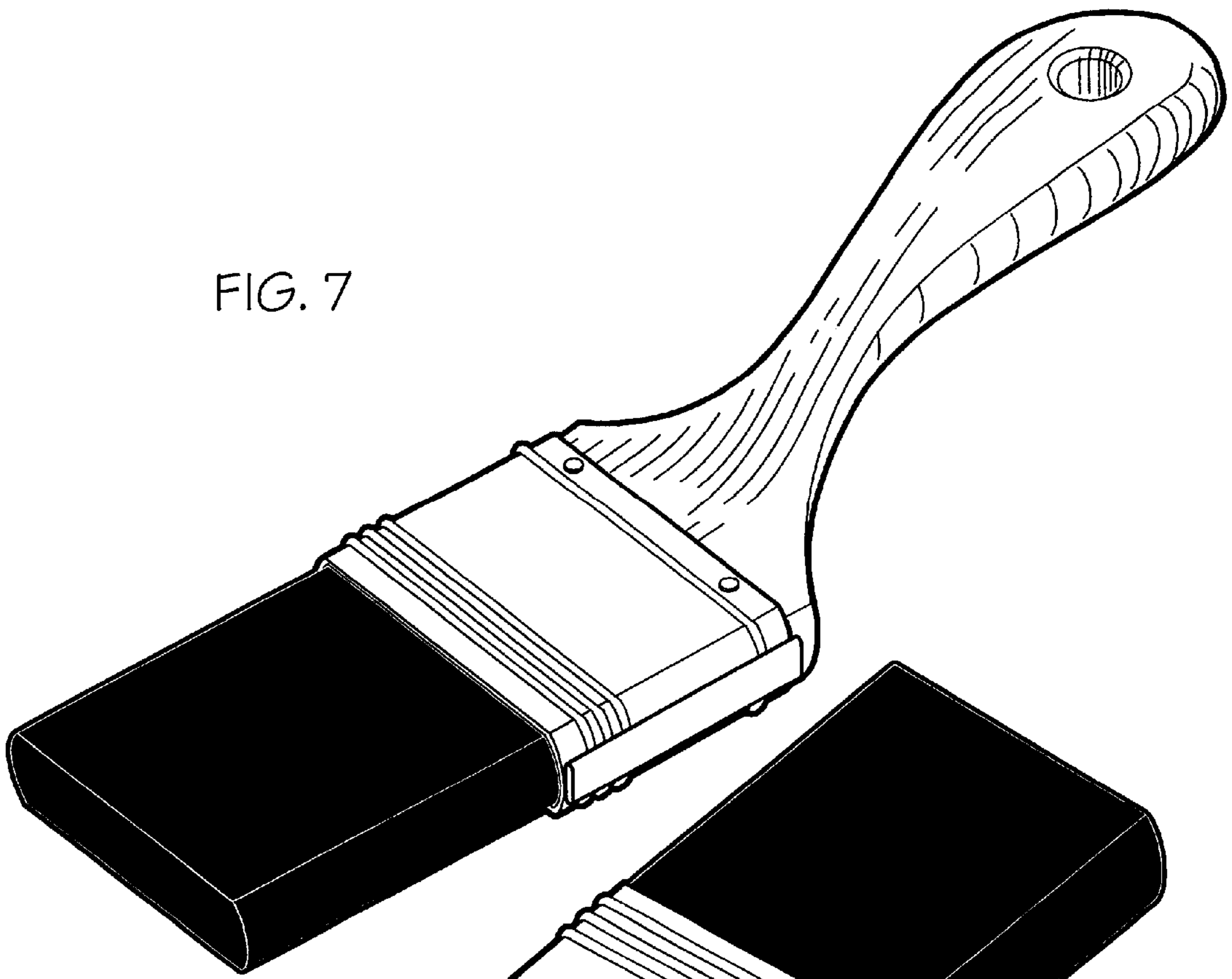

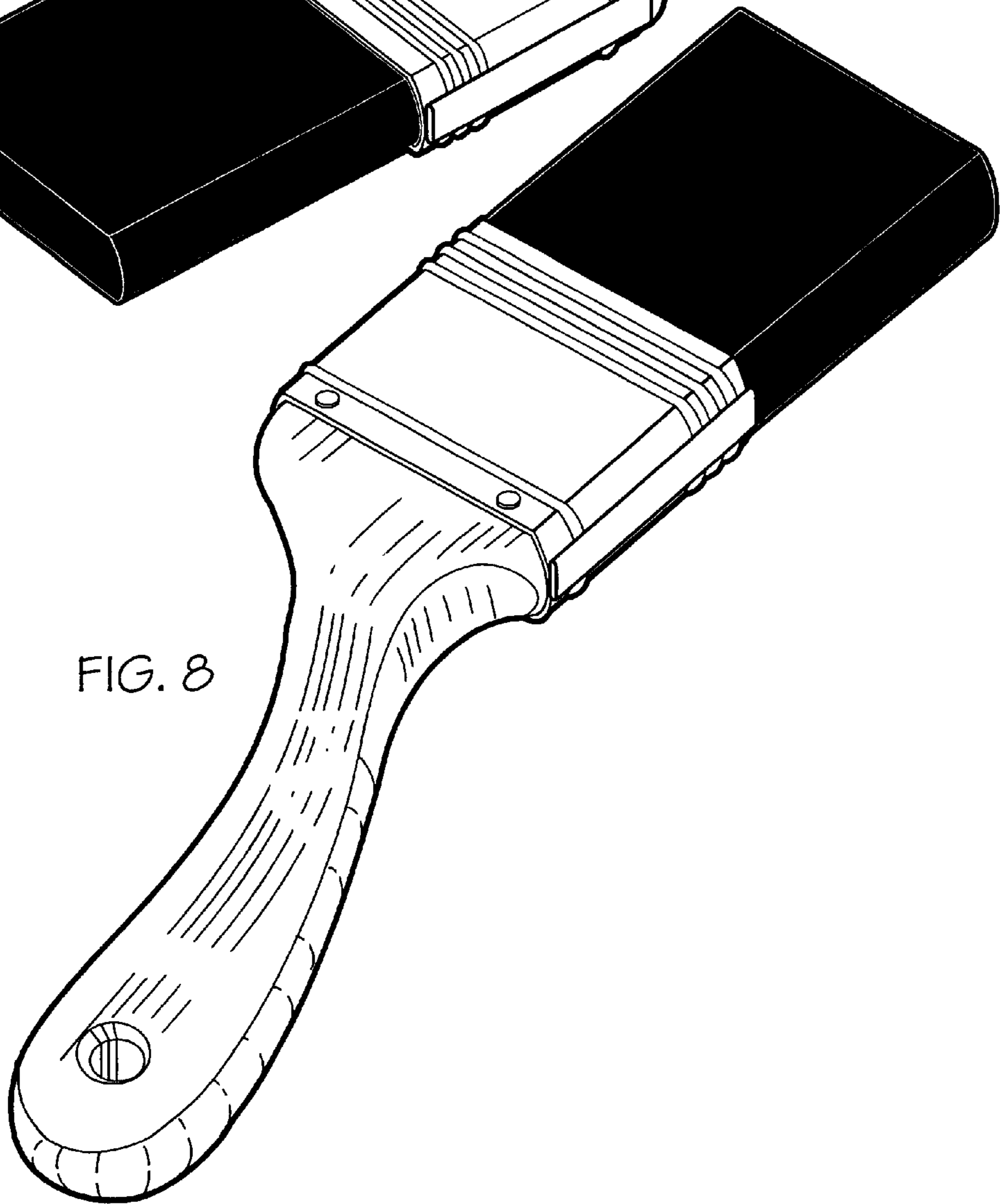

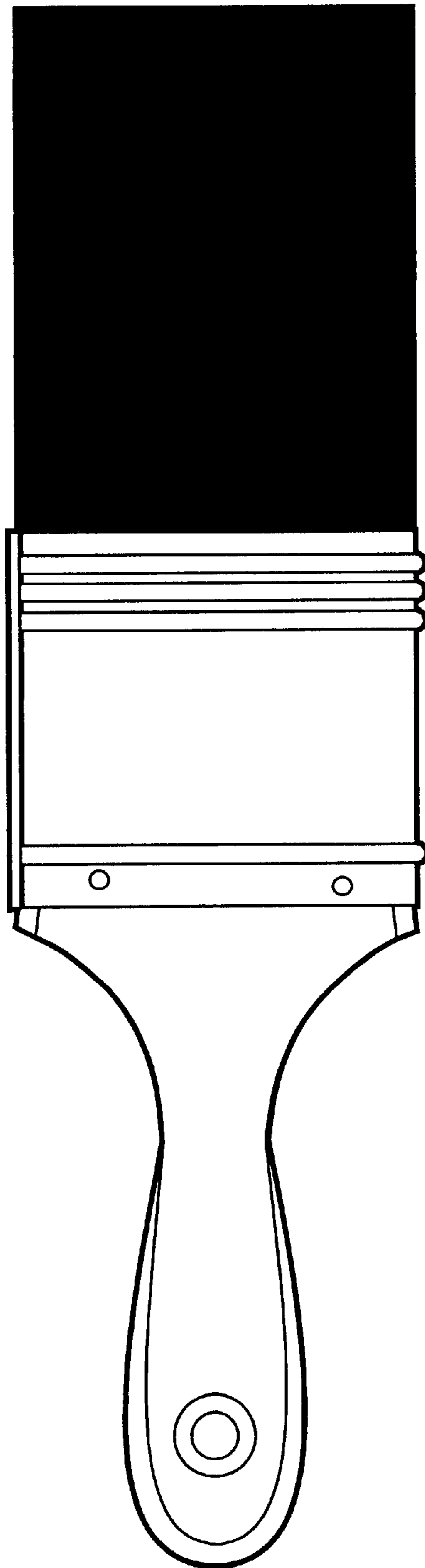
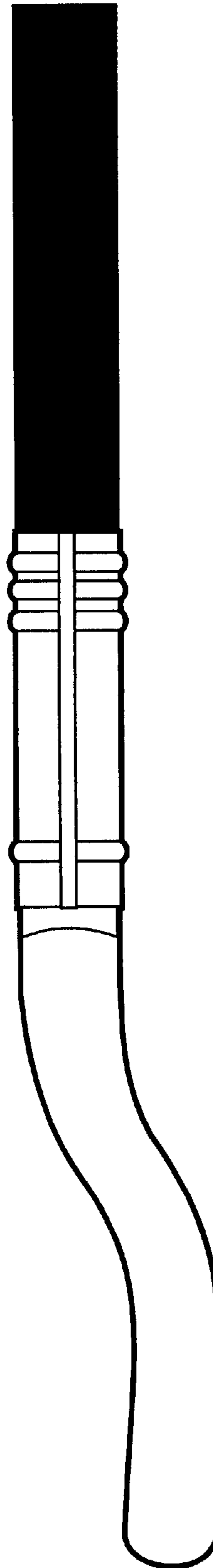

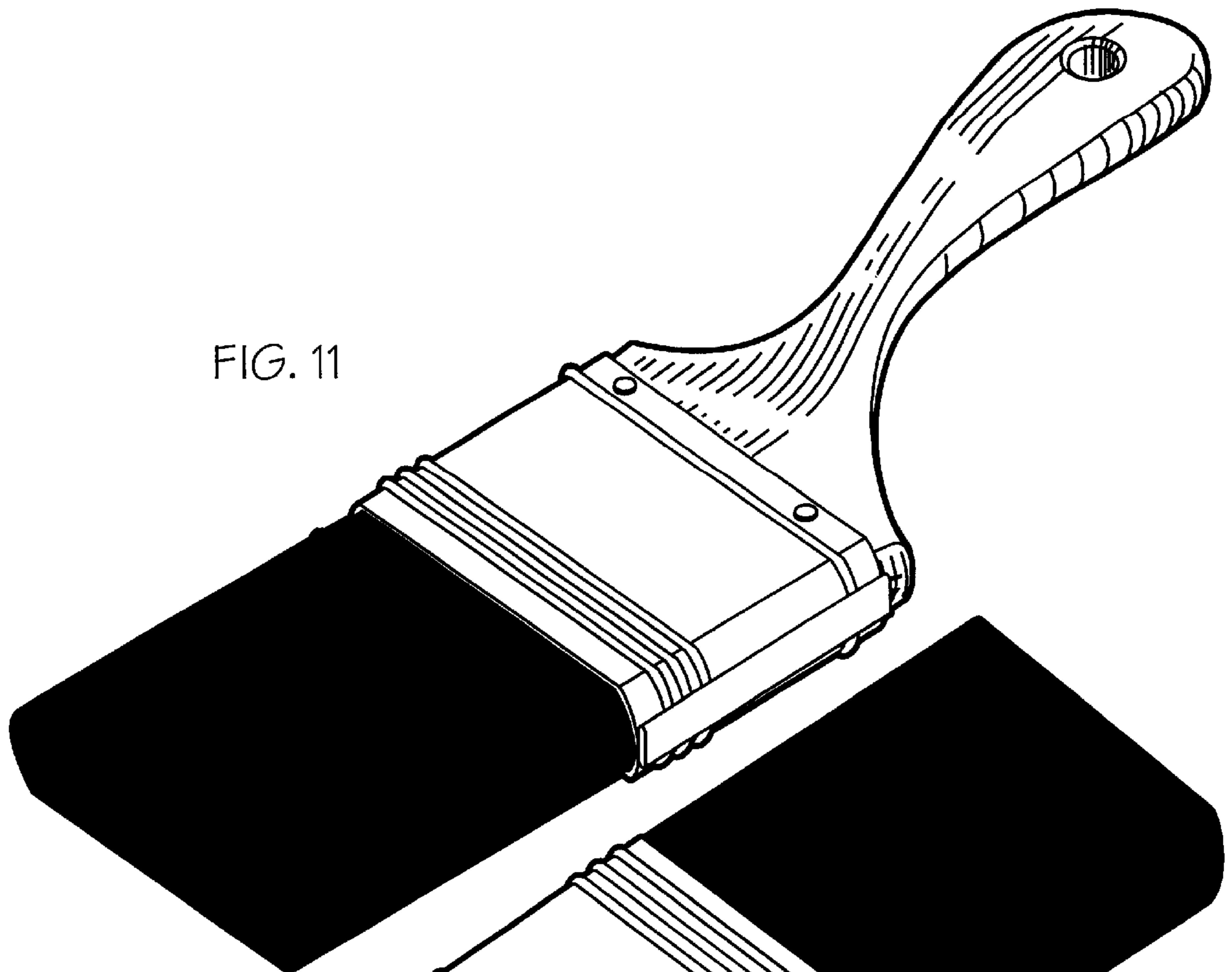

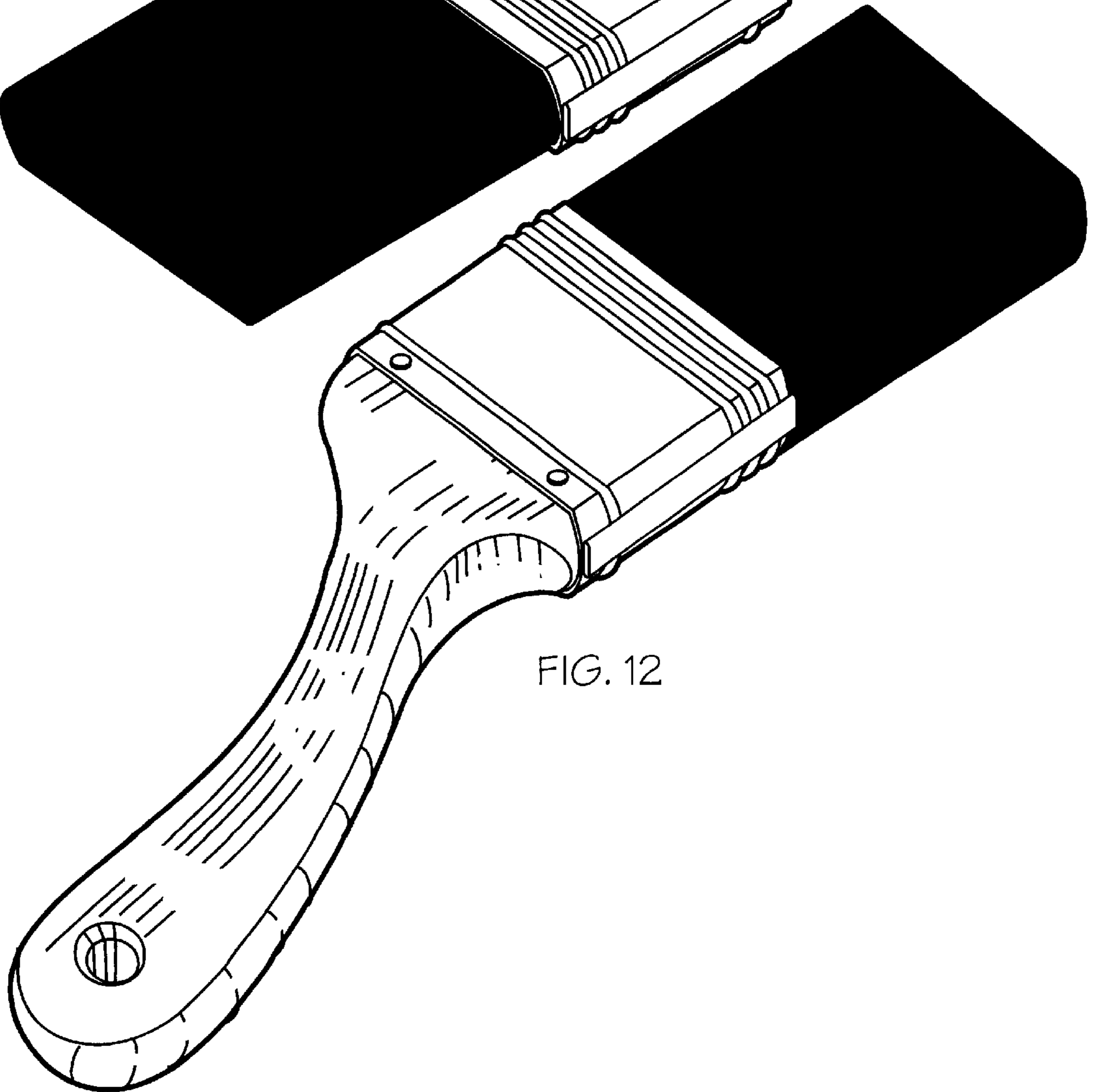

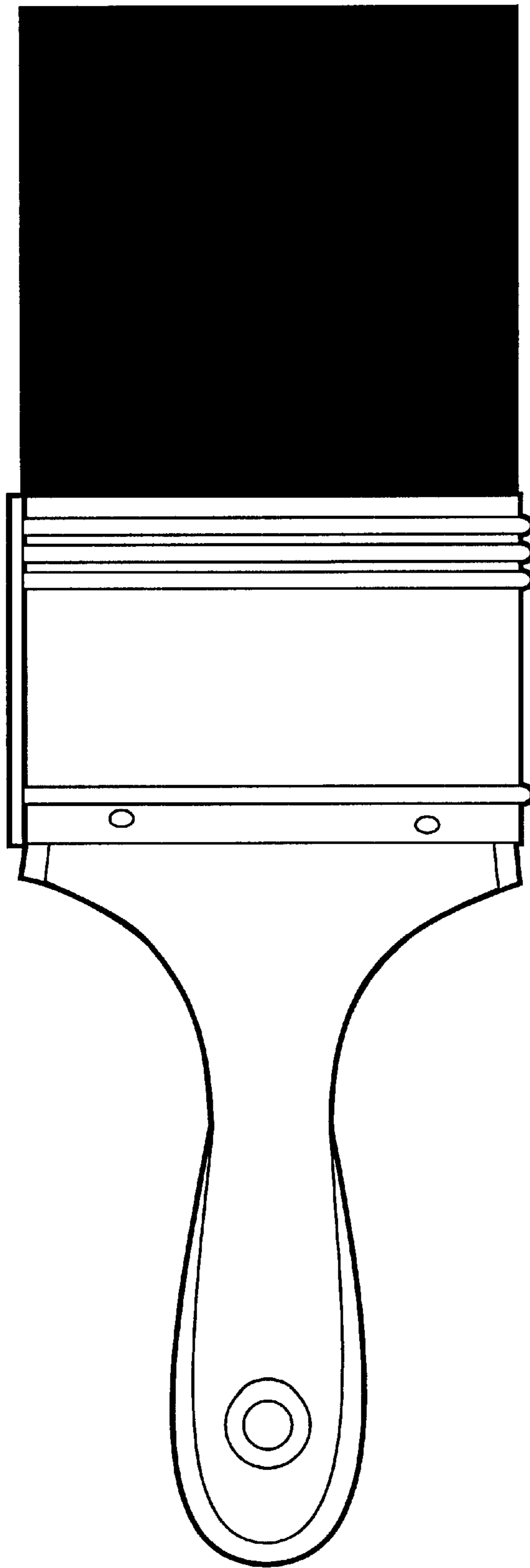
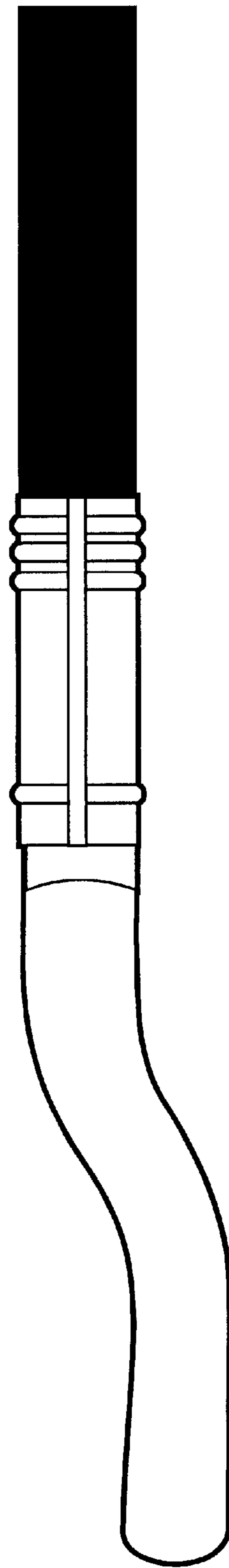

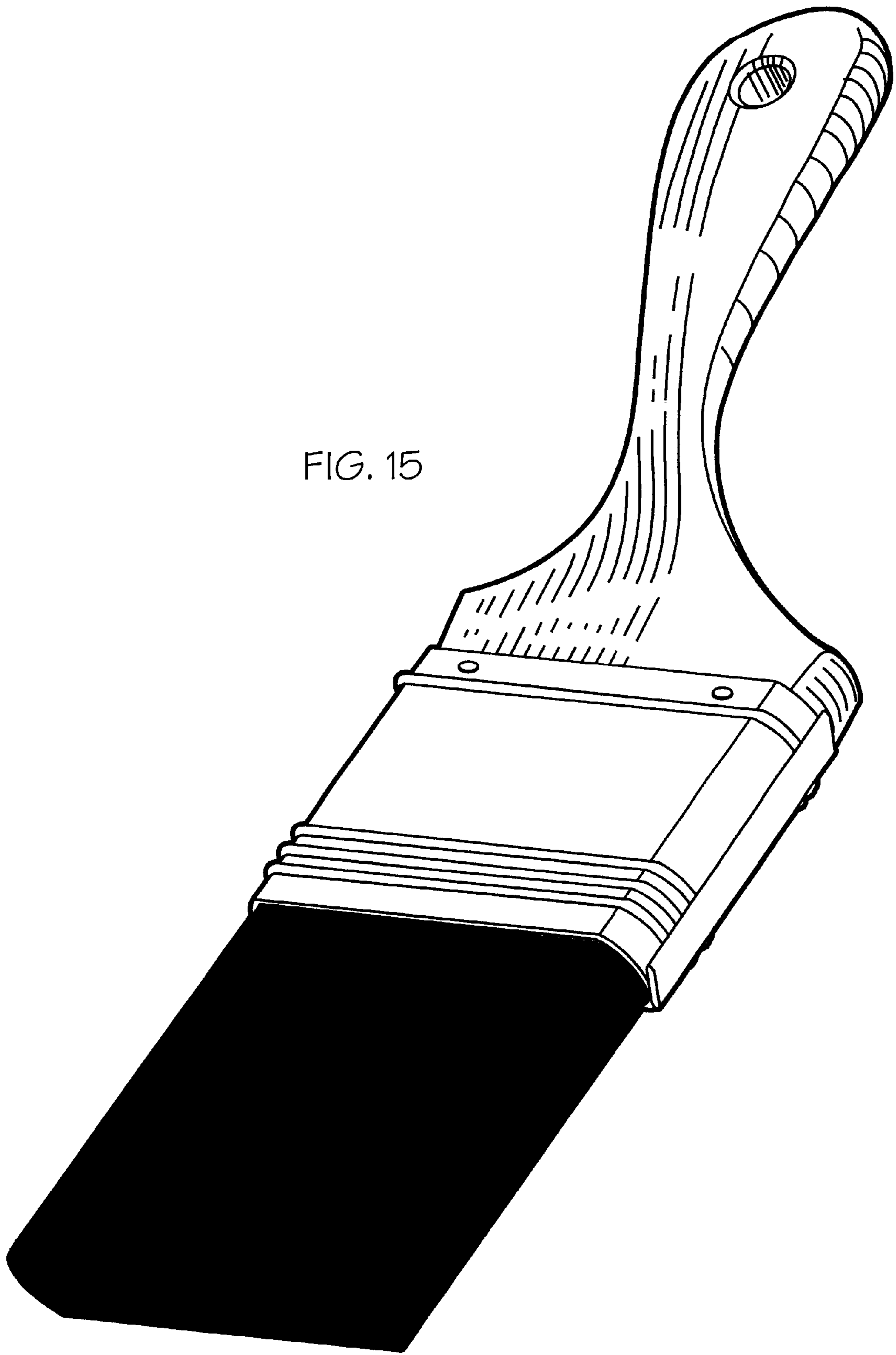

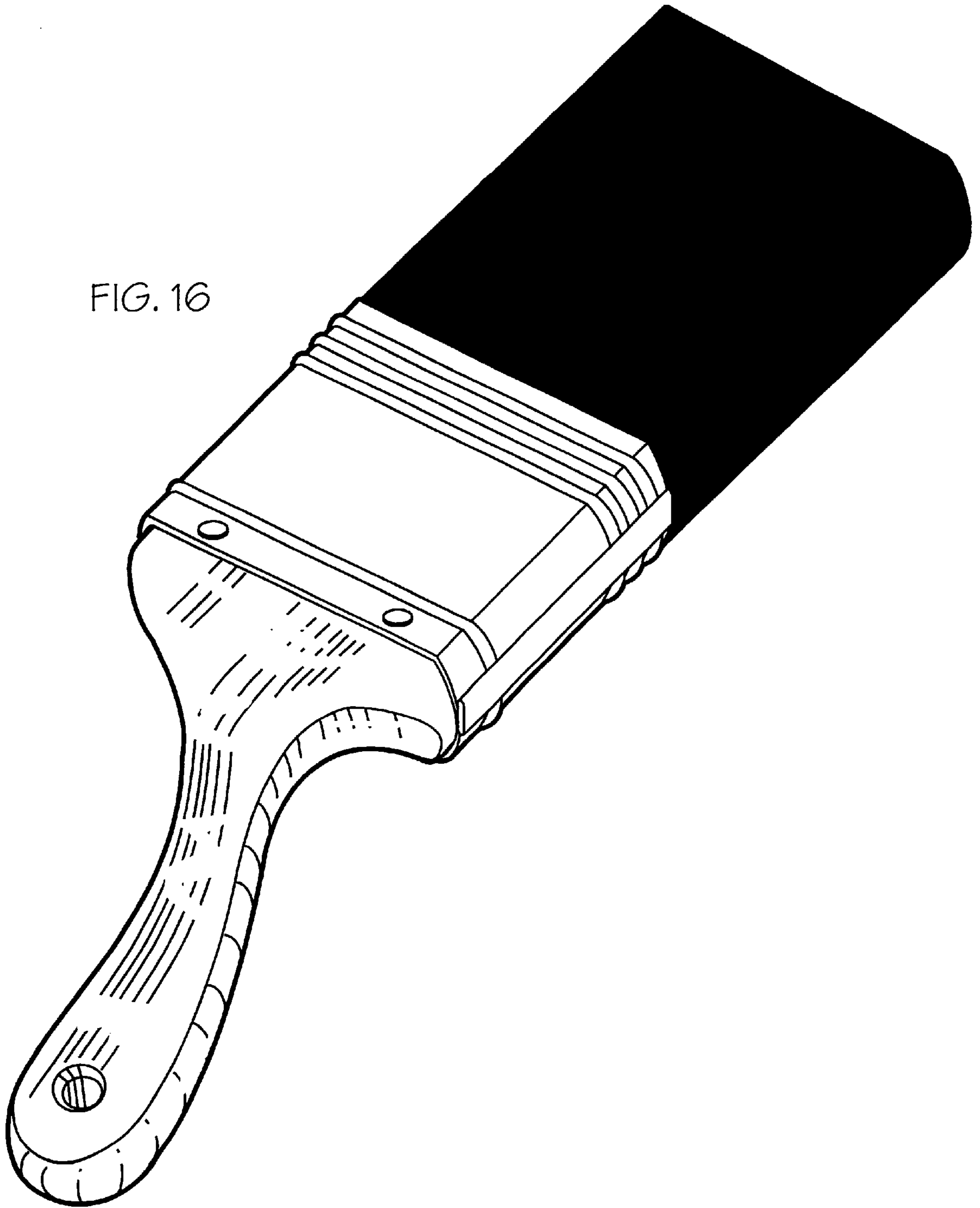

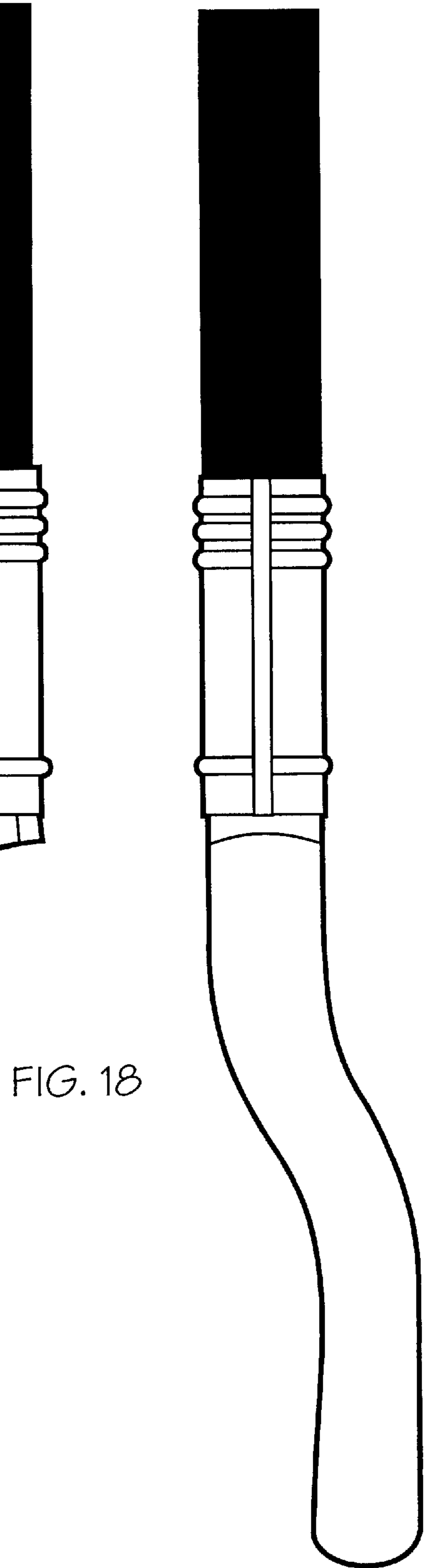
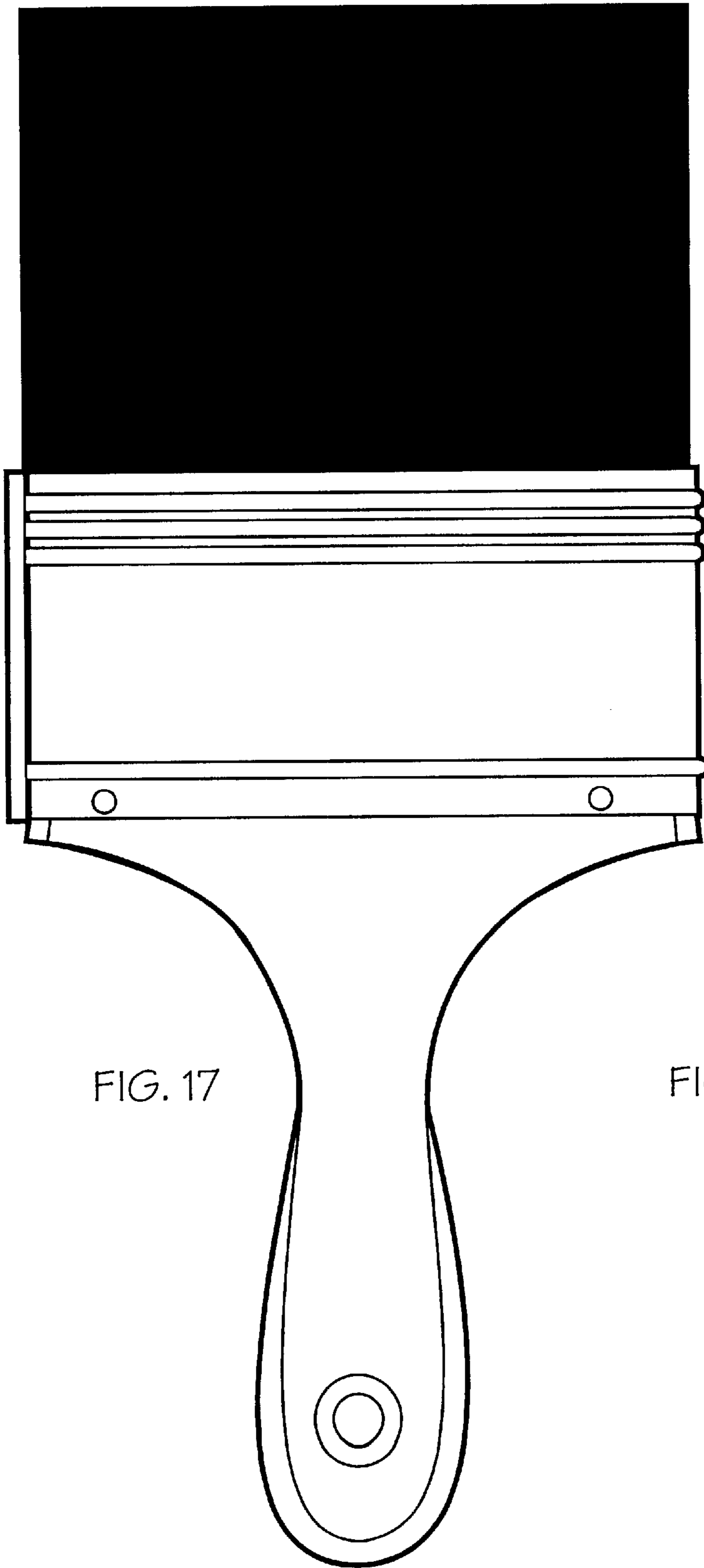

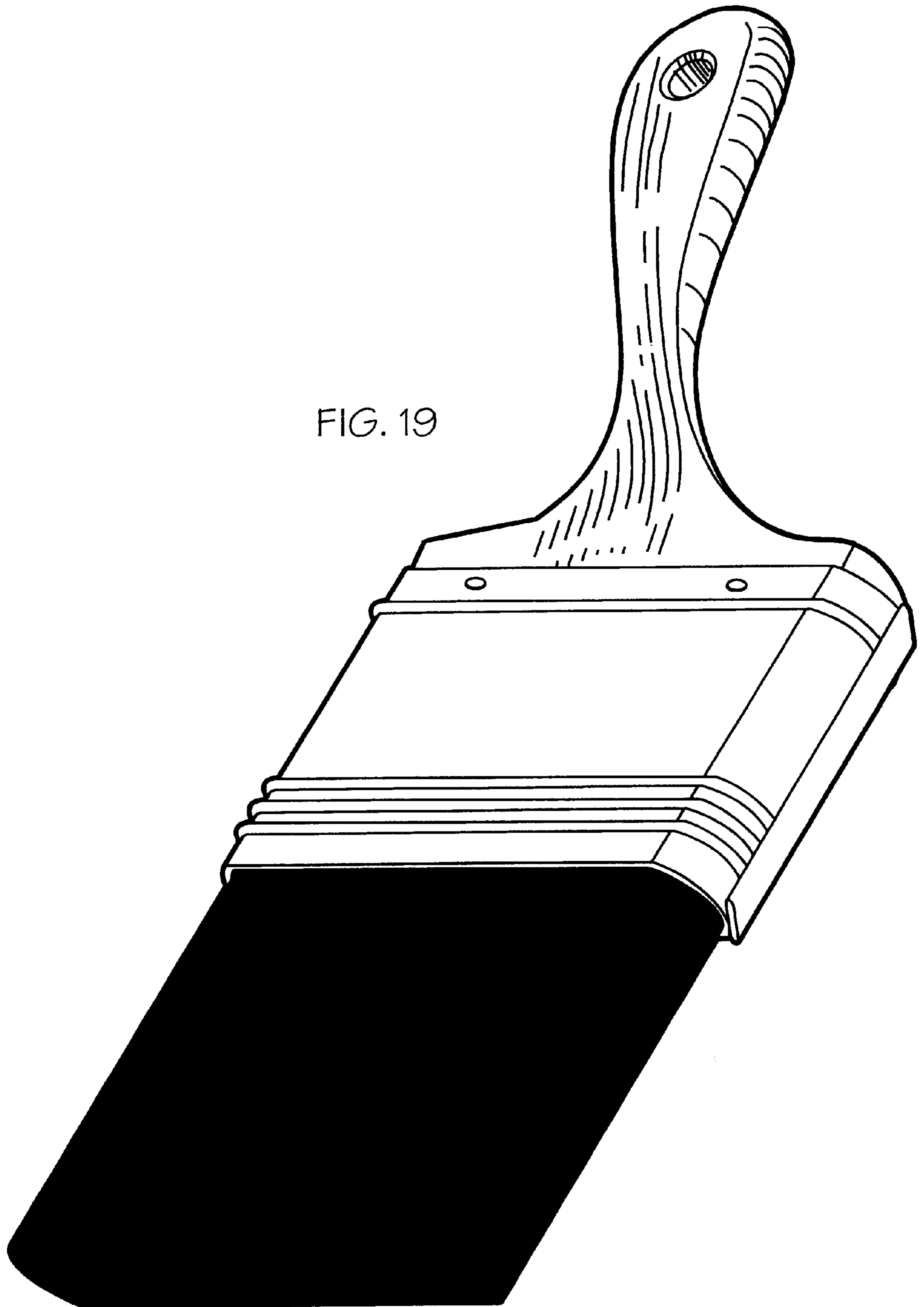
