(57) **CLAIM**

The ornamental design for the furniture stile and post, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of my new design for a furniture stile and post, showing it incorporated in a bed frame headboard.

FIG. 2 is a left side elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a right side elevational view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof.

FIG. 7 is a cross-sectional view along Line 7—7 of FIG. 2. The broken line elements of the bed frame are solely to illustrate the first embodiment of my new design, and form no part of the claimed design.

FIG. 8 is a front elevational view of a second embodiment of my new design for a furniture stile and post, showing it incorporated in a bed frame footboard.

FIG. 9 is a left side elevational view thereof.

FIG. 10 is a rear elevational view thereof.

FIG. 11 is a right side elevational view thereof.

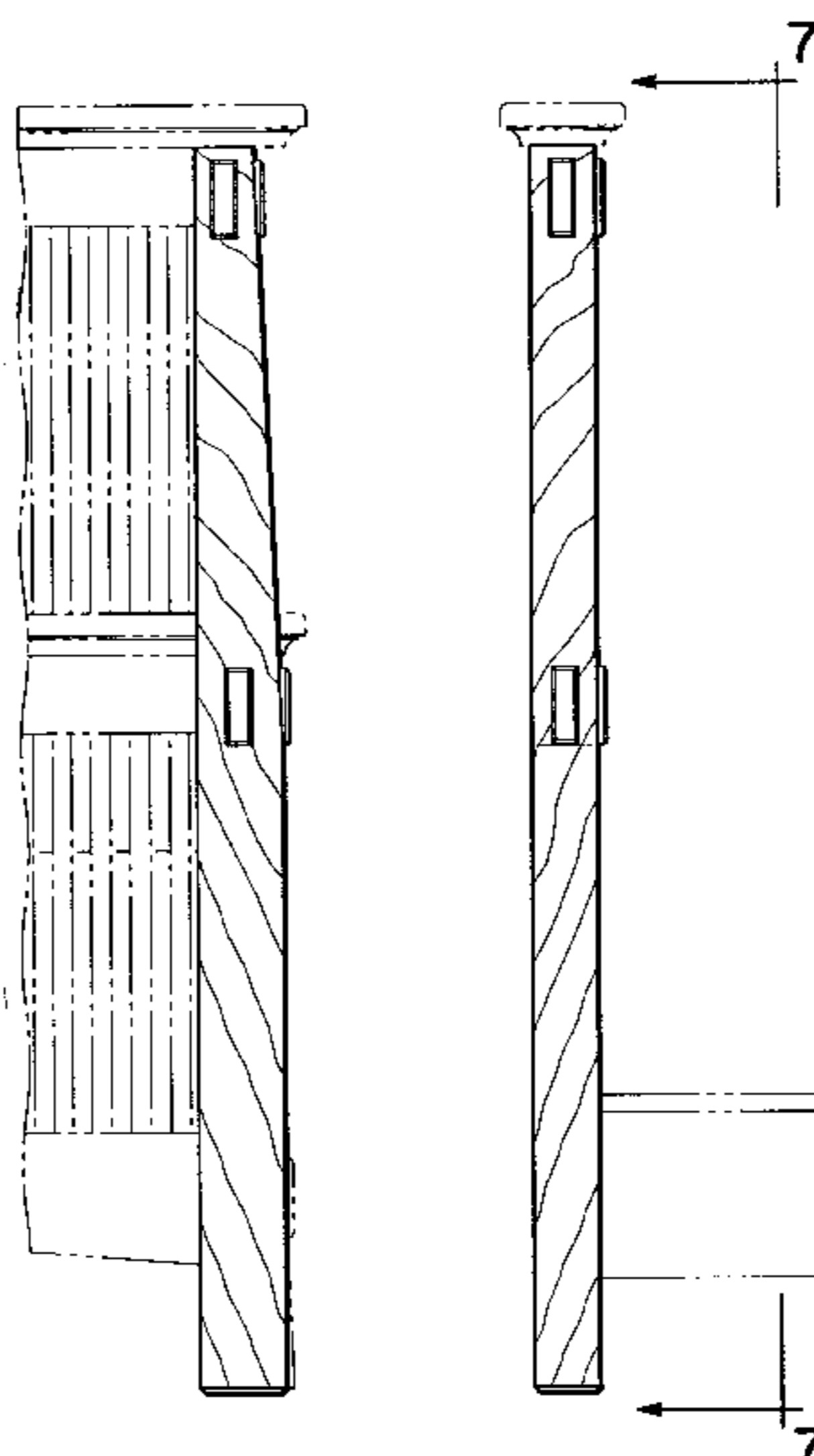
FIG. 12 is a top plan view thereof.

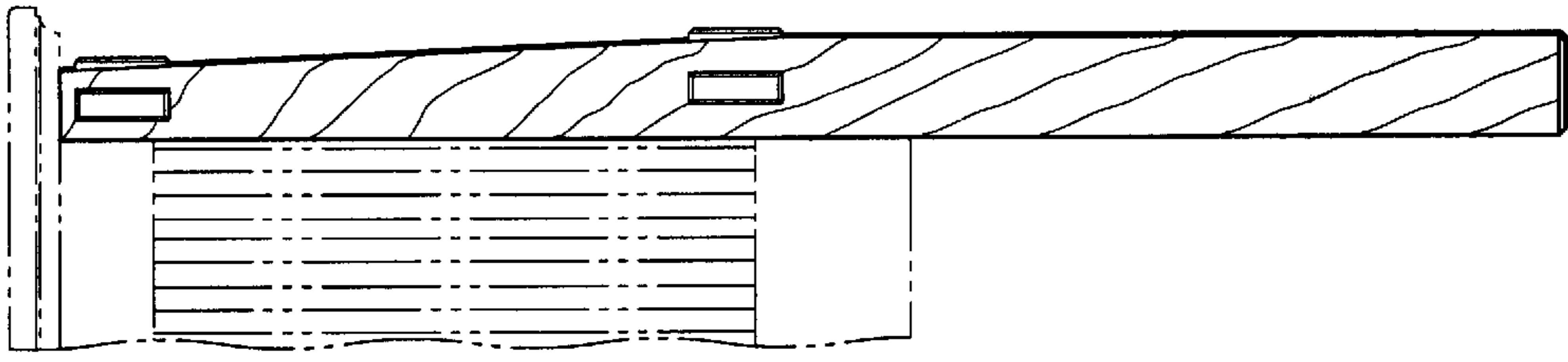

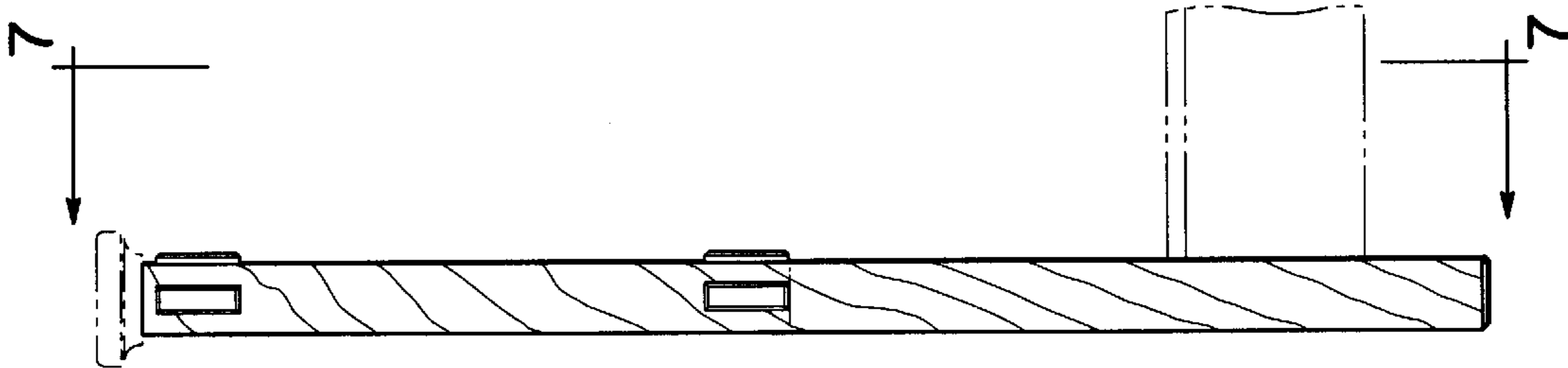

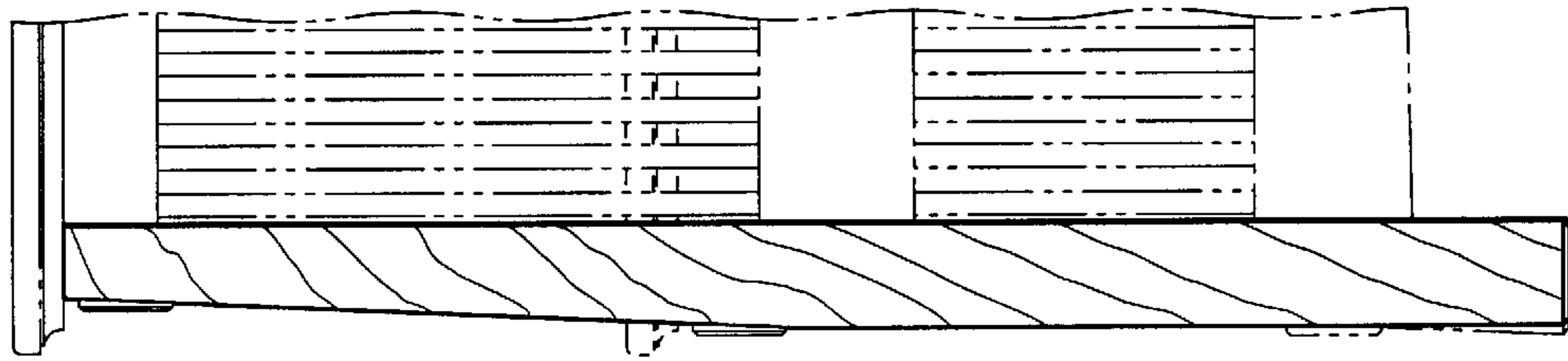

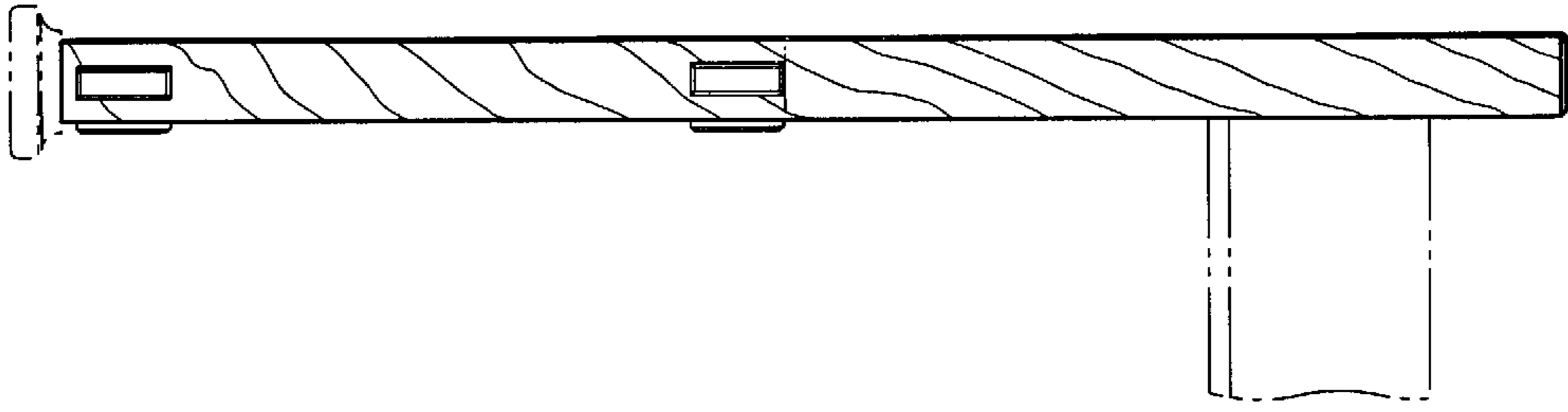

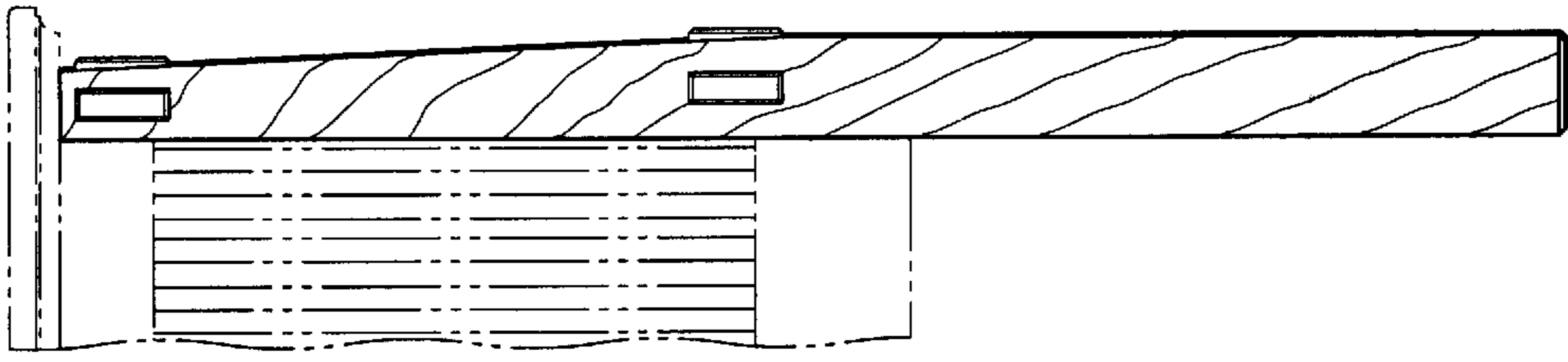

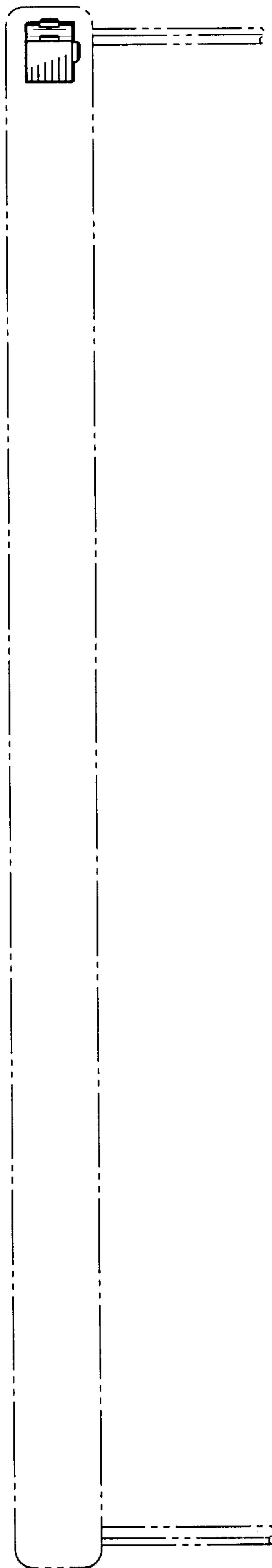

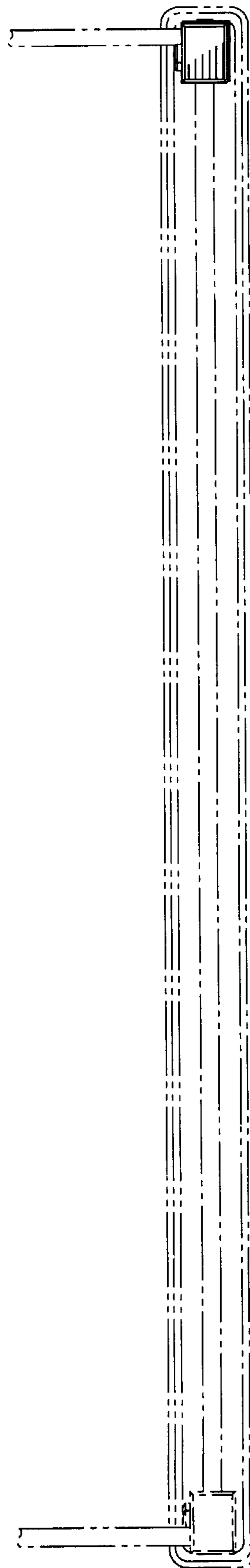

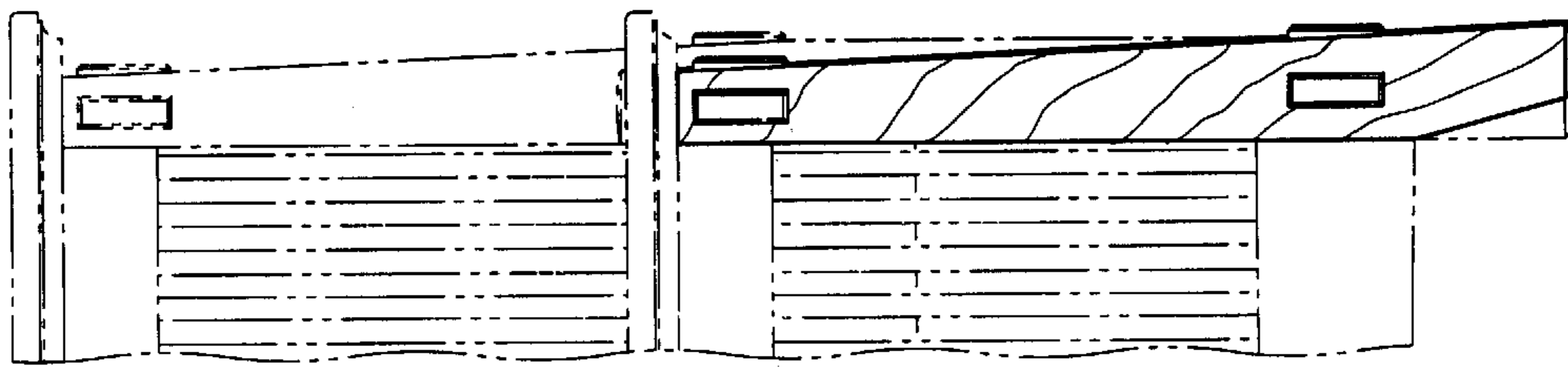

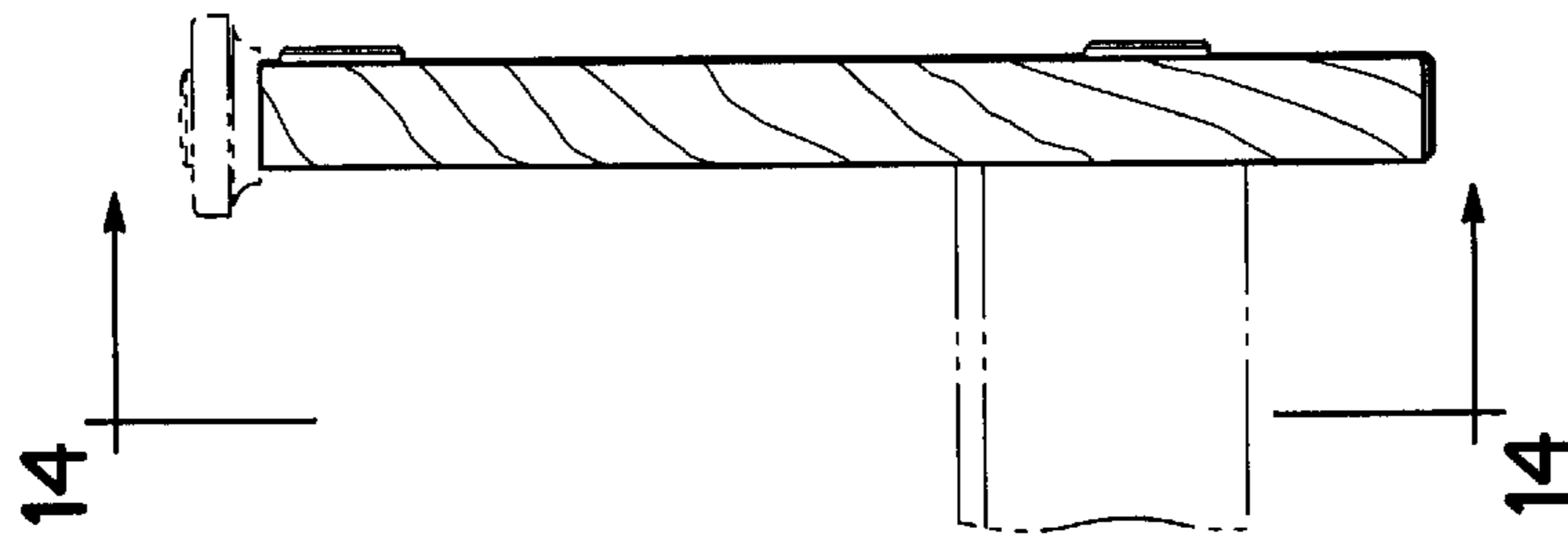

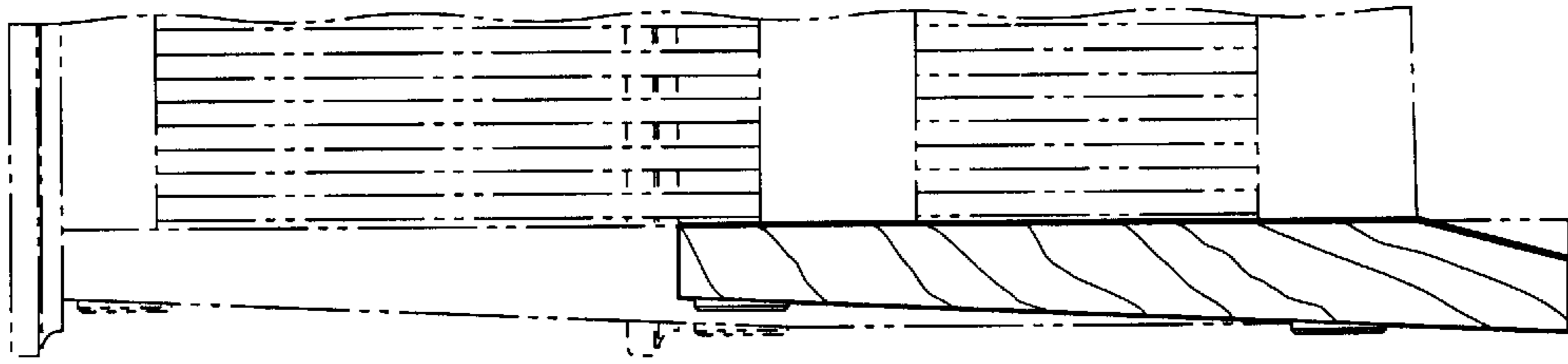

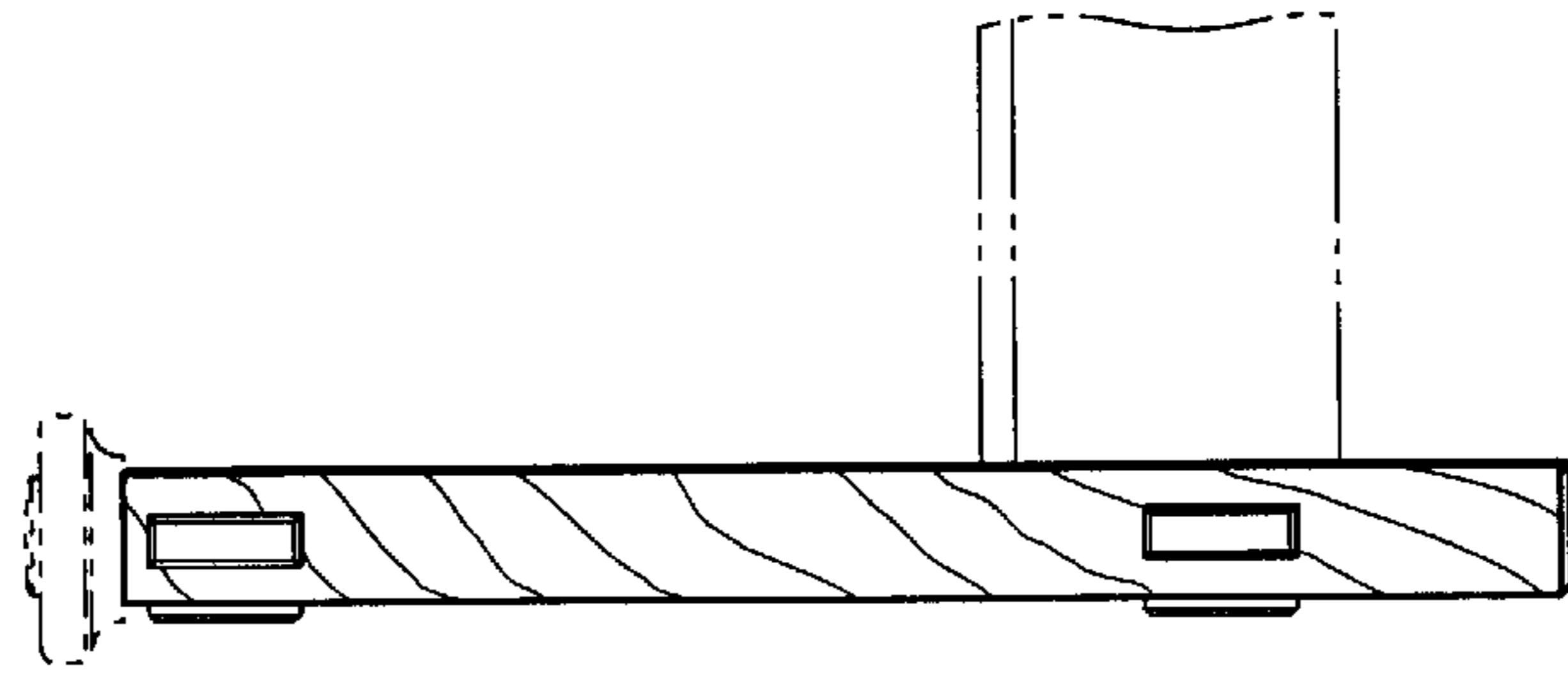

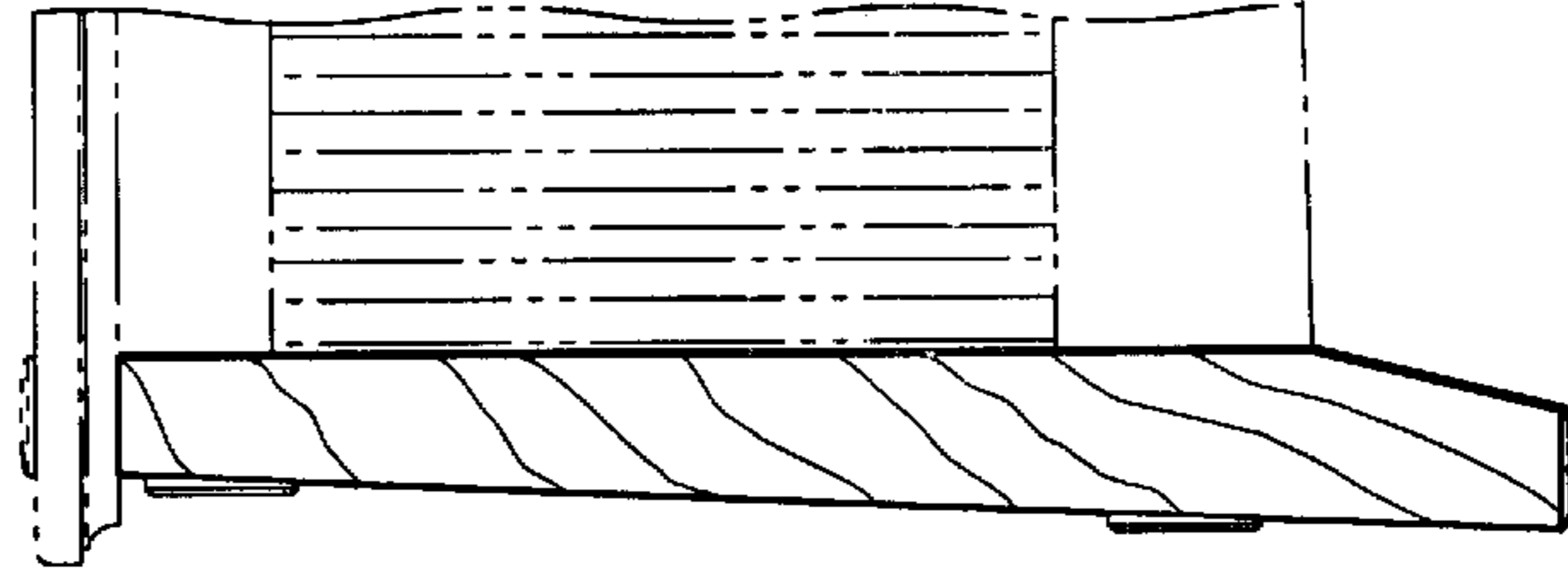

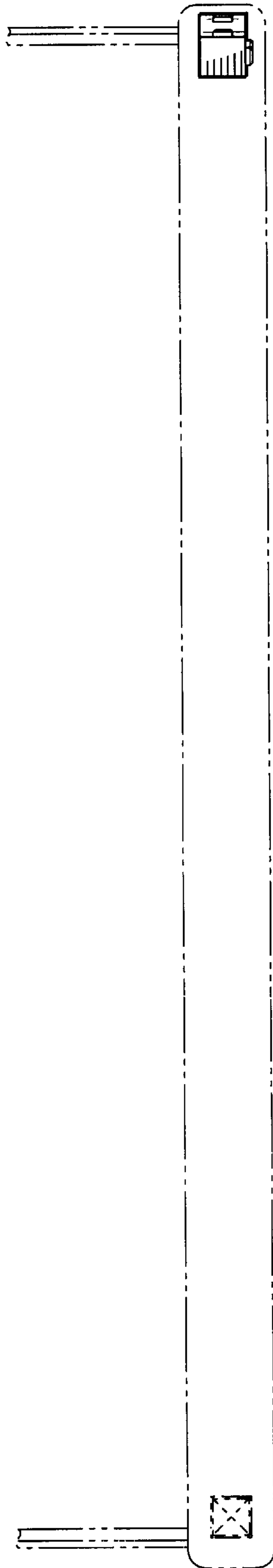

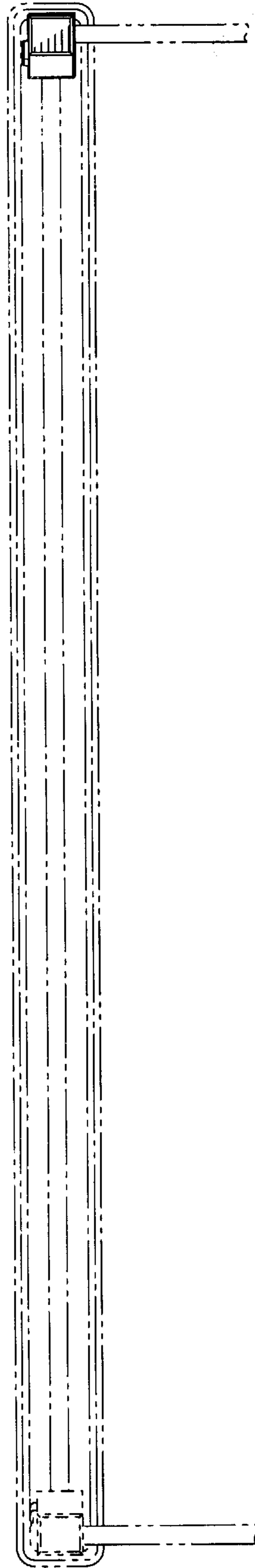
