FIG. 3 is a front side elevation view of FIG. 1.

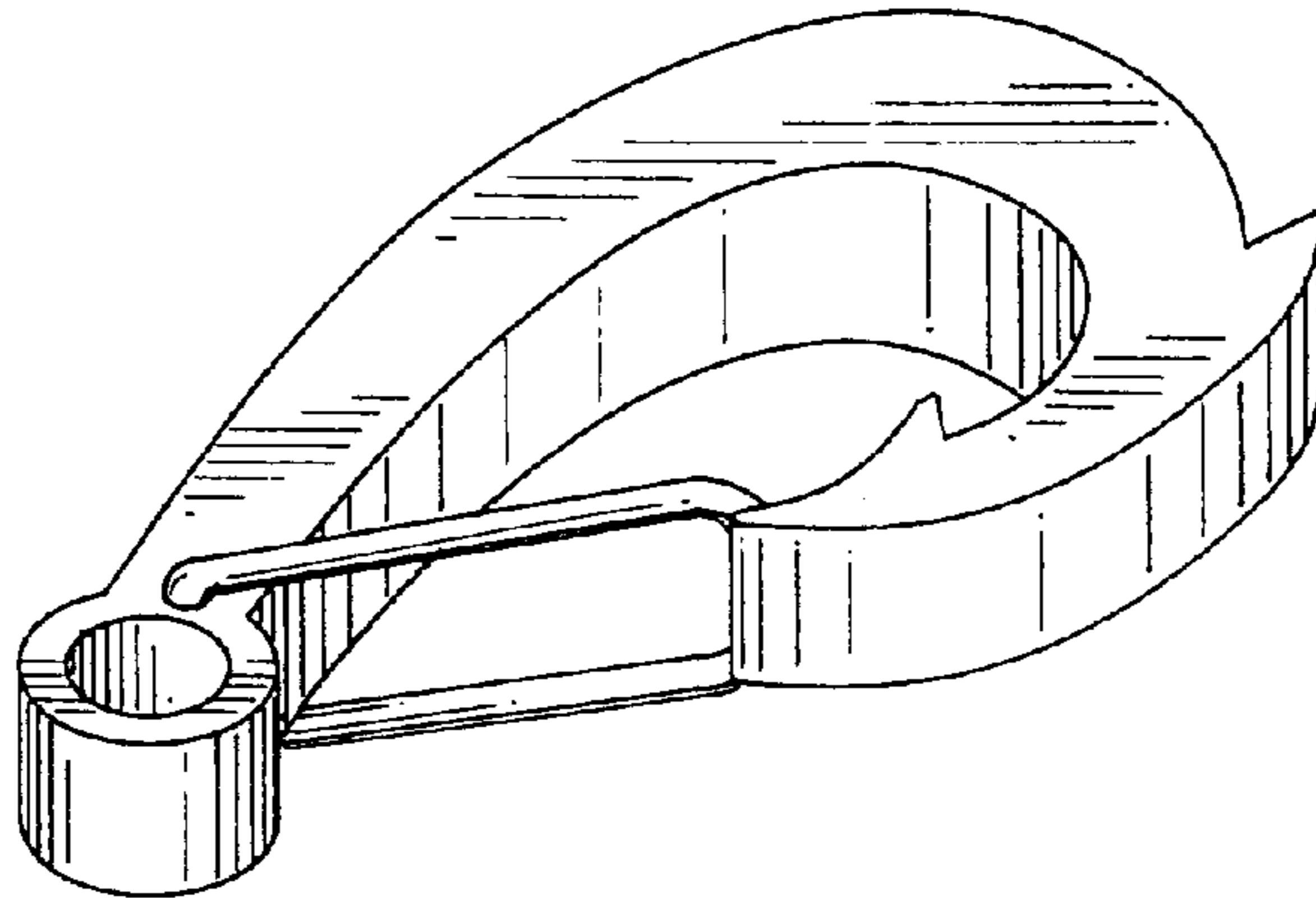
FIG. 4 is a back side elevation view of FIG. 1.

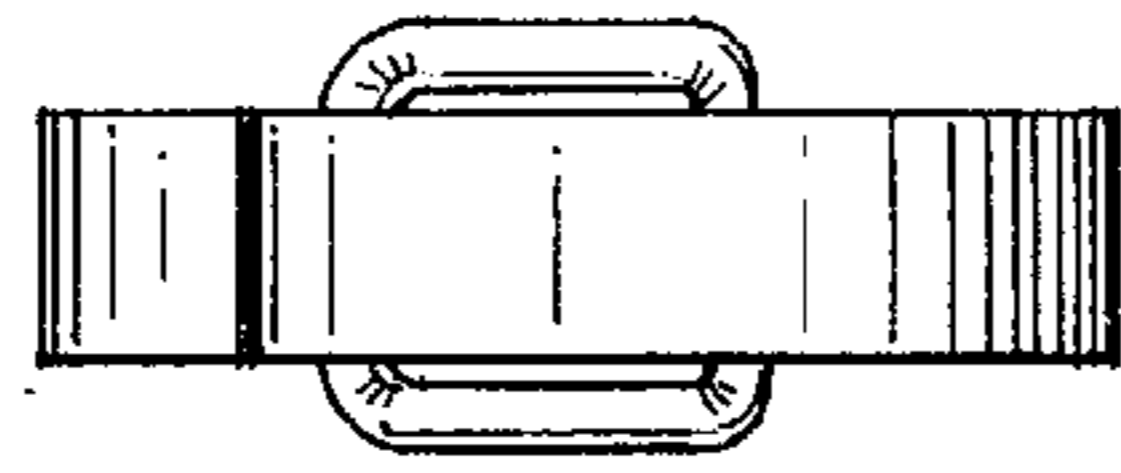

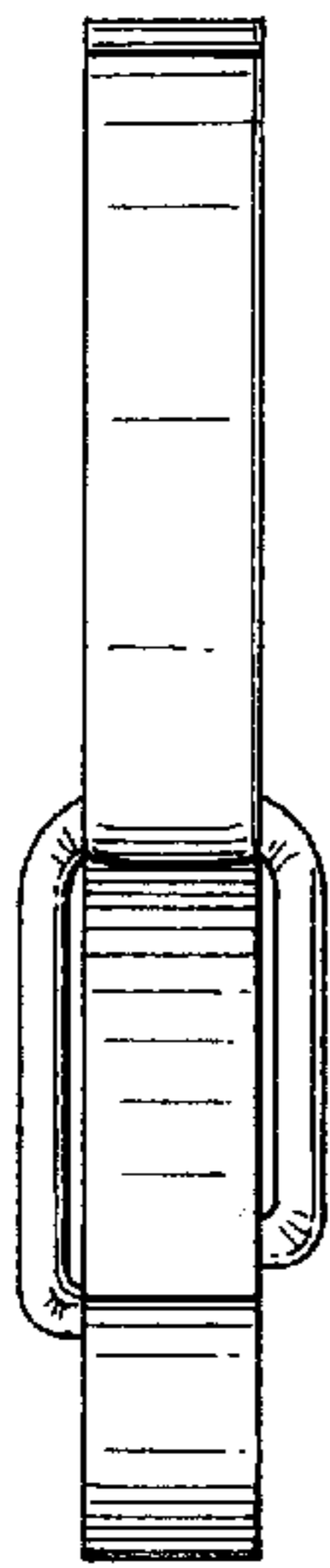

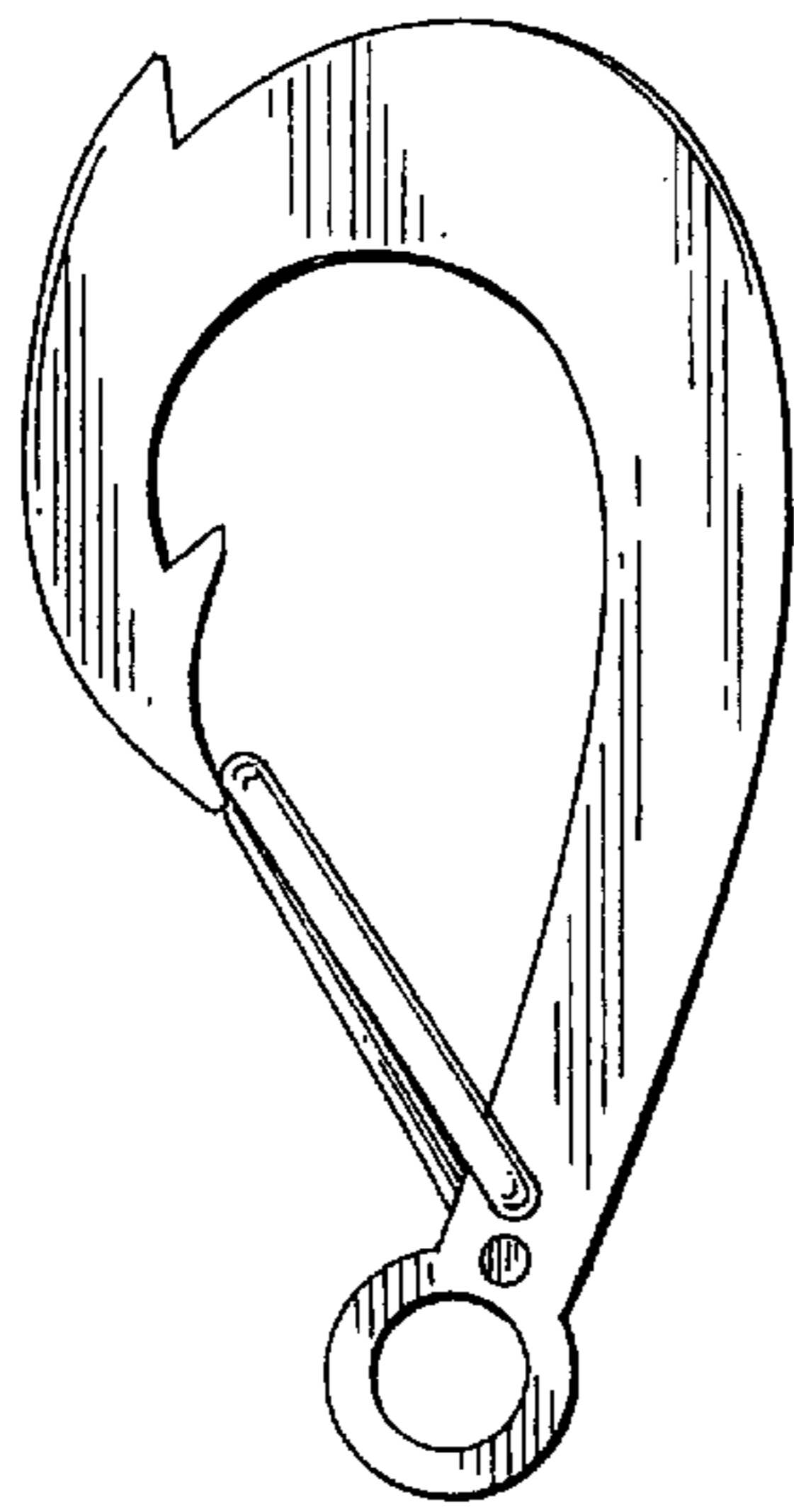

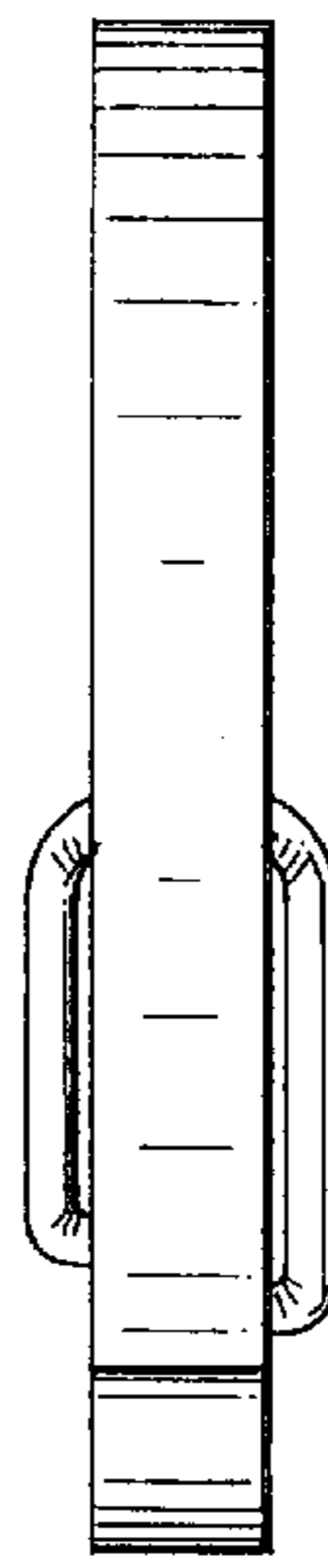

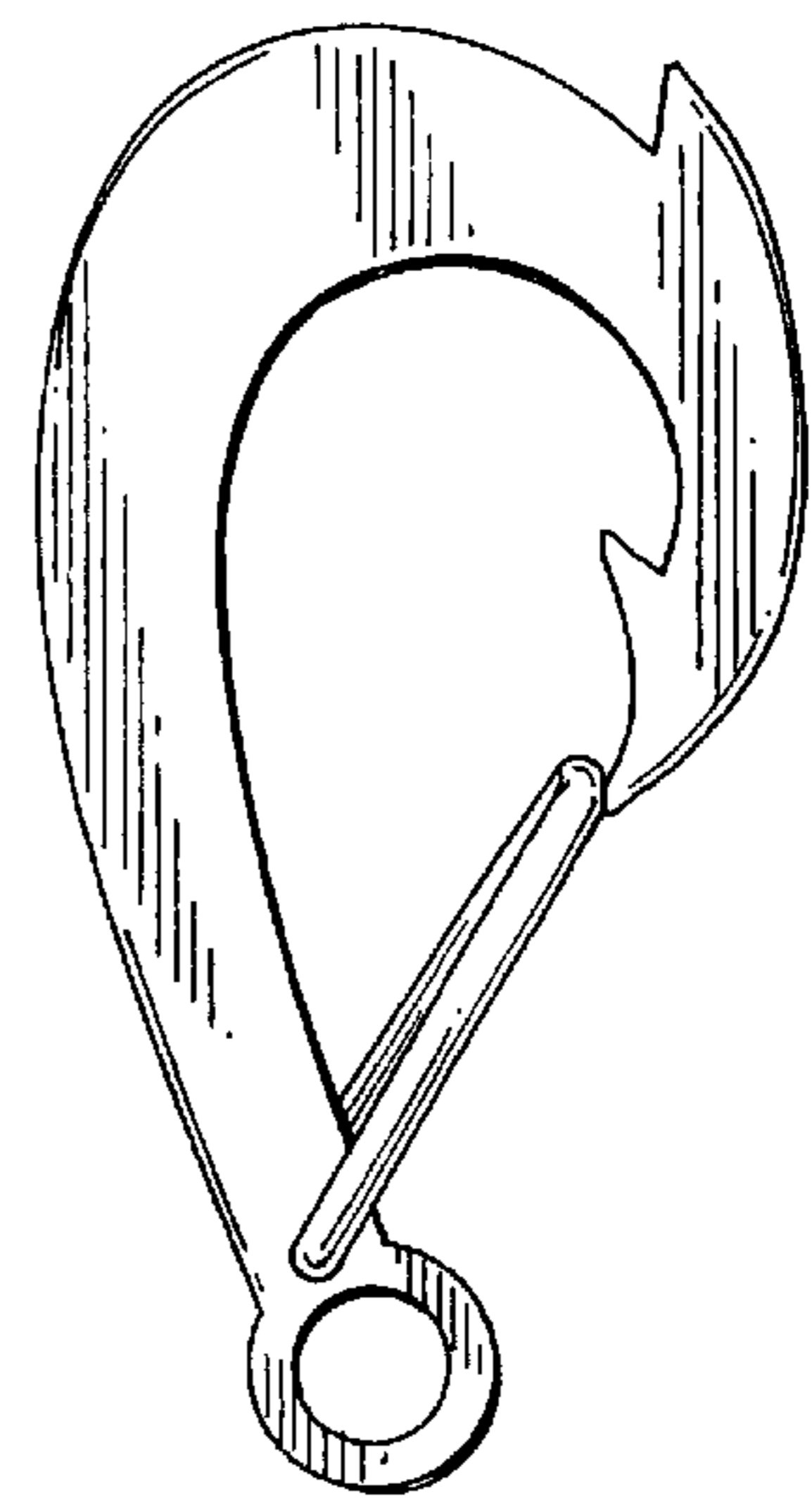

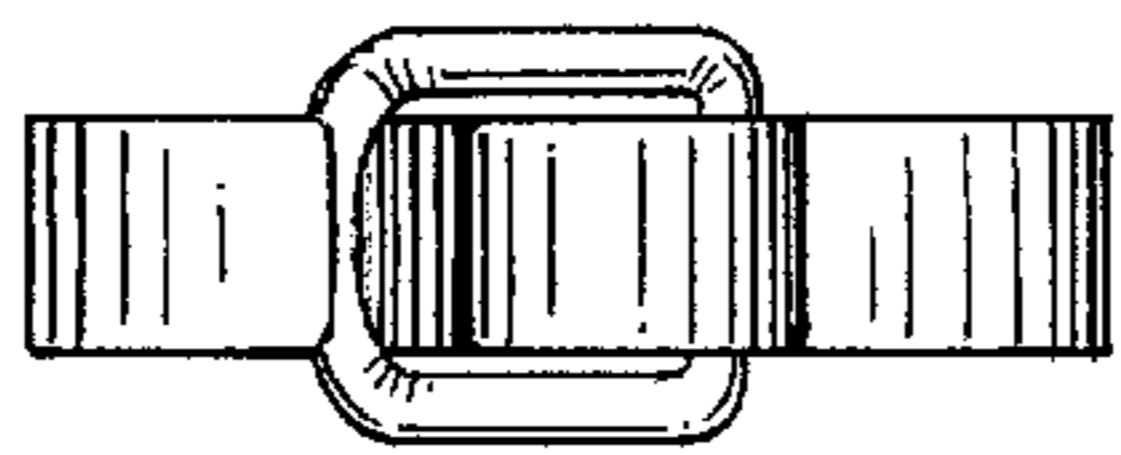

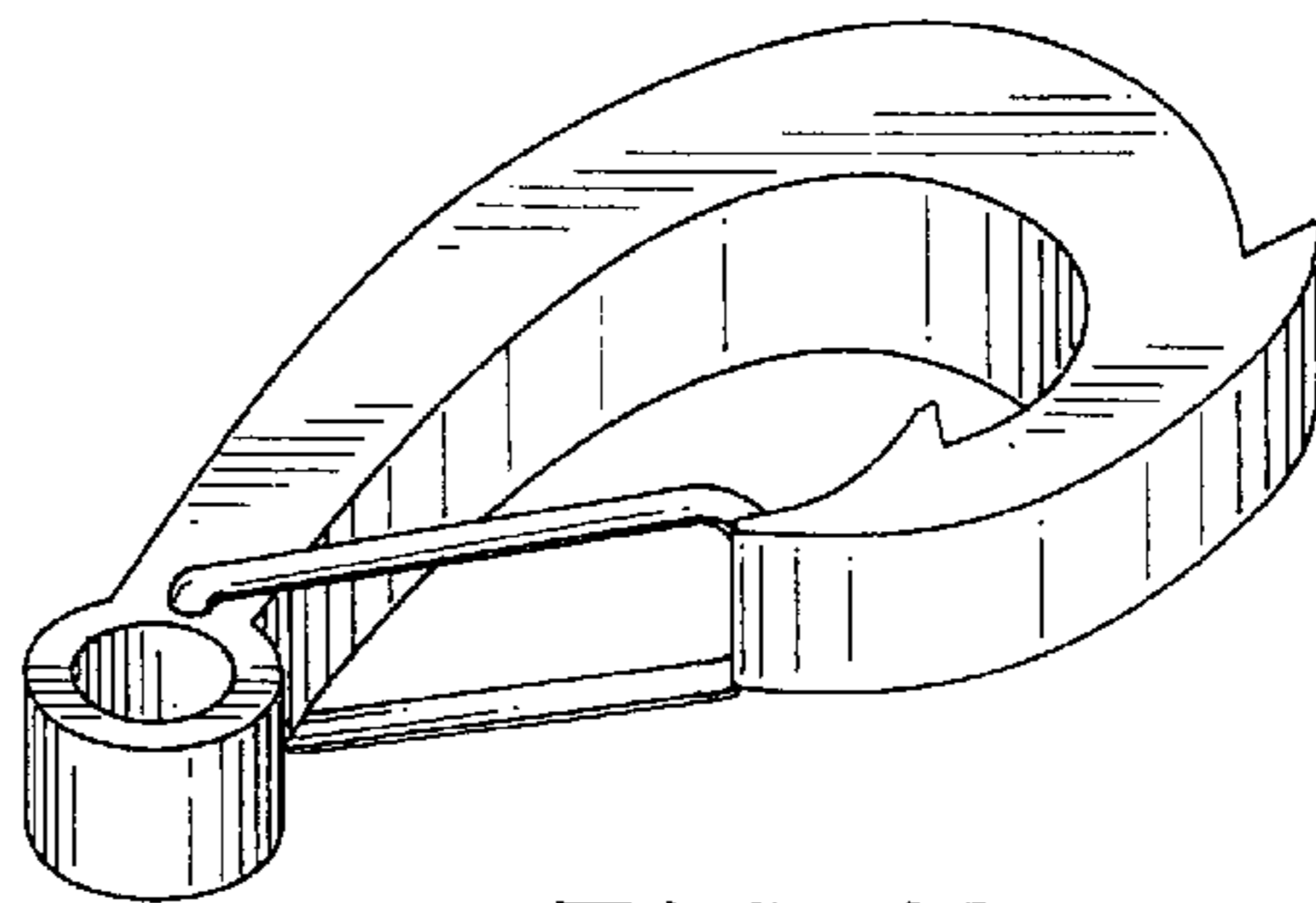
