(57) **CLAIM**

The ornamental design for a beverage bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage bottle in accordance with my new design, the broken line showing is for illustrative purposes only and forms no part of the claimed design.

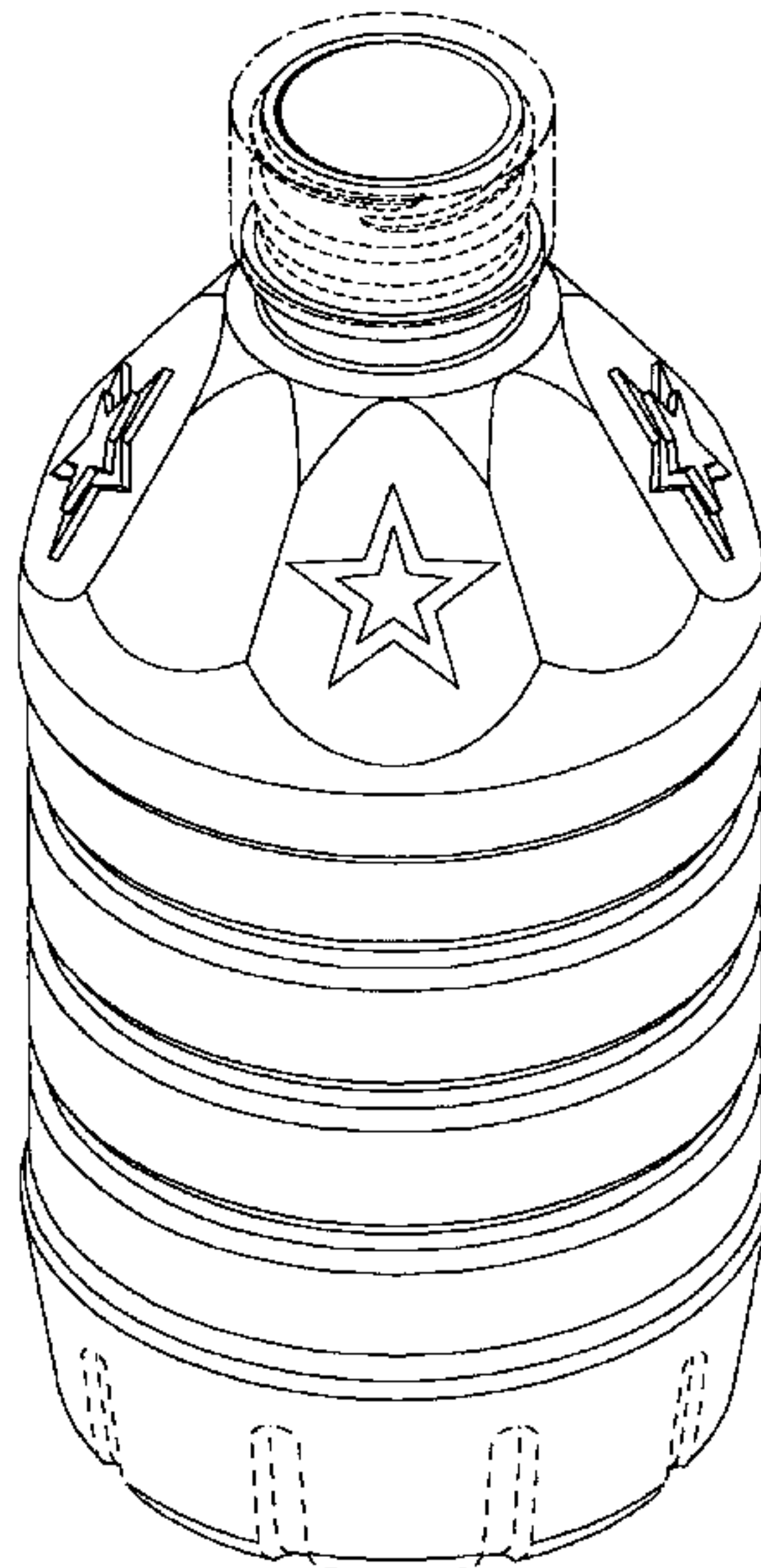
FIG. 2 is a front view of the beverage bottle shown in FIG. 1. The back view is similar and not separately illustrated herein.

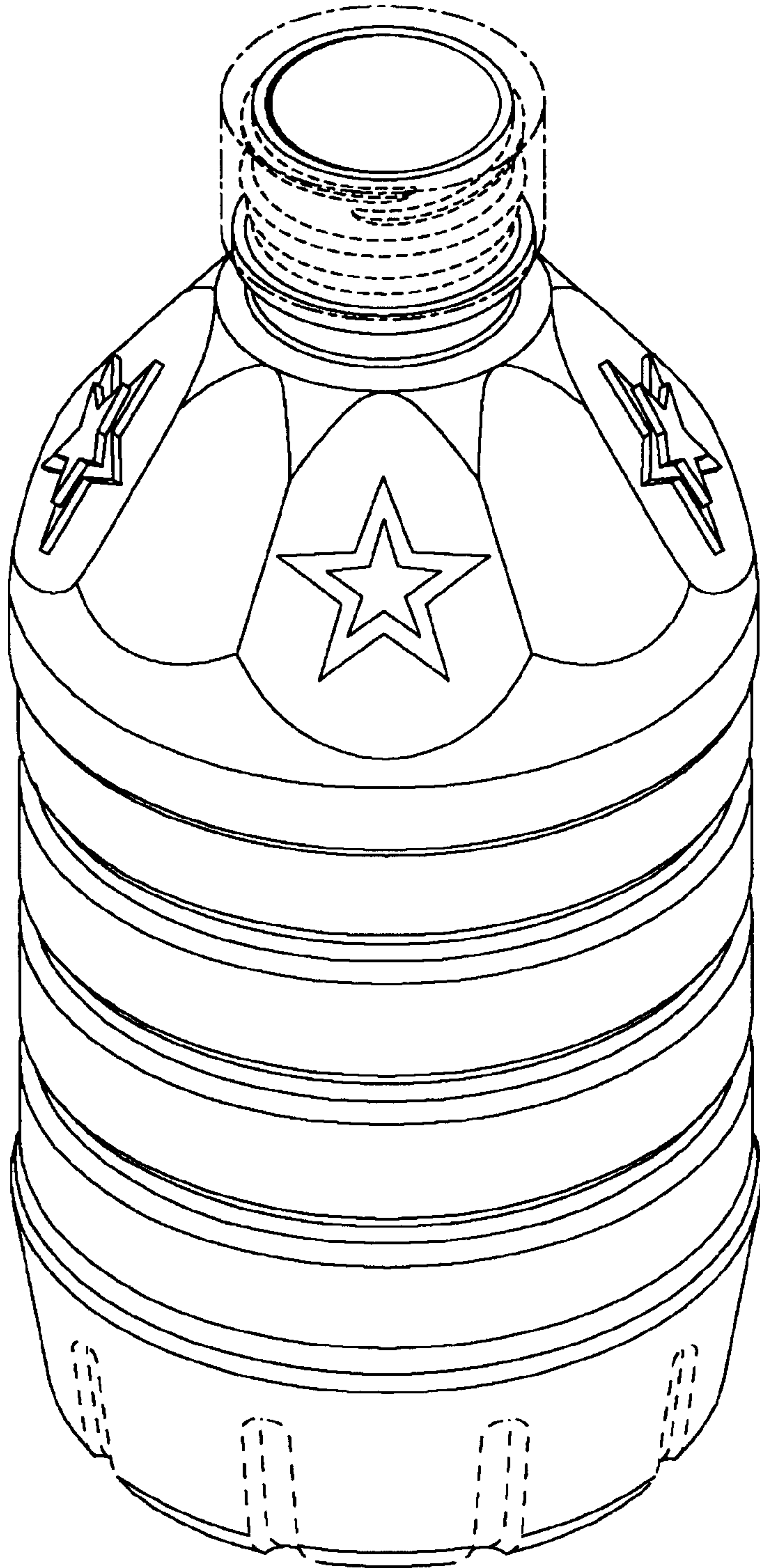

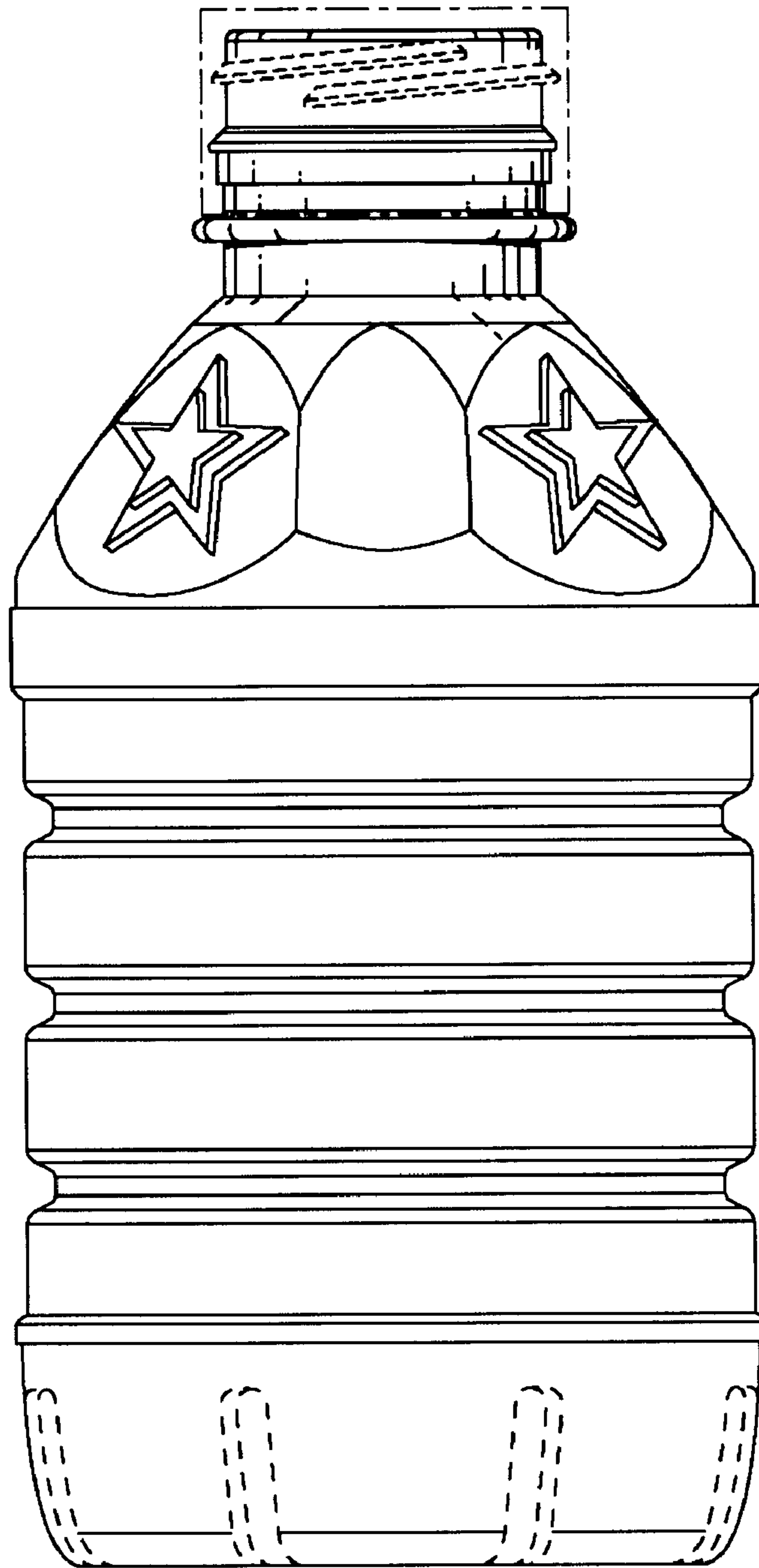

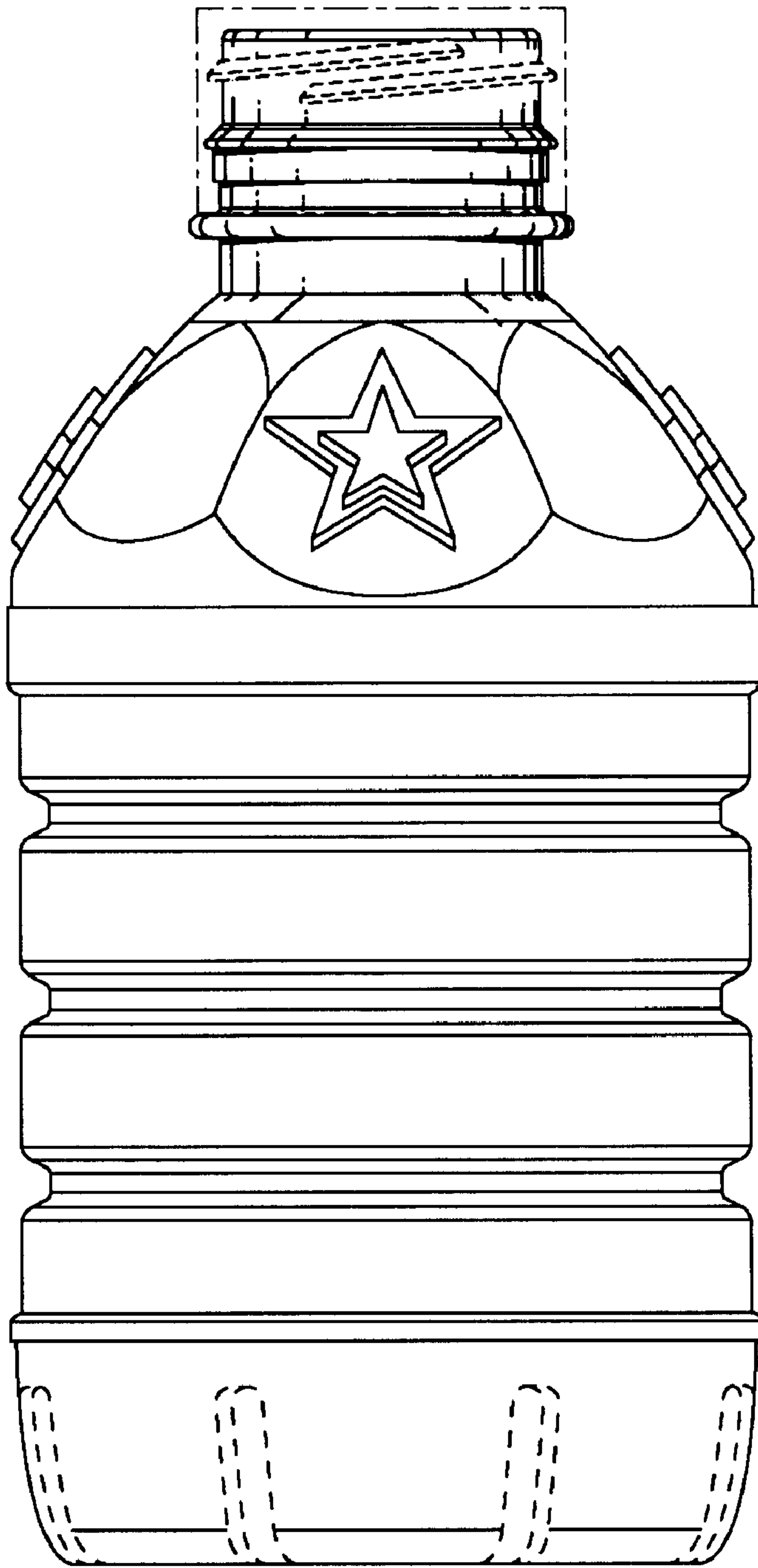

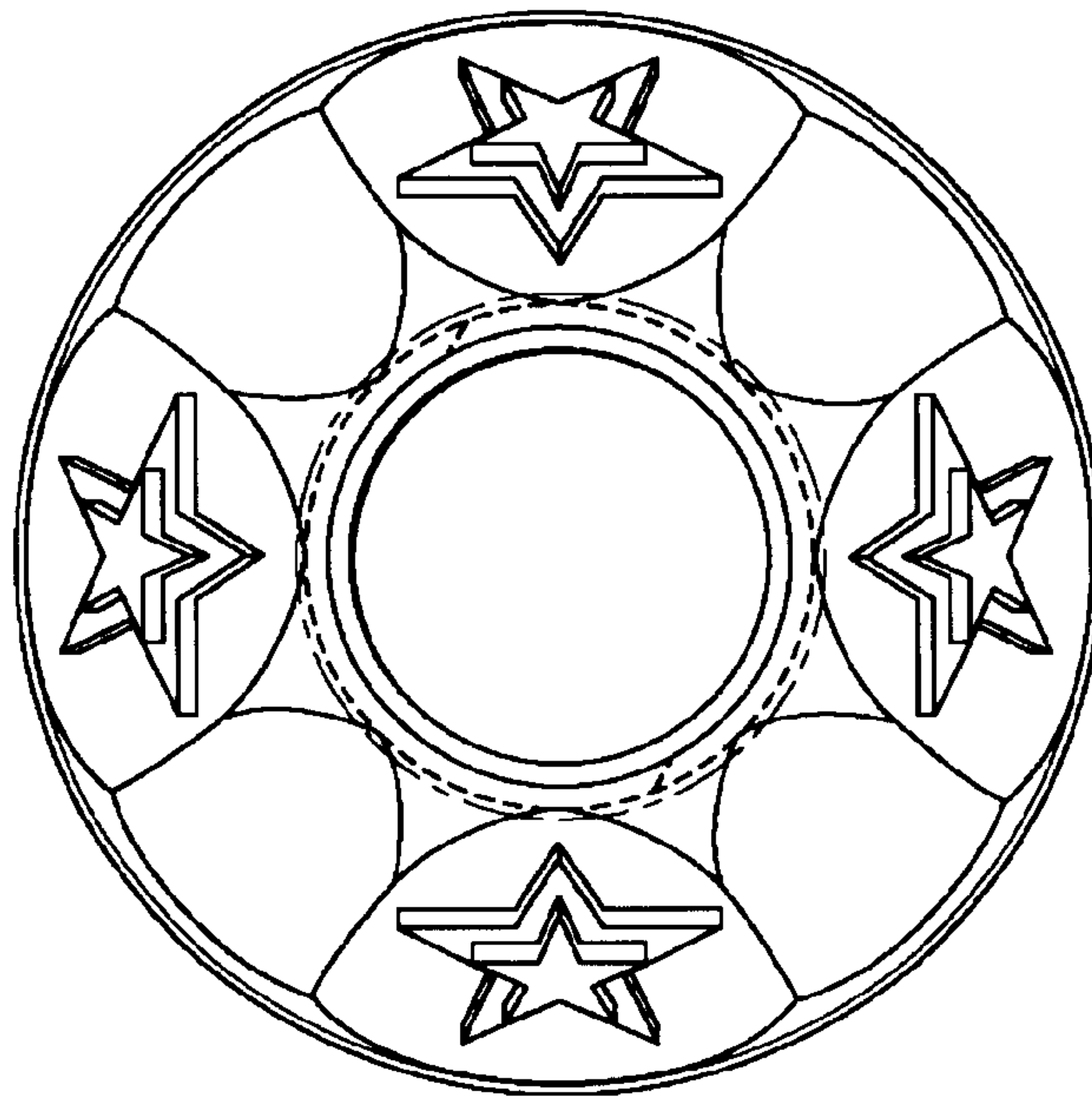

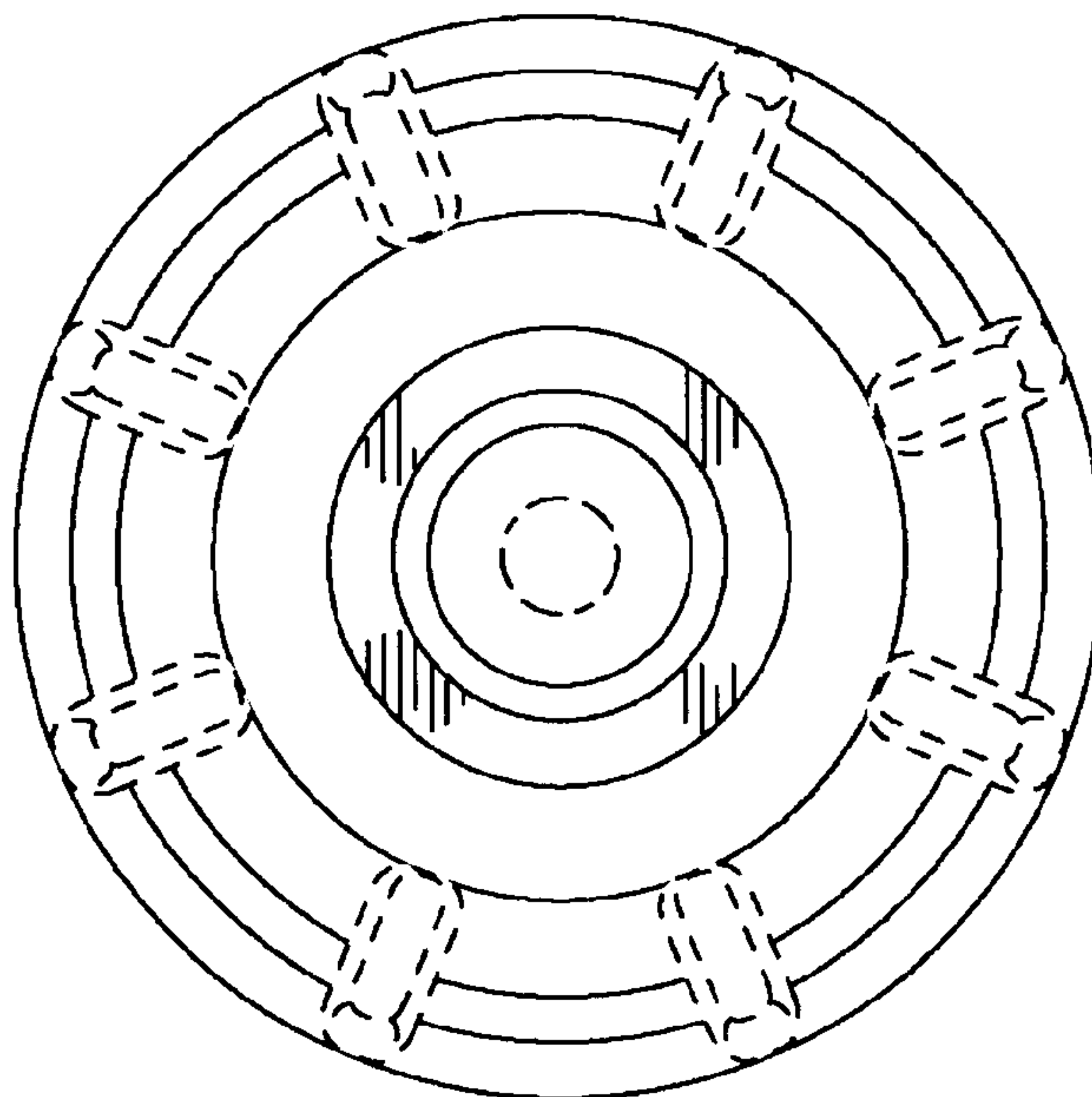
