(57) **CLAIM**

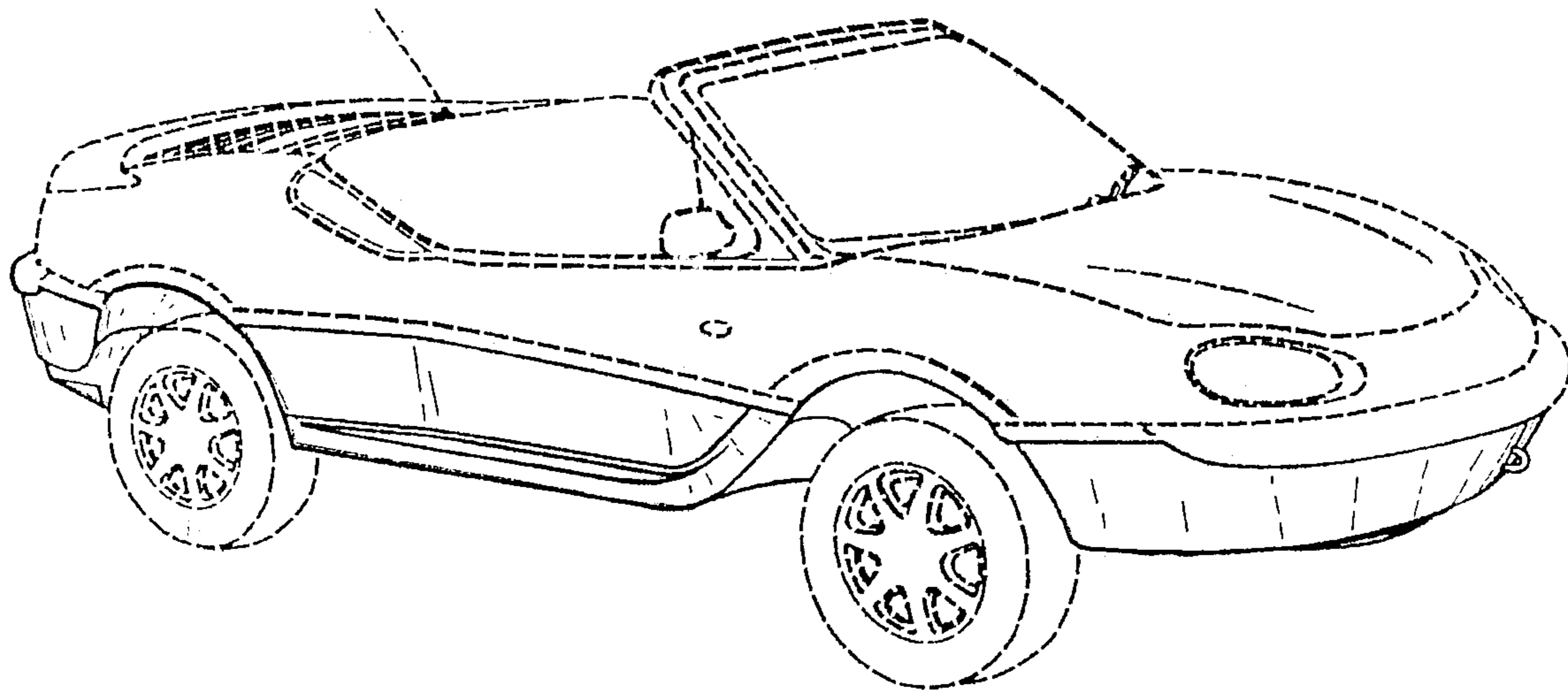
The ornamental design for a vehicle lower body, as shown and described.

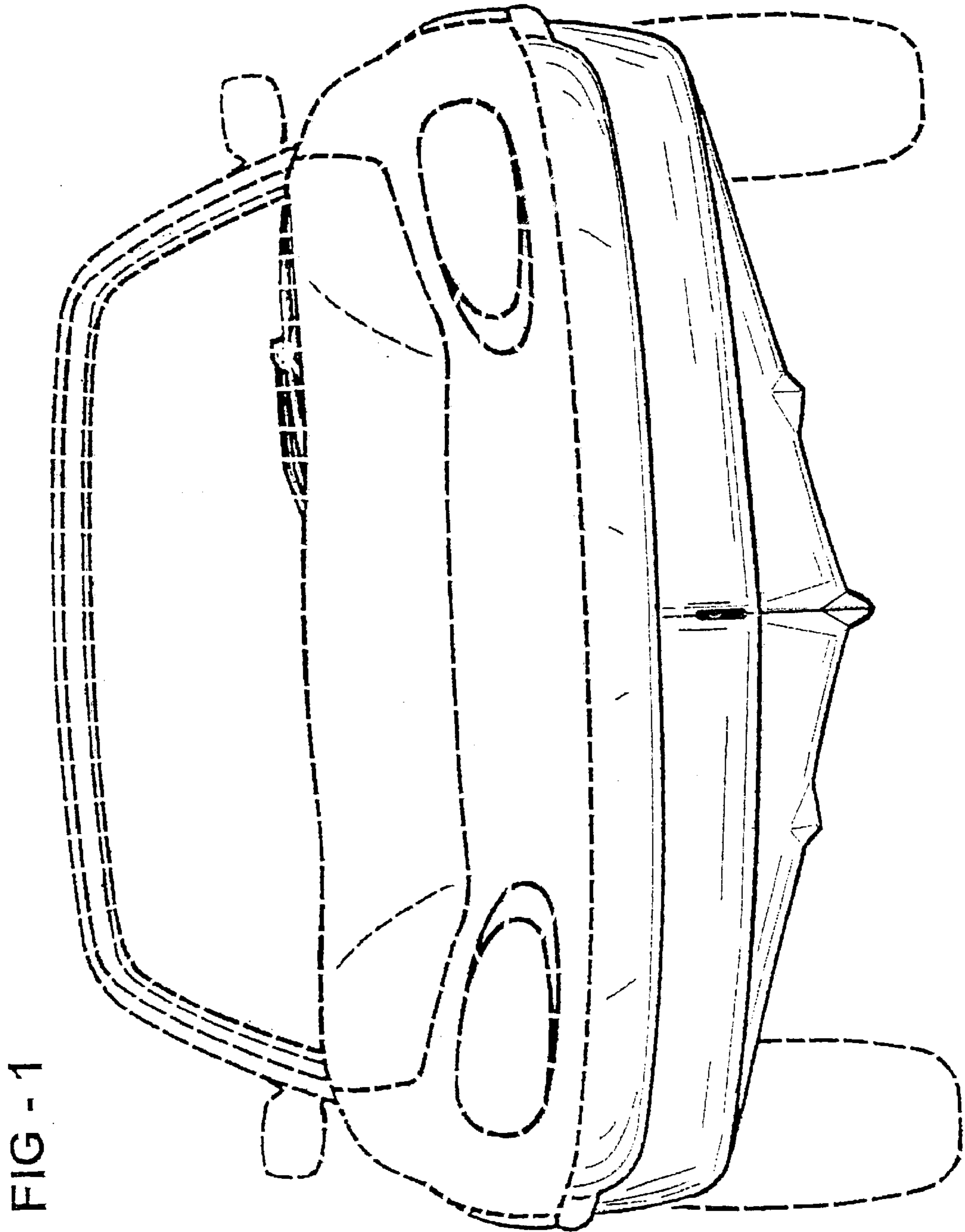
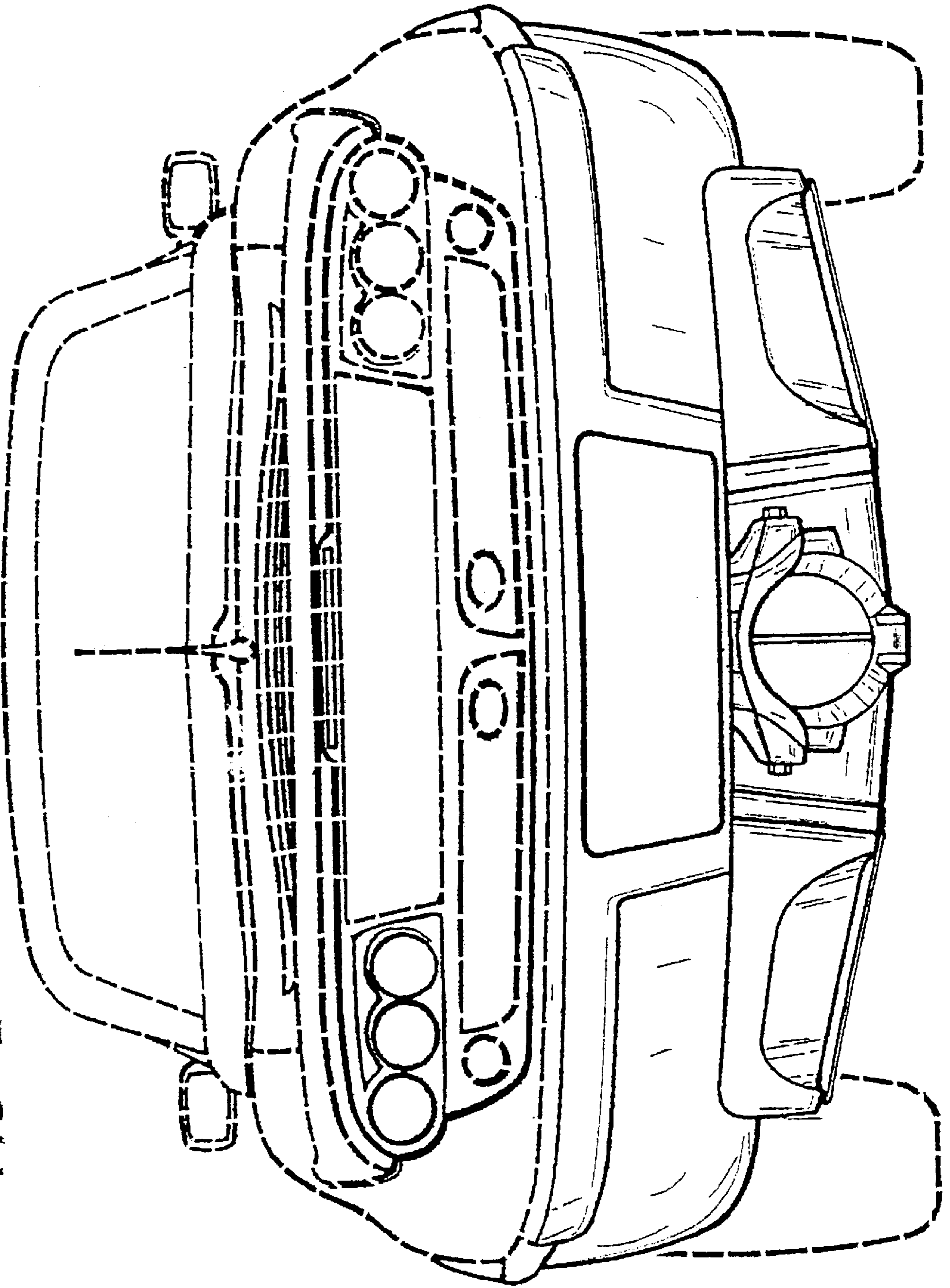

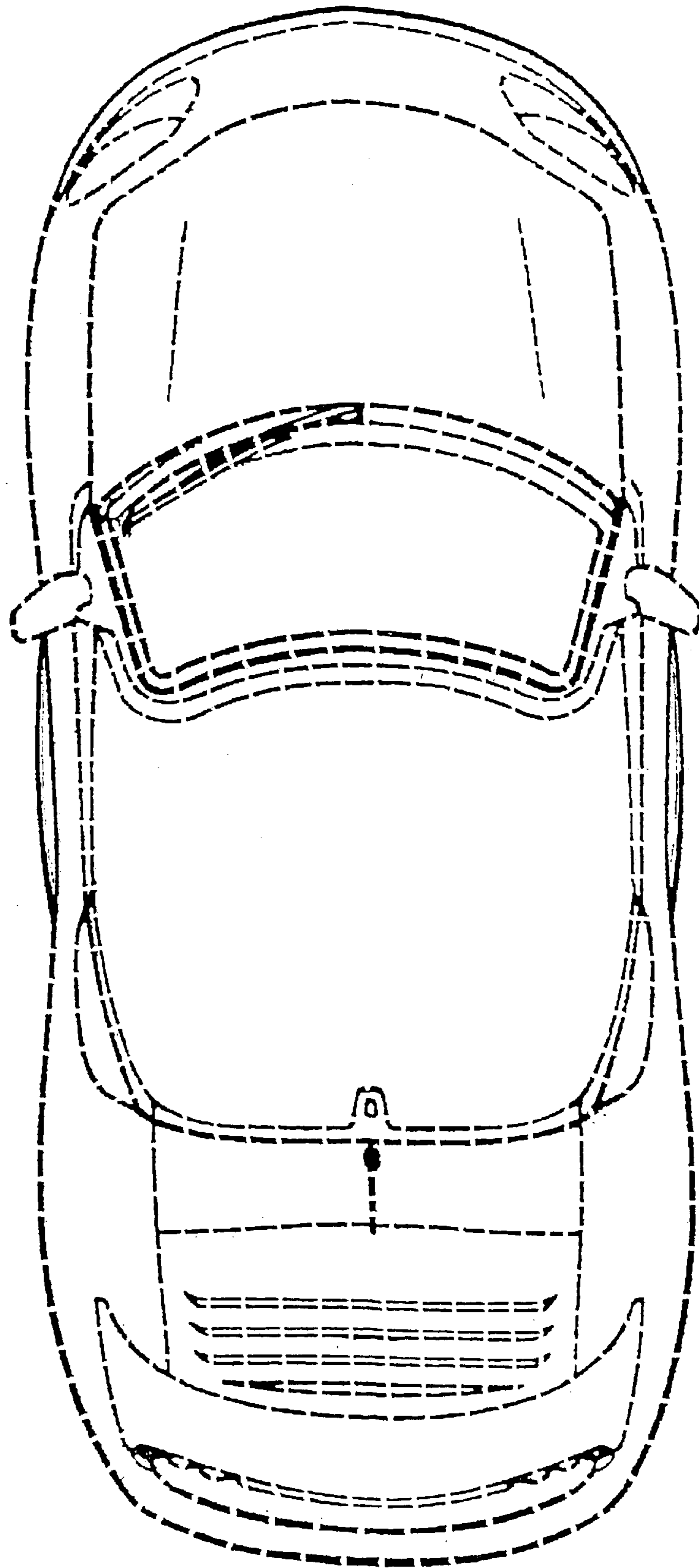

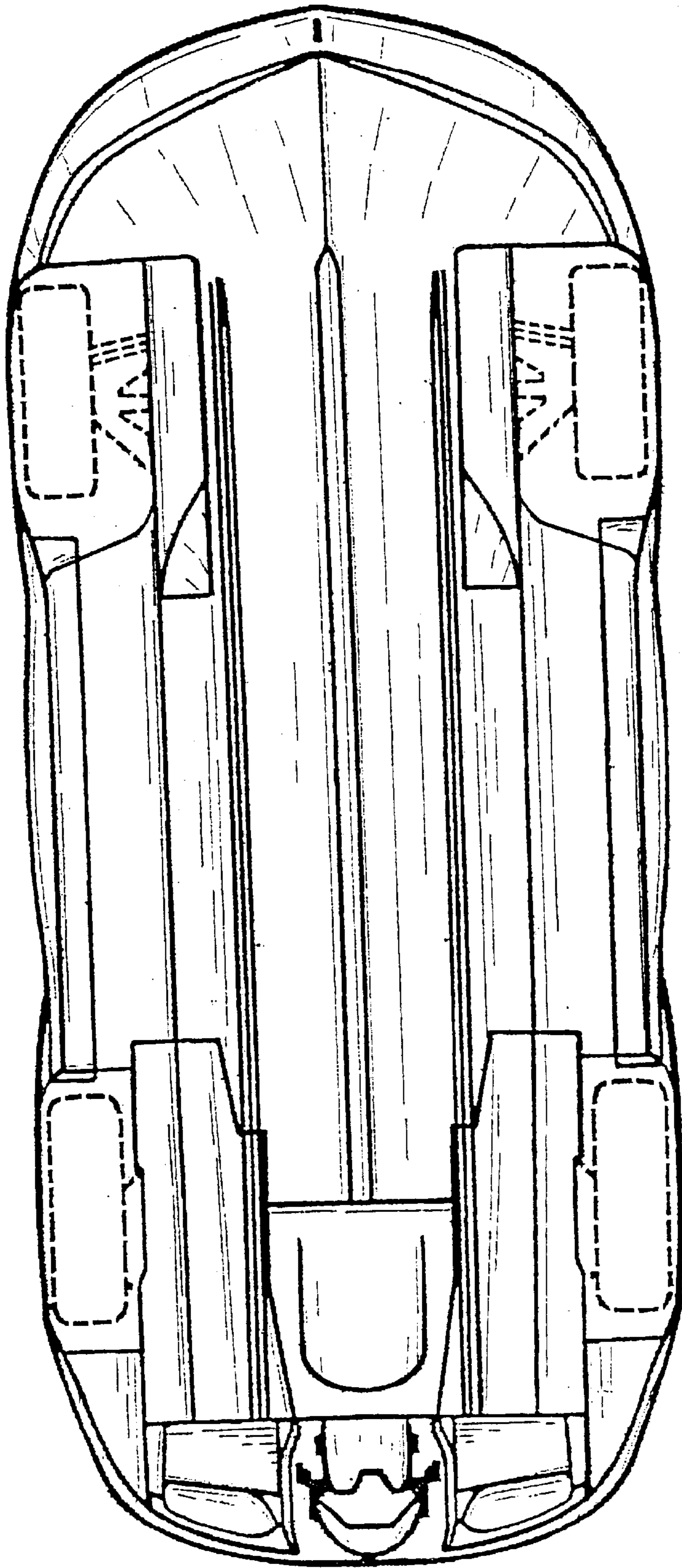
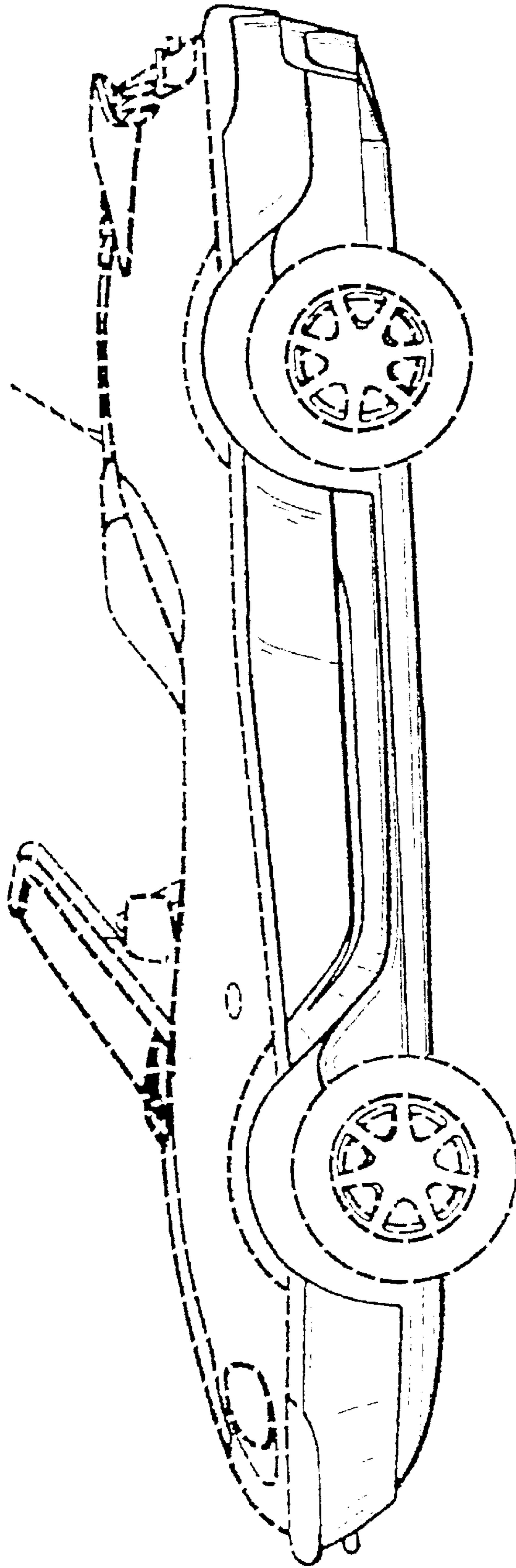

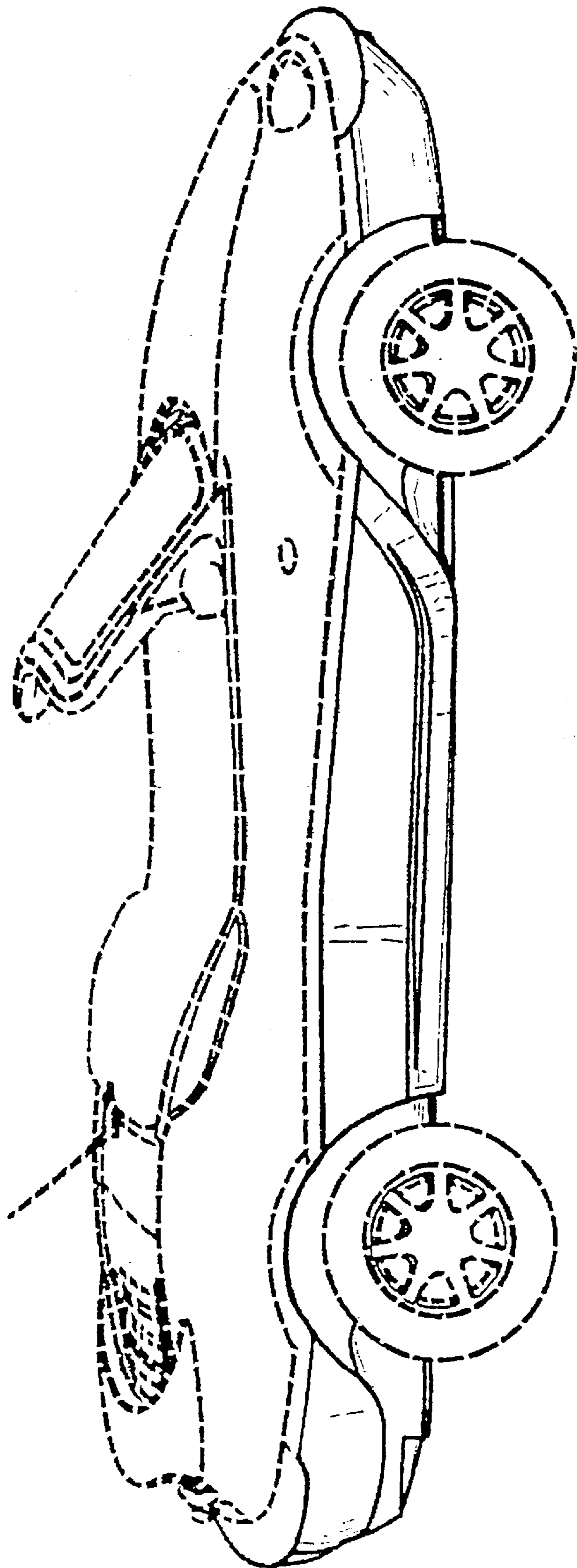

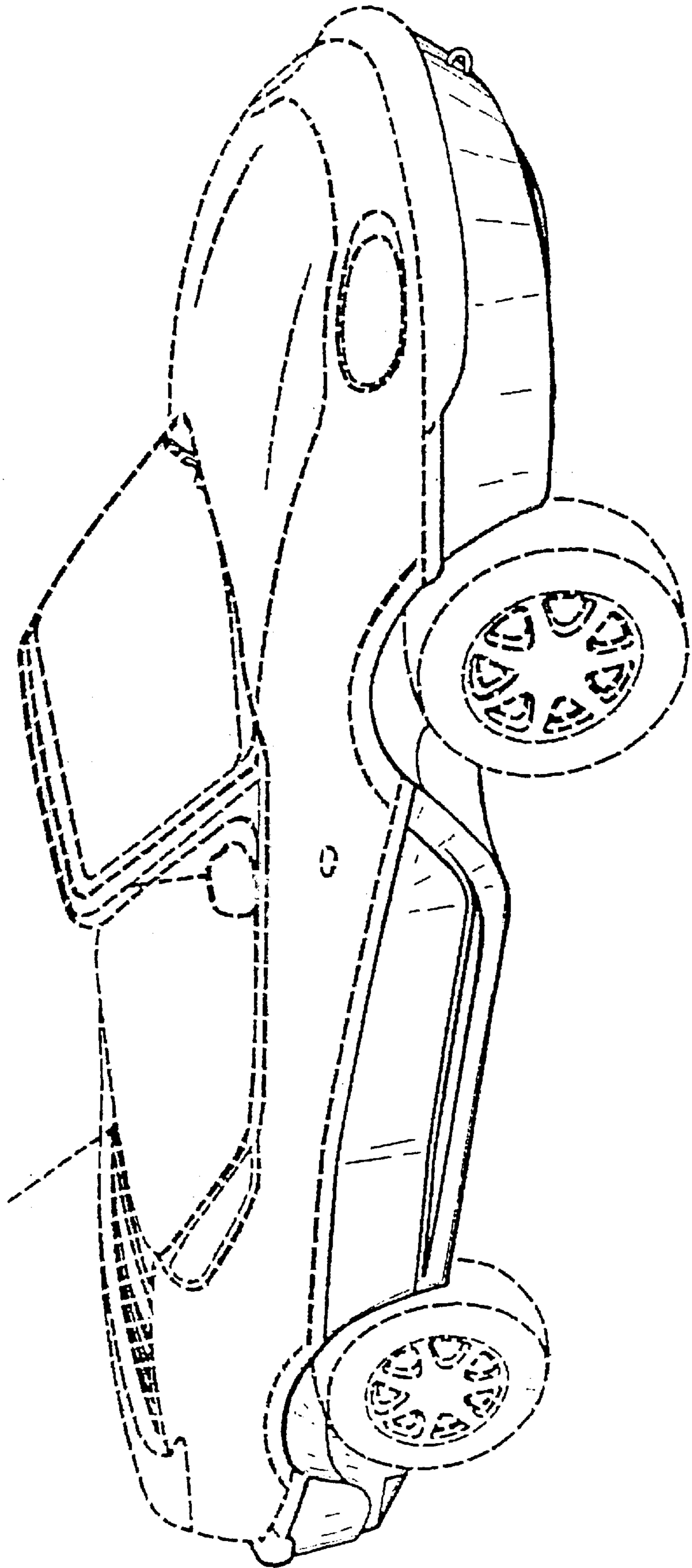

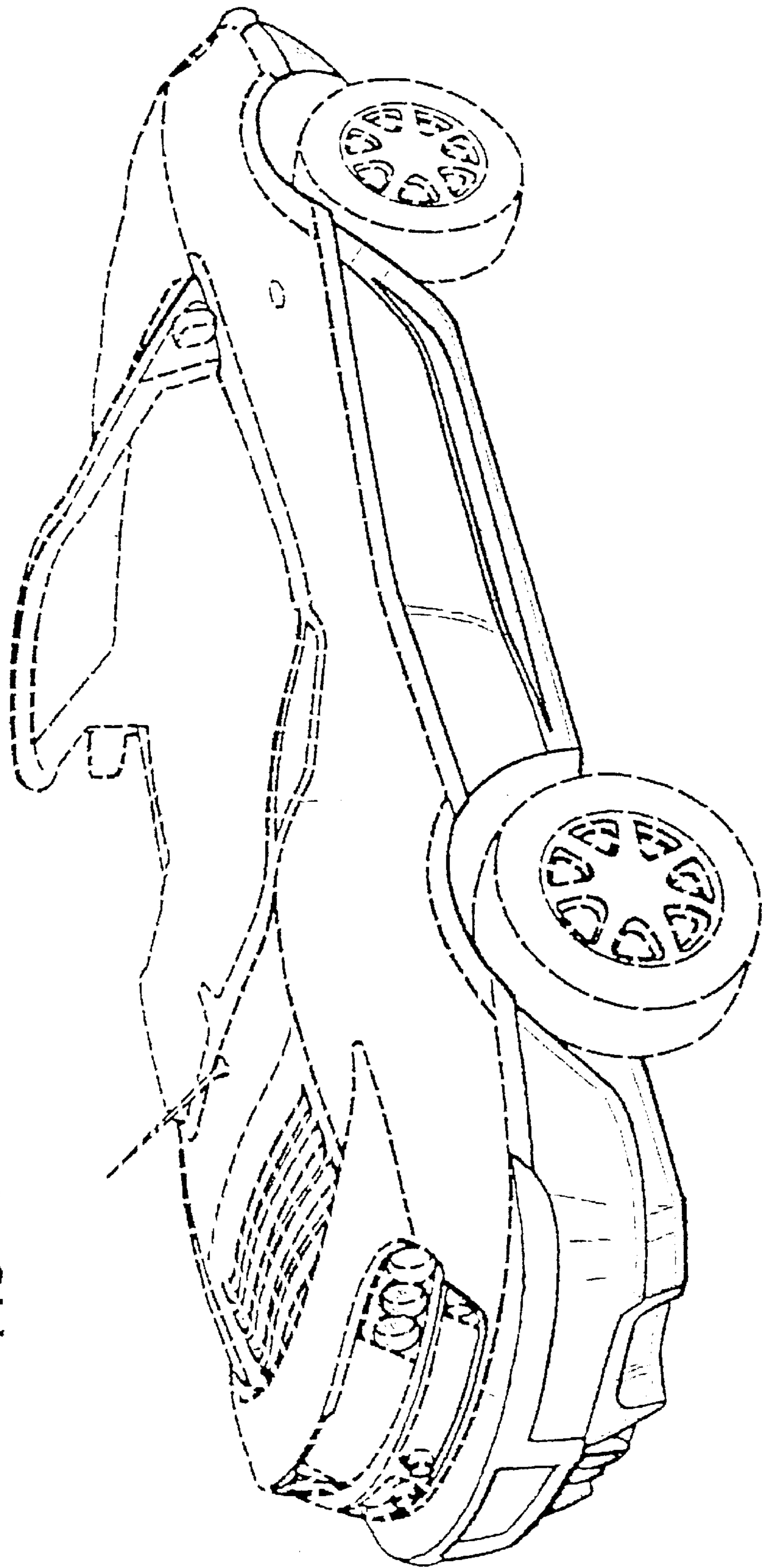
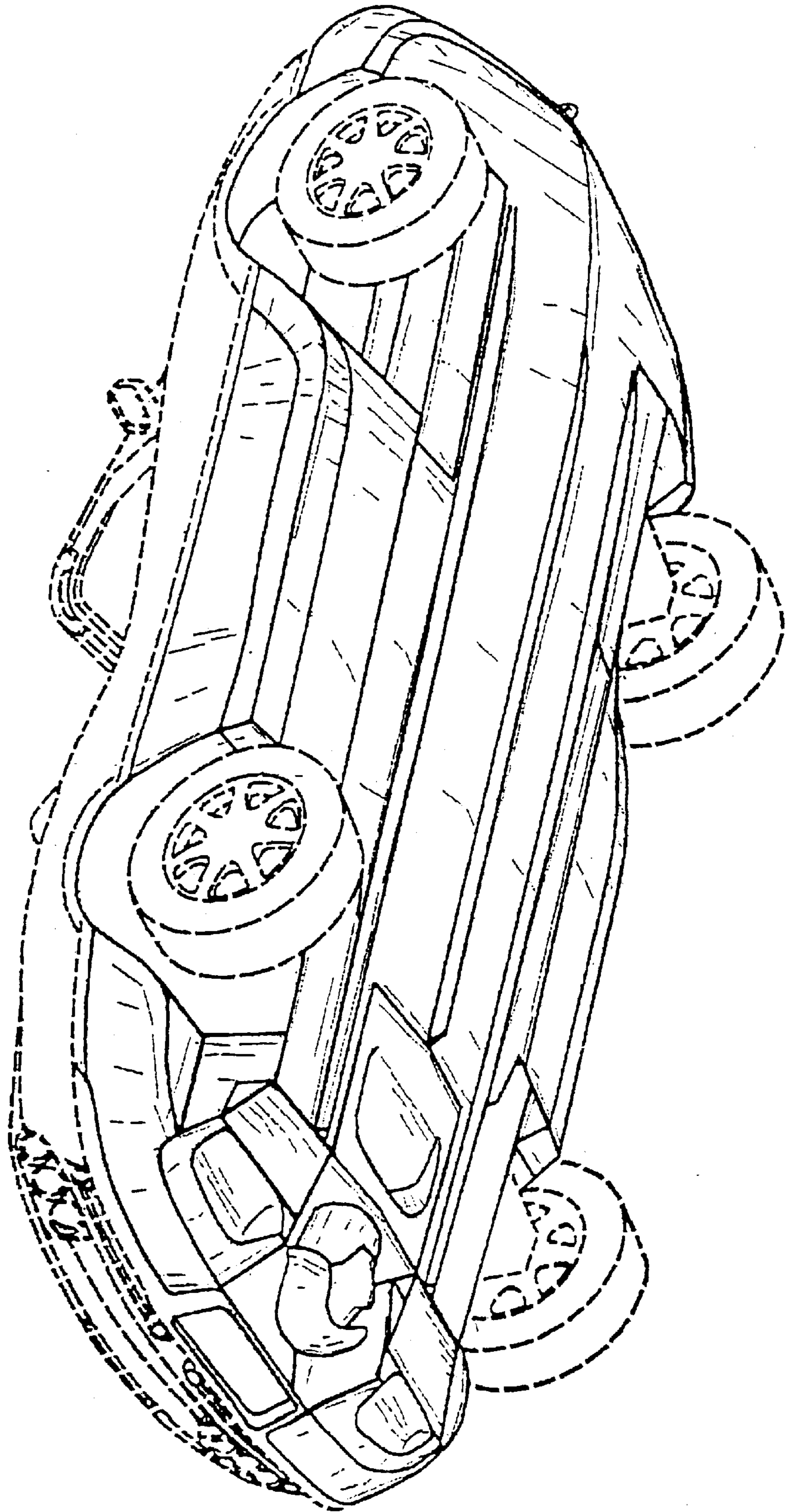

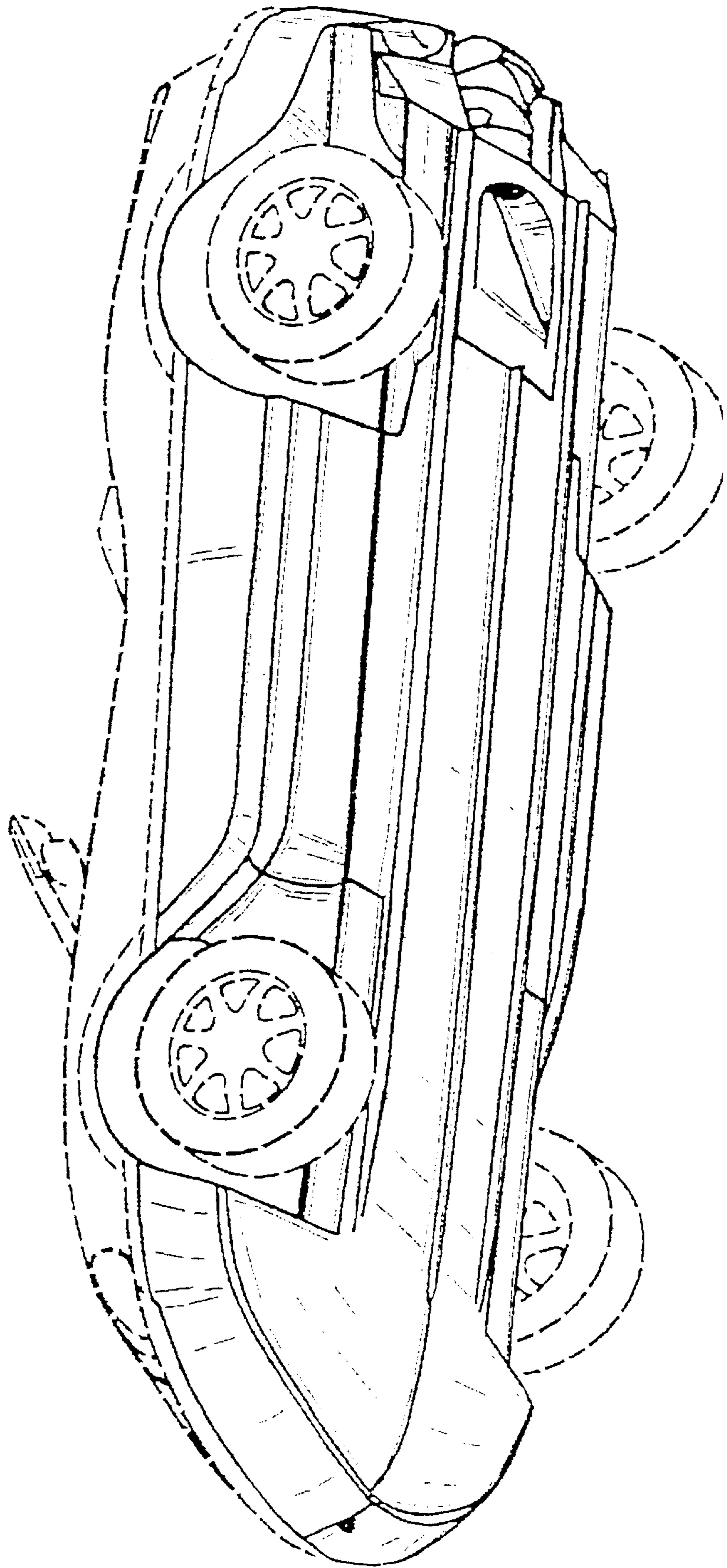
