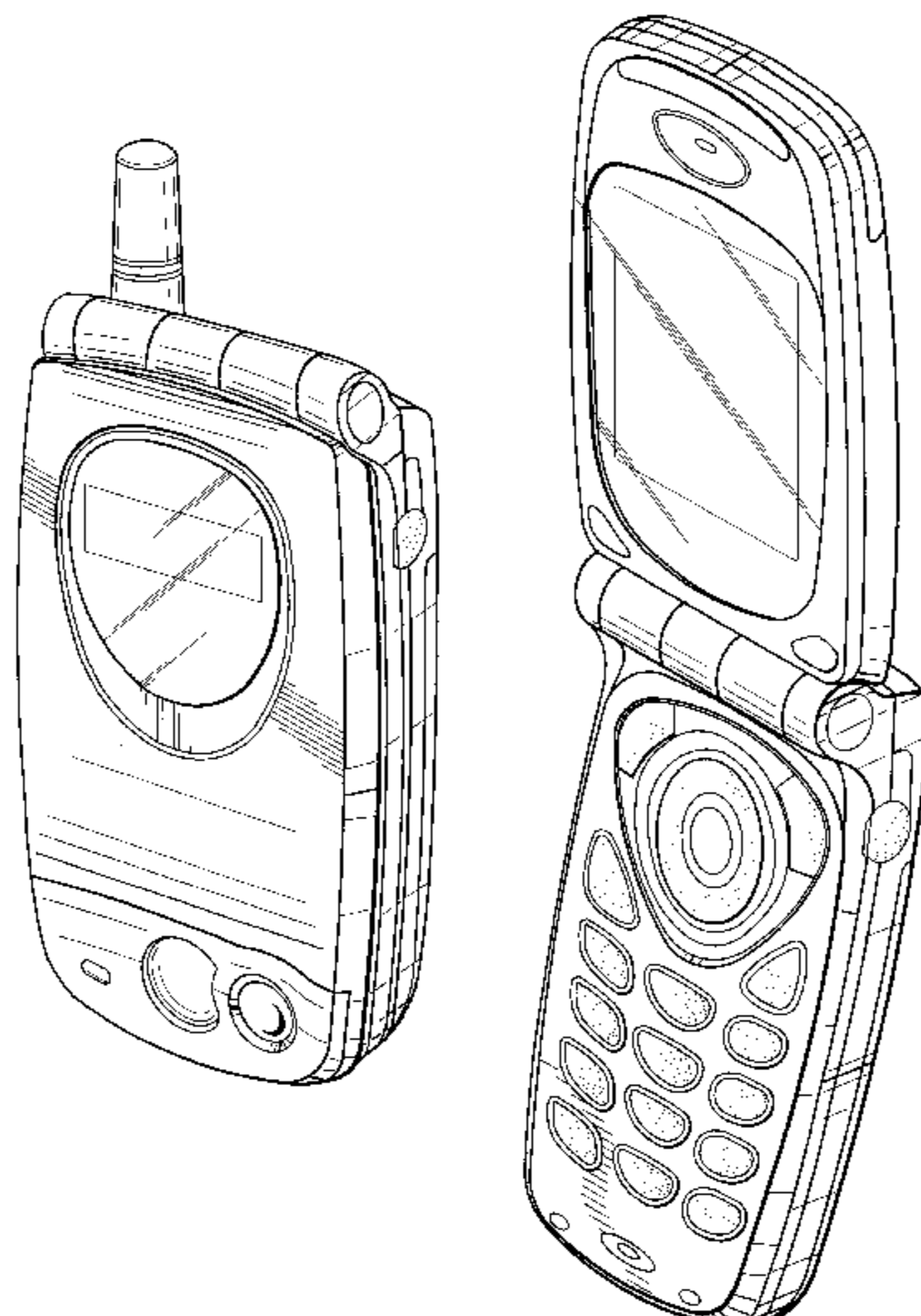
(57) **CLAIM**

The ornamental design for a "portable telephone", as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a portable telephone according to our design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevational view thereof;

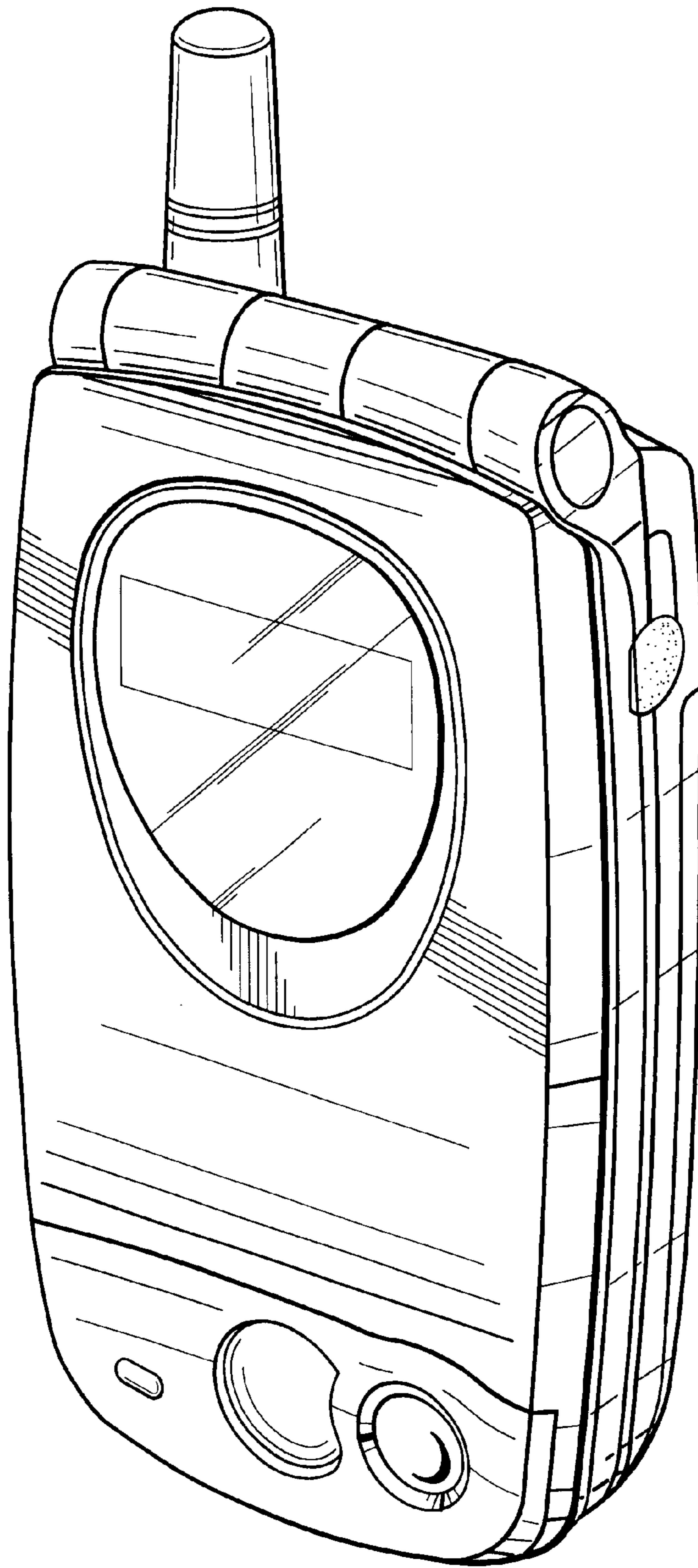

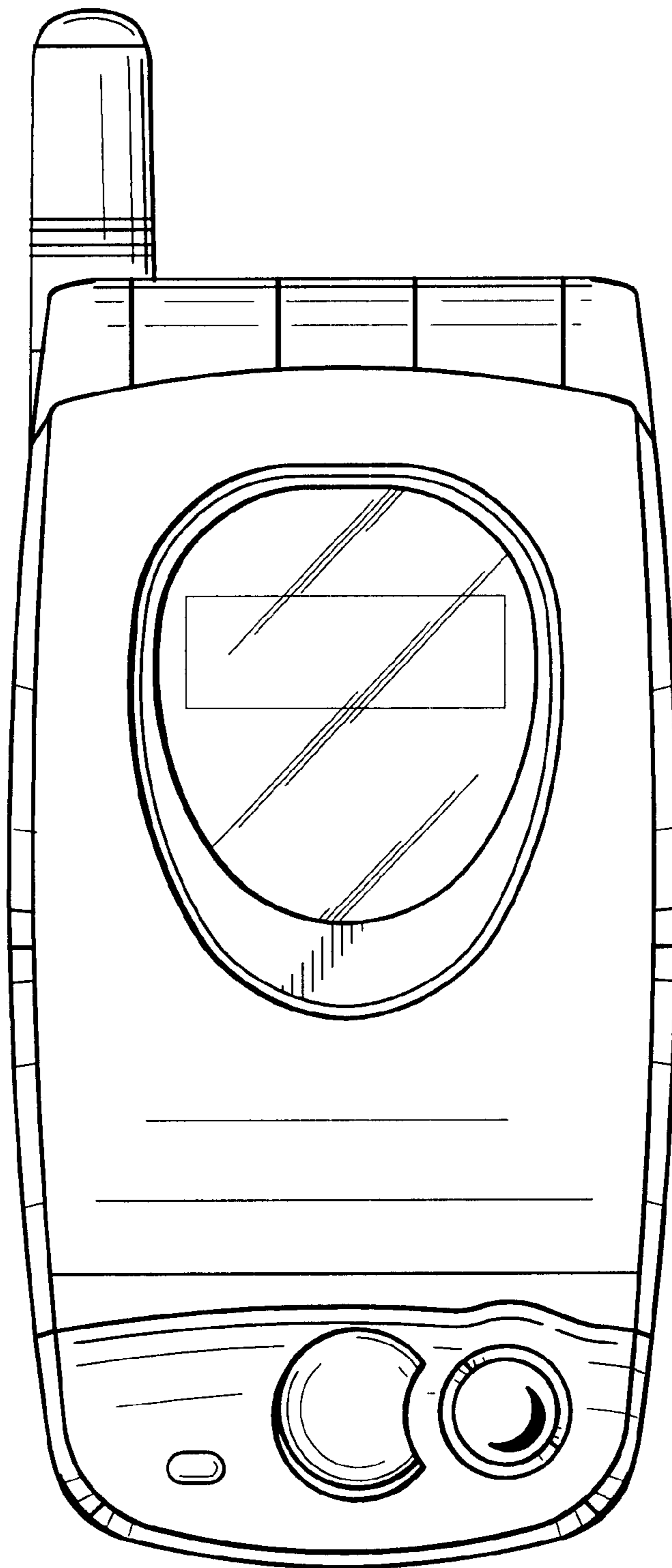

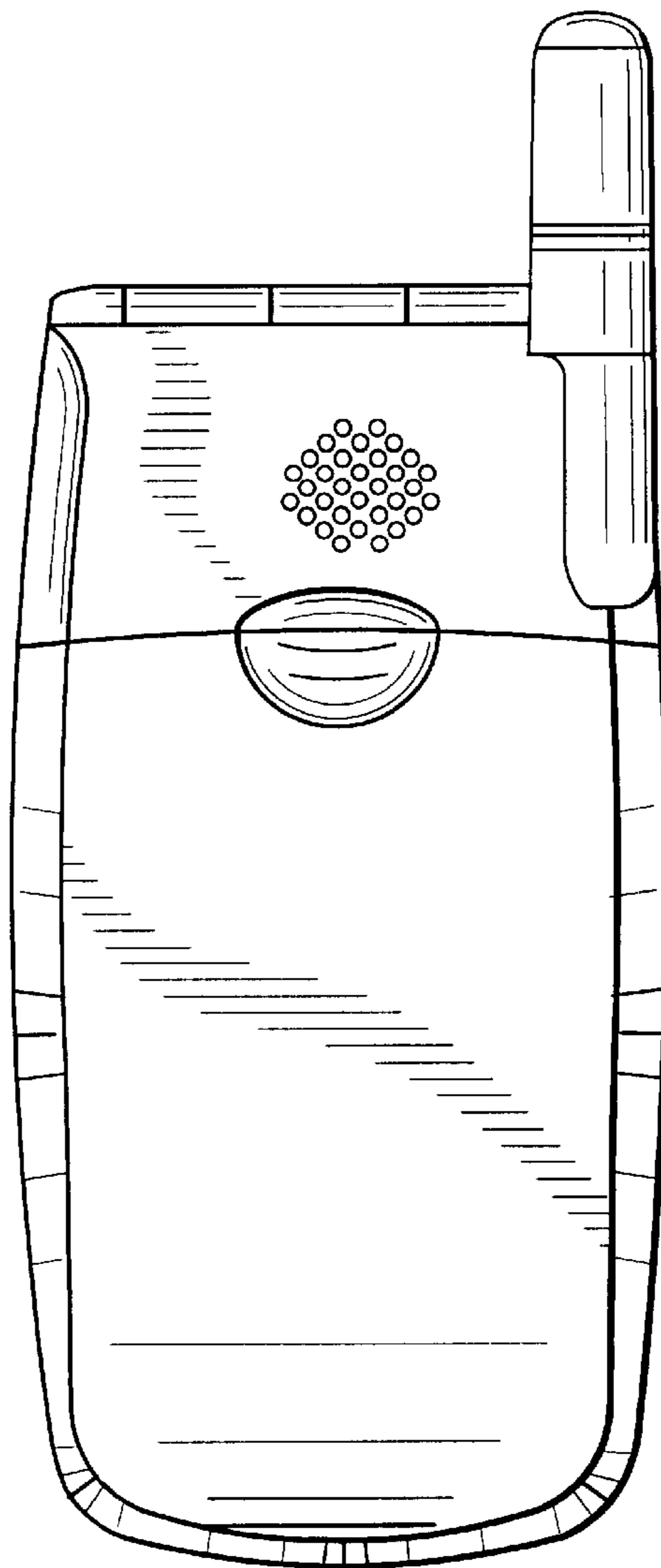

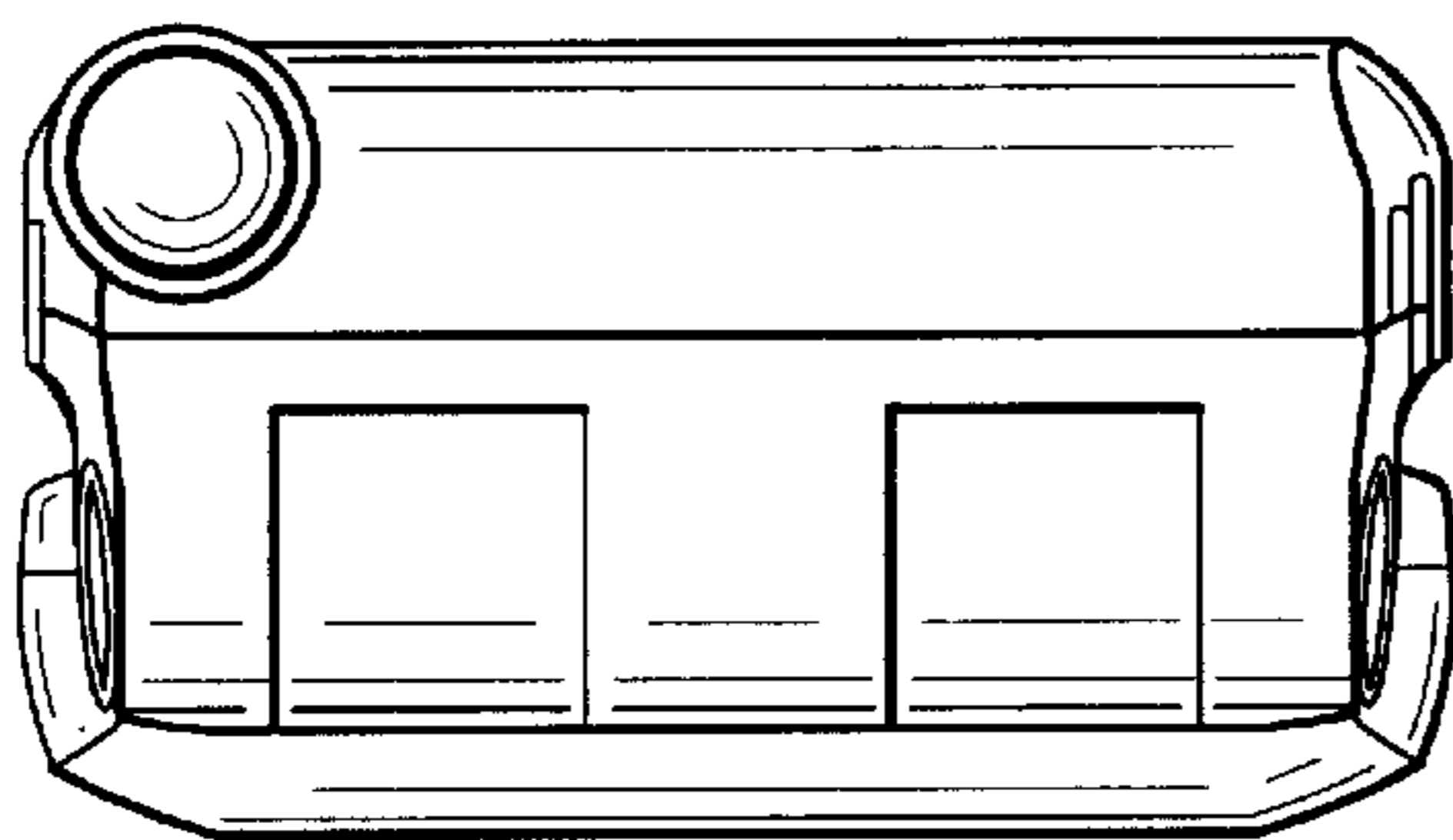

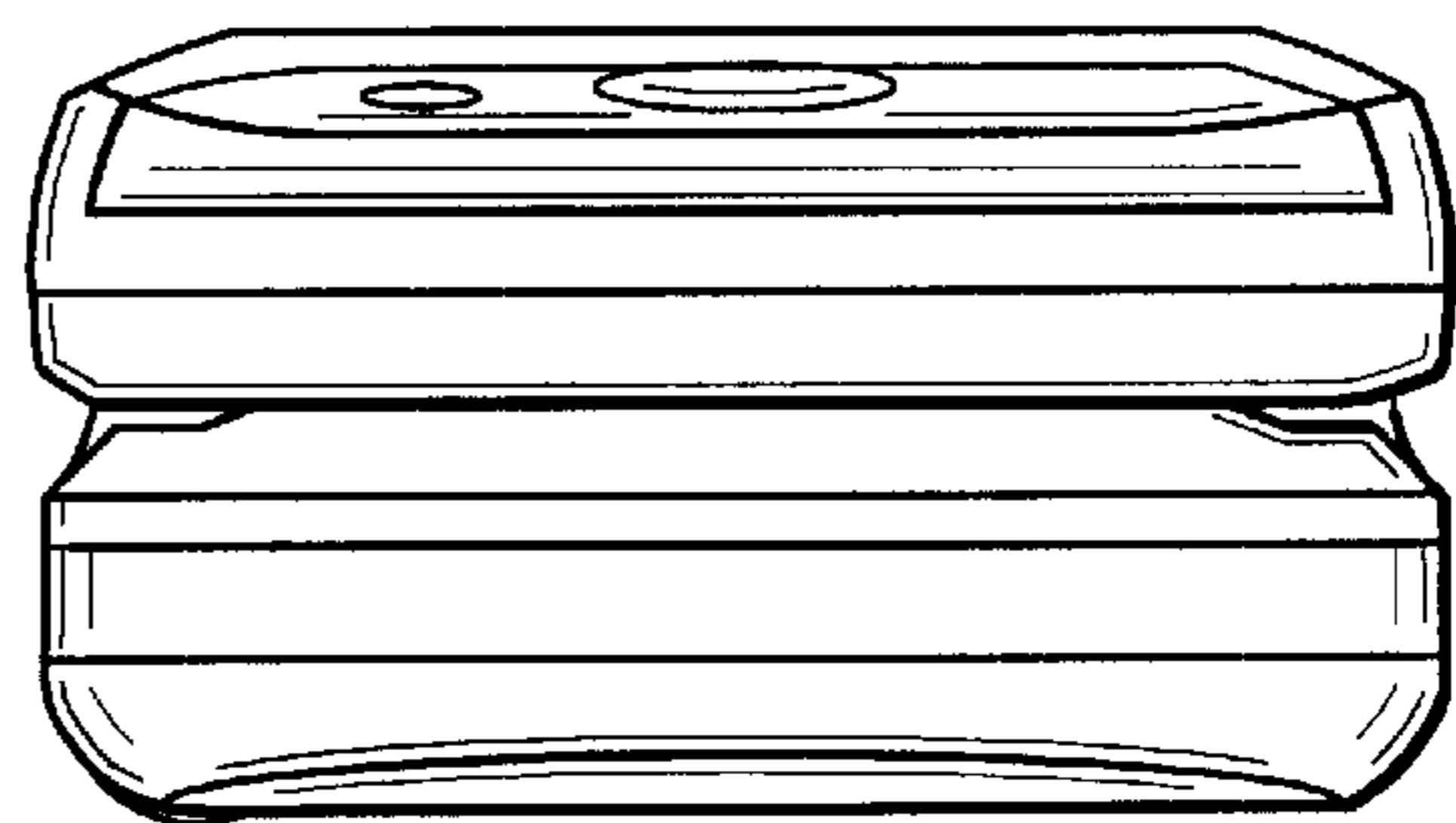

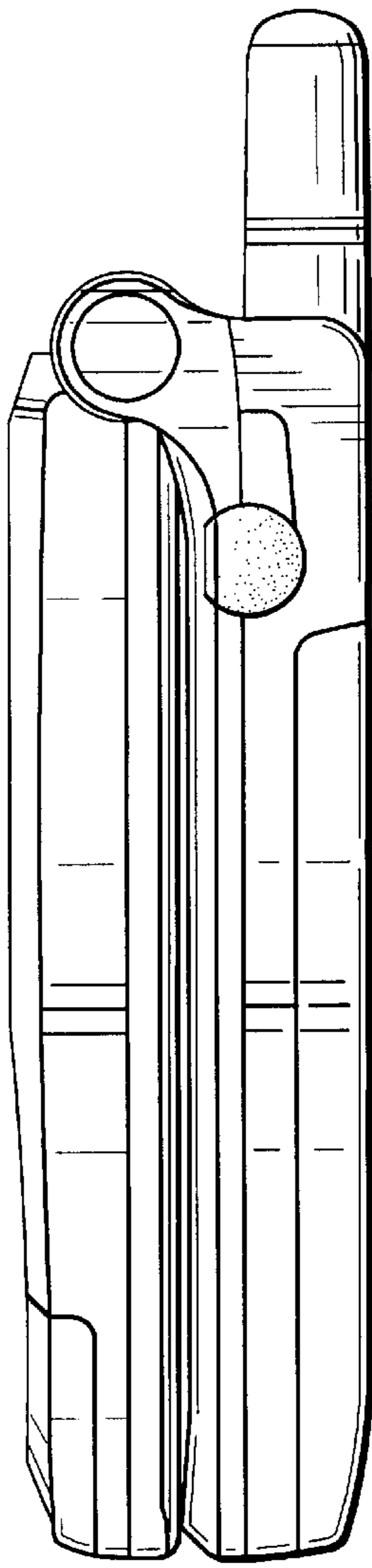

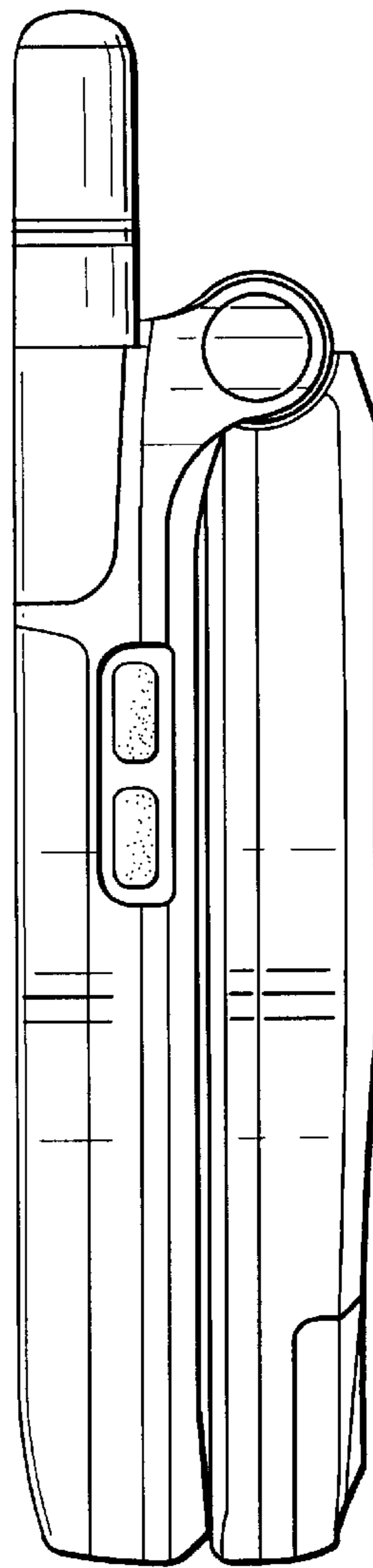

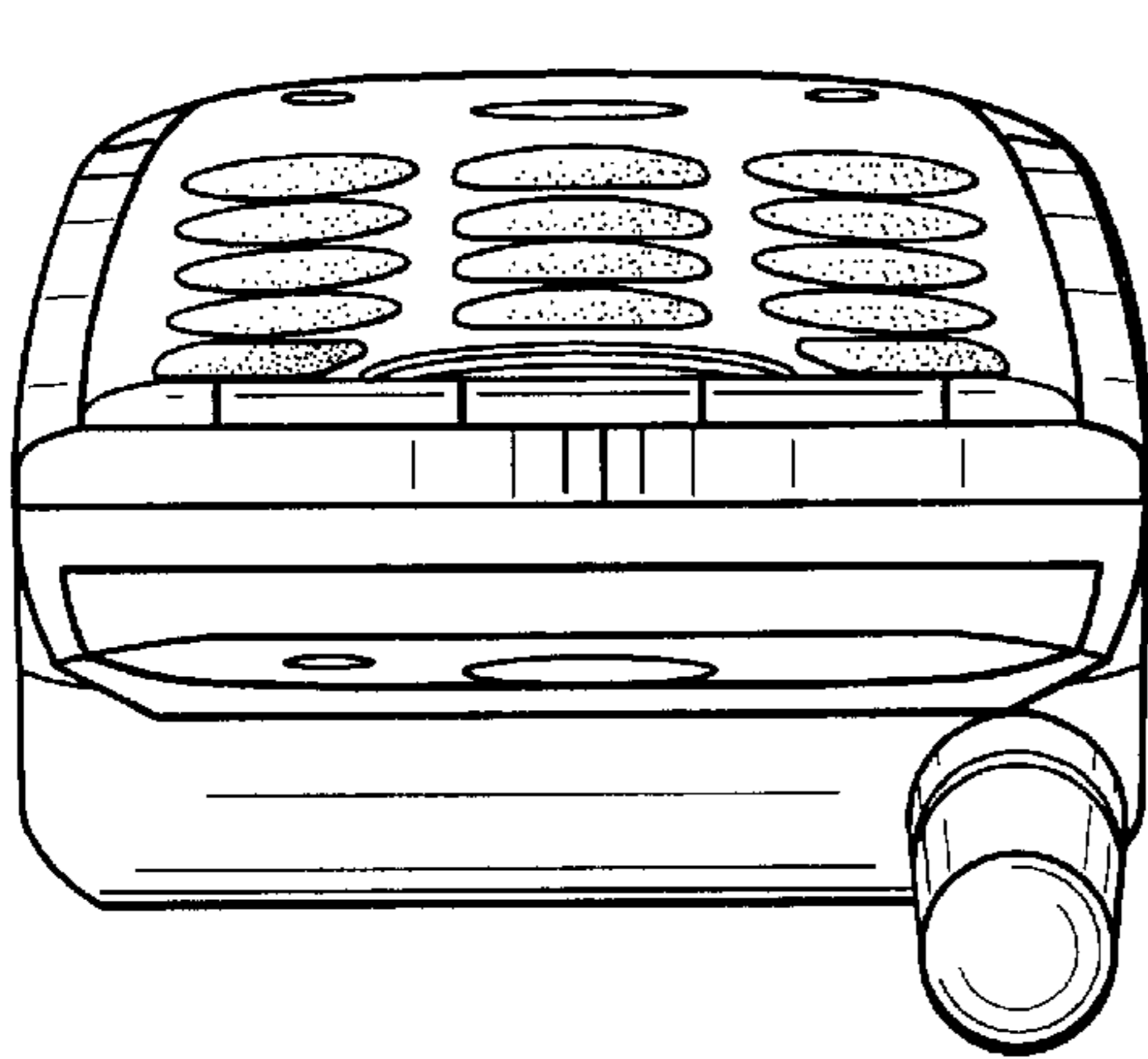

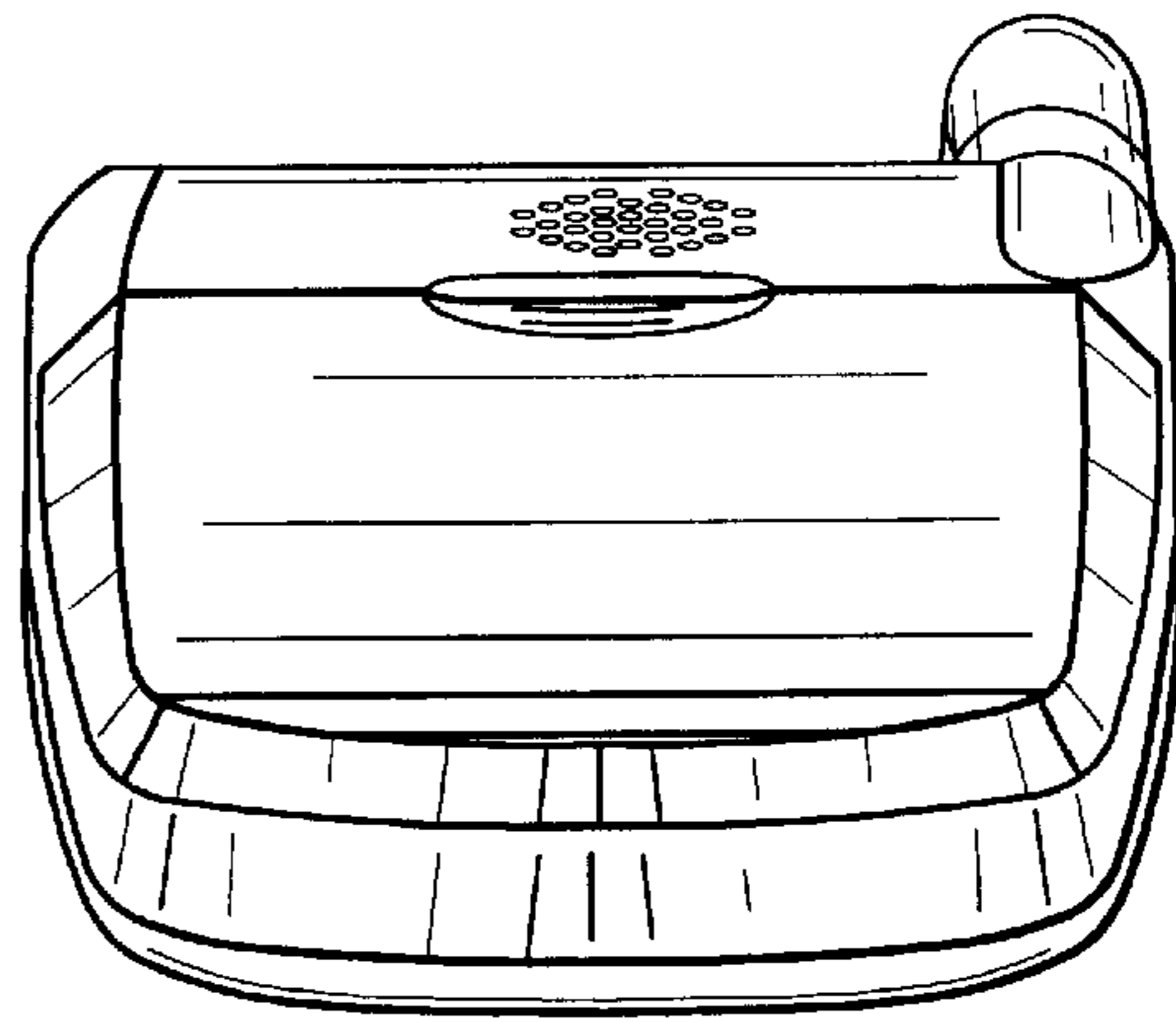

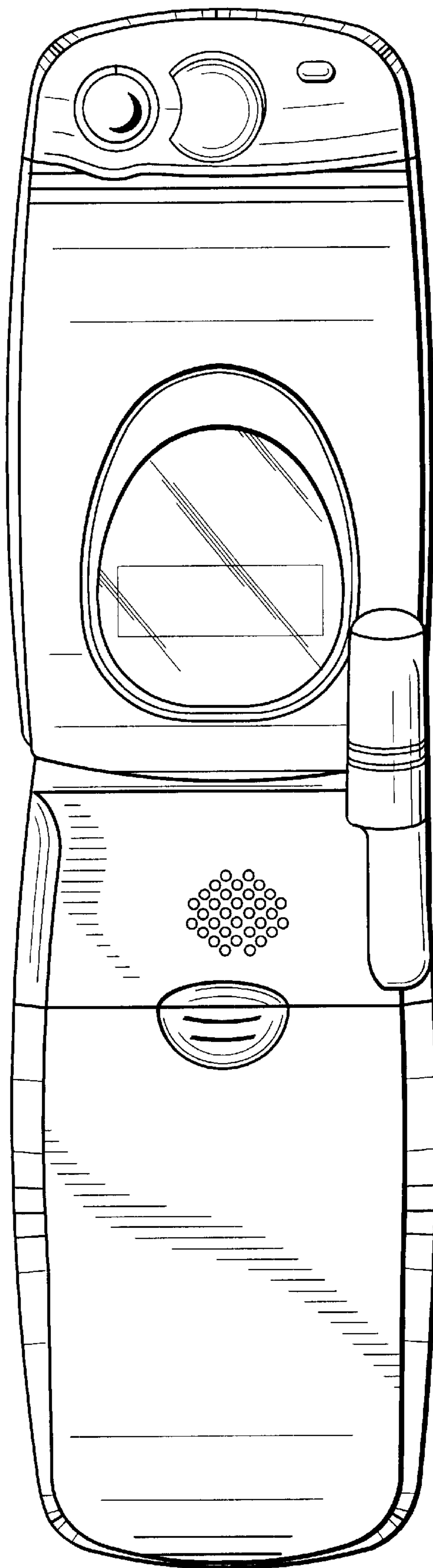

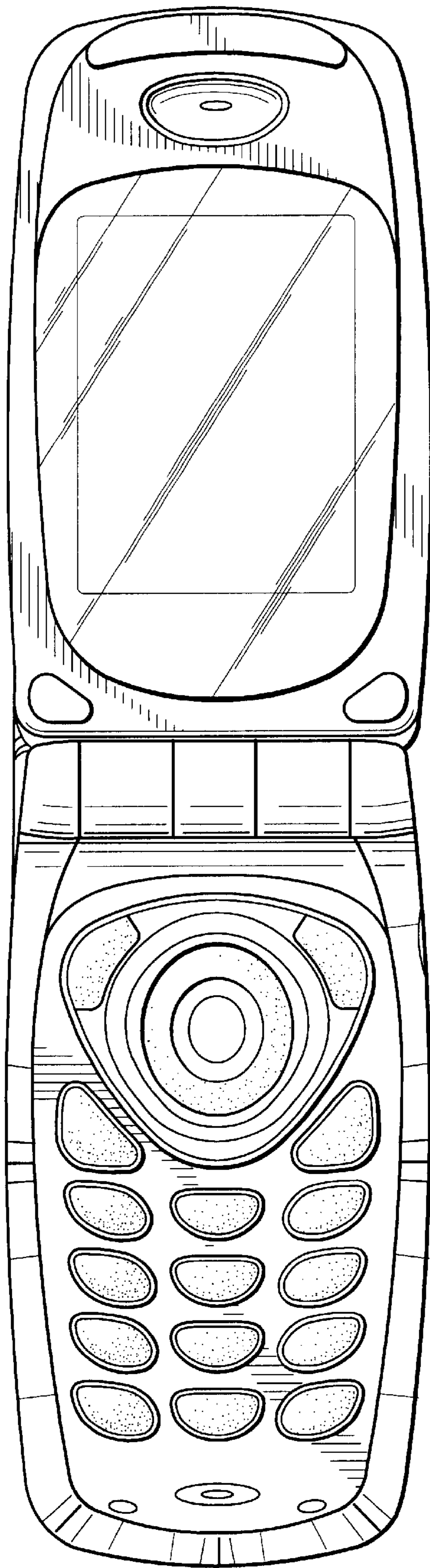
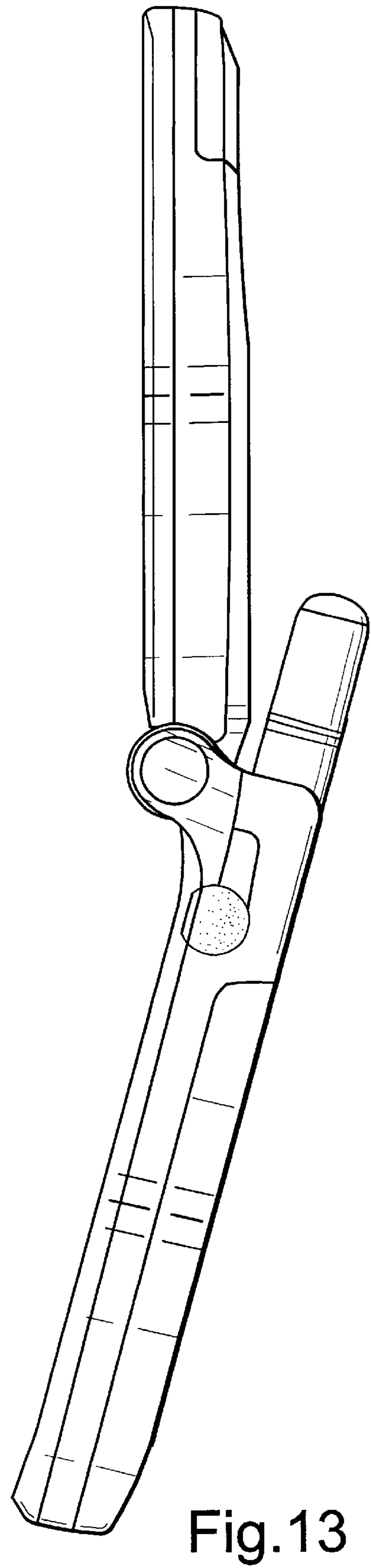
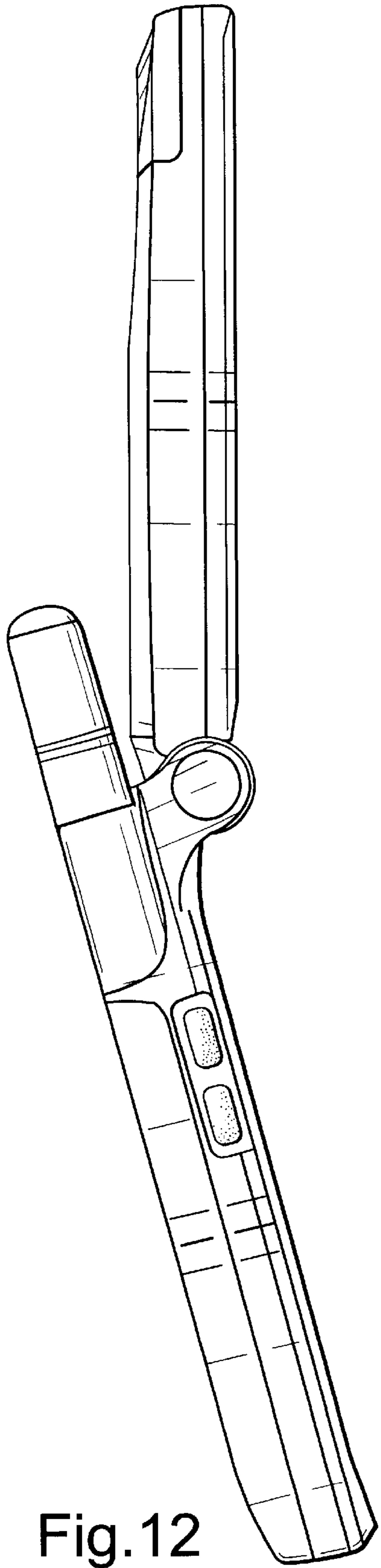

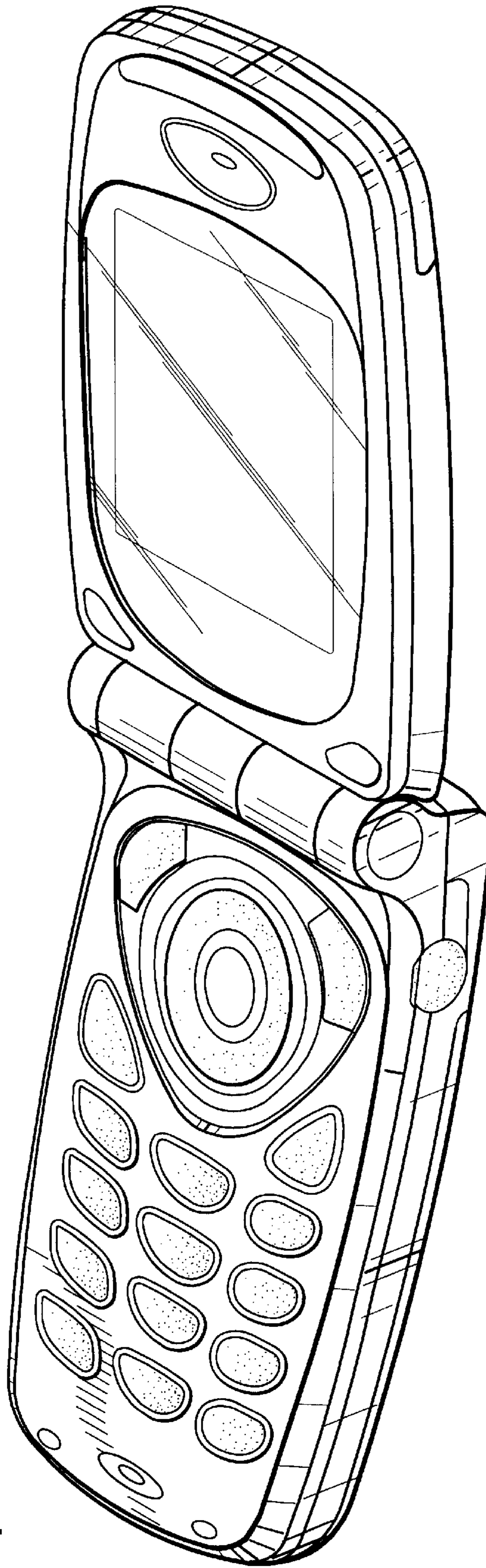
