**DESCRIPTION**

FIG. 1 is a top plan view of a label sheet of the present invention;  
FIG. 2 is a left edge elevational view thereof;  
FIG. 3 is a top edge elevational view thereof;  
FIG. 4 is a right edge elevational view thereof;  
FIG. 5 is a bottom edge elevational view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is an enlarged cross-sectional view taken on line 7—7 of FIG. 1.

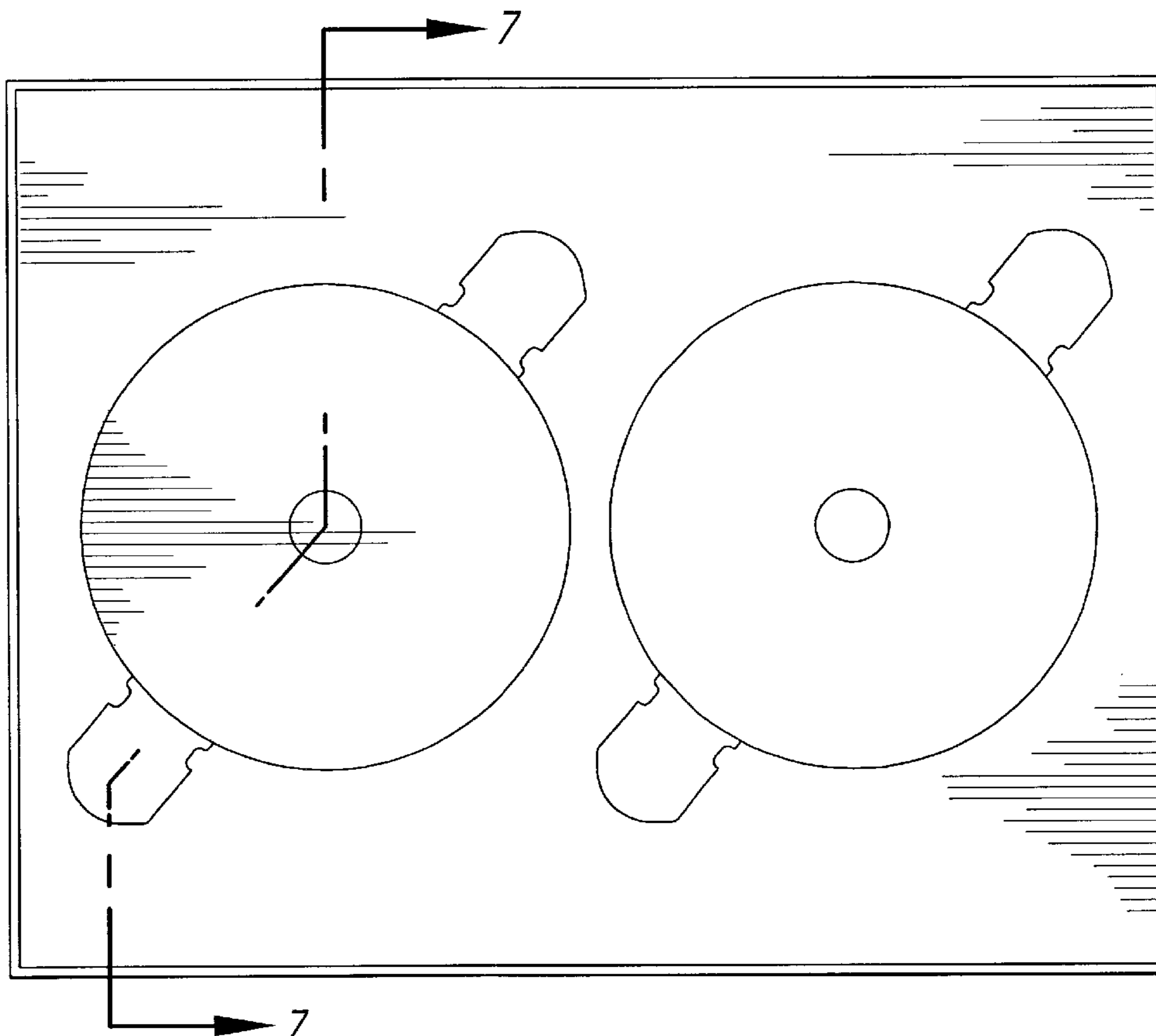

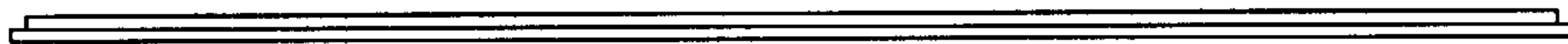

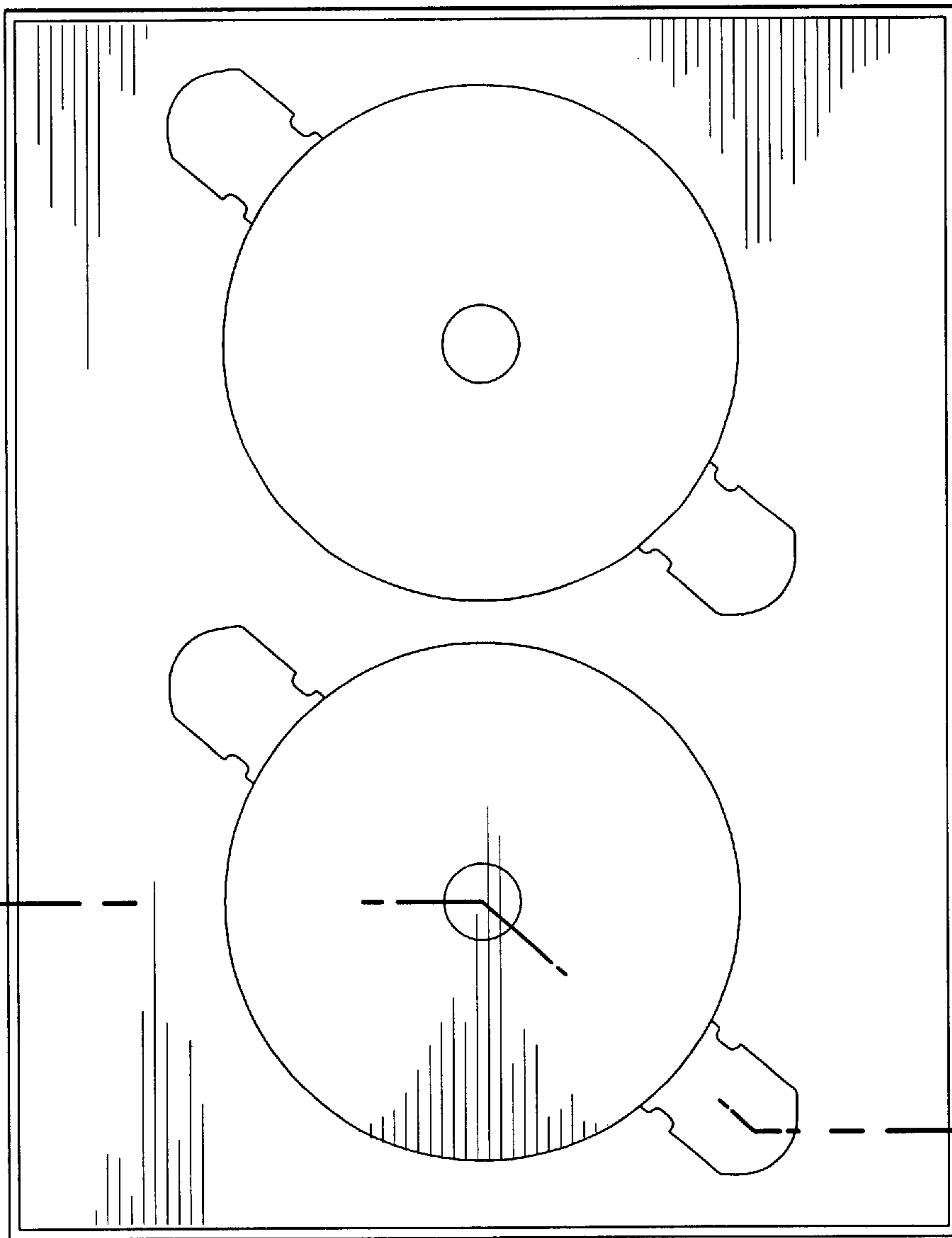

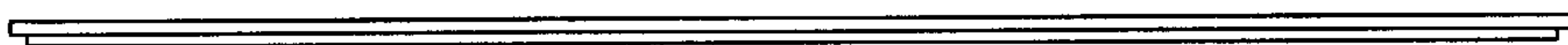

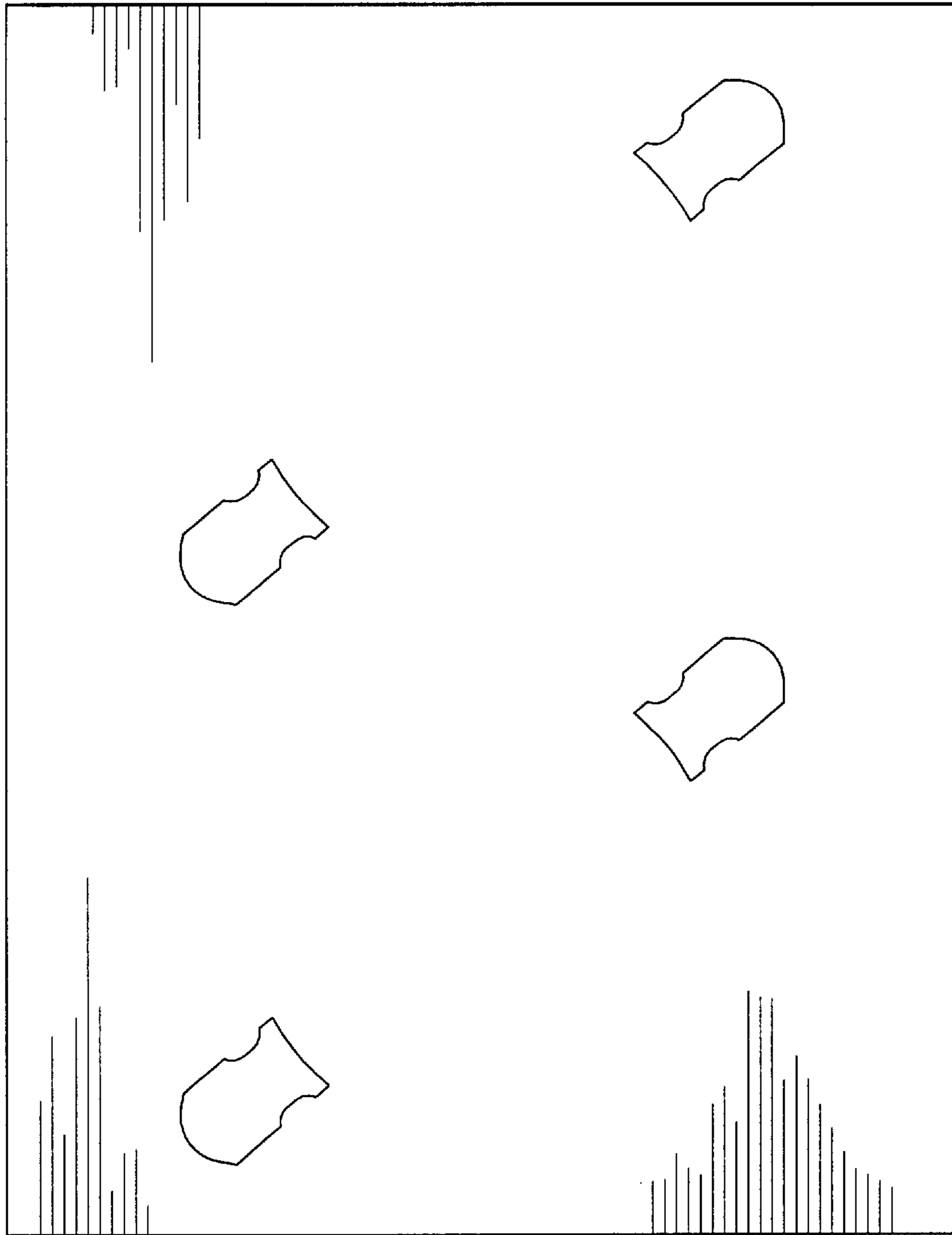
