FIG. 12 is a front view in opened position according to the present invention.

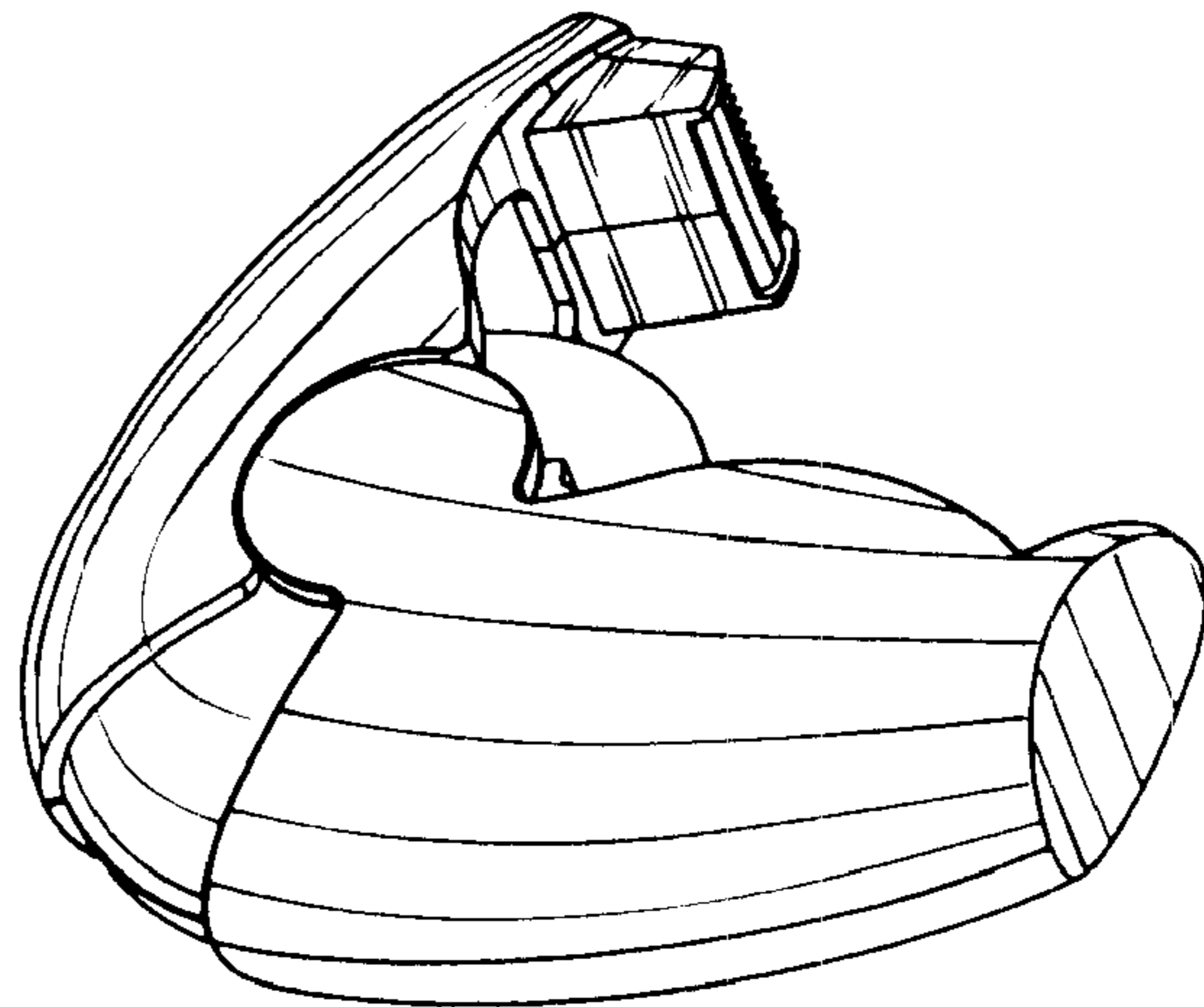
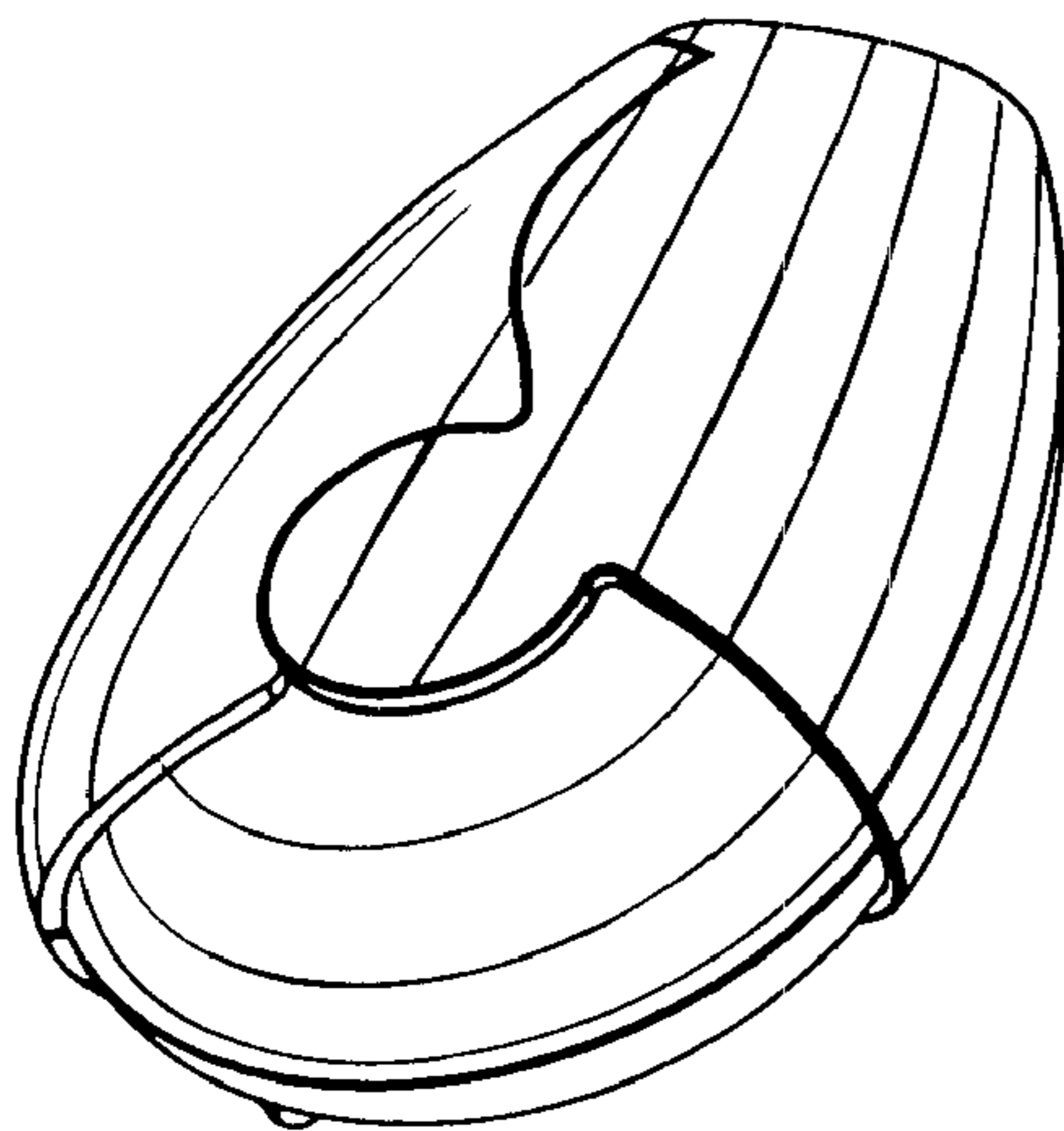
FIG. 13 is a back view according to the present invention.

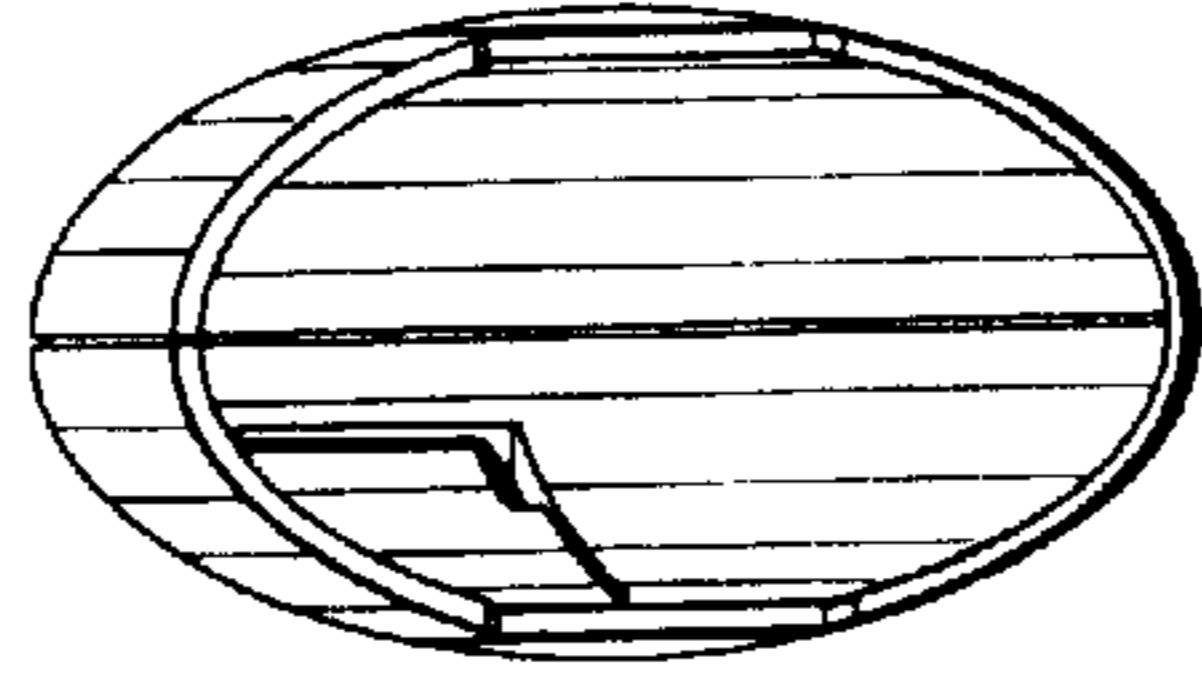

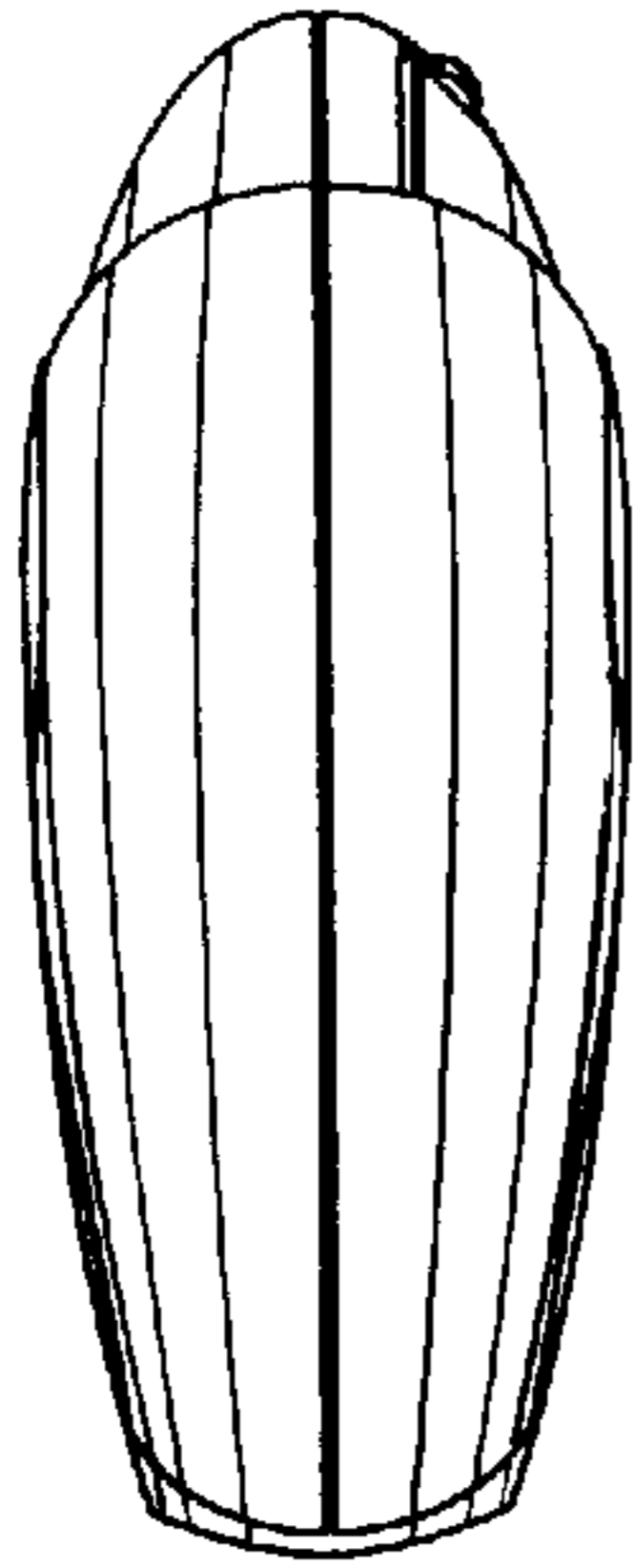

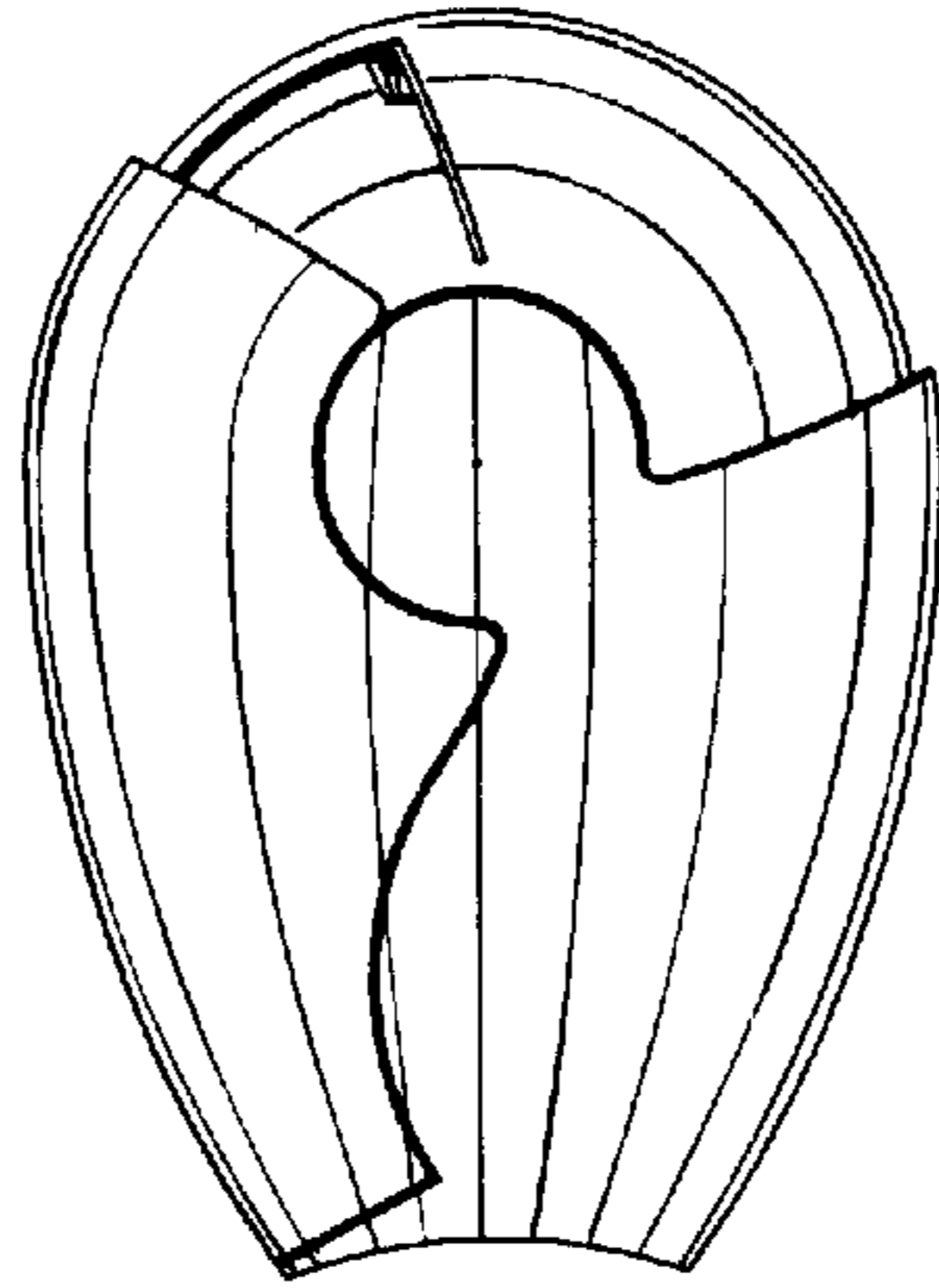

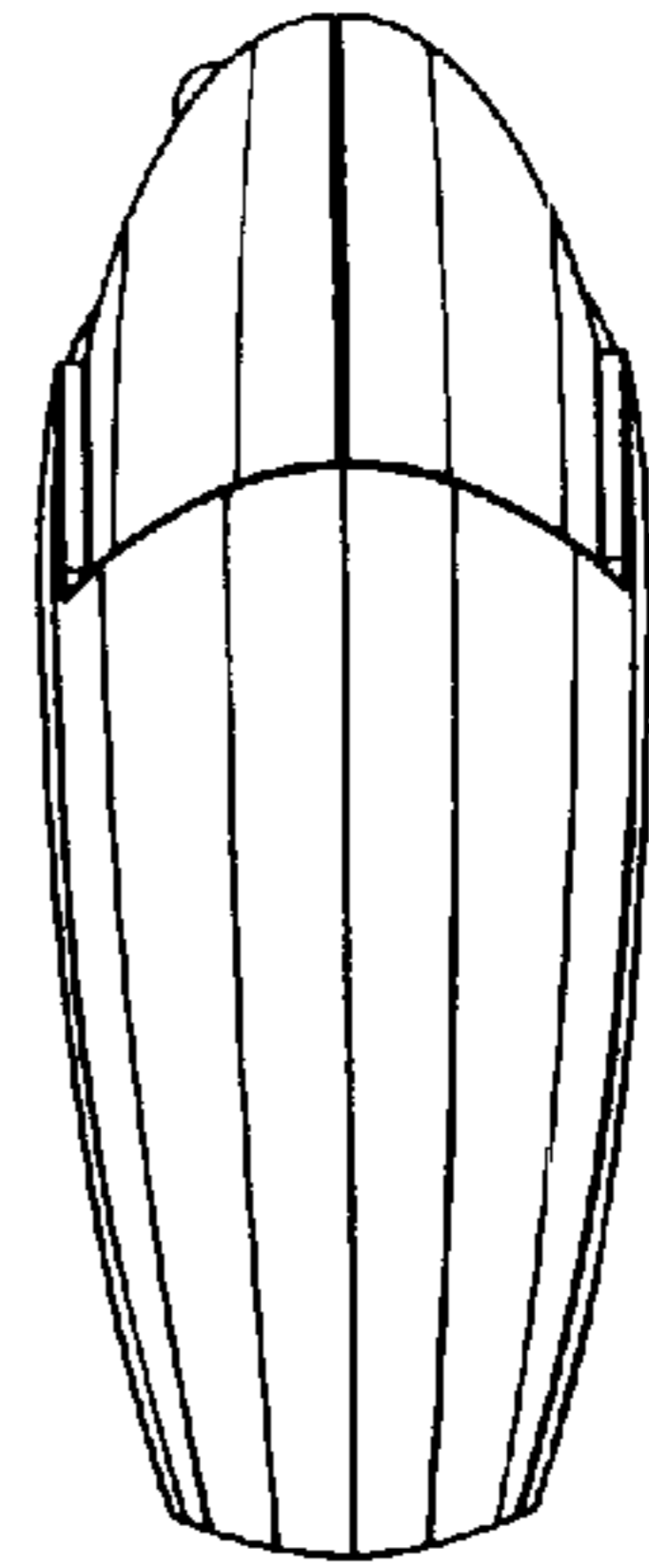

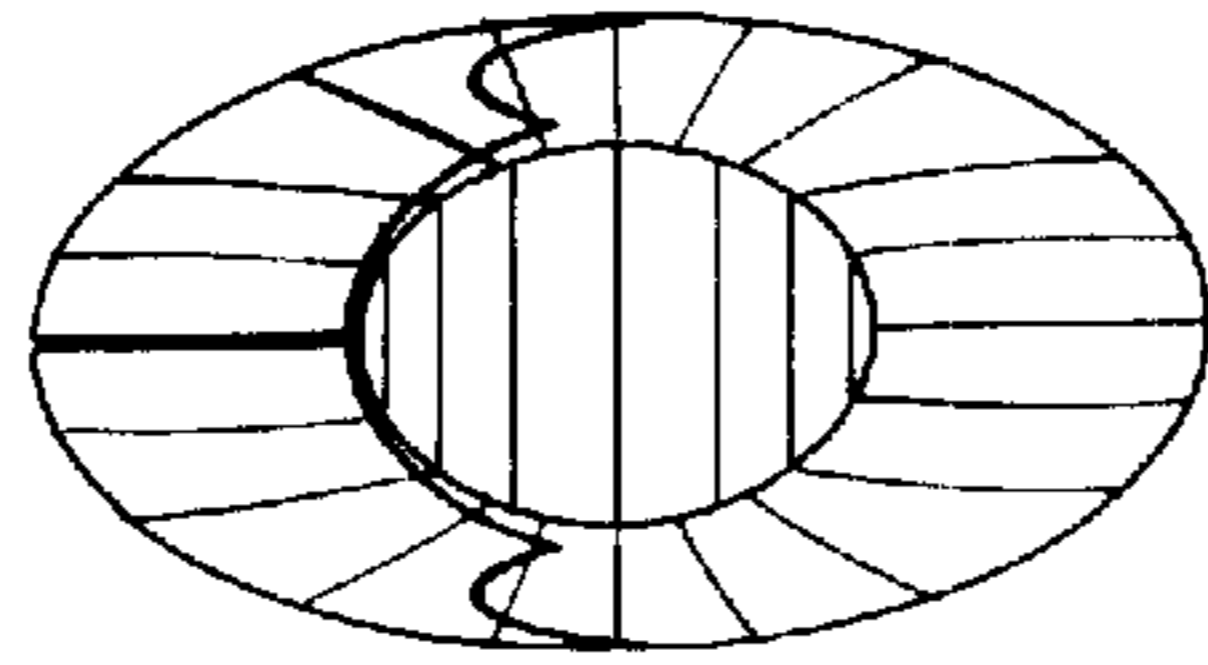

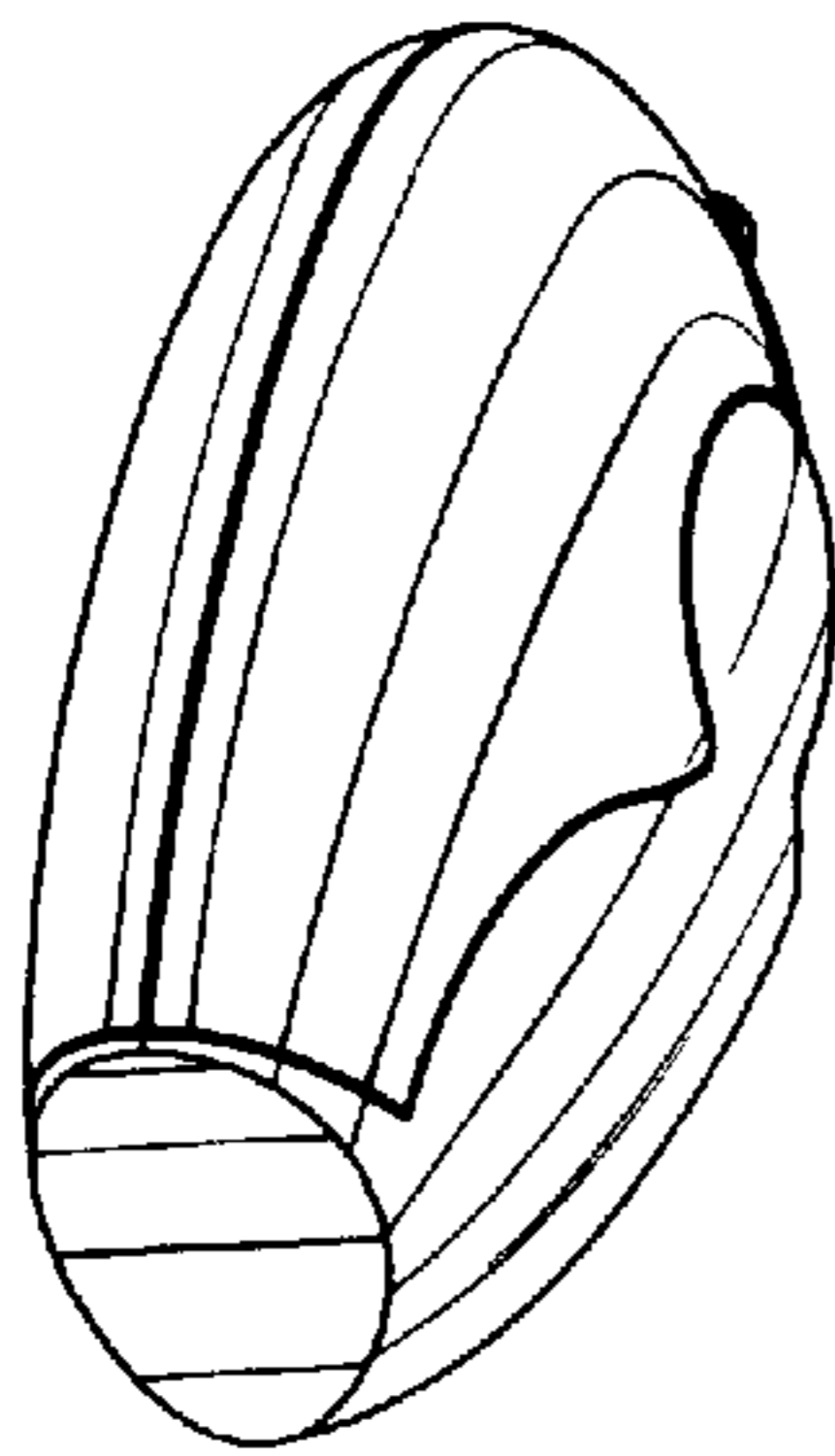

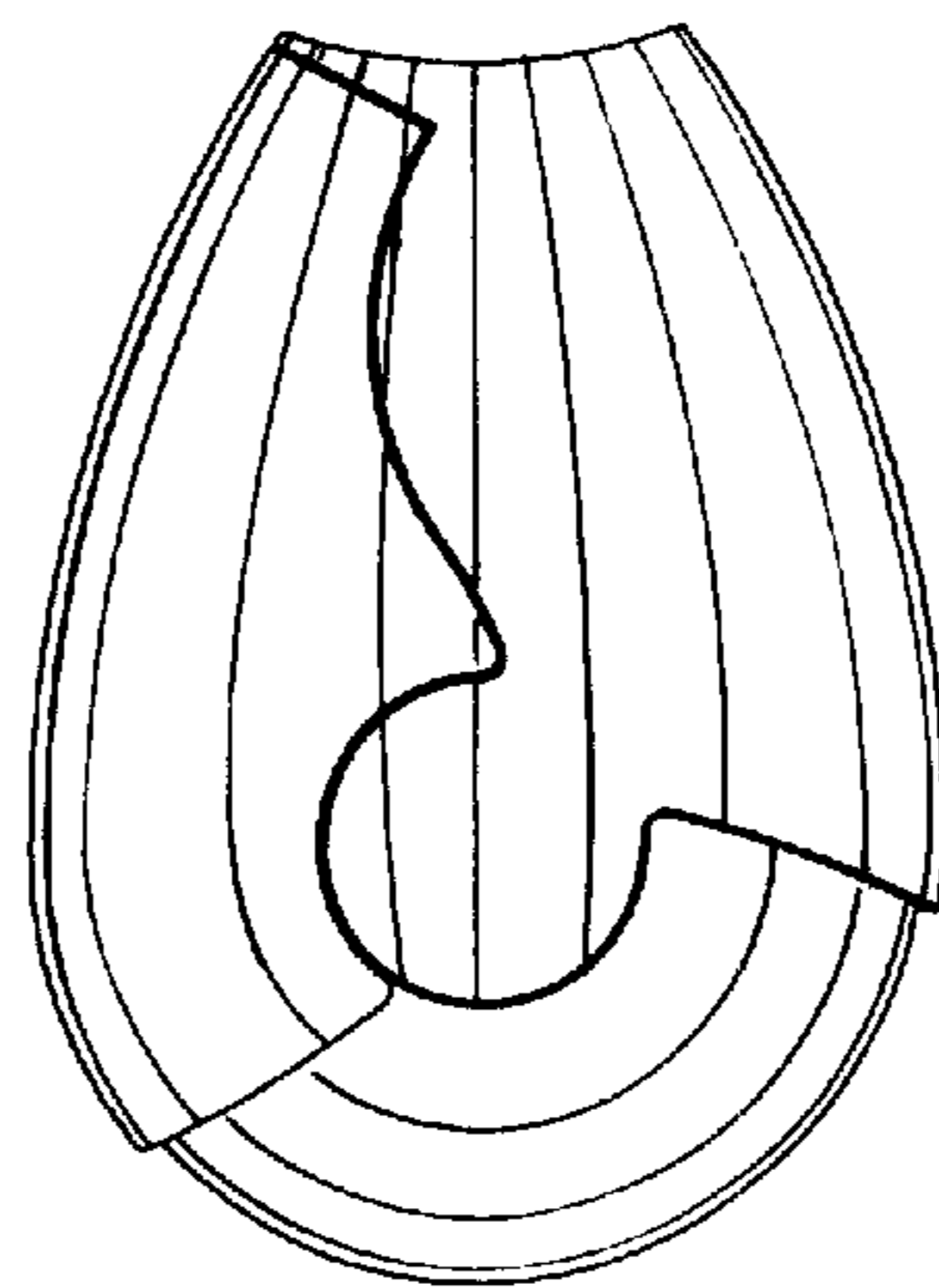

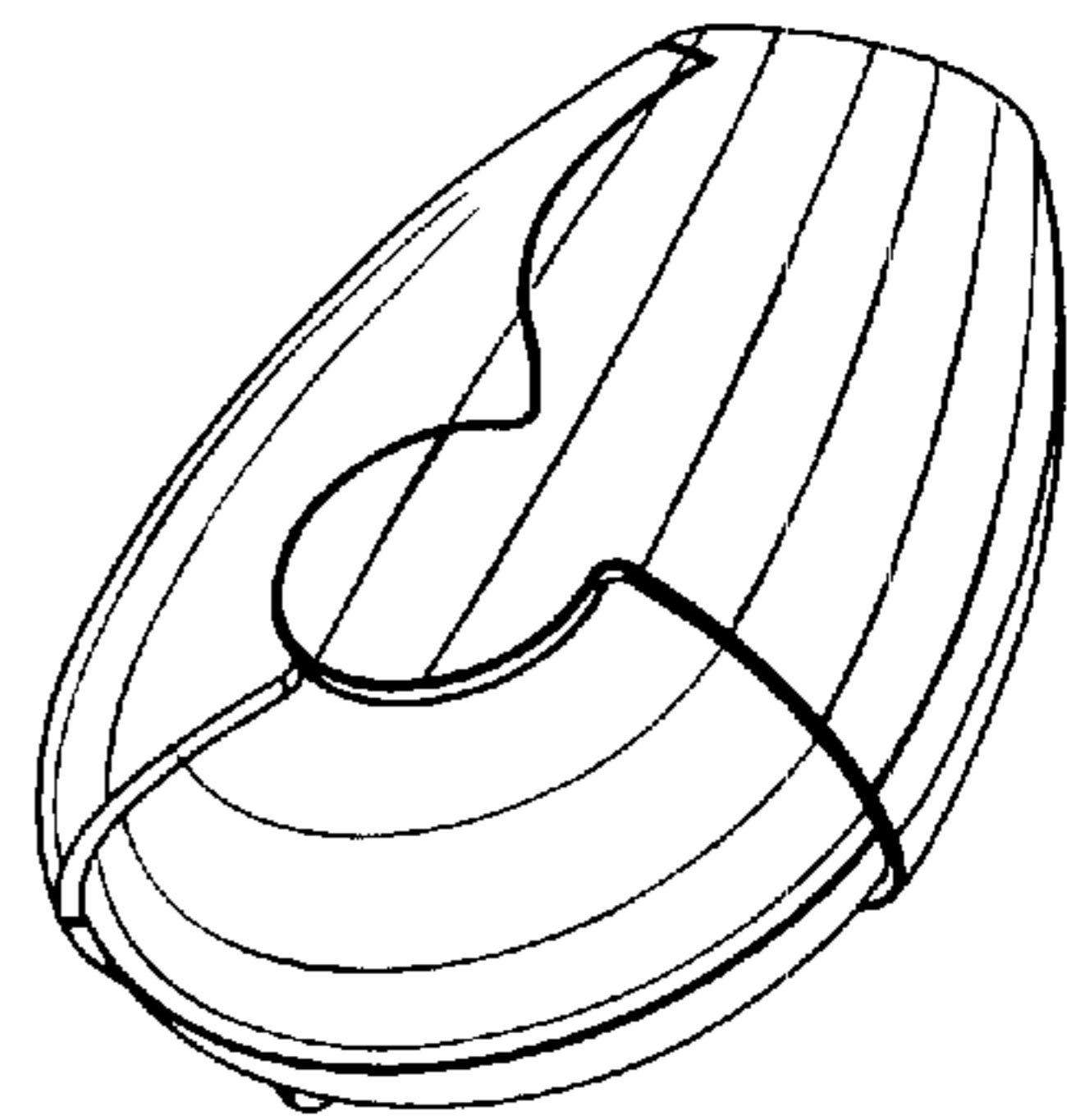

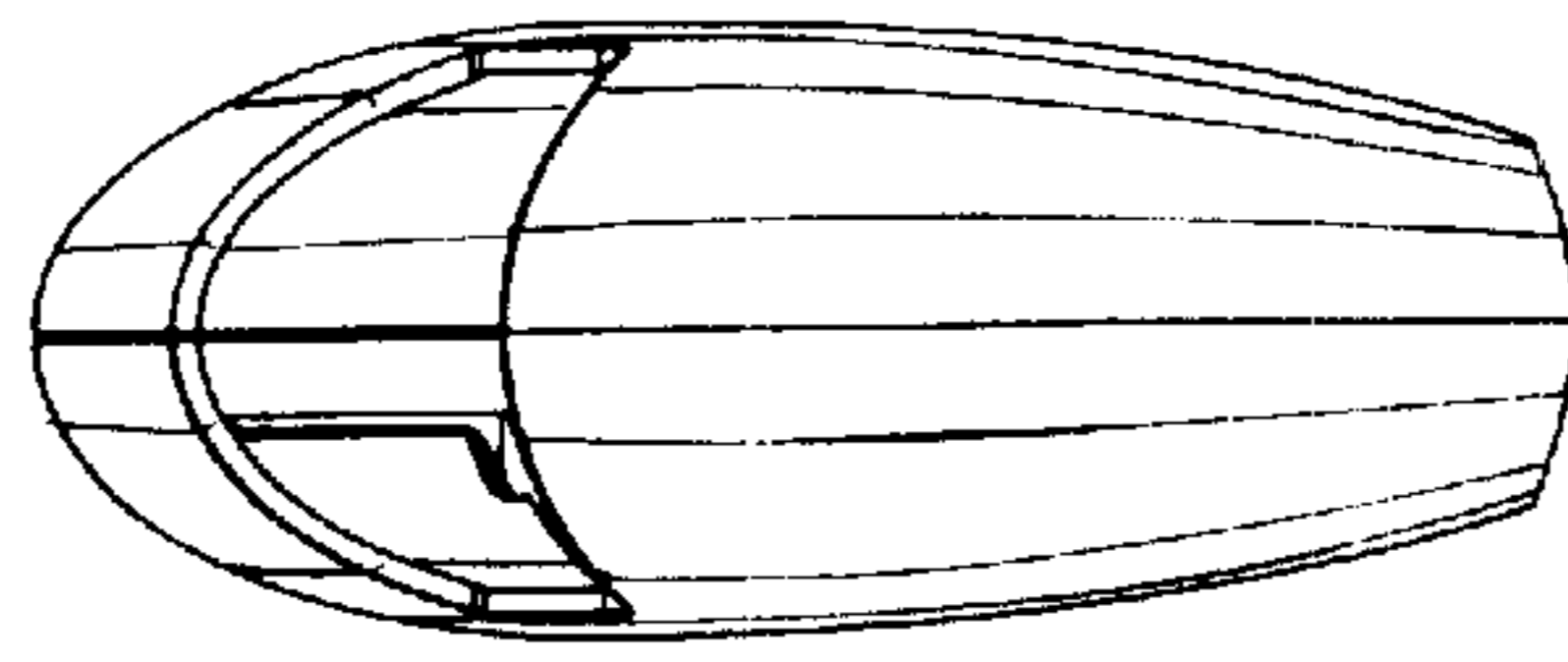

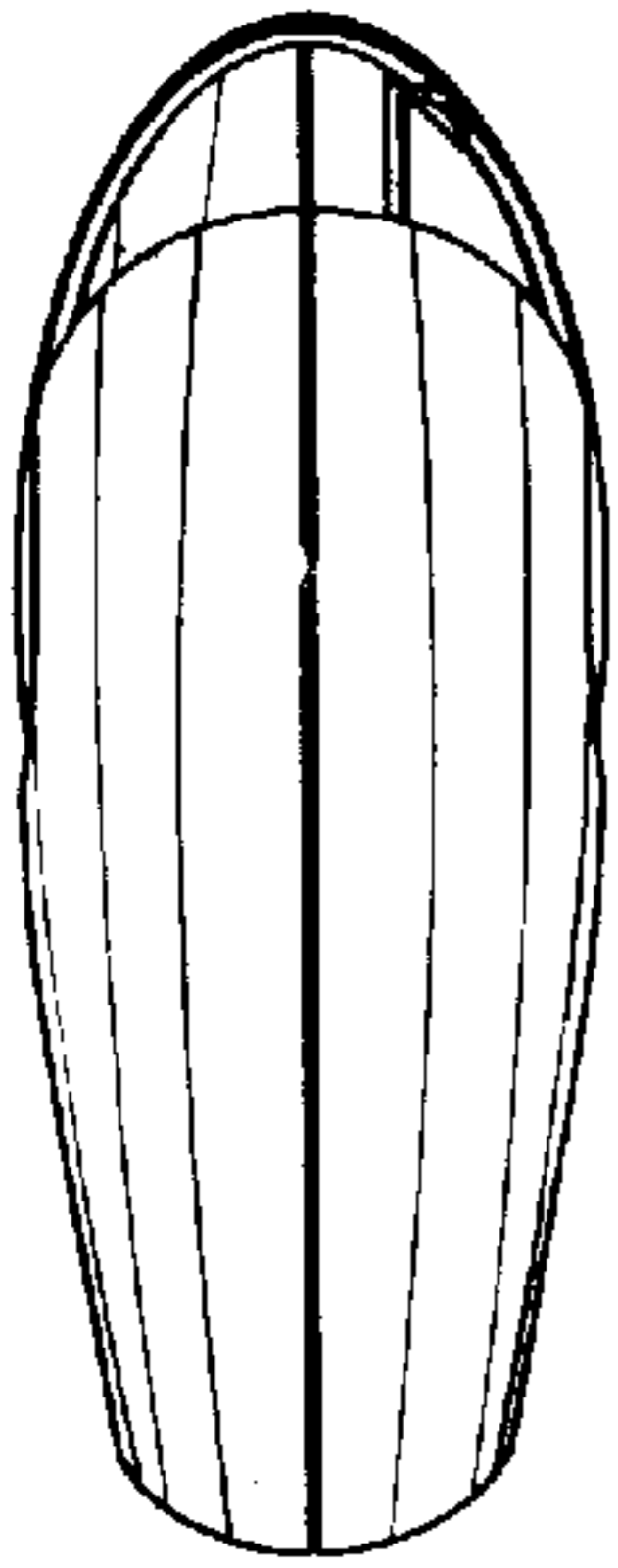

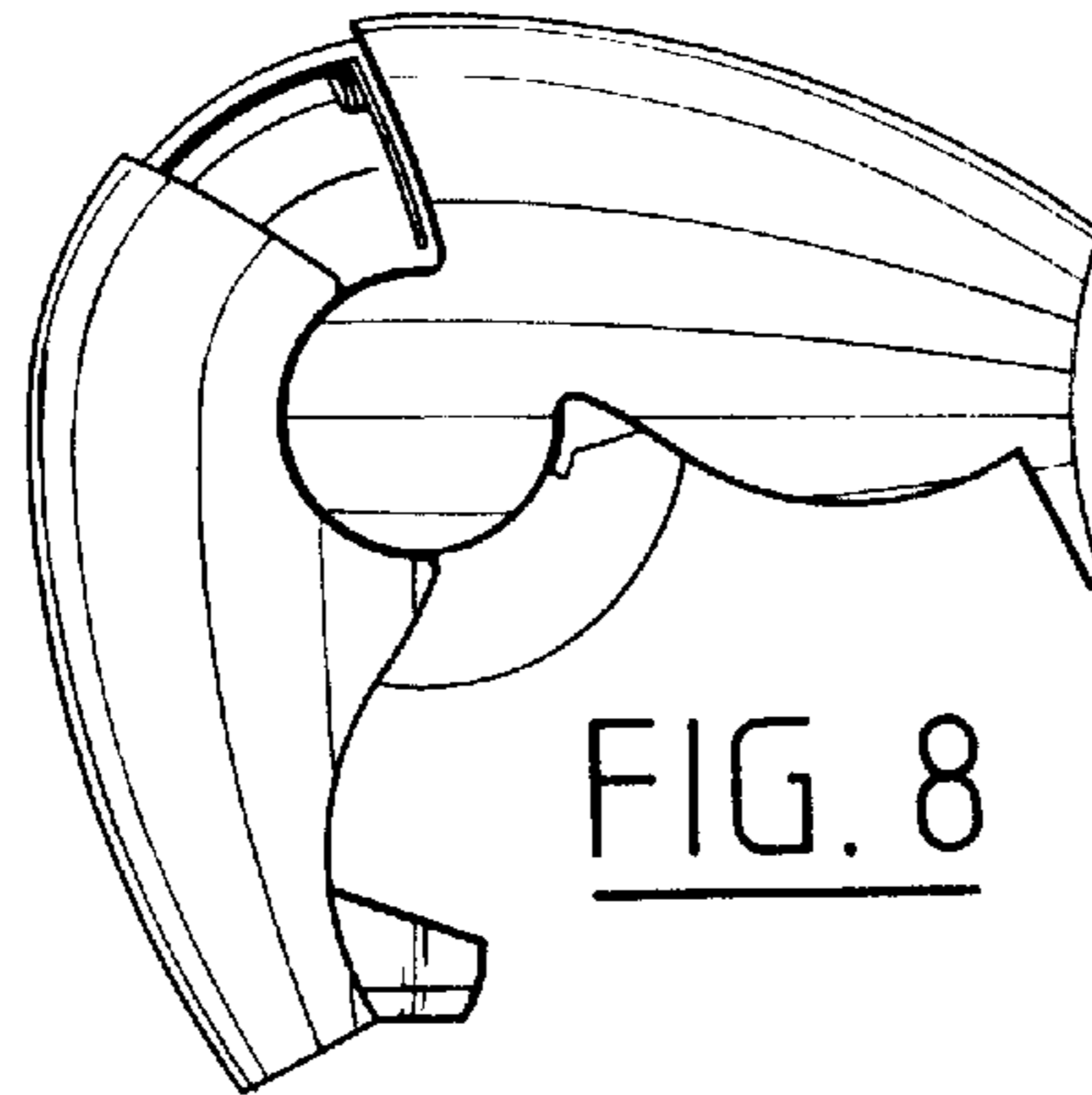

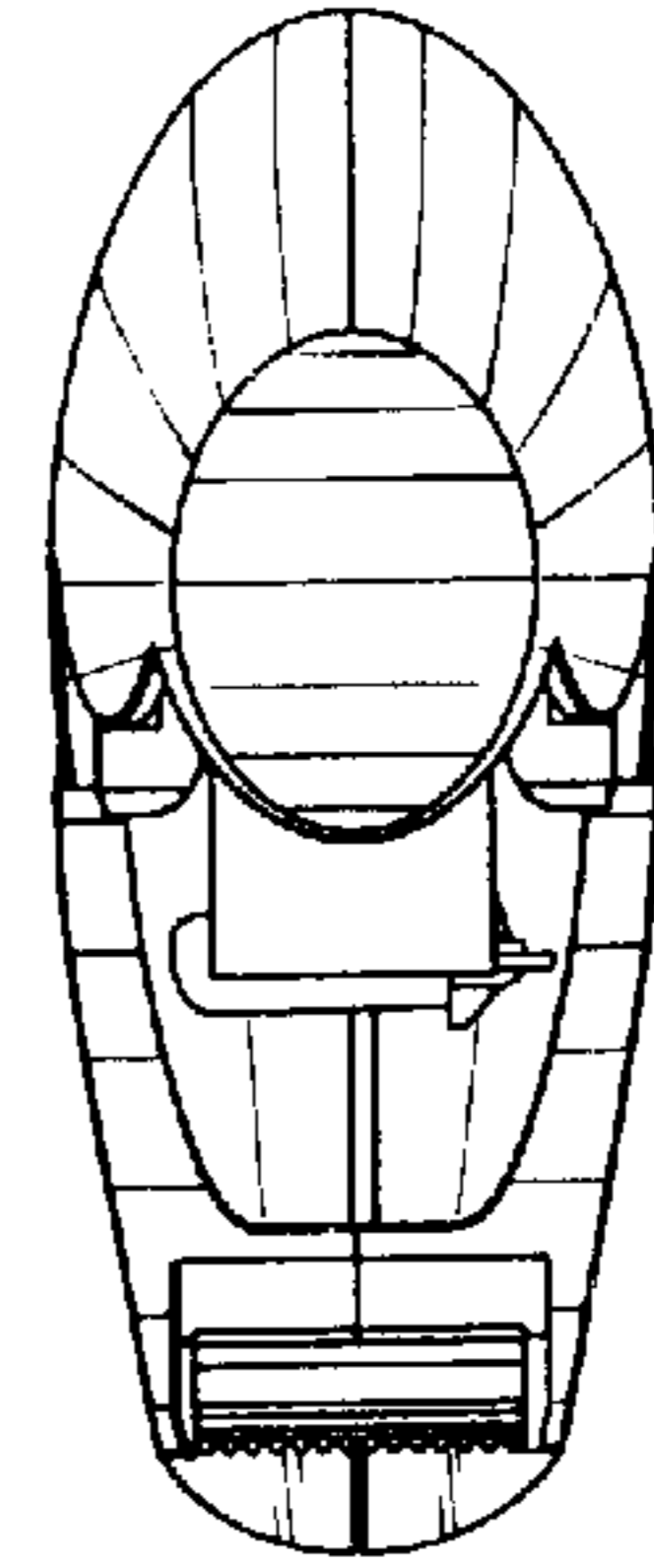

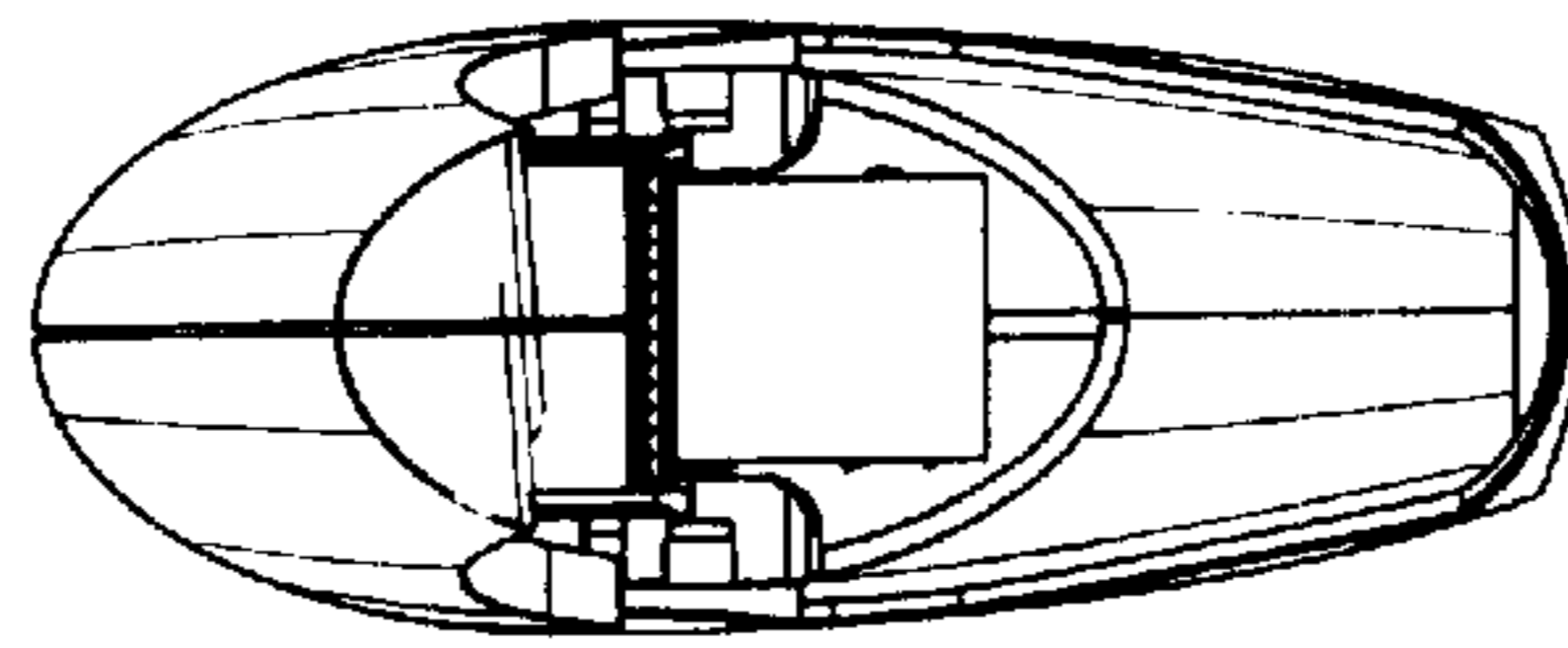

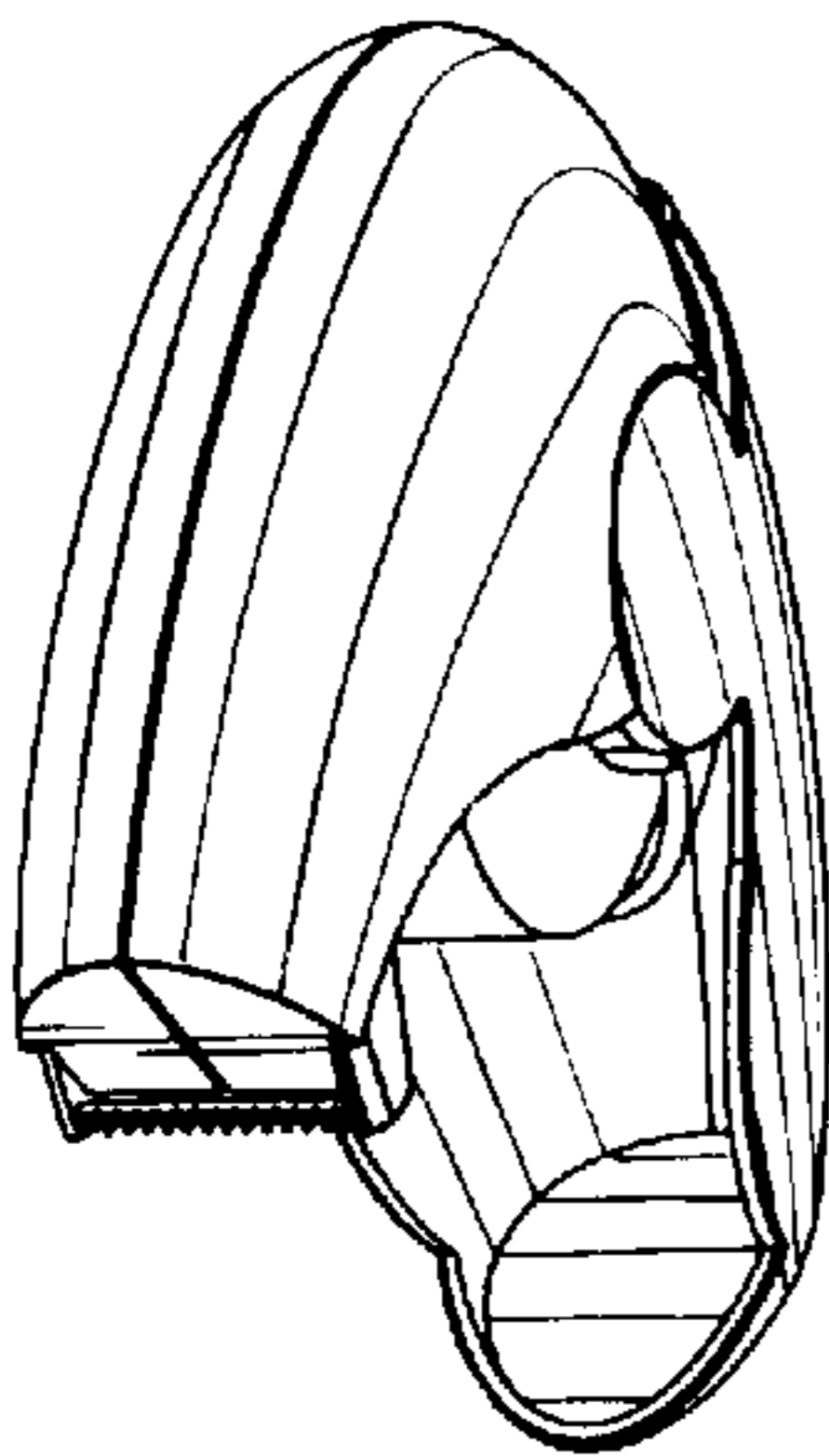

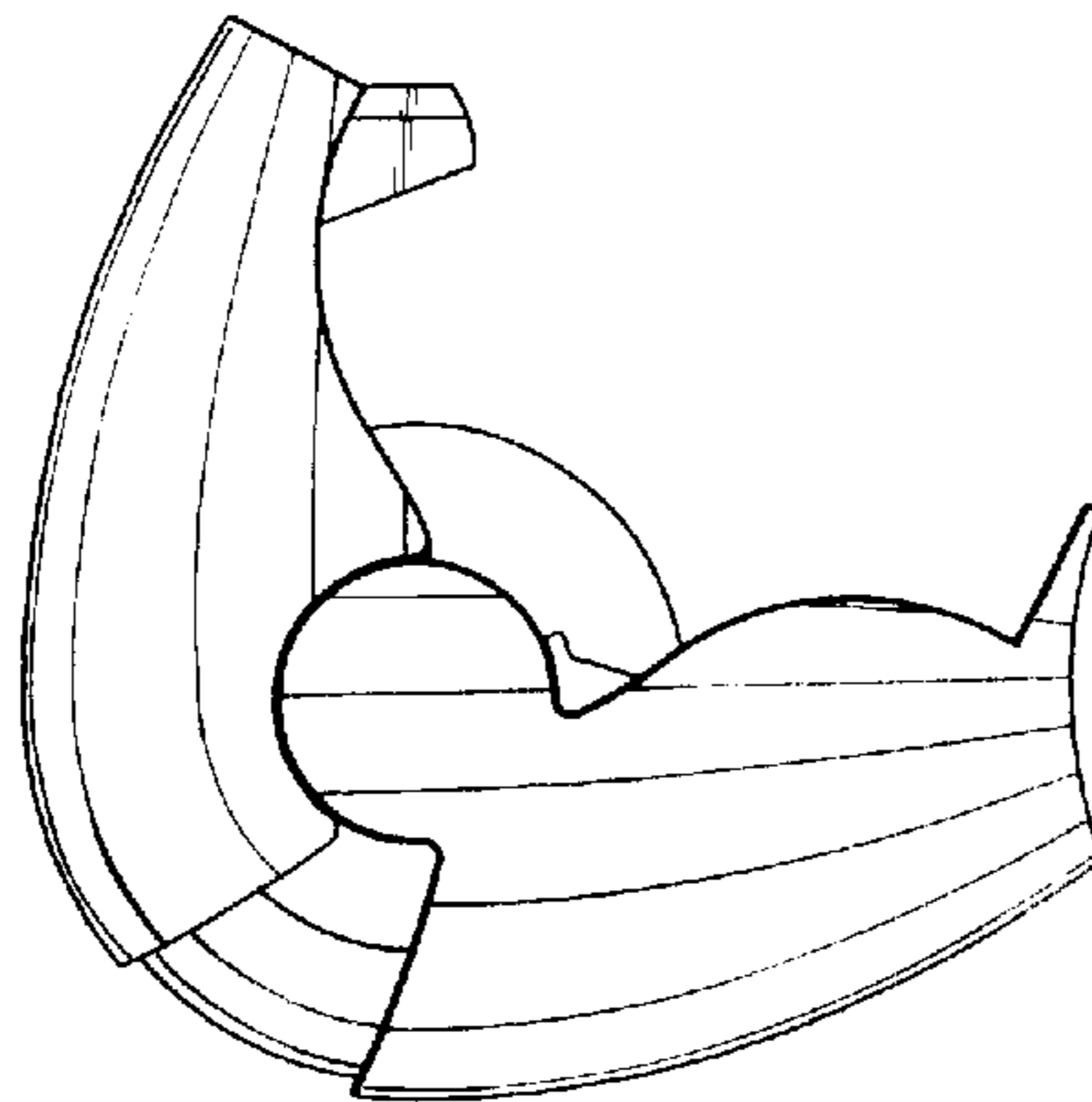

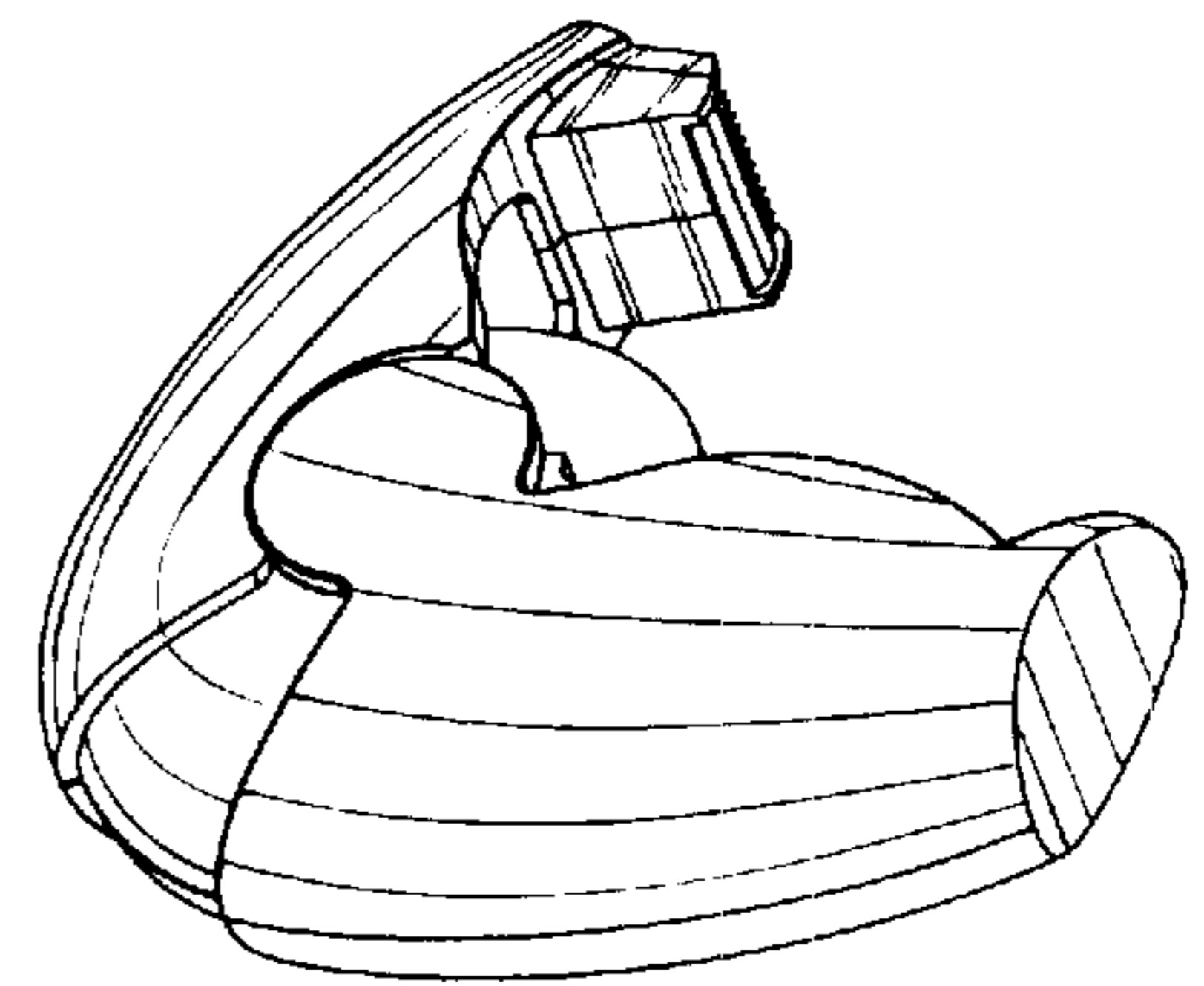
