**DESCRIPTION**

FIG. 1 is a plan view showing my new design for tape holder;

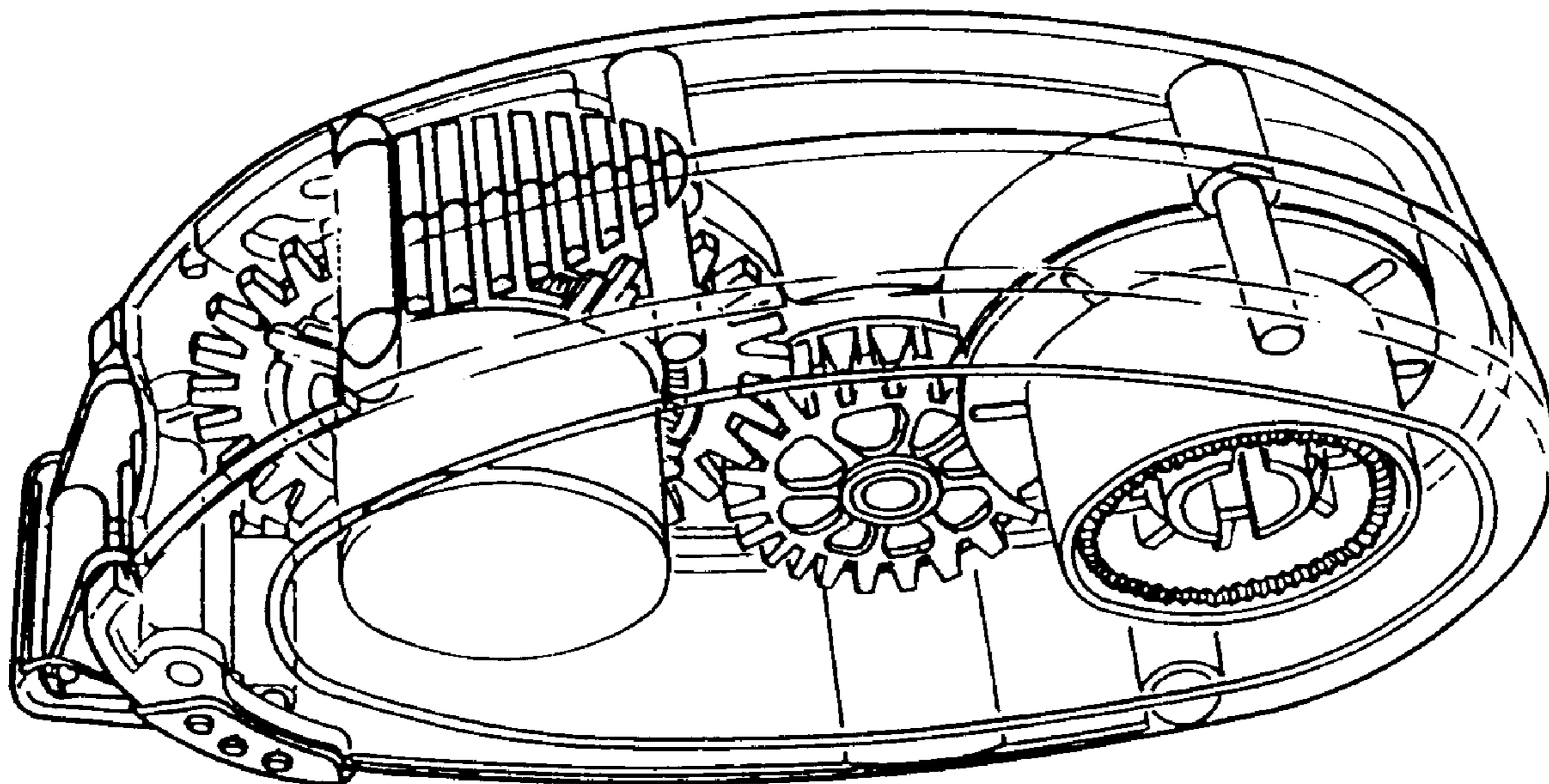

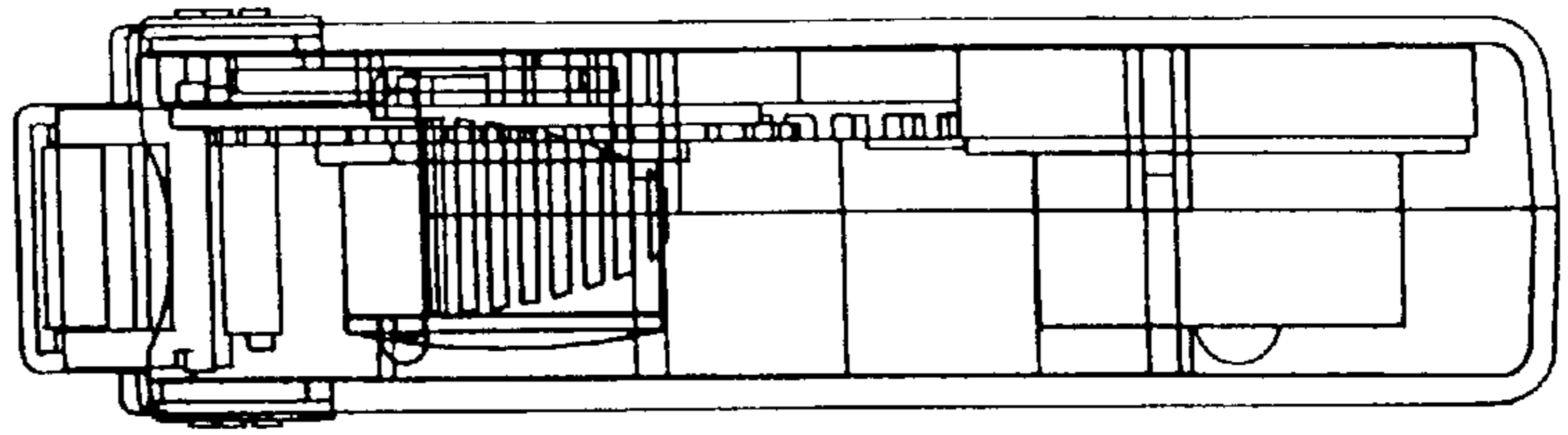

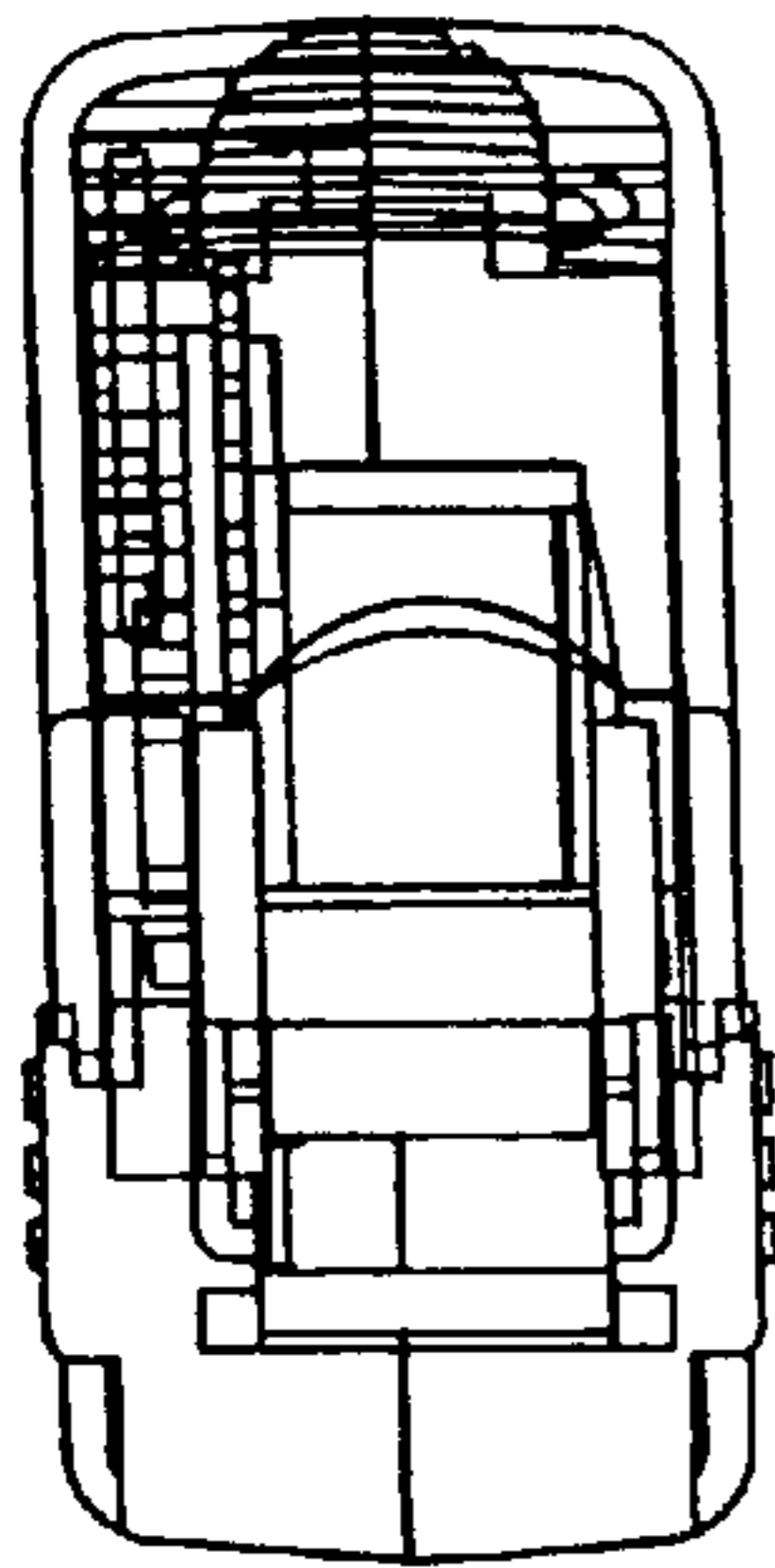

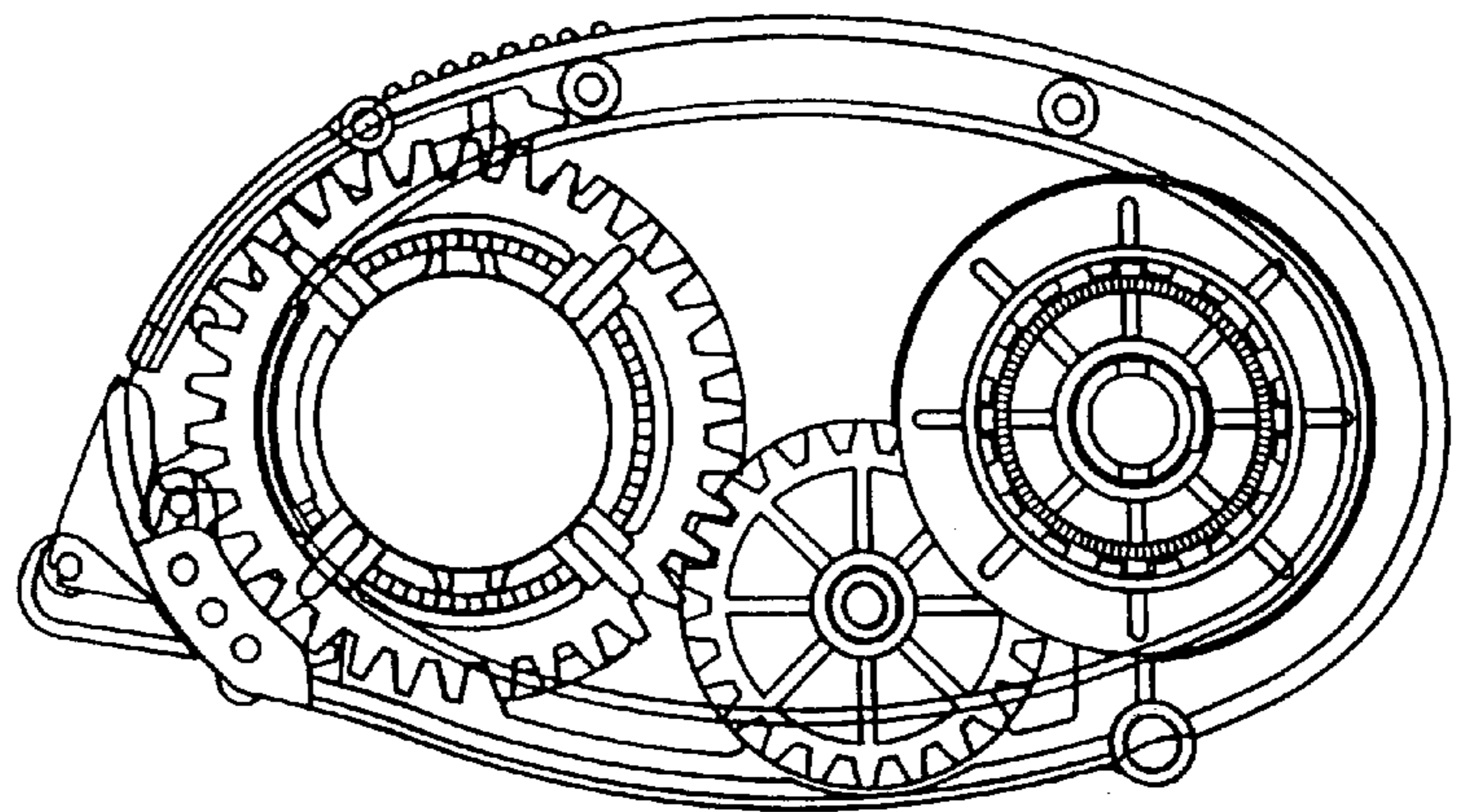

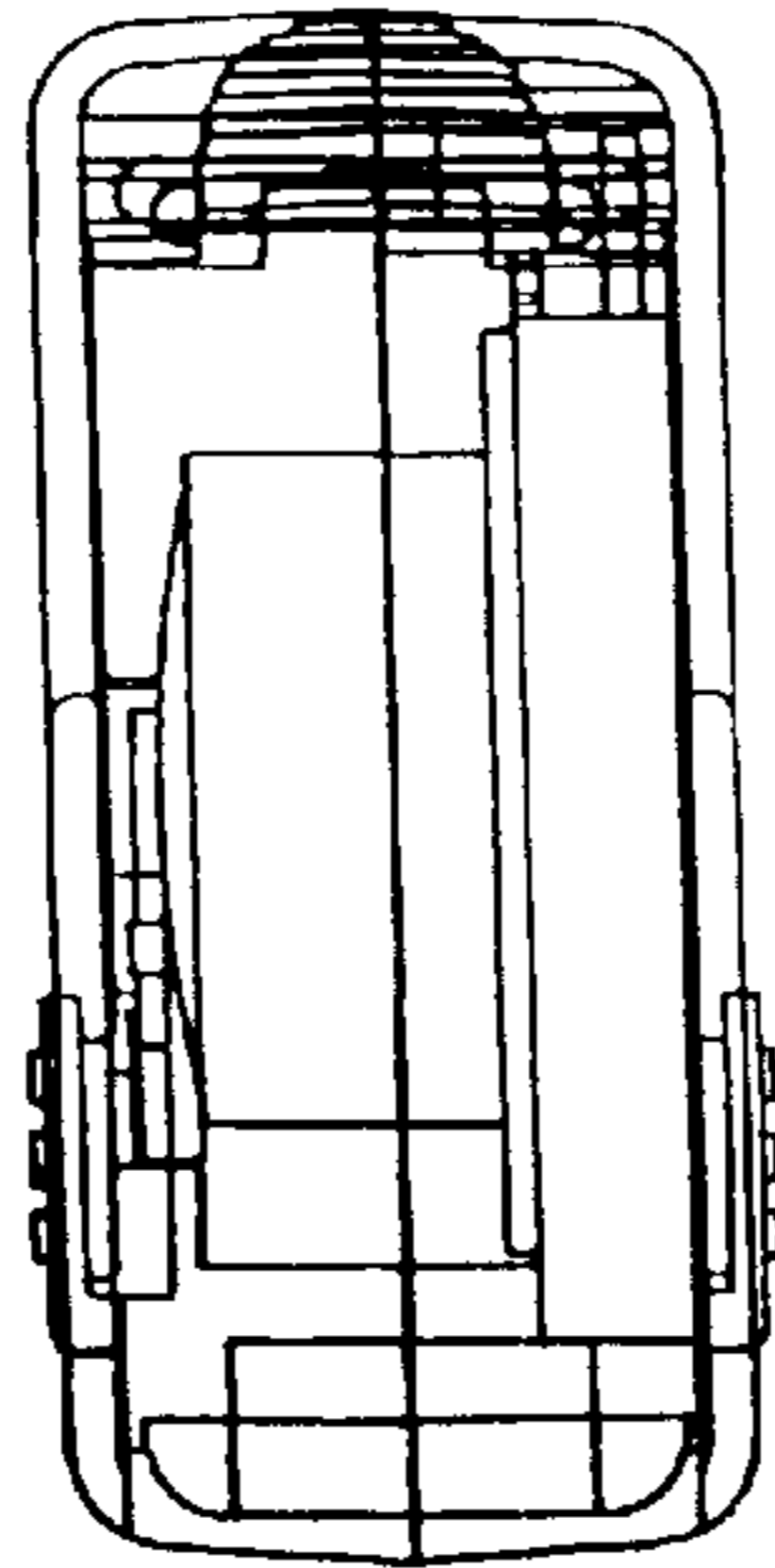

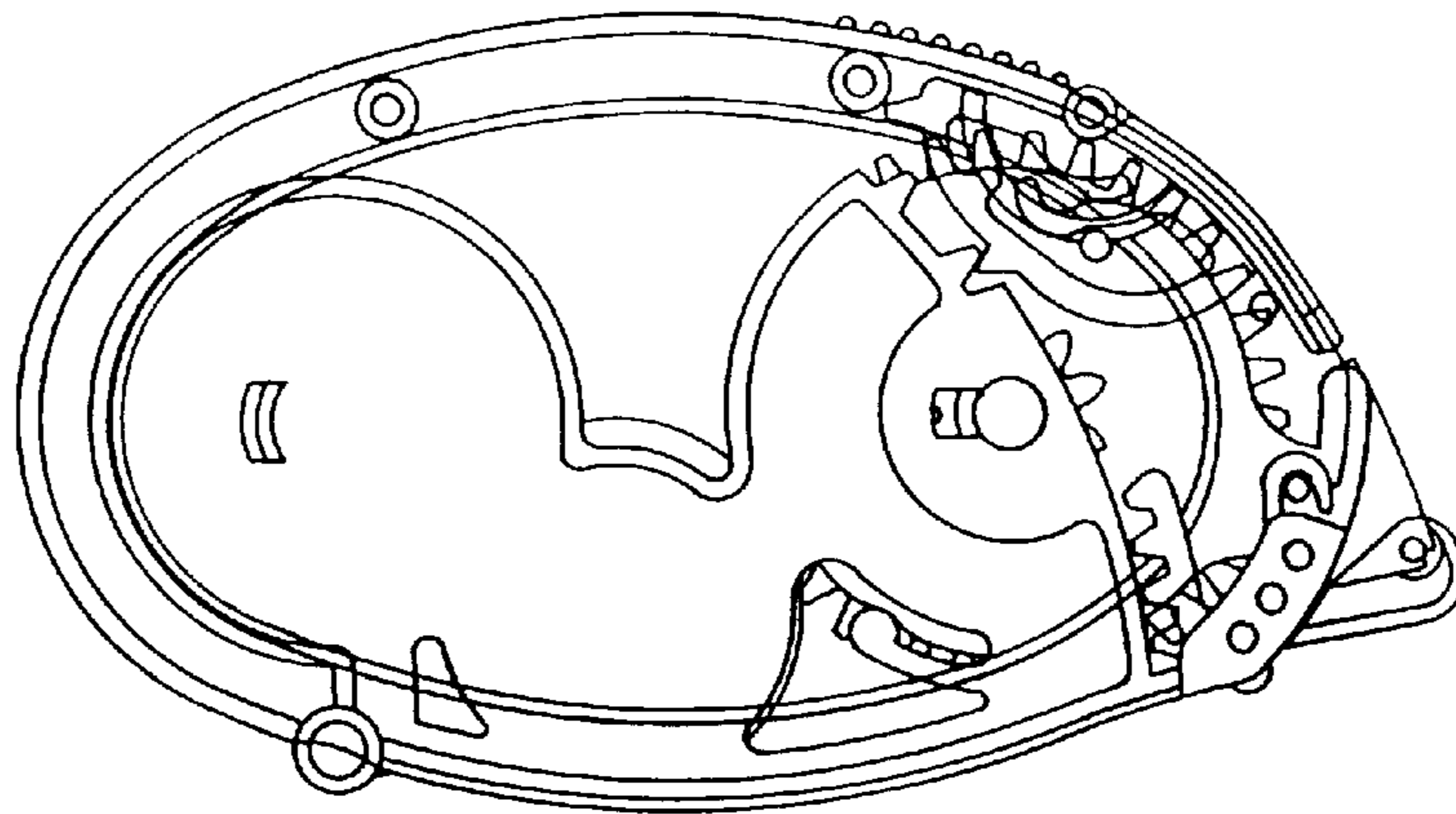

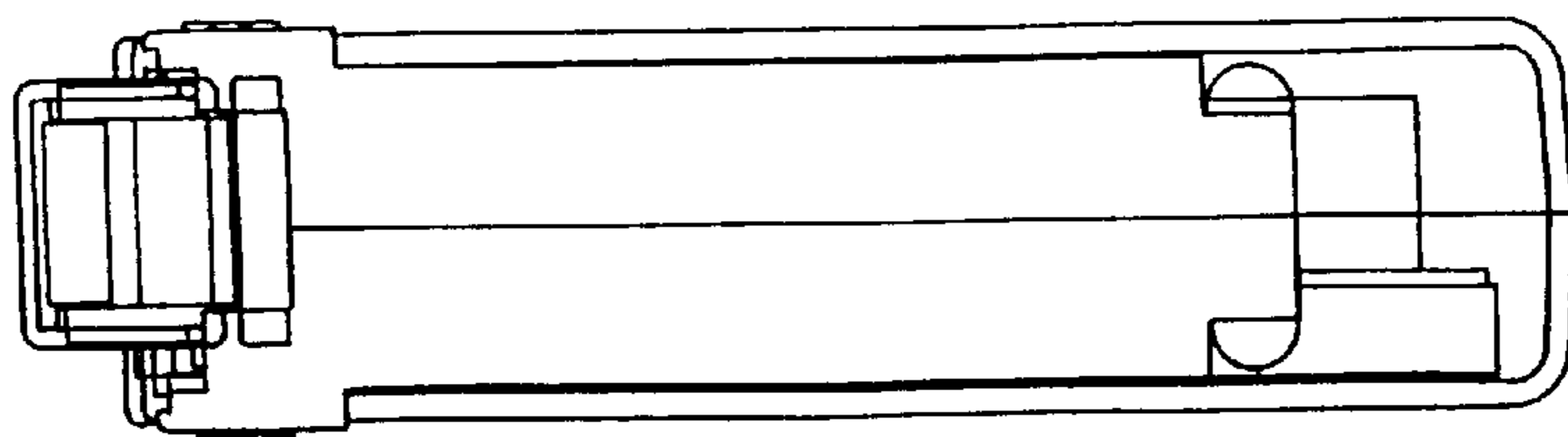
