(57) **CLAIM**

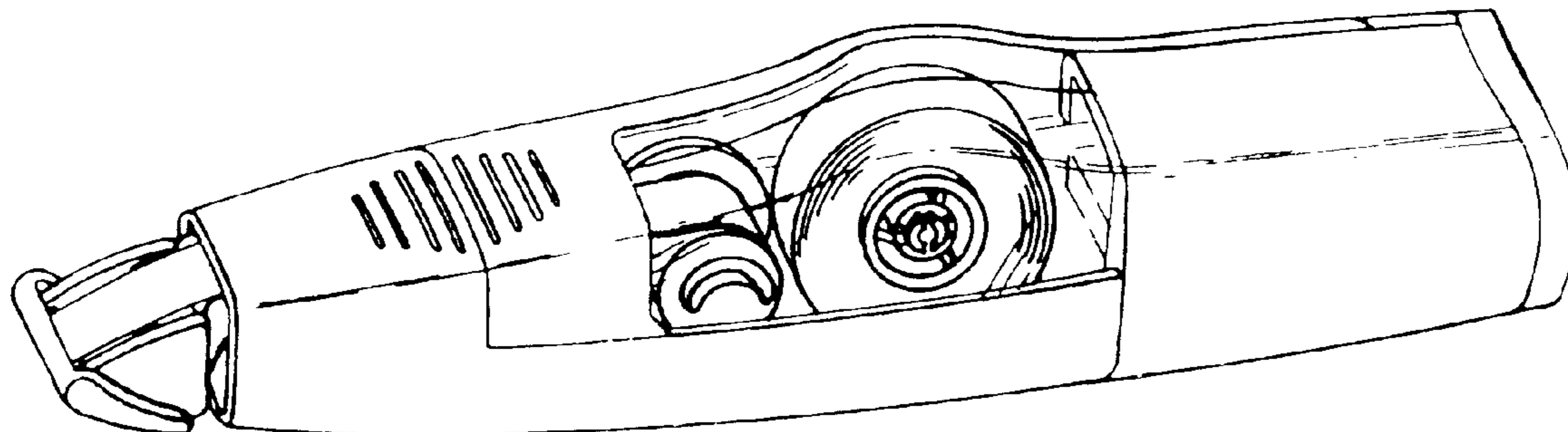
The ornamental design for a film-transferring device for office use, as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view showing my new design for a film-transferring device for office use;

FIG. 2 is a front elevation view thereof;  
FIG. 3 is a cross-sectional view taken in the direction of arrows 3—3 in FIG. 1;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a rear elevational view thereof;  
FIG. 8 is a cross-sectional view taken in the direction of arrows 8—8 in FIG. 2;  
FIG. 9 is a cross-sectional view taken in the direction of arrows 9—9 in FIG. 2;  
FIG. 10 is a front elevational view in an in-use position with the cover member folded back, the ground line being shown for illustrative purposes only and forming no part of the claimed design;  
FIG. 11 is a top plan view of the body portion shown separately for each of illustration;  
FIG. 12 is a front elevational view of FIG. 11;  
FIG. 13 is a left side elevational view of FIG. 11;  
FIG. 14 is a right side elevational view of FIG. 11;  
FIG. 15 is a bottom plan view of FIG. 11;

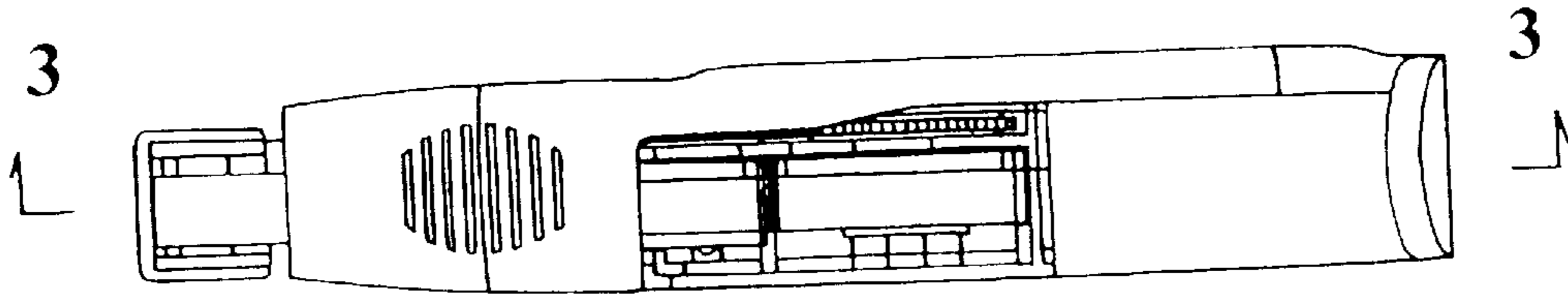

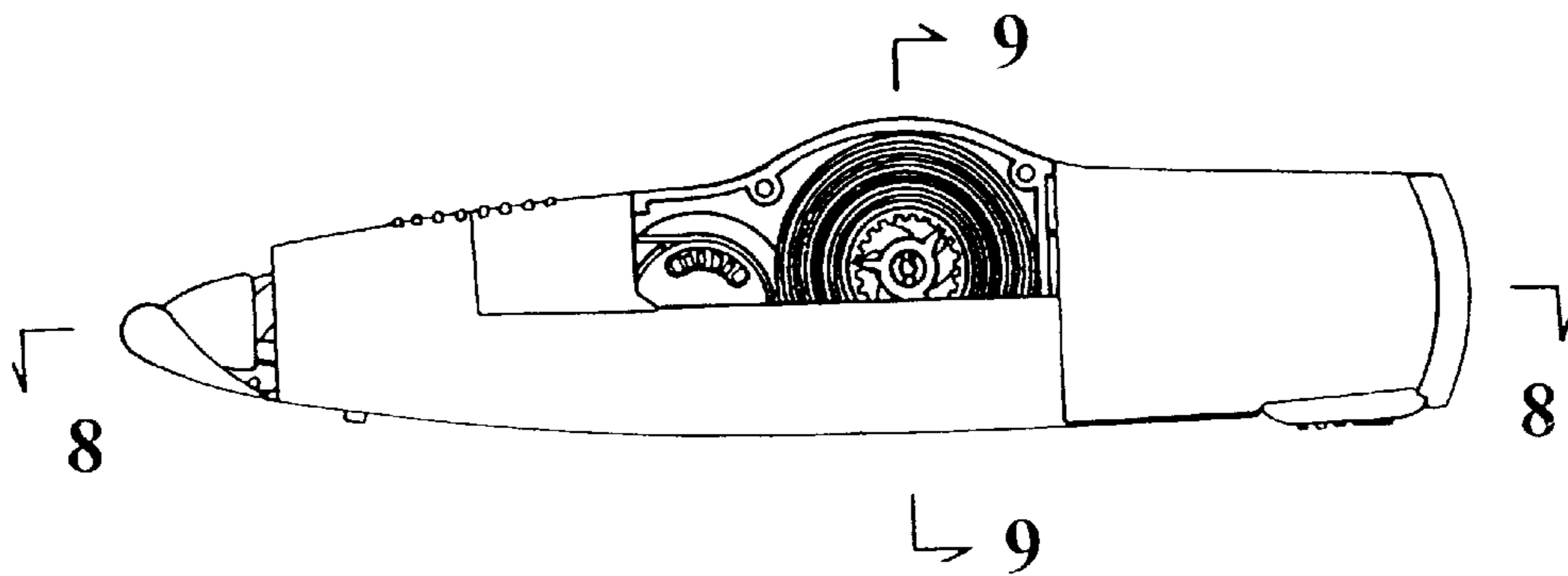

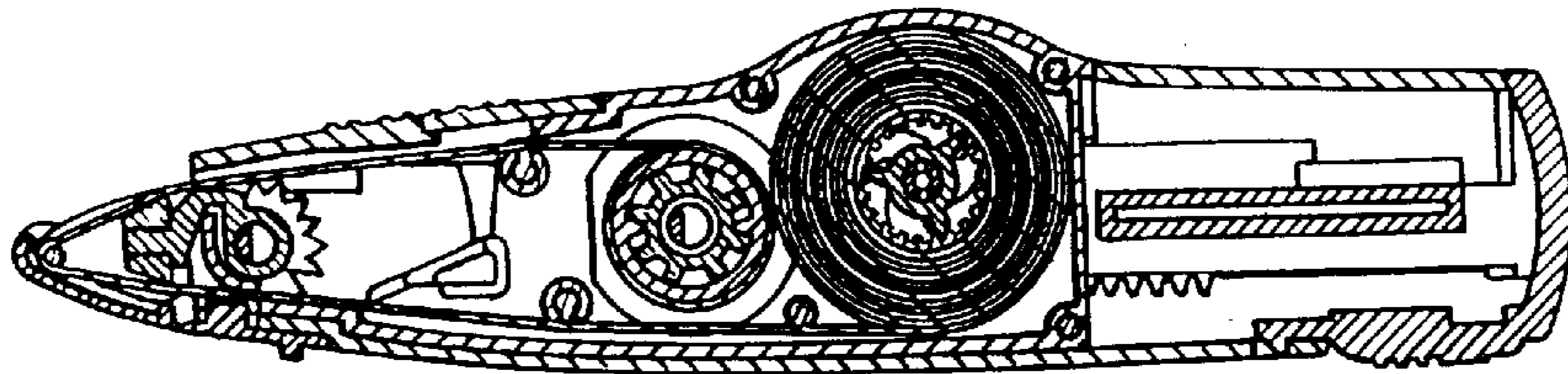

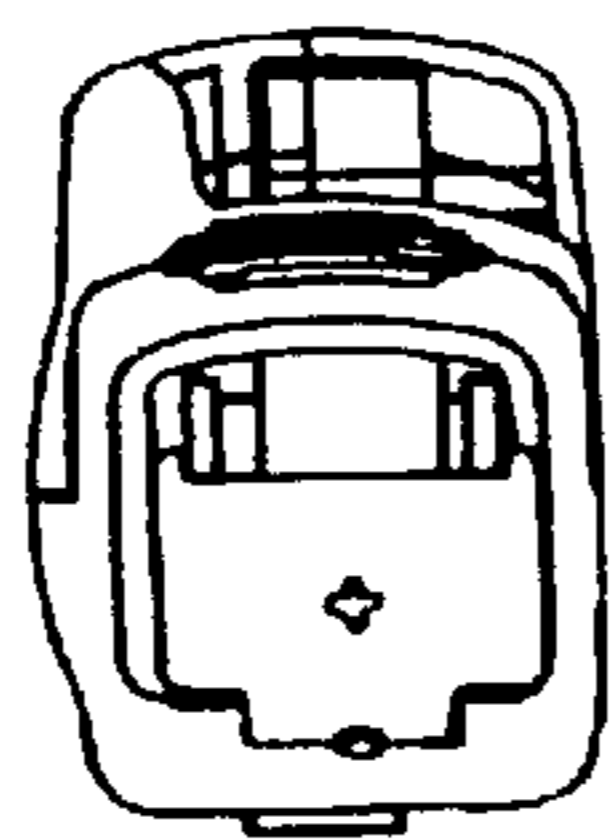

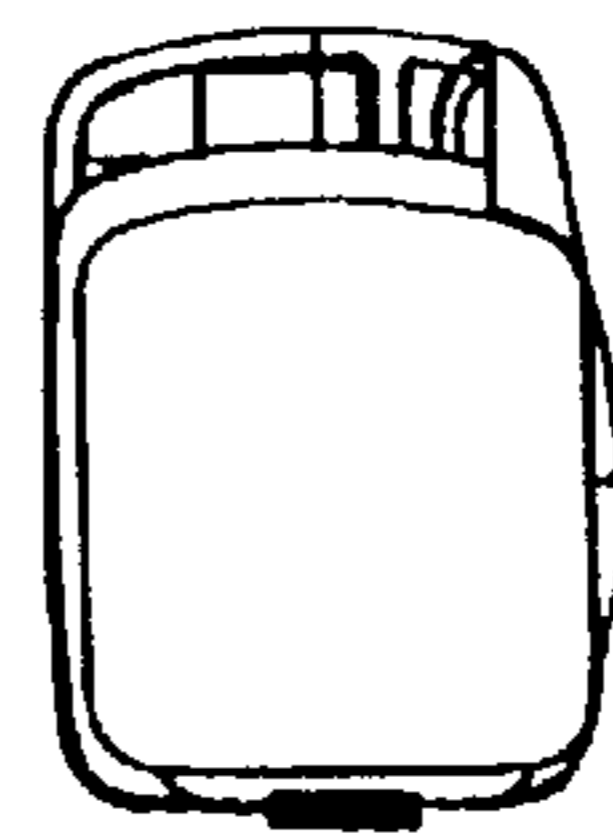

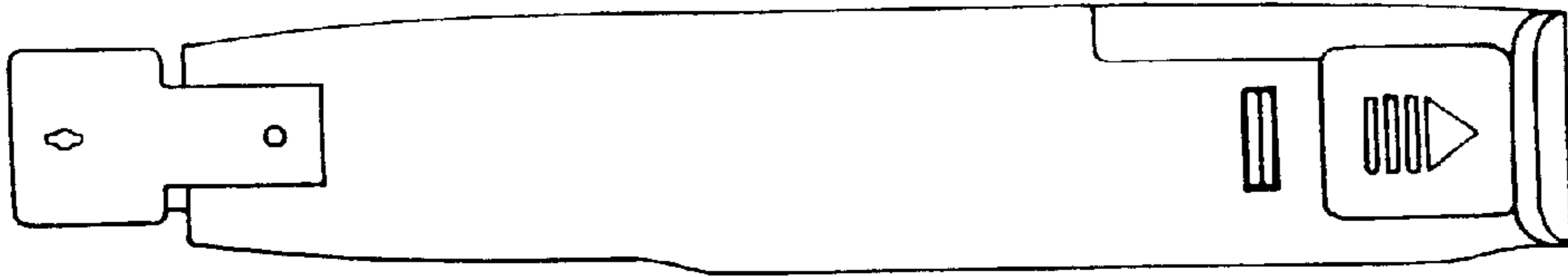

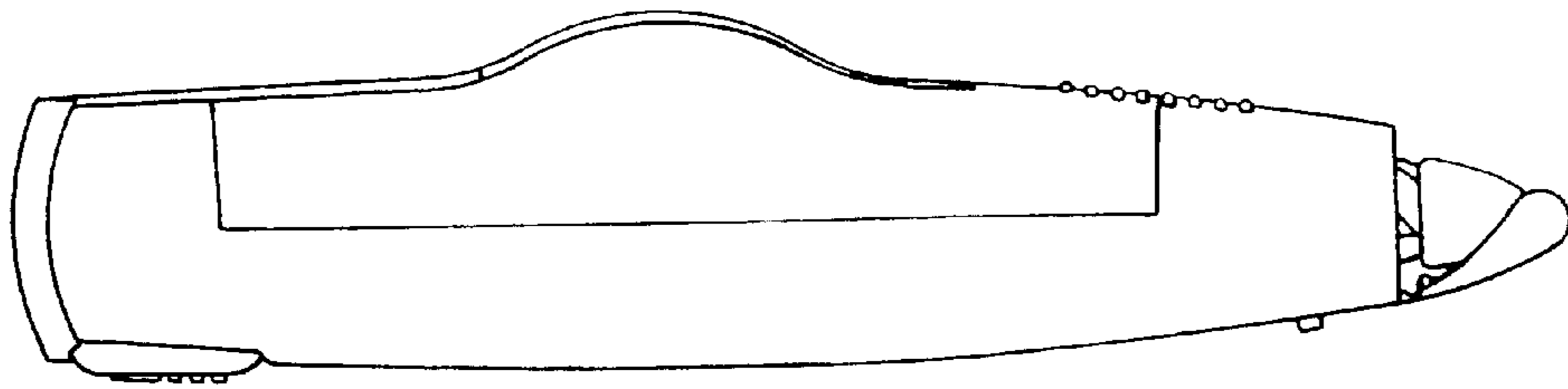

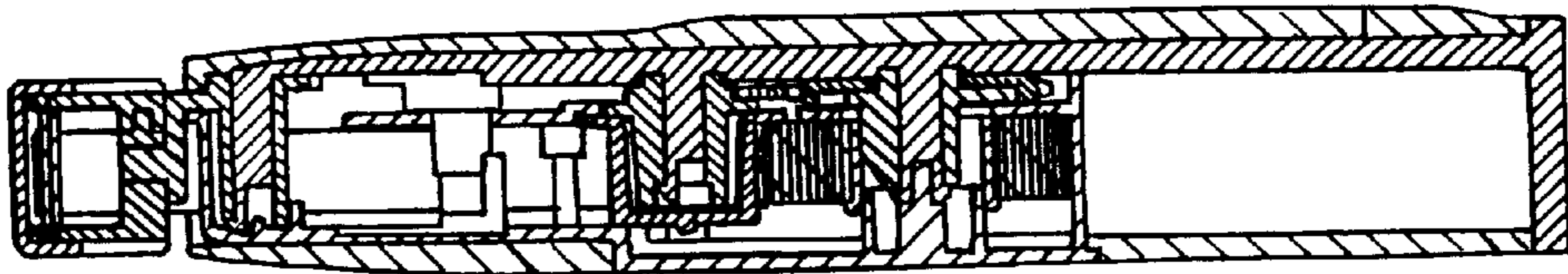

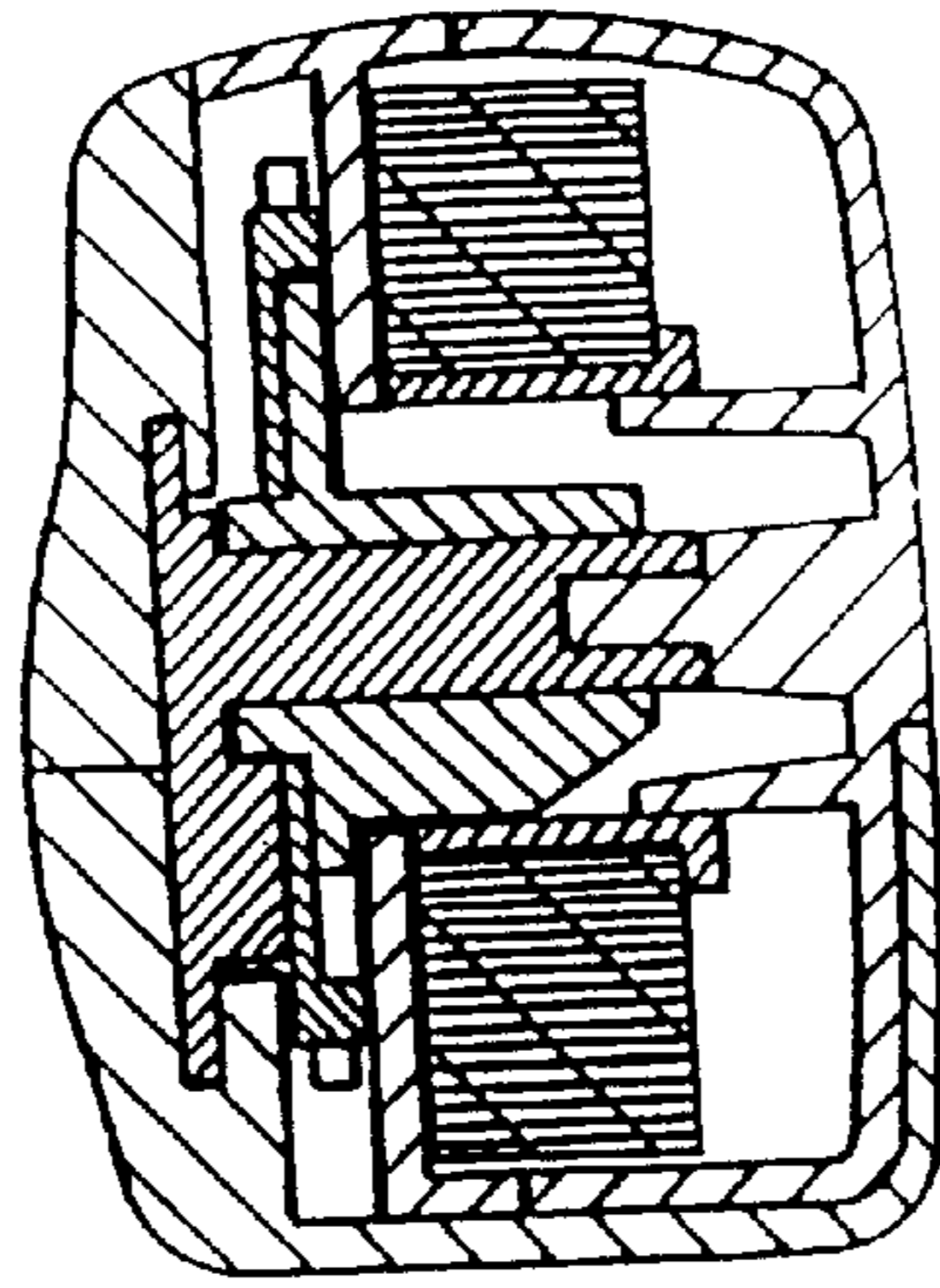

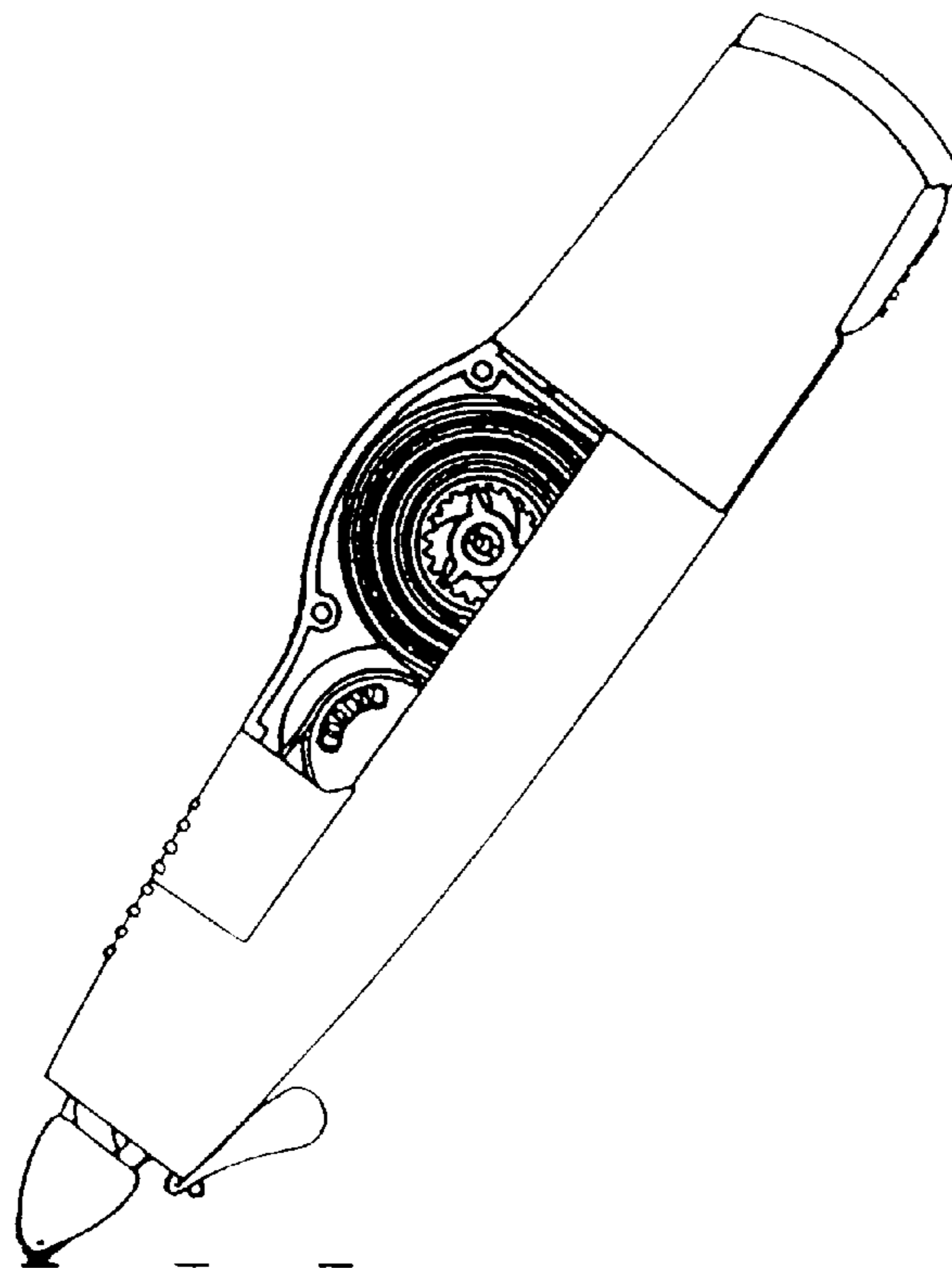

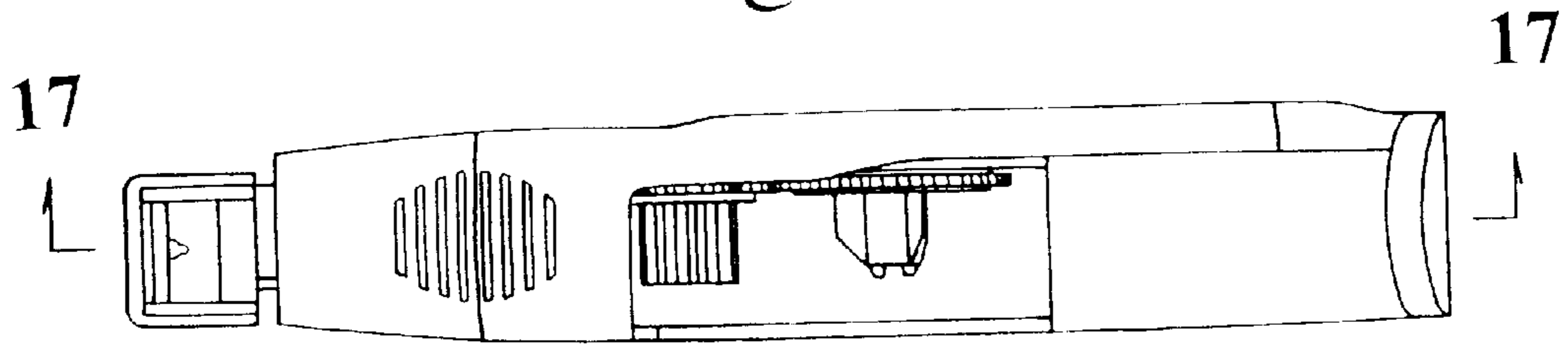

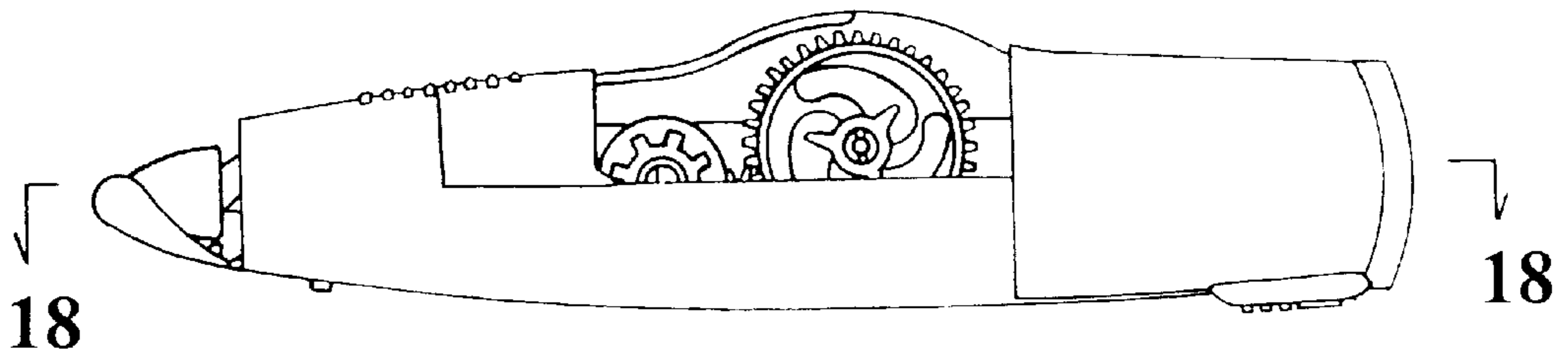

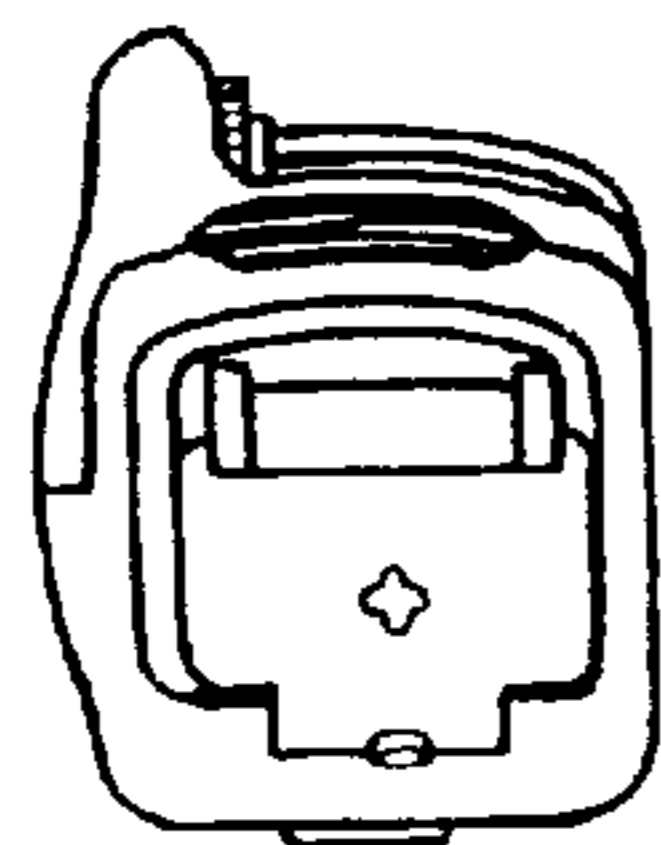

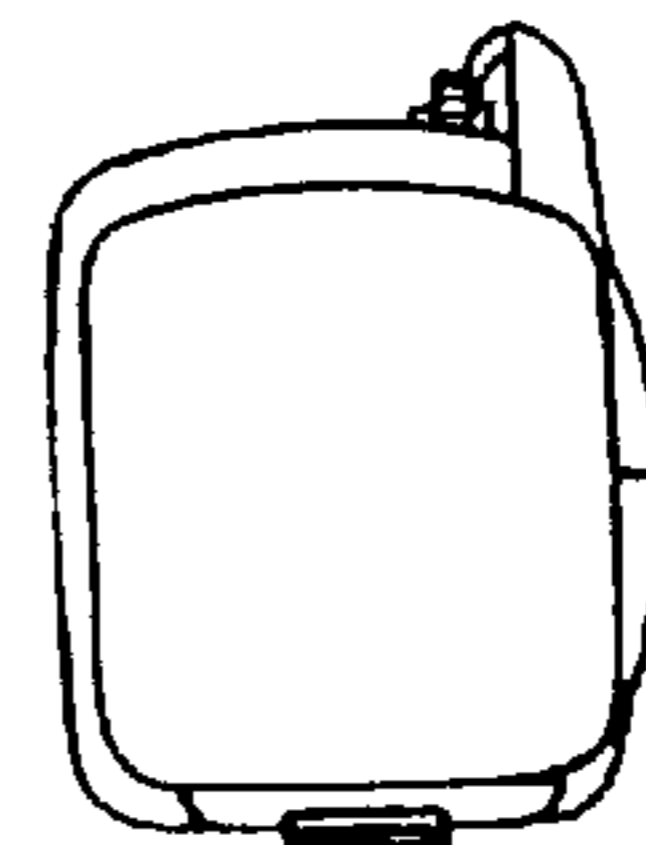

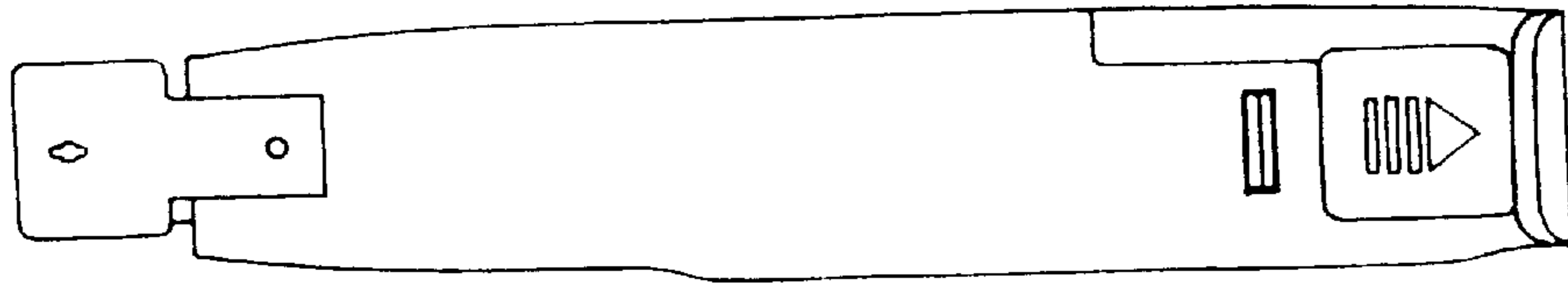

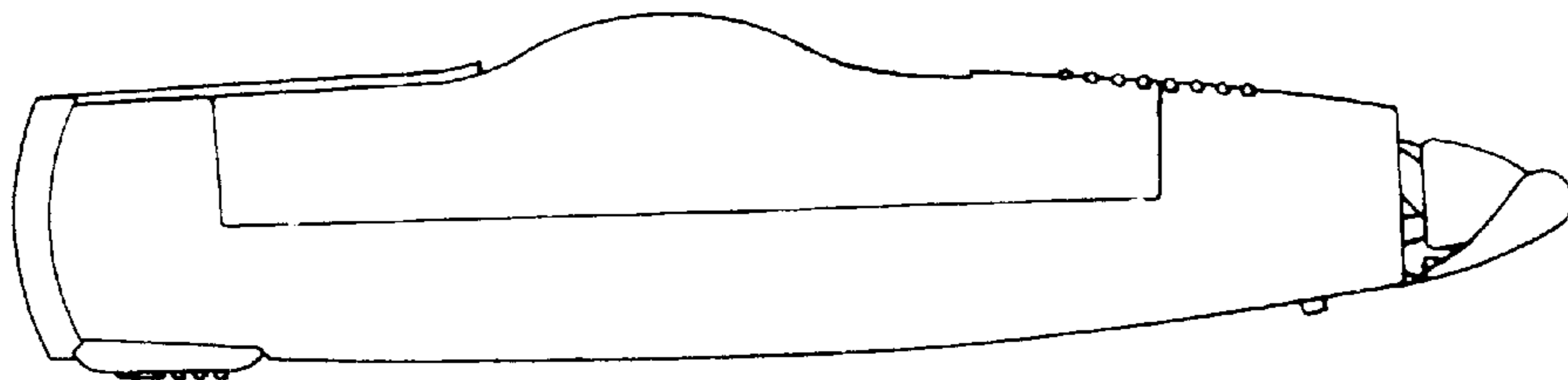

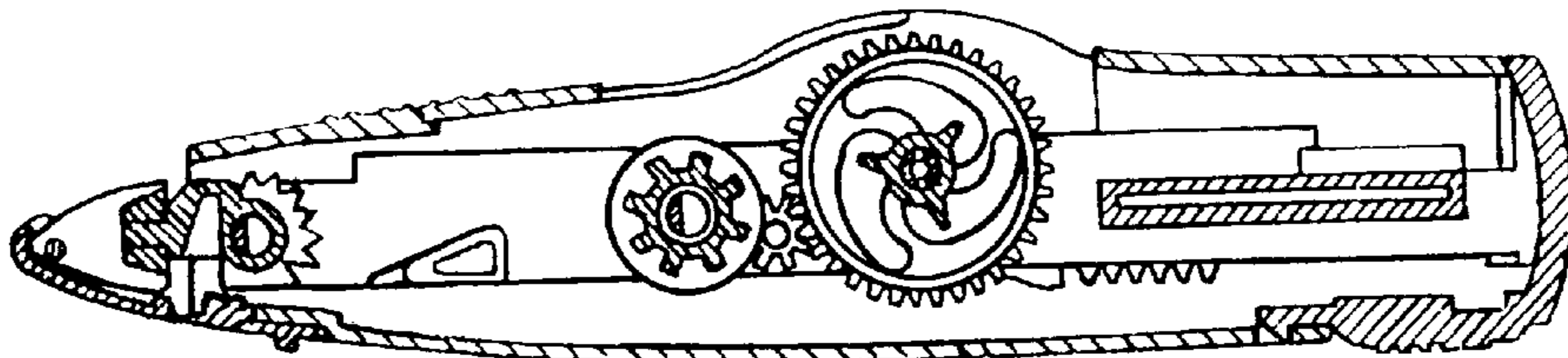
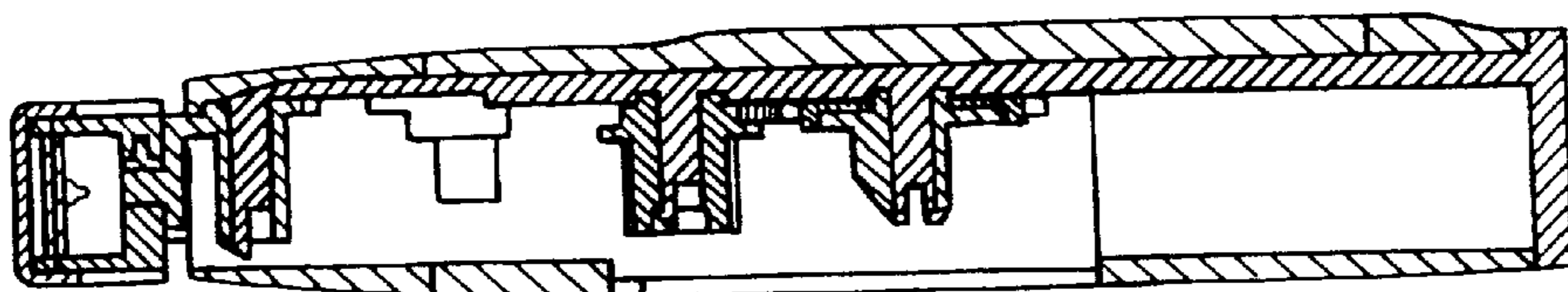

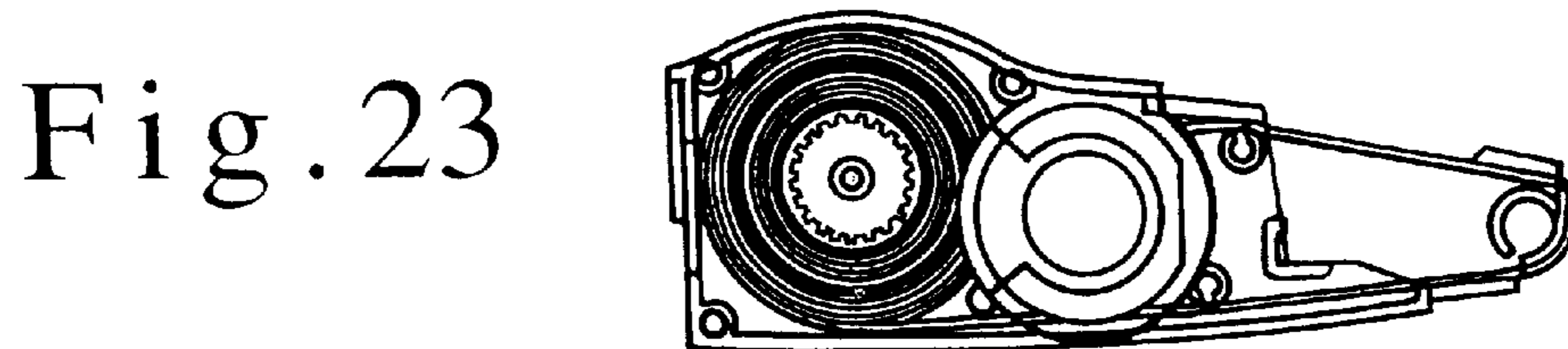
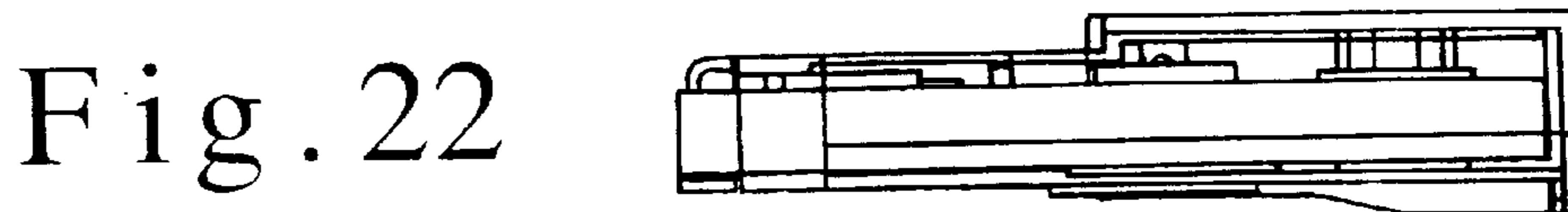
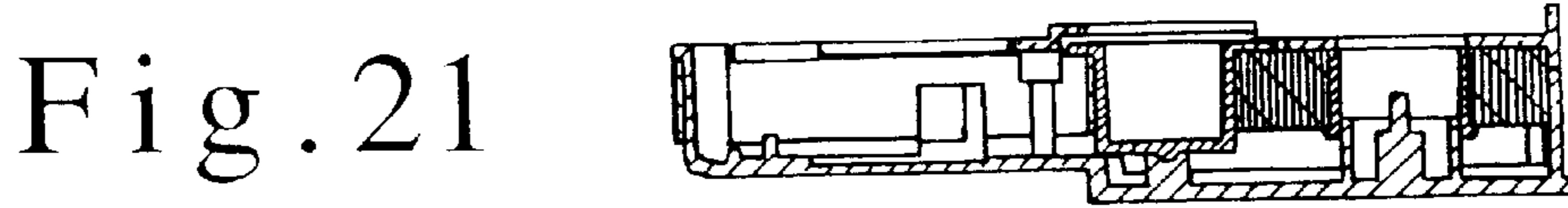
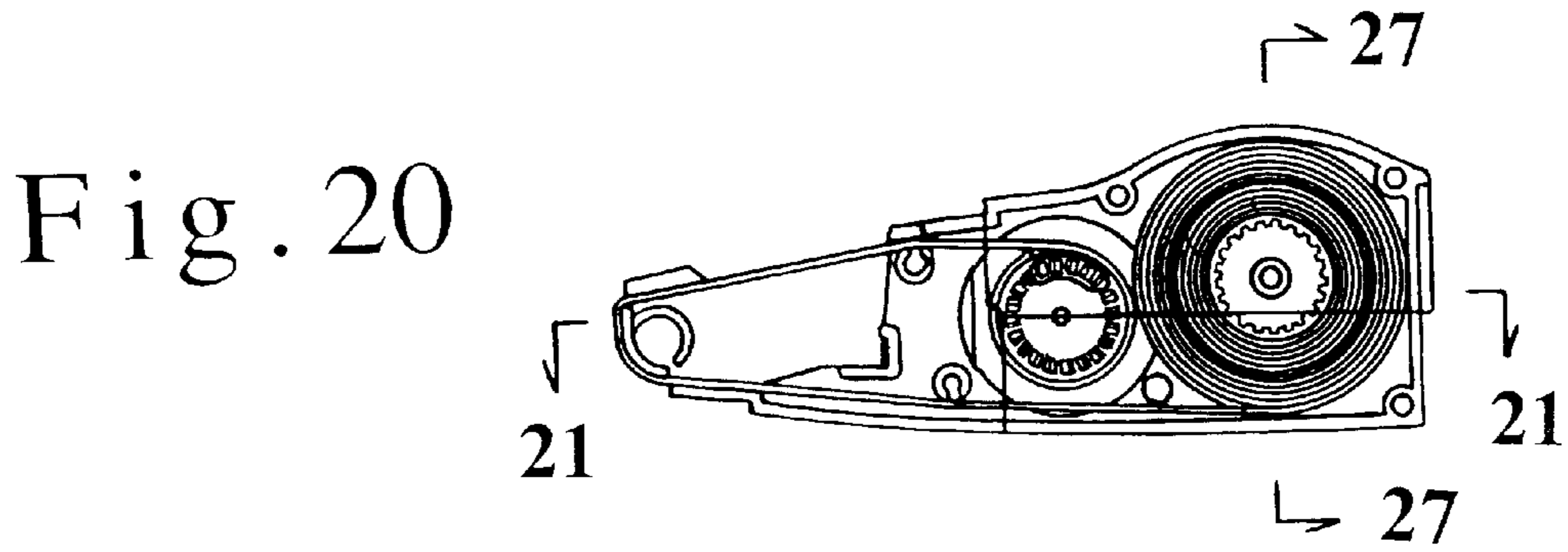
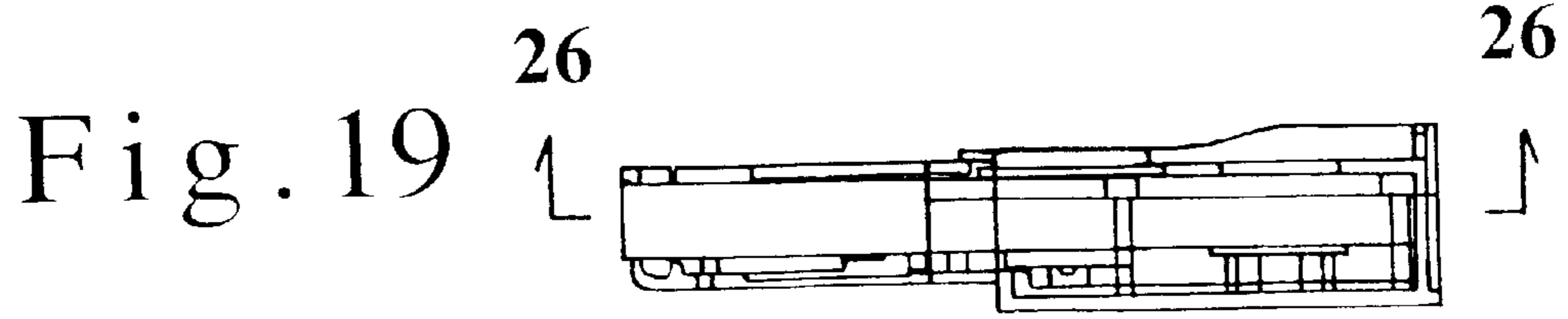

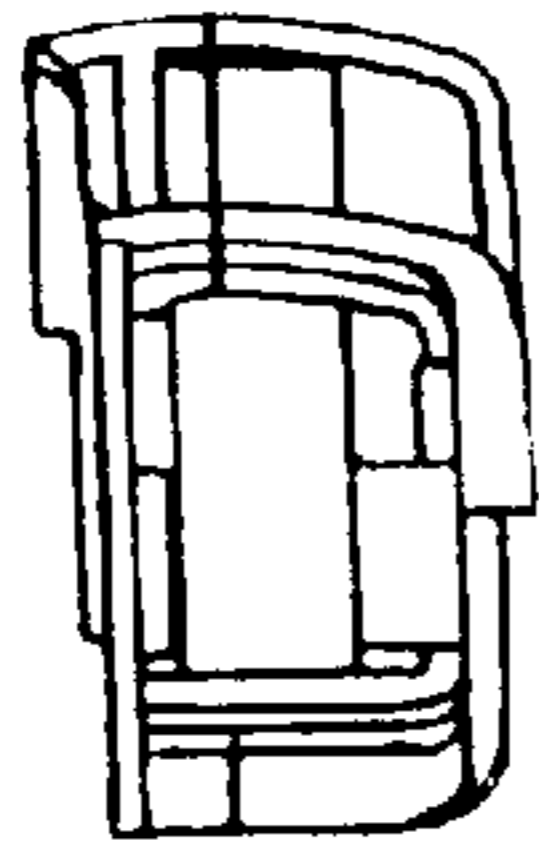

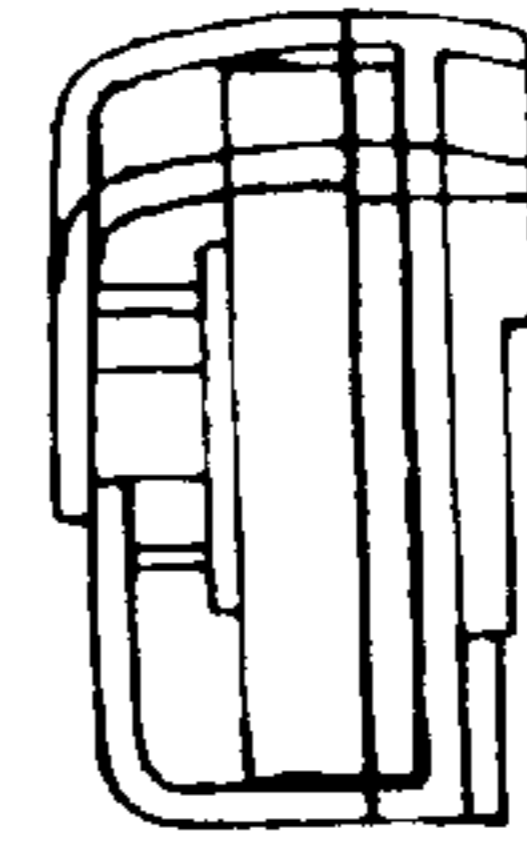

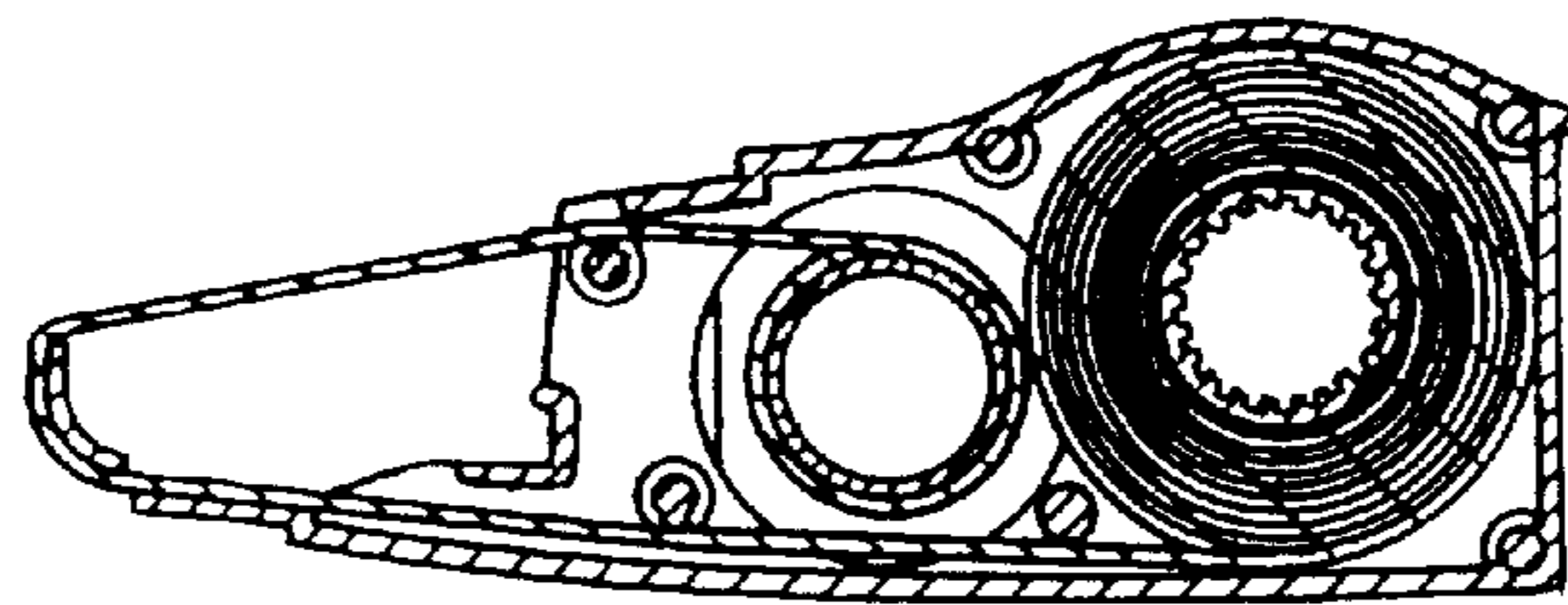

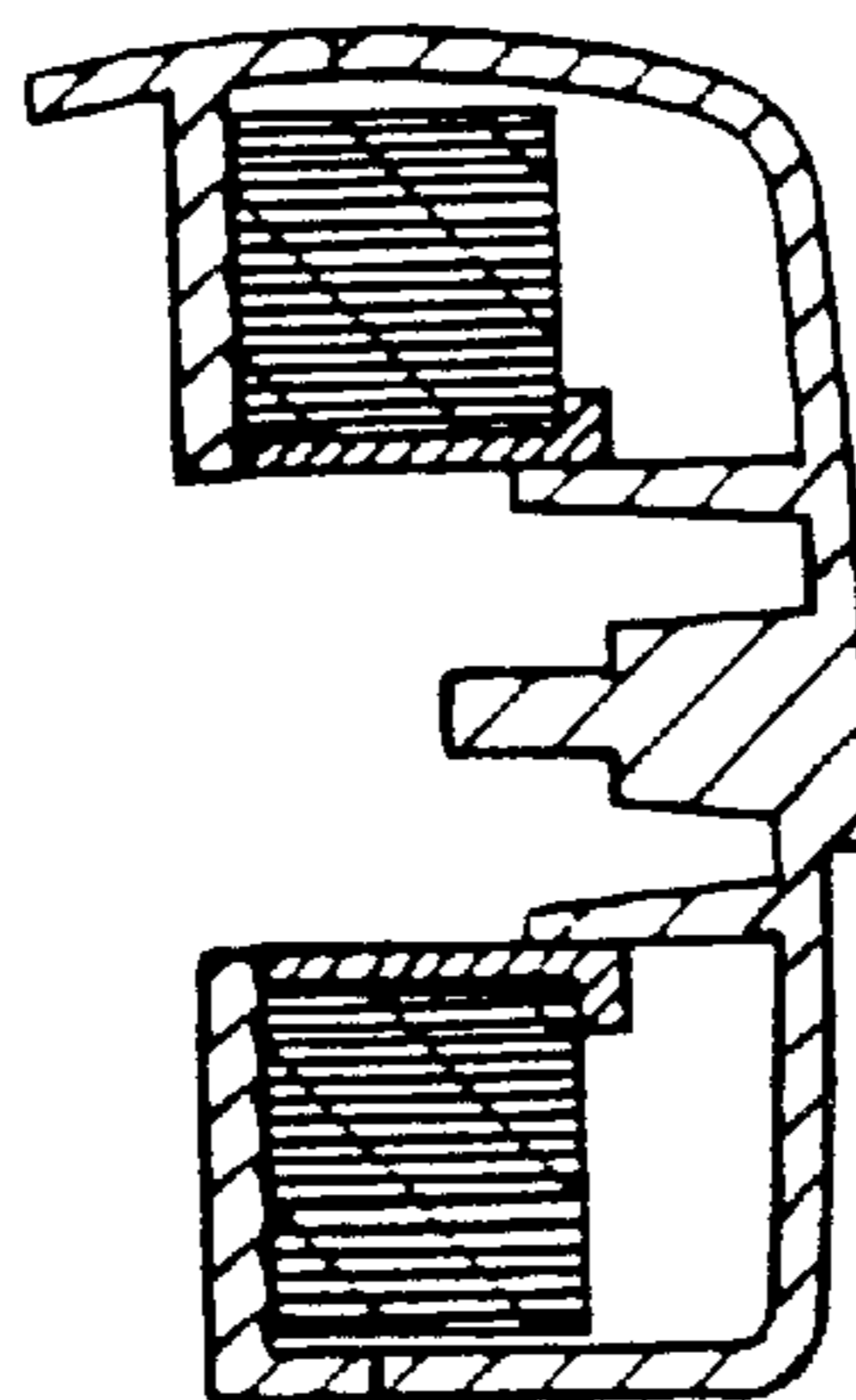

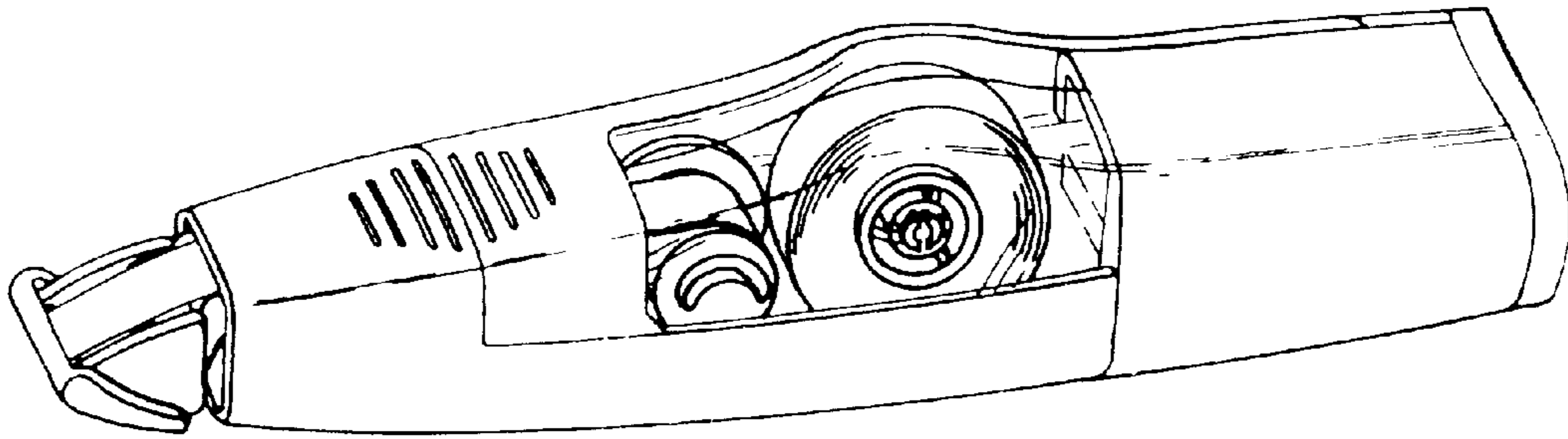

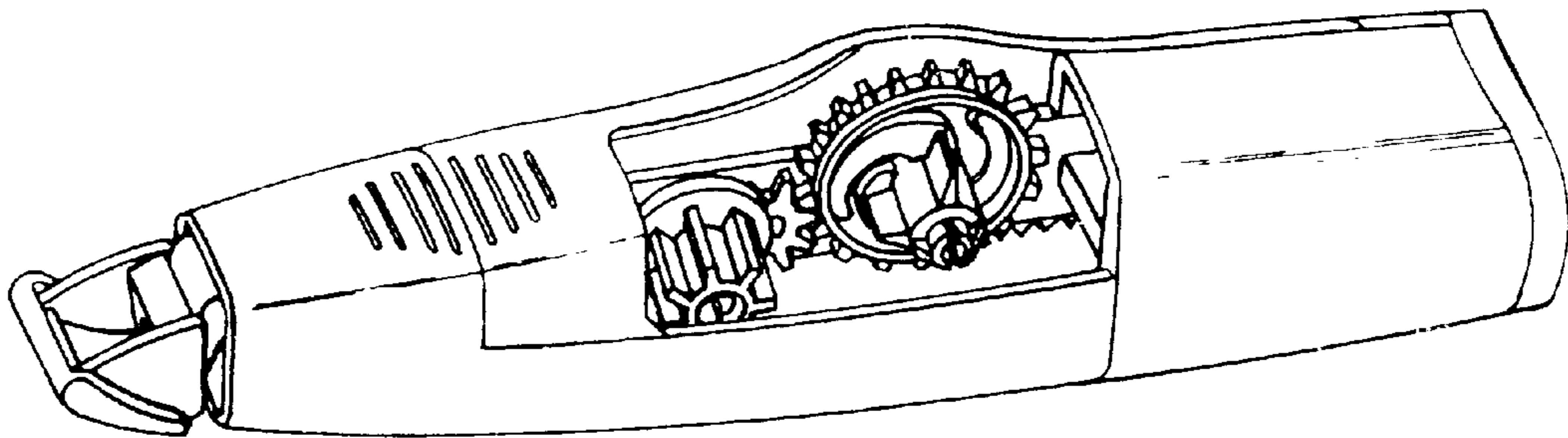
