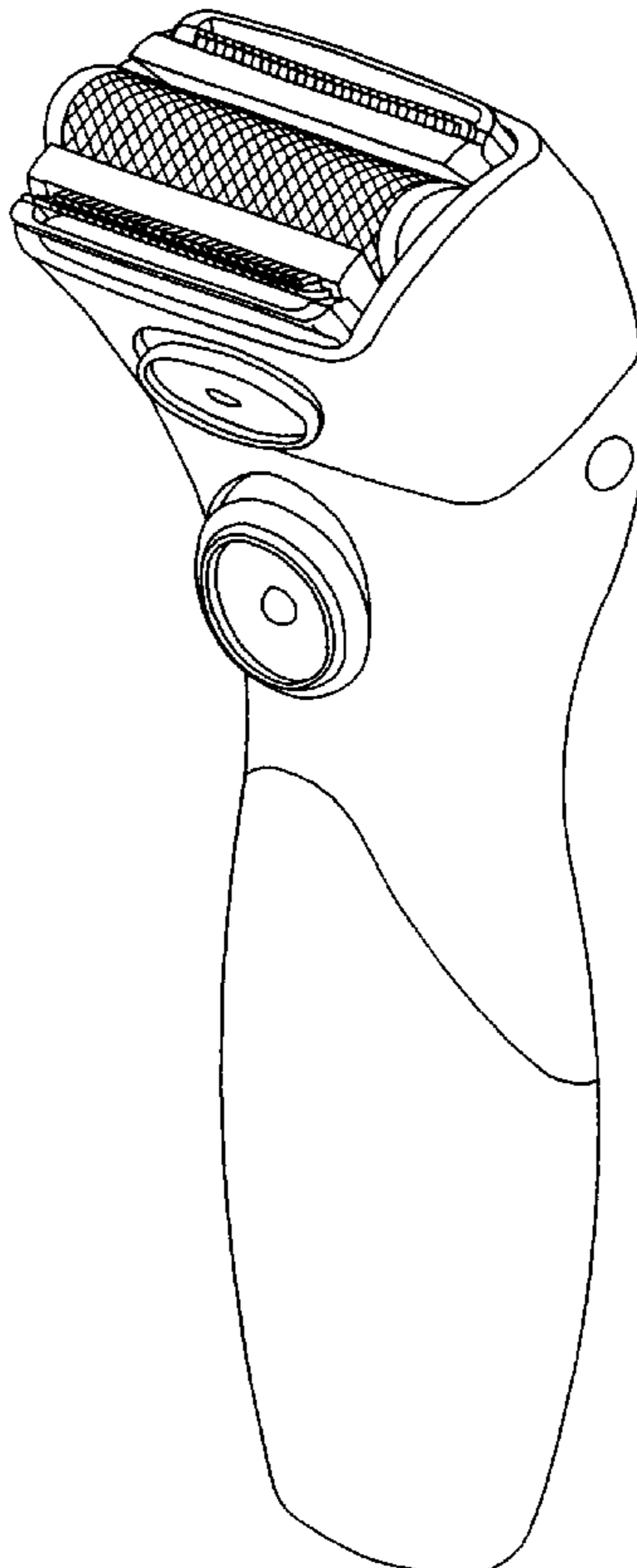
FIG. 1 is a top and right front perspective view of an electric shaver, showing our design;

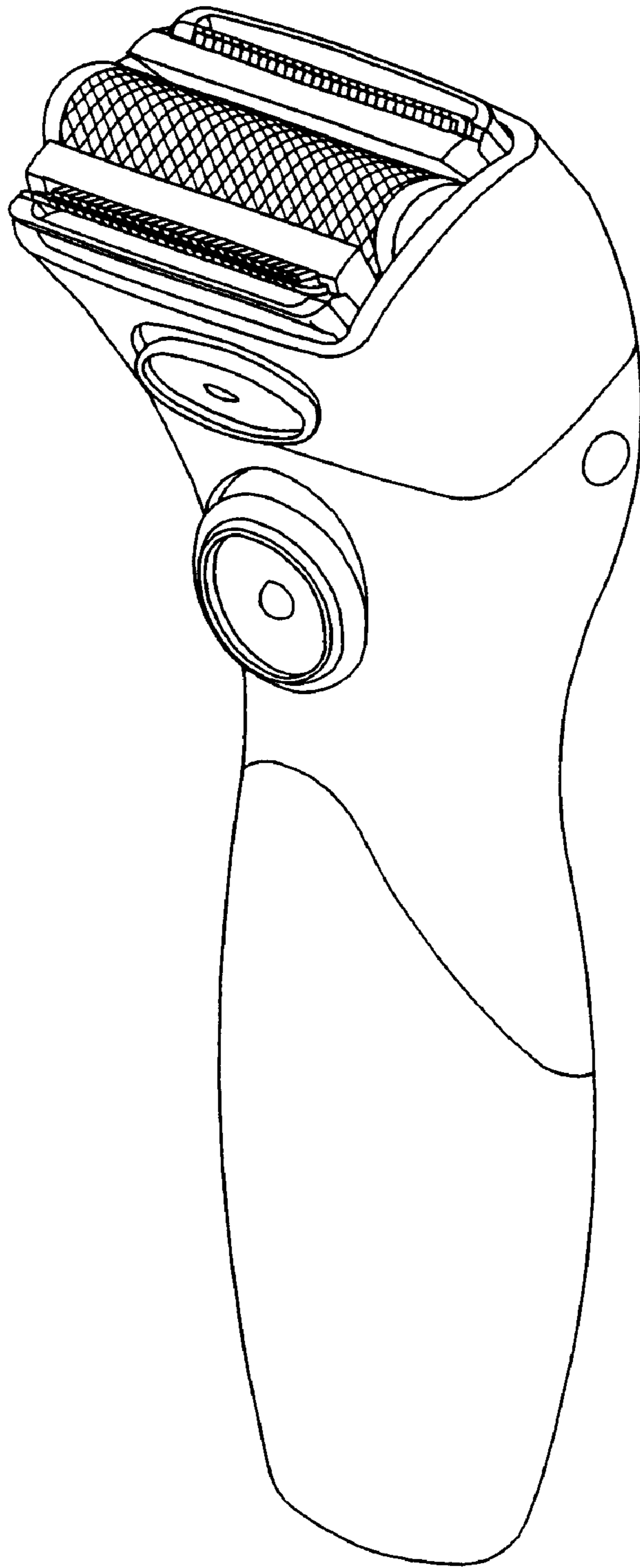

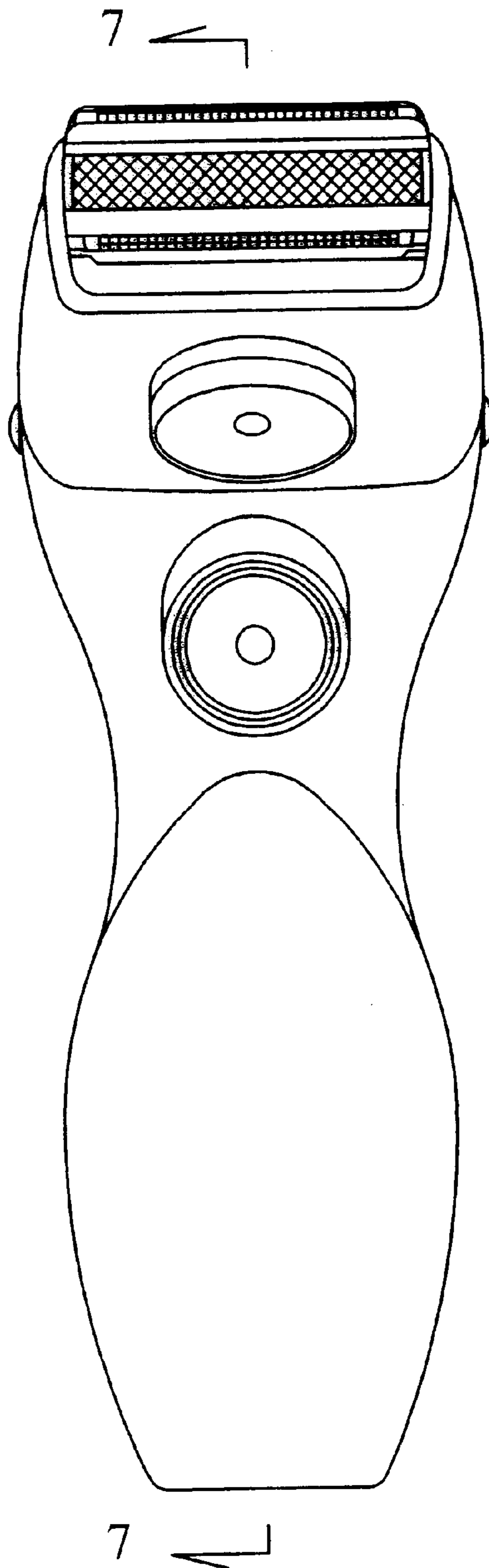

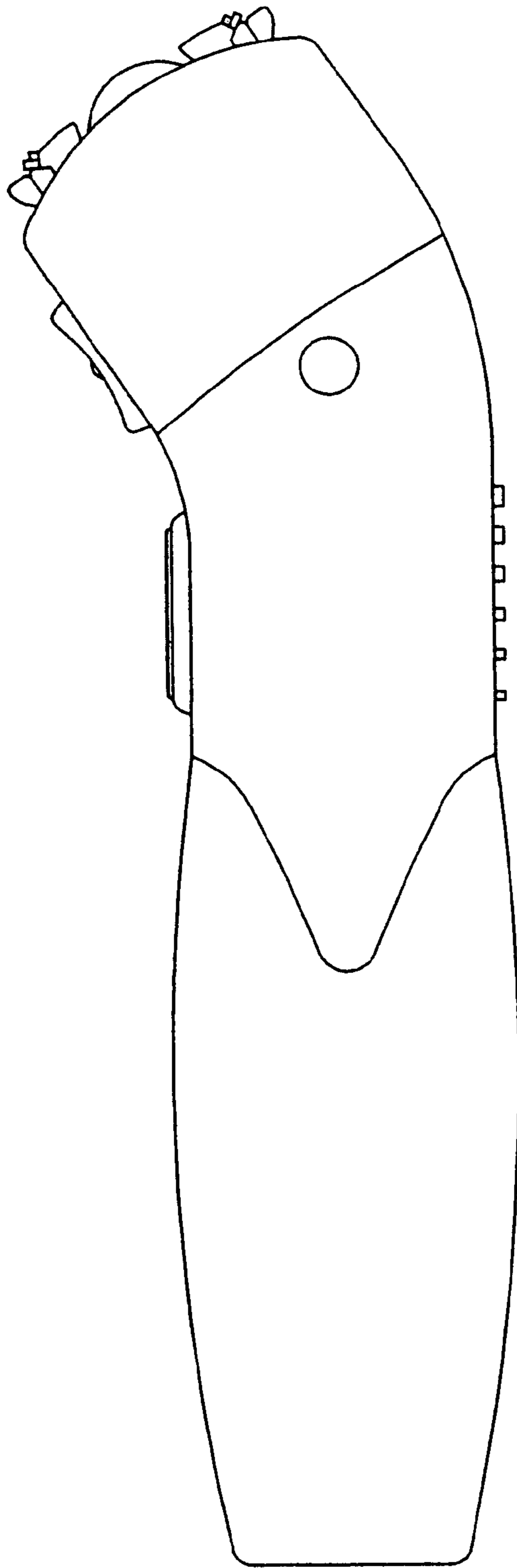

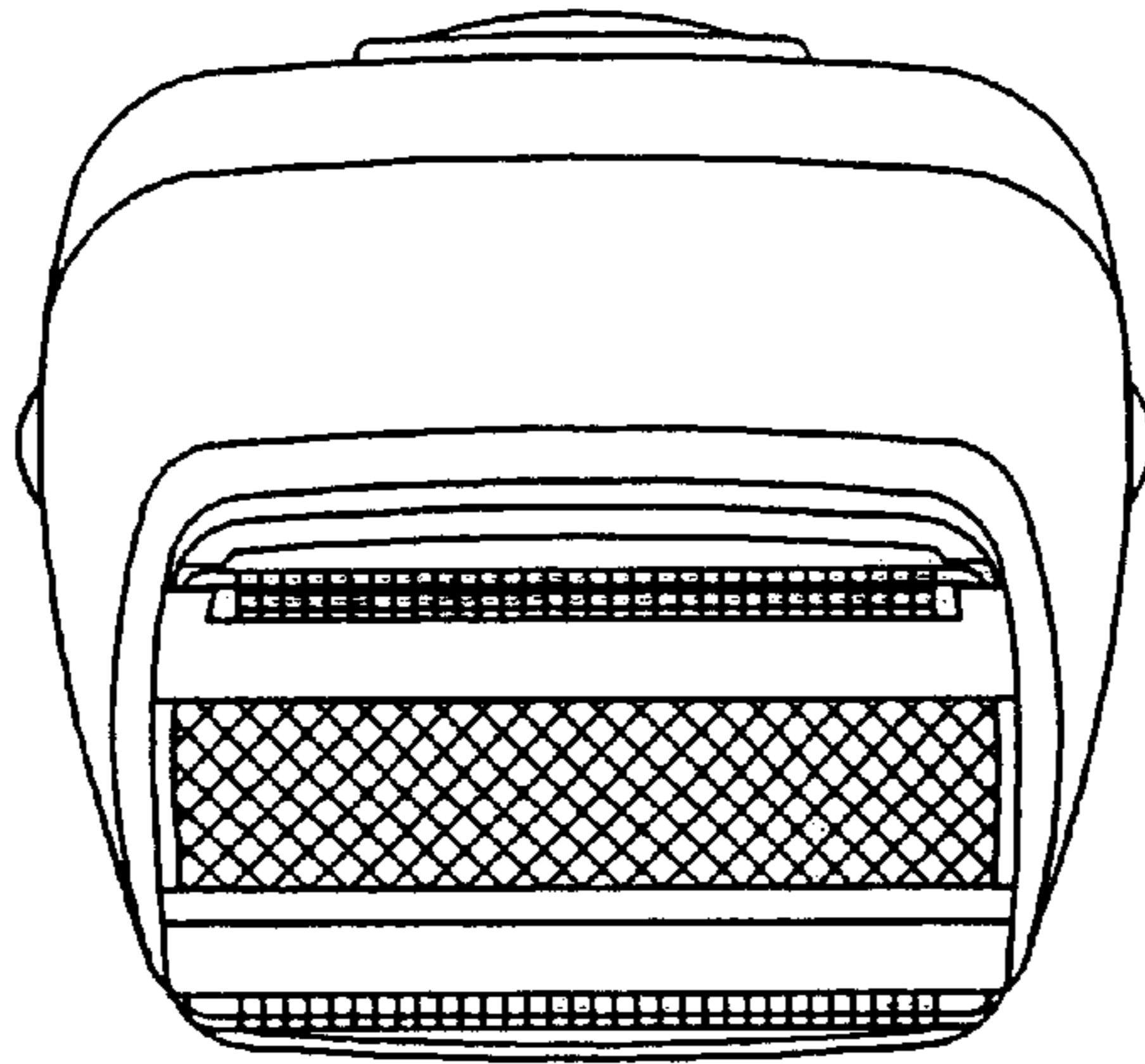

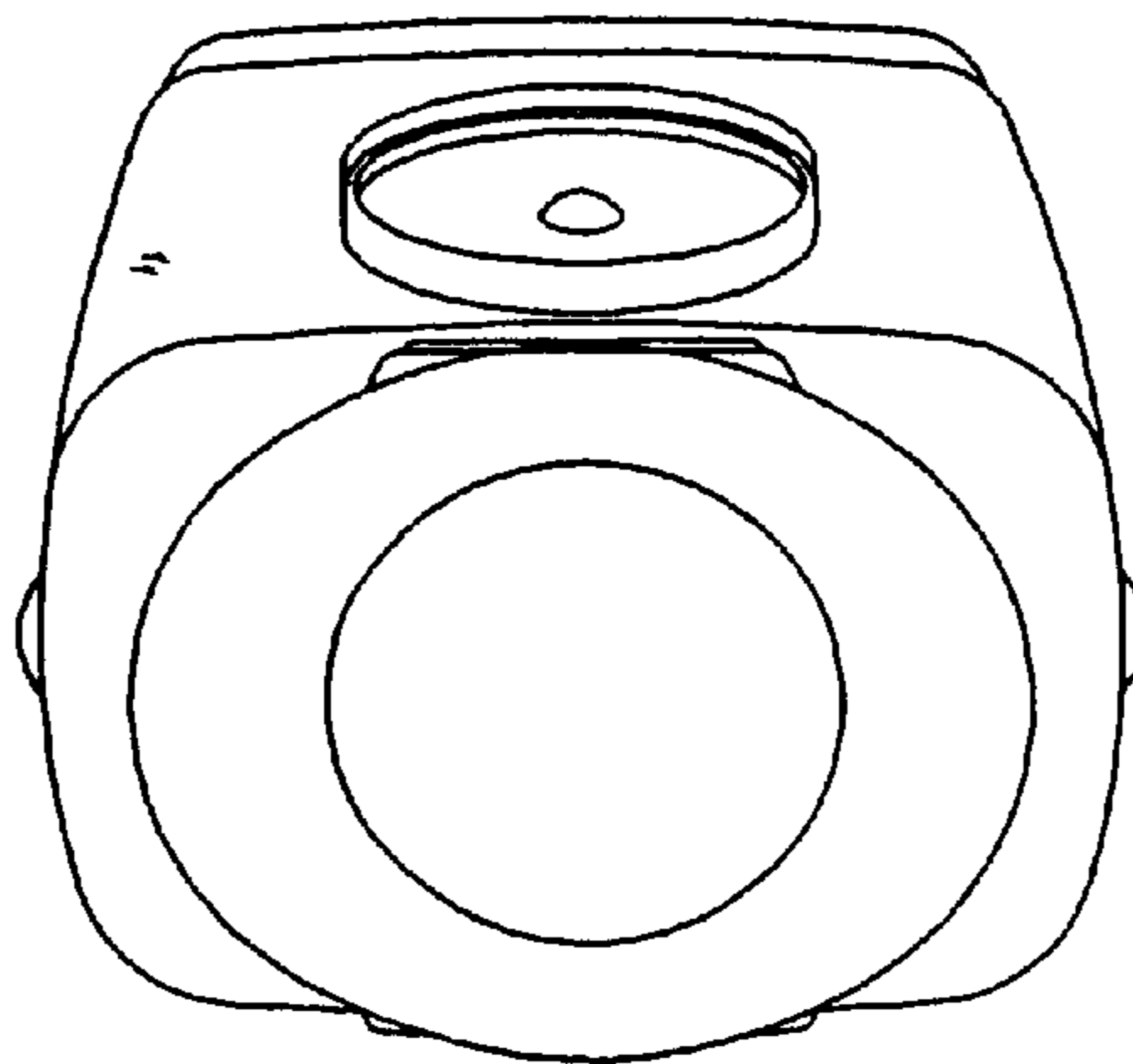

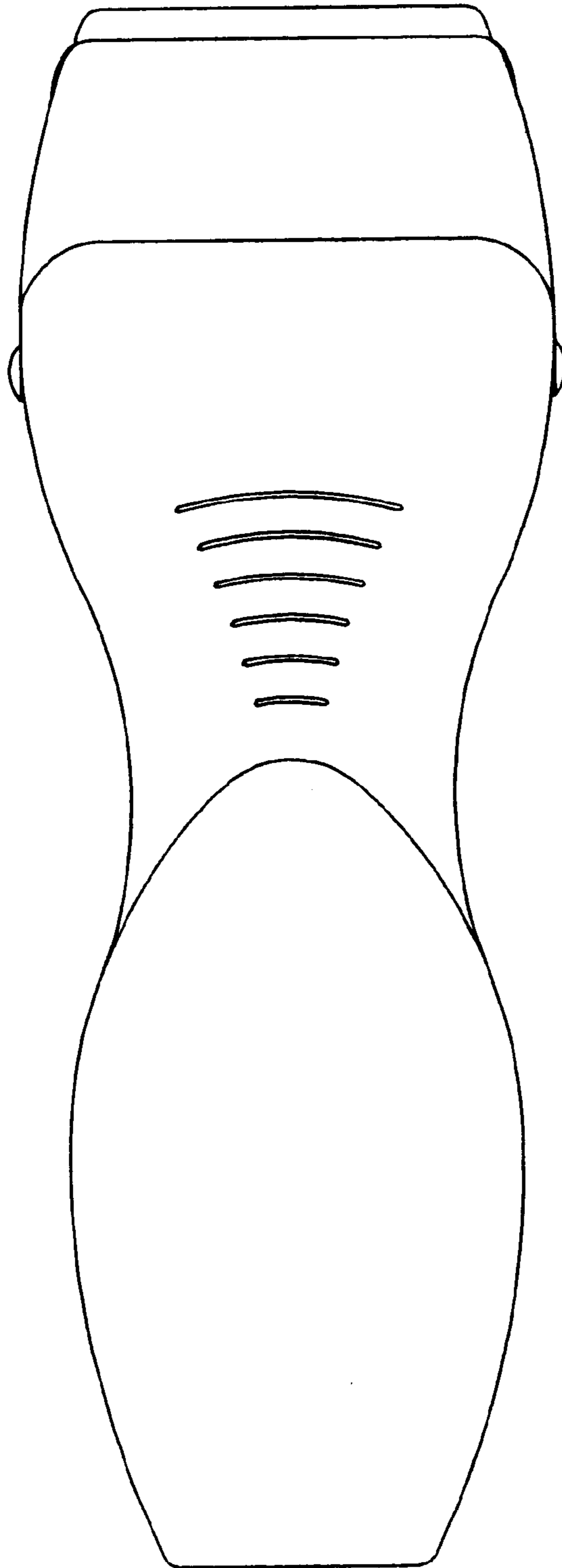

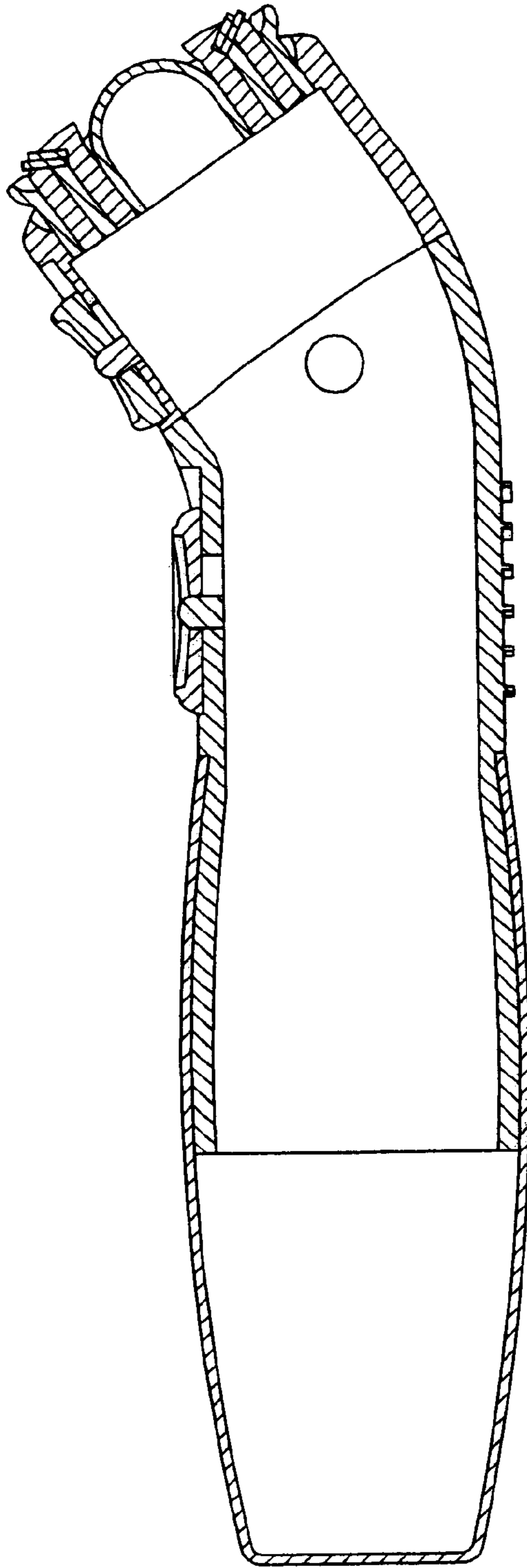
