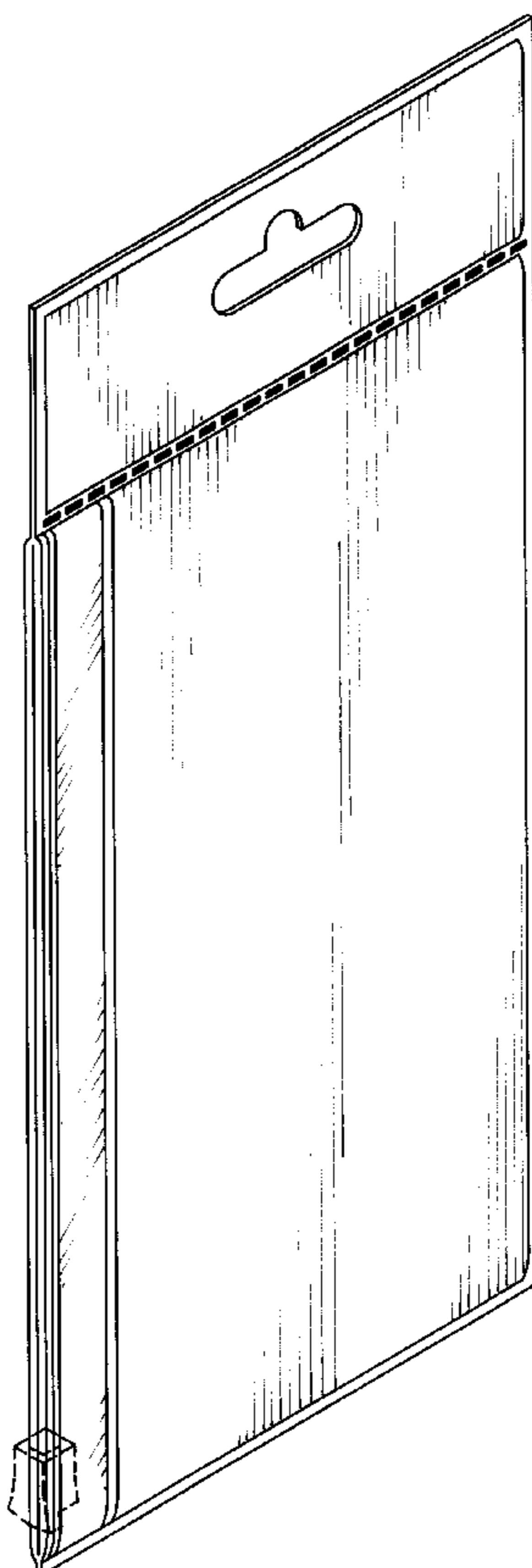
(57) **CLAIM**

The ornamental design for a cosmetic carrying case, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cosmetic carrying case showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front perspective view of a modified form of a cosmetic carrying case showing by new design;
 FIG. 9 is a front elevational view of FIG. 8;
 FIG. 10 is a rear elevational view of FIG. 8;
 FIG. 11 is a left side elevational view of FIG. 8;
 FIG. 12 is a right side elevational view of FIG. 8;
 FIG. 13 is a top plan view of FIG. 8; and,

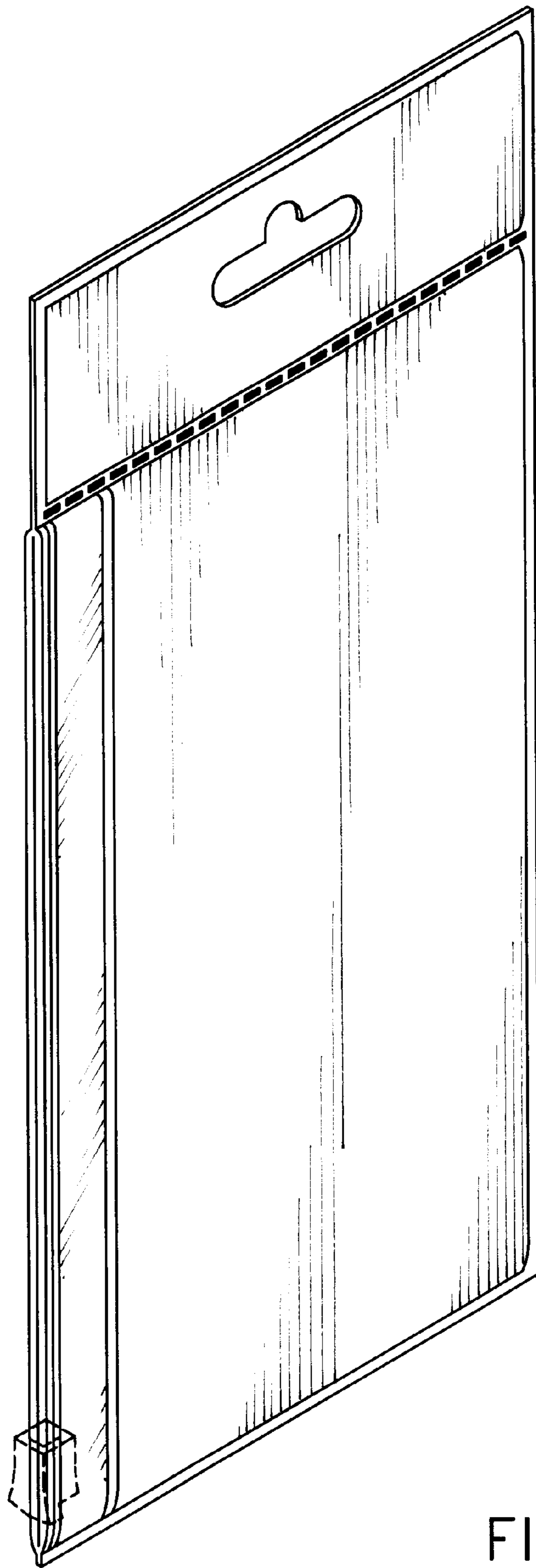

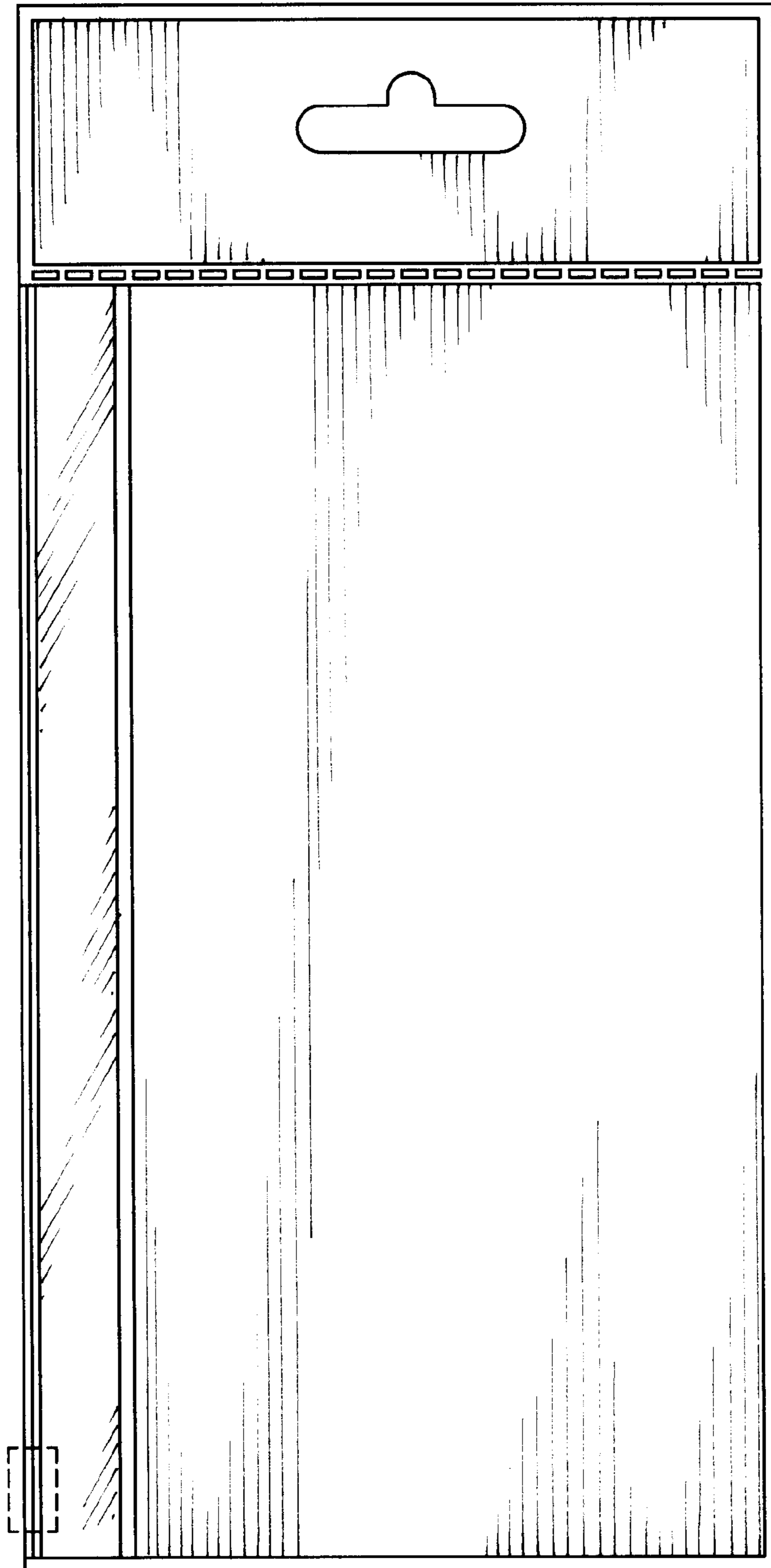

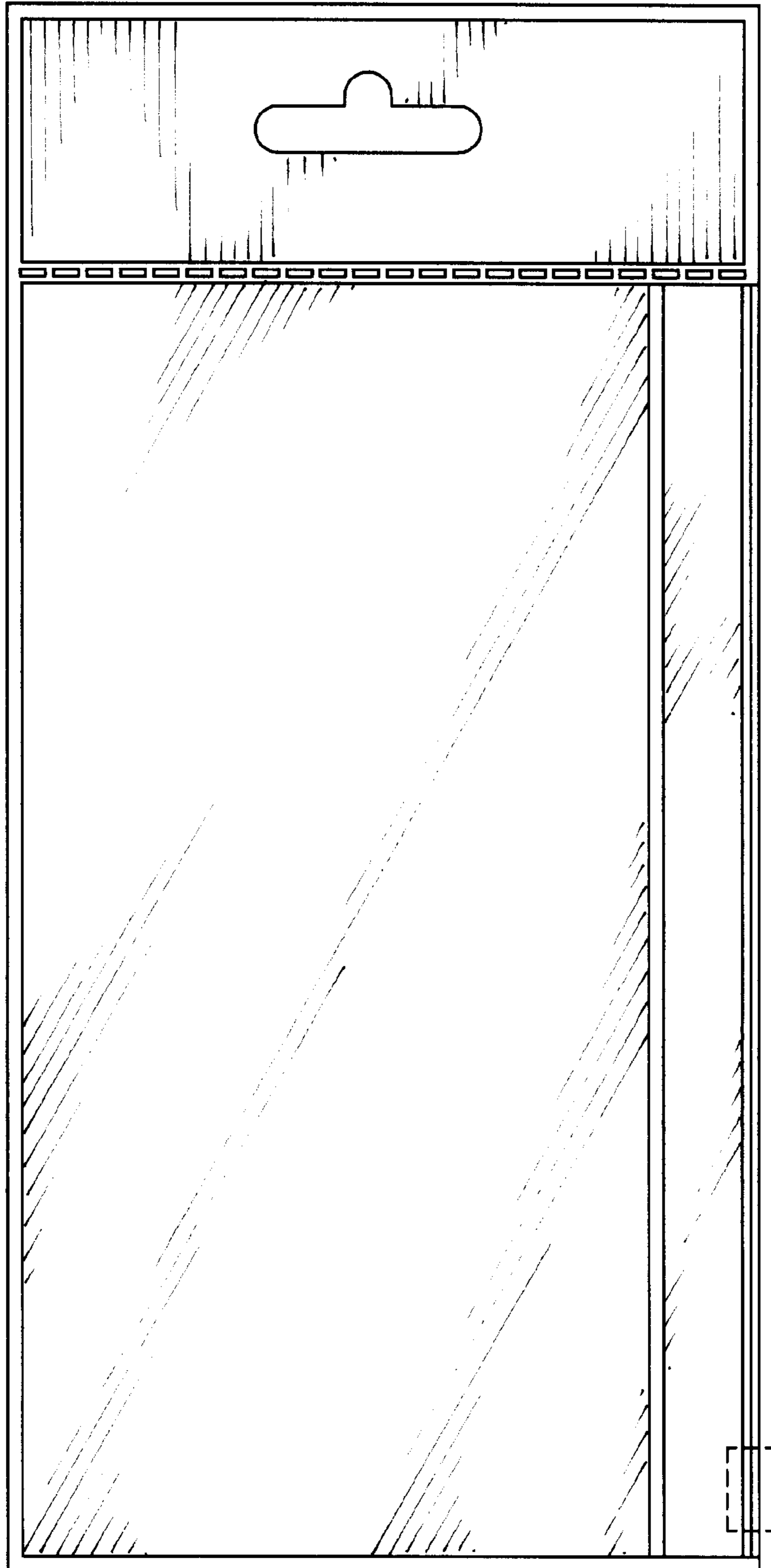

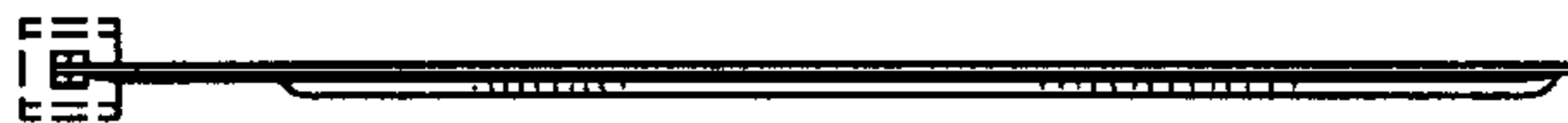

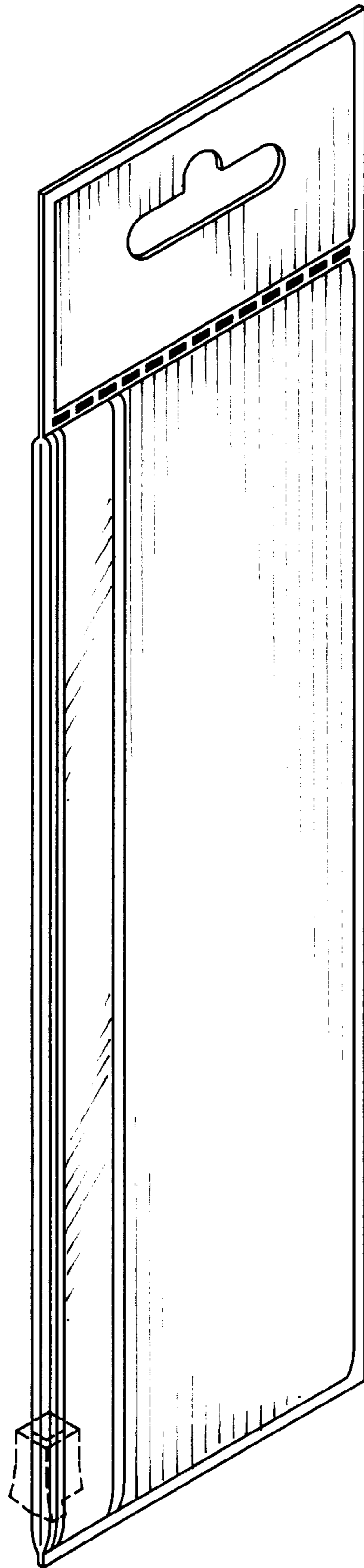

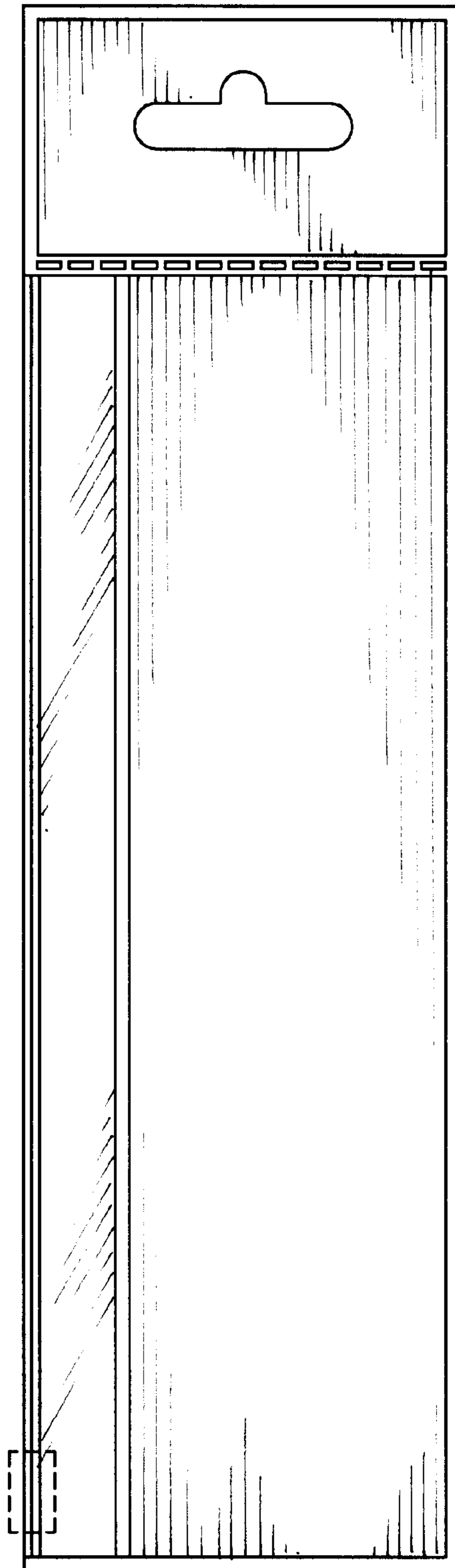

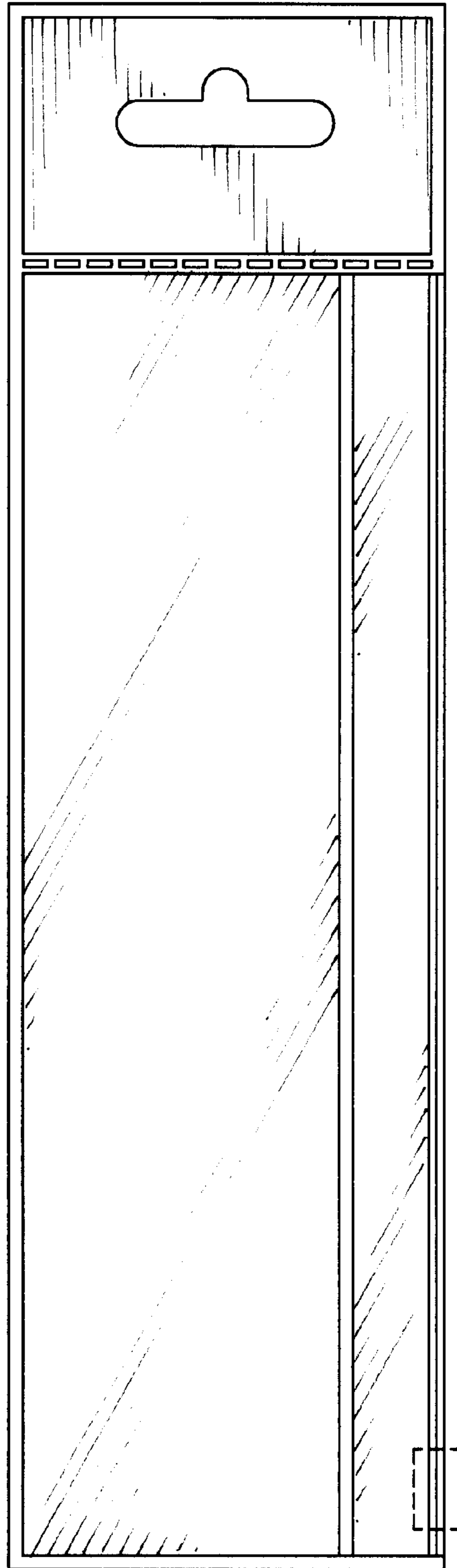

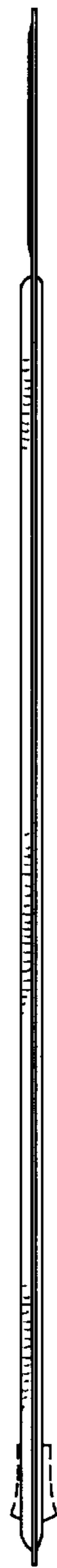
